FIG. 1 is a front elevation view of the glove of the present invention.

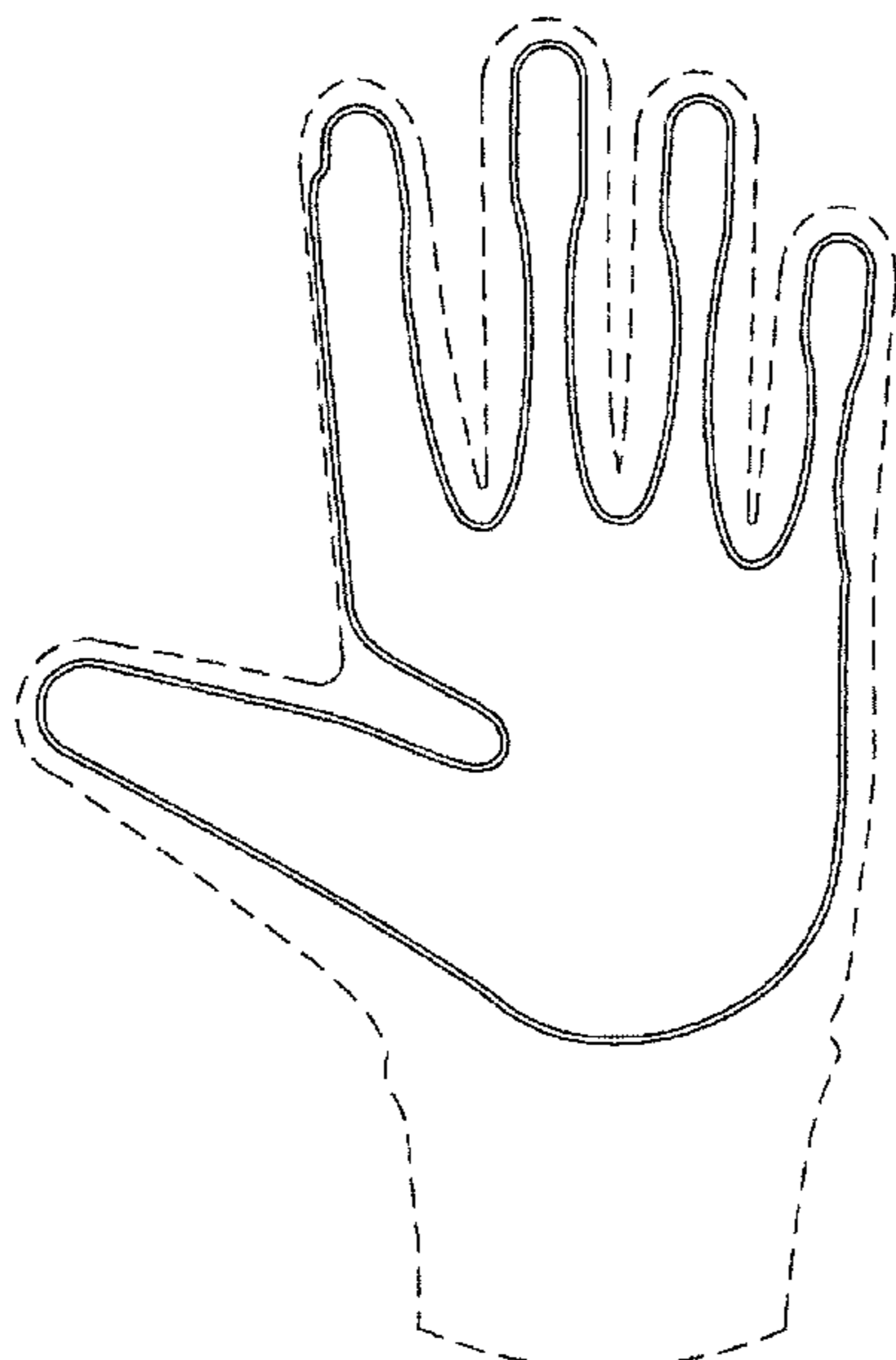
FIG. 2 is a left side elevation view of the glove of the present invention.

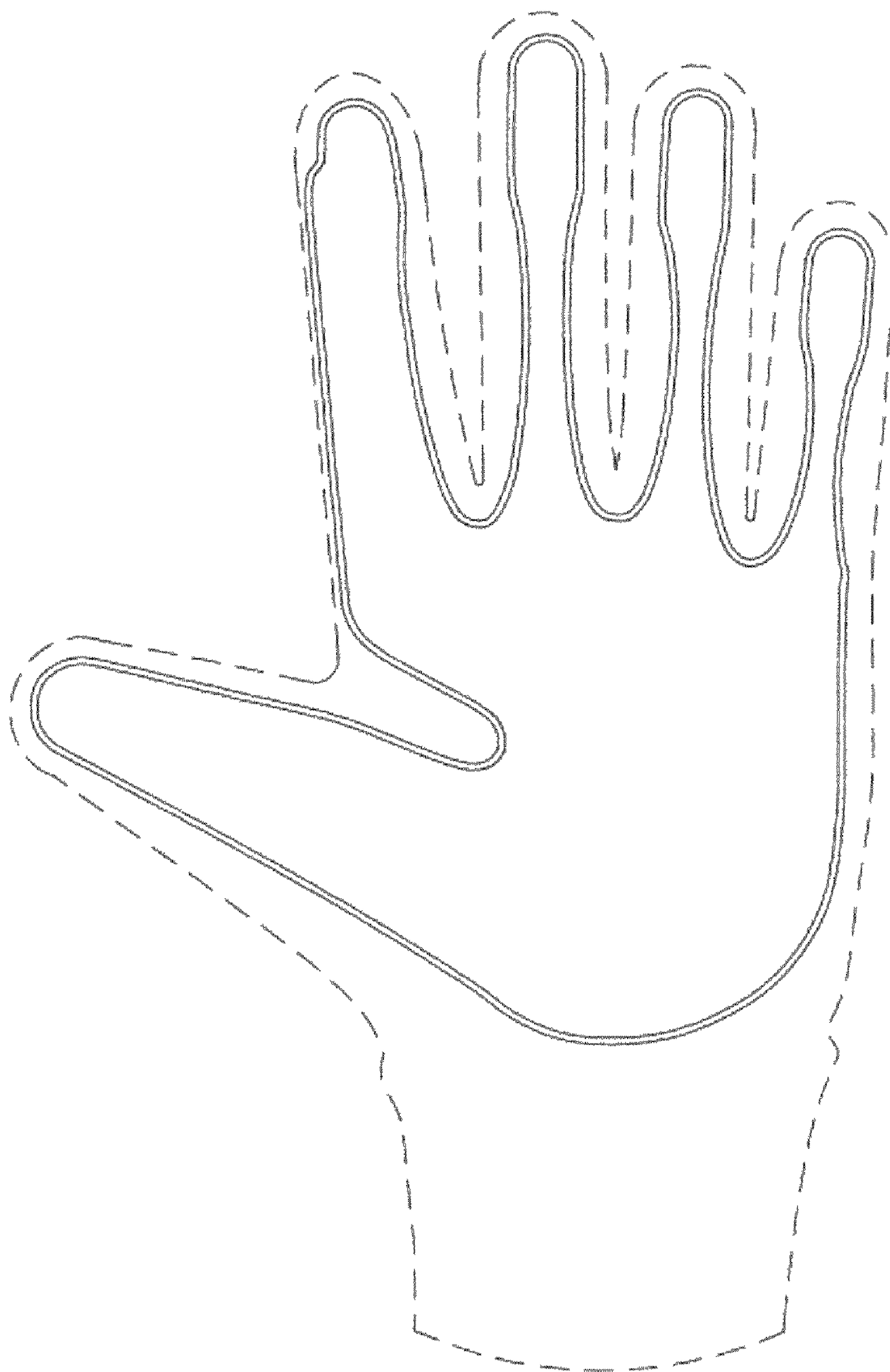

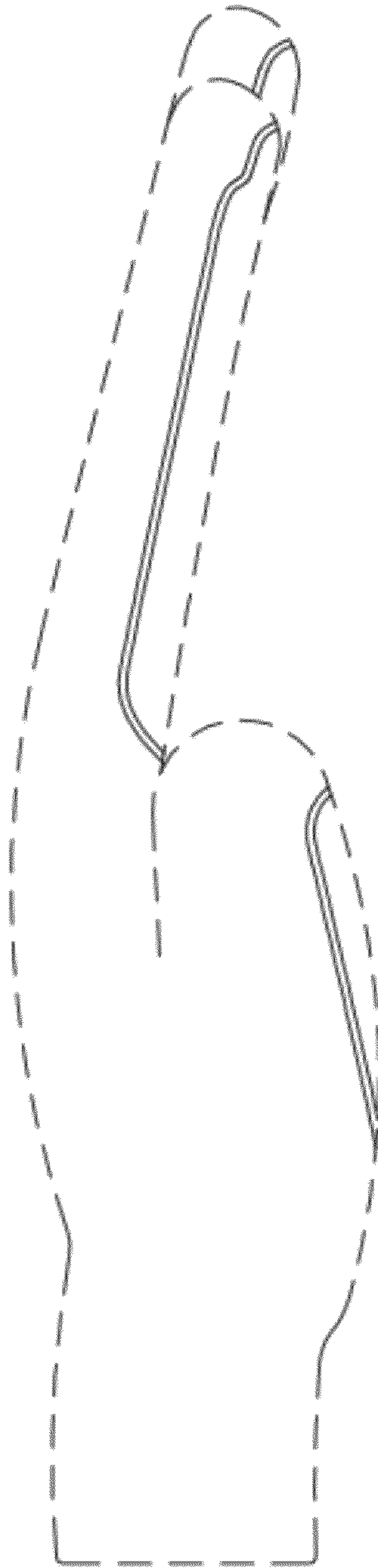

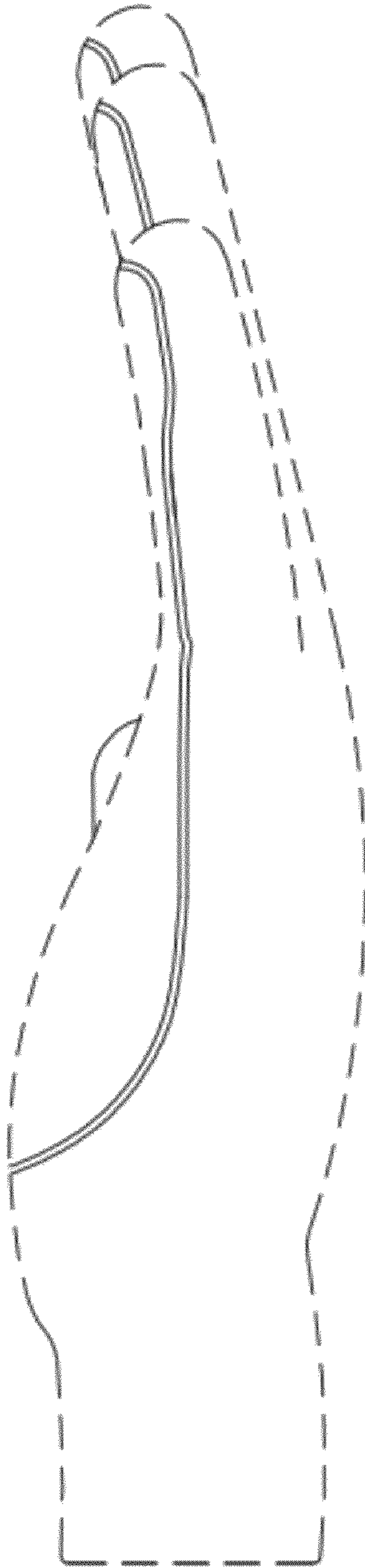

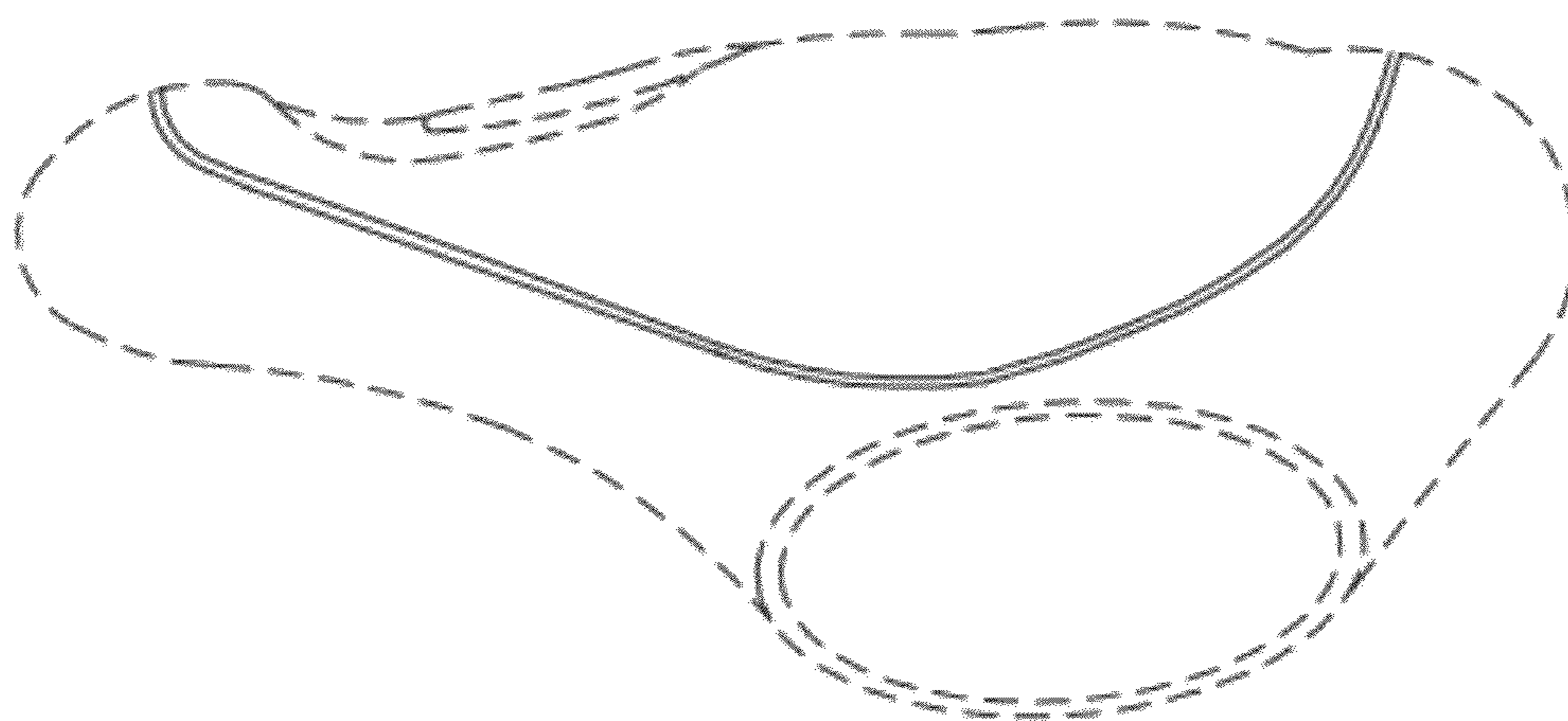

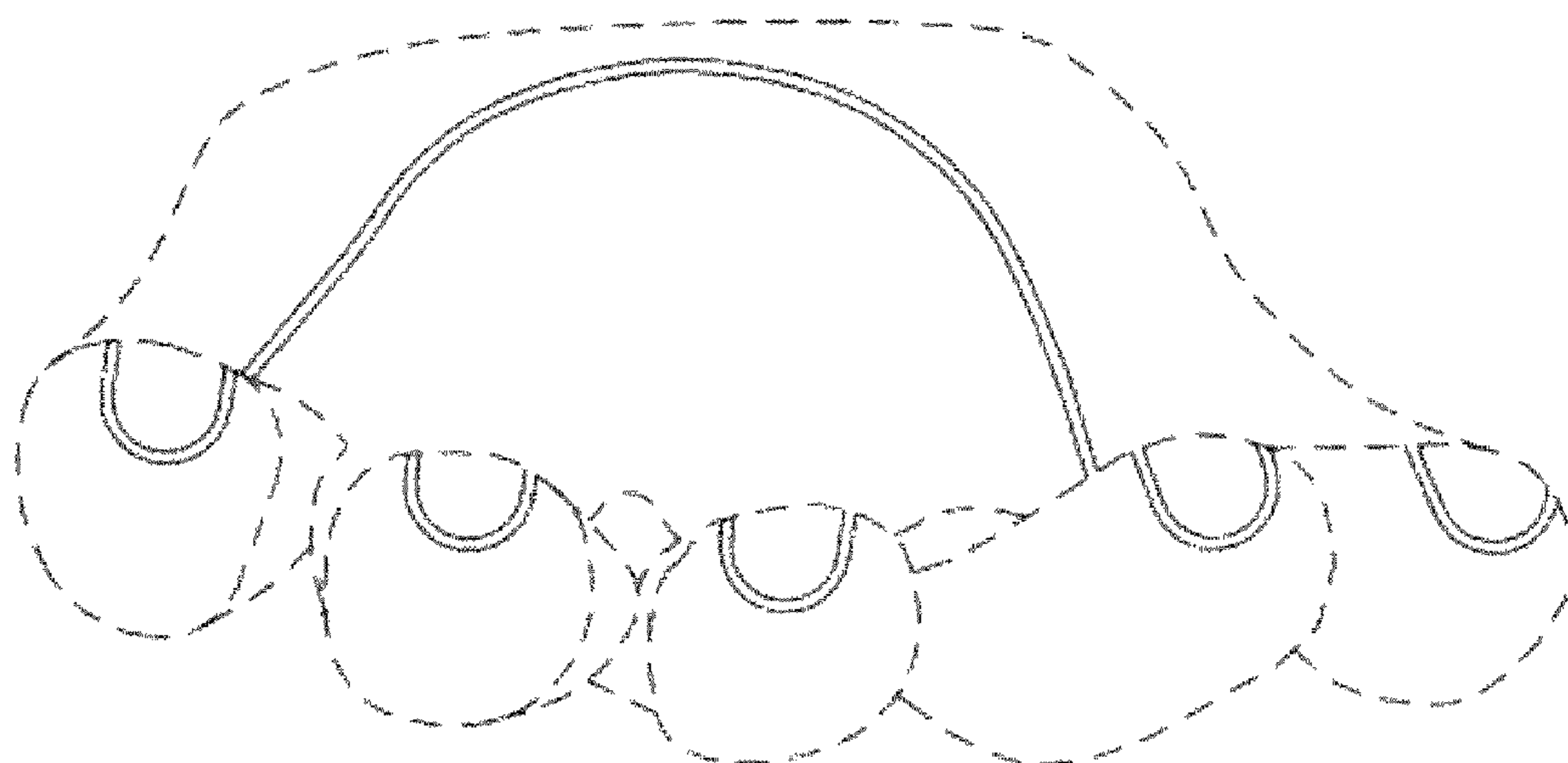
