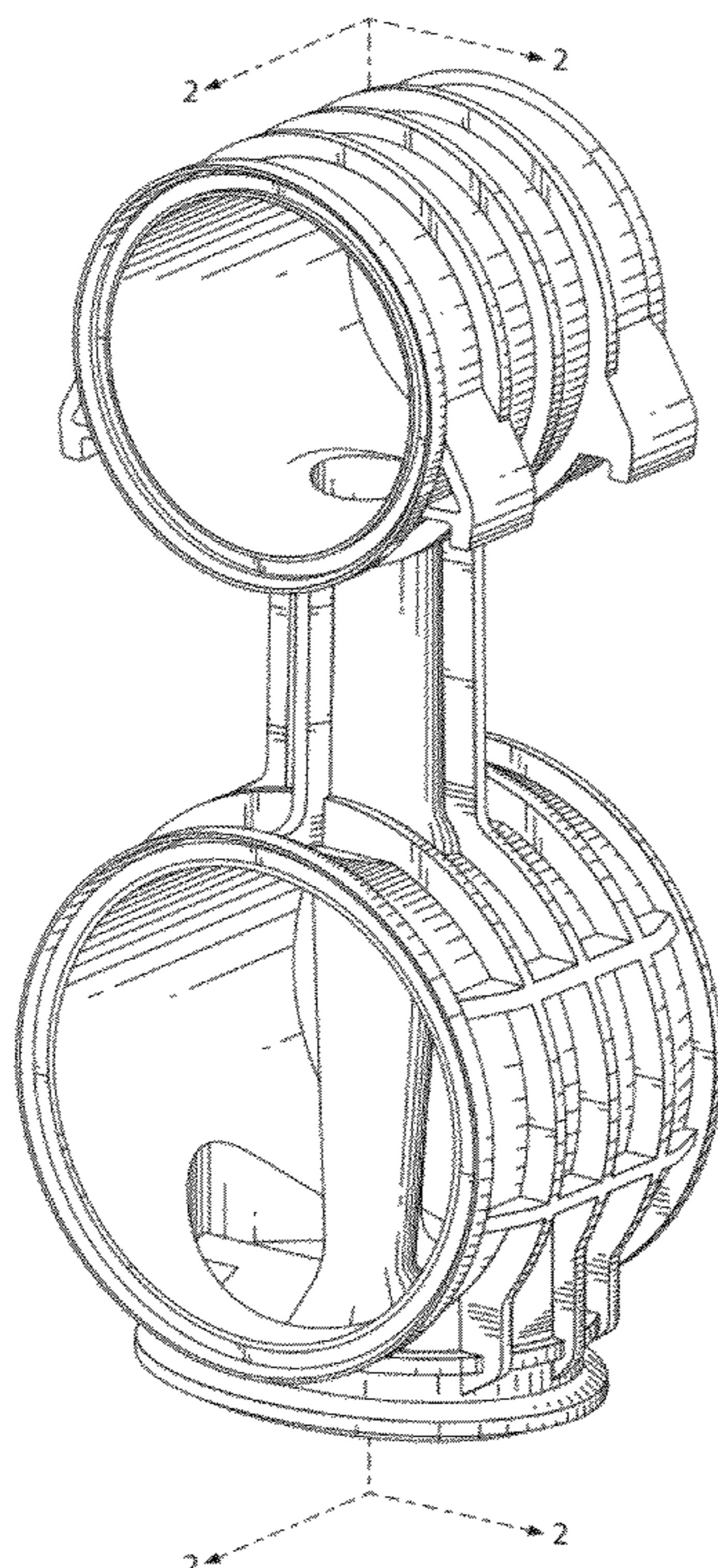
(57) **CLAIM**

The ornamental design for a pulp suspension hydrocyclone cleaner, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a pulp suspension hydrocyclone cleaner showing our new design;
 FIG. 2 is a cross-sectional view of 2-2 of FIG. 1;
 FIG. 3 is a front elevational view of FIG. 1;
 FIG. 4 is a side elevational view, the opposite side being a mirror image thereof;
 FIG. 5 is a front elevational view thereof; reduced in size to show environment;
 FIG. 6 is a top plan view thereof; and,
 FIG. 7 is a bottom plan view thereof.
 The broken line showing of details in FIGS. 2, 5, and 7 is included for the purpose of showing environmental portions of the pulp suspension hydrocyclone cleaner and forms no part of the claimed design.

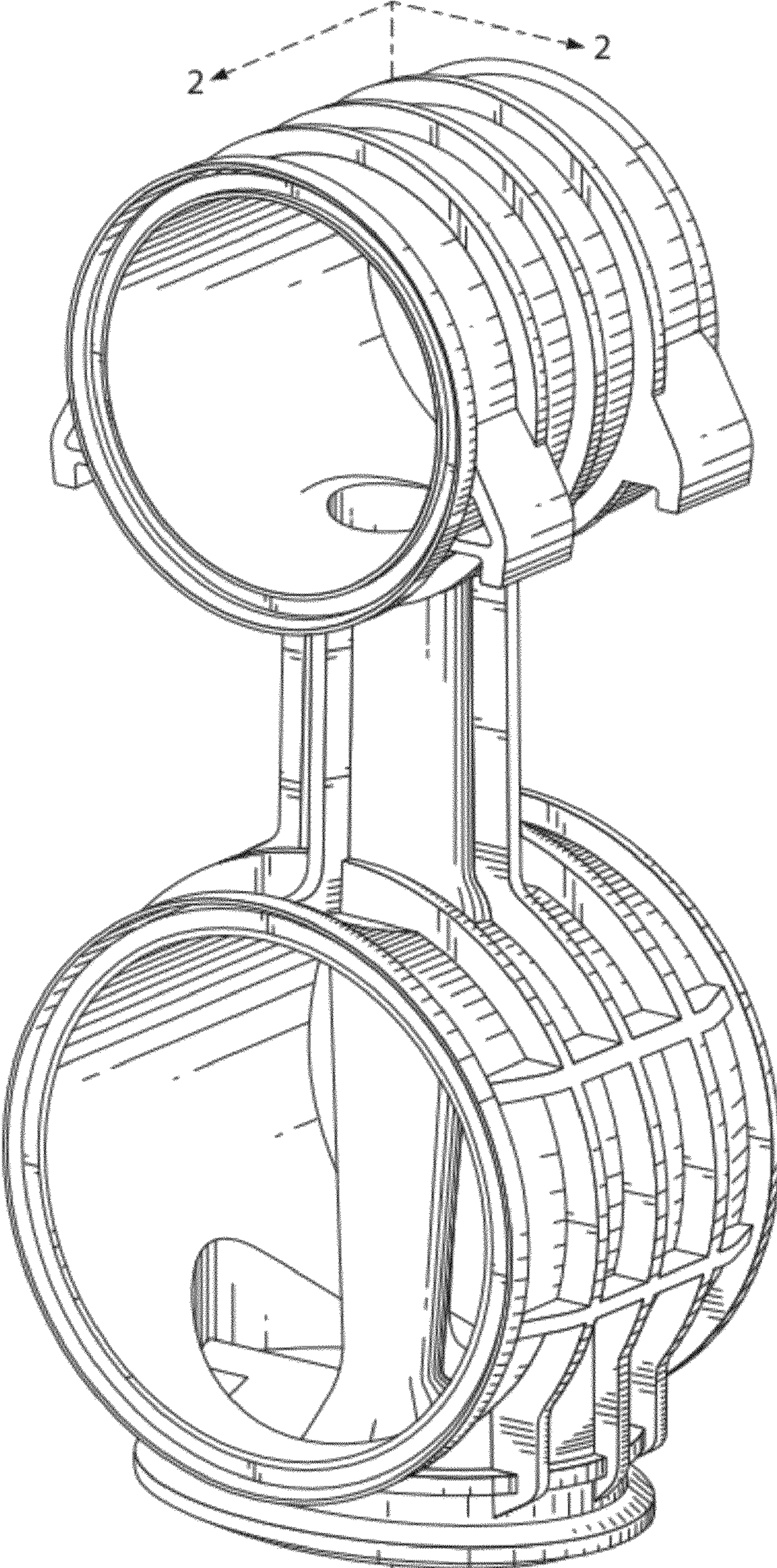

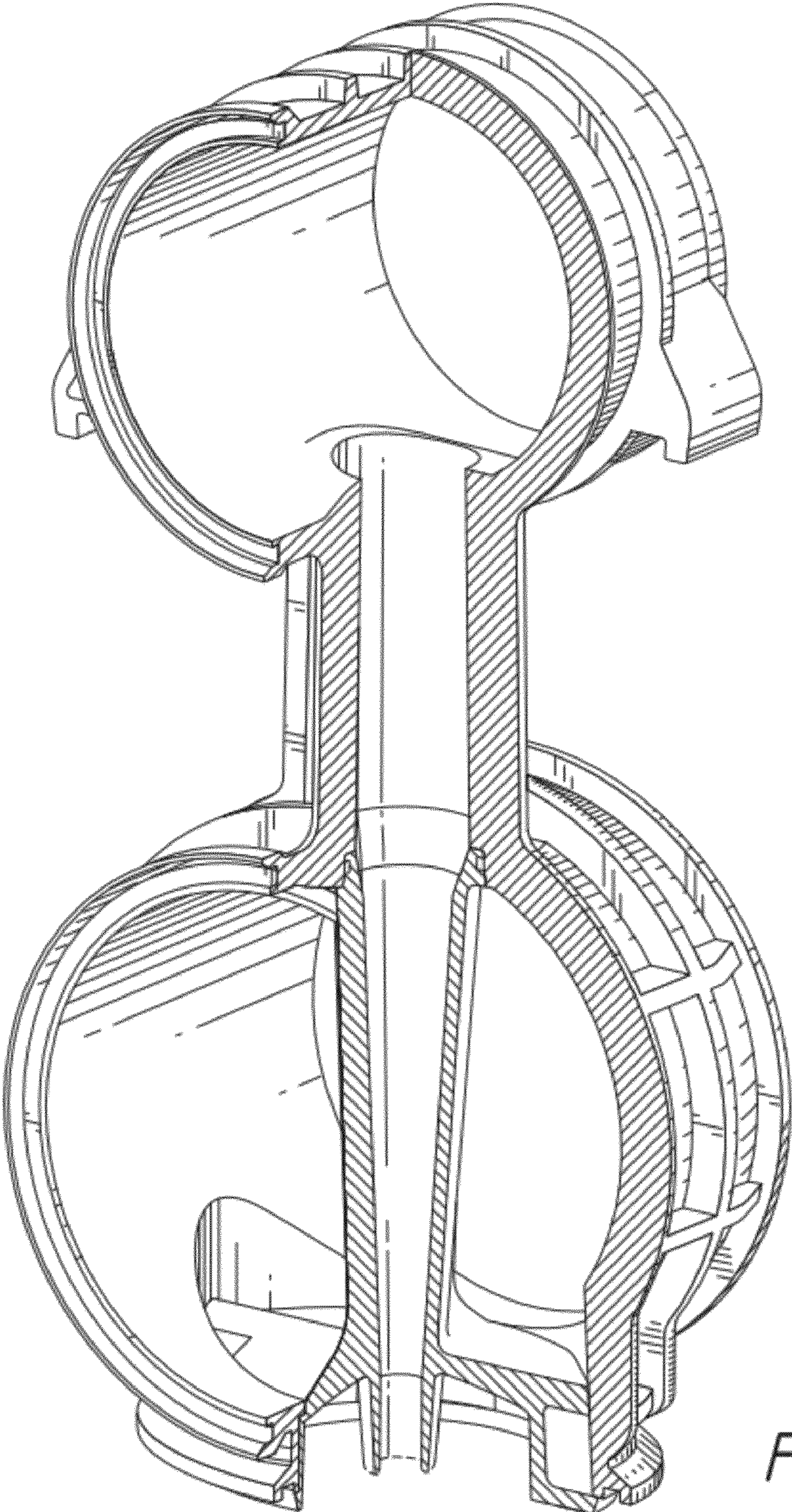

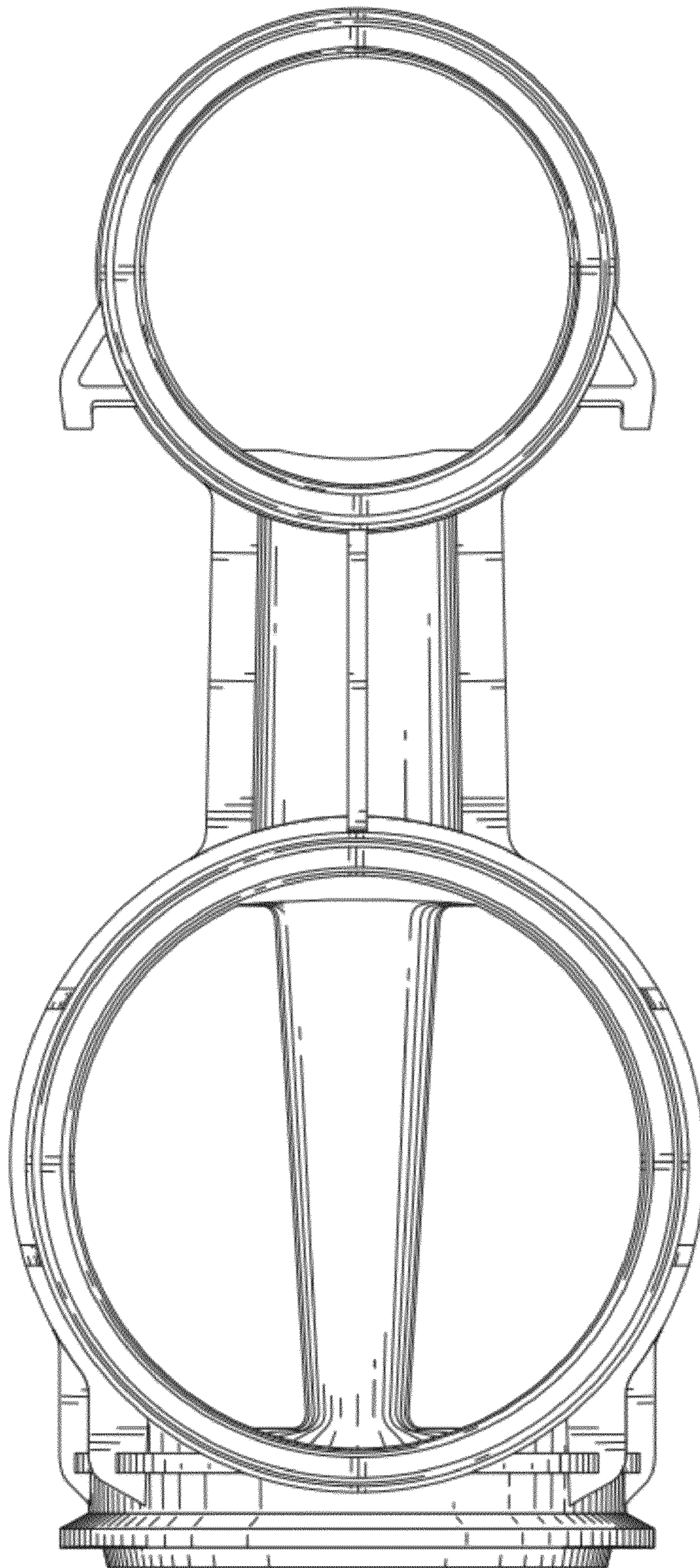

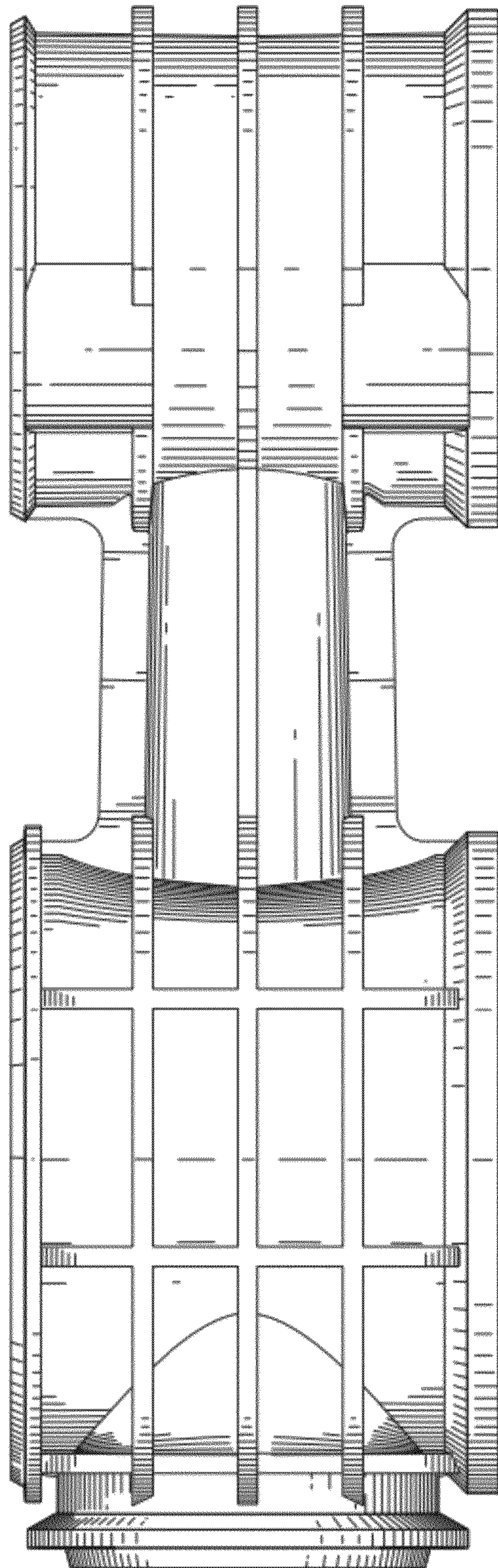

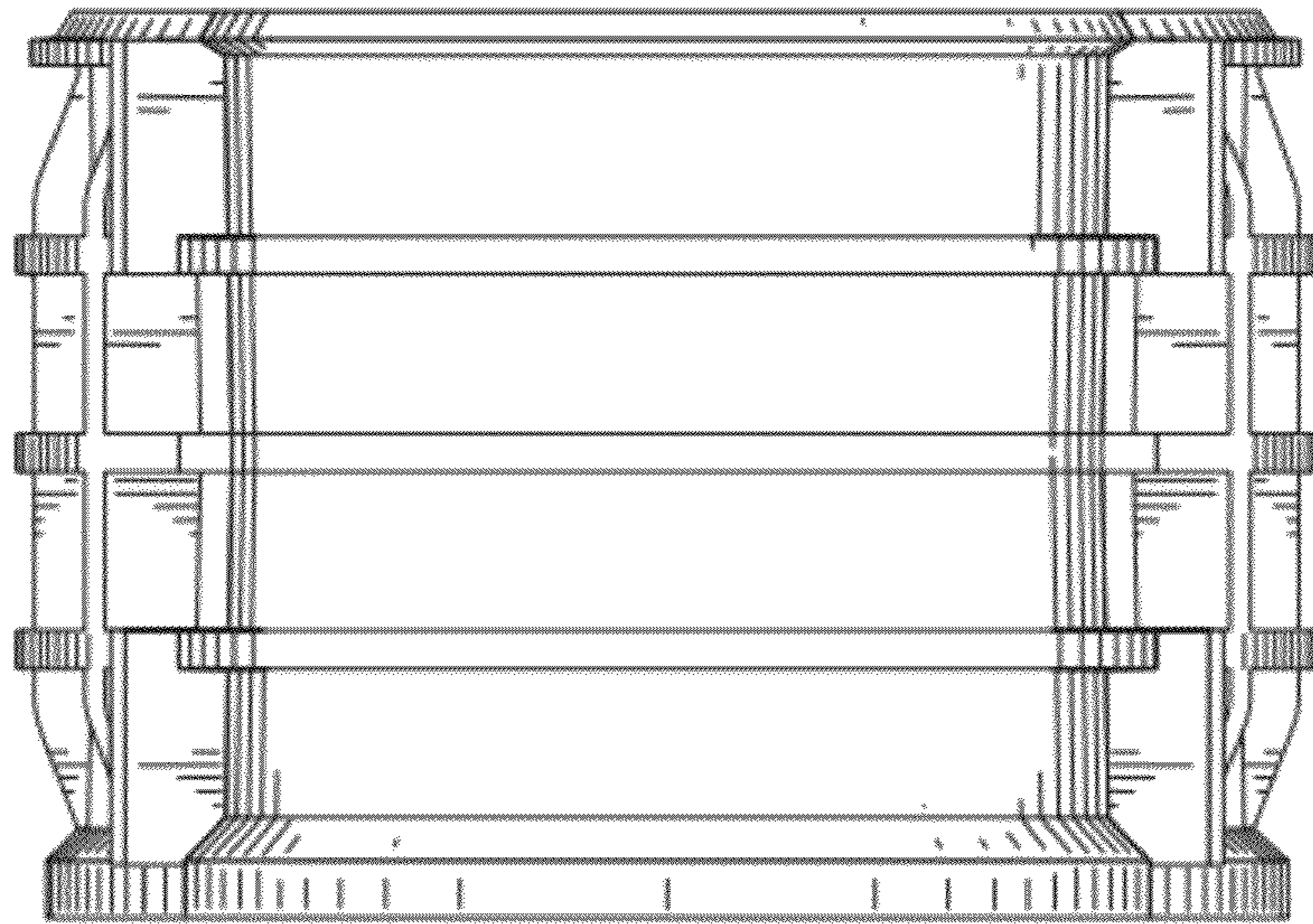

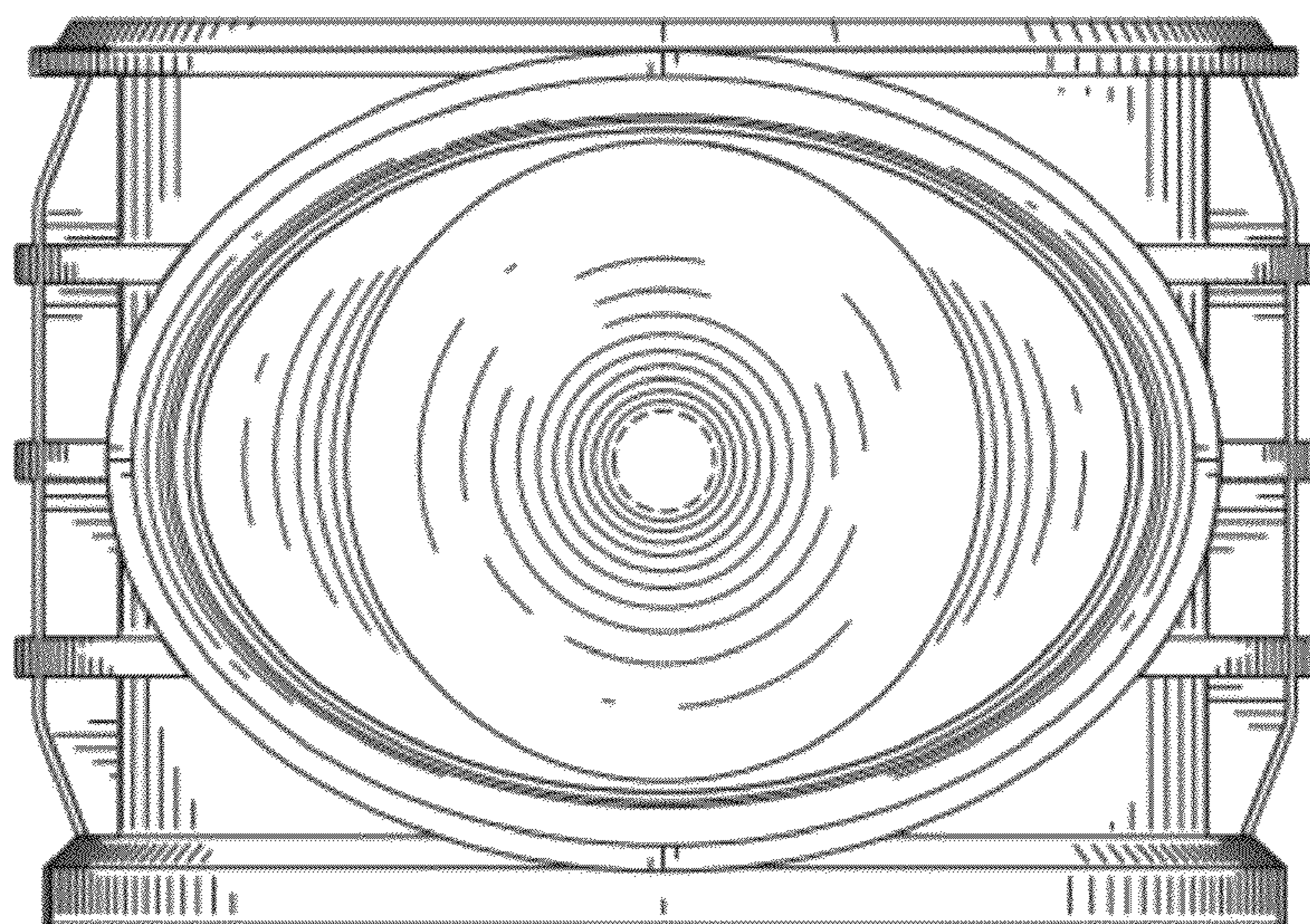
