The ornamental design for a cleaning wipe, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a cleaning wipe showing the new design;

FIG. 2 is a top view of the cleaning wipe of FIG. 1;

FIG. 3 is a bottom view of the cleaning wipe of FIG. 1;

FIG. 4 is a side view in the direction of line 4-4 in FIG. 2;

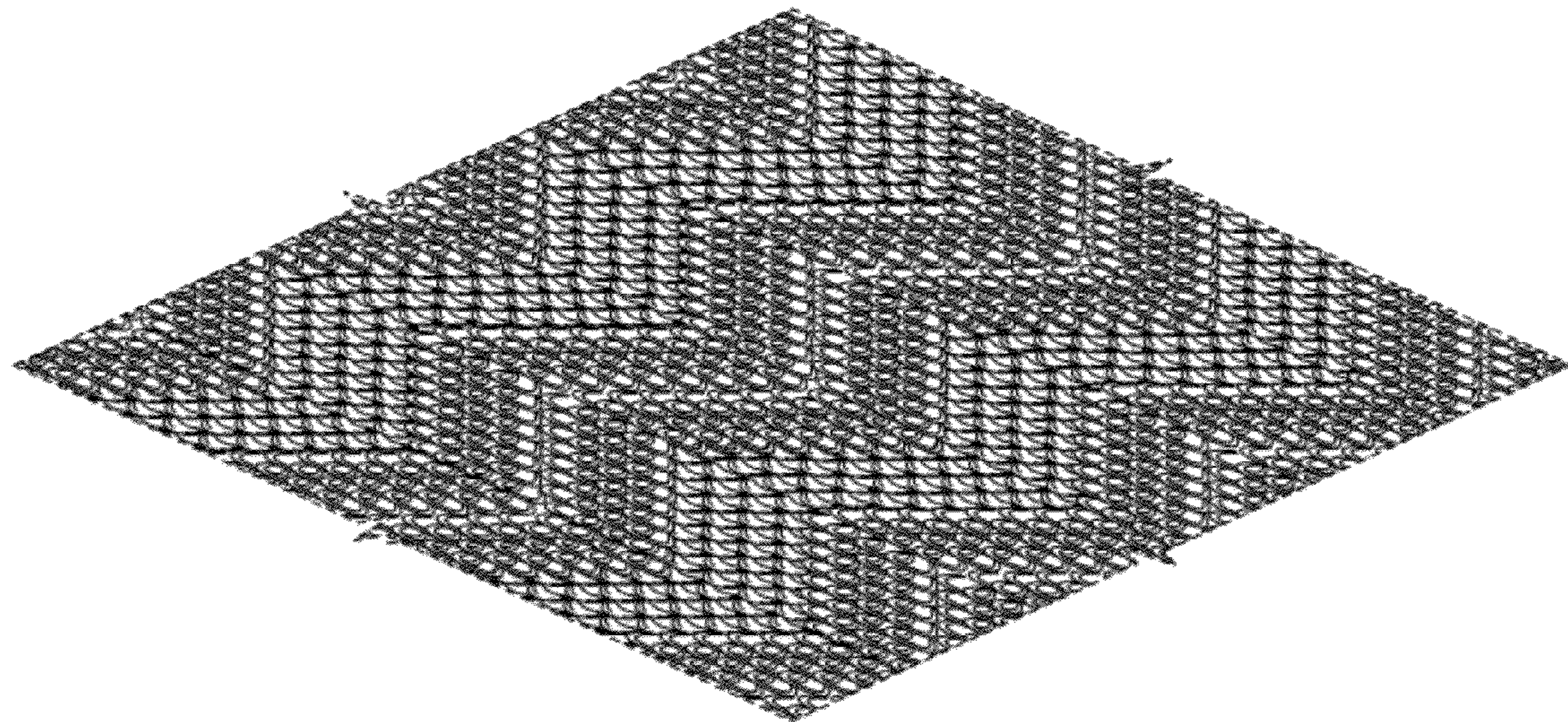
FIG. 5 is a side view in the direction of line 5-5 in FIG. 2;

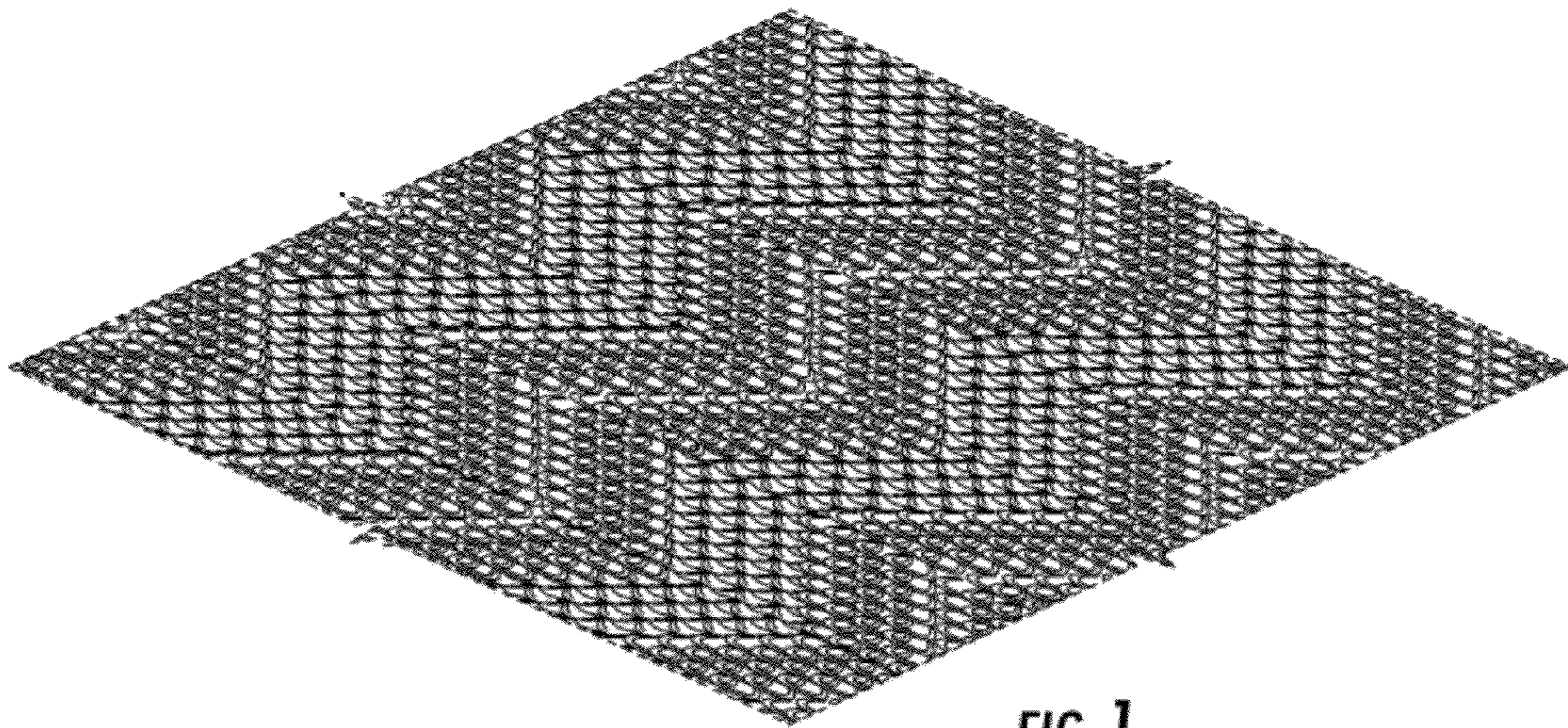

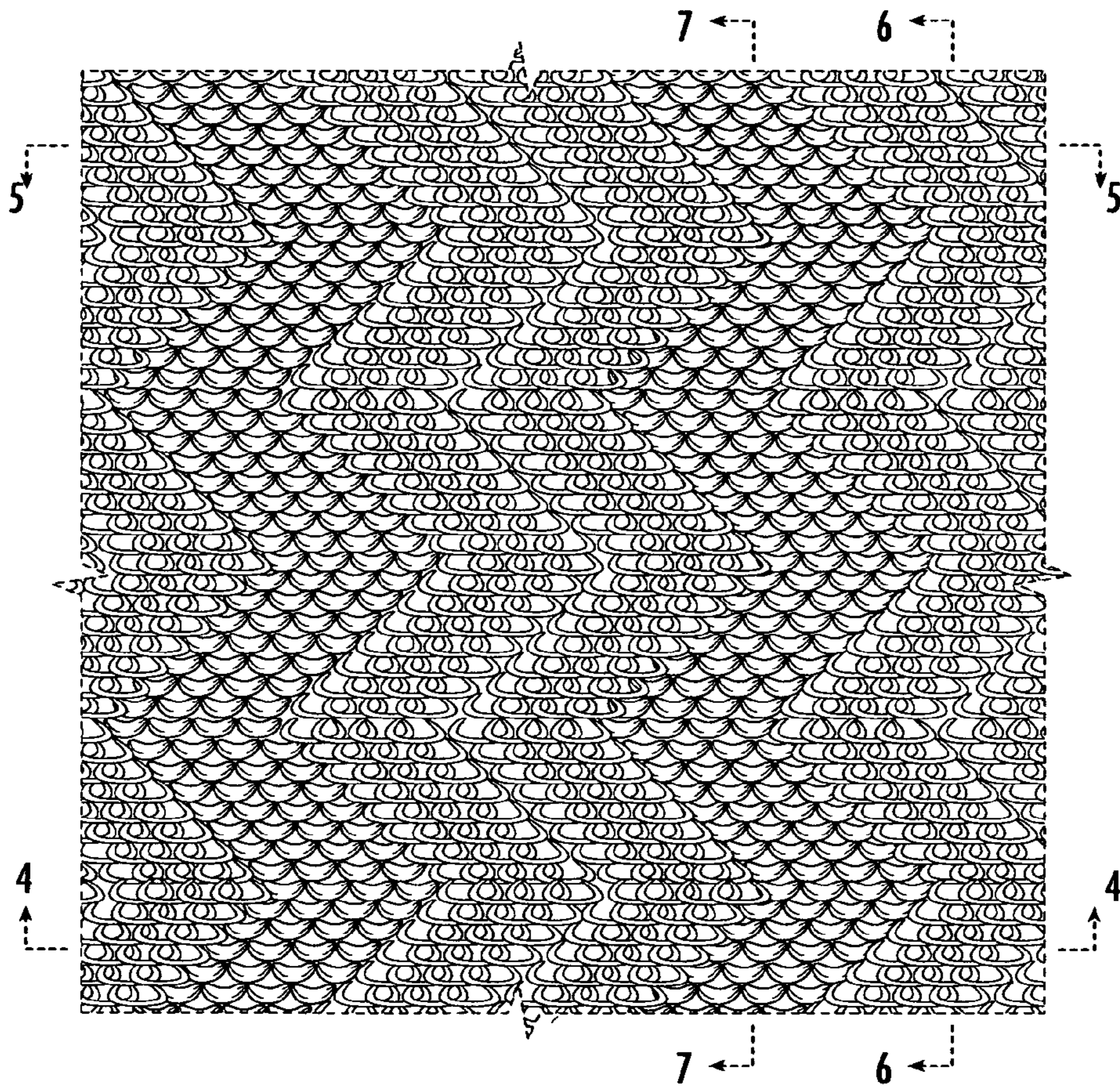

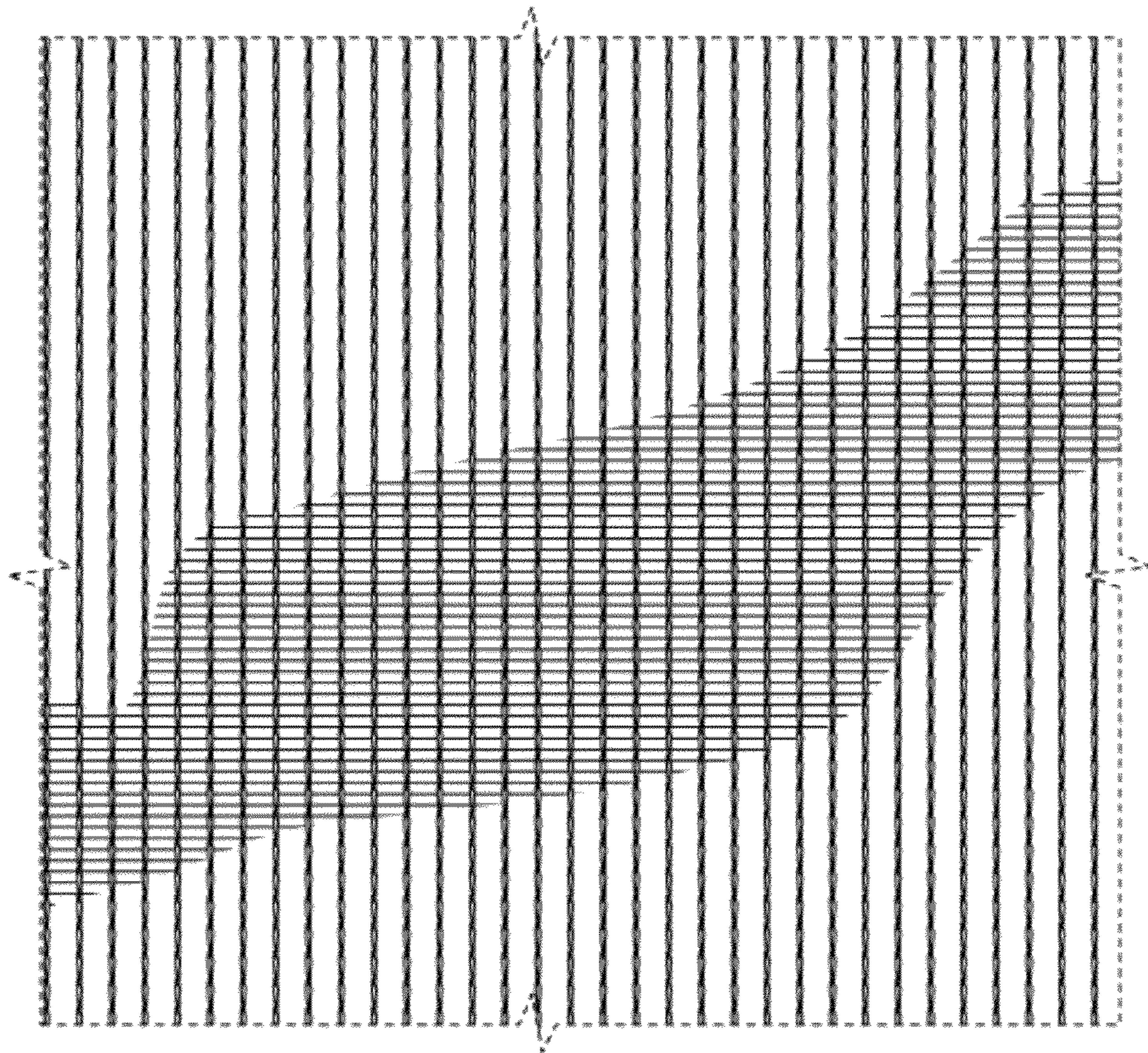
