(57) **CLAIM**

We claim an ornamental design for vented apparel, as shown and described.

DESCRIPTION

FIG. 1 is a back view of a vented apparel showing our new design, where the vents are shown in a closed position;

FIG. 2 is a front view thereof;

FIG. 3 is a left side view thereof;

FIG. 4 is a right side view thereof;

FIG. 5 is a top view thereof;

FIG. 6 is a bottom view thereof;

FIG. 7 is a back view of FIG. 1, where the vents are shown in an opened position;

FIG. 8 is a front view thereof;

FIG. 9 is a left side view thereof;

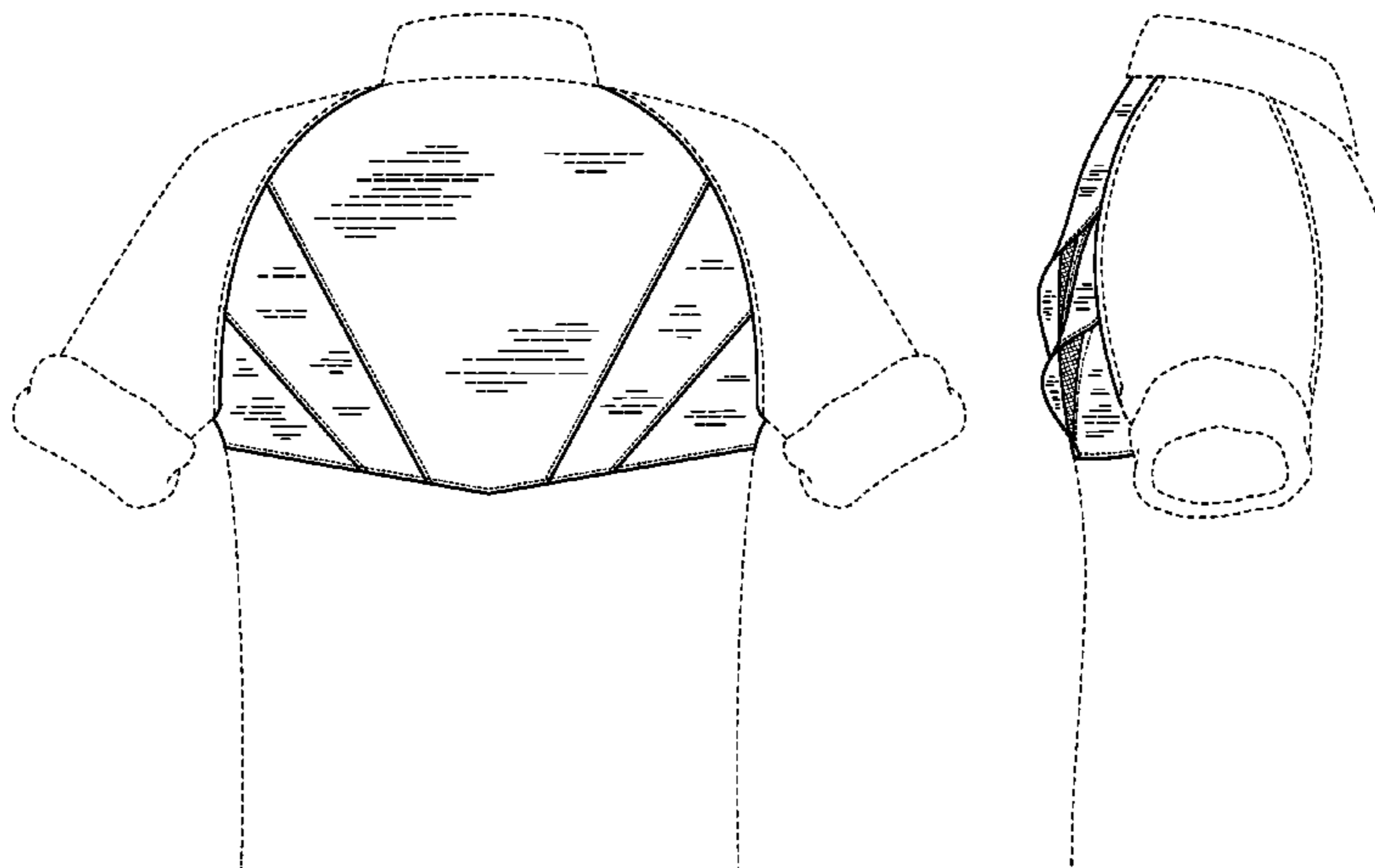
FIG. 10 is a right side view thereof;

FIG. 11 is a top view thereof; and,

FIG. 12 is a bottom view thereof.

The large broken lines showing portions of a vented apparel are included for illustrating environmental structure and form no part of the claimed design. The small dashed lines indicate unclaimed stitching.

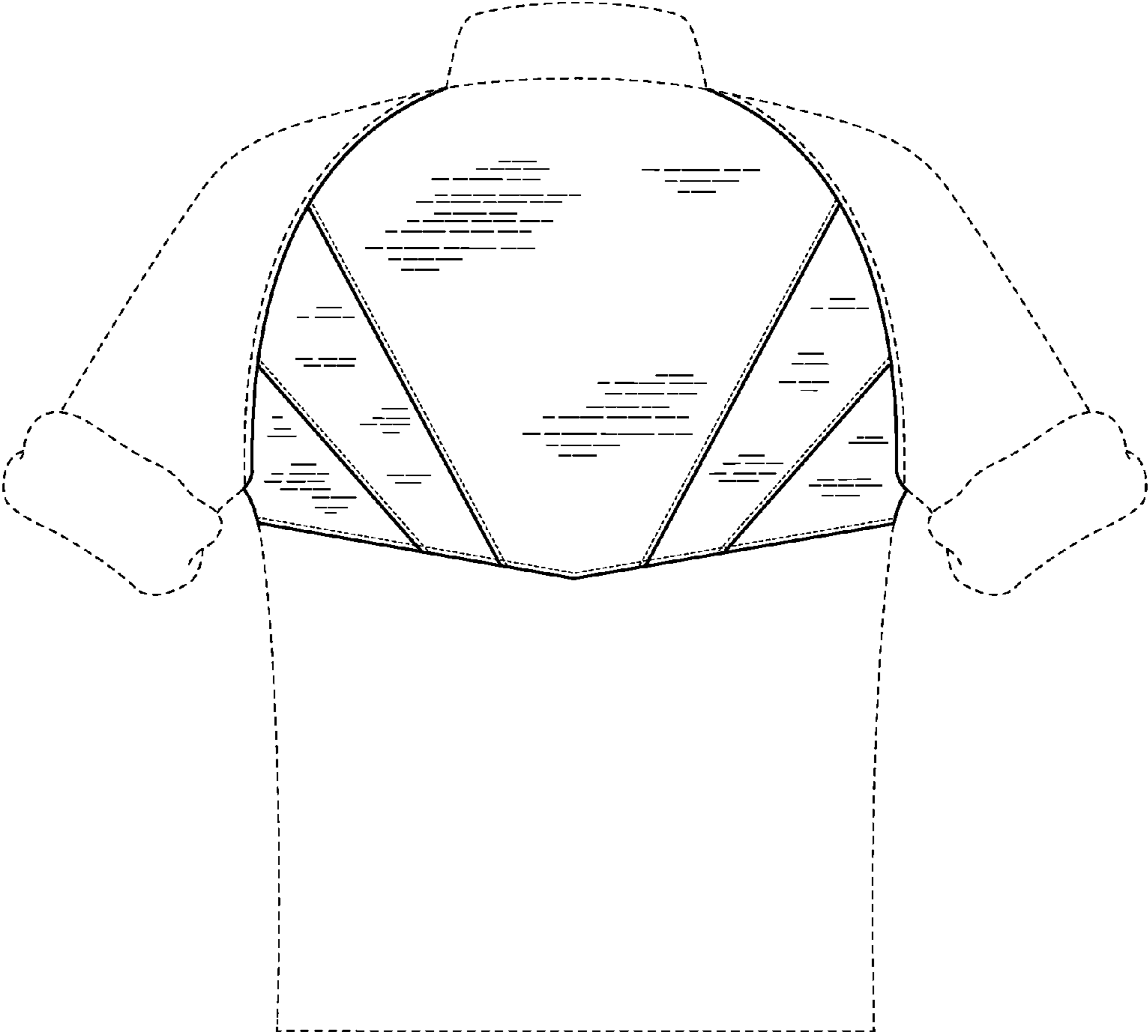

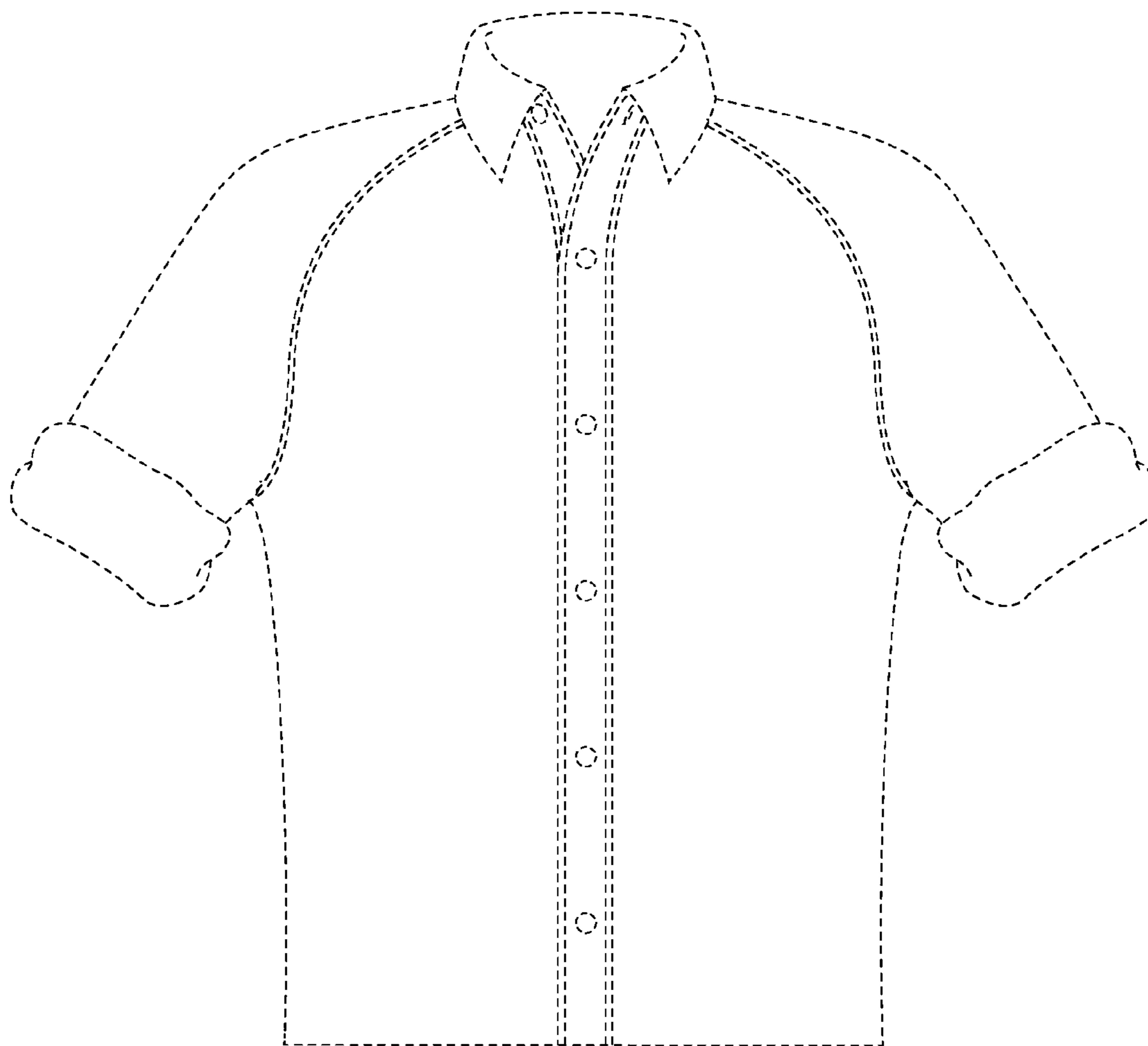

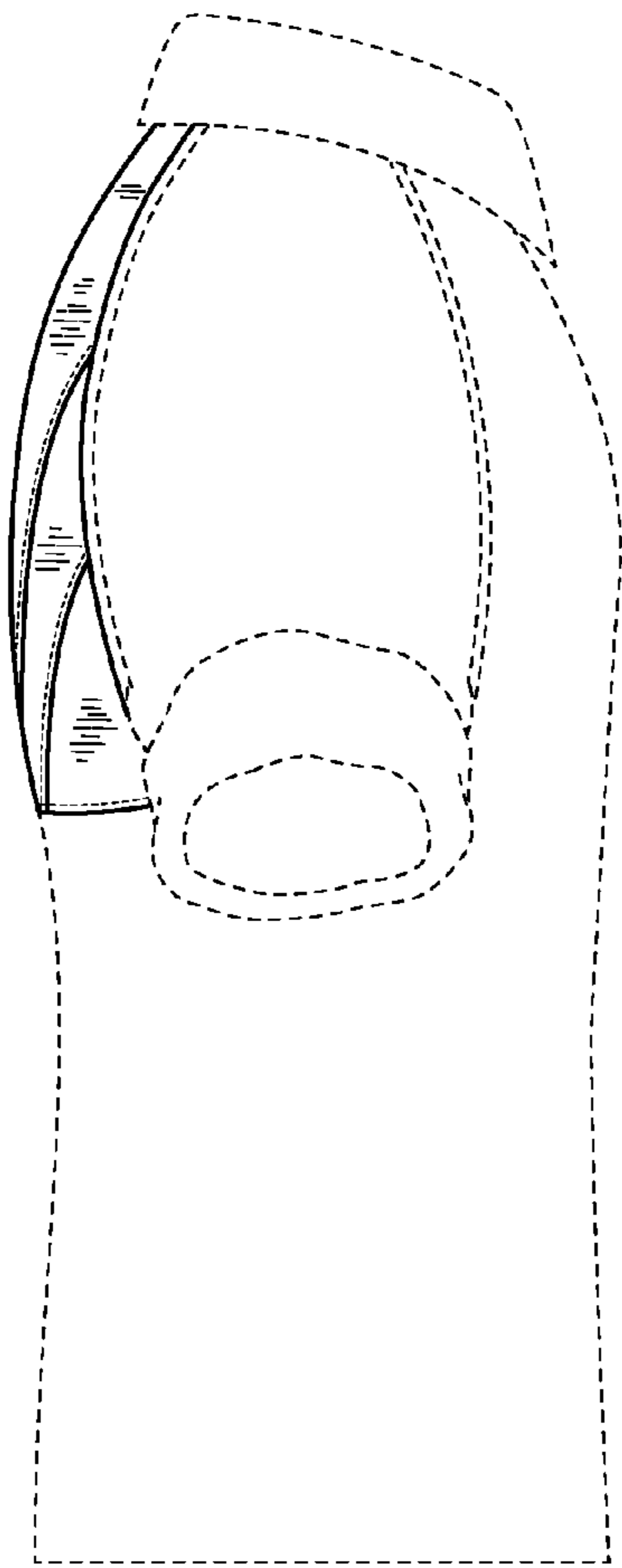

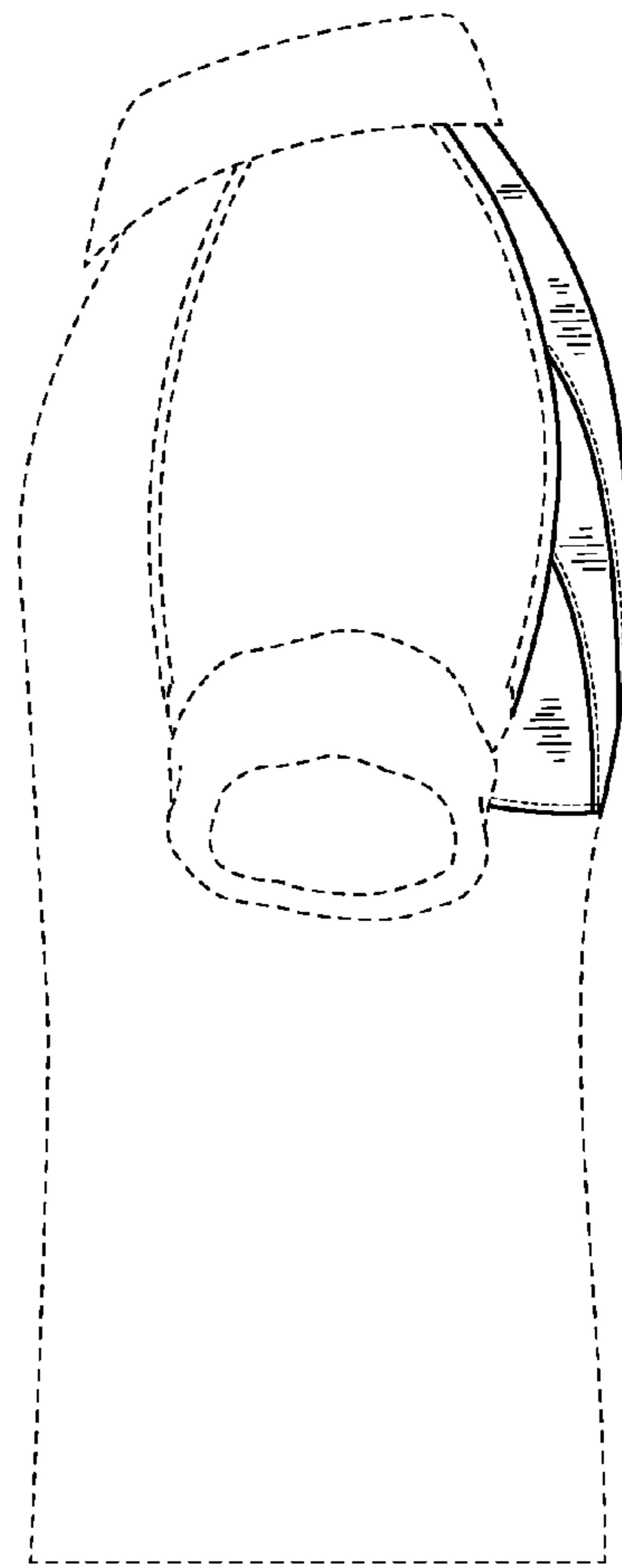

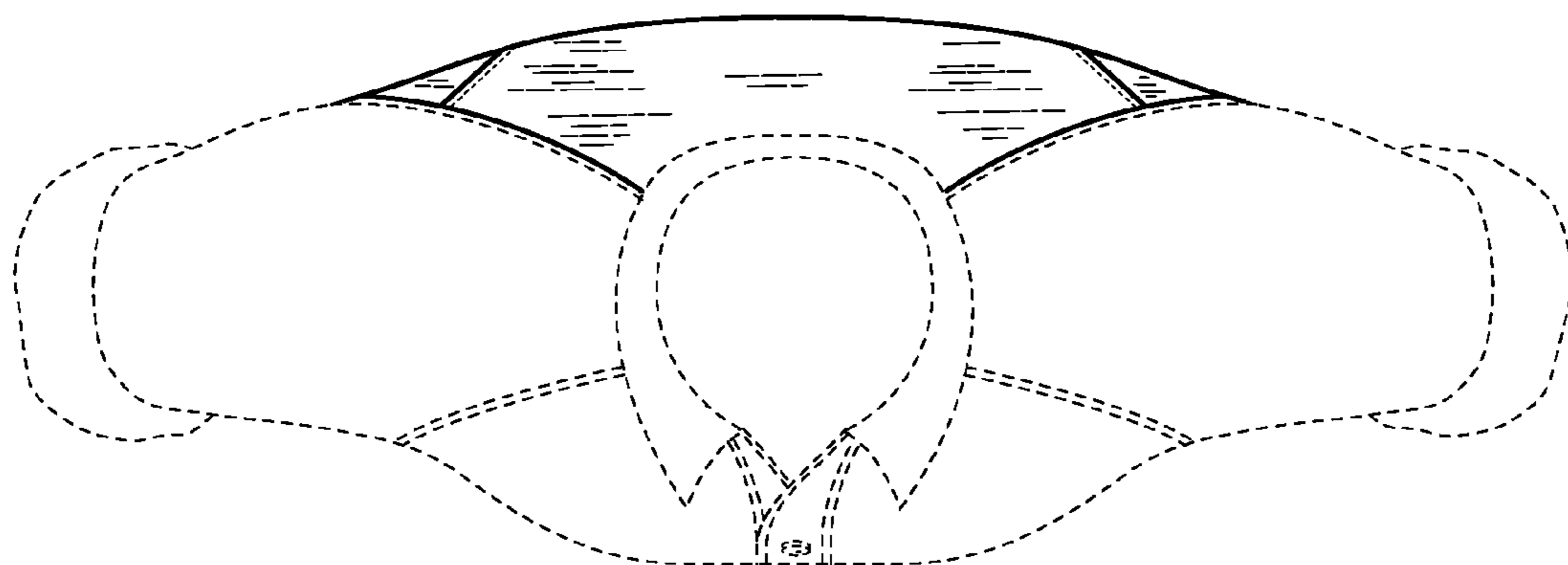

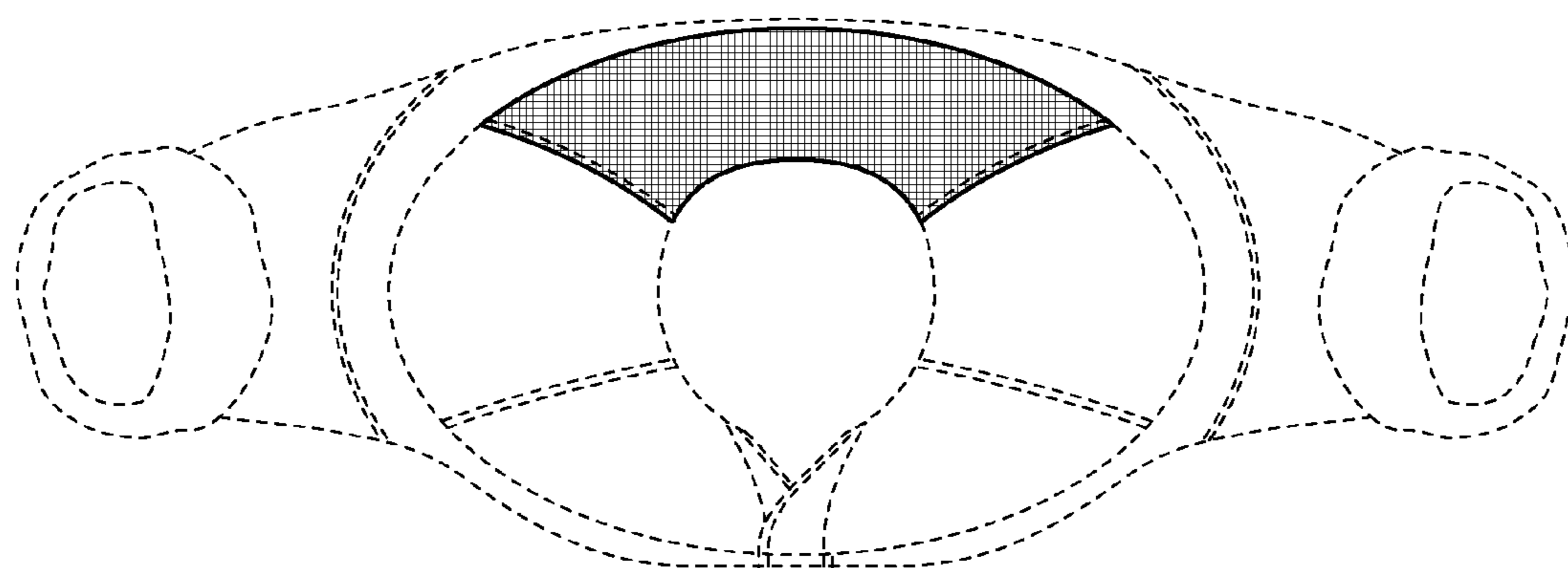

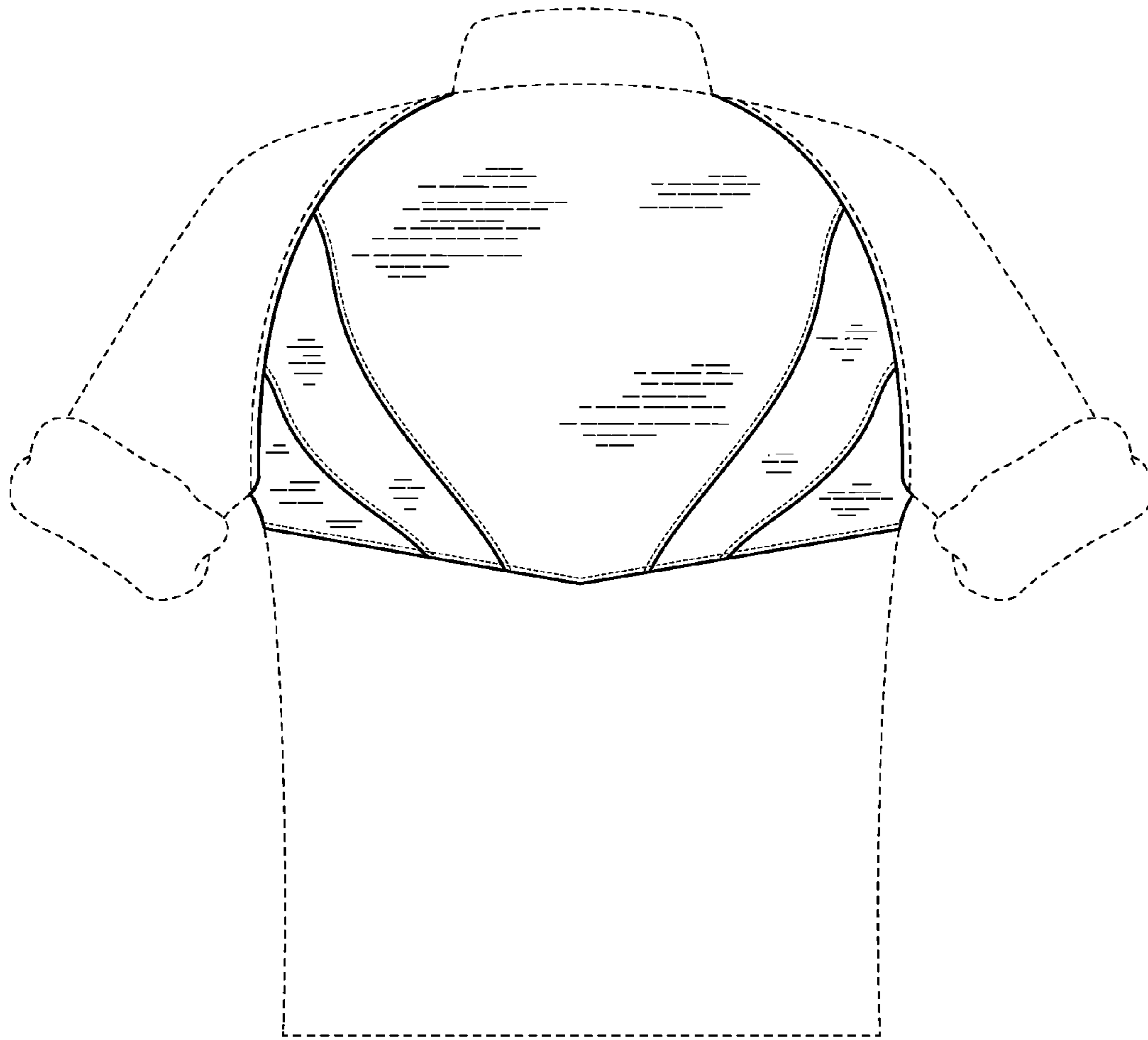

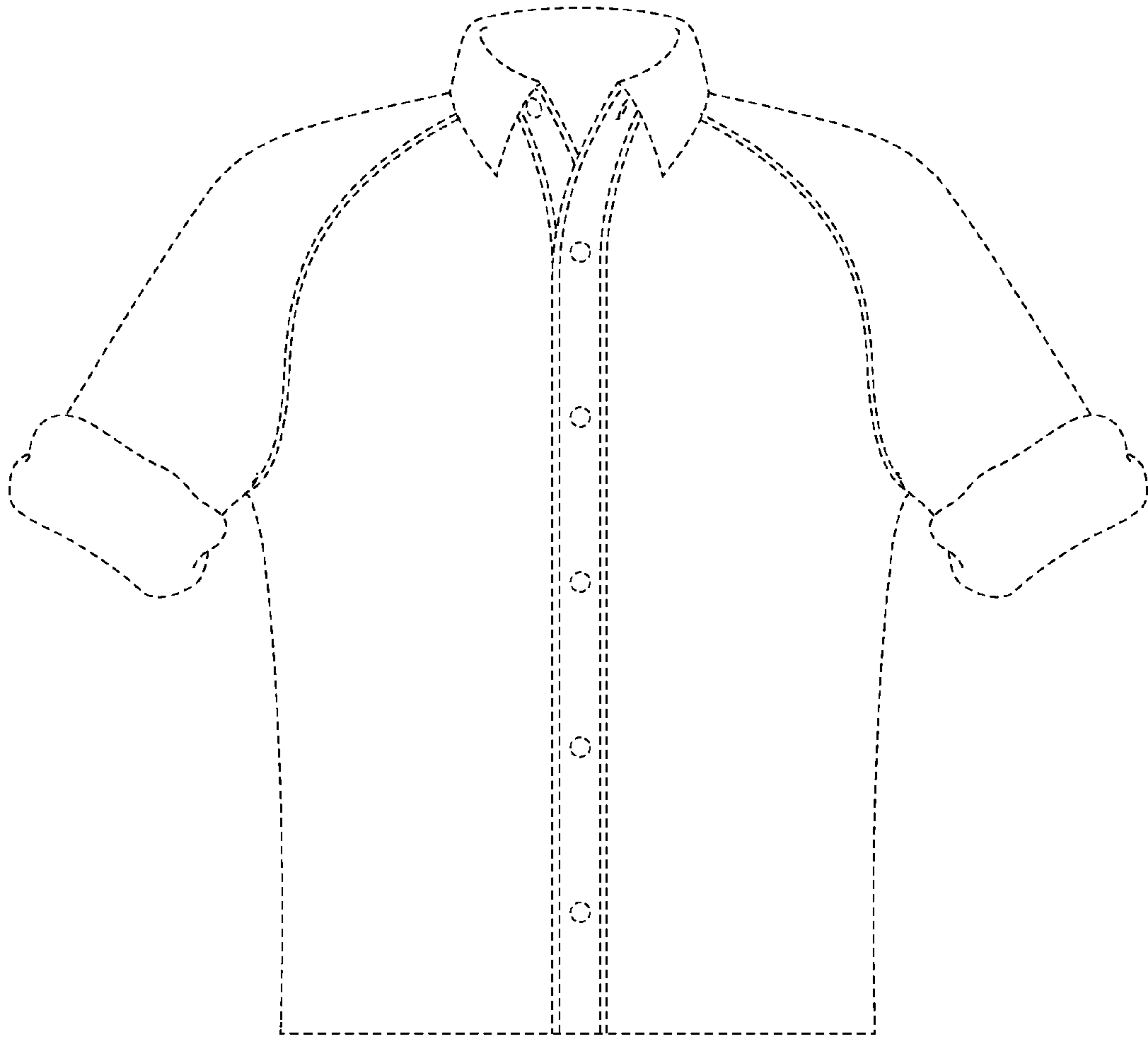

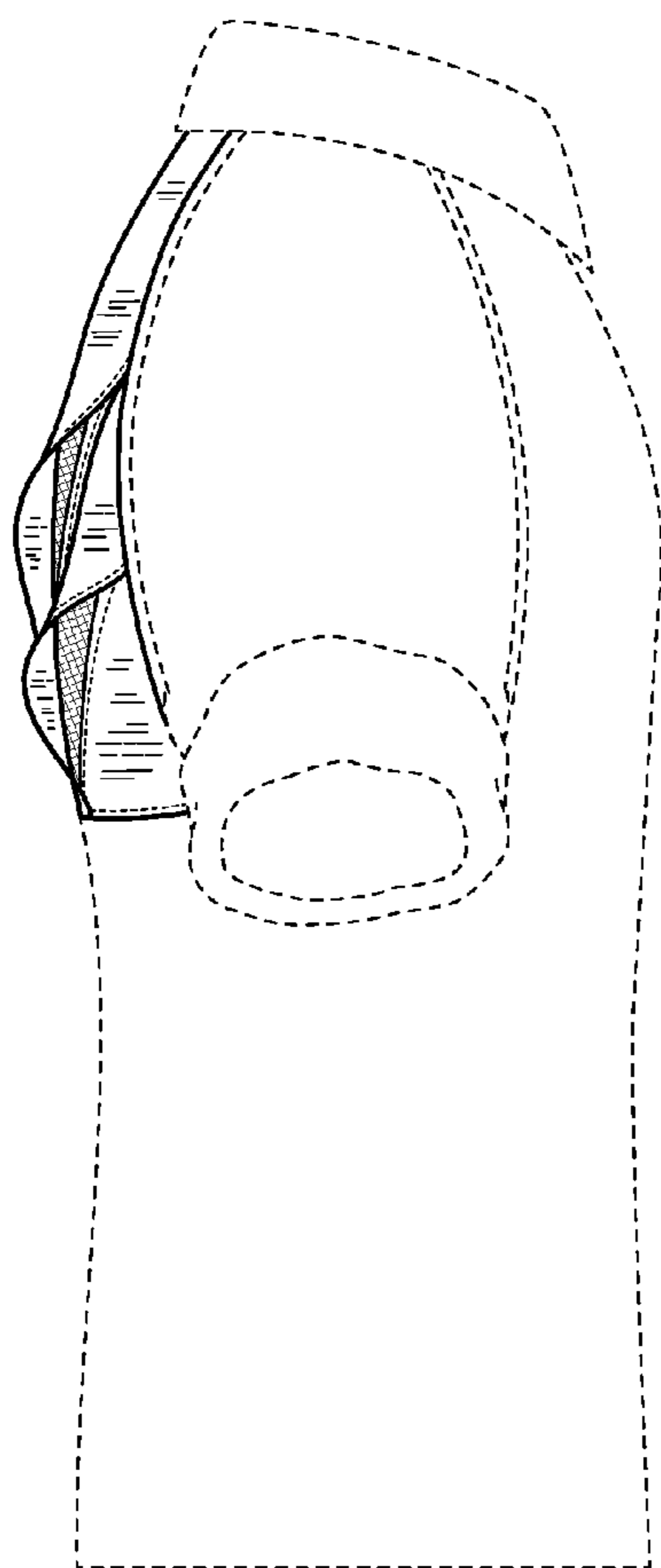

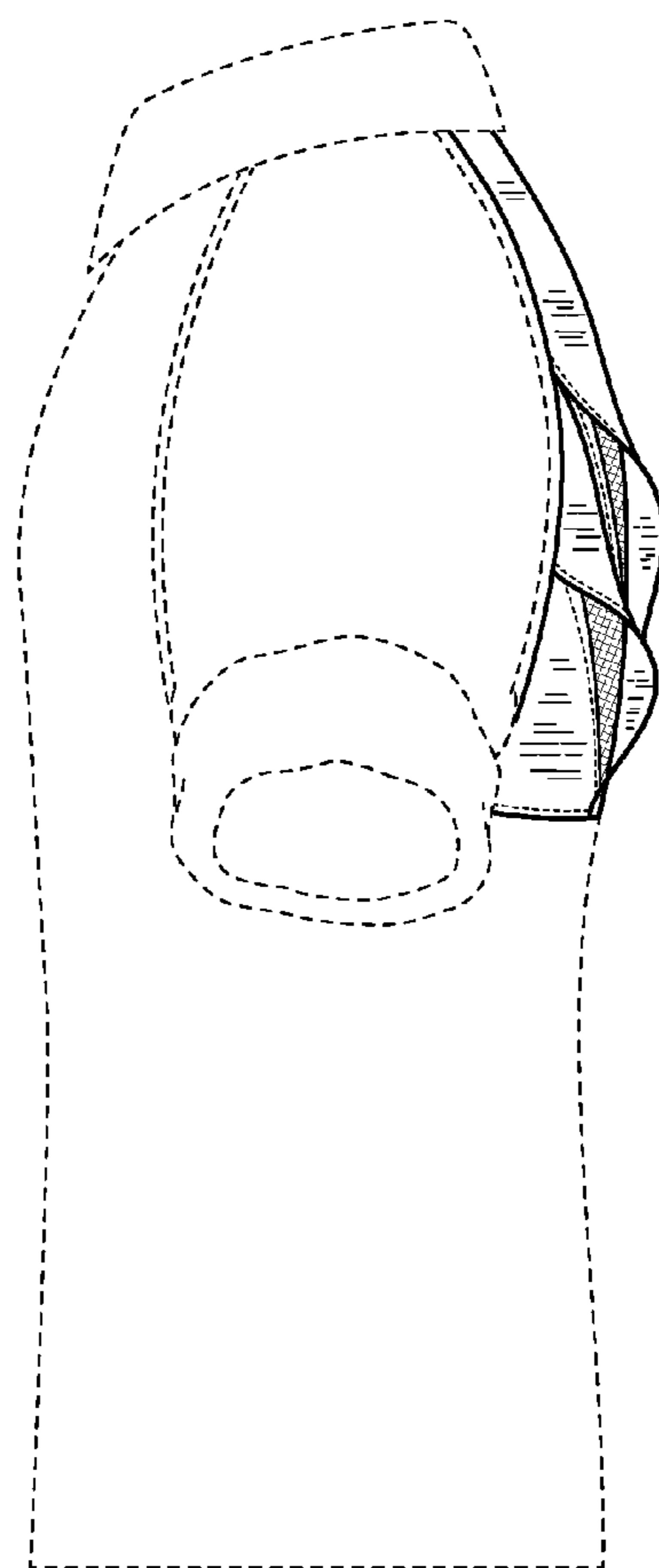

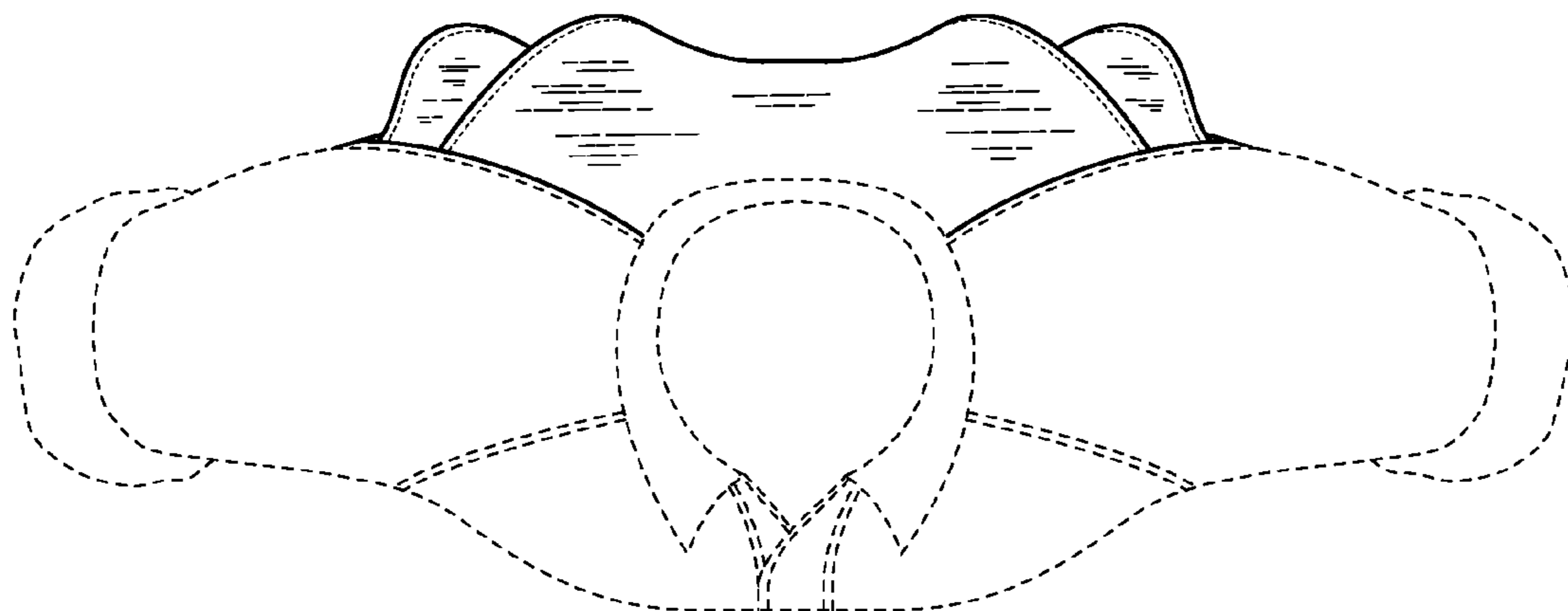

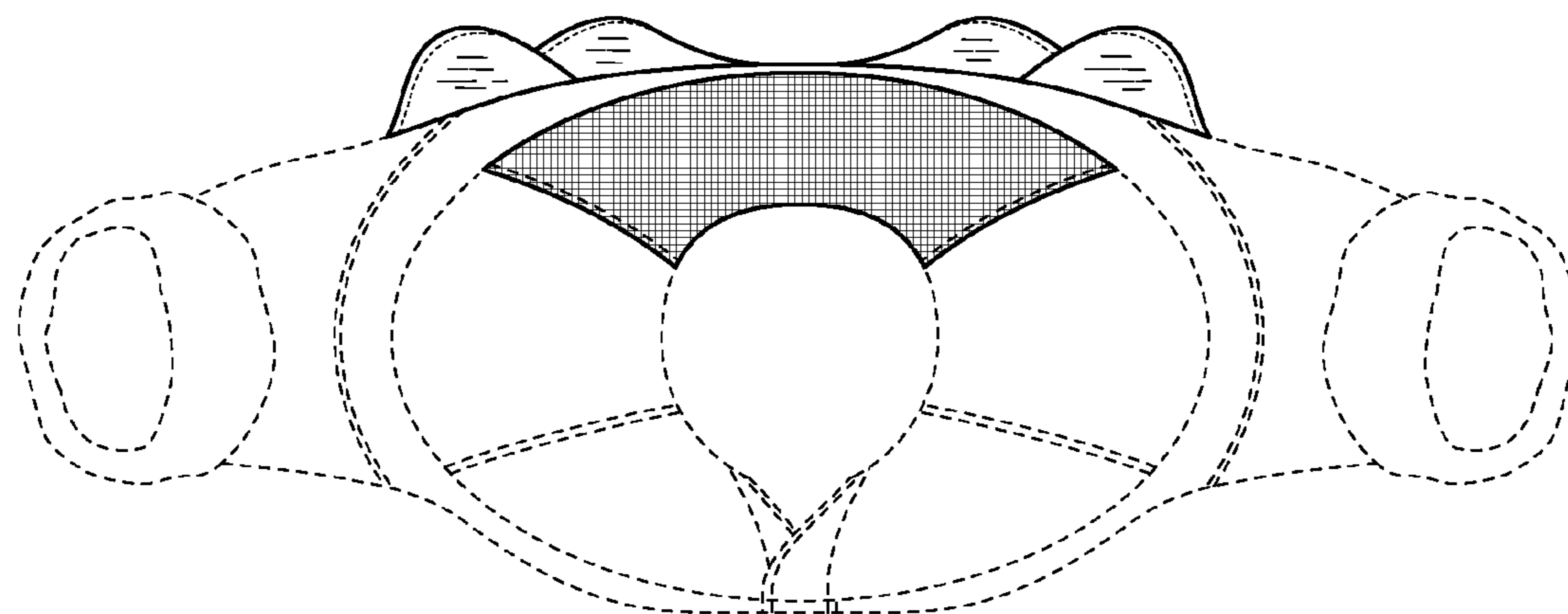
