DESCRIPTION

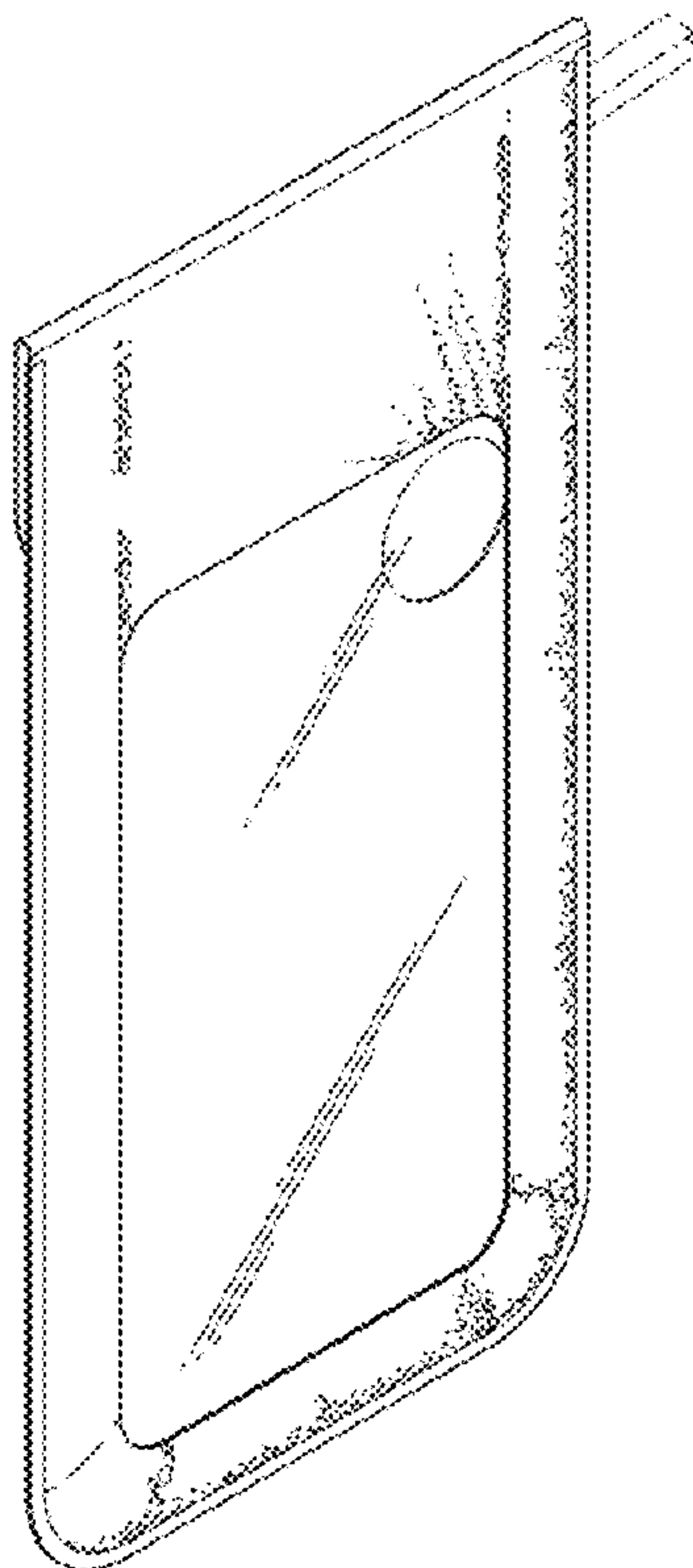
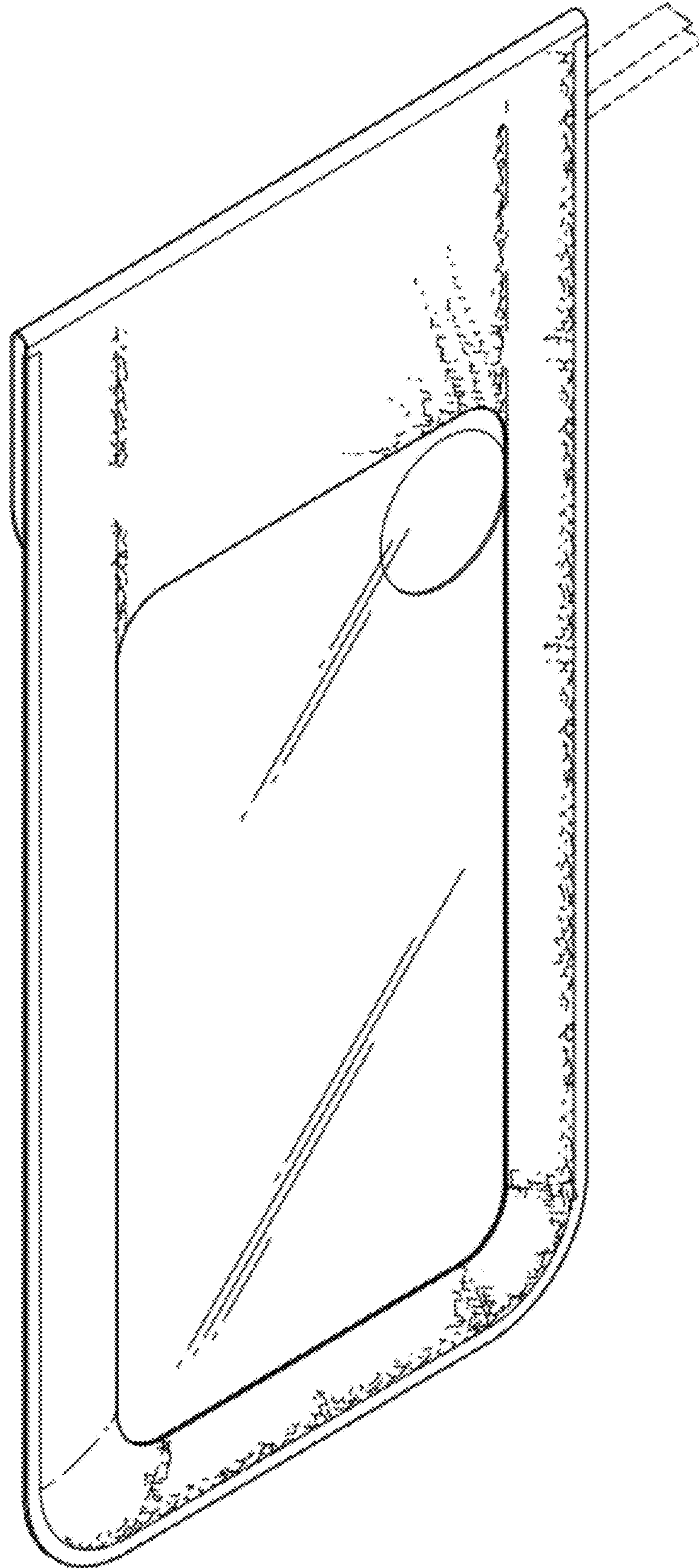

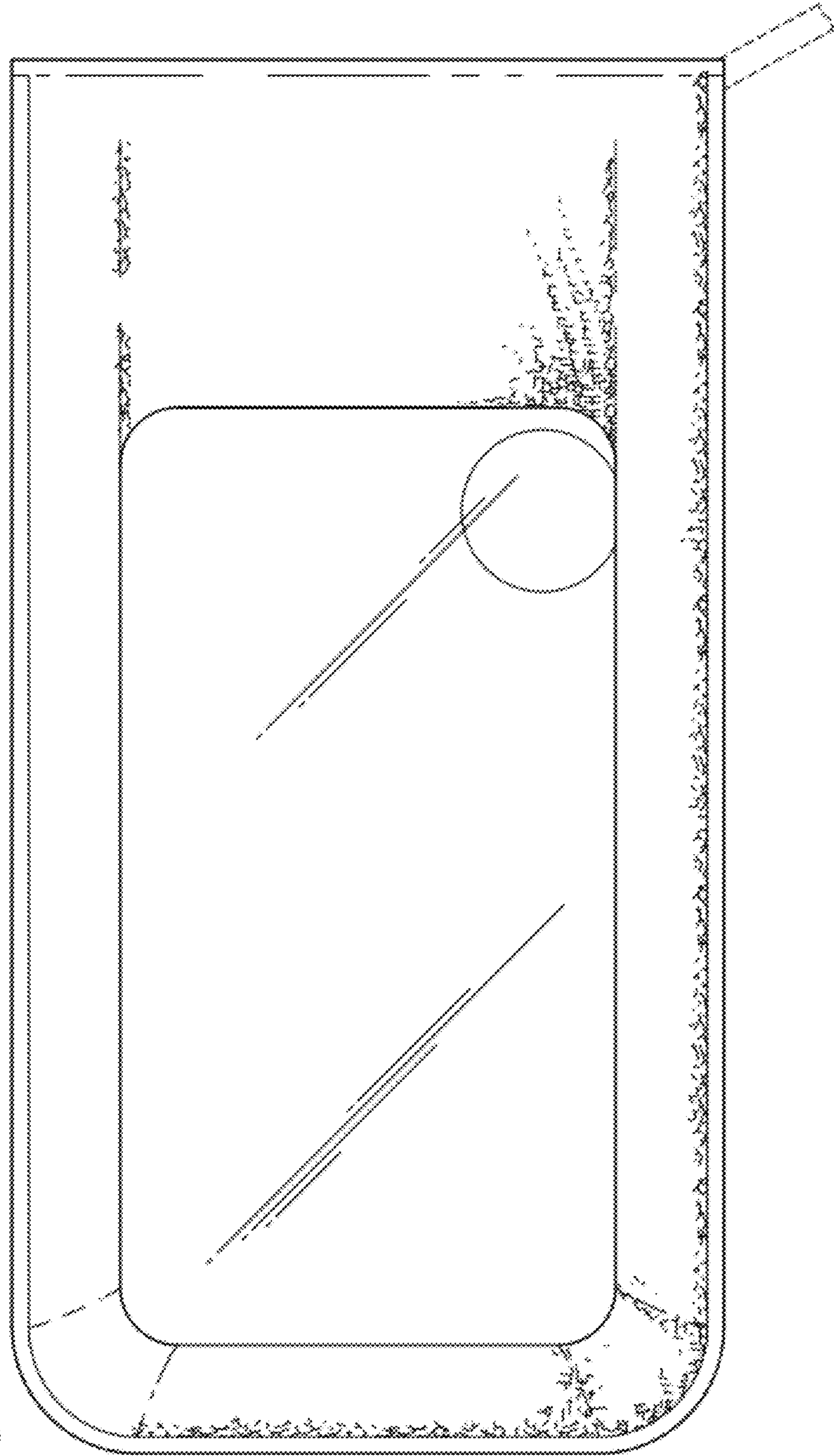

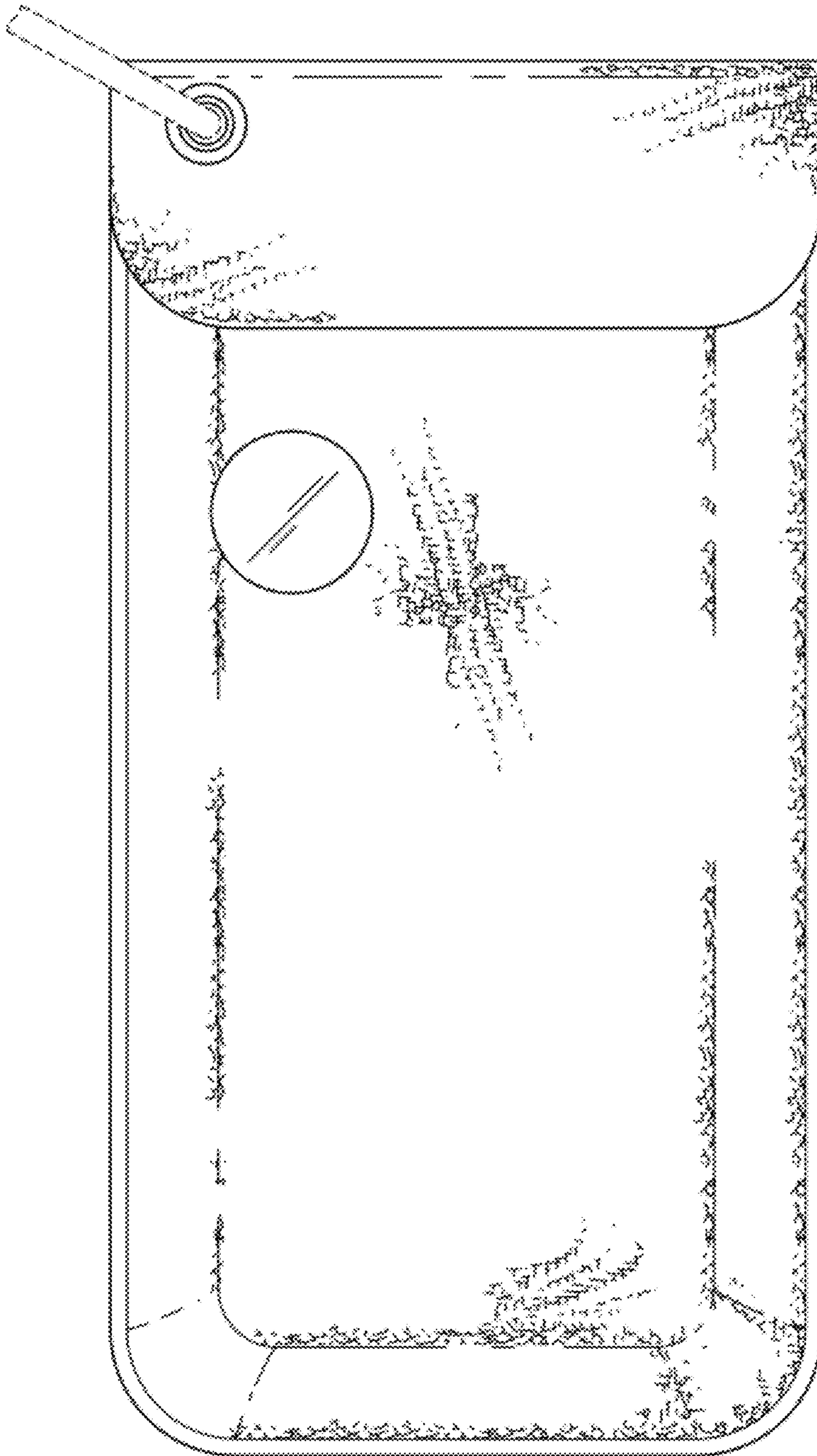

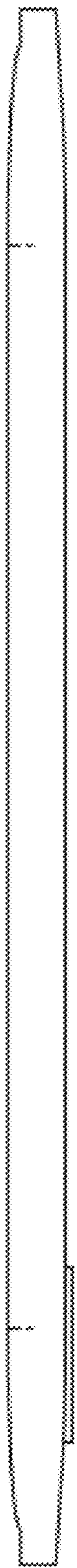

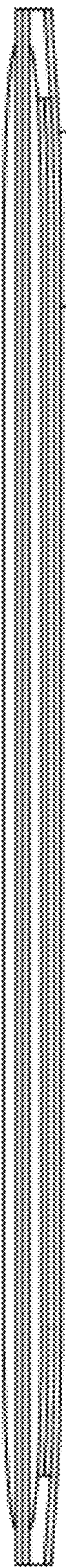

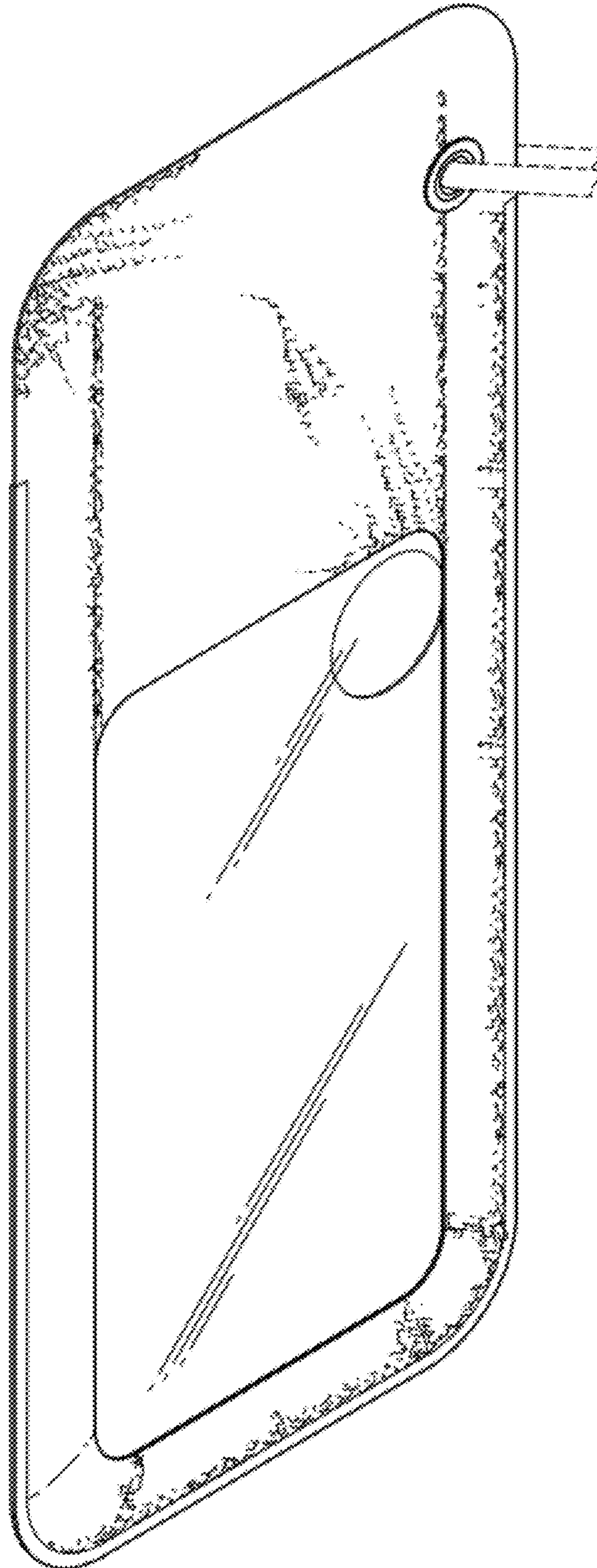

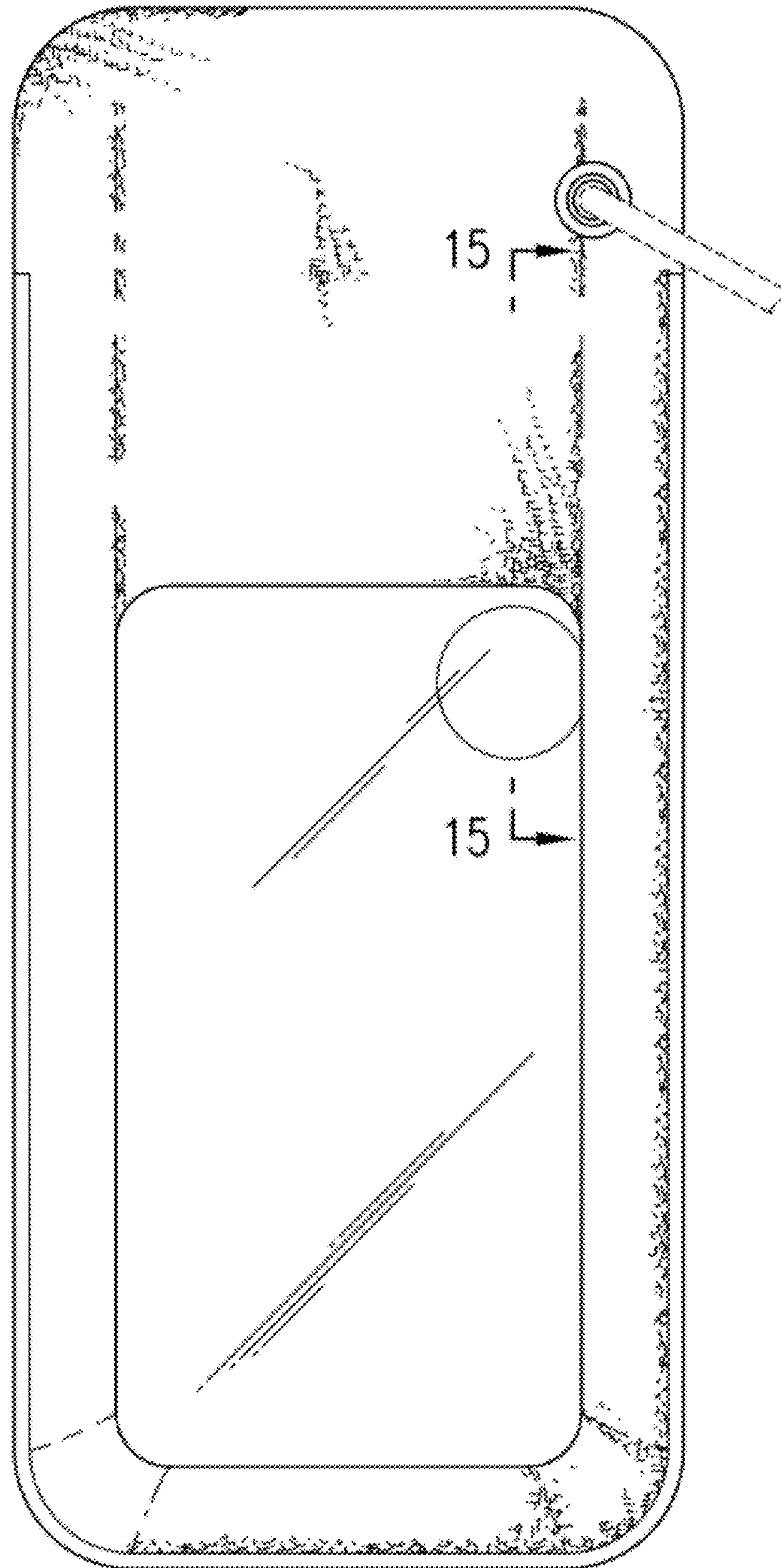

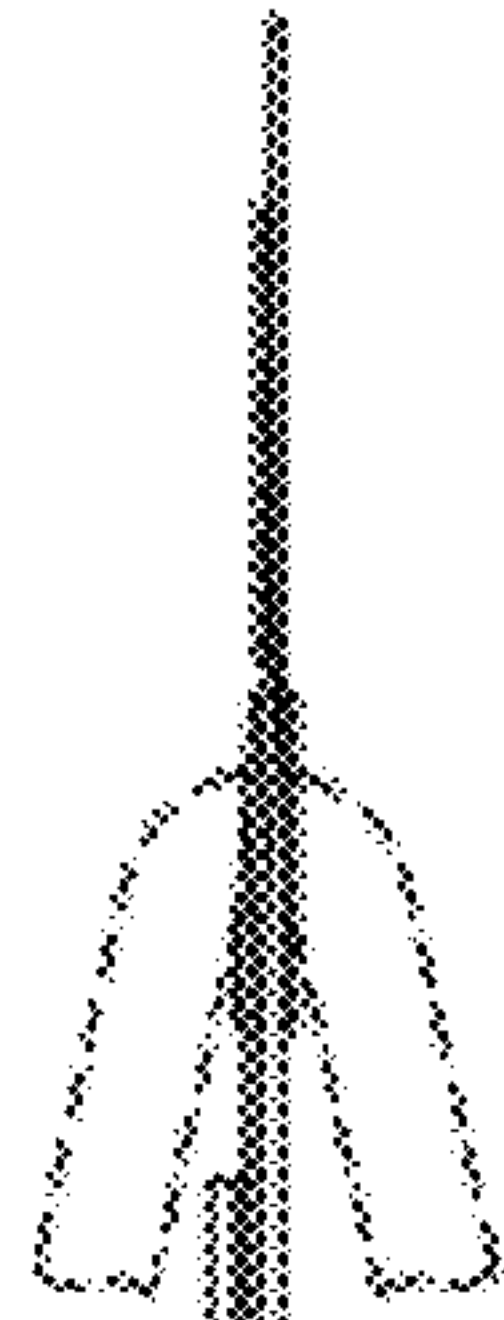

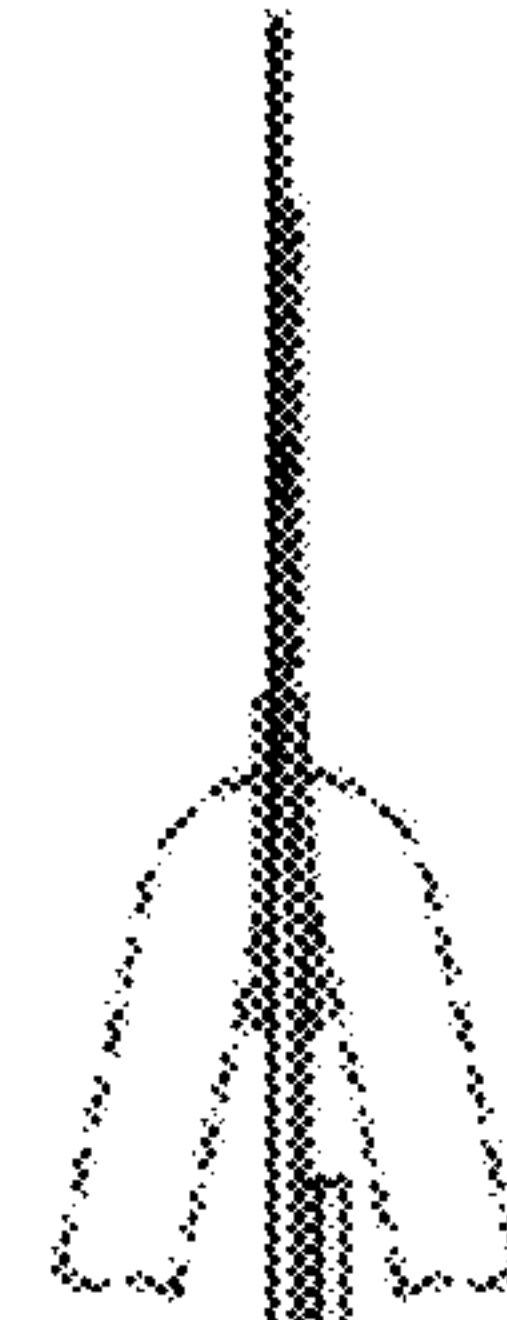

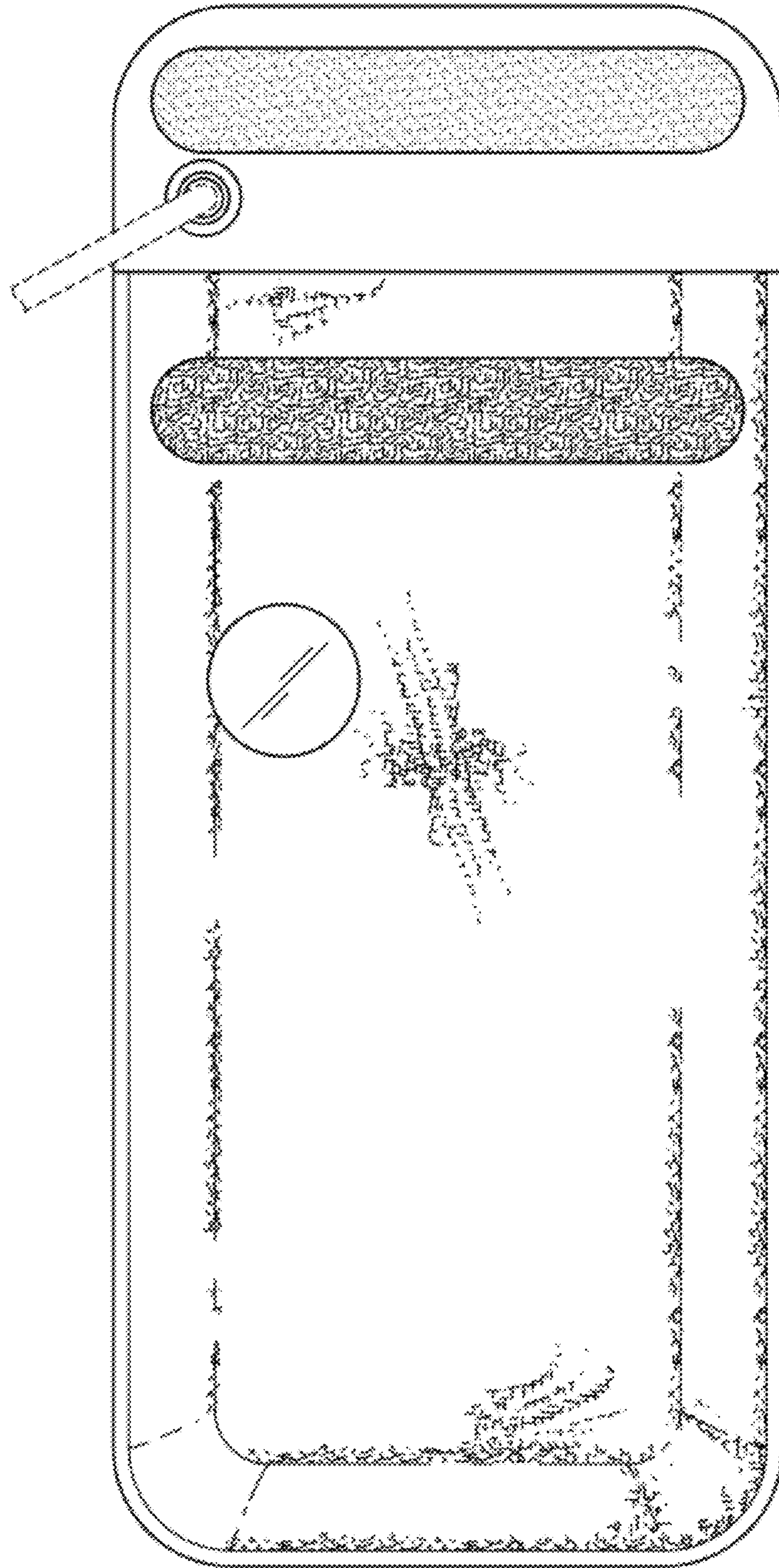

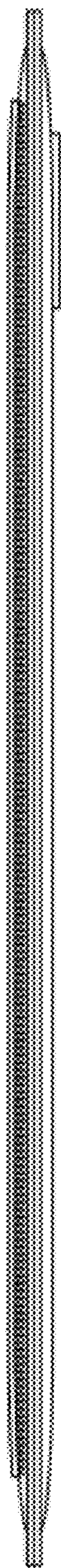

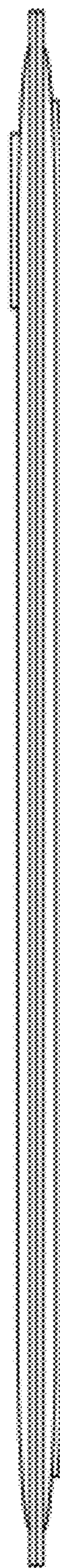

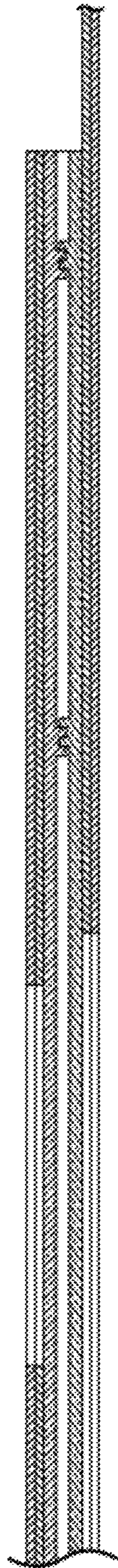
