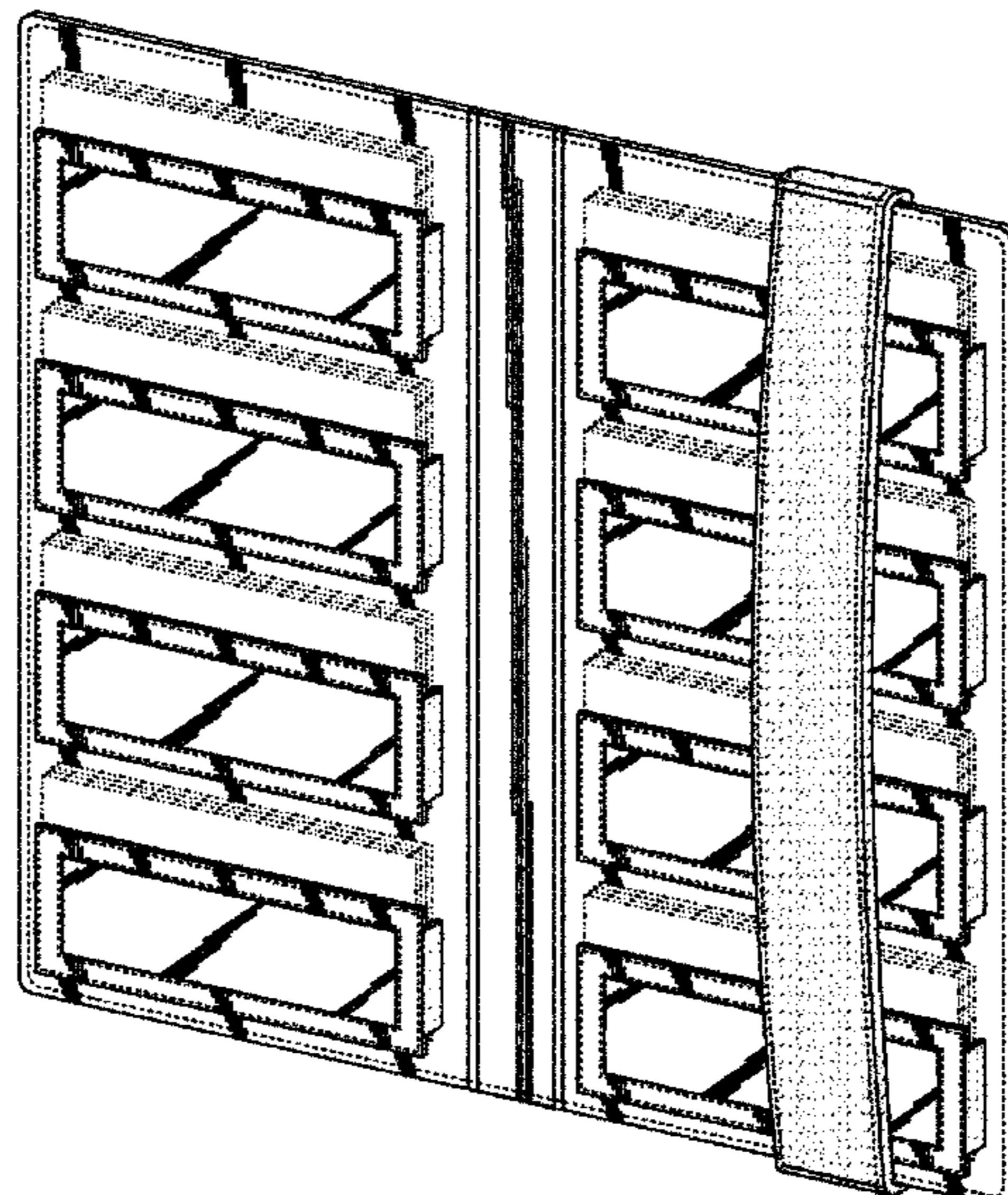
(57) **CLAIM**

The ornamental design for a multiple business card holder
having an elastic closure strap, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a multiple business card holder having an elastic closure strap;
 FIG. 2 is a front elevational view thereof;
 FIG. 3 is a back elevational view thereof;
 FIG. 4 is a left side elevational view thereof;
 FIG. 5 is a right side elevational view thereof;
 FIG. 6 is a top plan view thereof;
 FIG. 7 is a bottom plan view thereof;
 FIG. 8 is a front perspective view of the multiple business card holder having an elastic closure strap in a closed position showing the elastic closure strap stretched to fit around the outside of the closed business card holder.
 FIG. 9 is a front perspective view of the multiple business card holder having an elastic closure strap, the strap being partially removed to show all of the card holder pockets; and,
 FIG. 10 is a front elevational view of the multiple business card holder having an elastic closure strap, the elastic closure strap being partially removed to show all of the card holder pockets.
 The broken line showing of multiple business cards in pockets is included for purpose of illustrating environment and forms no part of the claimed design.
 The broken line showing of the stitching shown as a perimeter around the base of the card holder, the individual card holder pockets, and the strap is part of the claimed design.

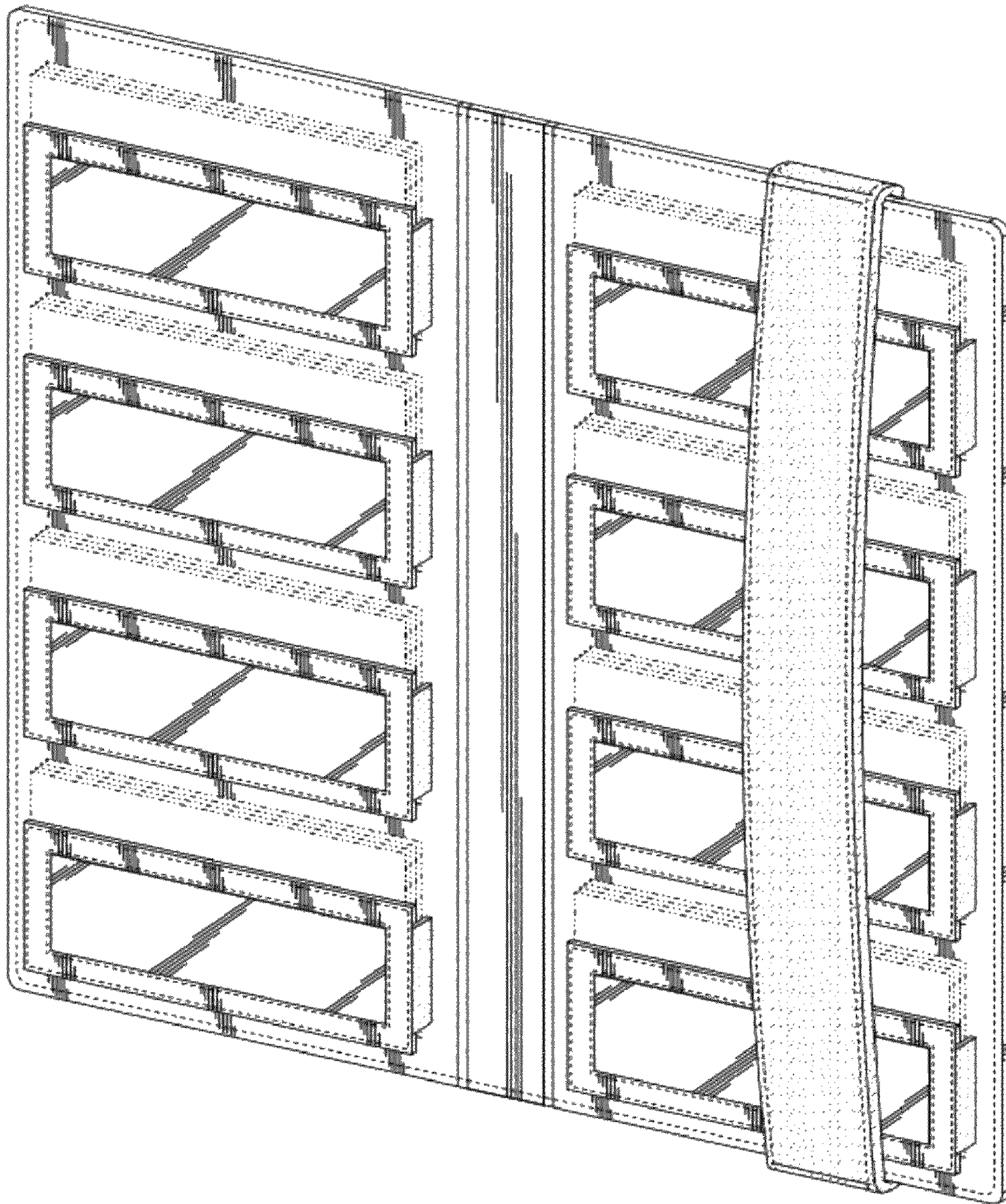

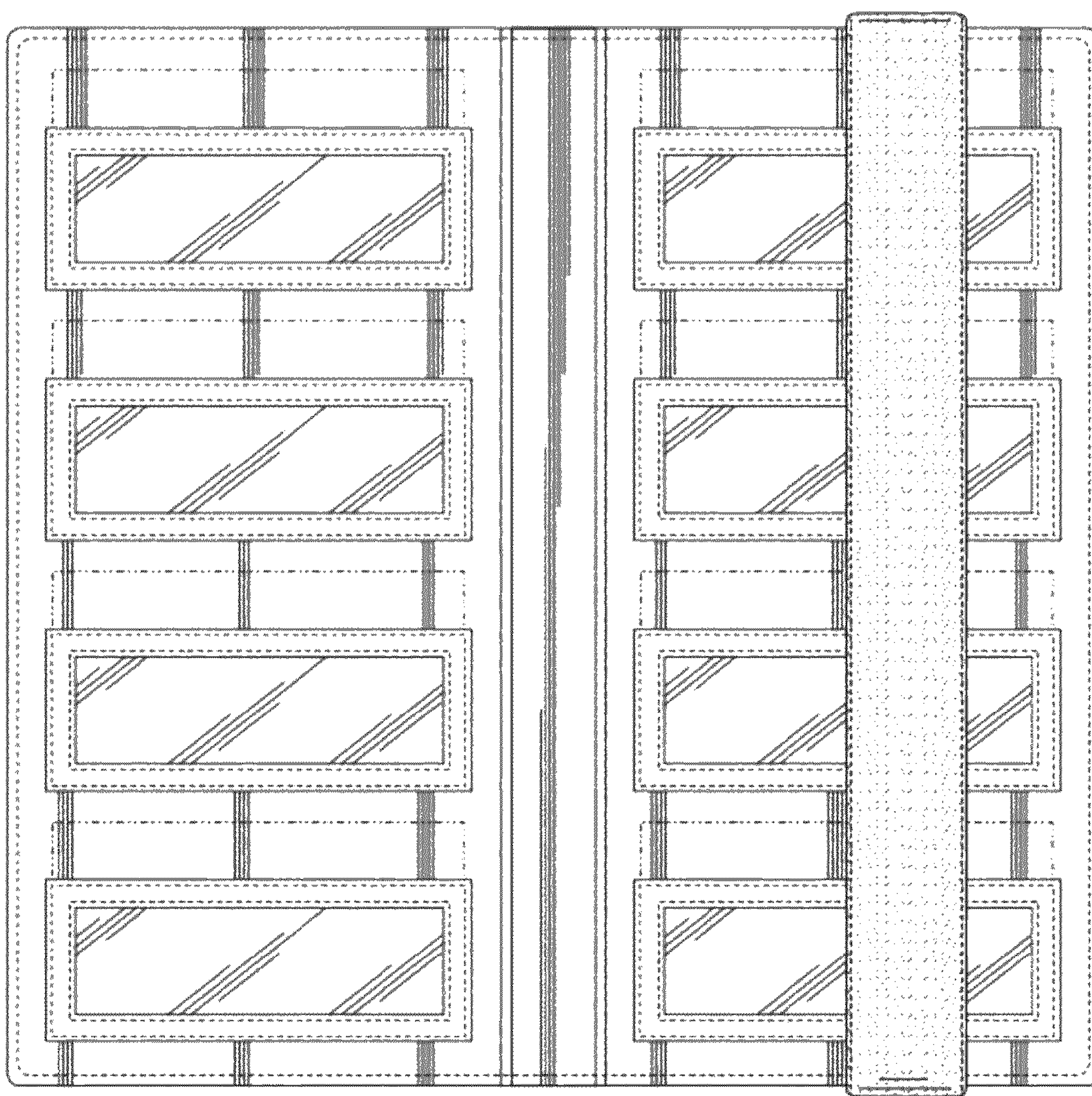

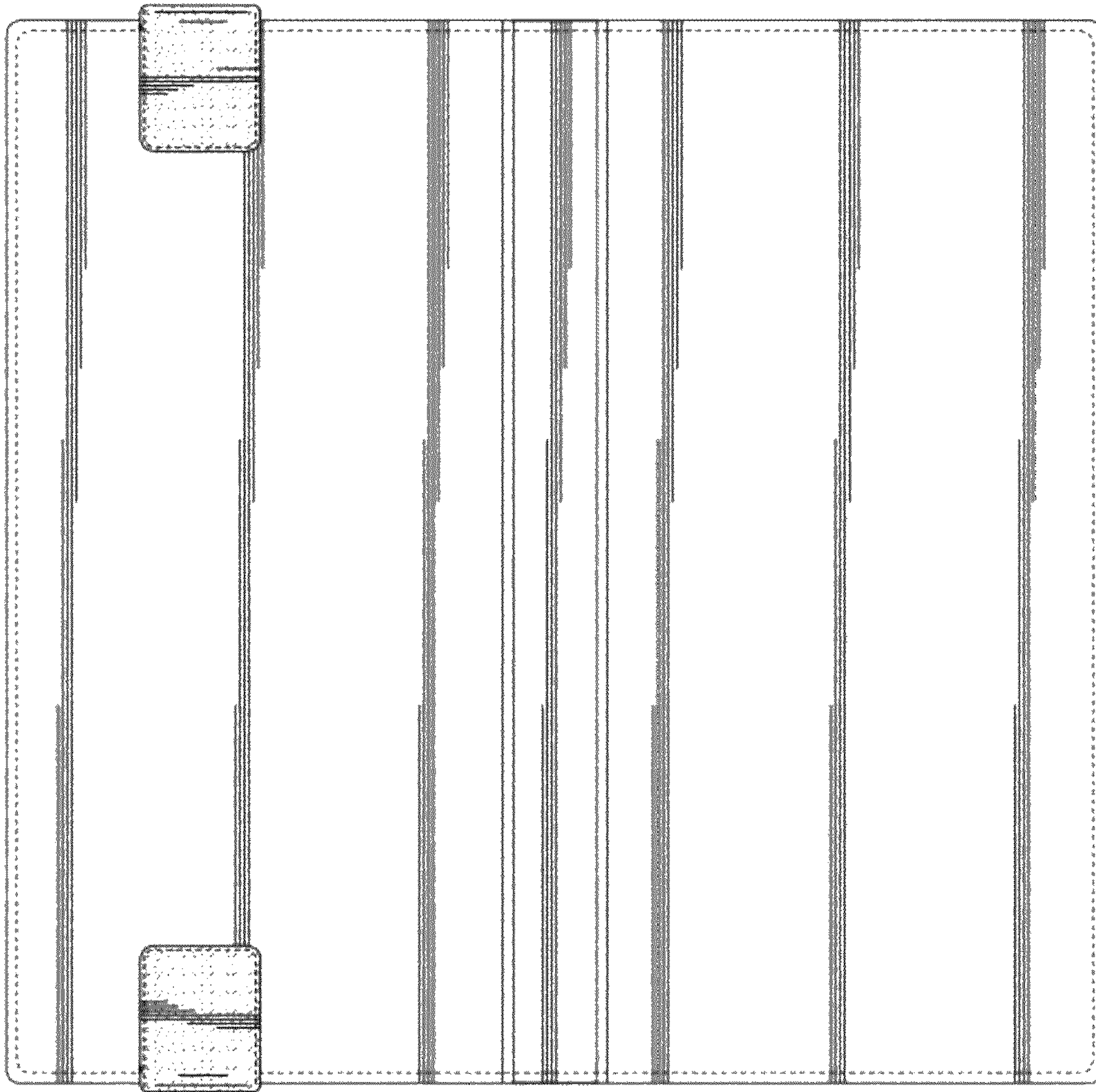

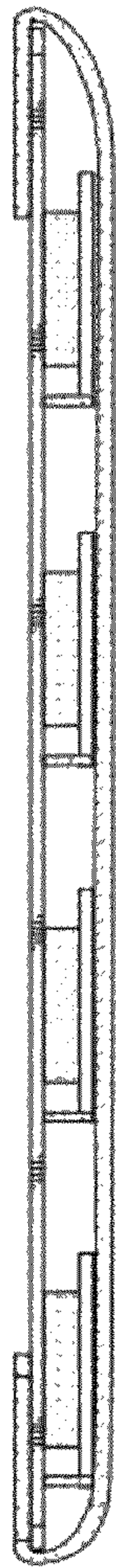

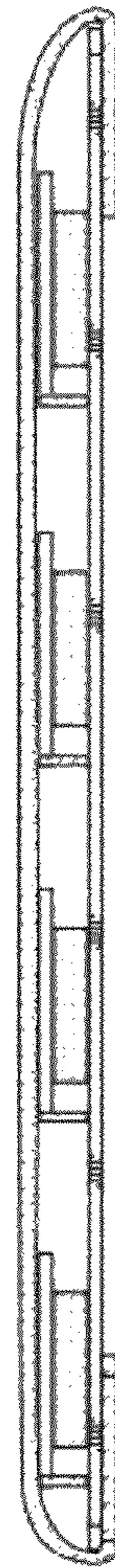

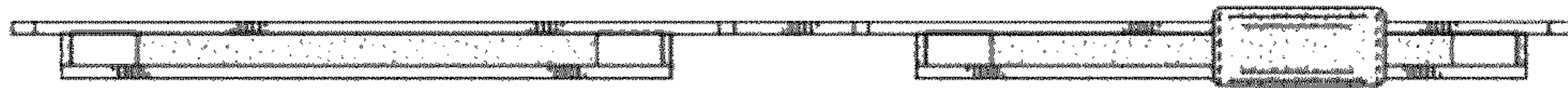

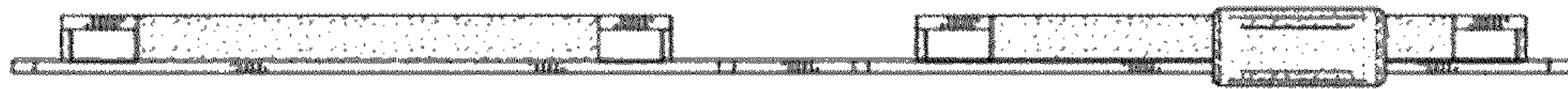

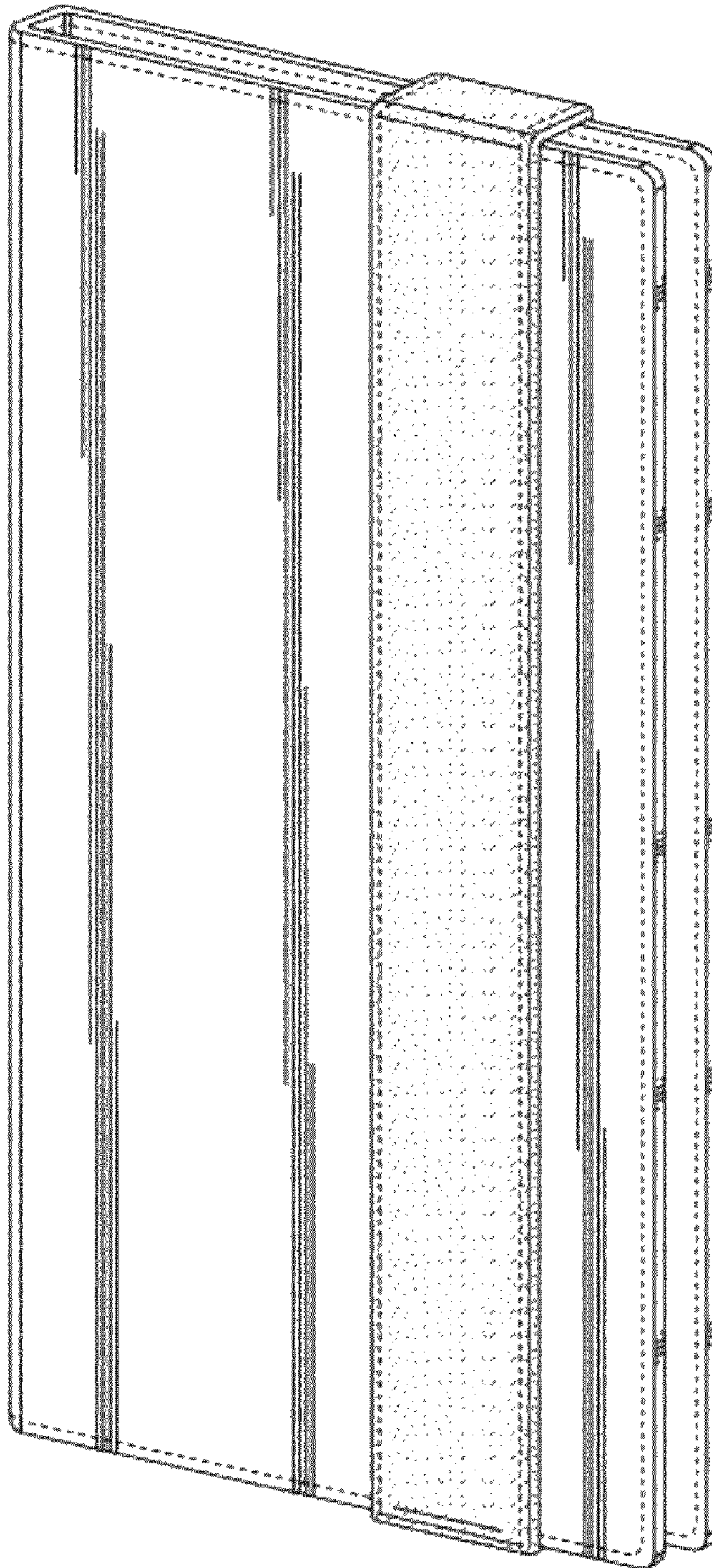

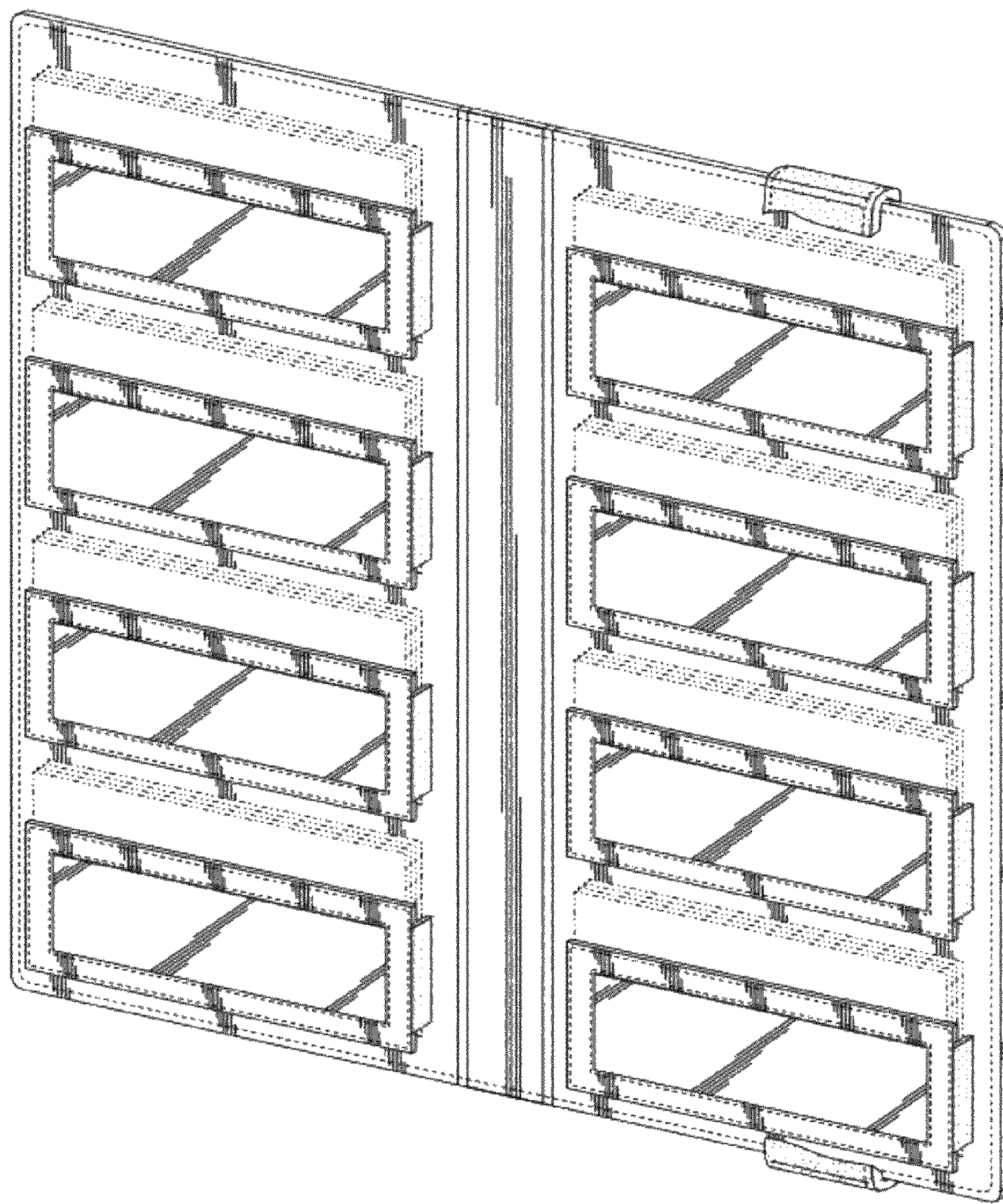

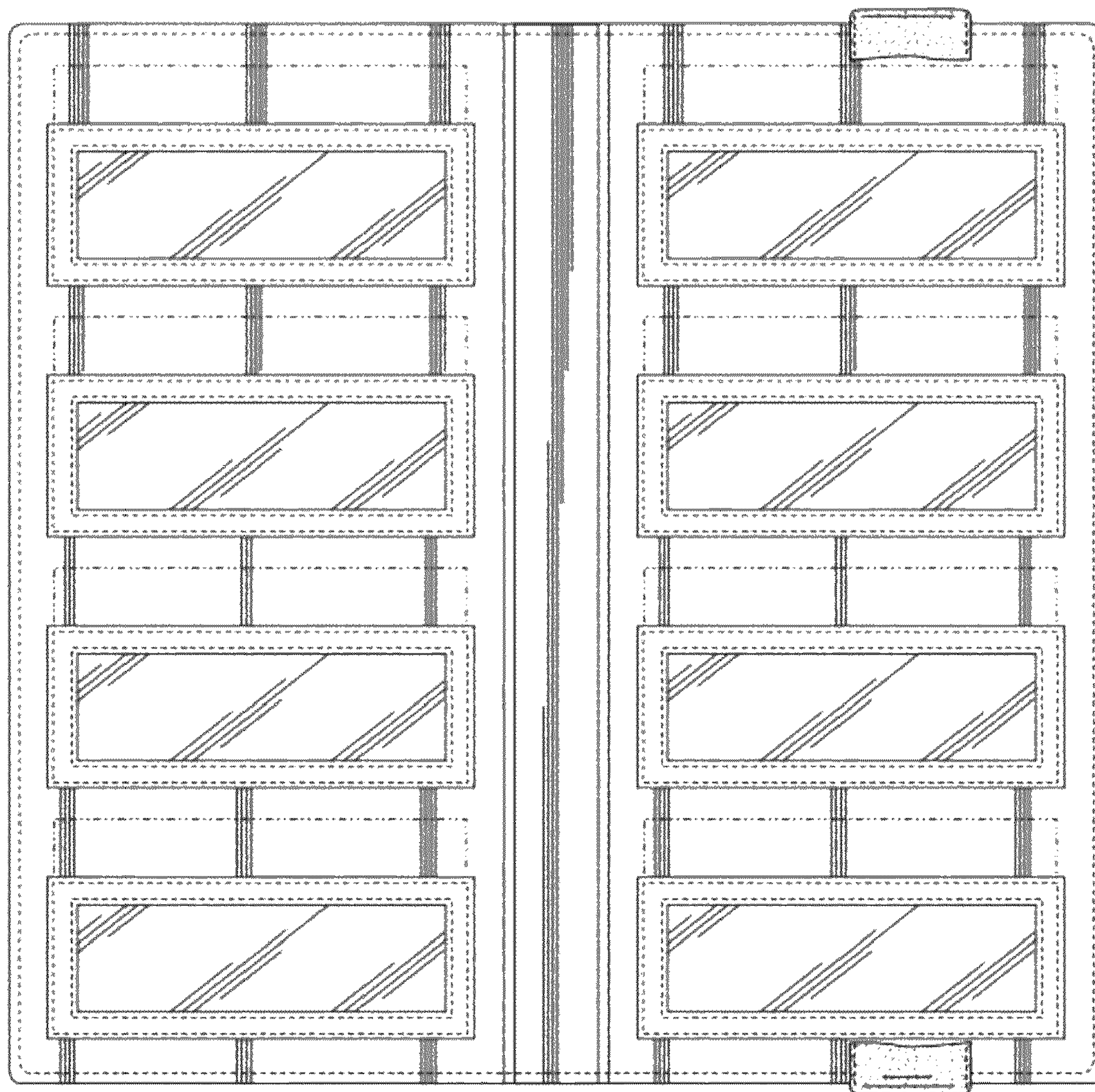
