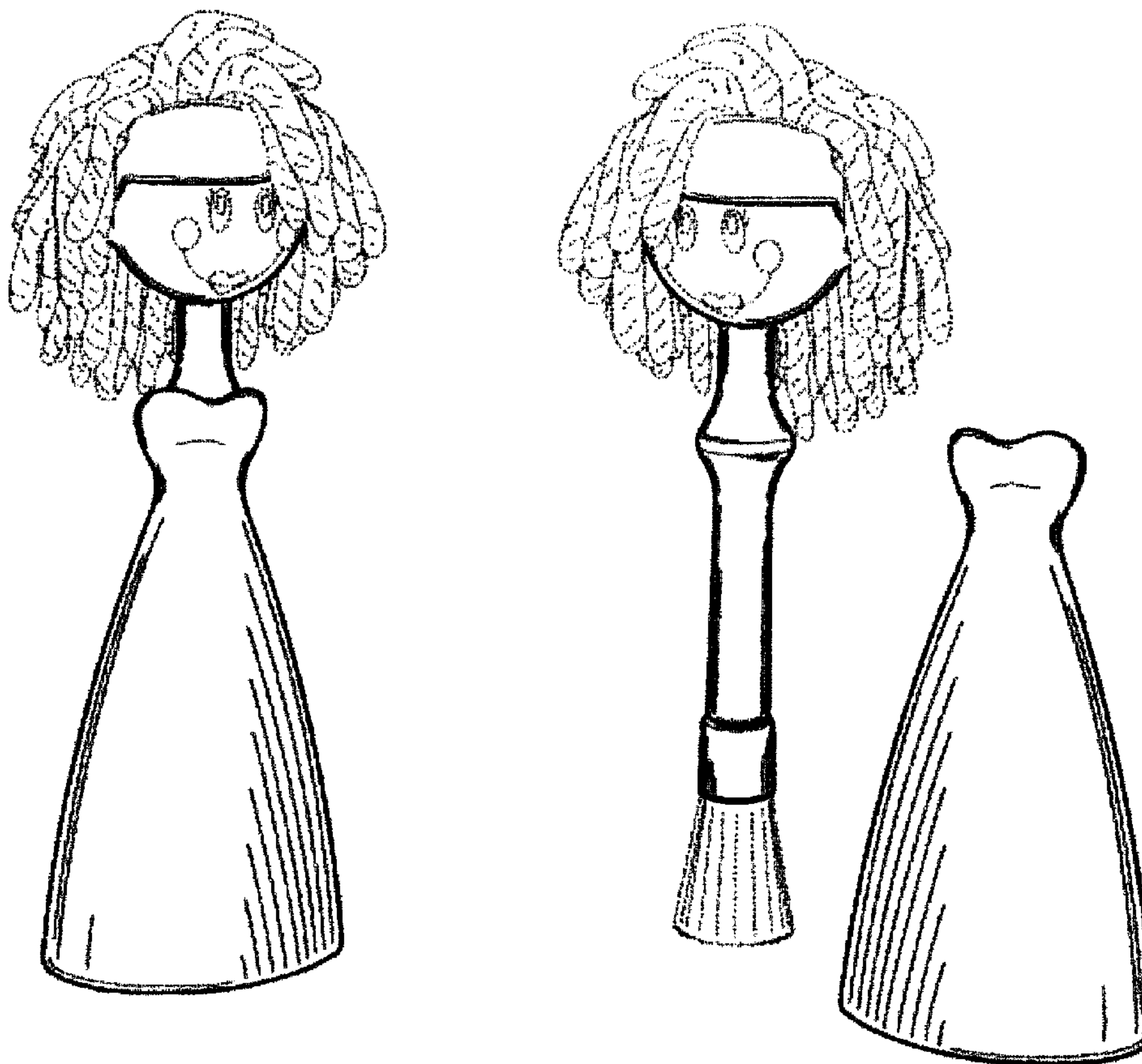
(57) **CLAIM**

The ornamental design for a doll brush, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a doll brush in accordance with my new design;
FIG. 2 is a left view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a front view of the doll and stand shown in FIG. 1; and,
FIG. 5 is a rear view of the doll and stand shown in FIG. 1.

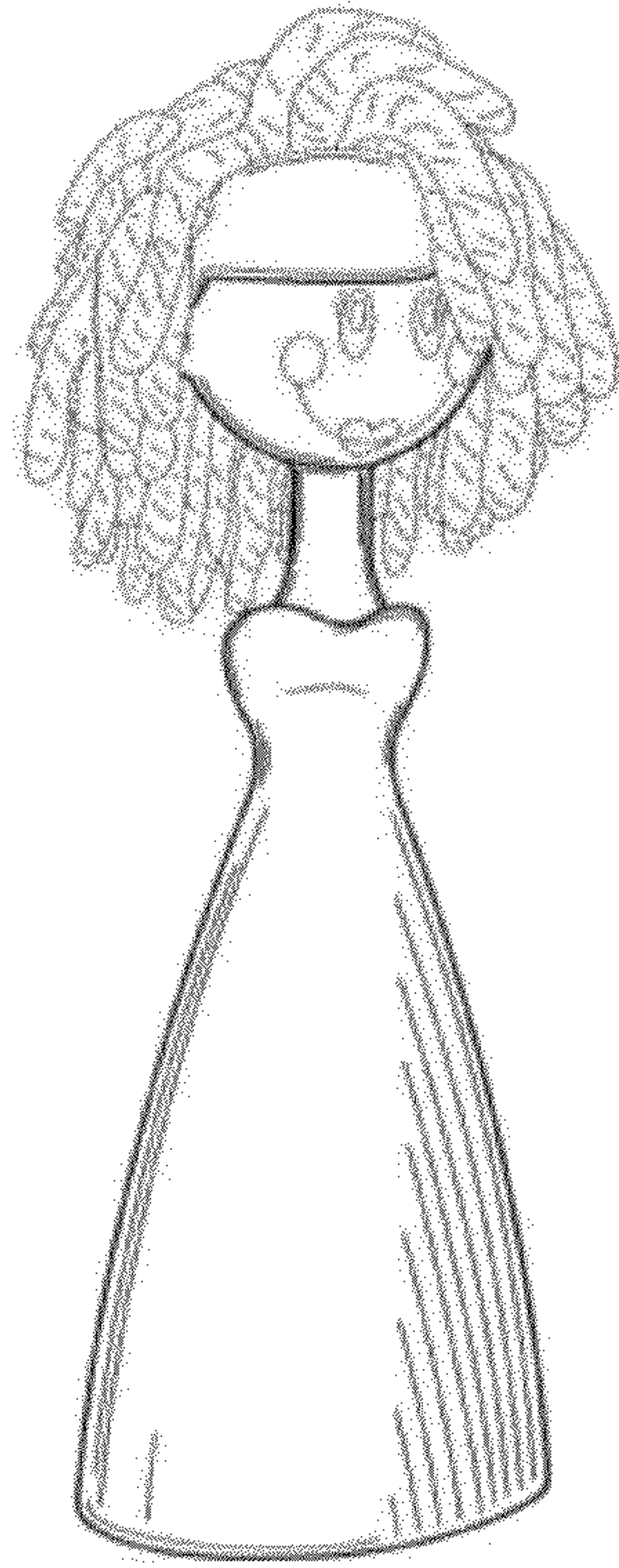

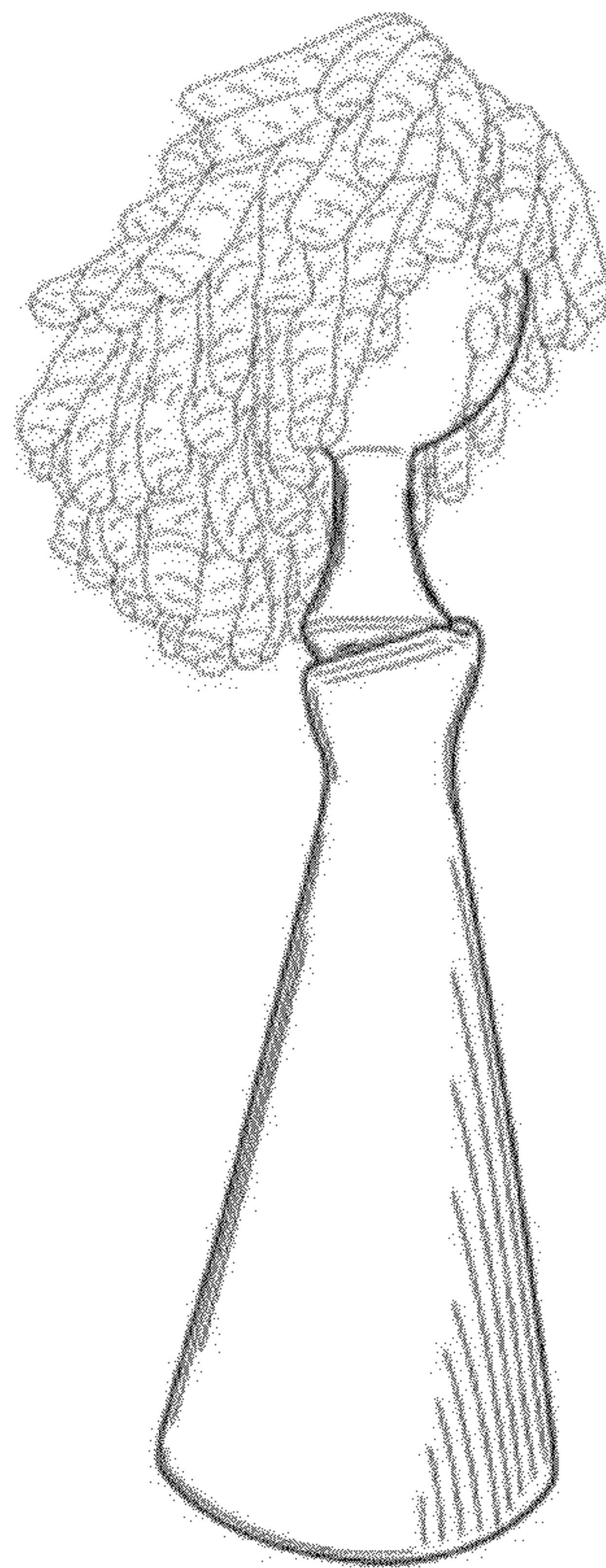

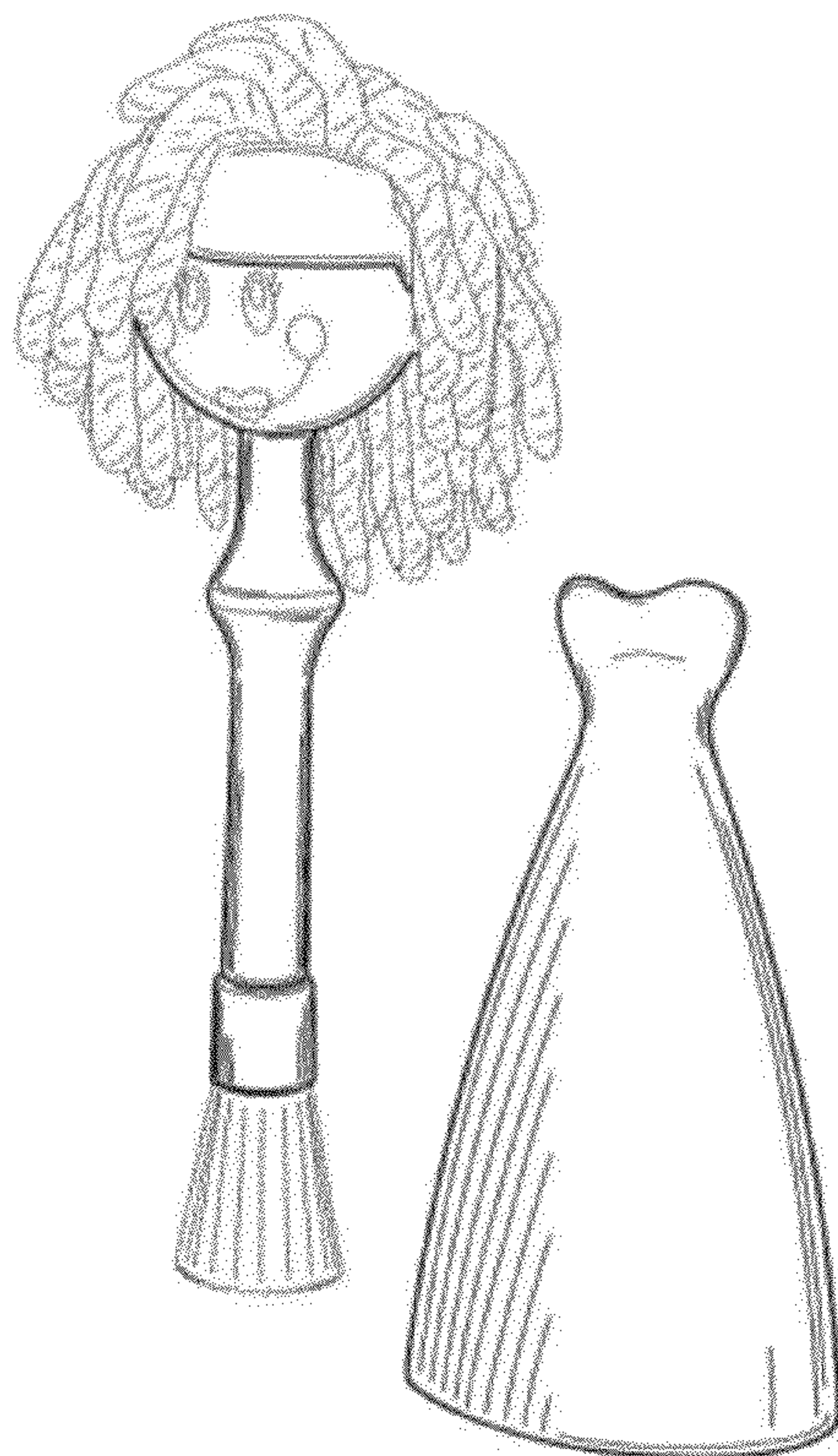

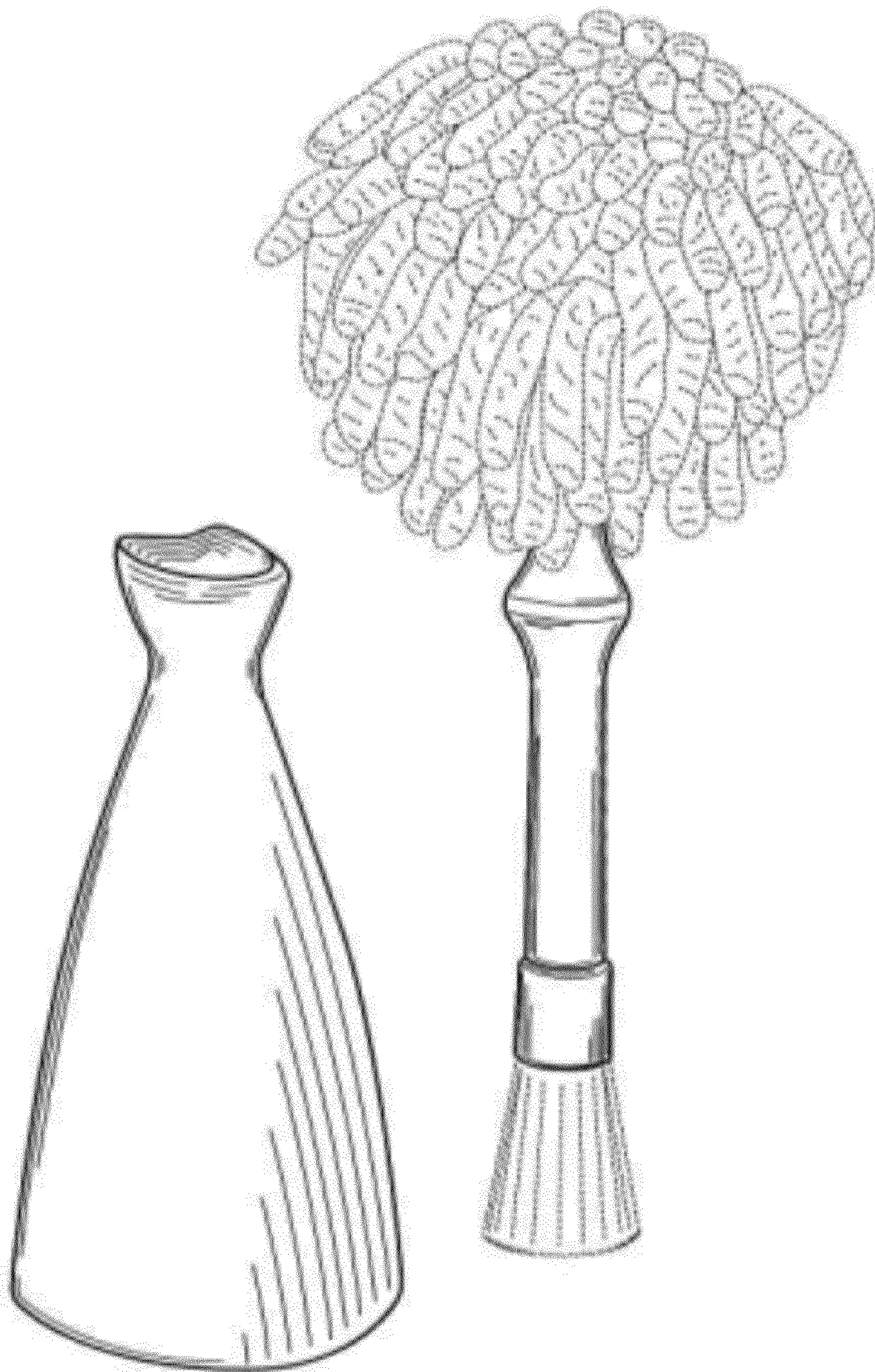
