(57) **CLAIM**

The ornamental design for a beverage container, as shown and described.

DESCRIPTION

FIG. 1 is a top rear perspective view of a beverage container showing my new design.

FIG. 2 is a rear elevational view thereof.

FIG. 3 is a front elevational view thereof.

FIG. 4 is a right side elevational view thereof, the left side elevational view being the mirror image thereof.

FIG. 5 is a top plan view thereof.

FIG. 6 is a bottom plan view thereof.

FIG. 7 is a top rear perspective view of a second embodiment thereof.

FIG. 8 is a rear elevational view thereof.

FIG. 9 is a front elevational view thereof.

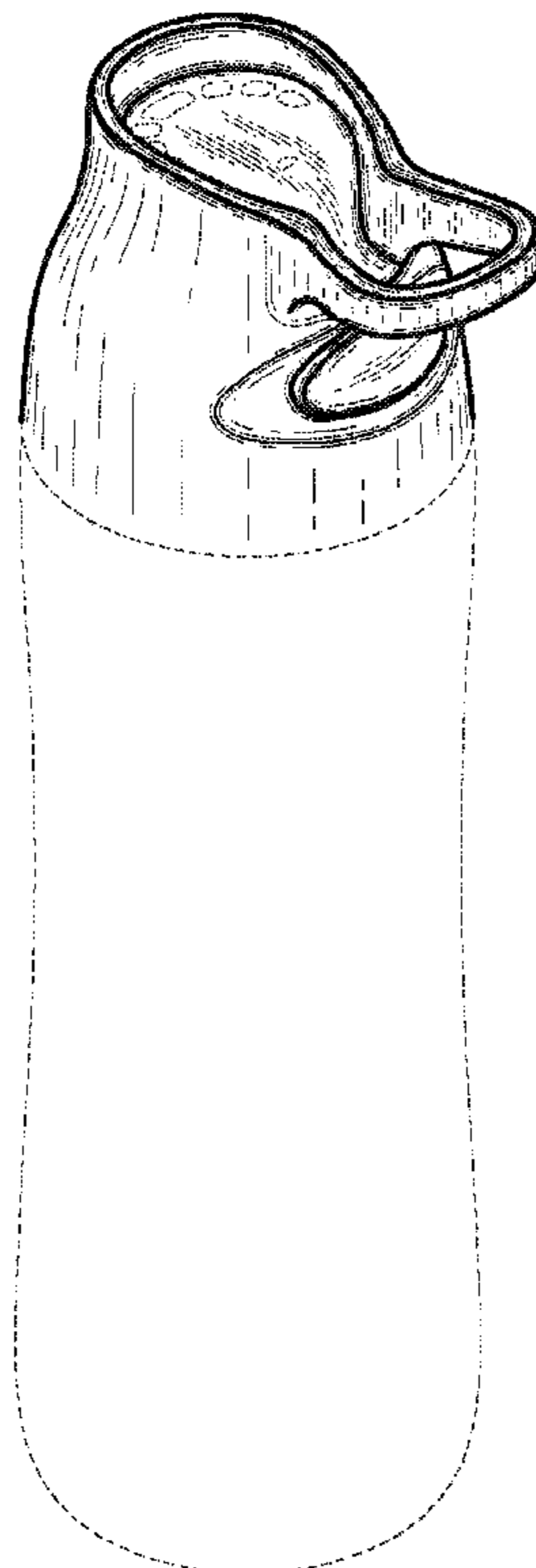
FIG. 10 is a right side elevational view thereof, the left side elevational view being the mirror image thereof.

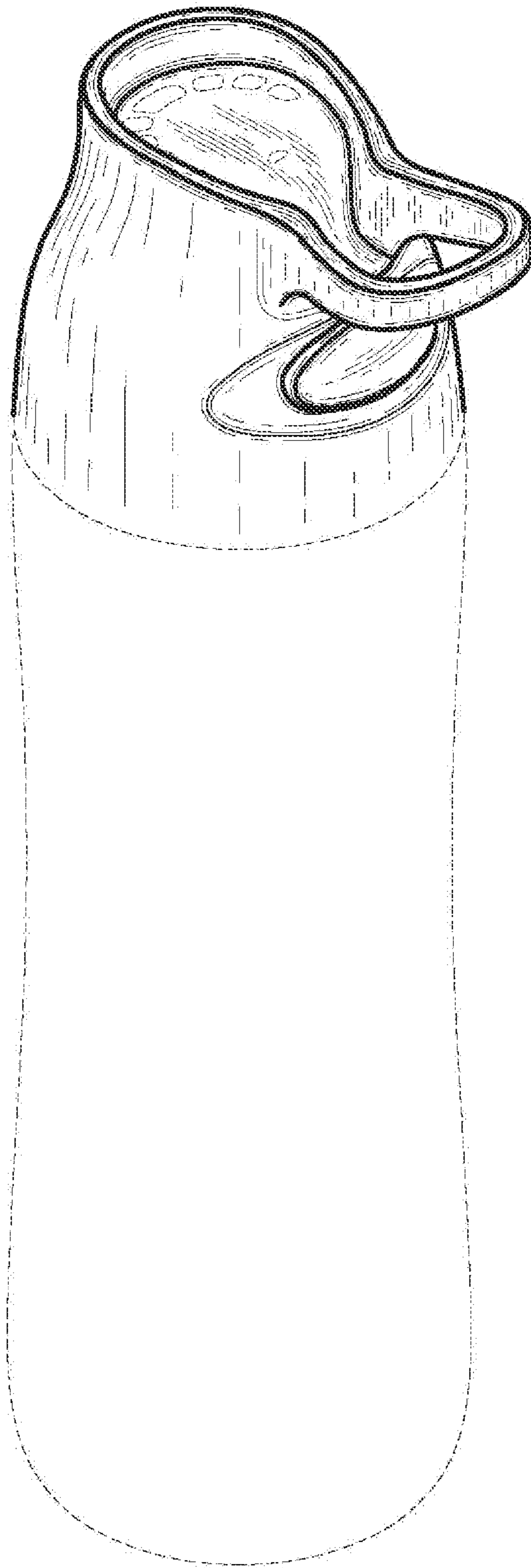

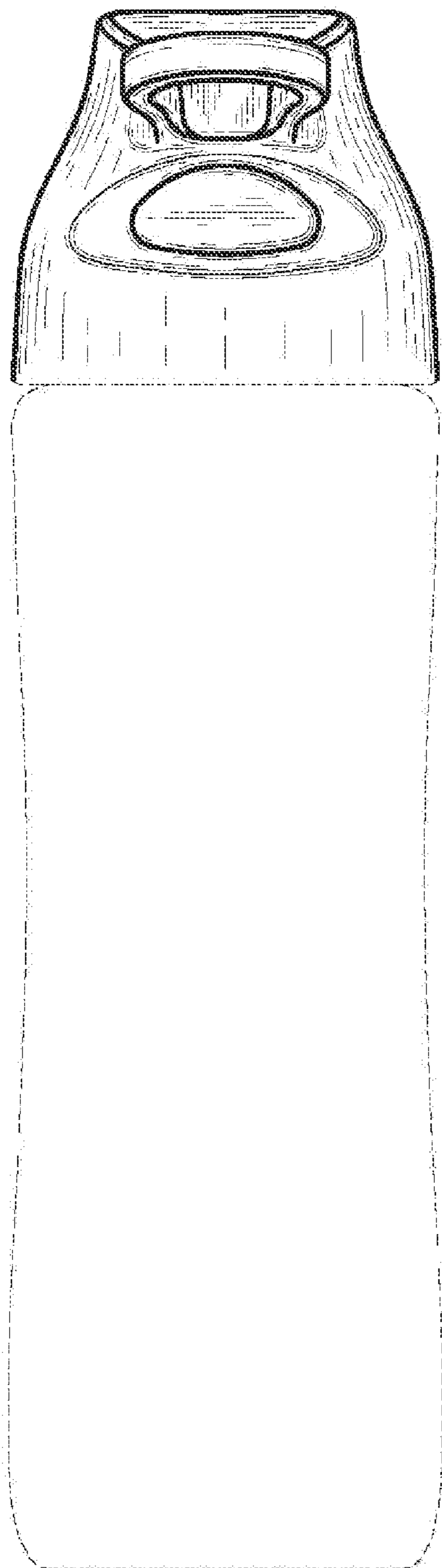

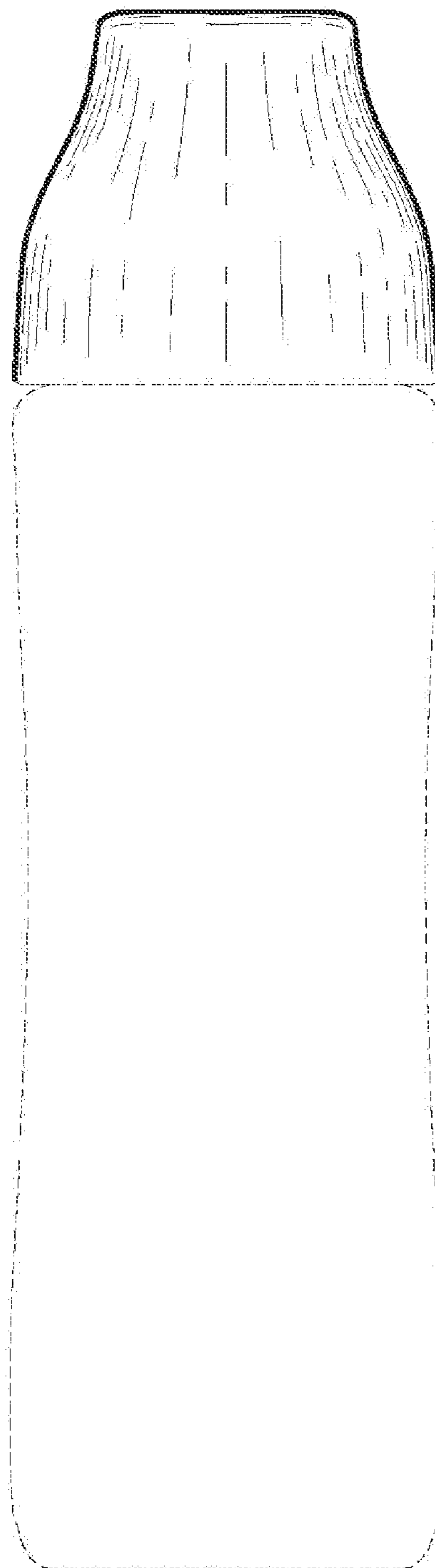

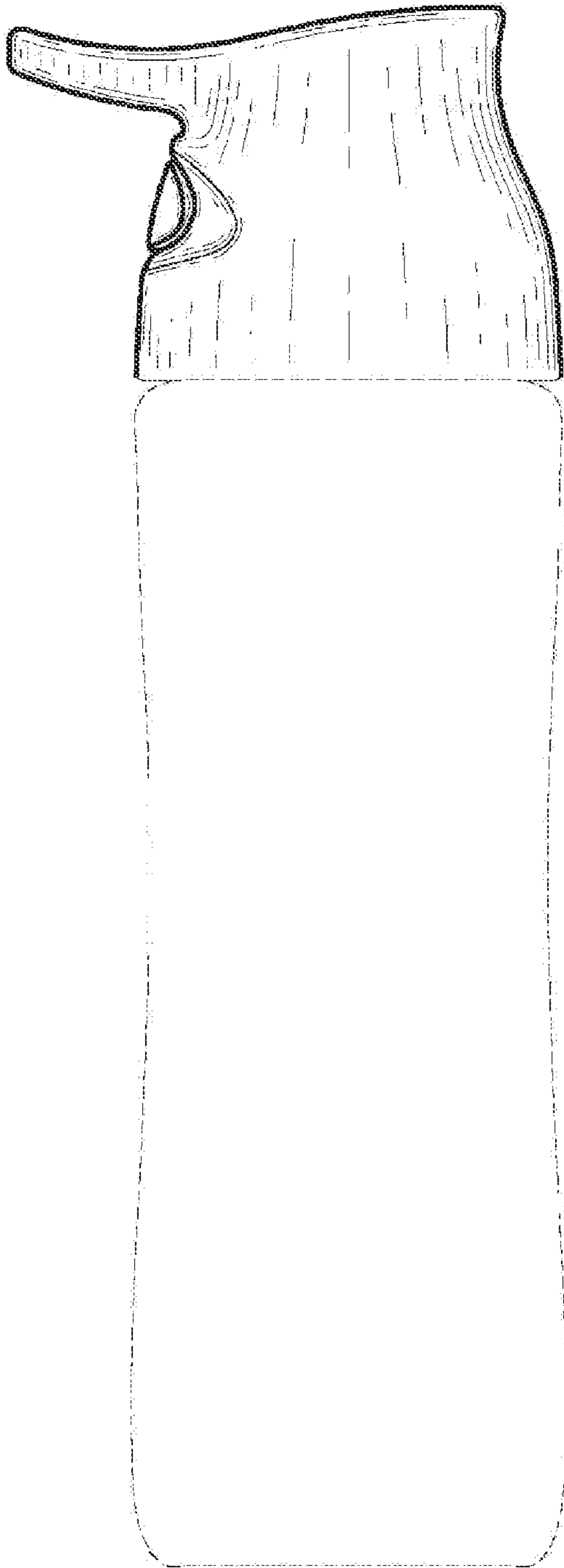

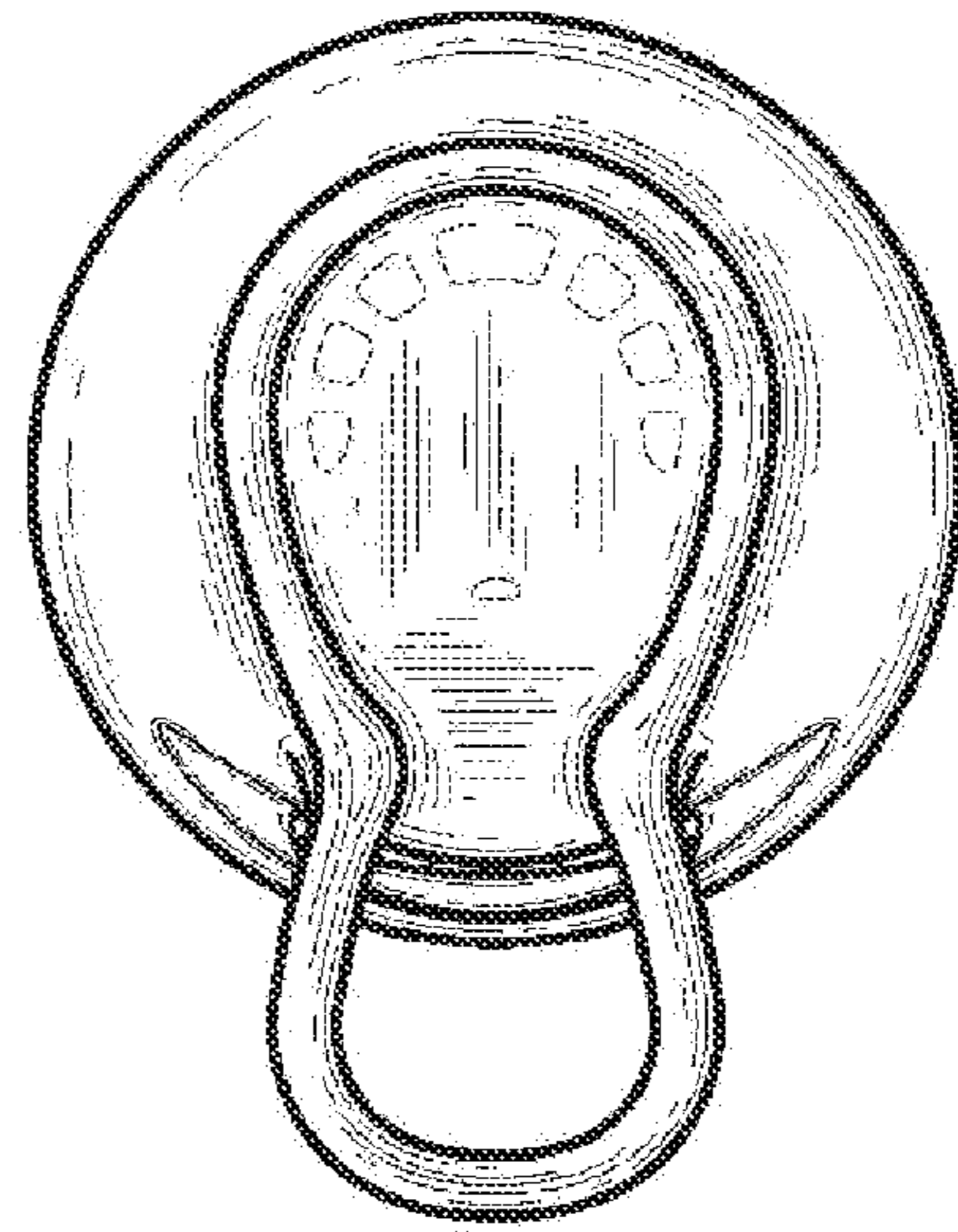

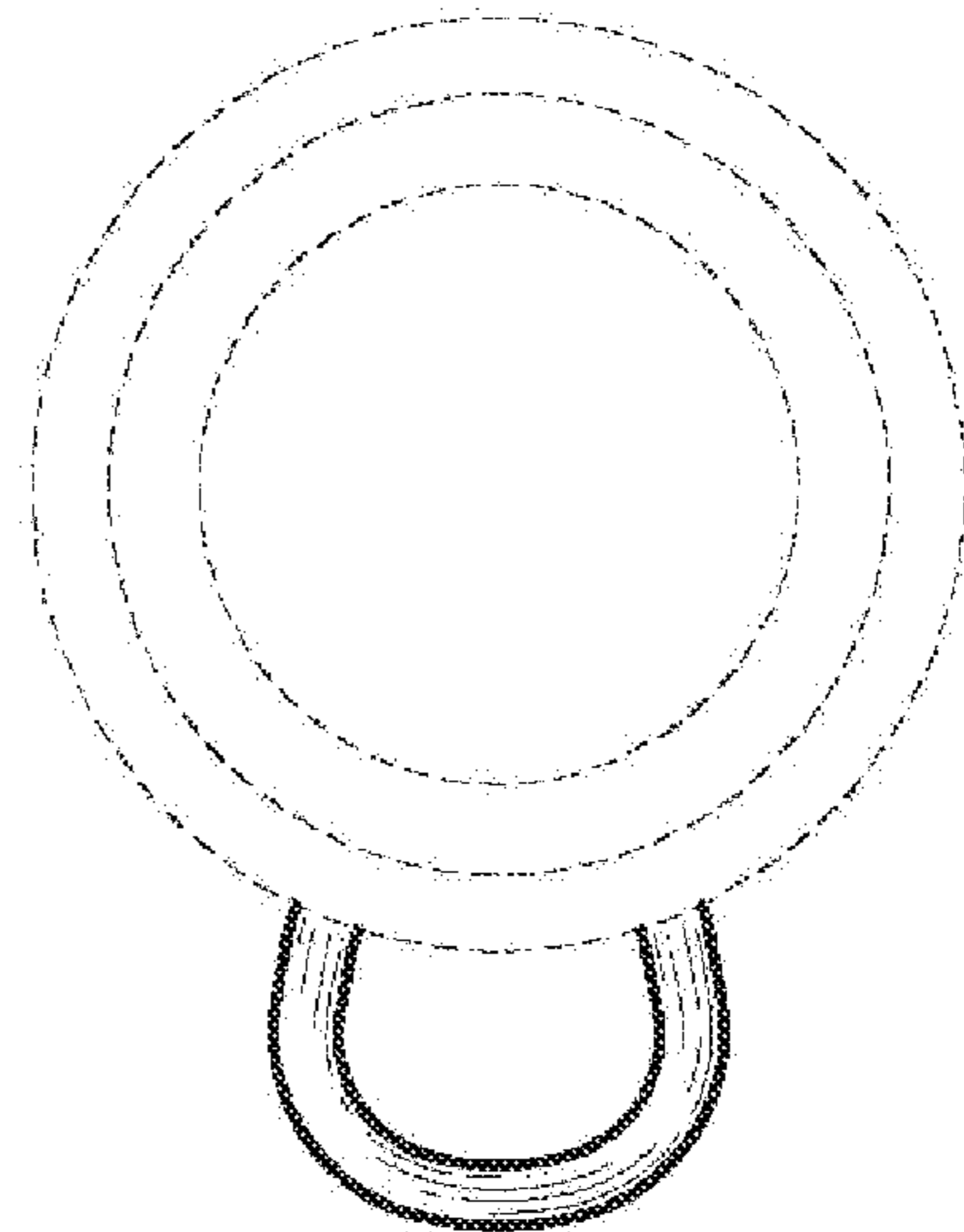

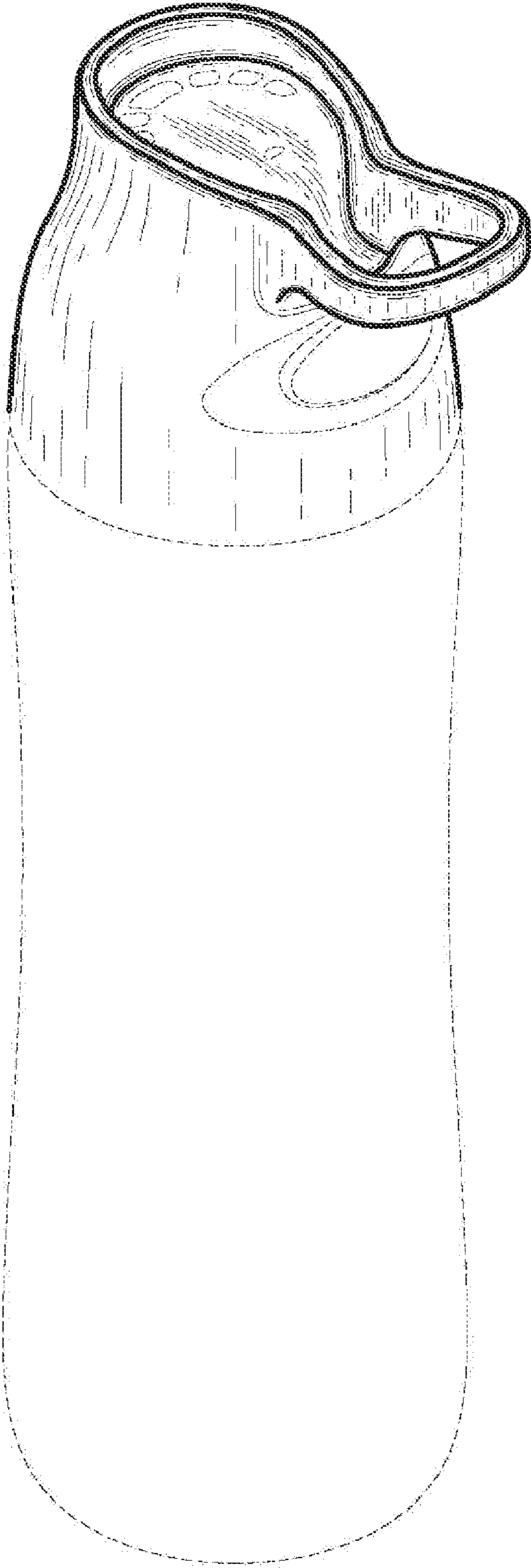

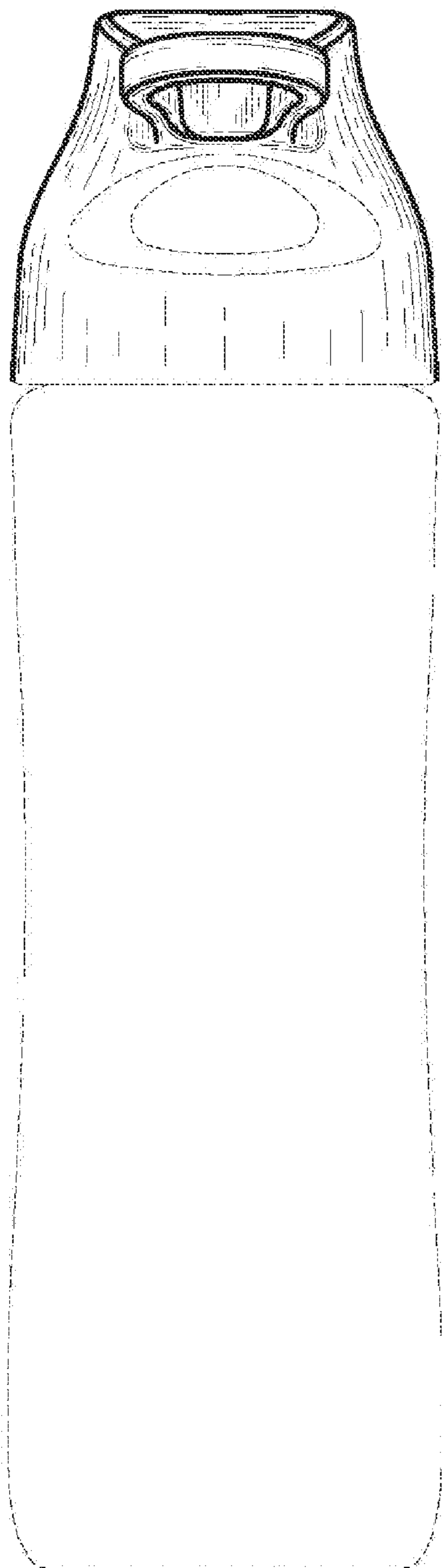

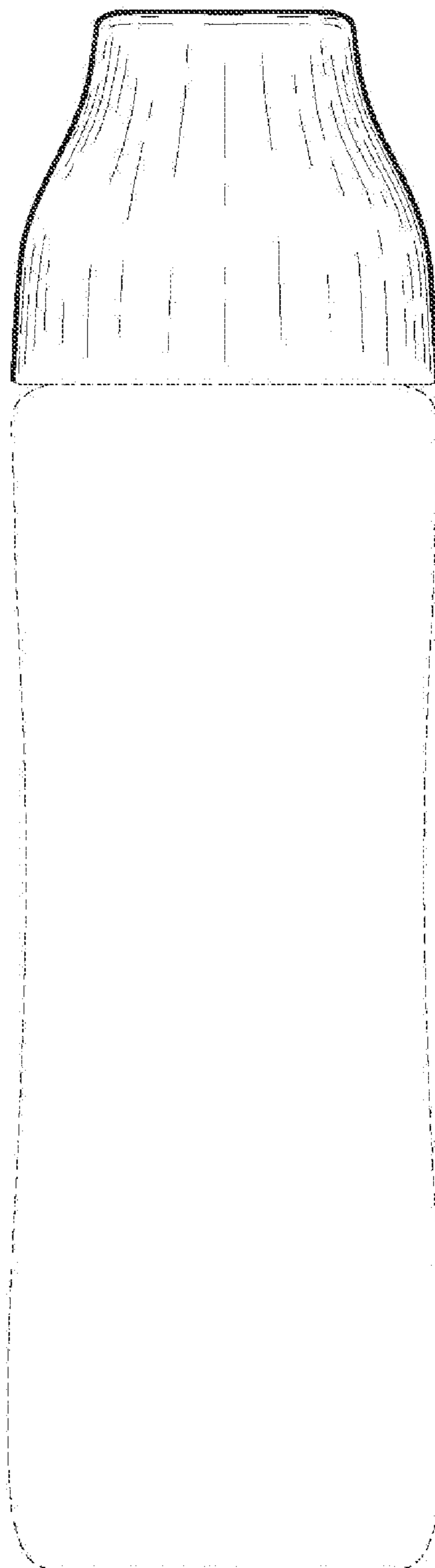

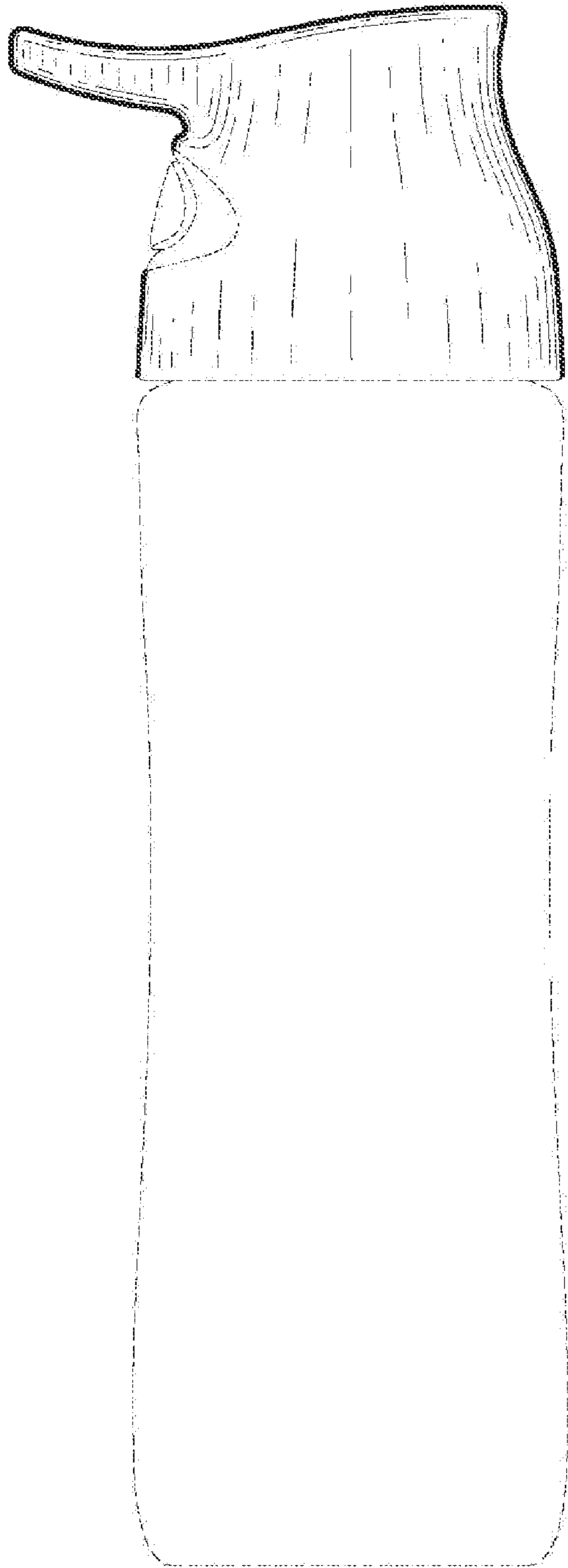

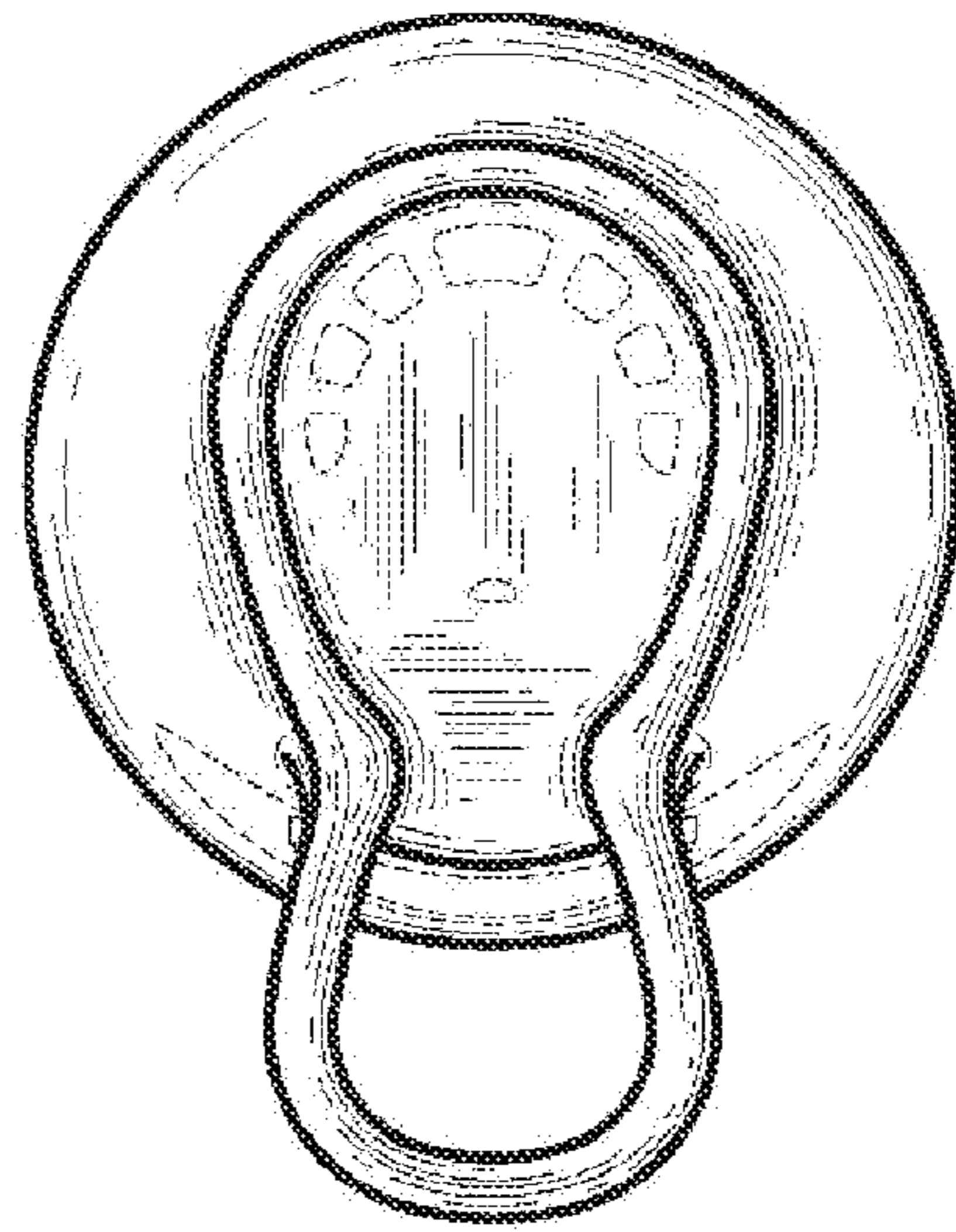

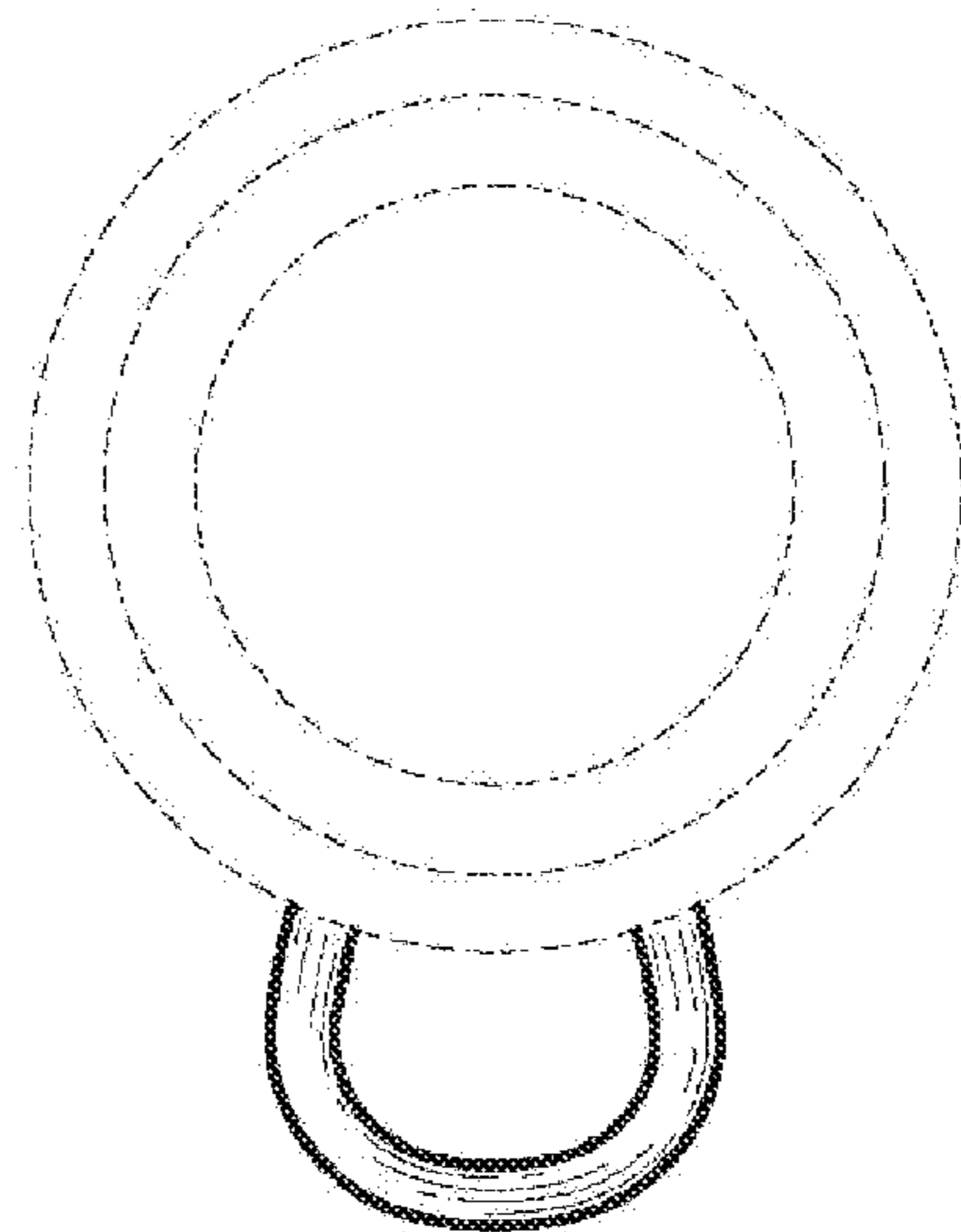
