FIG. 1 is a front perspective view of a funnel with caps showing my new design.

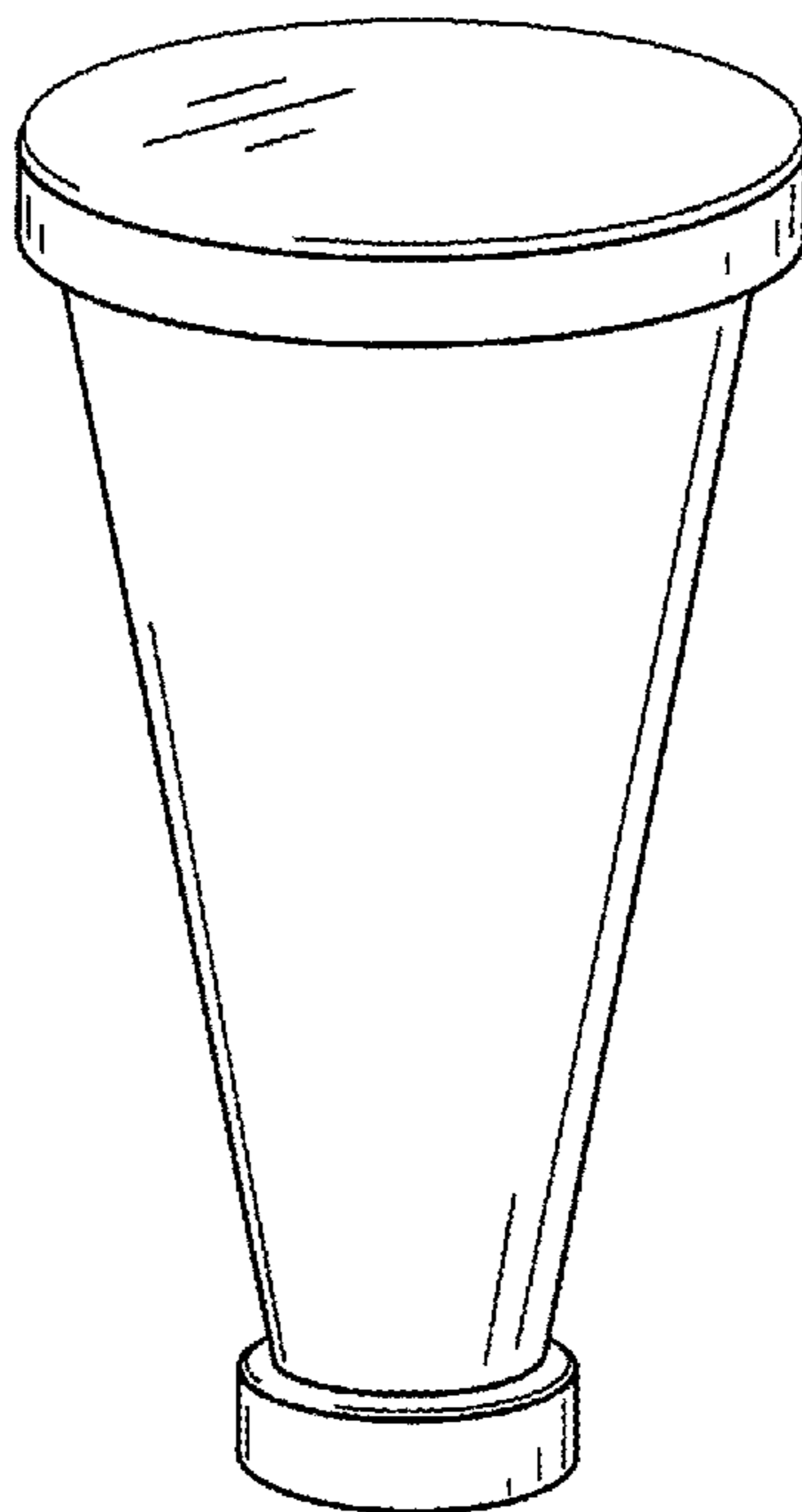
FIG. 2 is a front, exploded perspective view thereof.

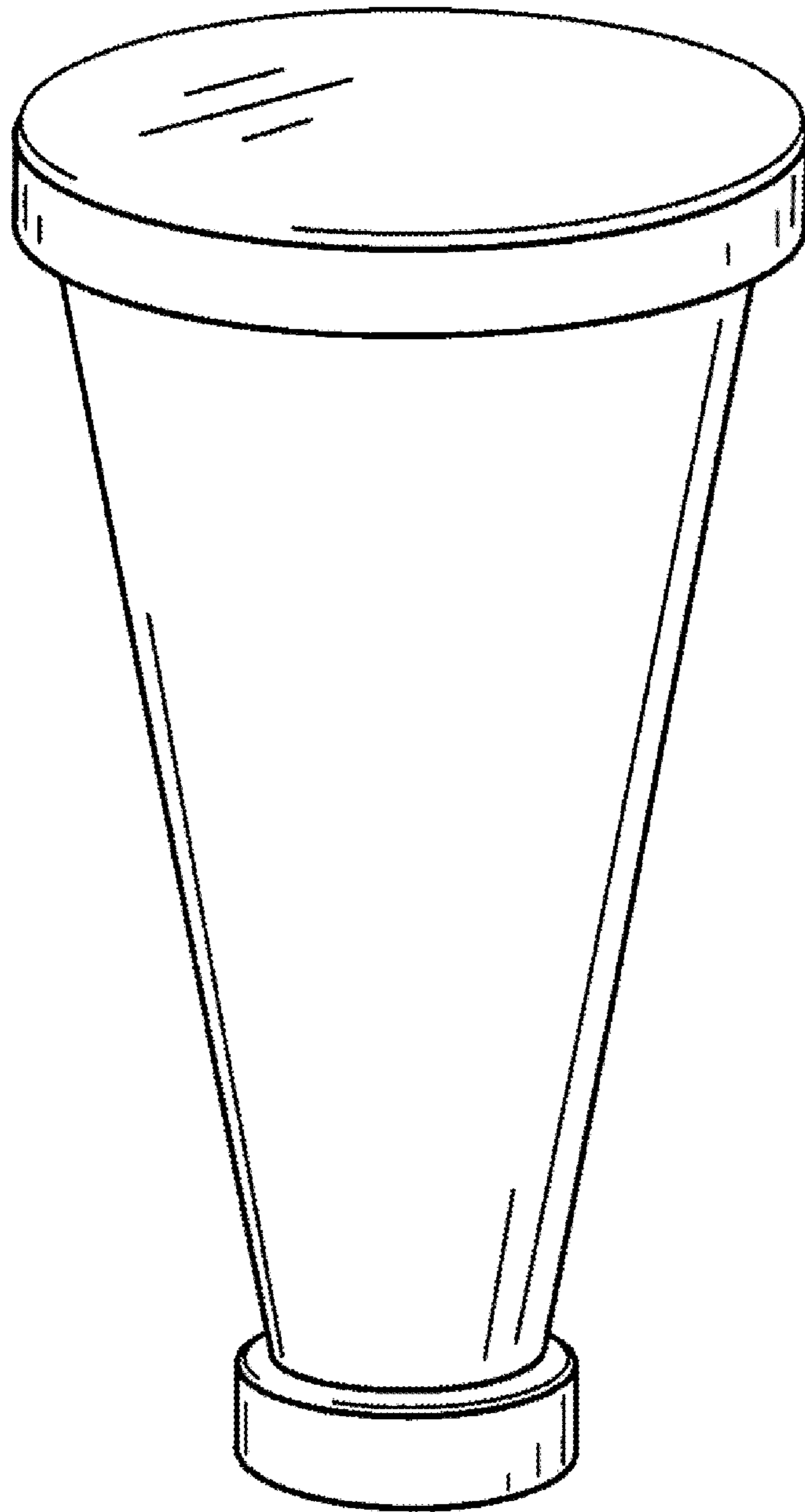

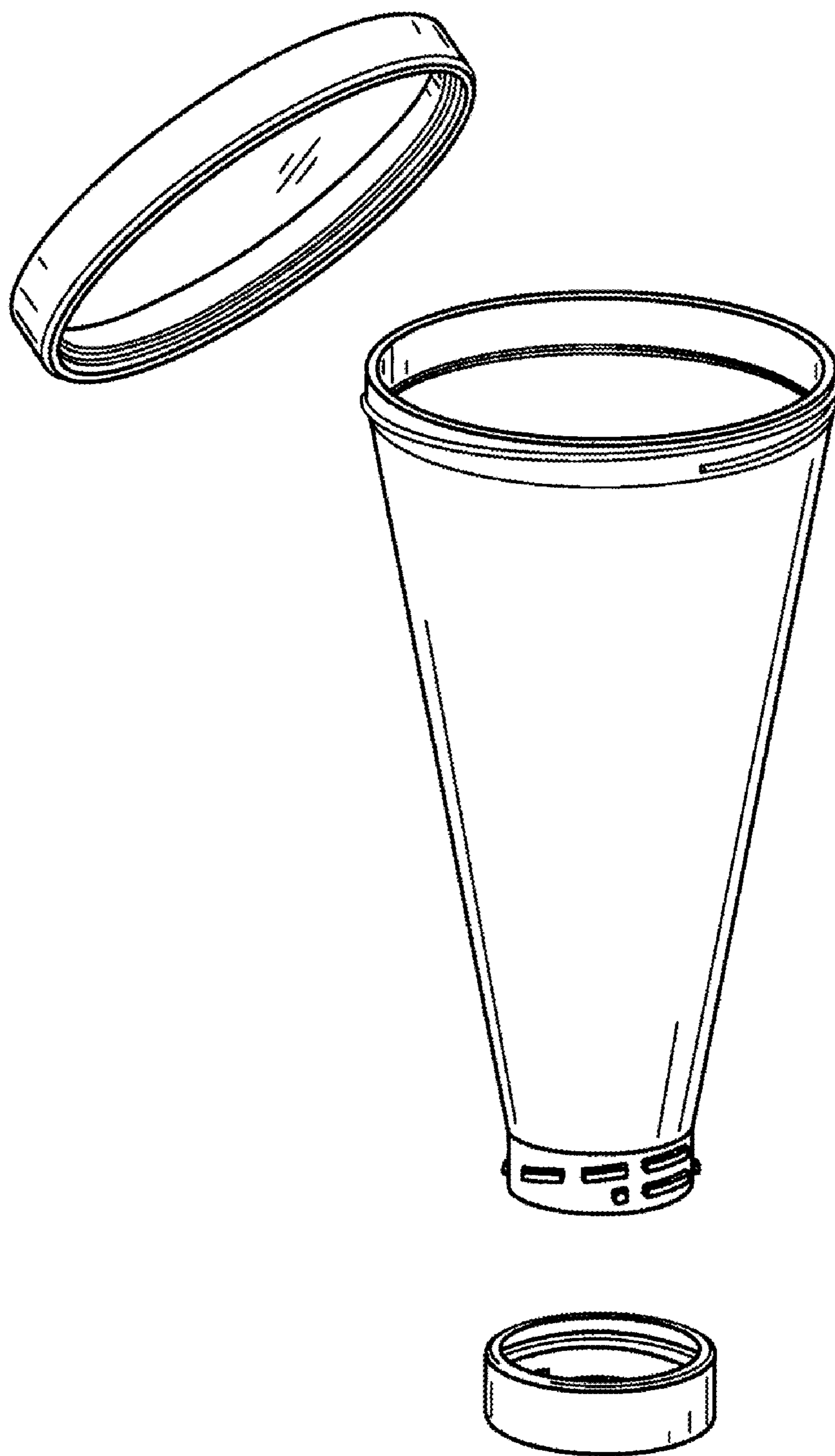

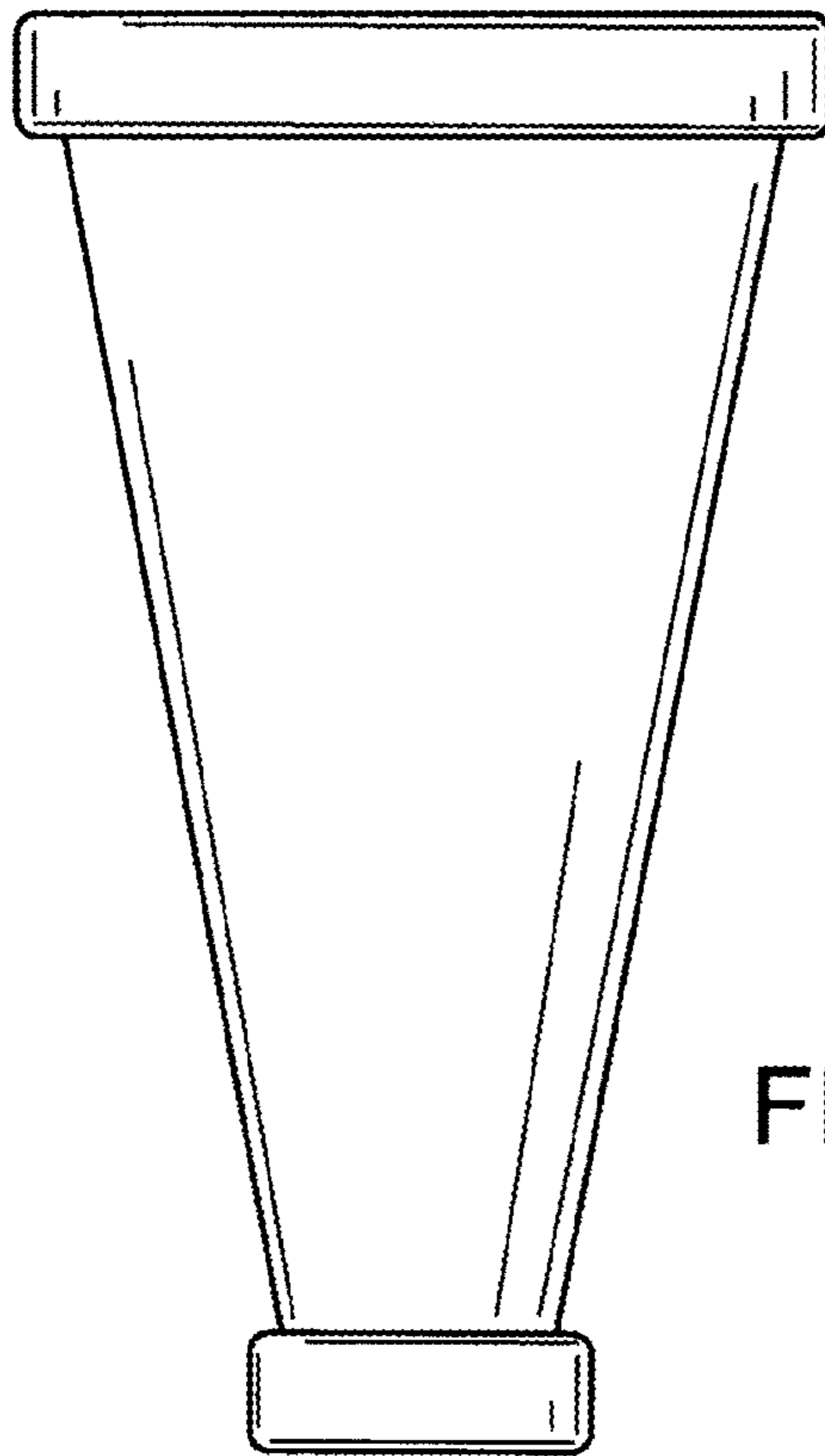

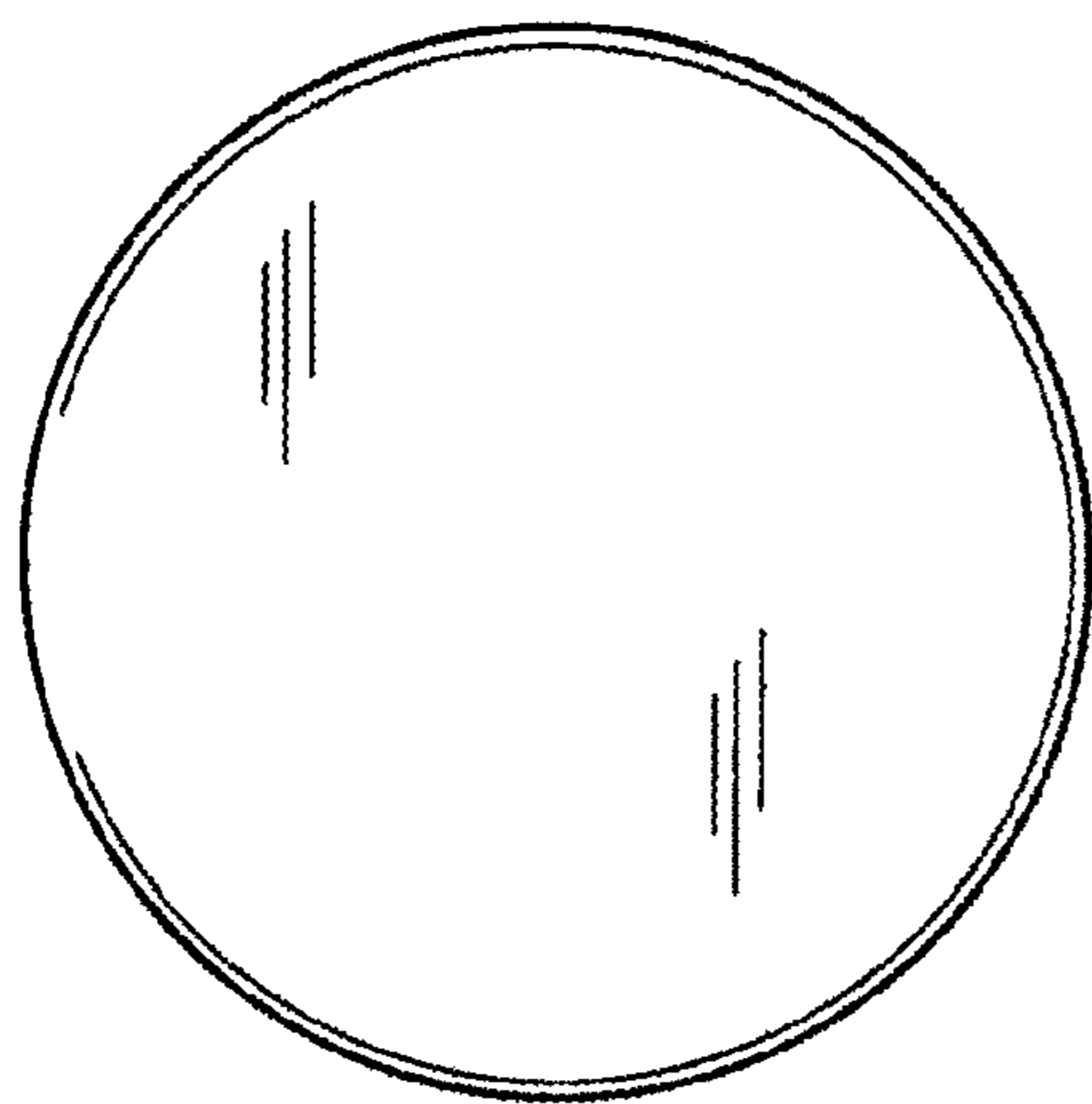

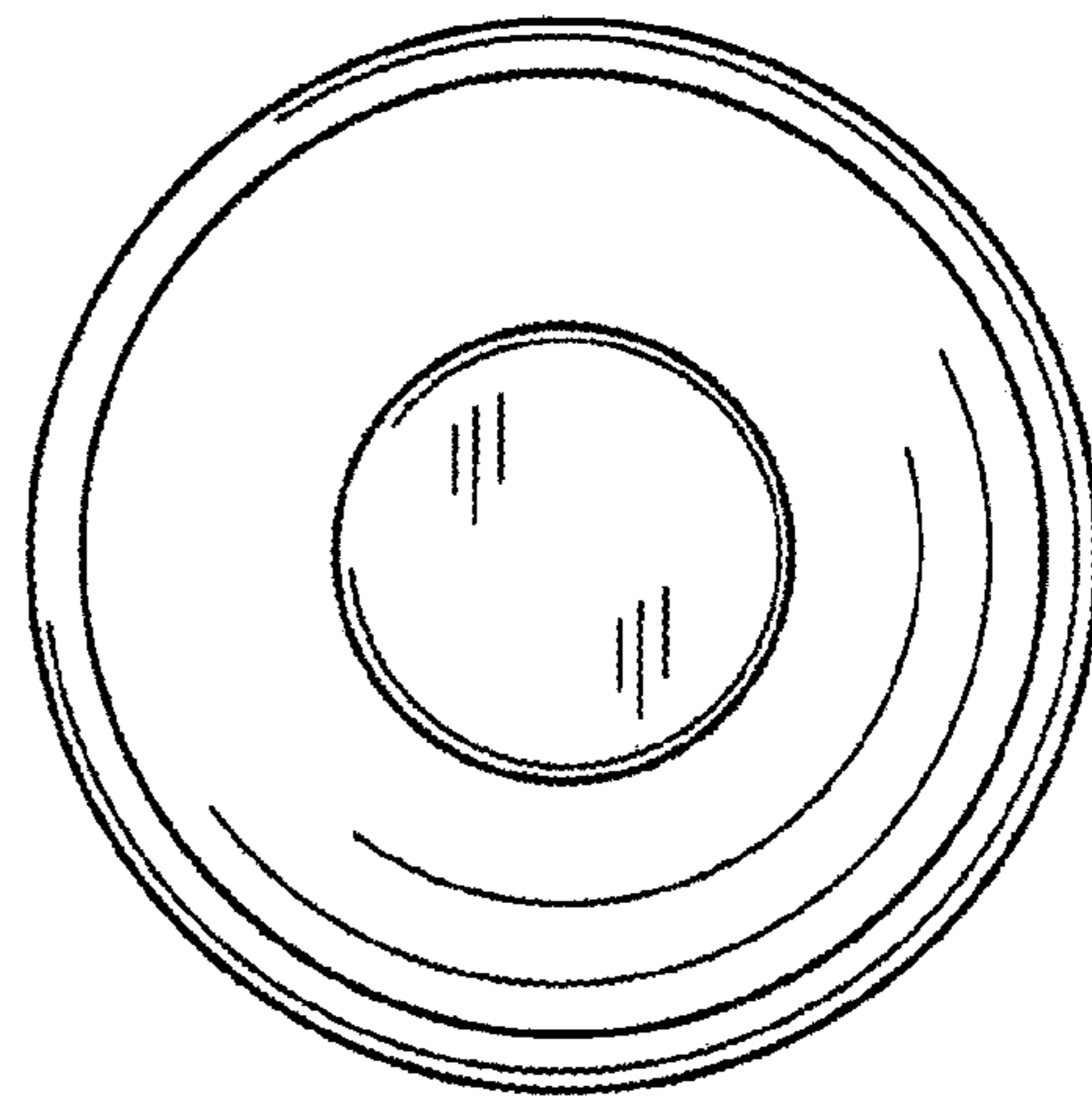
