(57) **CLAIM**

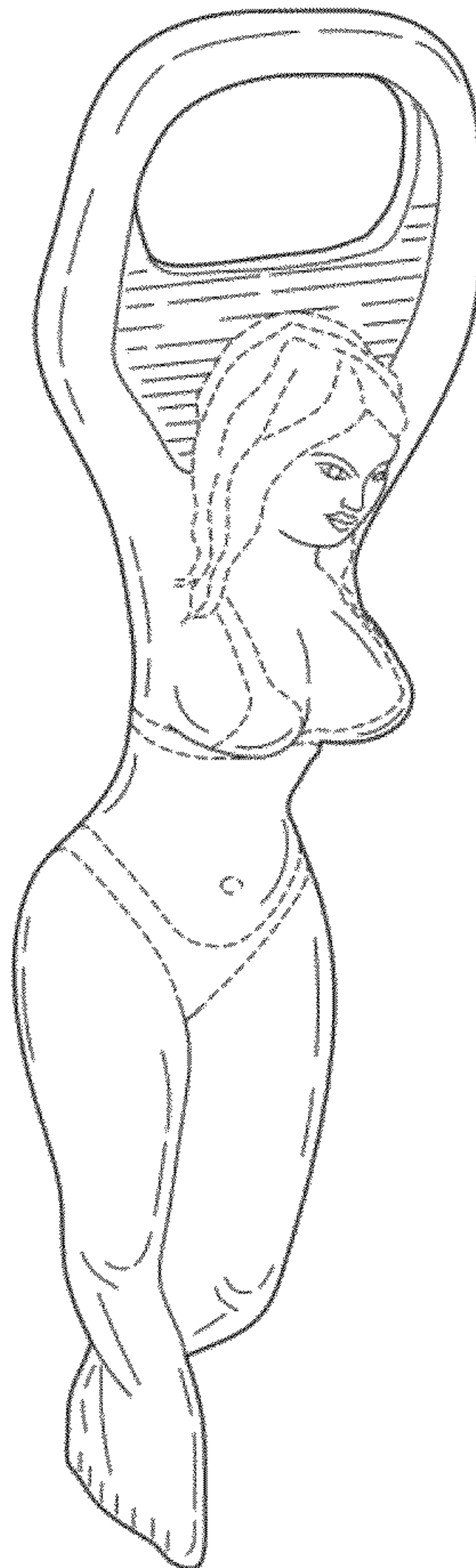
I claim the ornamental design for a figurine bottle opener, as shown and described.

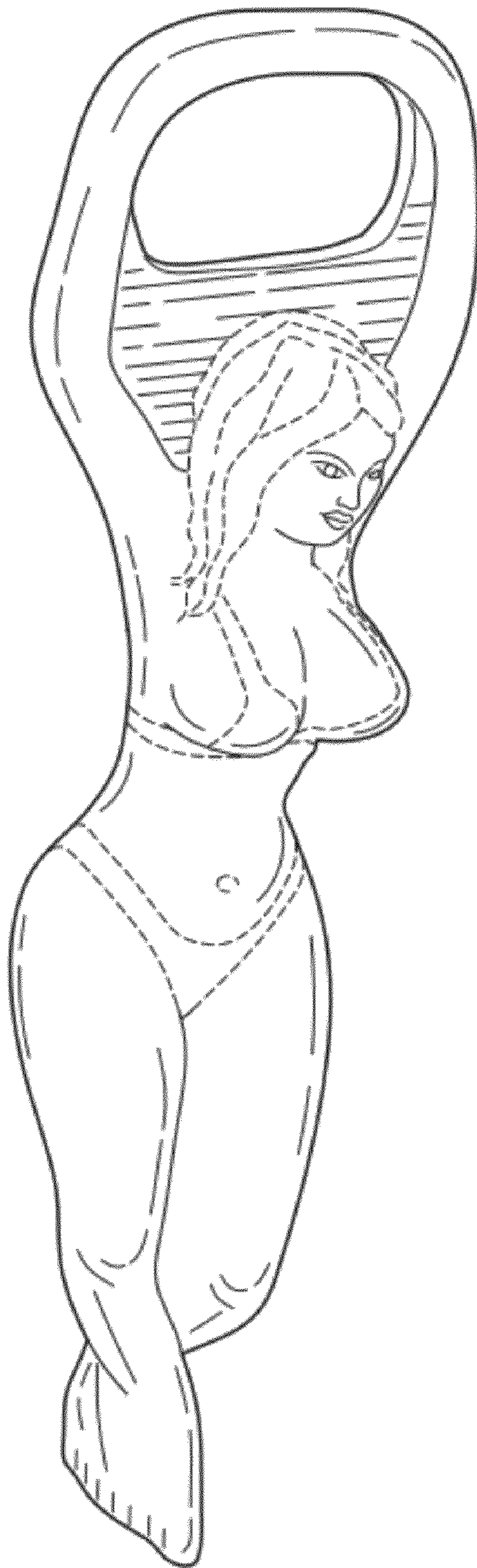
**DESCRIPTION**

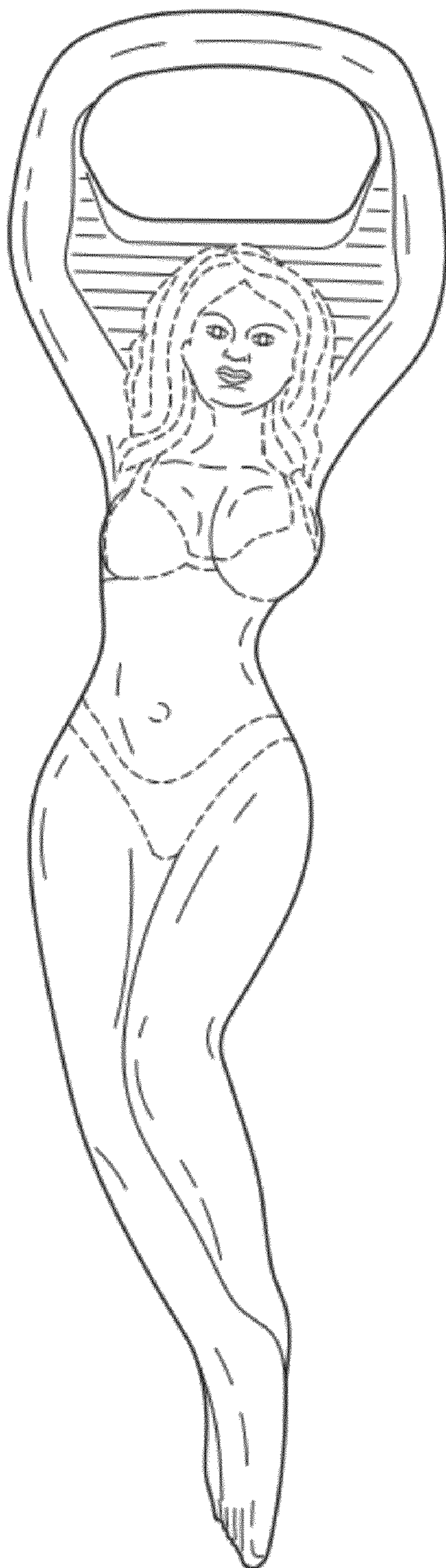
The broken lines representing a bathing suit artwork and a hairstyle are for illustrative purposes only and do not form part of the claimed design.

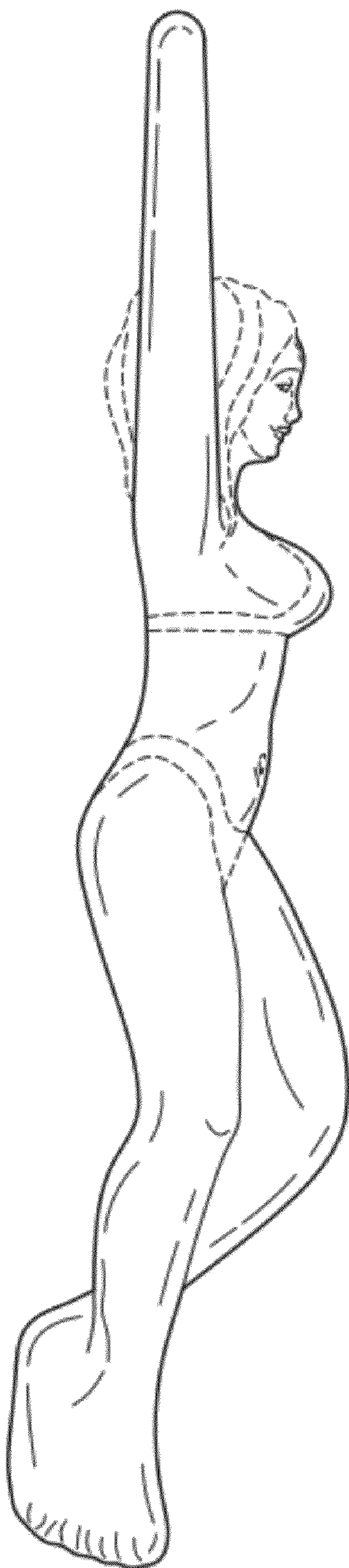

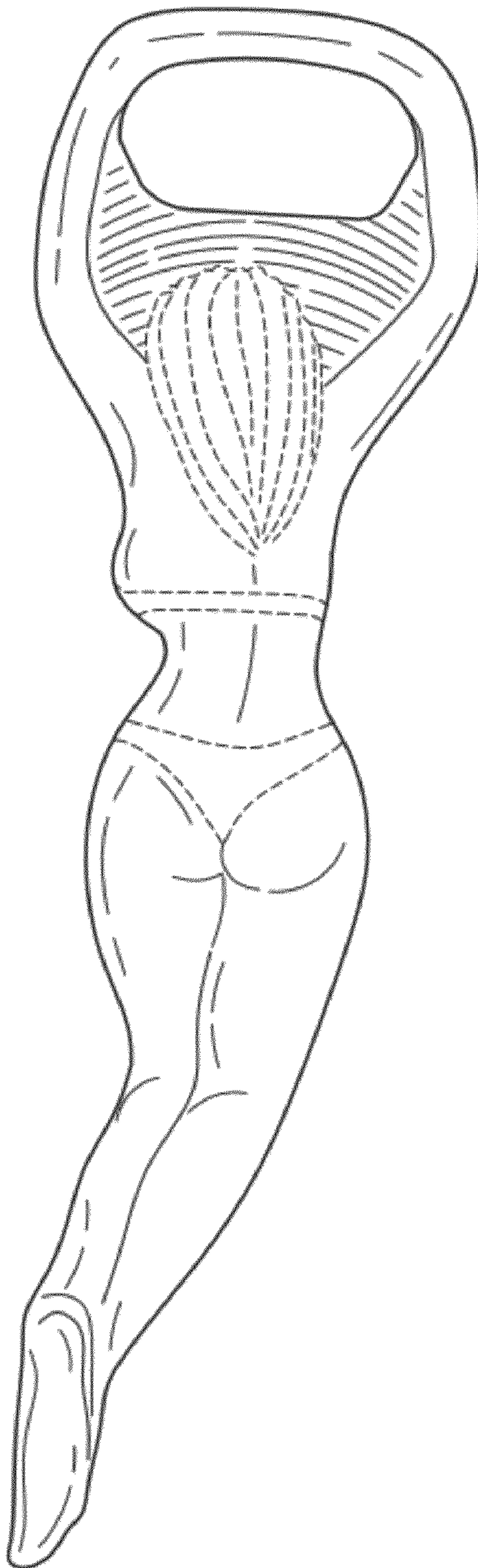

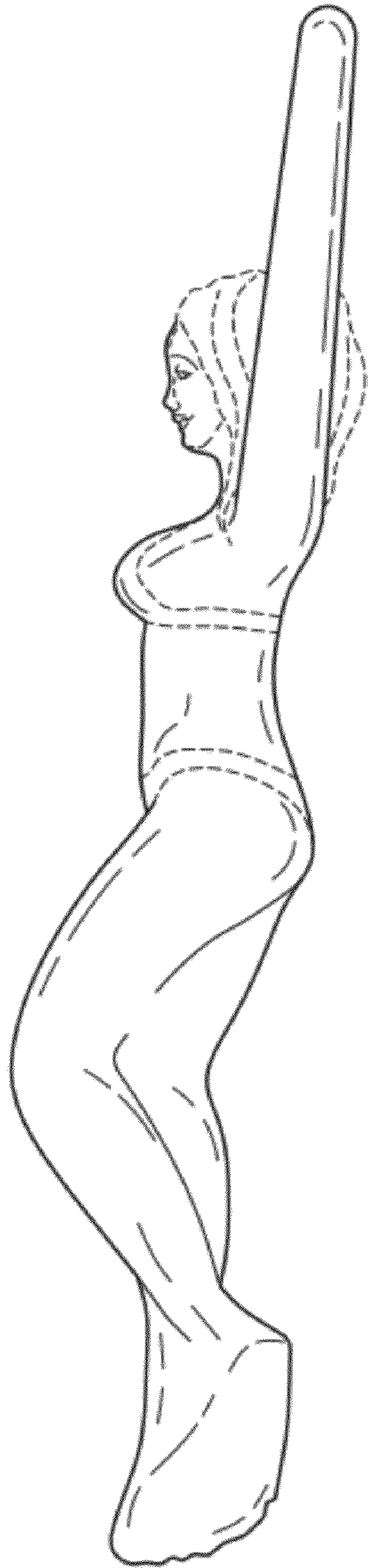
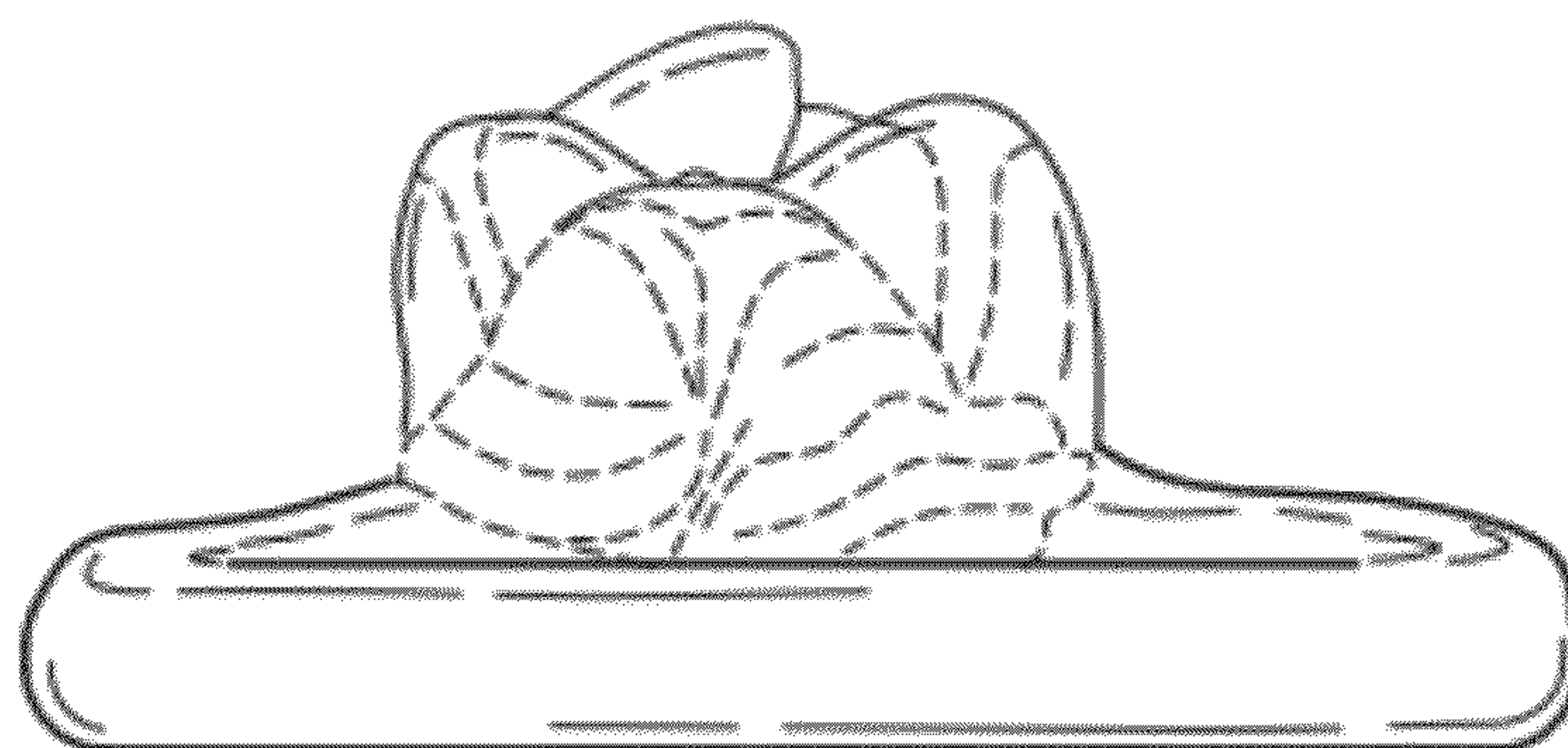
