DESCRIPTION

FIG. 1 is a perspective view of a clip that illustrates the novel design;

FIG. 2 is a top view of the clip of FIG. 1;

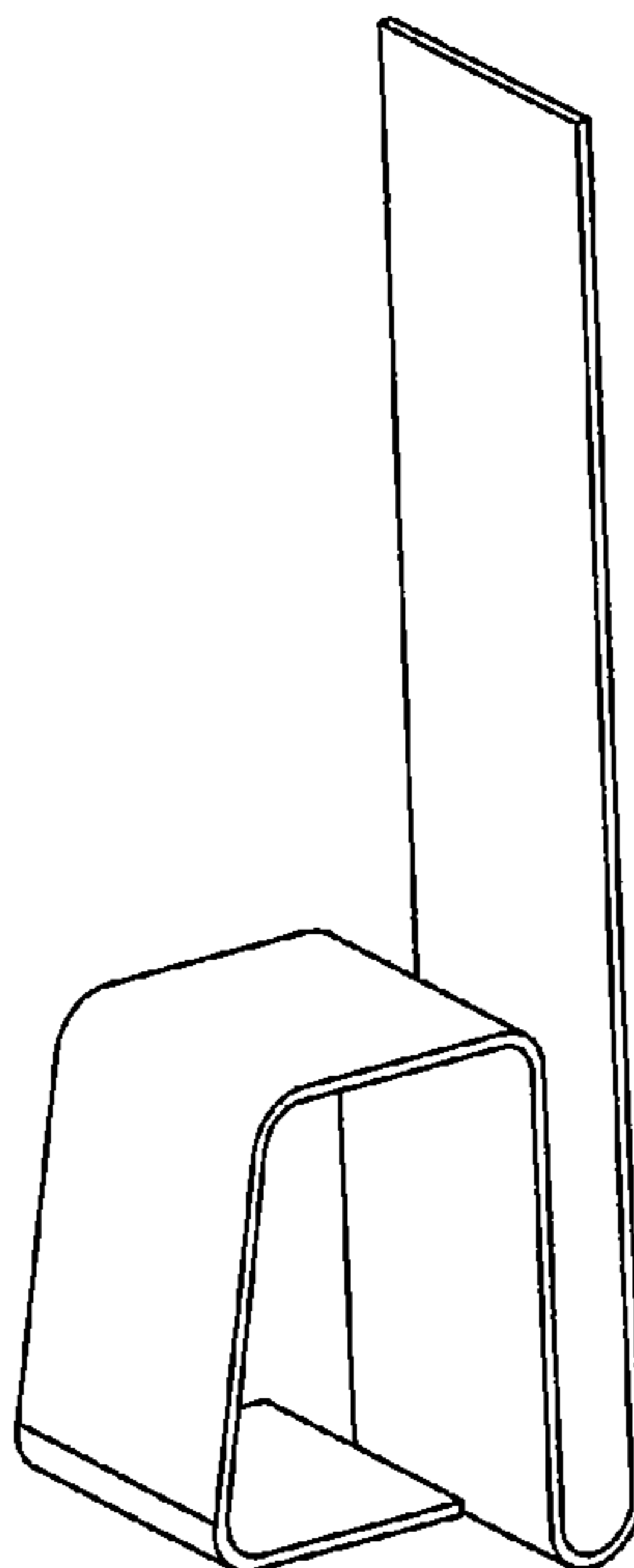
FIG. 3 is a left side elevational view of the clip of FIG. 1;

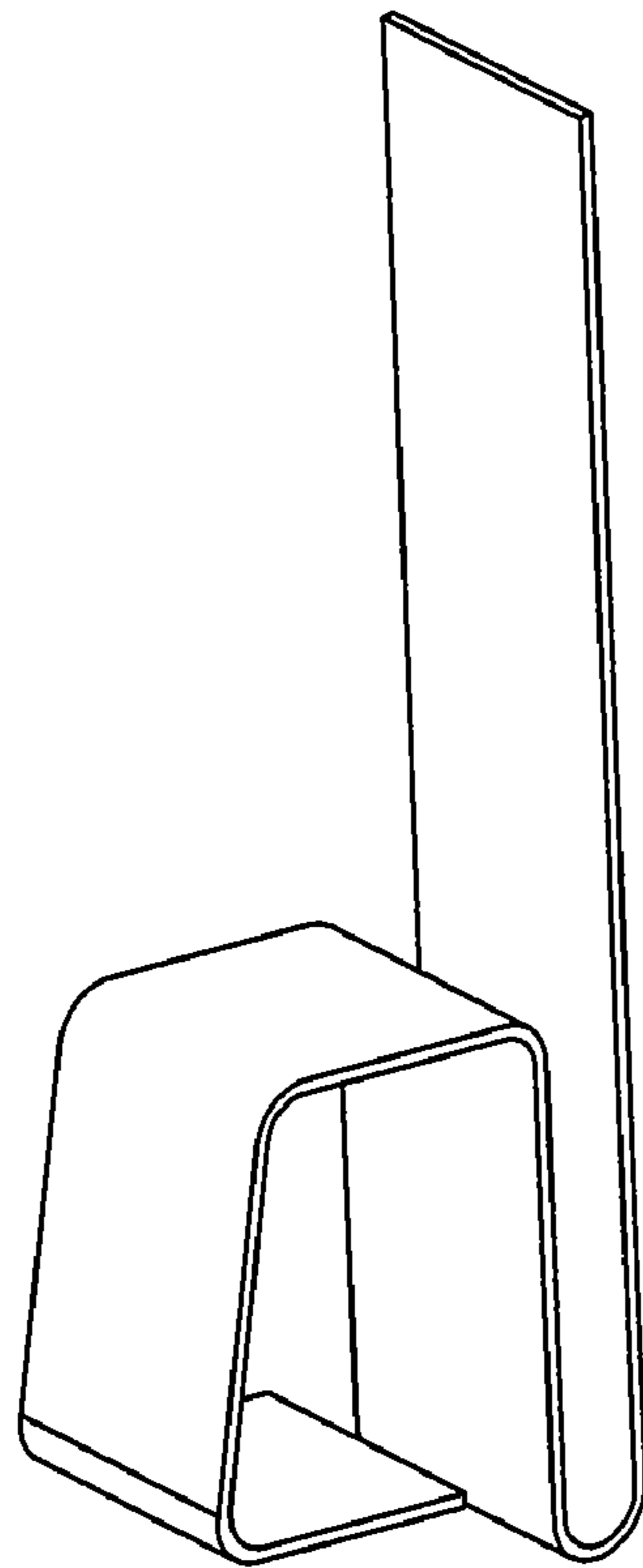

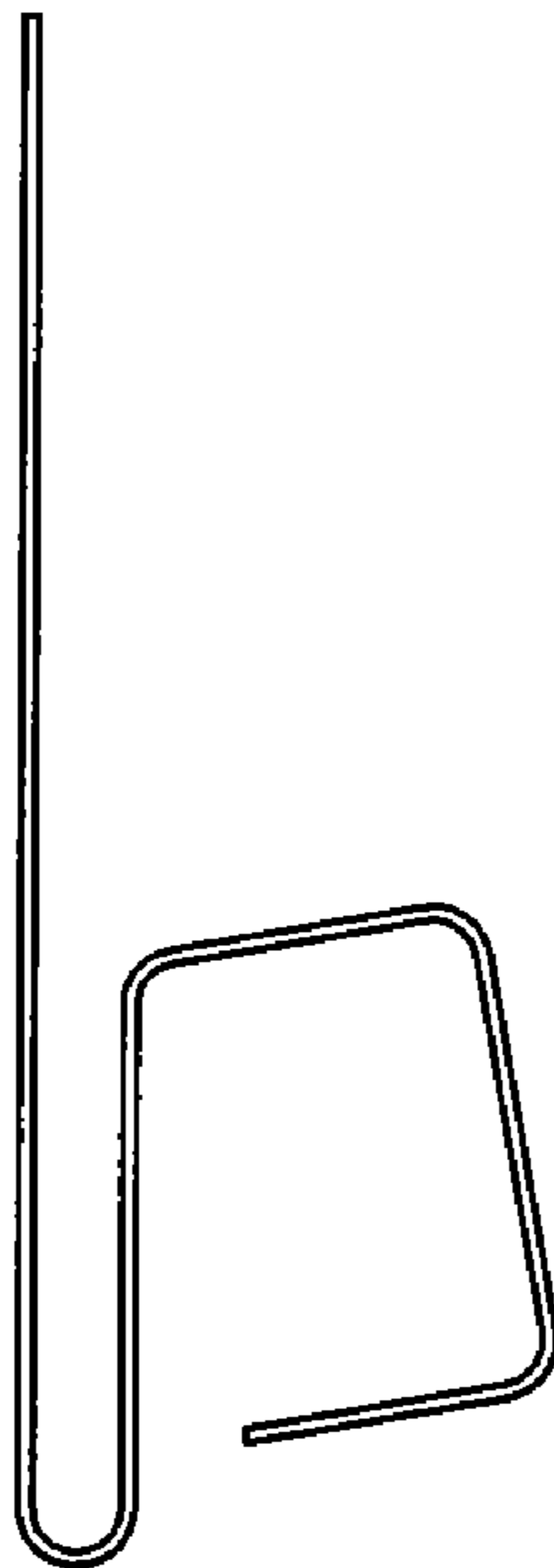

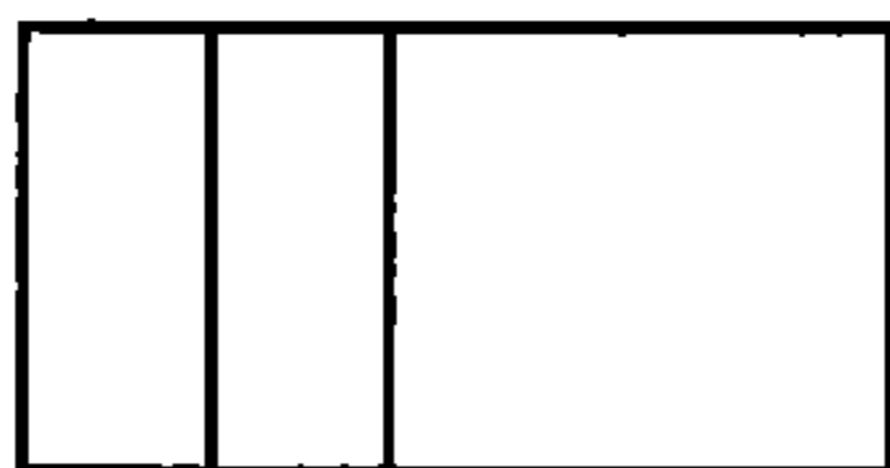

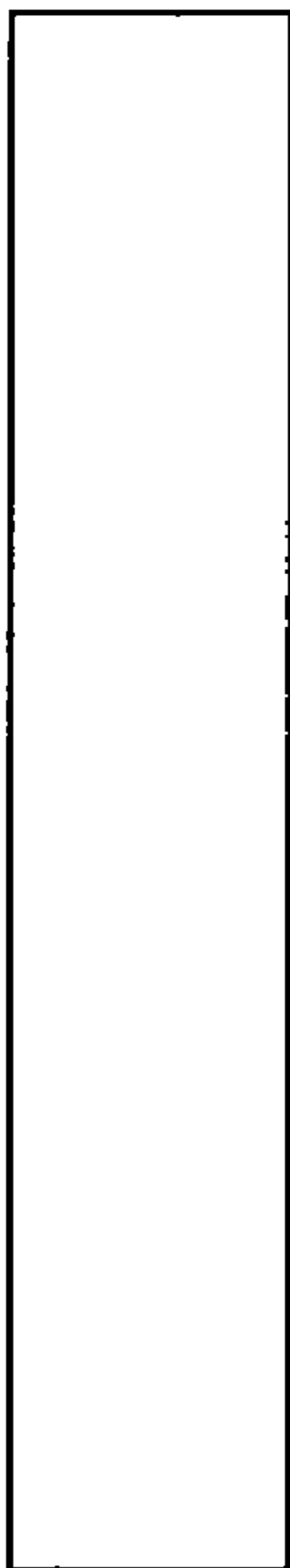
