(57) **CLAIM**

The ornamental design for a four-heart-clover pendant, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a four-heart-clover pendant showing my new design in an open position where the four hearts are aligned one next to the other;

FIG. 2 is a top plan view thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a right side elevational view thereof;

FIG. 5 is a rear elevational view thereof;

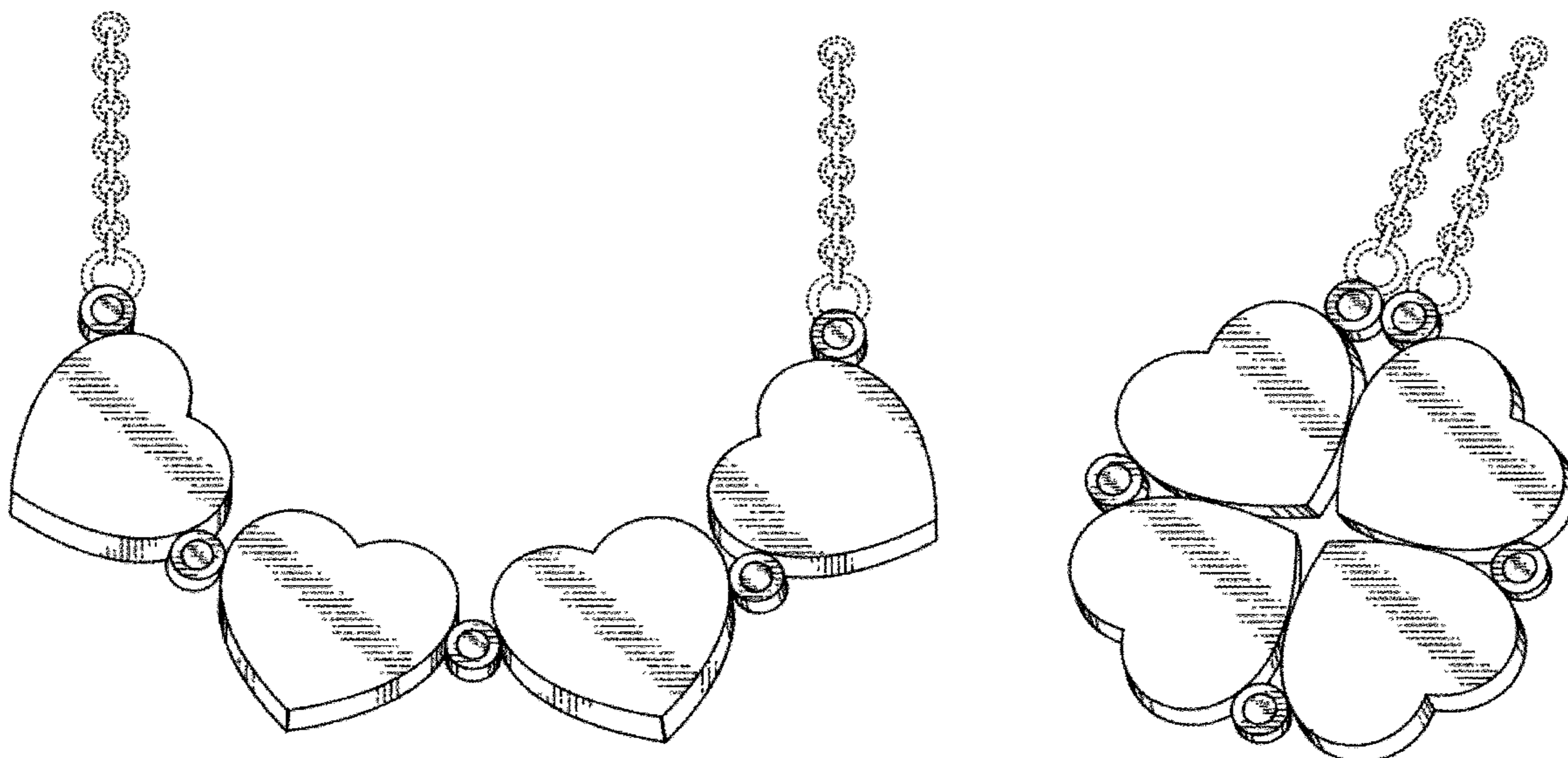
FIG. 6 is a bottom plan view thereof;

FIG. 7 is a left side elevational view thereof; and,

FIG. 8 is a perspective view of a four-heart-clover pendant showing my new design in a closed position where the four hearts are arranged in a four-heart clover manner.

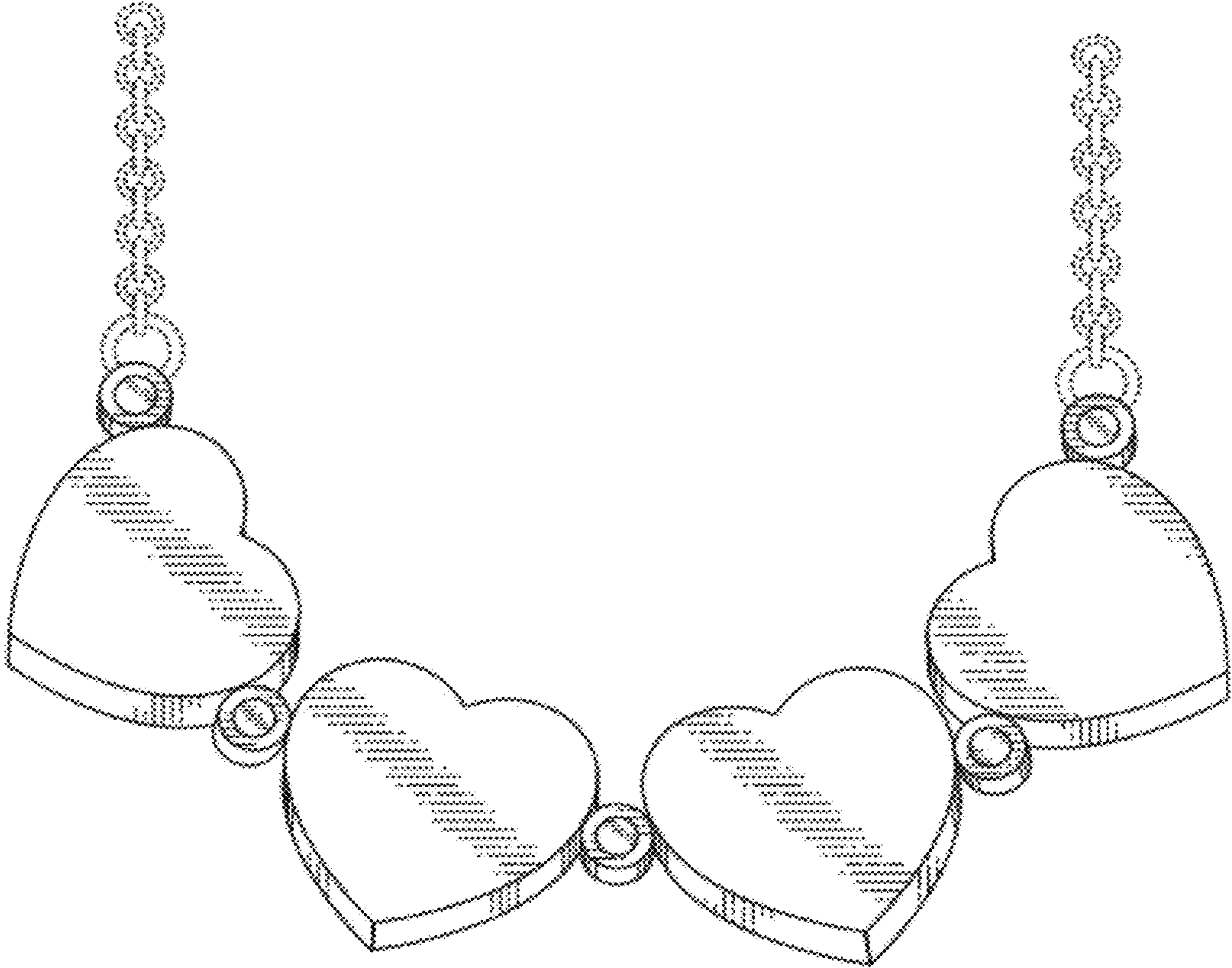

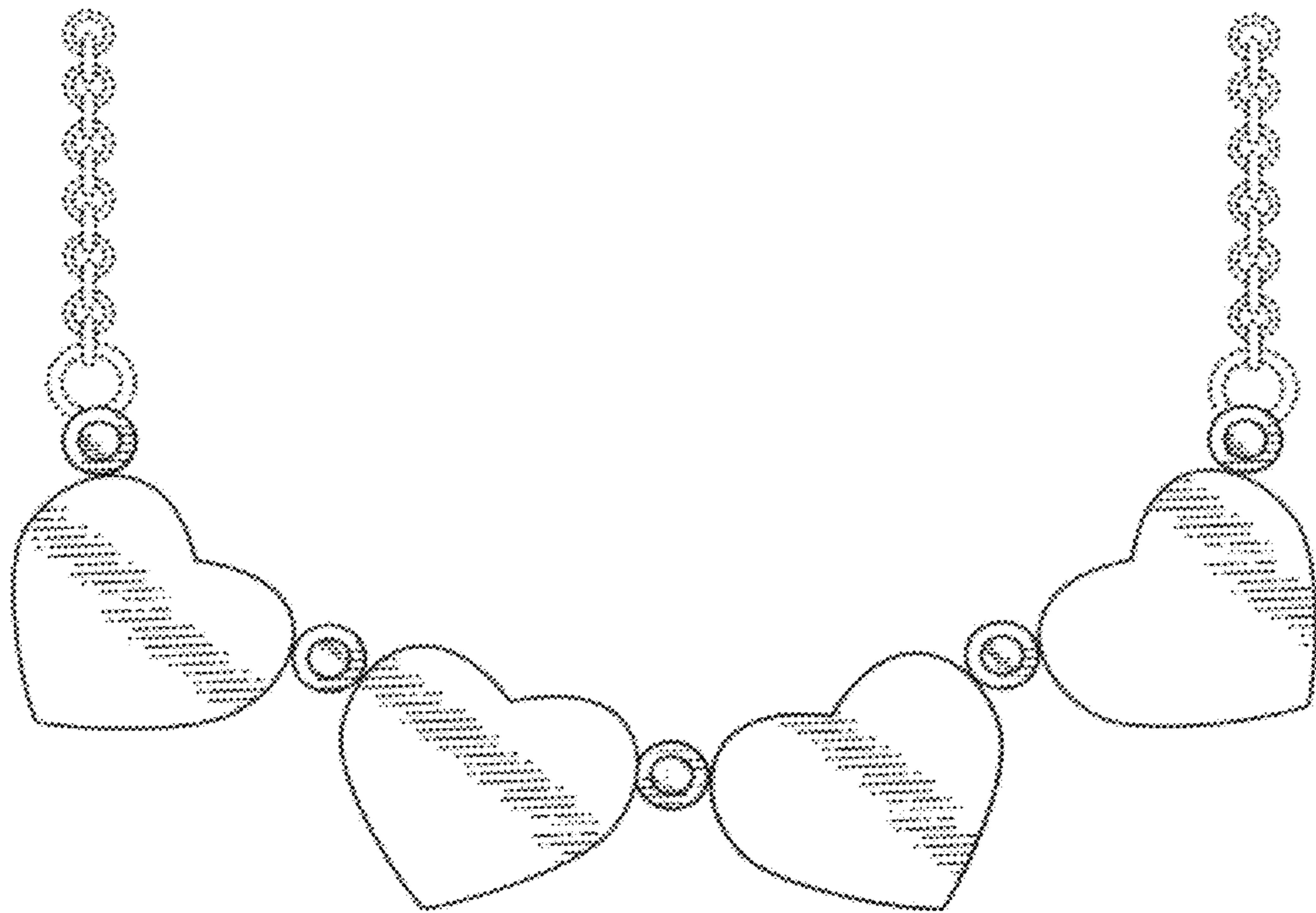

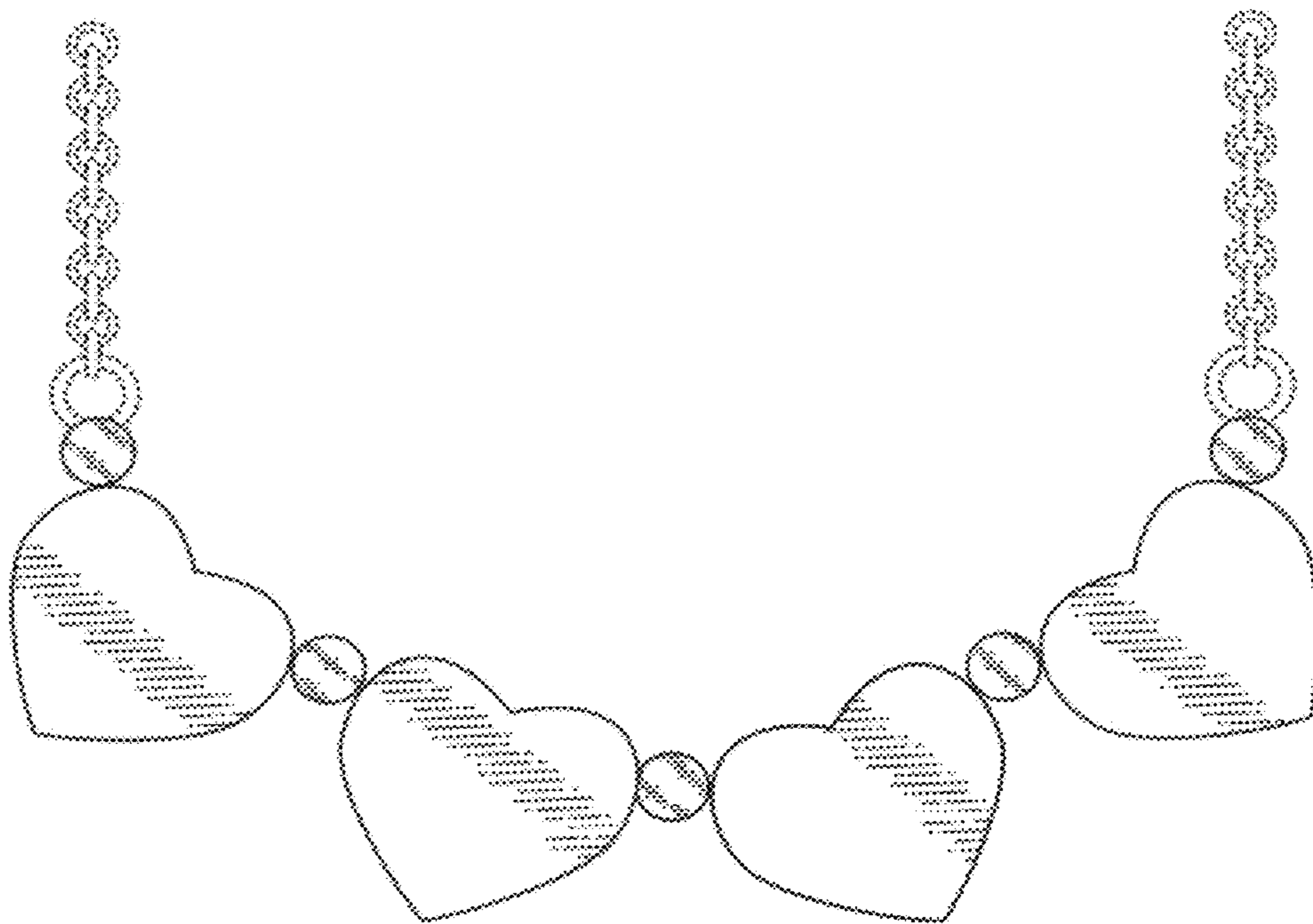

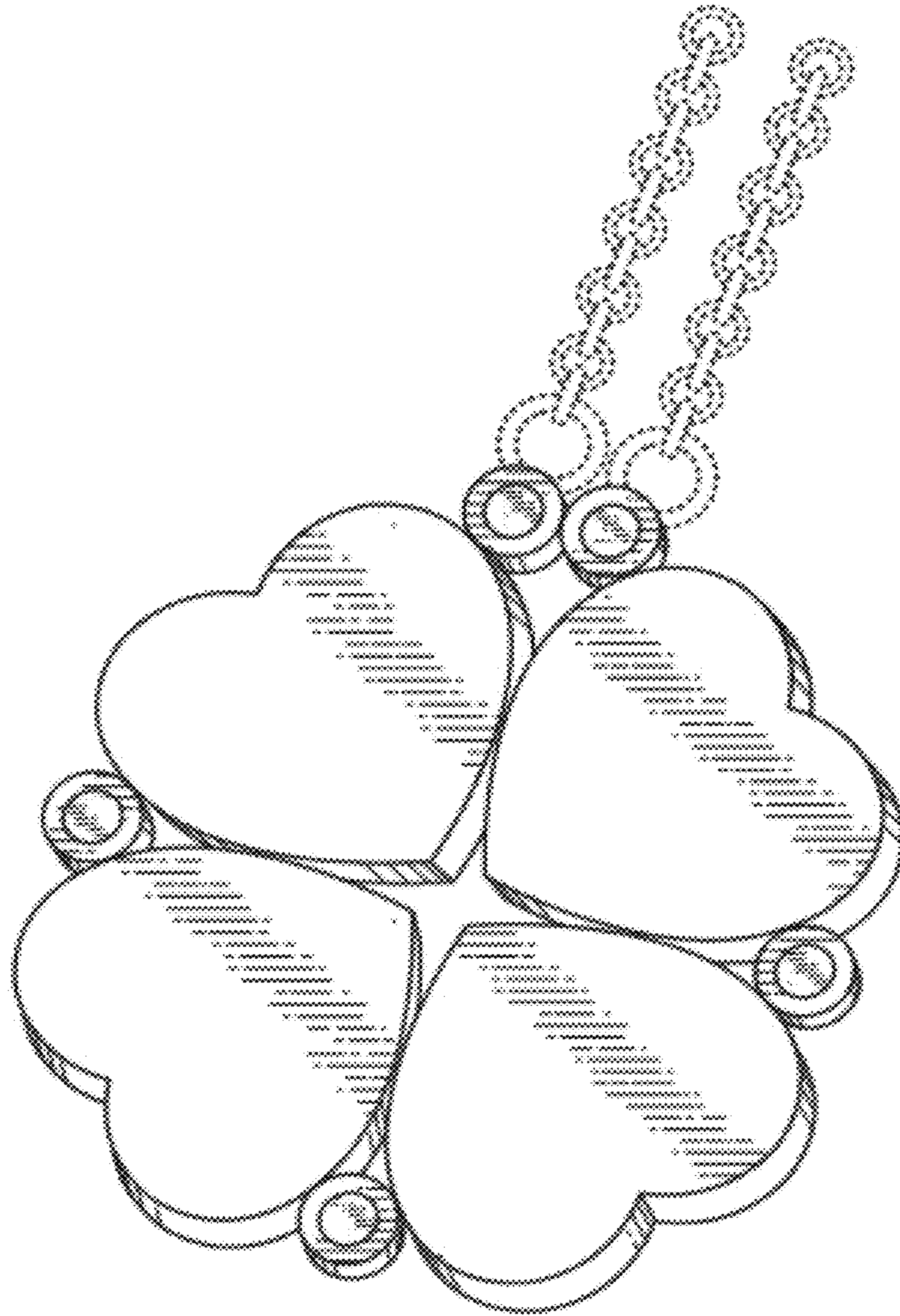
