(57) **CLAIM**

We claim the ornamental design for the all terrain vehicle, as shown and described.

DESCRIPTION

FIG. 1 is a right front perspective view of the all terrain vehicle;

FIG. 2 is a right rear perspective view of the all terrain vehicle;

FIG. 3 is a right-hand side view of the all terrain vehicle;

FIG. 4 is a left-hand side view of the all terrain vehicle;

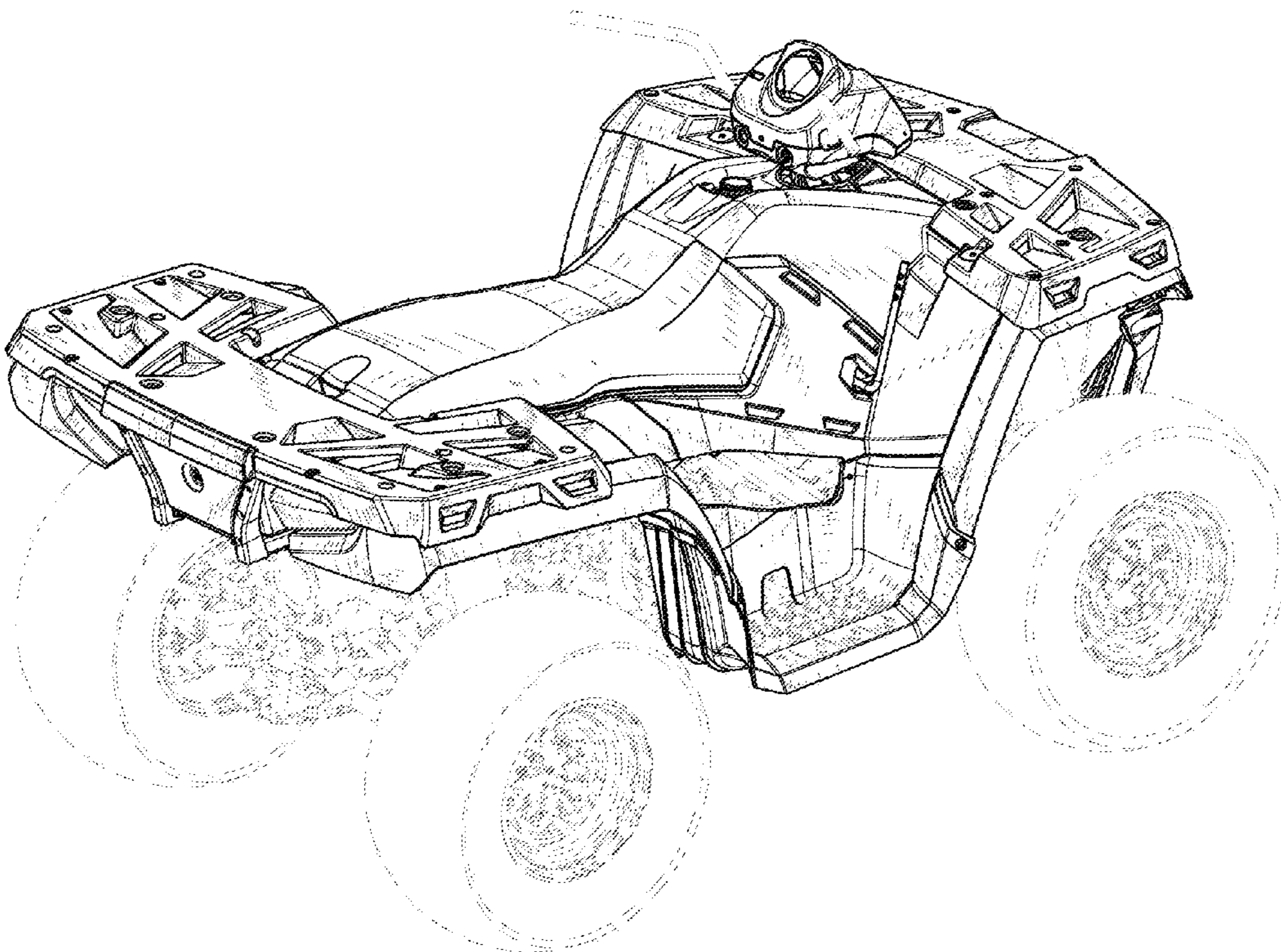
FIG. 5 is a front view of the all terrain vehicle;

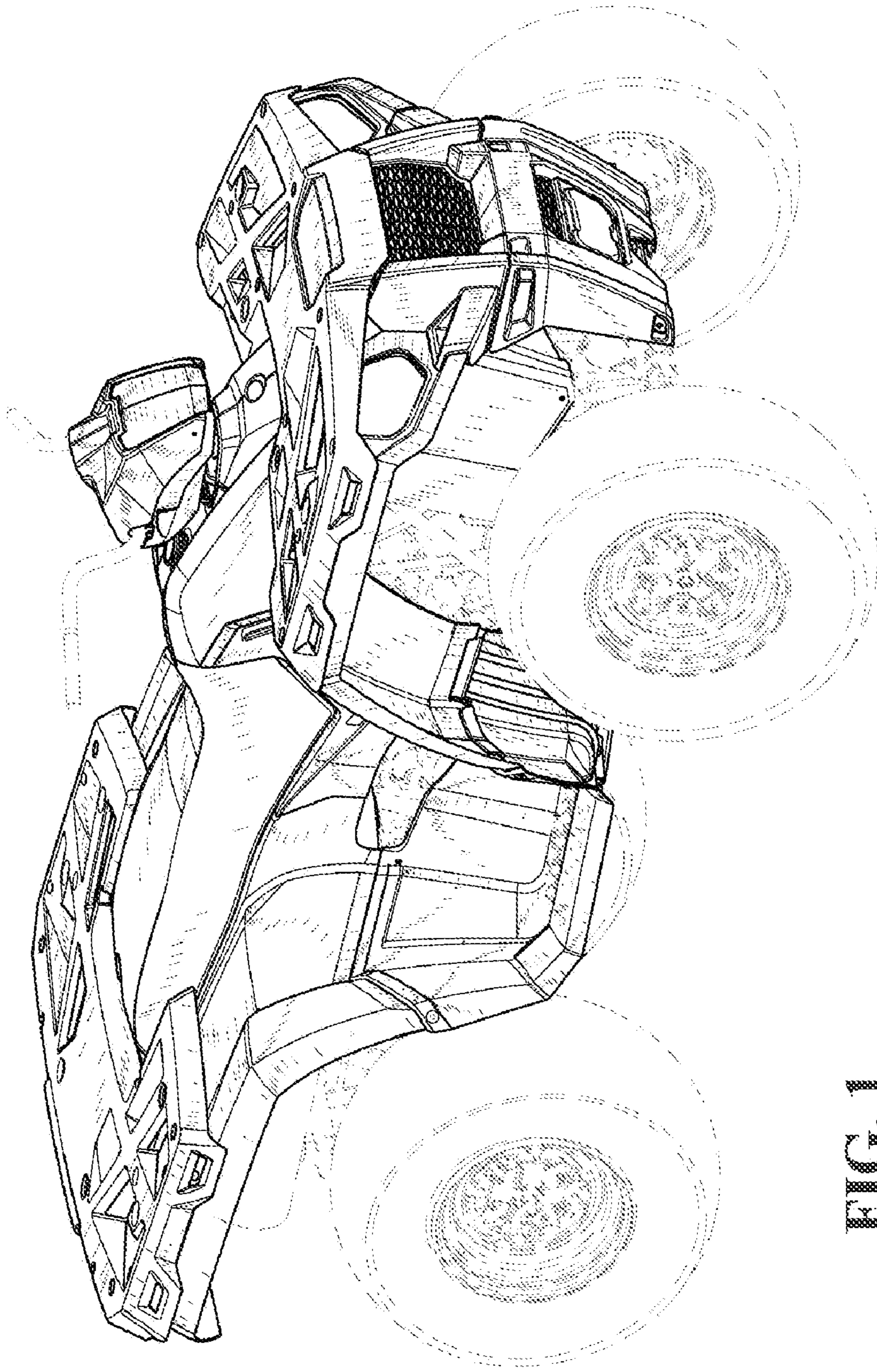

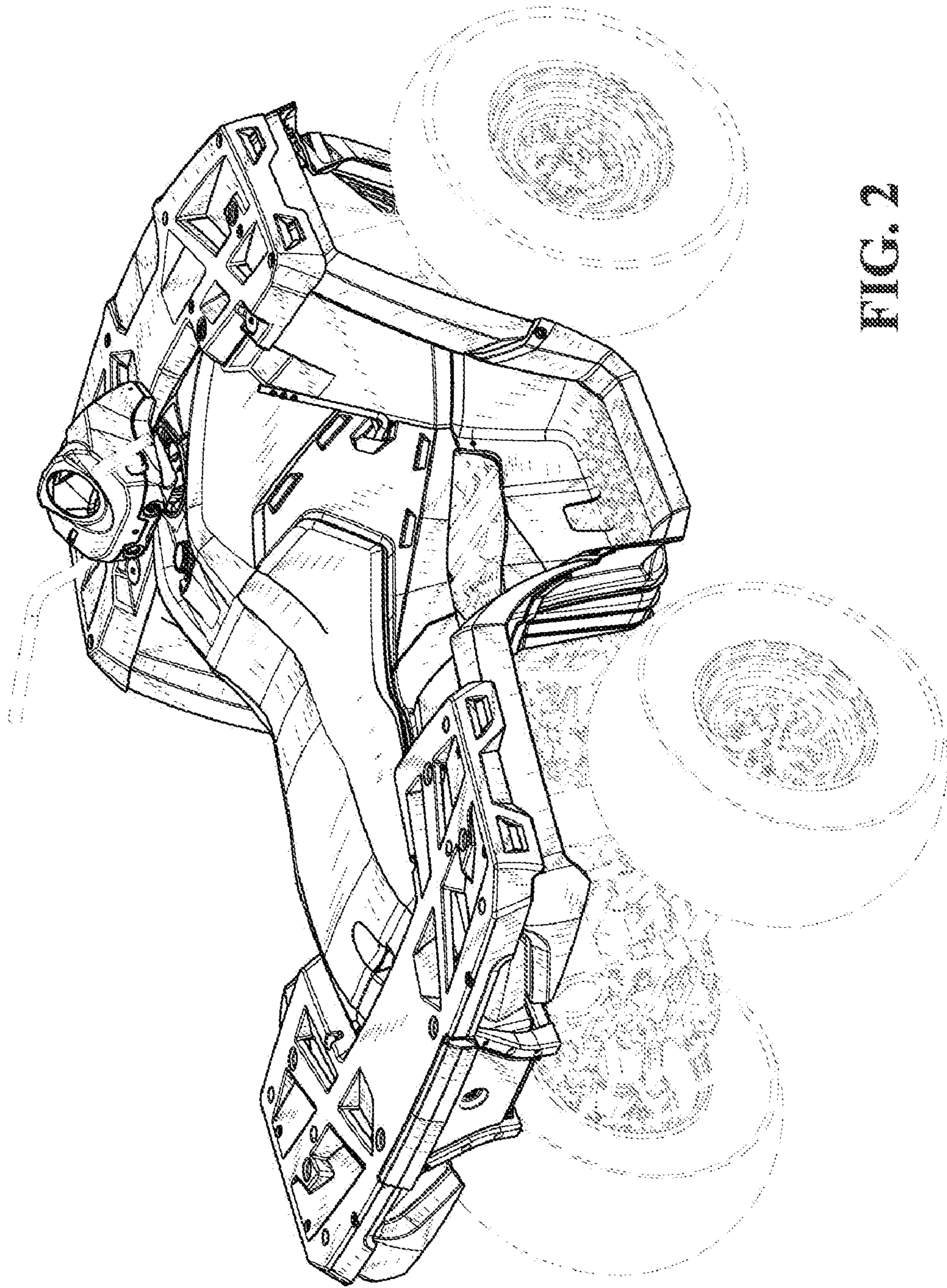

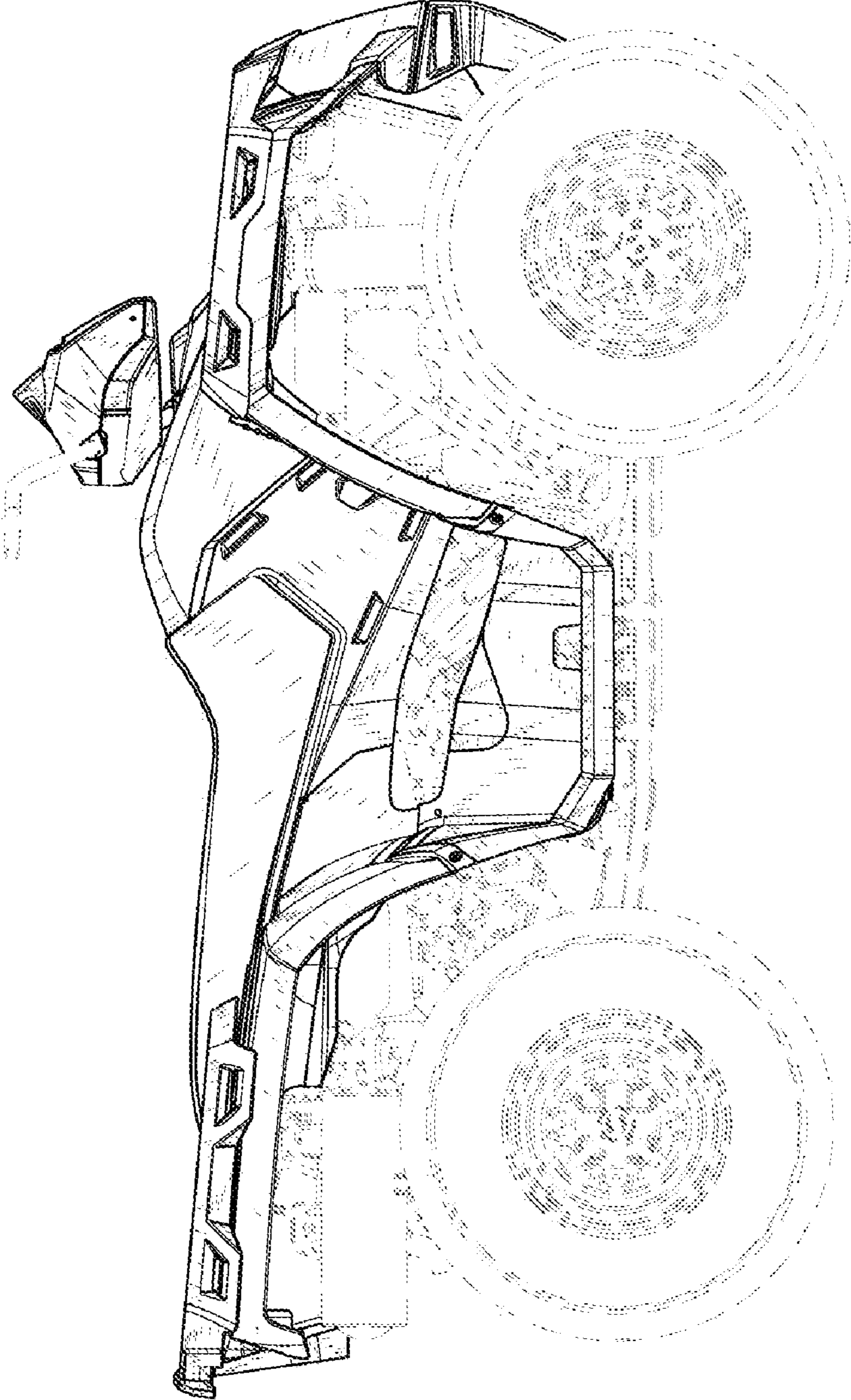

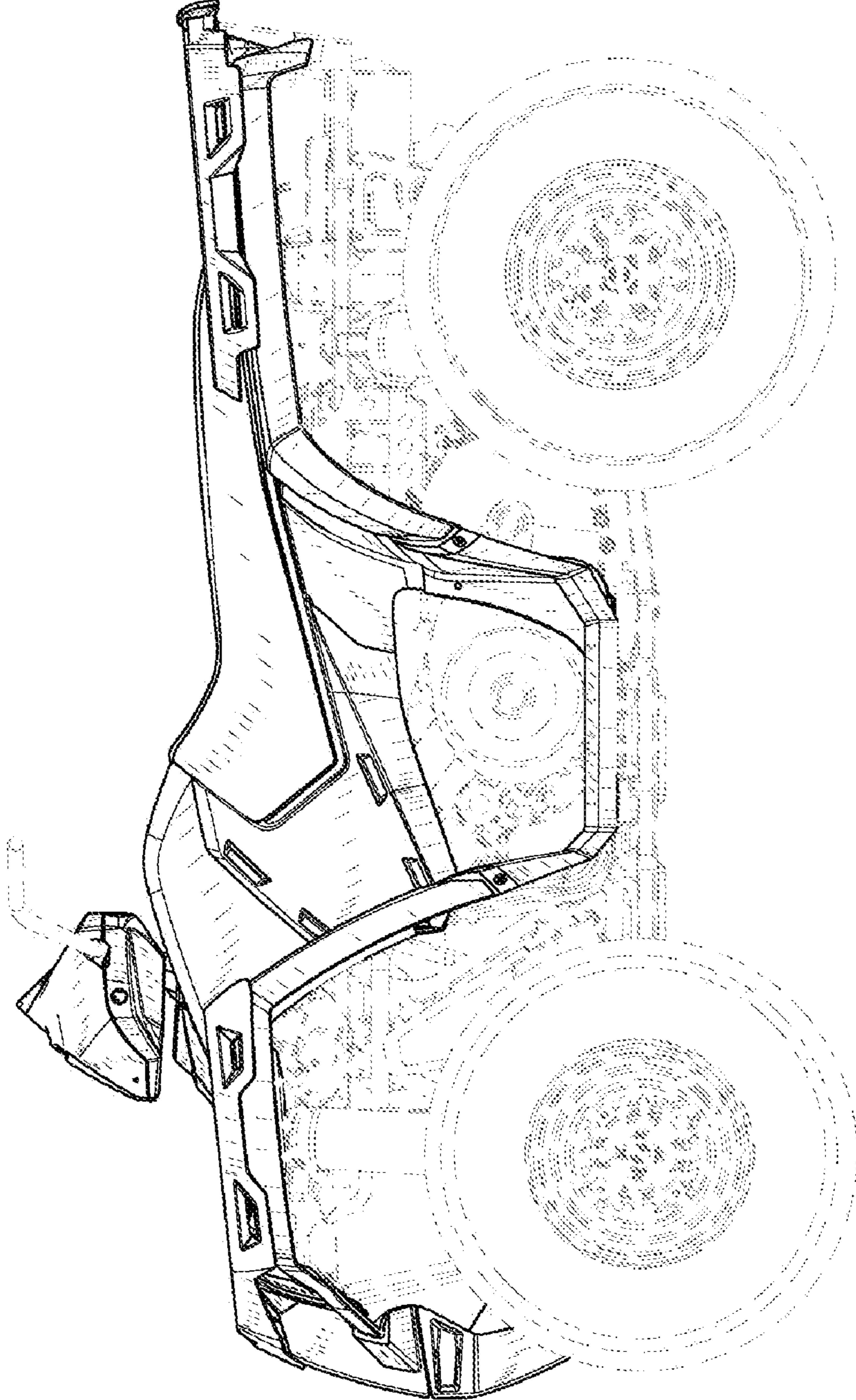

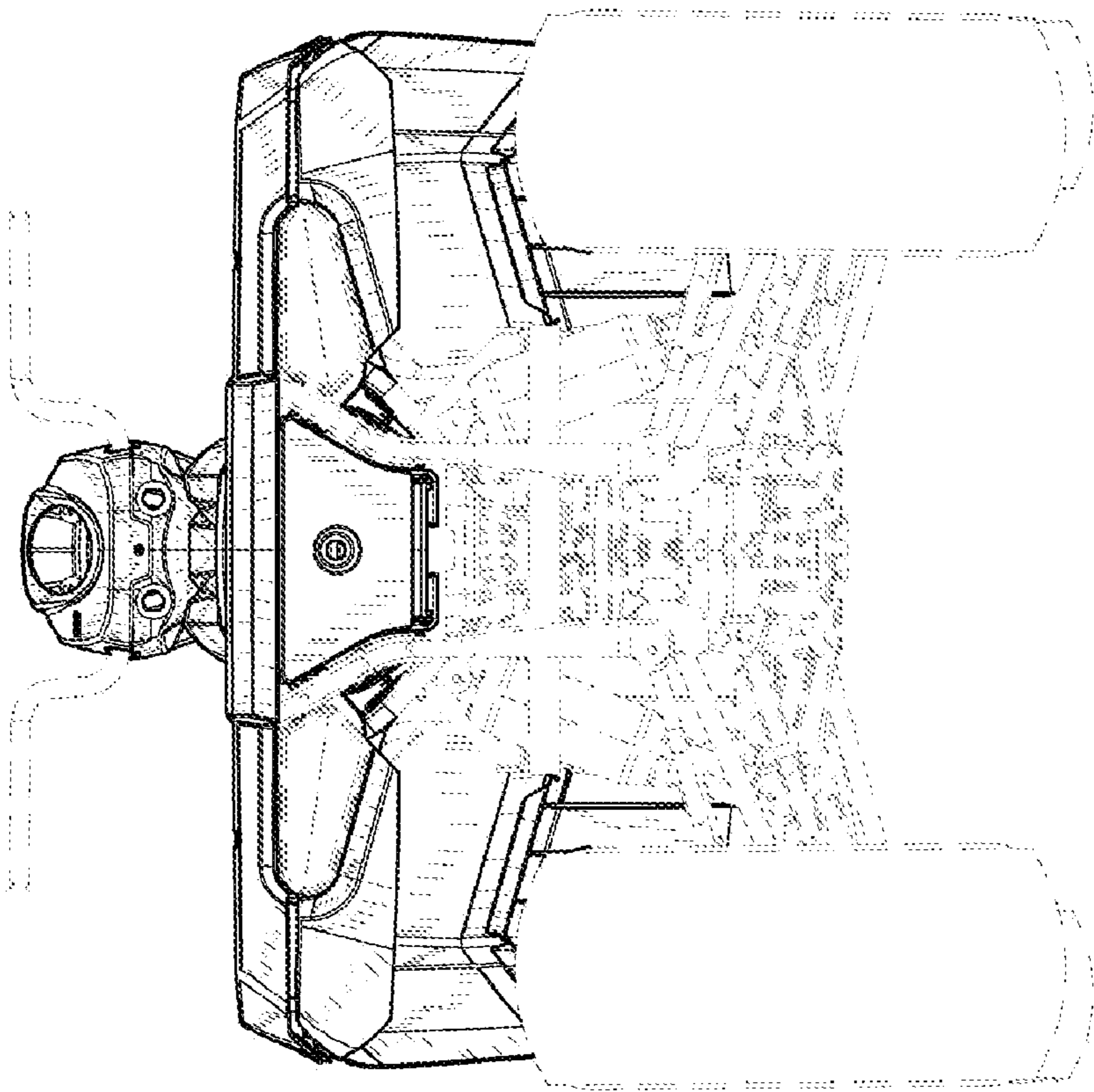

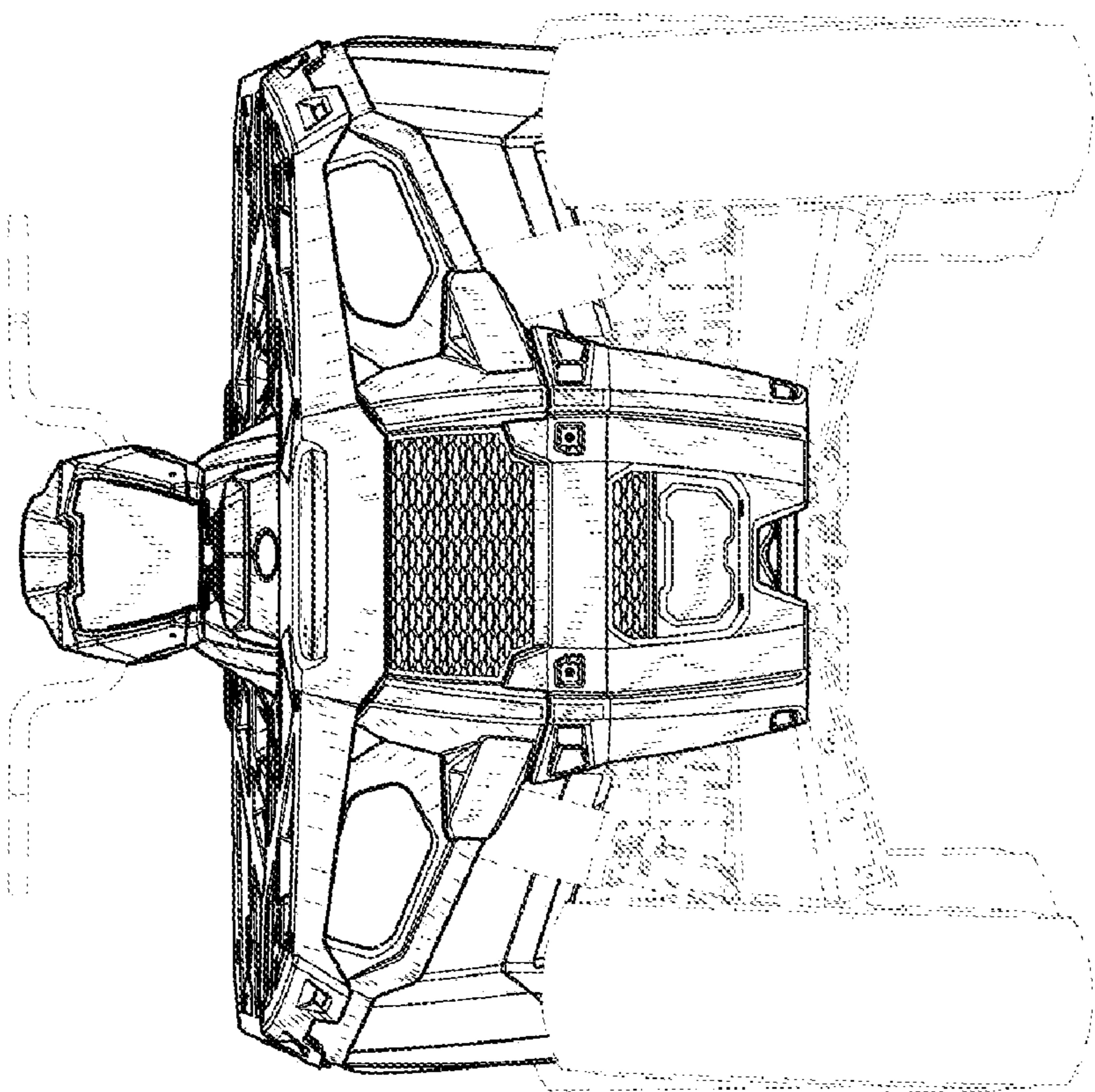

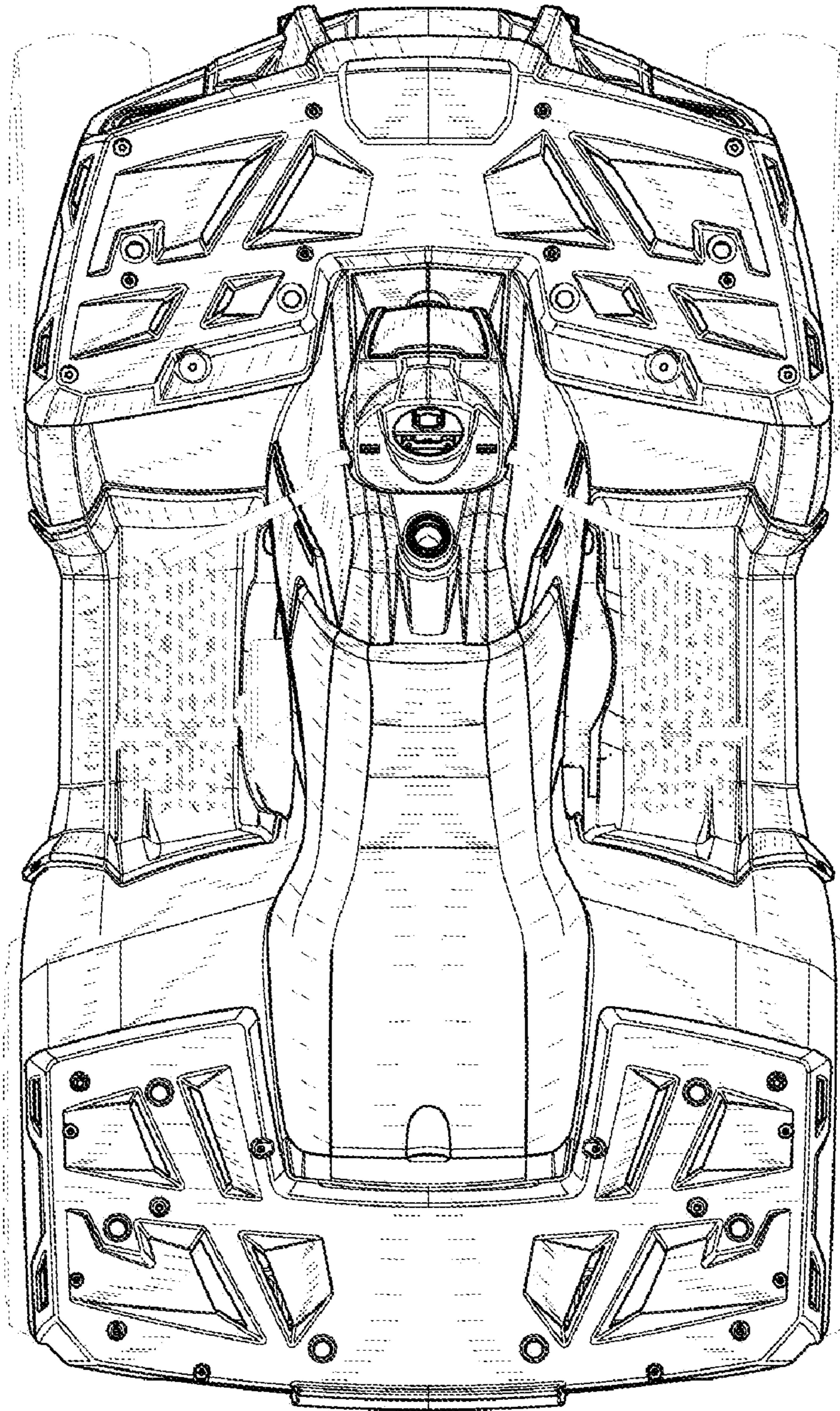
