(57) **CLAIM**

The ornamental design for the tarp with integral elastic cord, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a generally circular-shaped tarp with integral elastic cord in accordance with the present invention, shown in a relaxed or non-stretched state;

FIG. 2 is a top plan view of the tarp with integral elastic cord of FIG. 1;

FIG. 3 is a bottom plan view of the tarp with integral elastic cord of FIG. 1;

FIG. 4 is a side elevation of the tarp with integral elastic cord of FIG. 1;

FIG. 5 is an opposite side elevation of the tarp with integral elastic cord of FIG. 1;

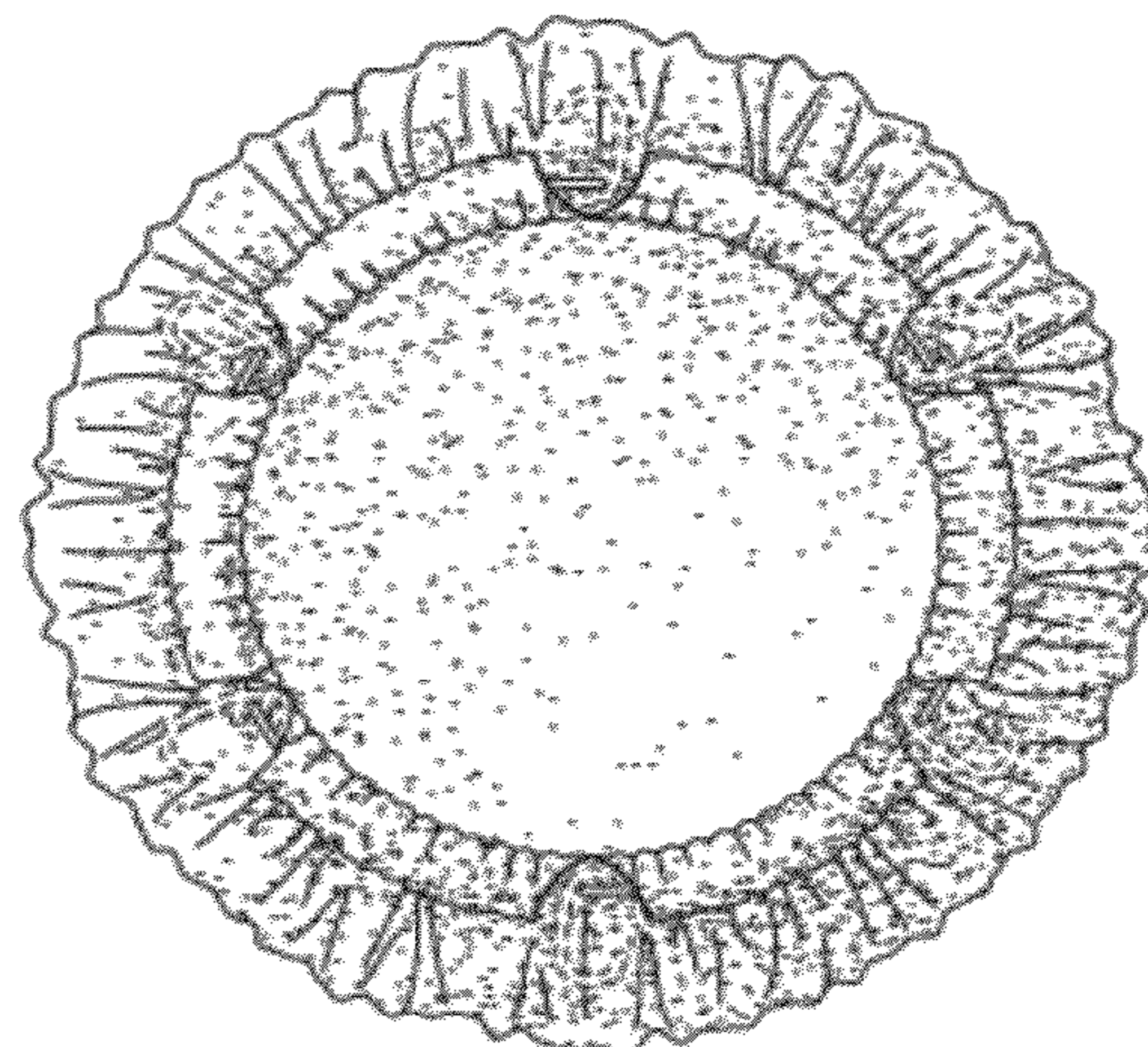
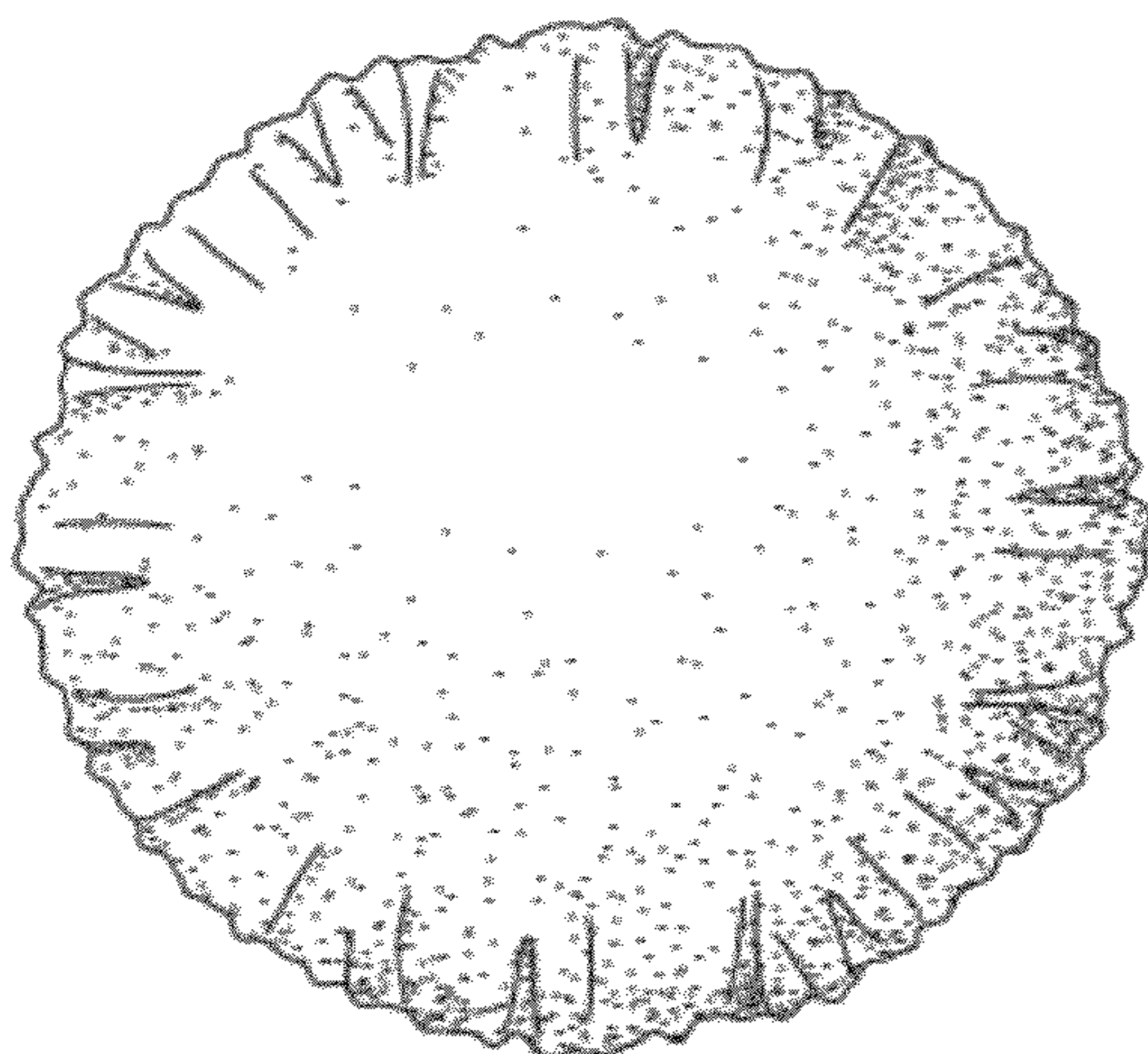
FIG. 6 is a top plan view of the tarp with integral elastic cord of FIG. 1, shown in a stretched state;

FIG. 7 is a bottom plan view of the tarp with integral elastic cord of FIG. 6; and,

FIG. 8 is a side elevation of the tarp with integral elastic cord of FIG. 6.

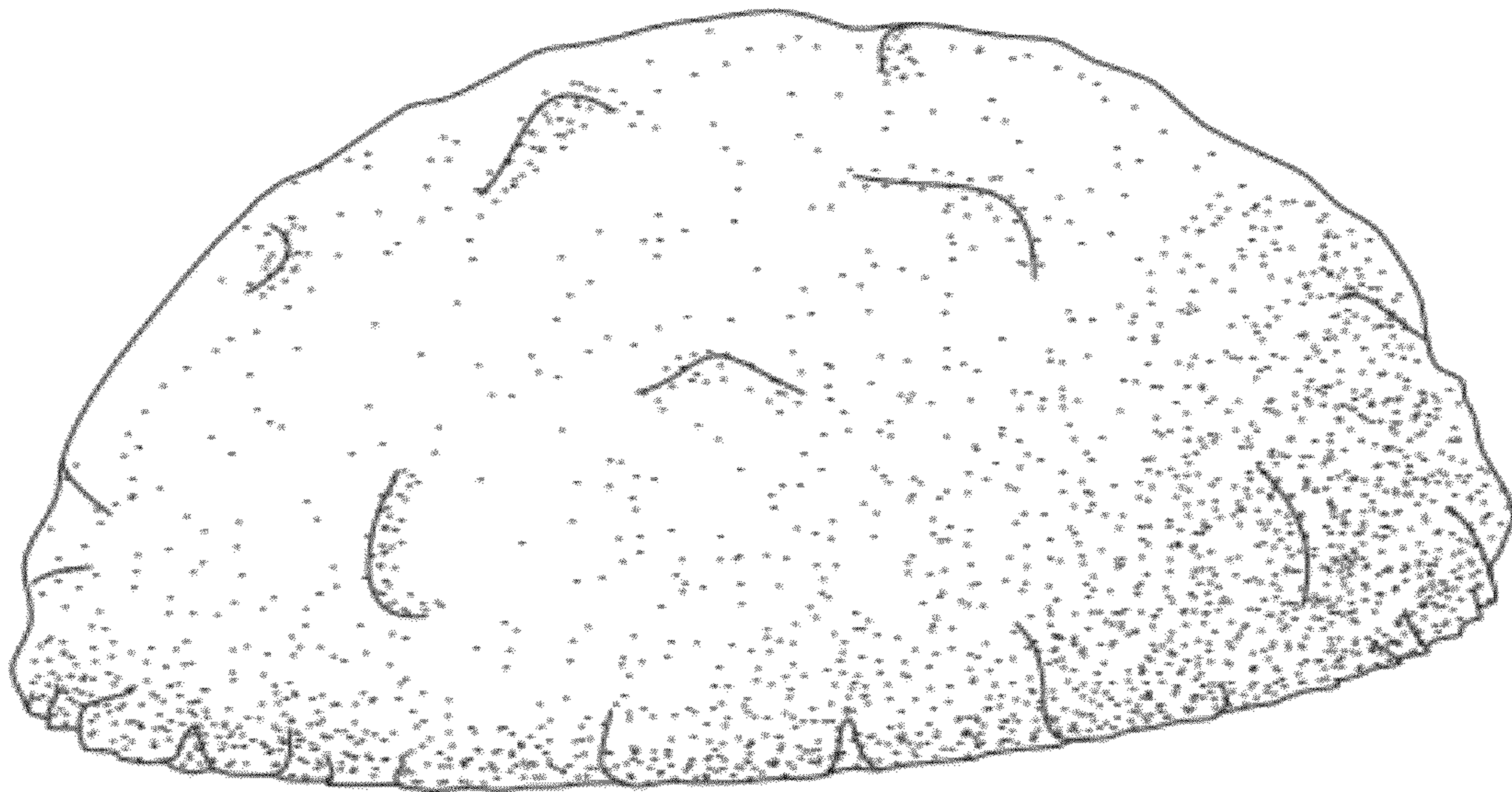

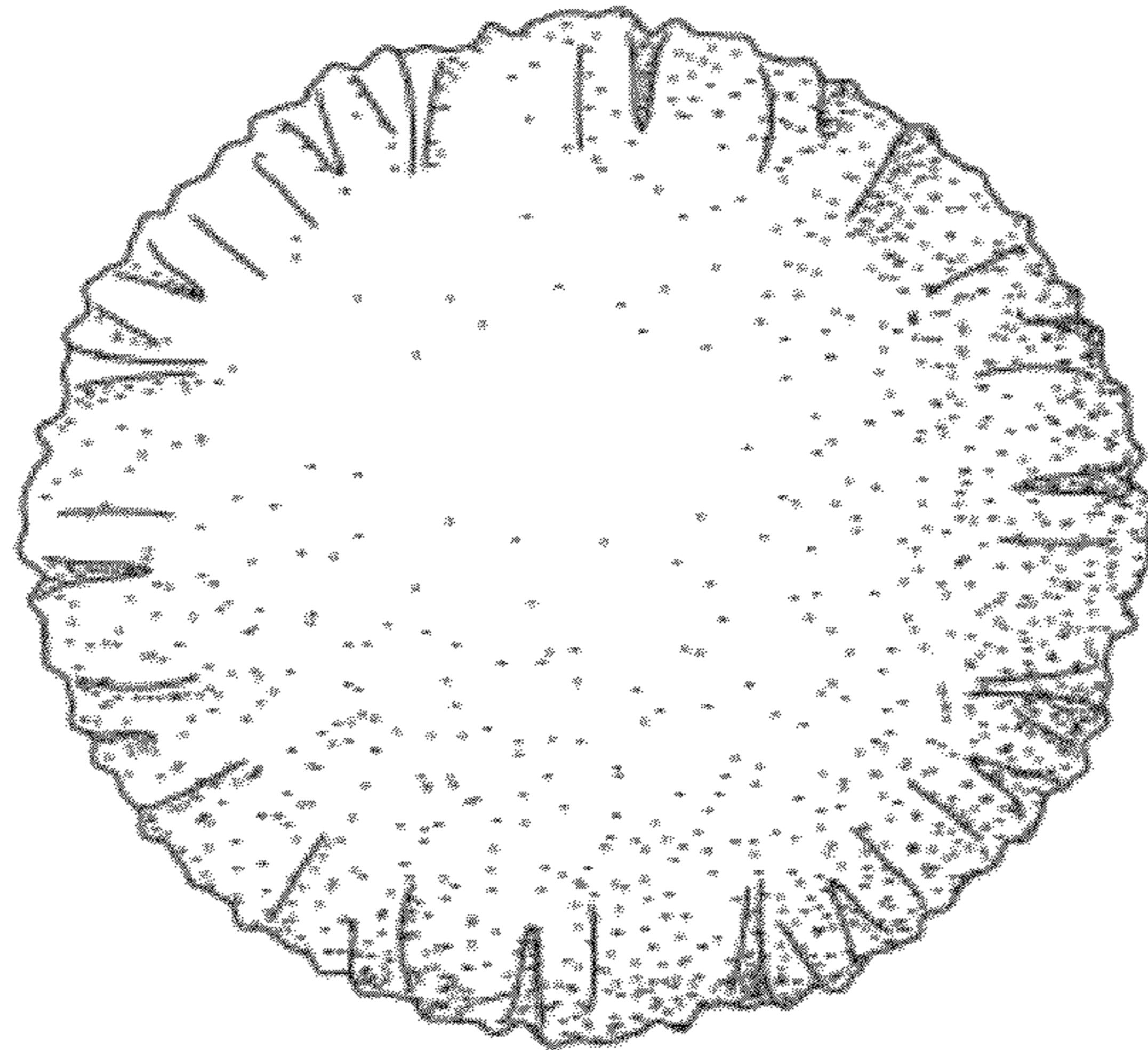

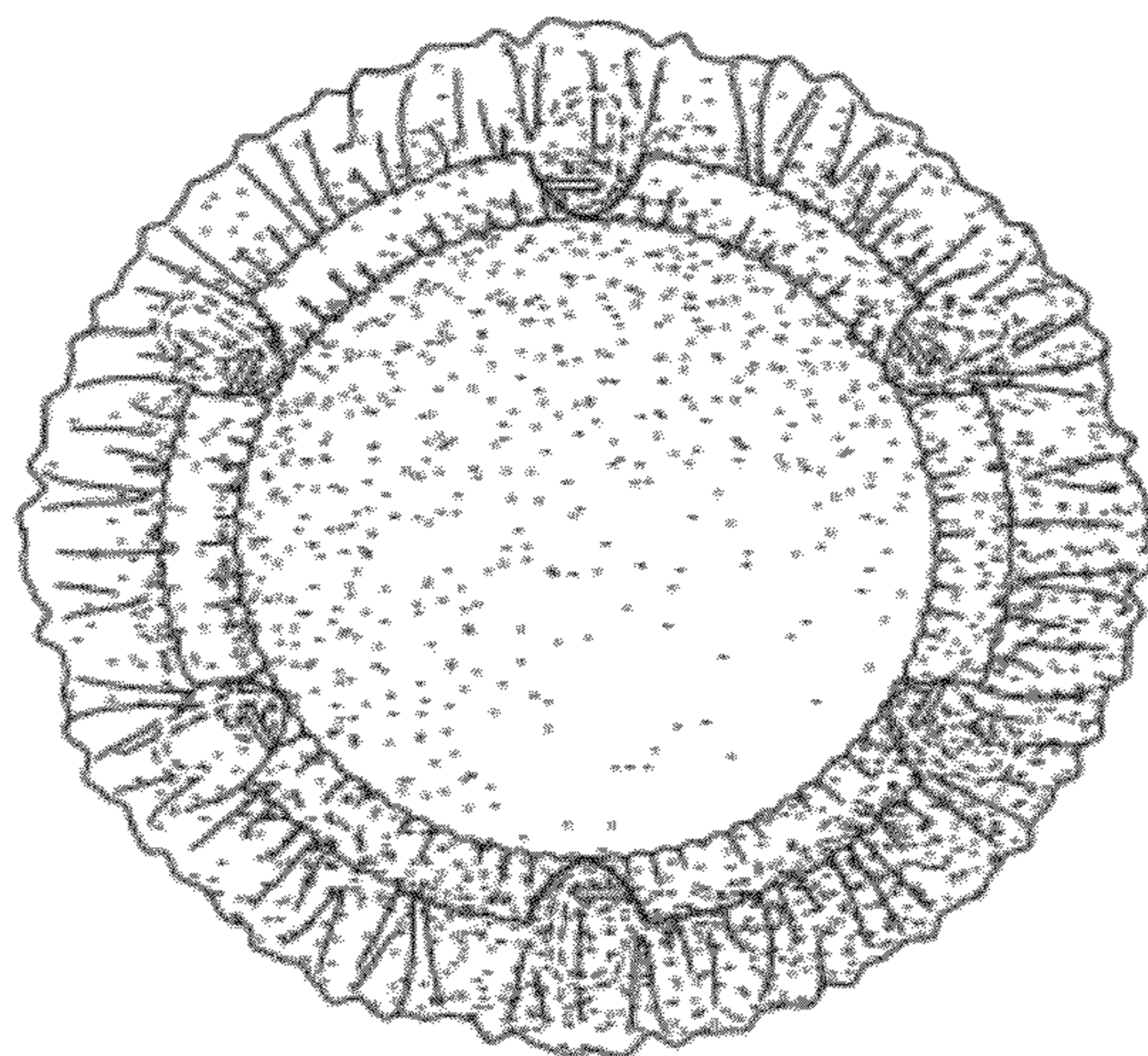

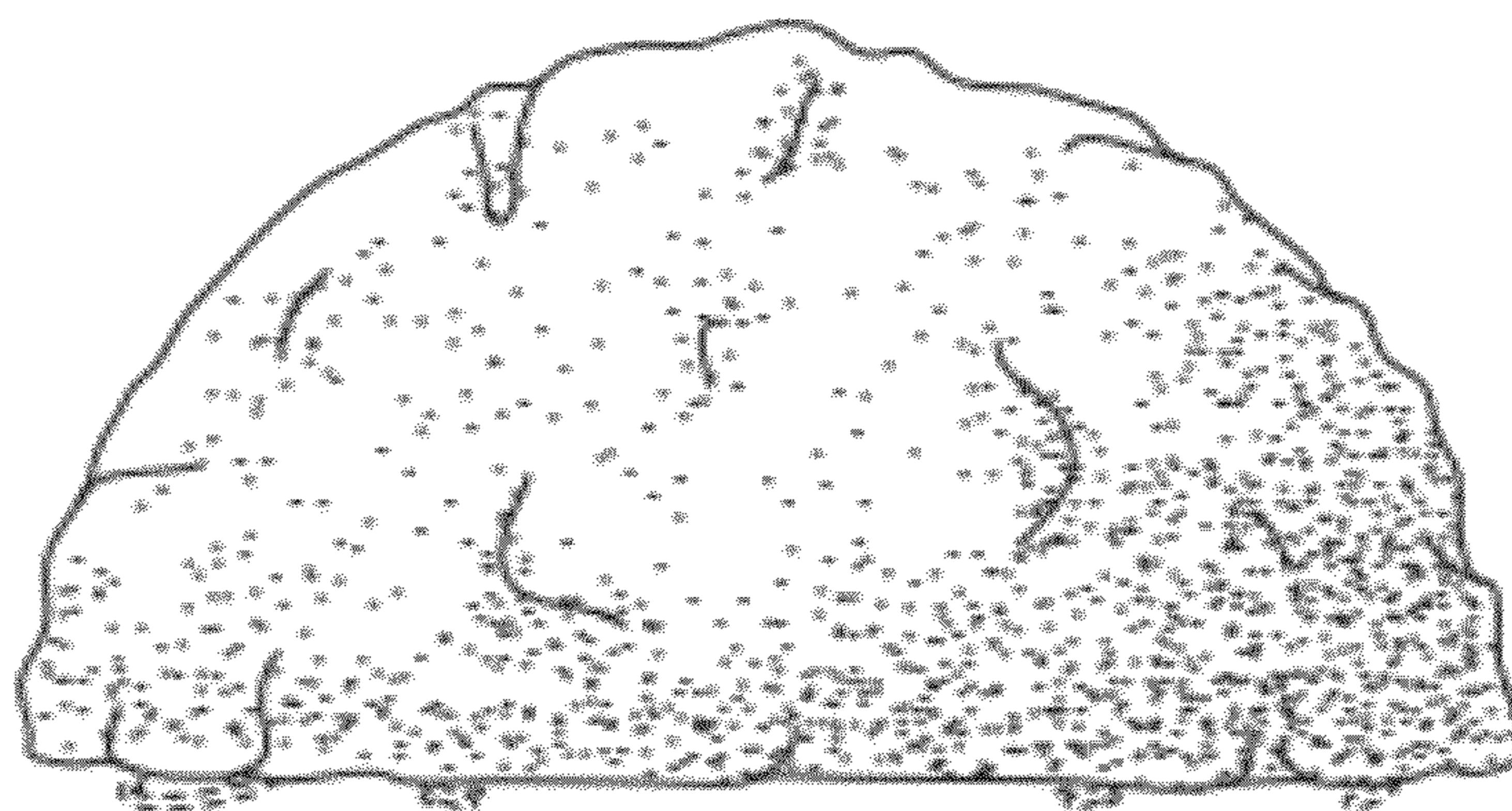

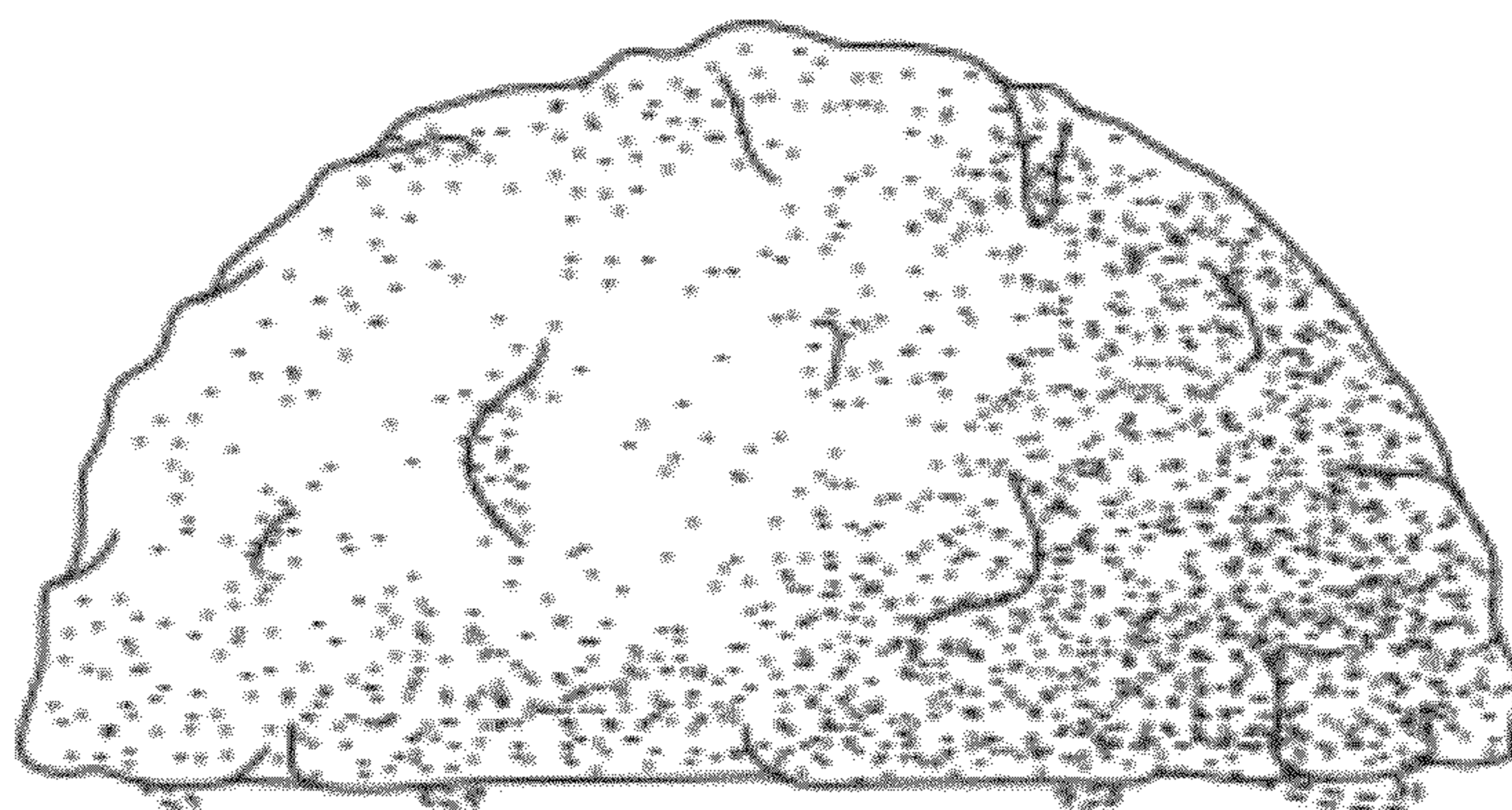

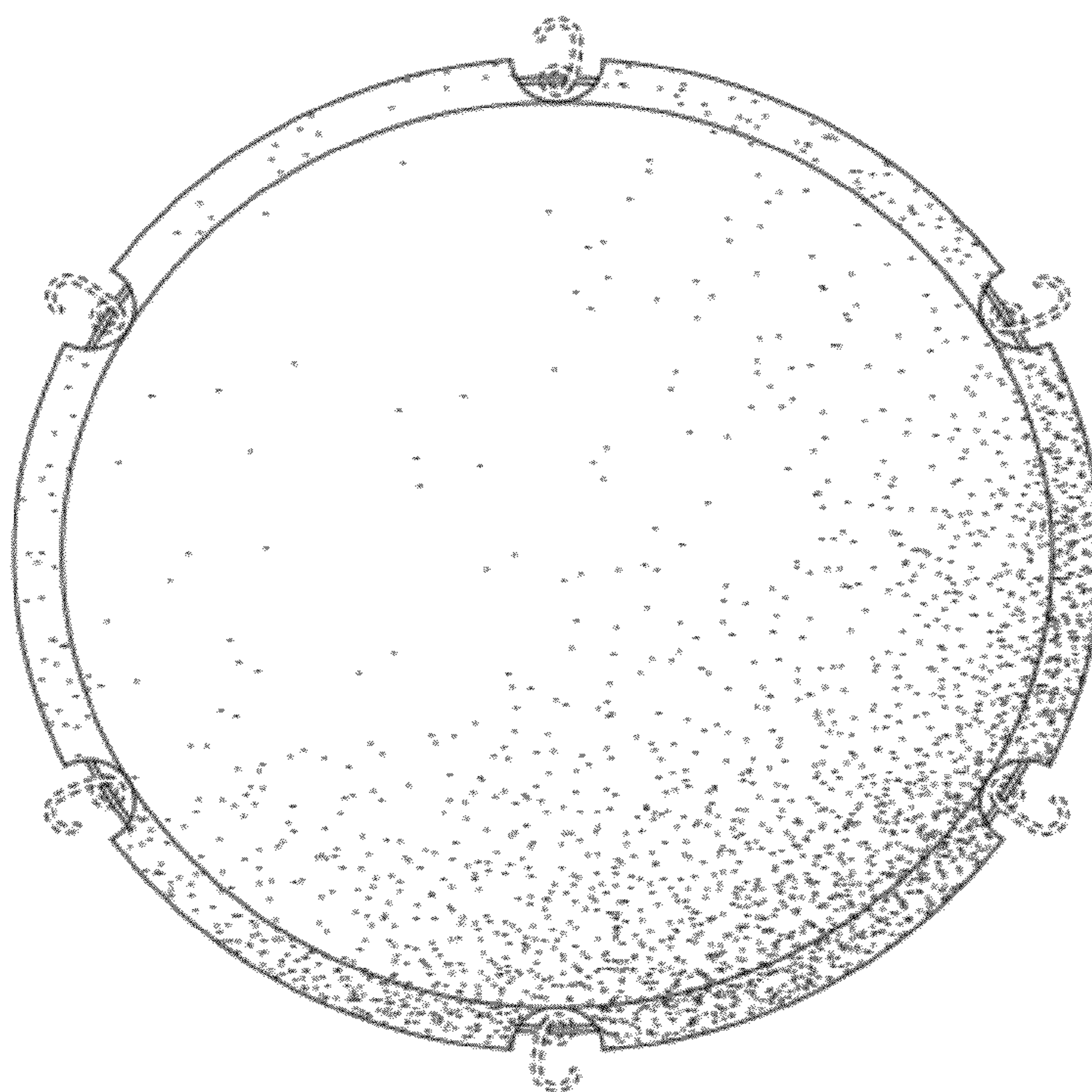

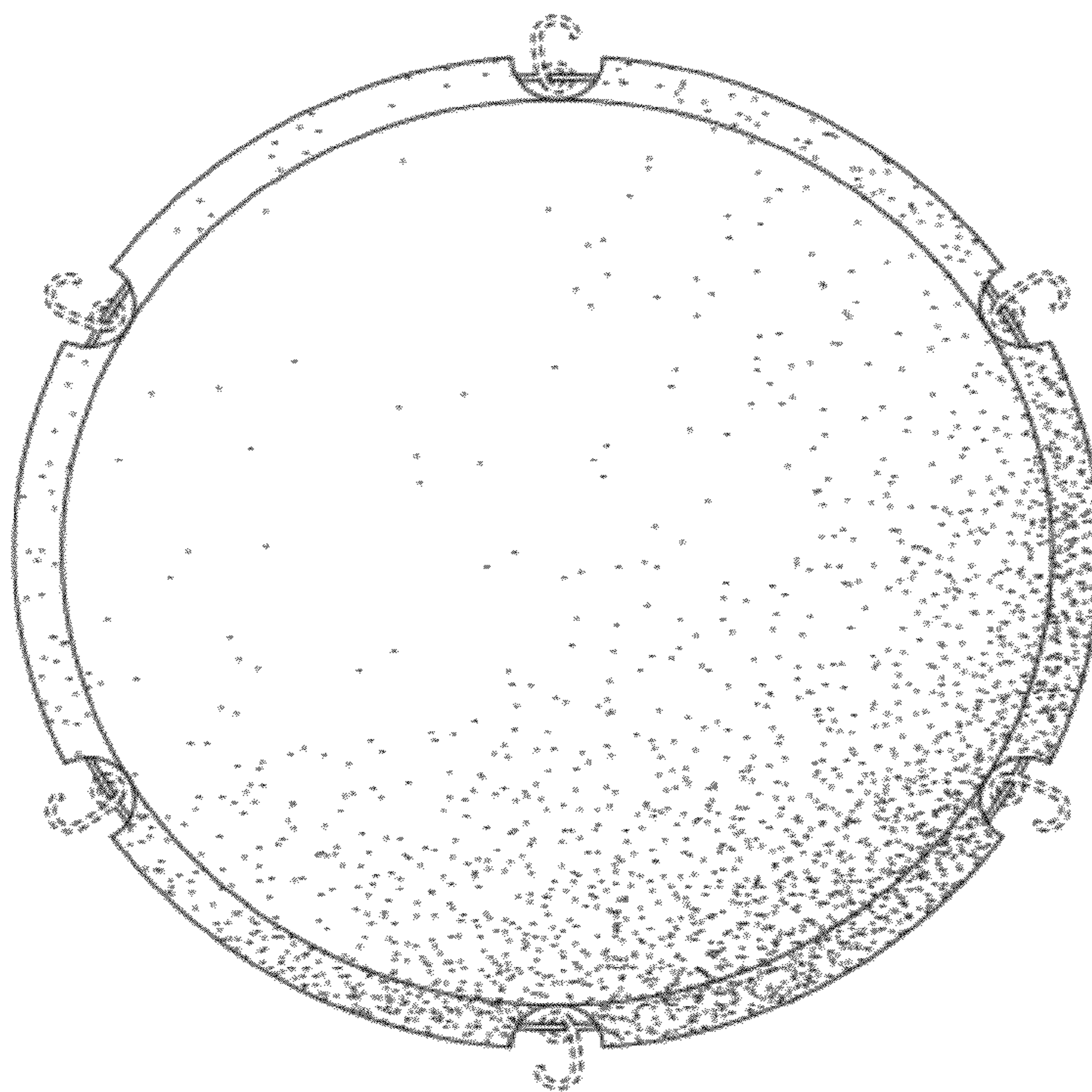

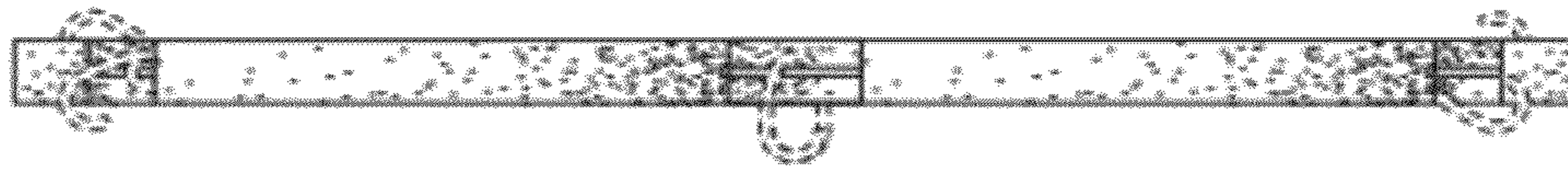
