FIG. 4 shows a right side view of the Design.

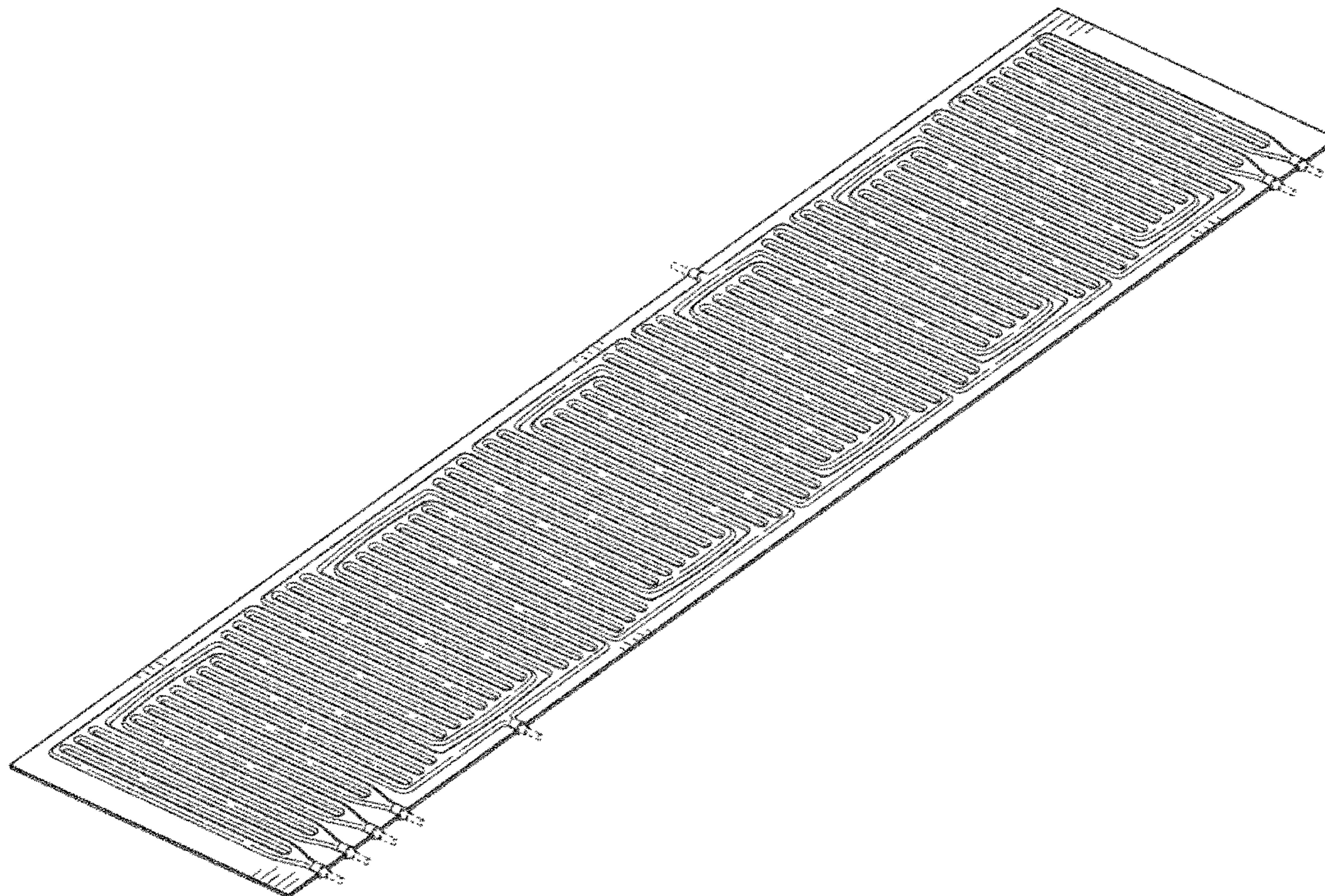
FIG. 5 shows a left side view of the Design.

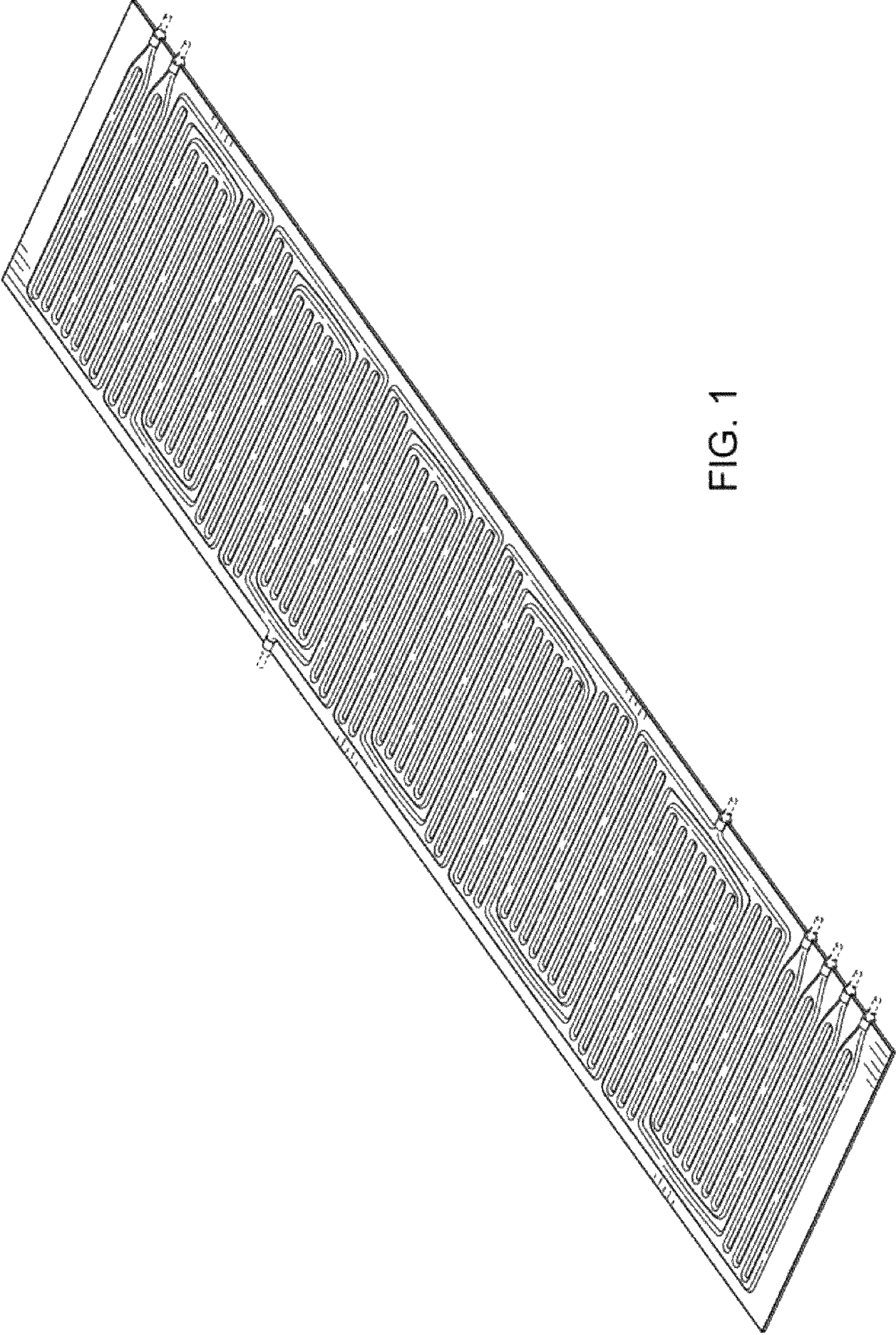

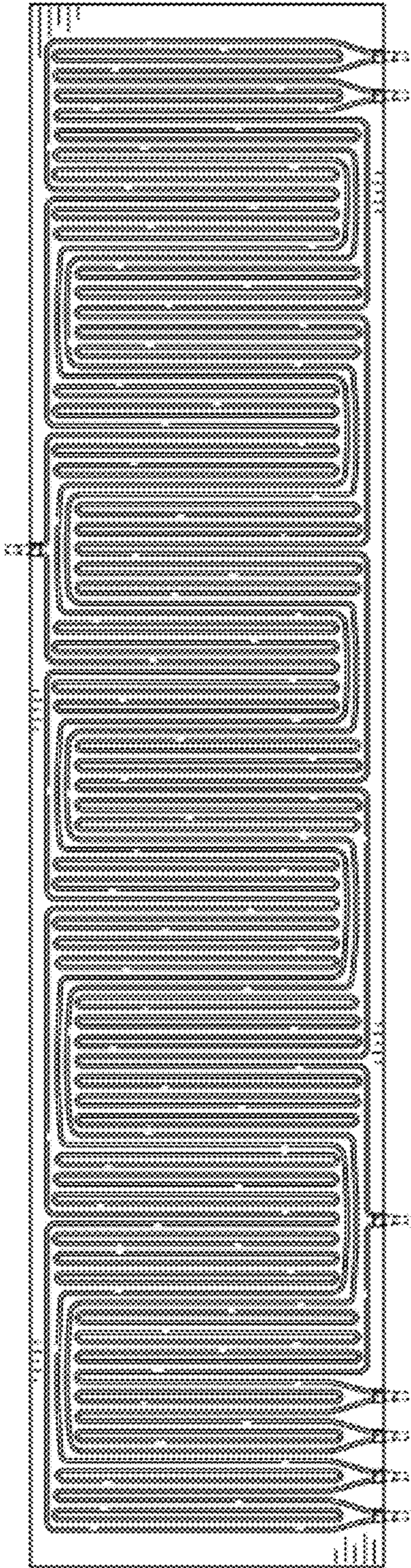

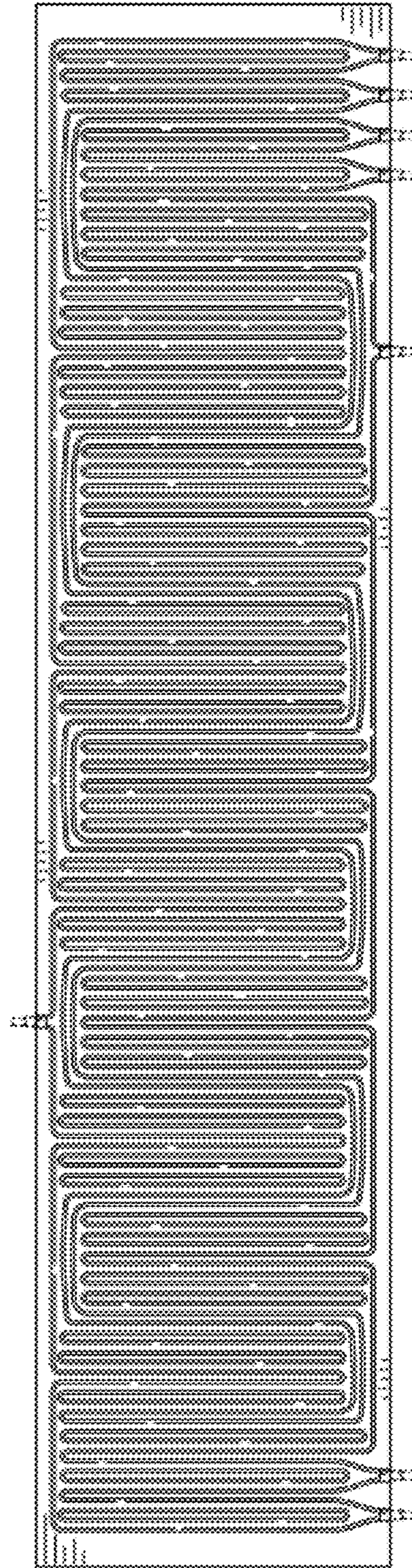

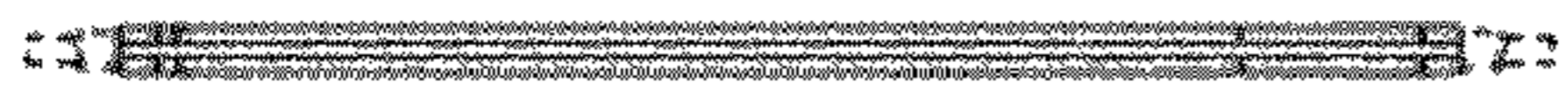
