The ornamental design for a portion of a dental implant, as shown and described.

**DESCRIPTION**

FIG. 1 is a side elevational view of a thread and neck portion of a dental implant according to our new design; the broken lines showing an upper abutment portion is included for the purpose of illustrating the environment and forms no part of the claimed design;

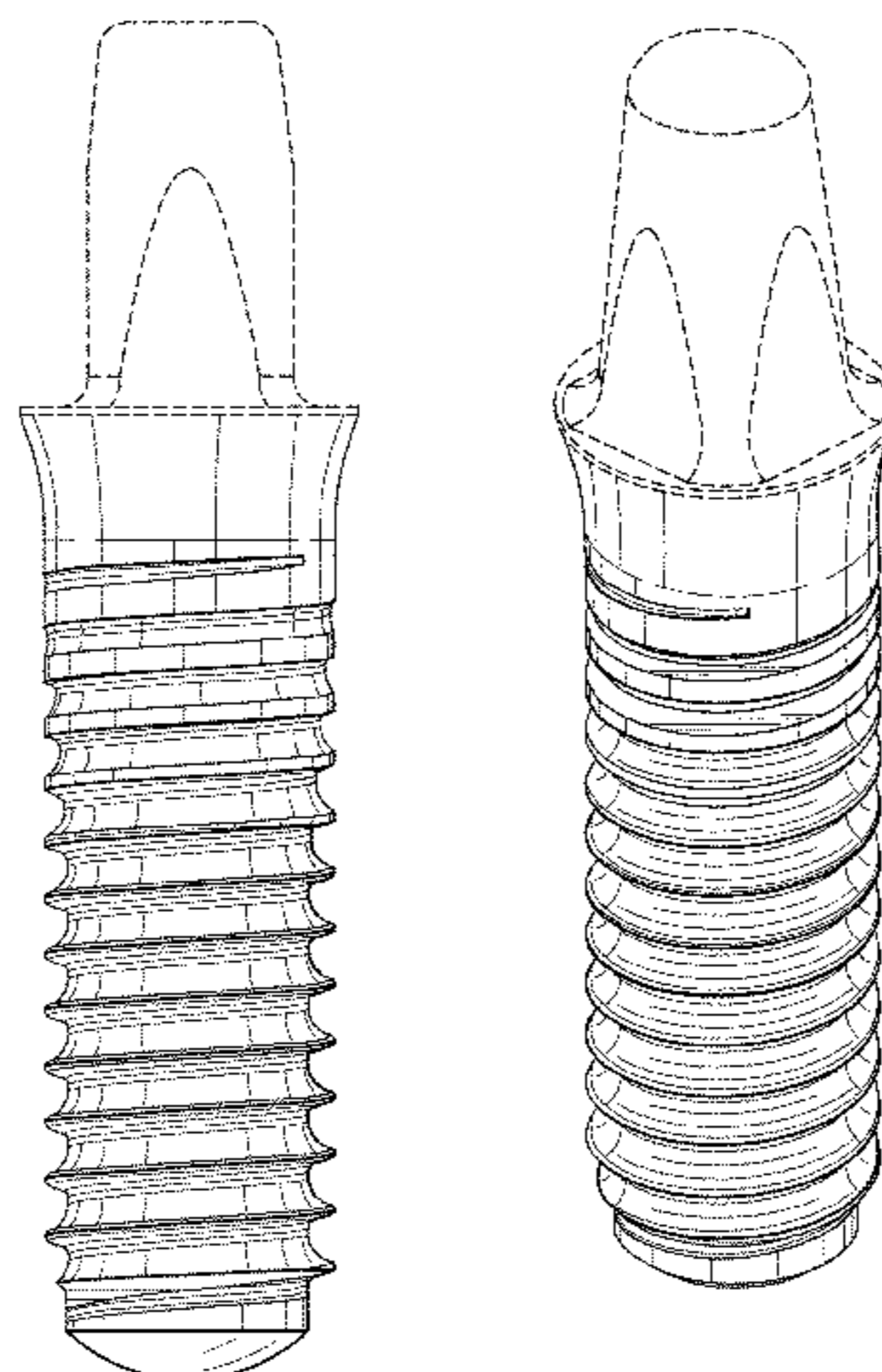
FIG. 2 is an end elevational view thereof;

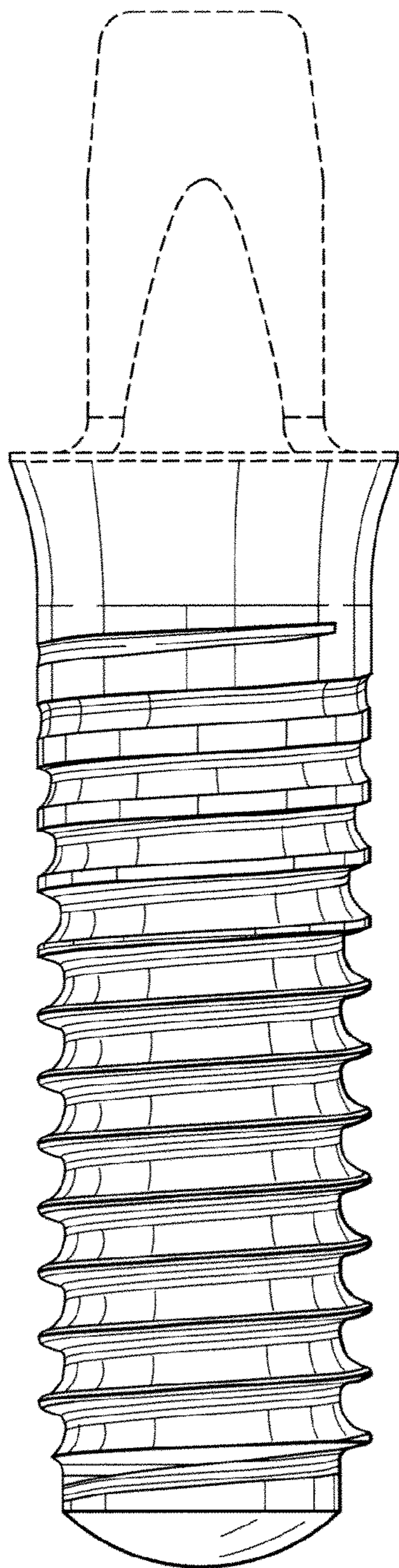
FIG. 3 is a bottom plan view thereof;

FIG. 4 is a perspective view thereof; and,

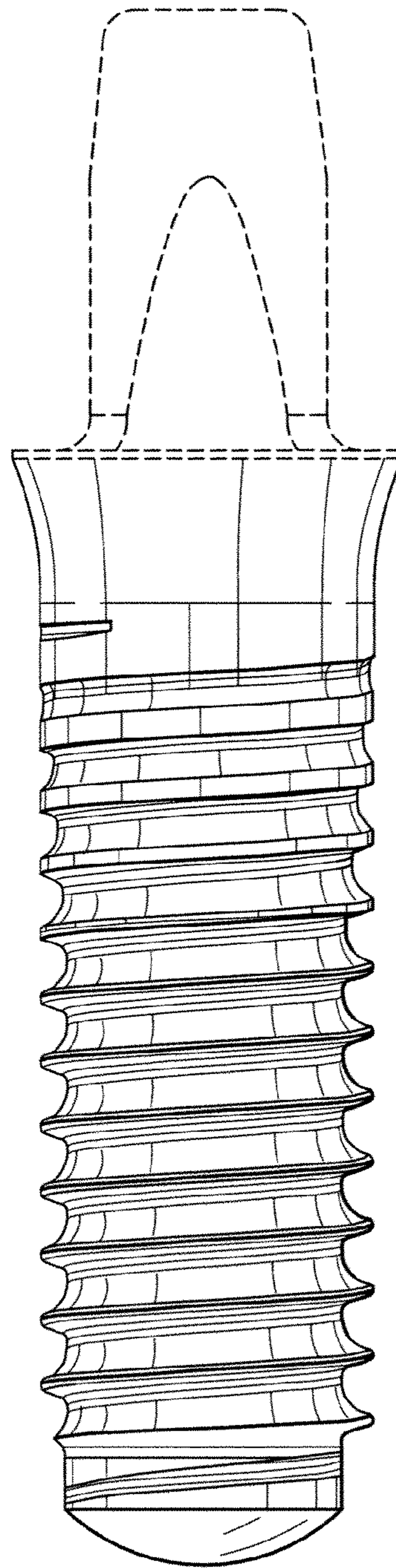
FIG. 5 is a top plan view thereof.

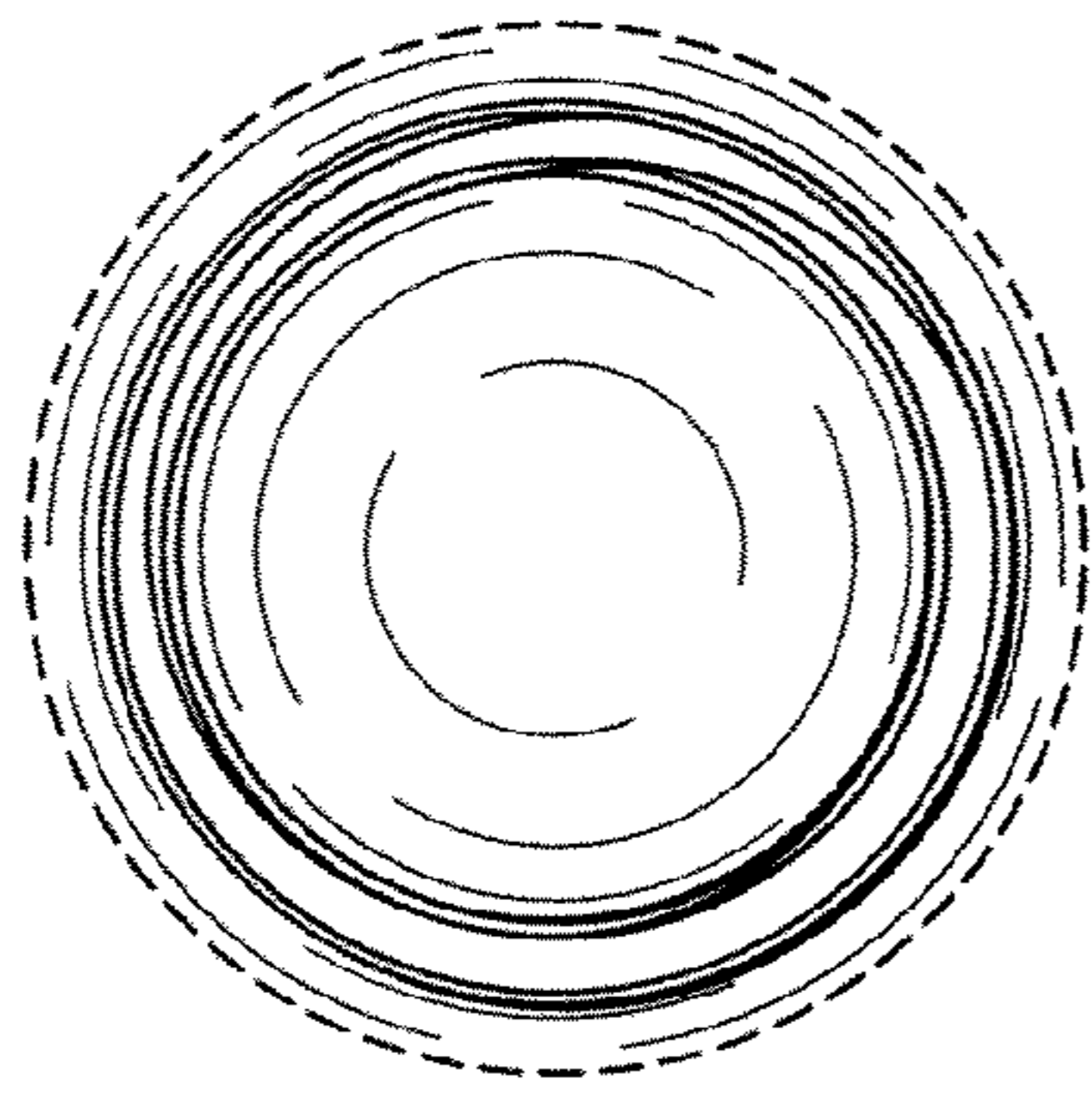




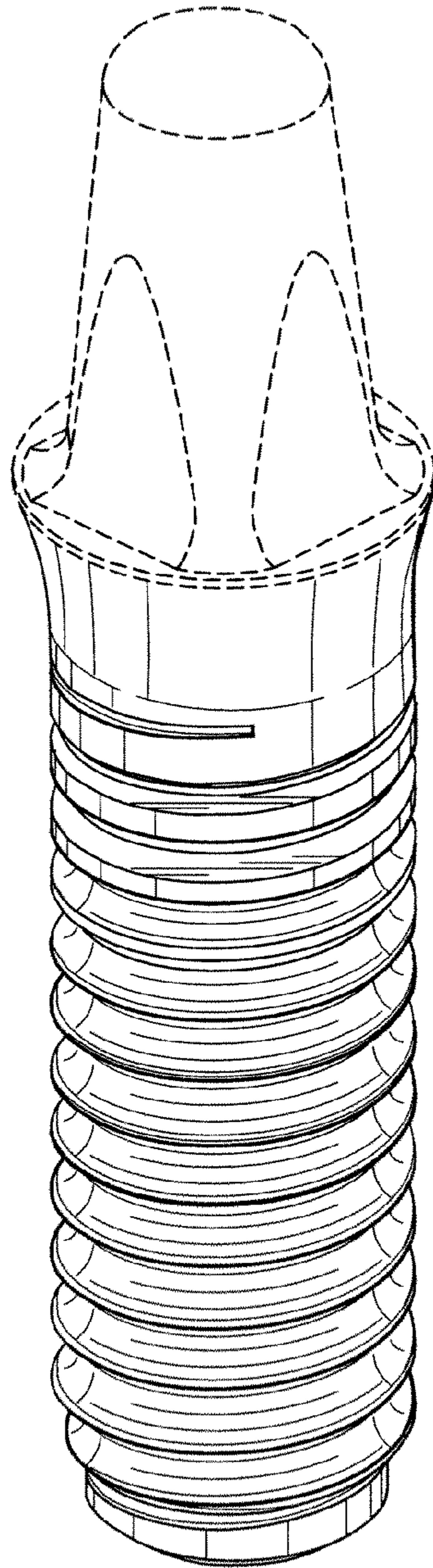

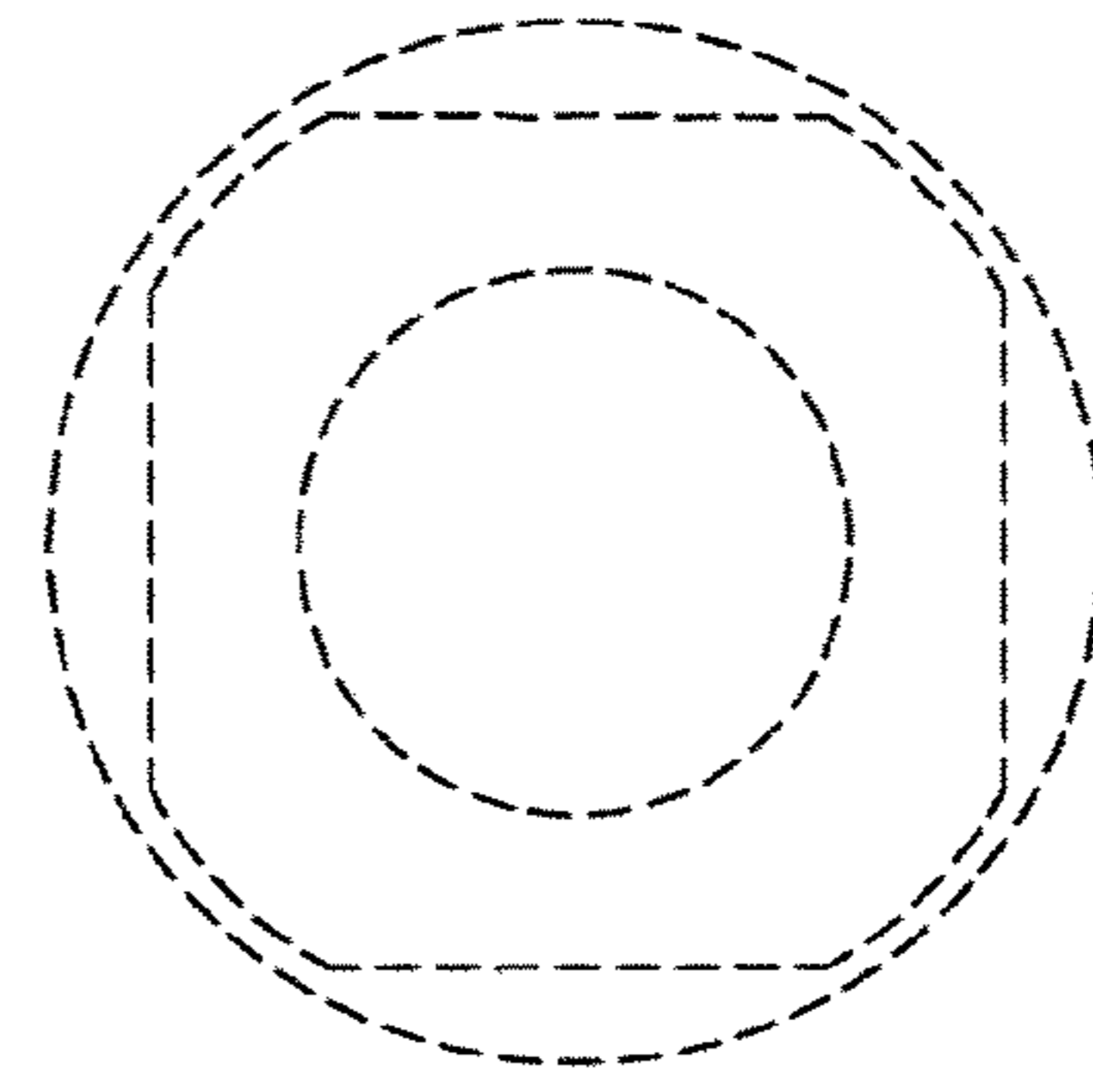
