FIG. 1 is a front perspective view of a lower assembly of an orthopedic device, showing our design.

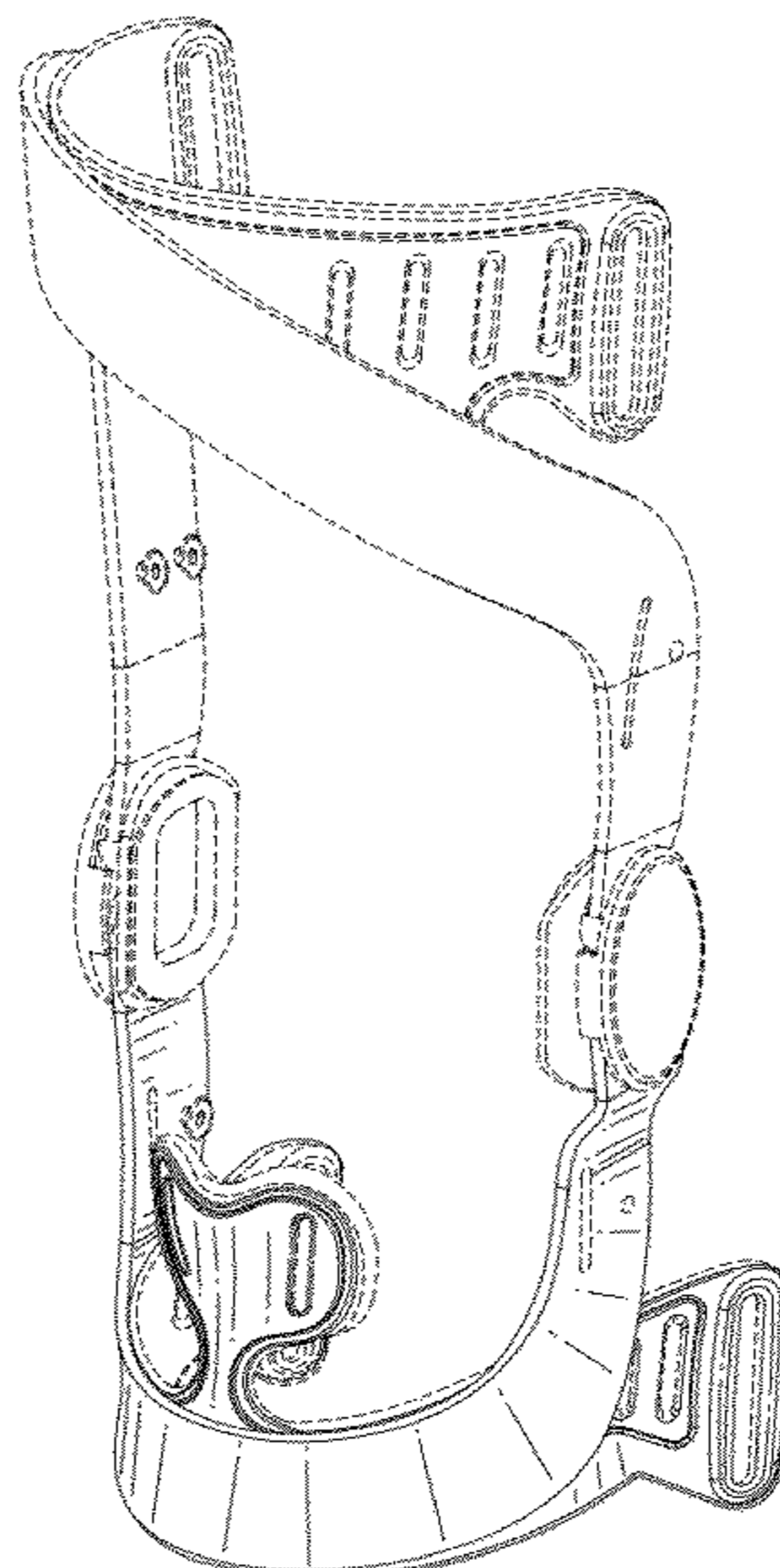
FIG. 2 is a front elevational view of the lower assembly of FIG. 1.

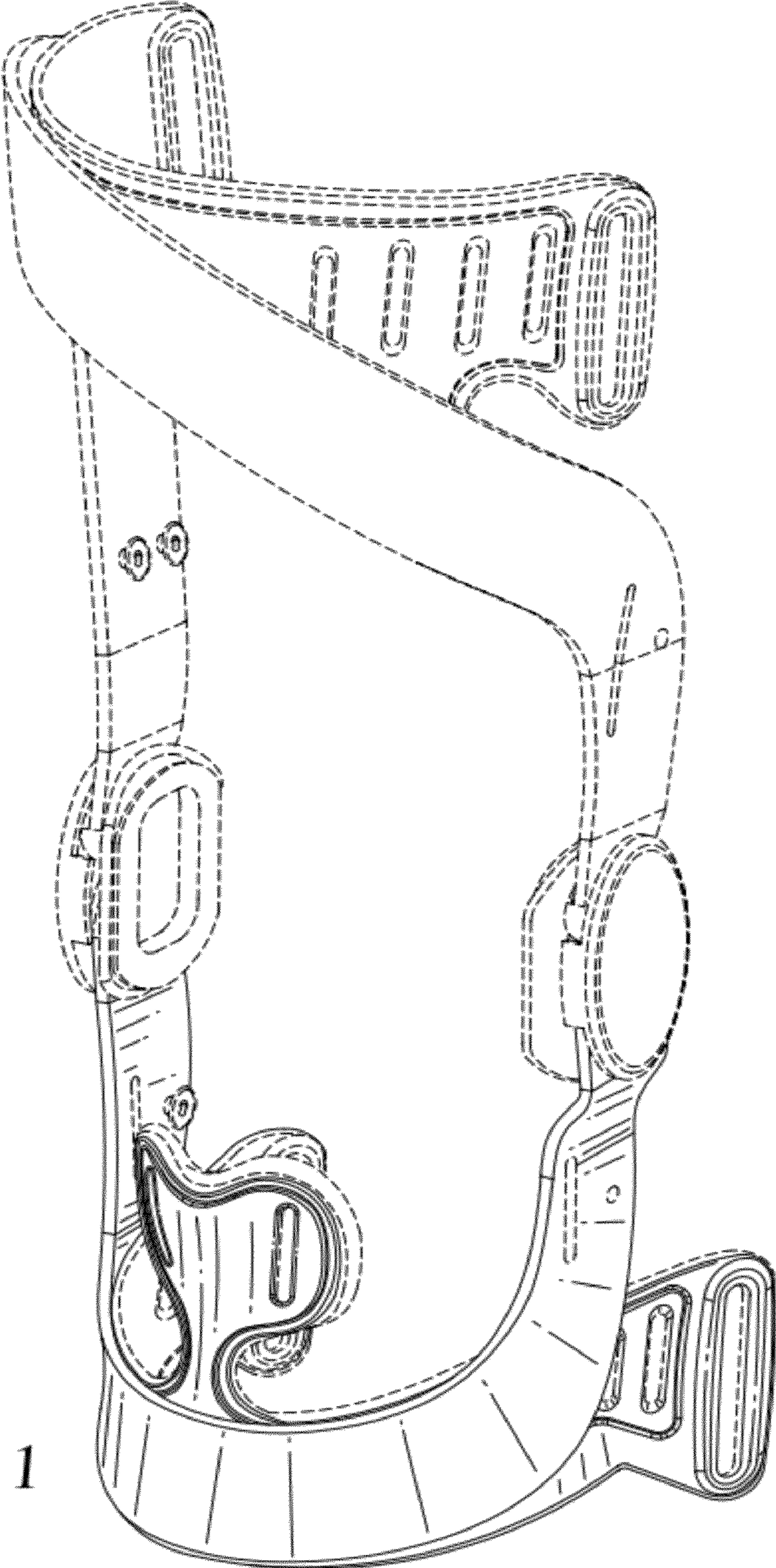

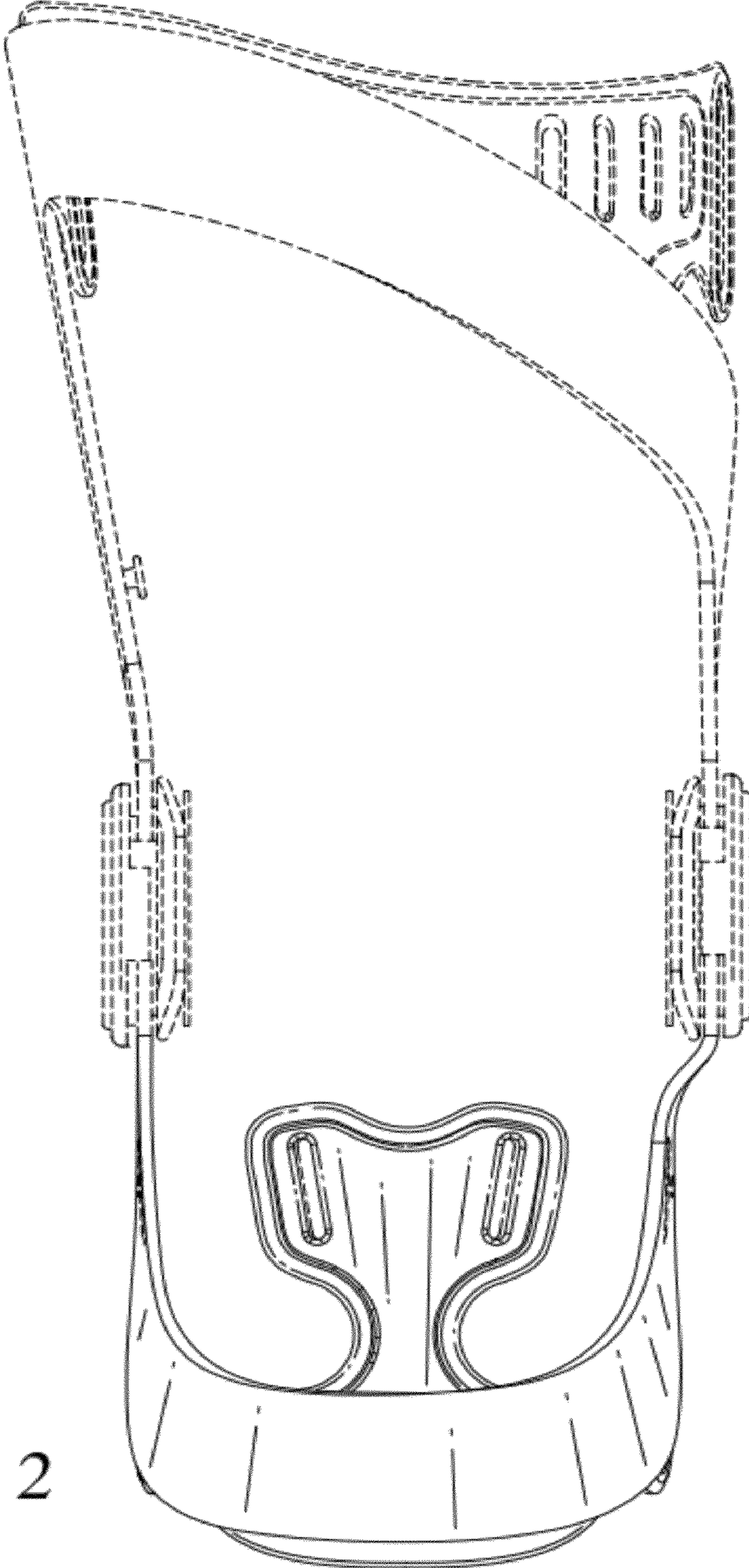

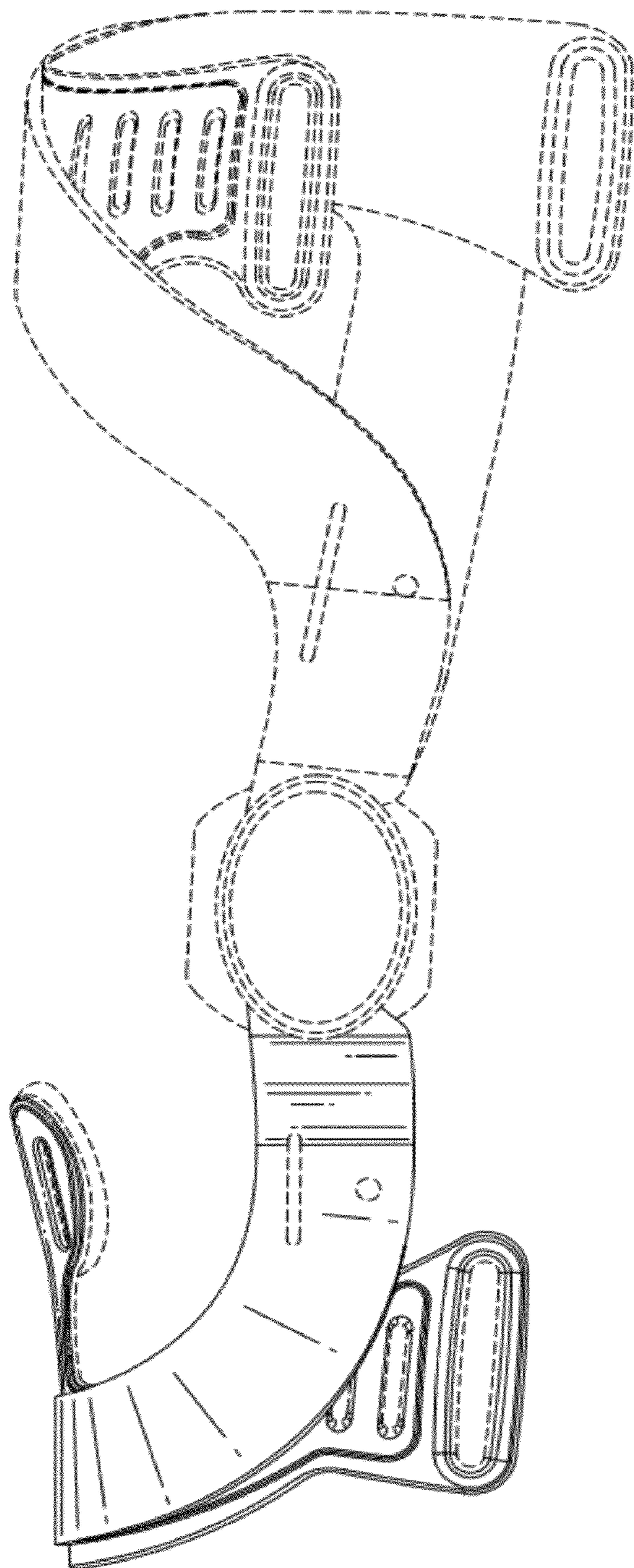

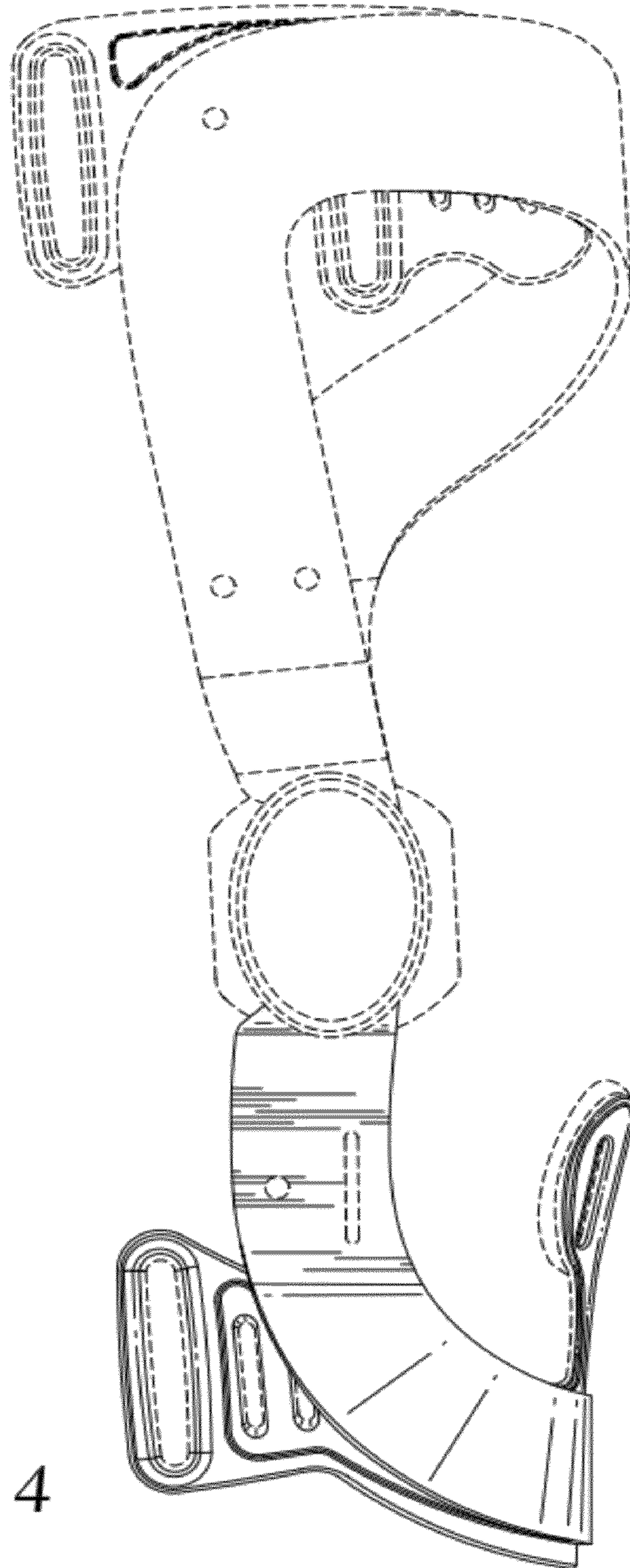
