**DESCRIPTION**

FIG. 18 is a left view of the third embodiment of a cleaning article shown in FIG. 15;

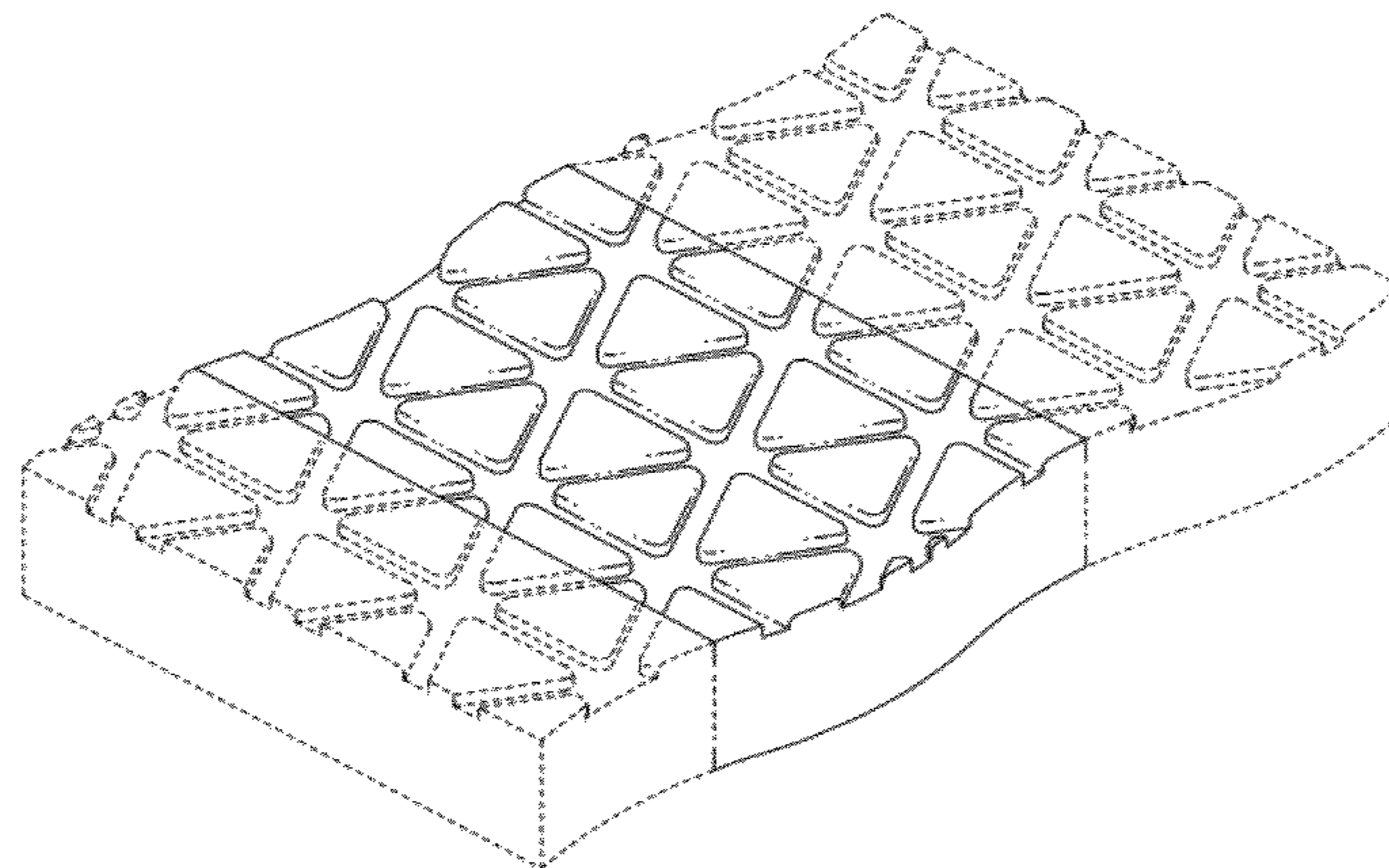
FIG. 19 is a back view of the third embodiment of a cleaning article shown in FIG. 15;

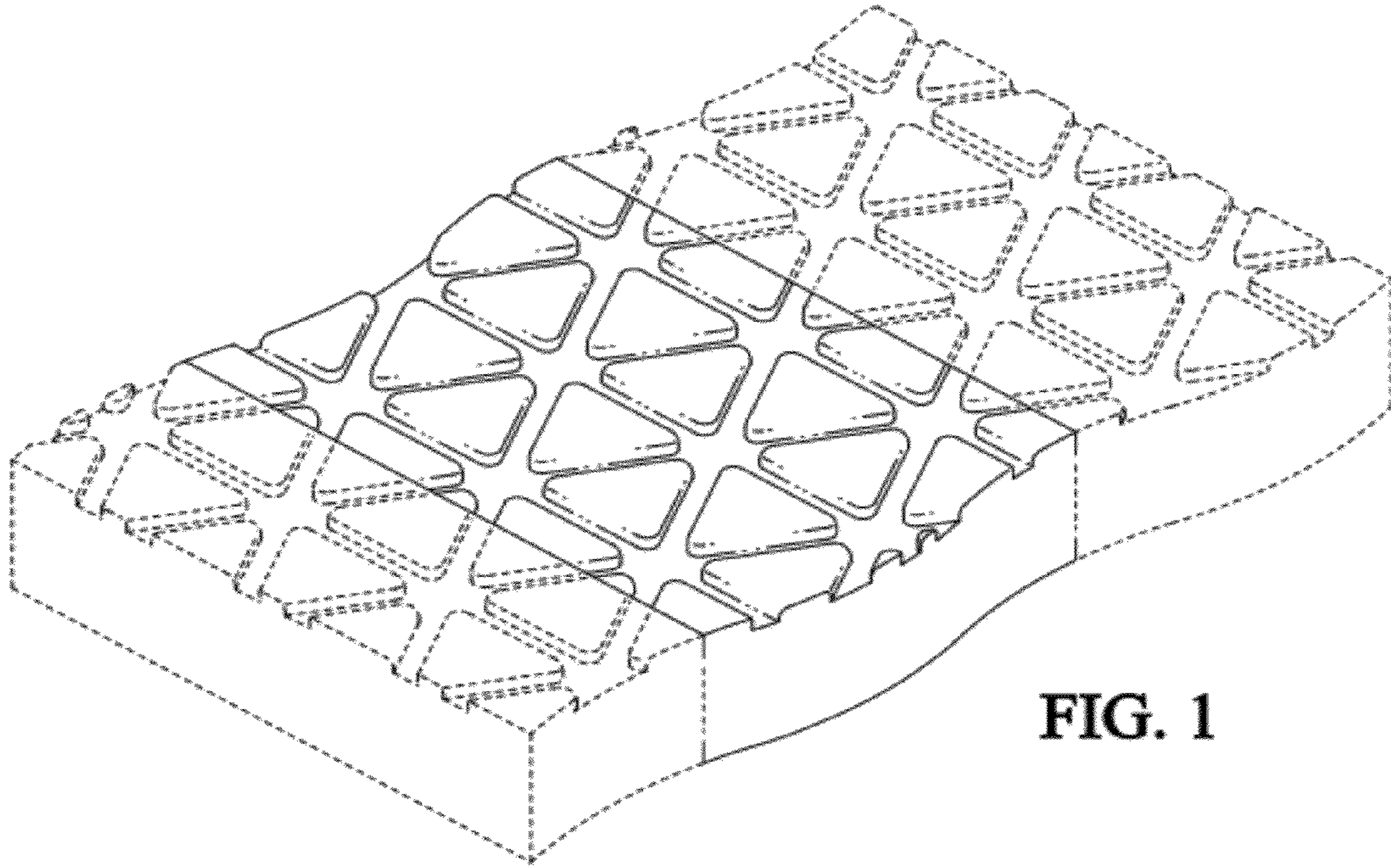

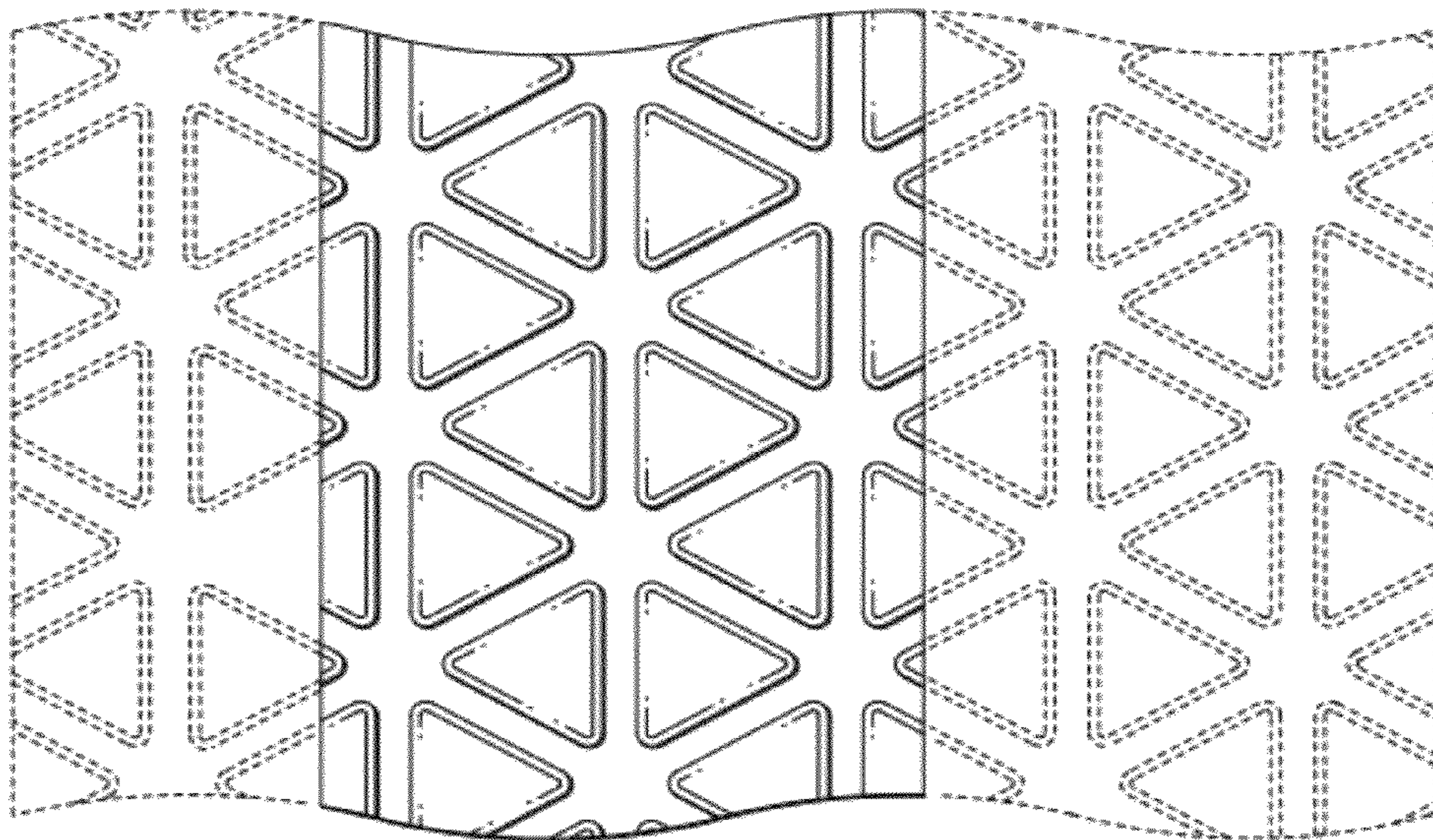

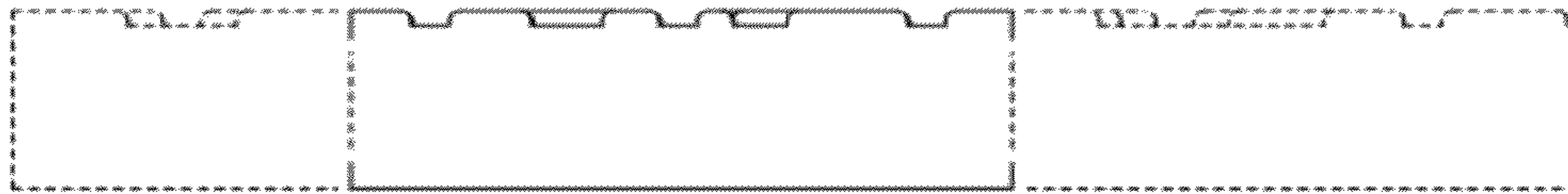

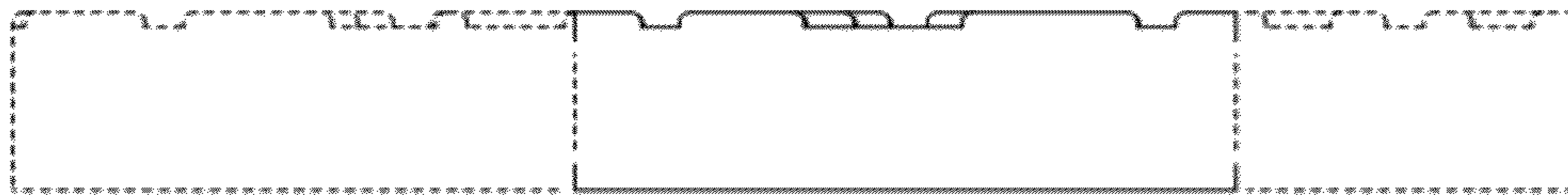

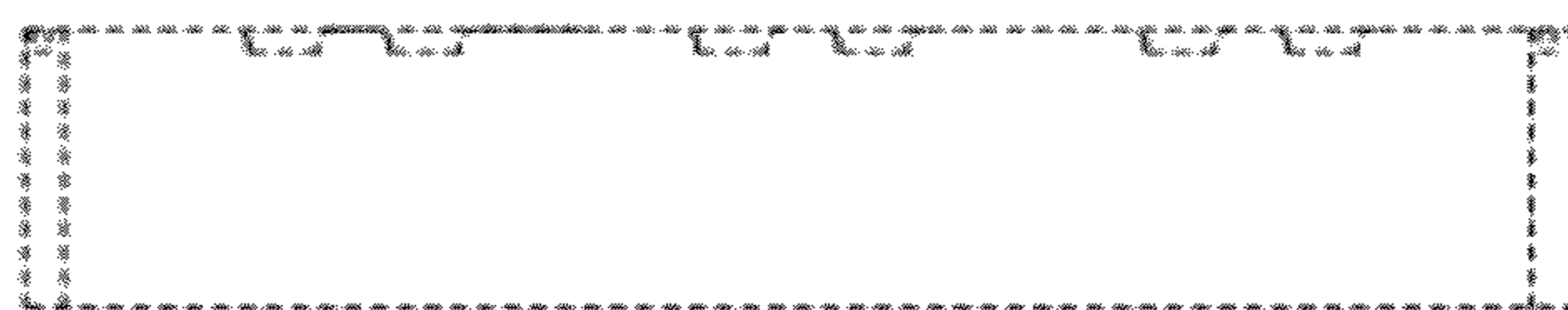

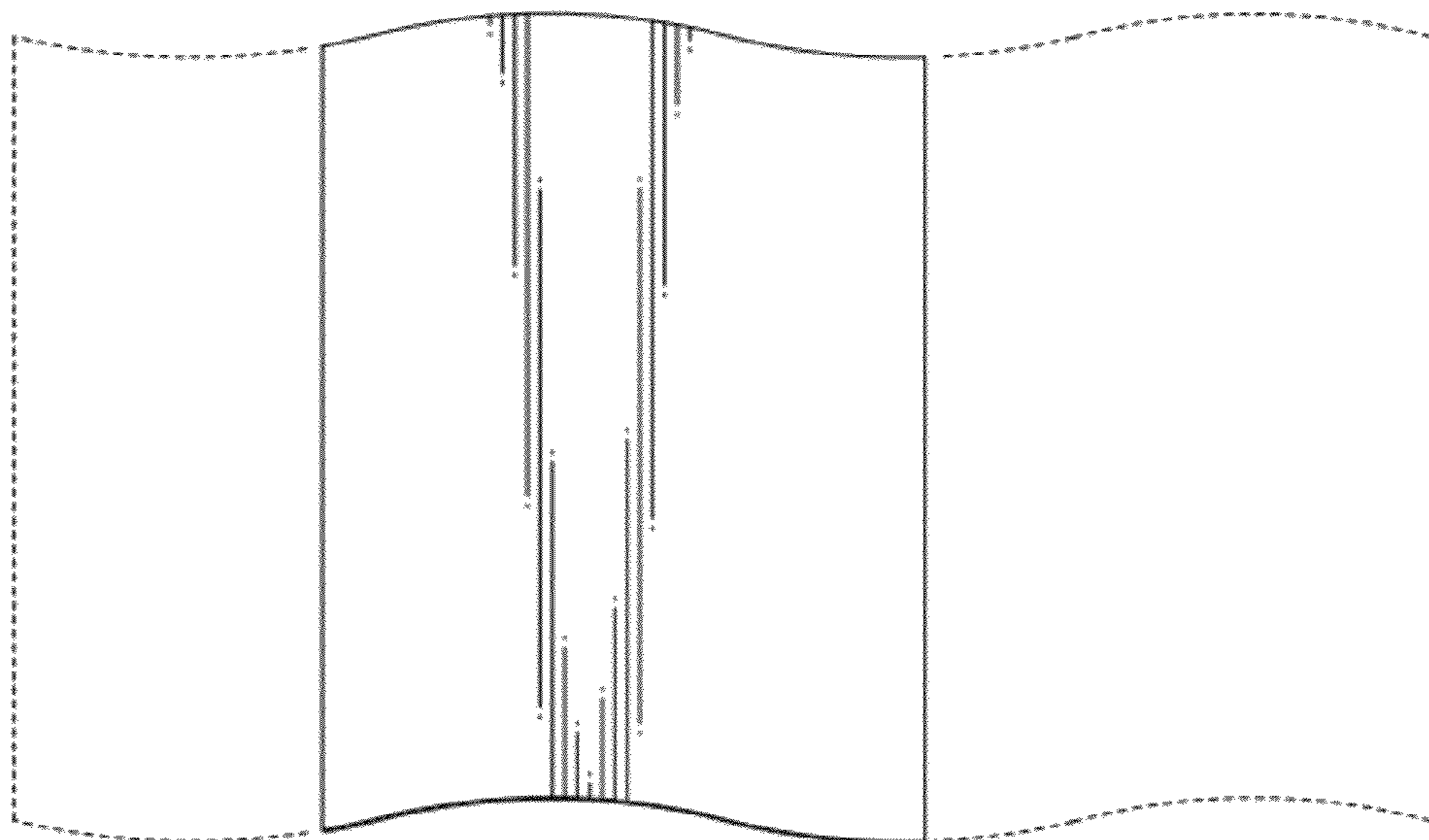

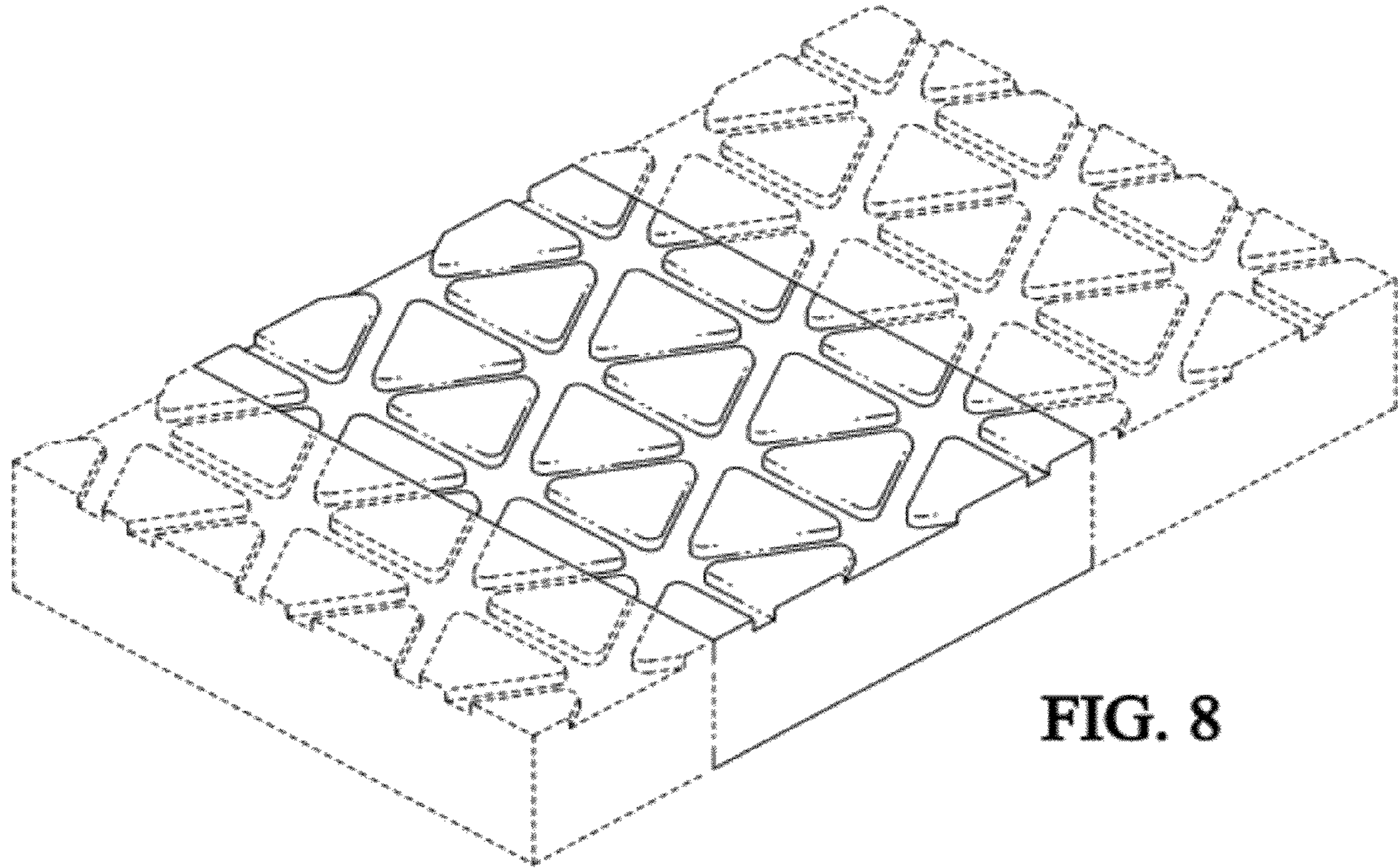

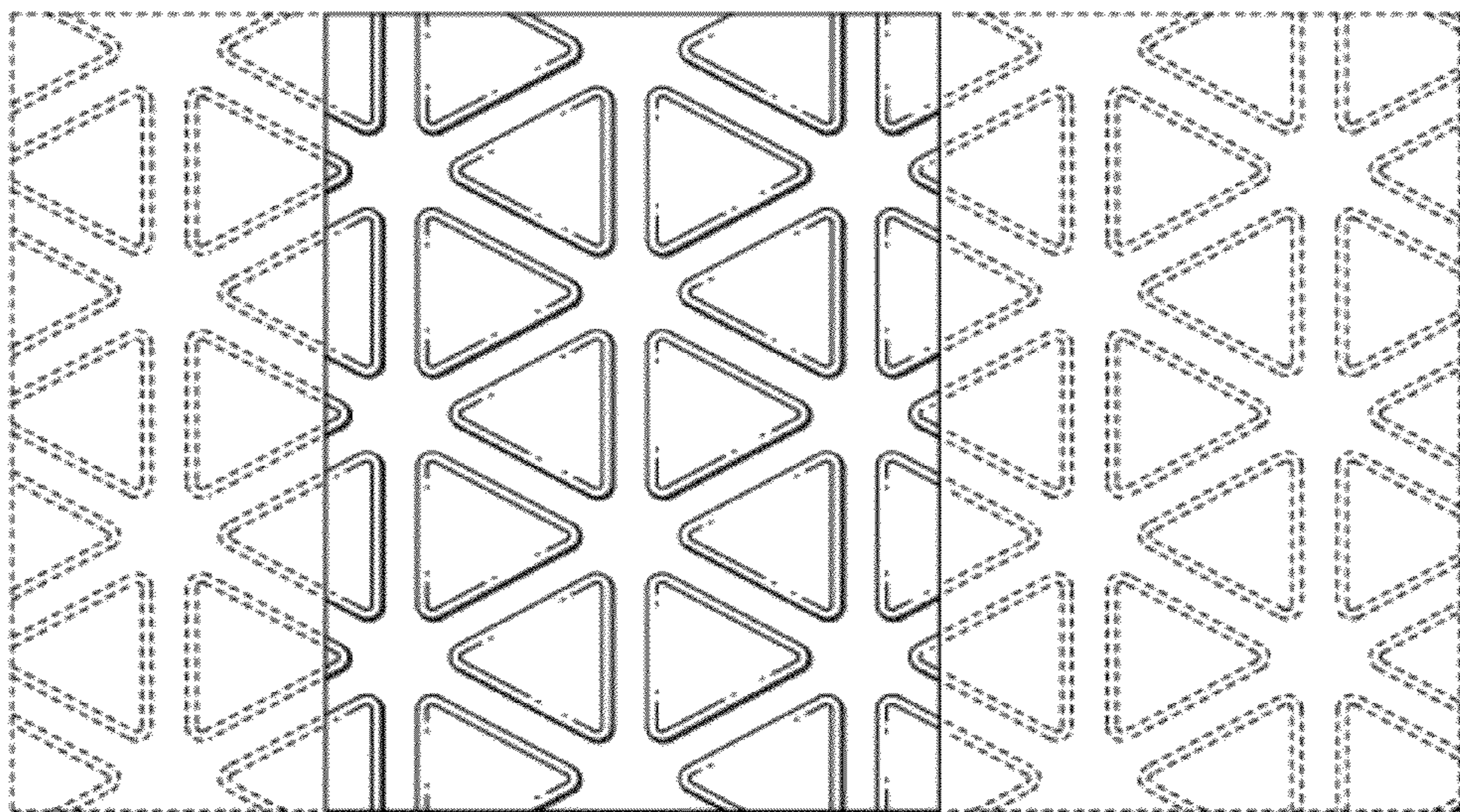

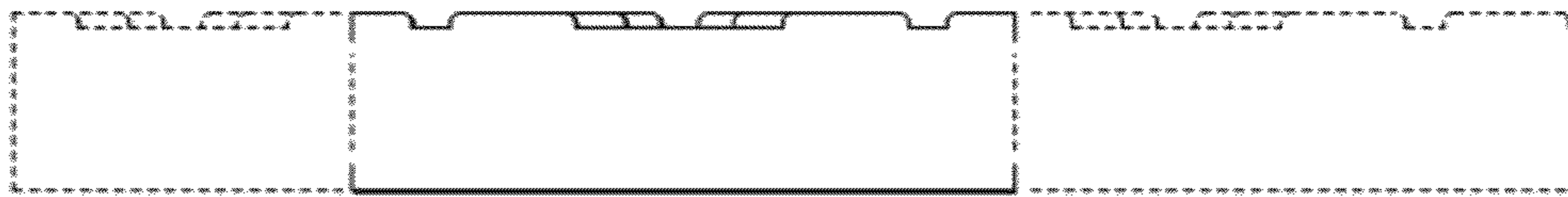

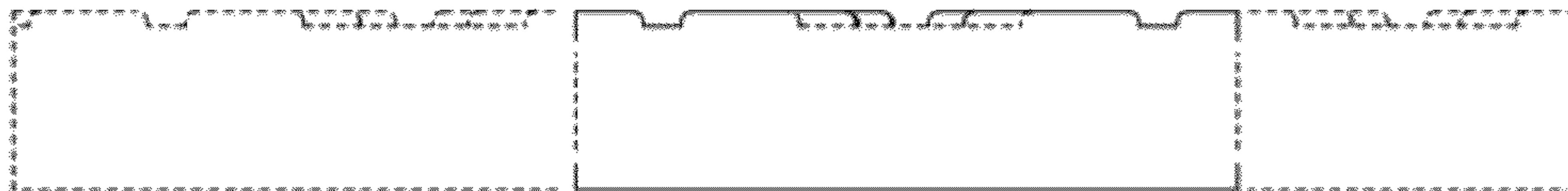

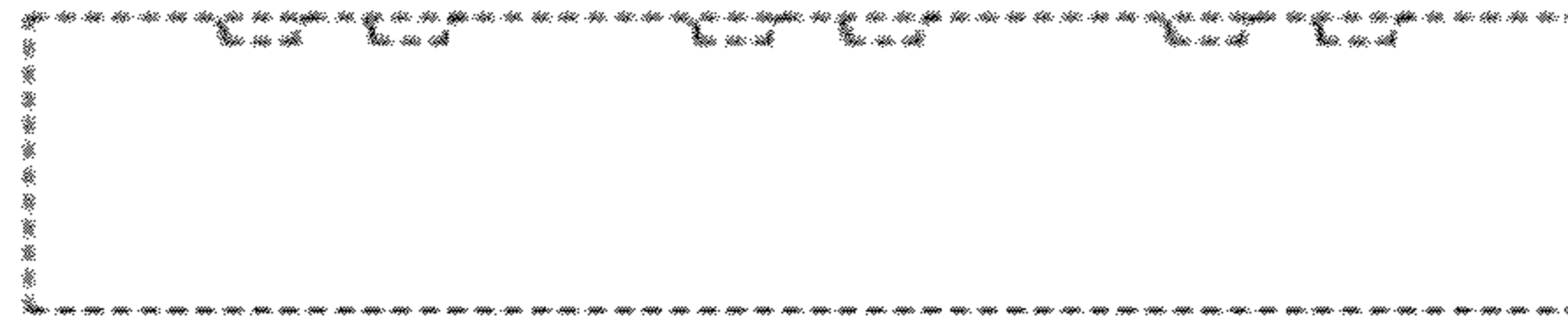

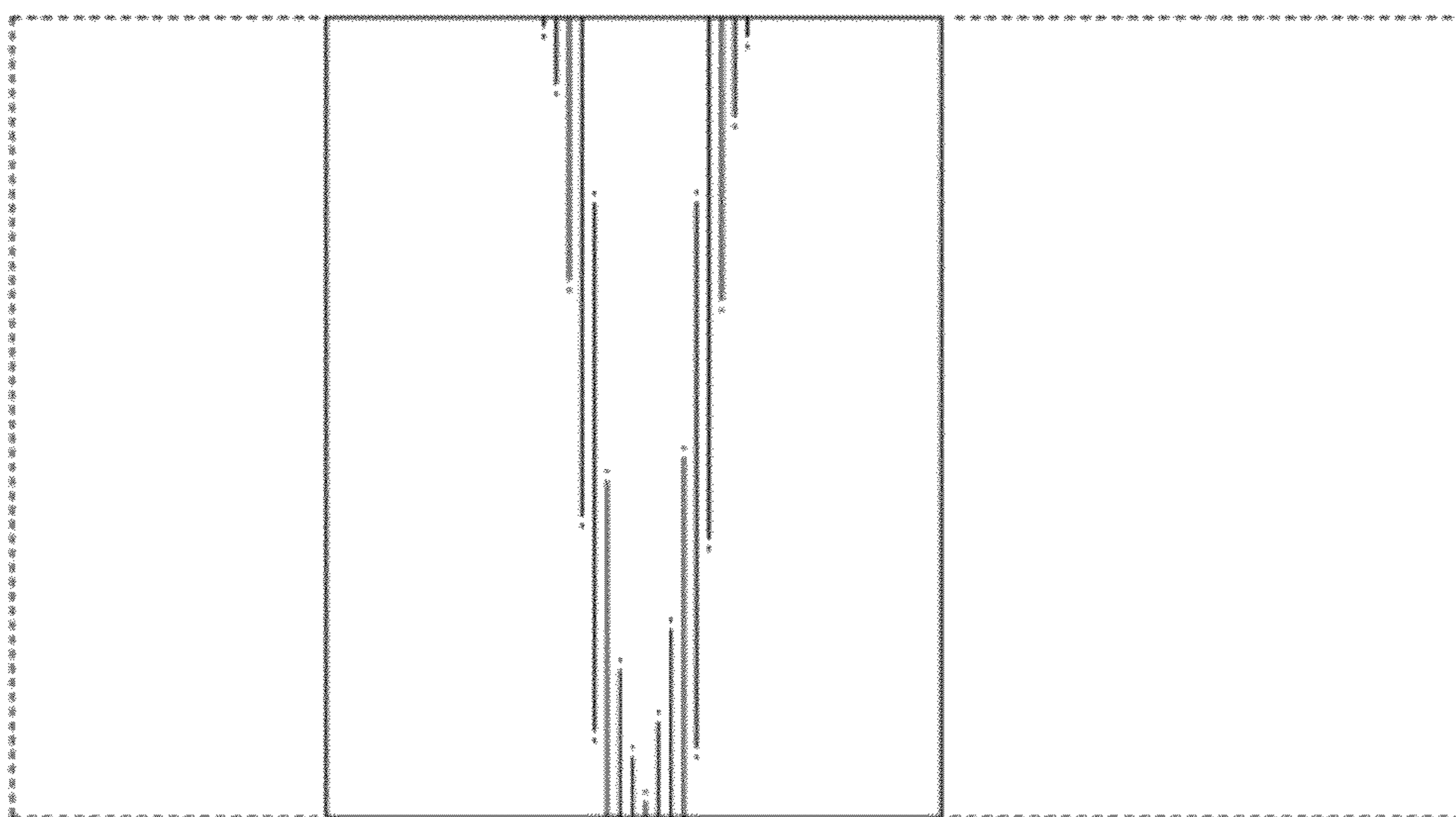

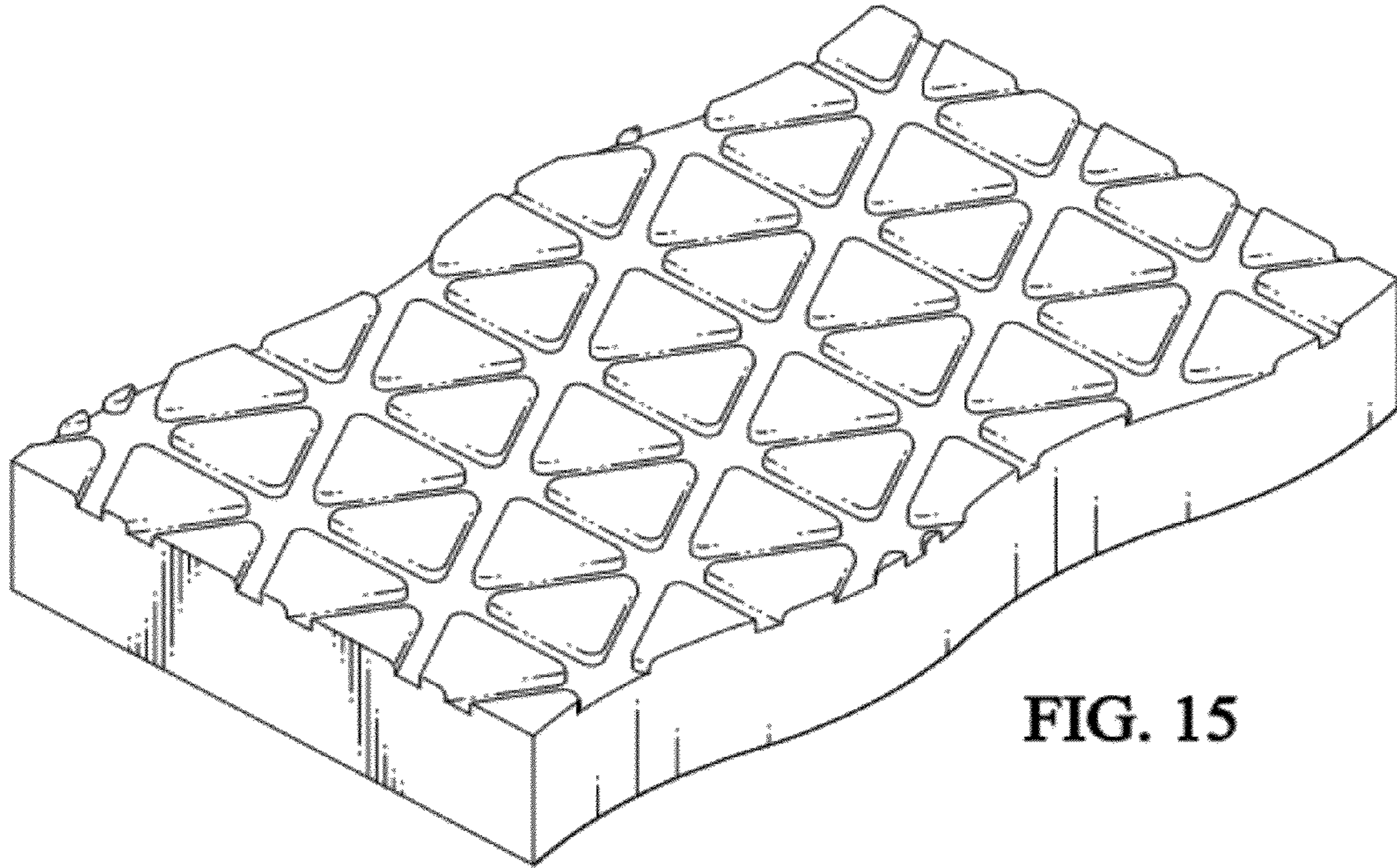

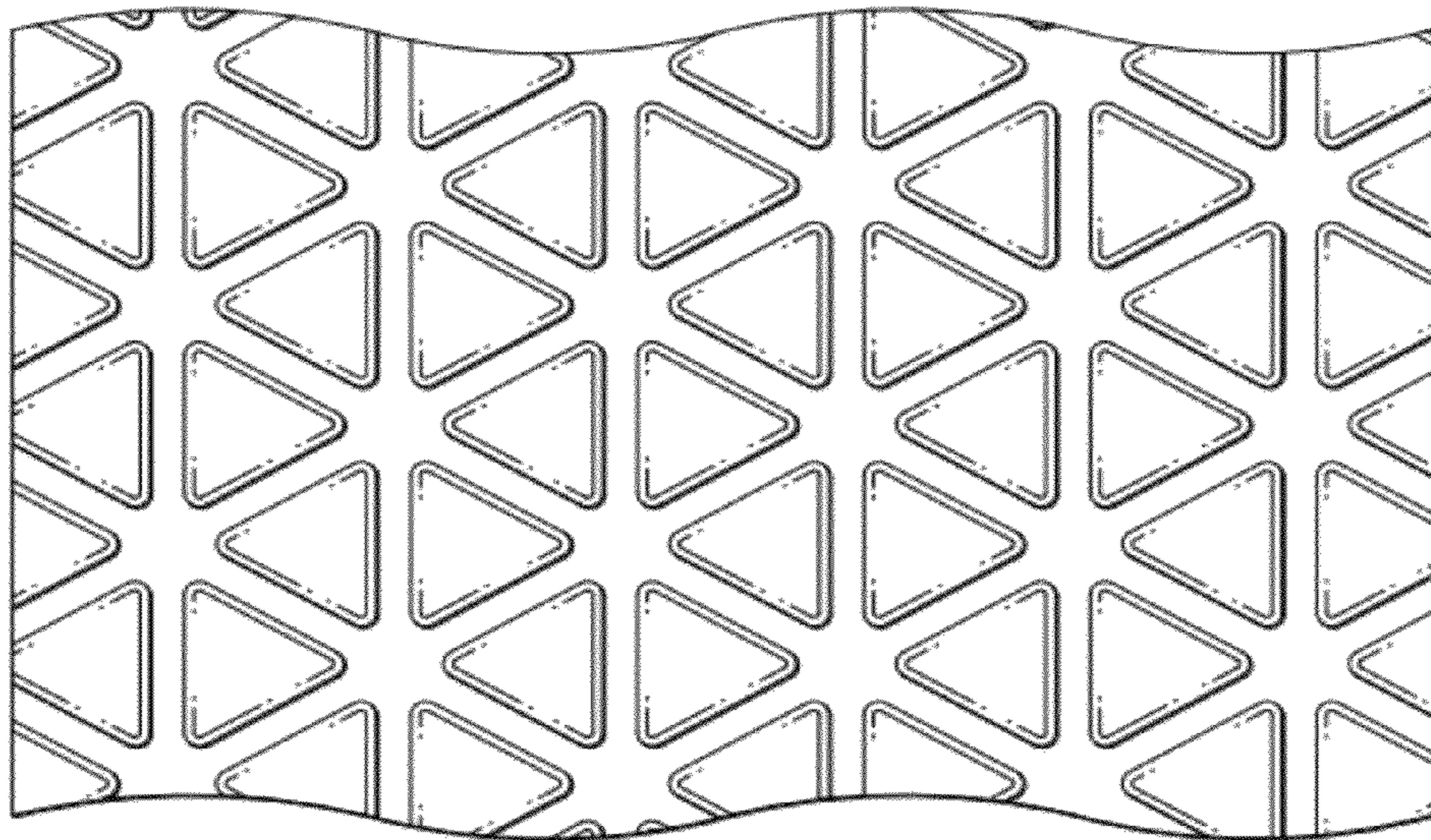

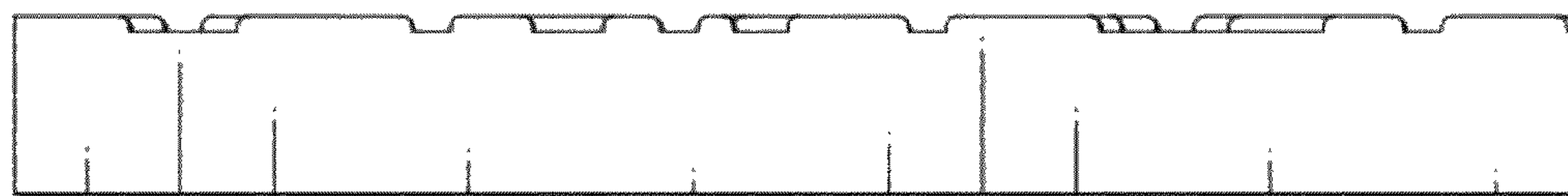

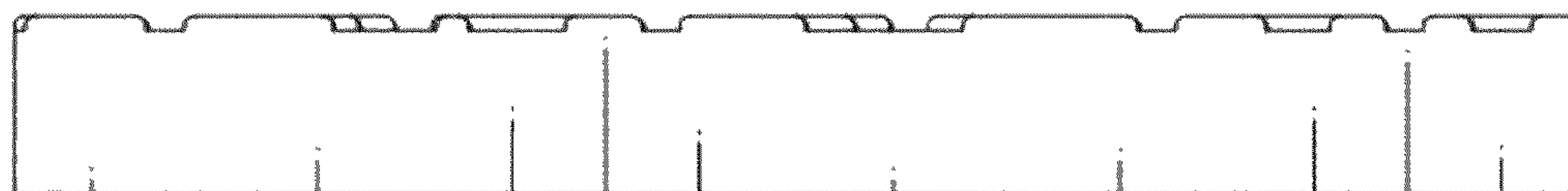

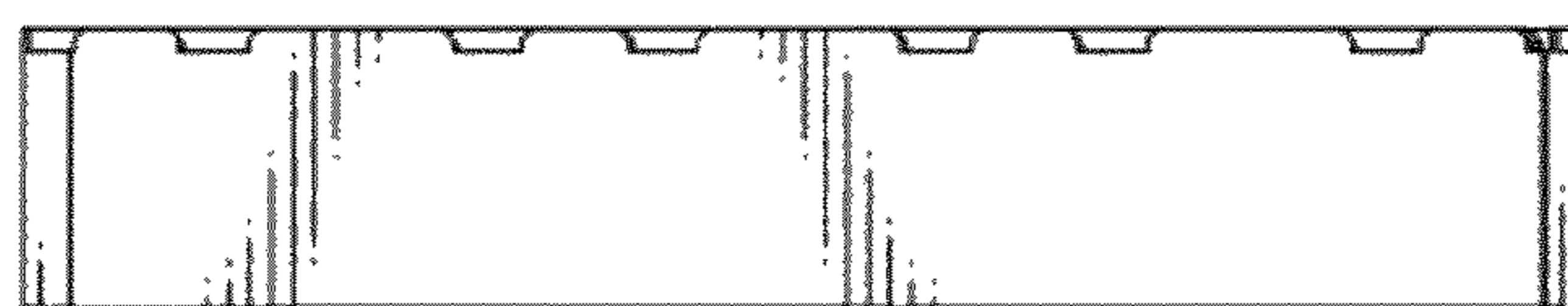

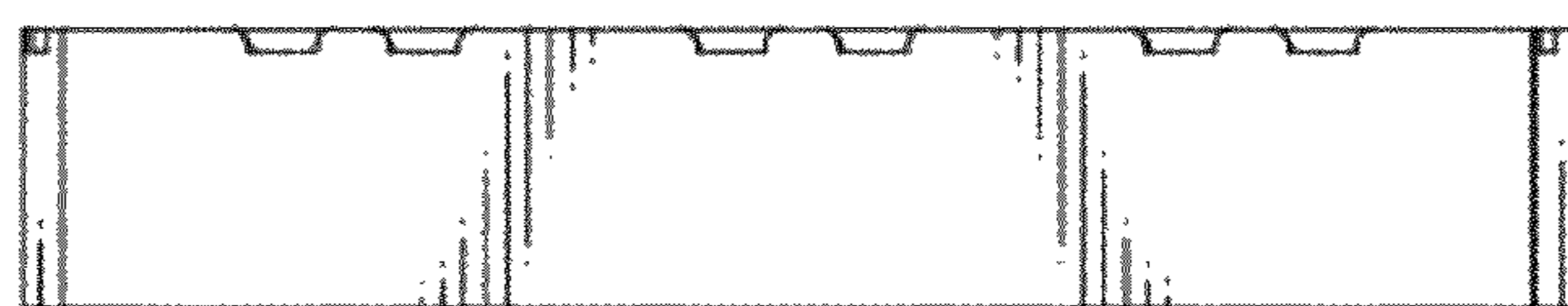

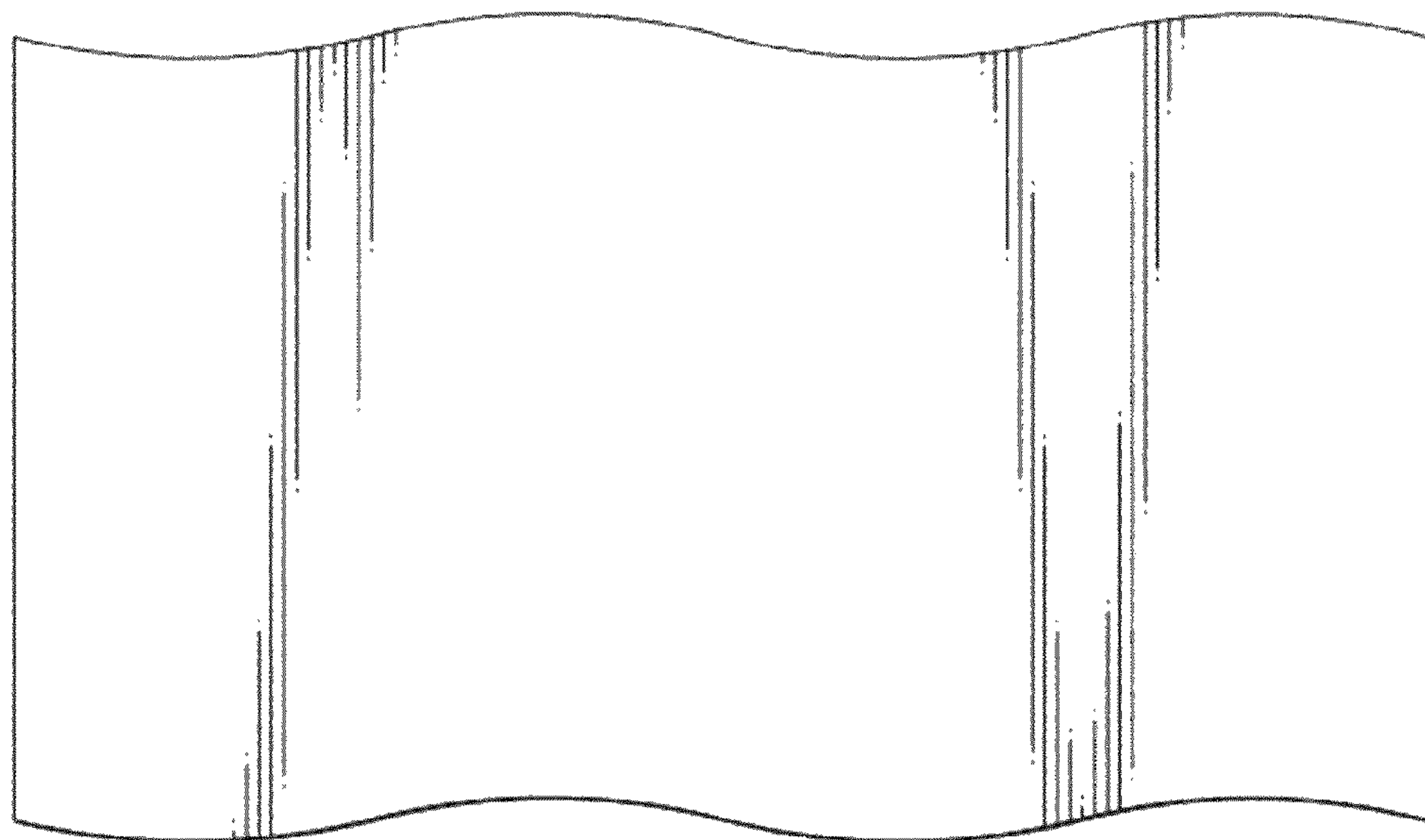
