FIG. 3 is a bottom plan view thereof;

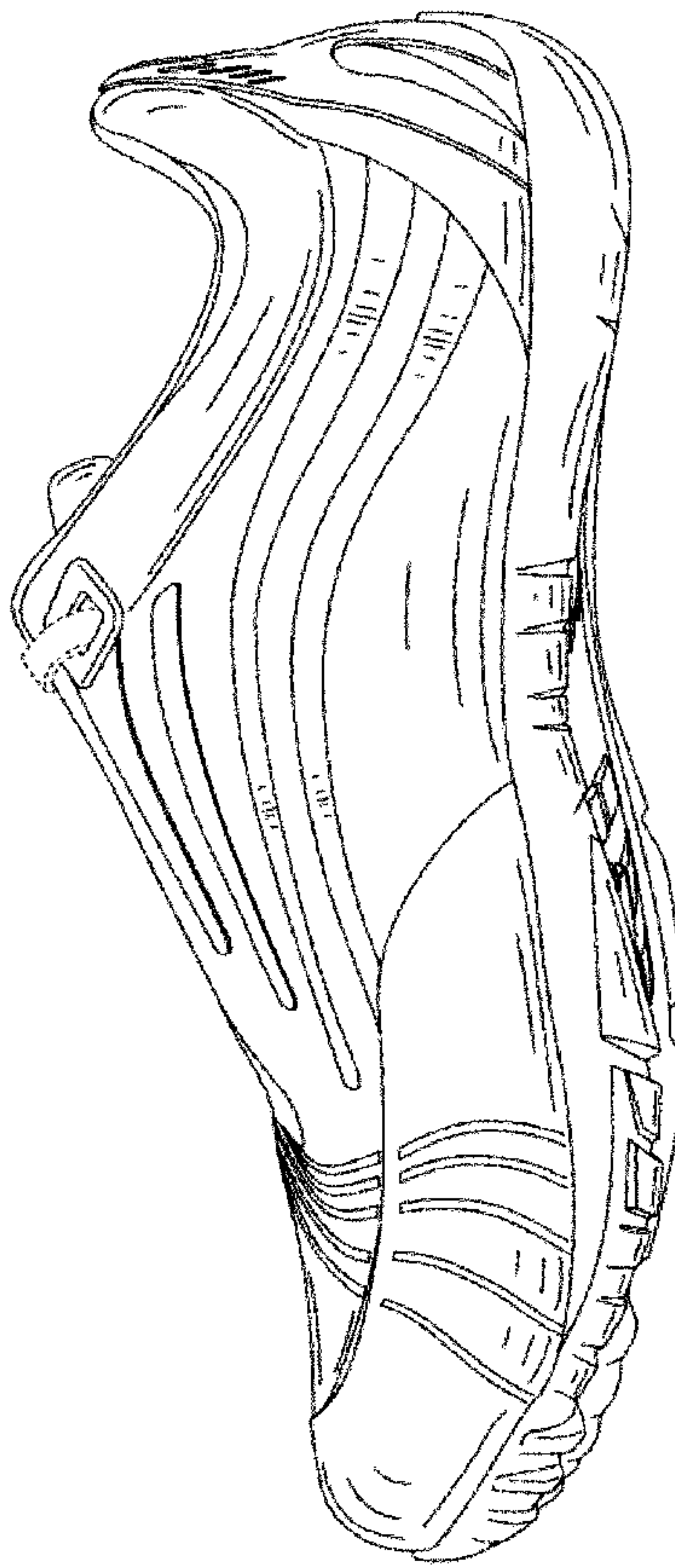
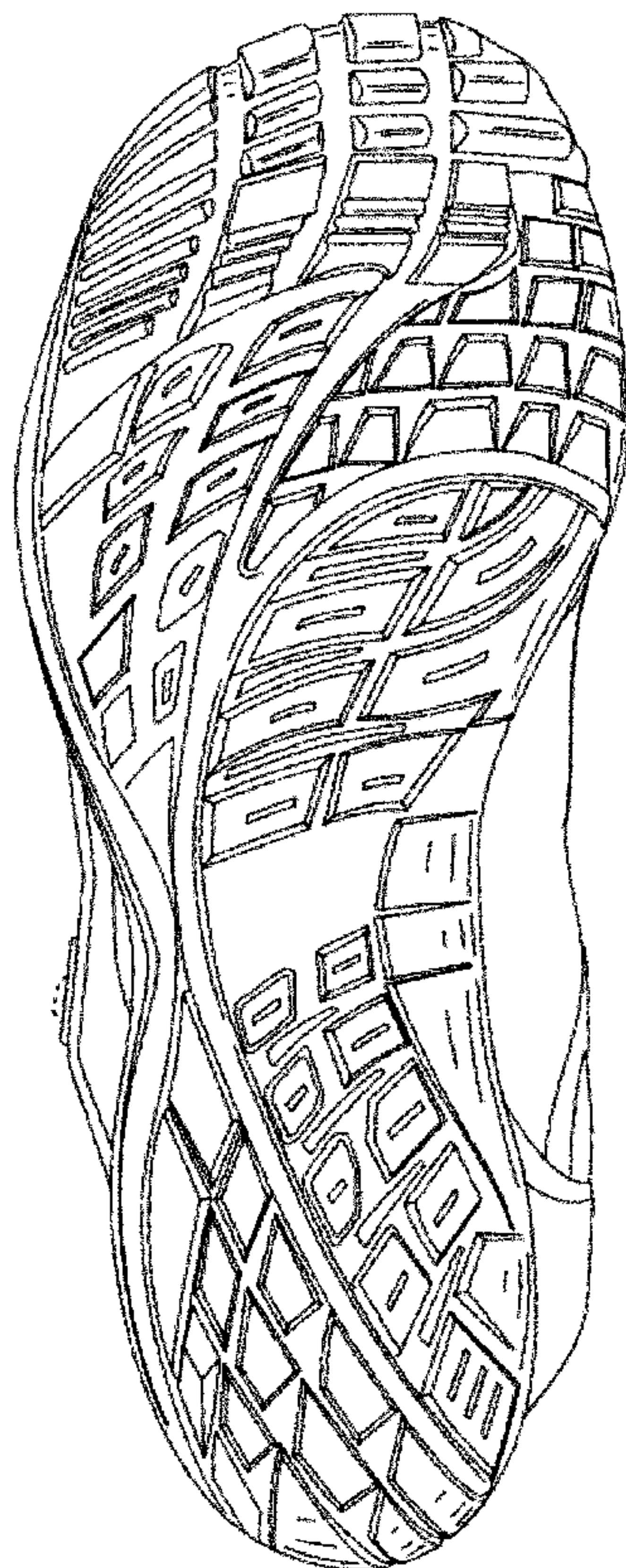
FIG. 4 is a side elevation view thereof taken from the right of FIG. 6;

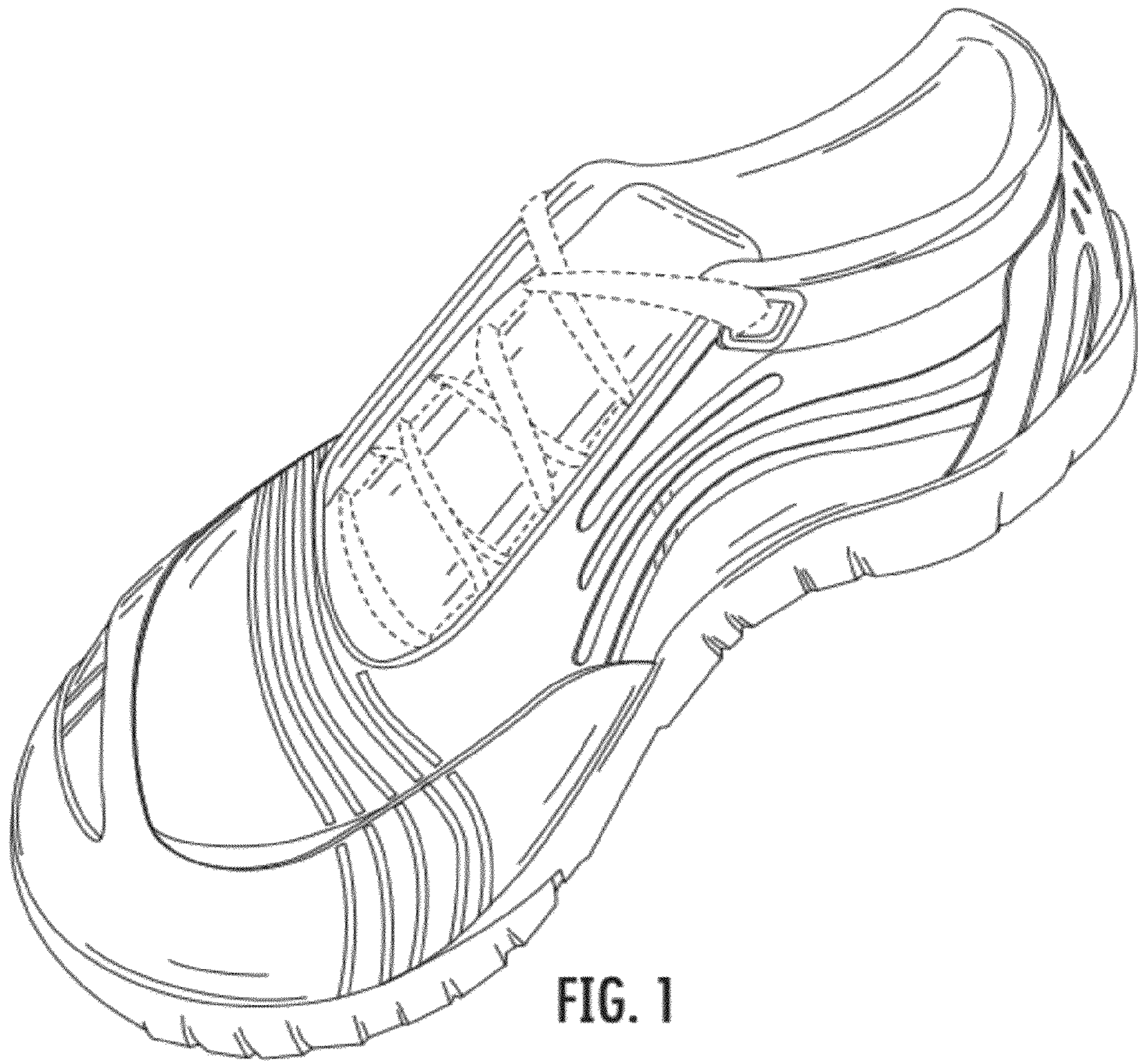

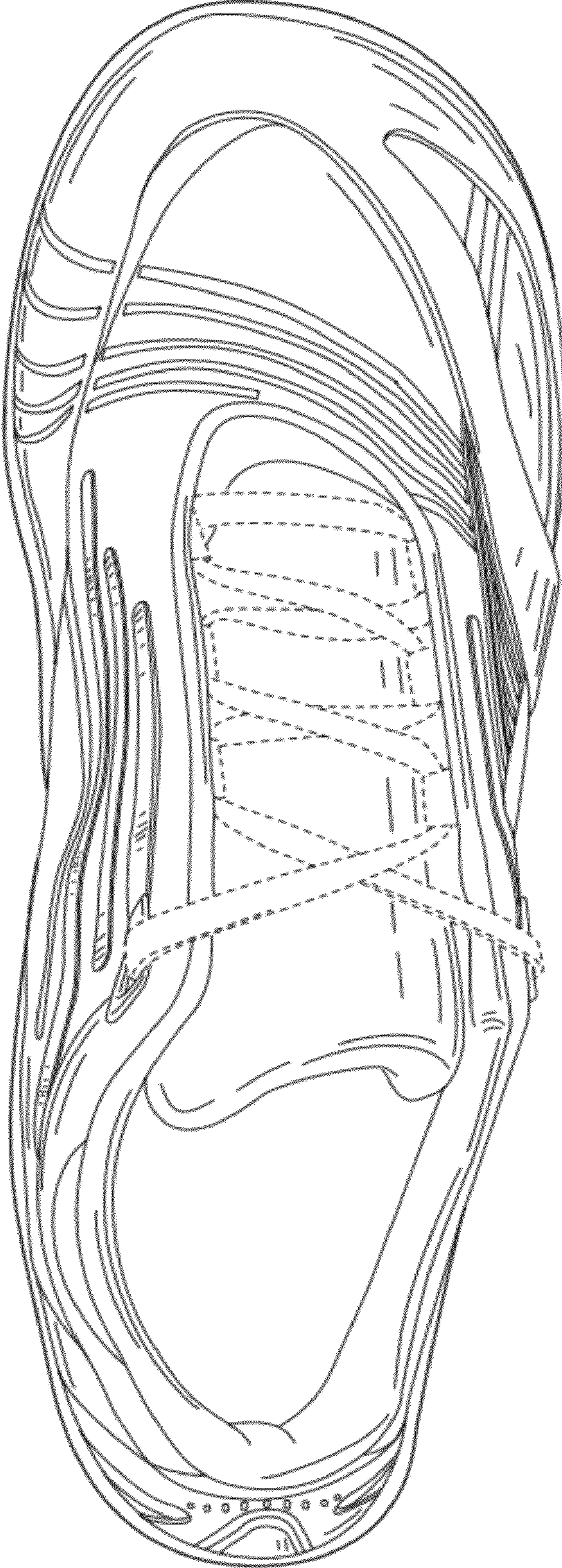

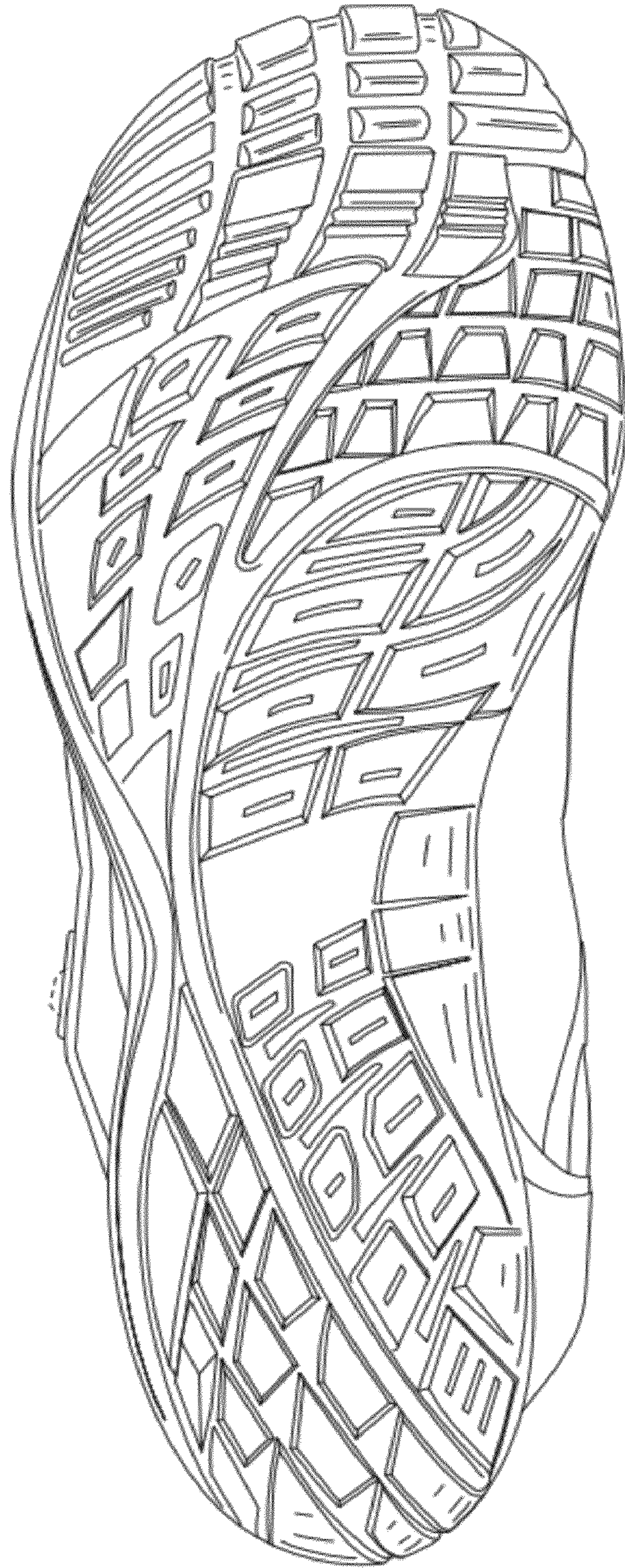

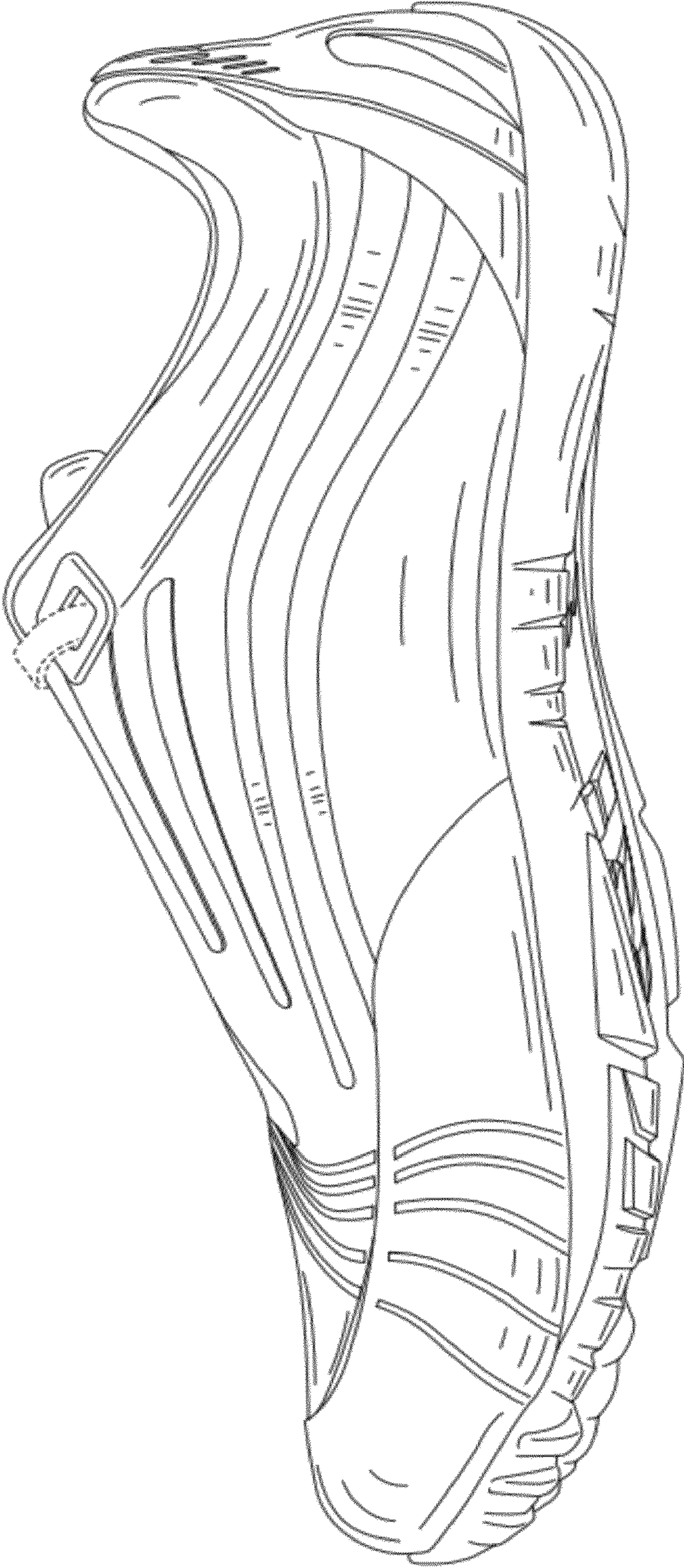

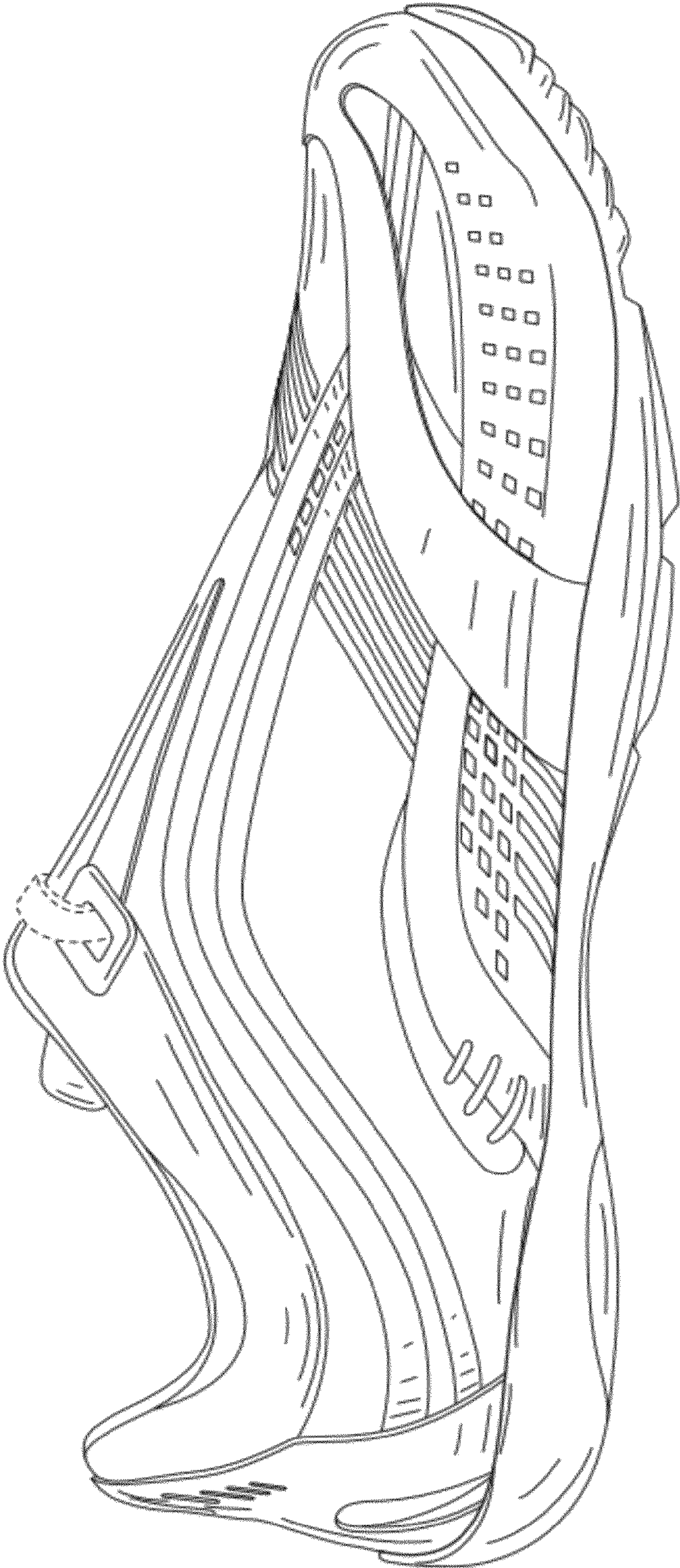

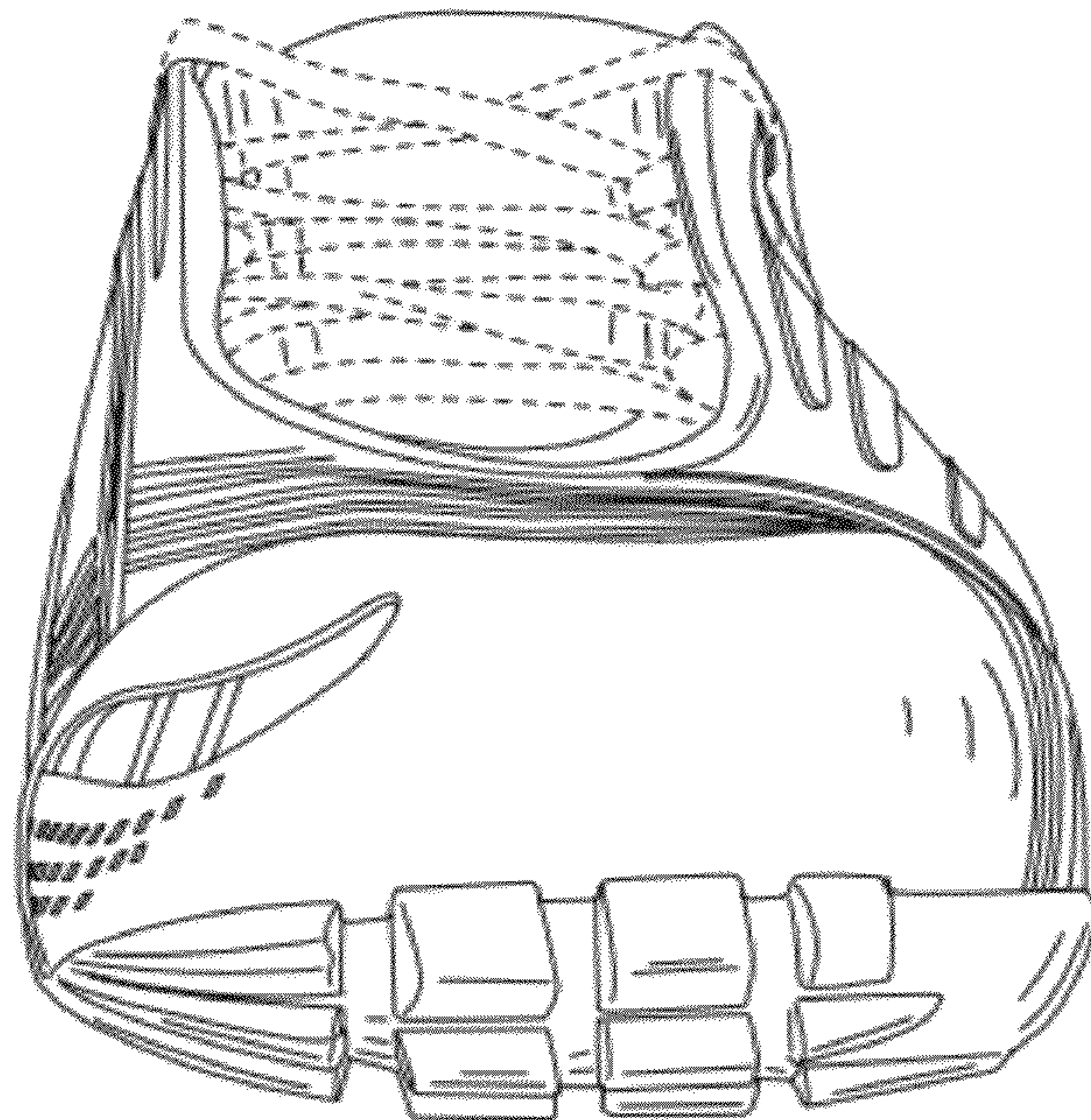
