(57) **CLAIM**

We claim the ornamental design for a footbed, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a footbed, embodying our new design, the three toe walls of the footbed being shown in a flat position;

FIG. 2 is a top view of the footbed of FIG. 1;

FIG. 3 is a bottom view of the footbed of FIG. 1;

FIG. 4 is a rear elevational view of the footbed of FIG. 1;

FIG. 5 is a front elevational view of the footbed of FIG. 1;

FIG. 6 is a first side elevational view of the footbed of FIG. 1;

FIG. 7 is a second side elevational view of the footbed of FIG. 1;

FIG. 8 is a top perspective view of the footbed of FIG. 1, the three toe walls of the footbed being shown in a folded position;

FIG. 9 is a top view of the footbed of FIG. 8;

FIG. 10 is a bottom view of the footbed of FIG. 8;

FIG. 11 is a rear elevational view of the footbed of FIG. 8;


FIG. 12 is a front elevational view of the footbed of FIG. 8;

FIG. 13 is a first side elevational view of the footbed of FIG. 8; and,

FIG. 14 is a second side elevational view of the footbed of FIG. 8.


























