The ornamental design for a chair, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a chair showing our new design;
FIG. 2 is a left side perspective view thereof, the right side being a mirror image thereof;
FIG. 3 is a front perspective view thereof;
FIG. 4 is a rear perspective view thereof; and,
FIG. 5 is a rear perspective view thereof.
The bottom view is not ornamental.

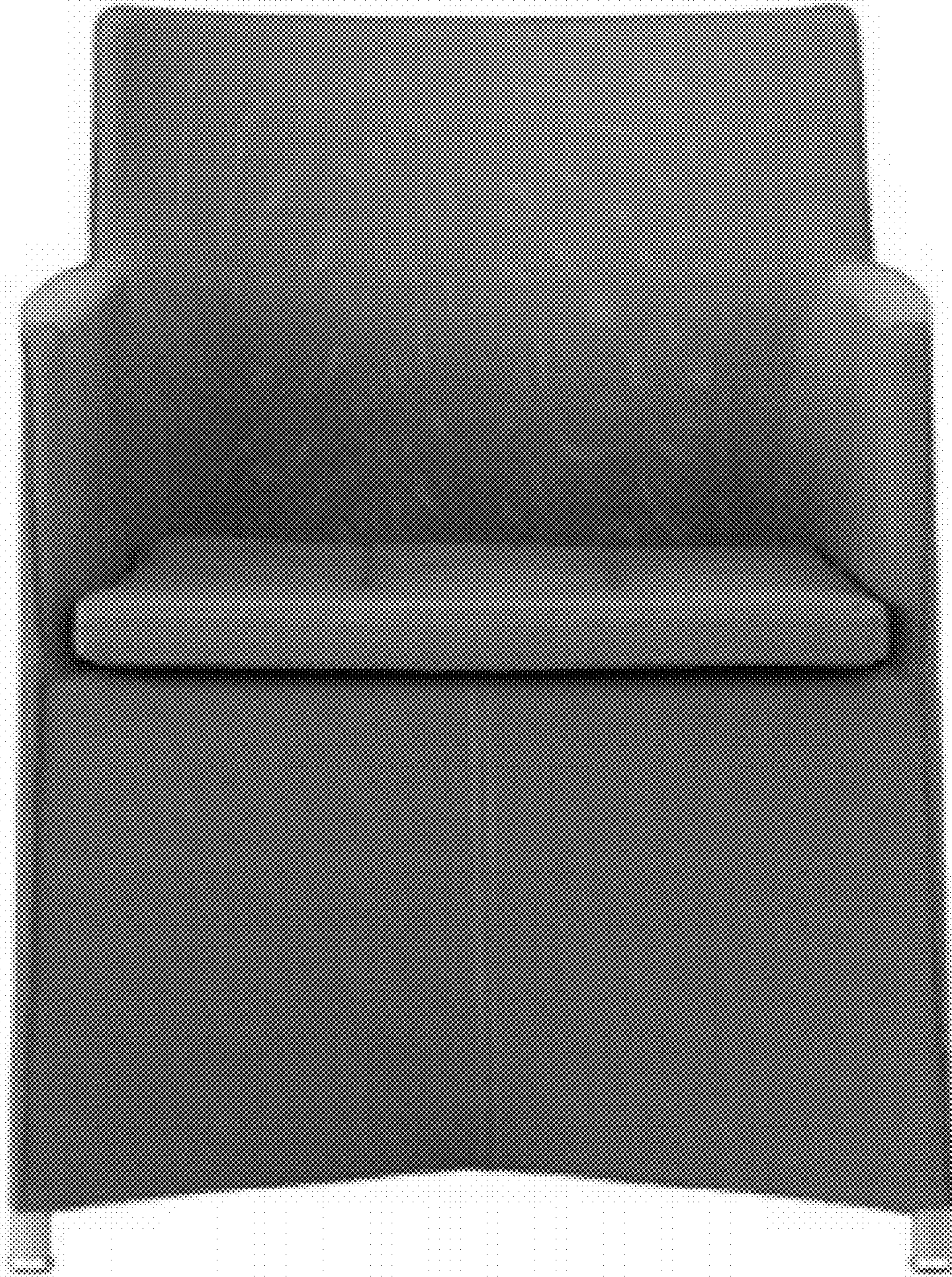

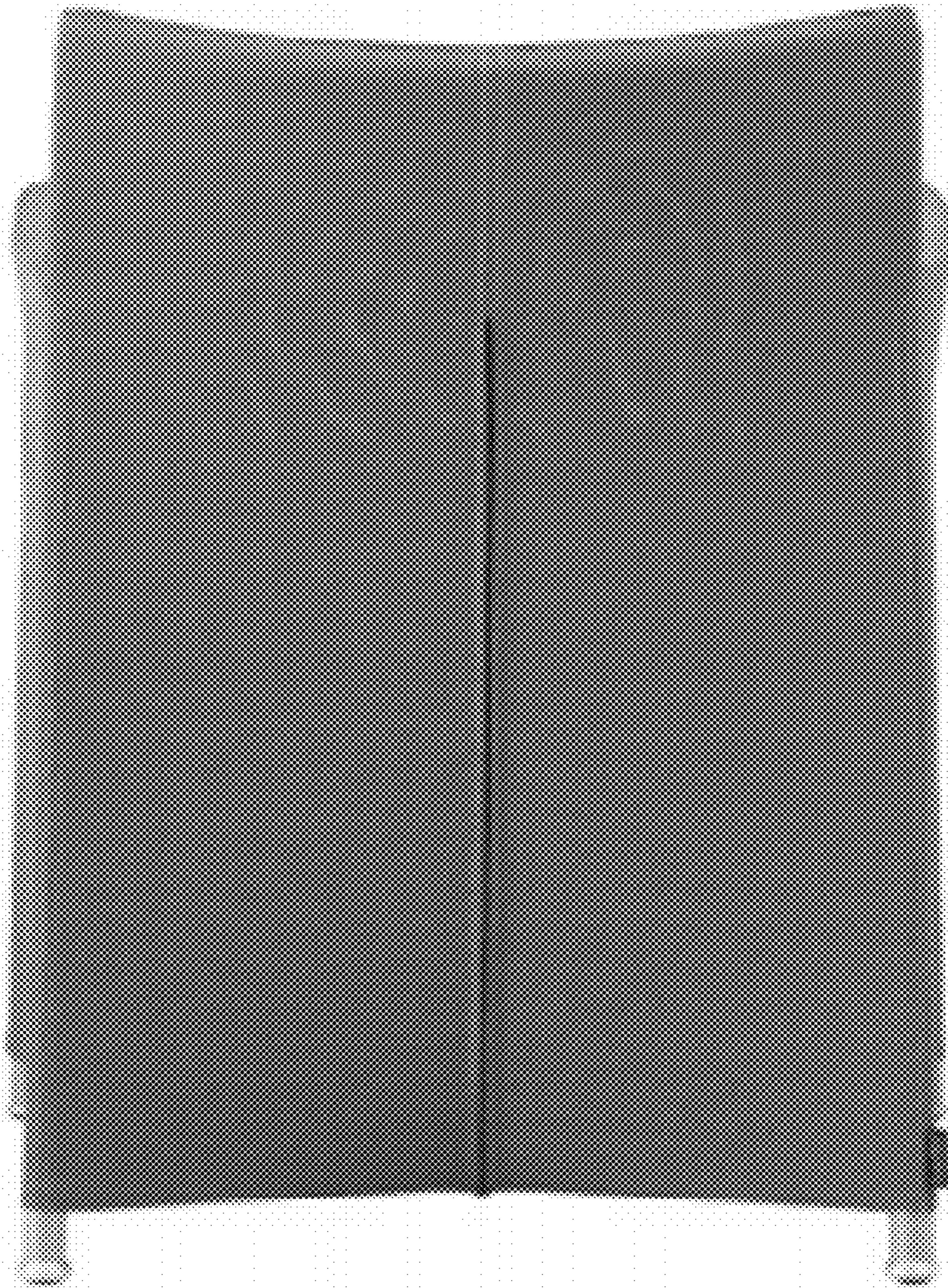
