The ornamental design for a toilet paper dispenser, as shown and described.

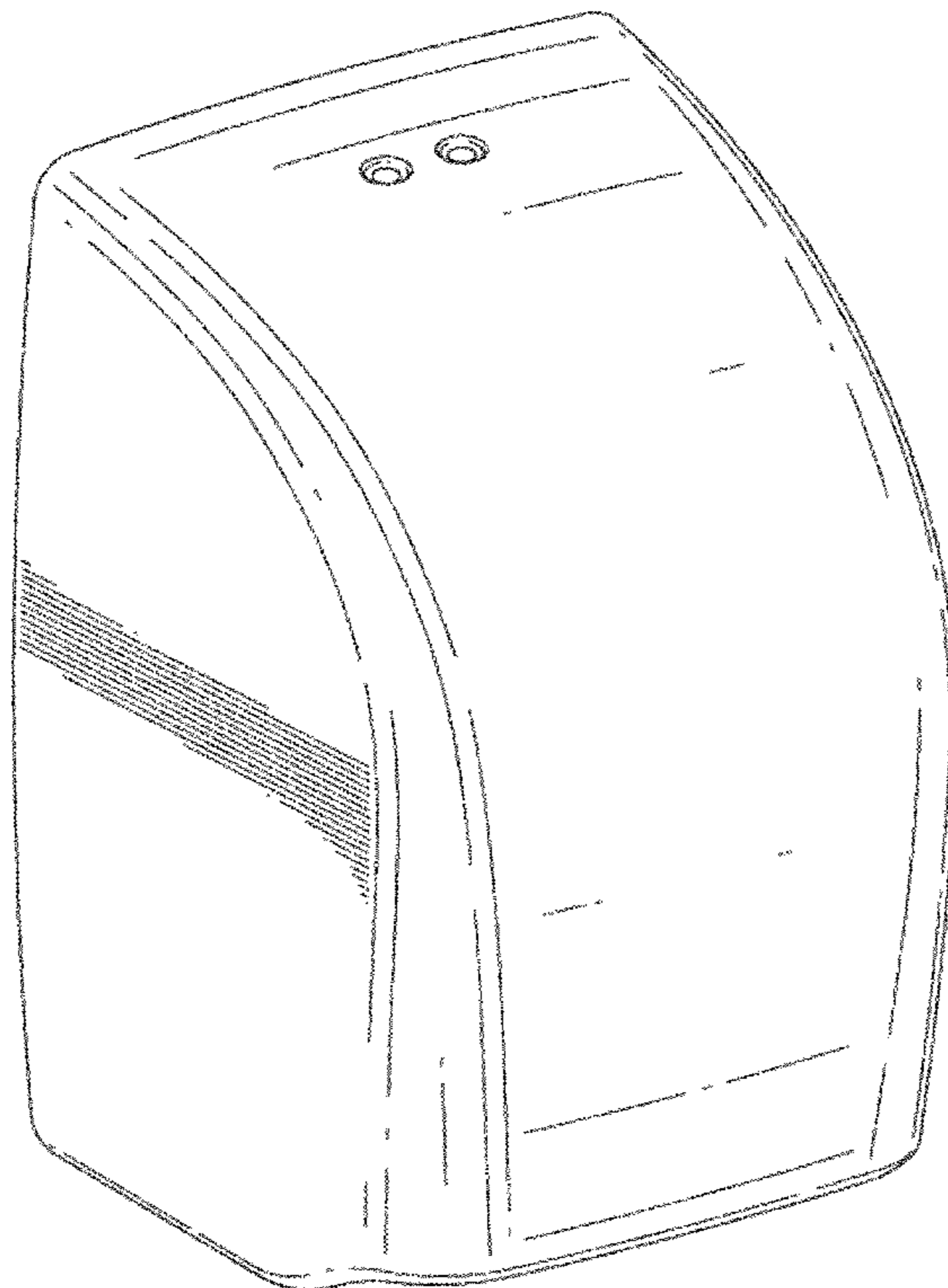
**DESCRIPTION**

FIG. 1 is a front, left perspective view of a toilet paper dispenser showing my new design;

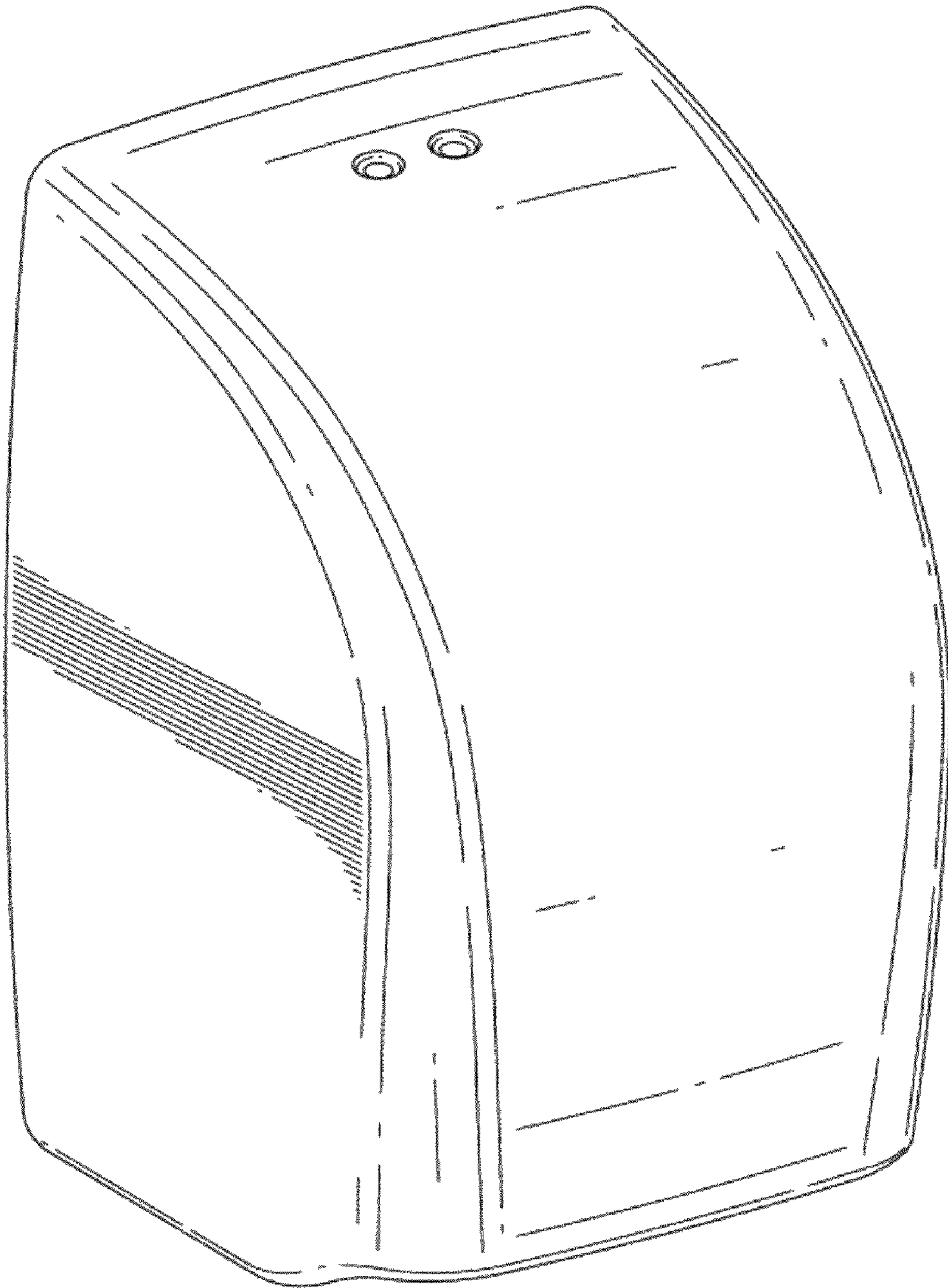

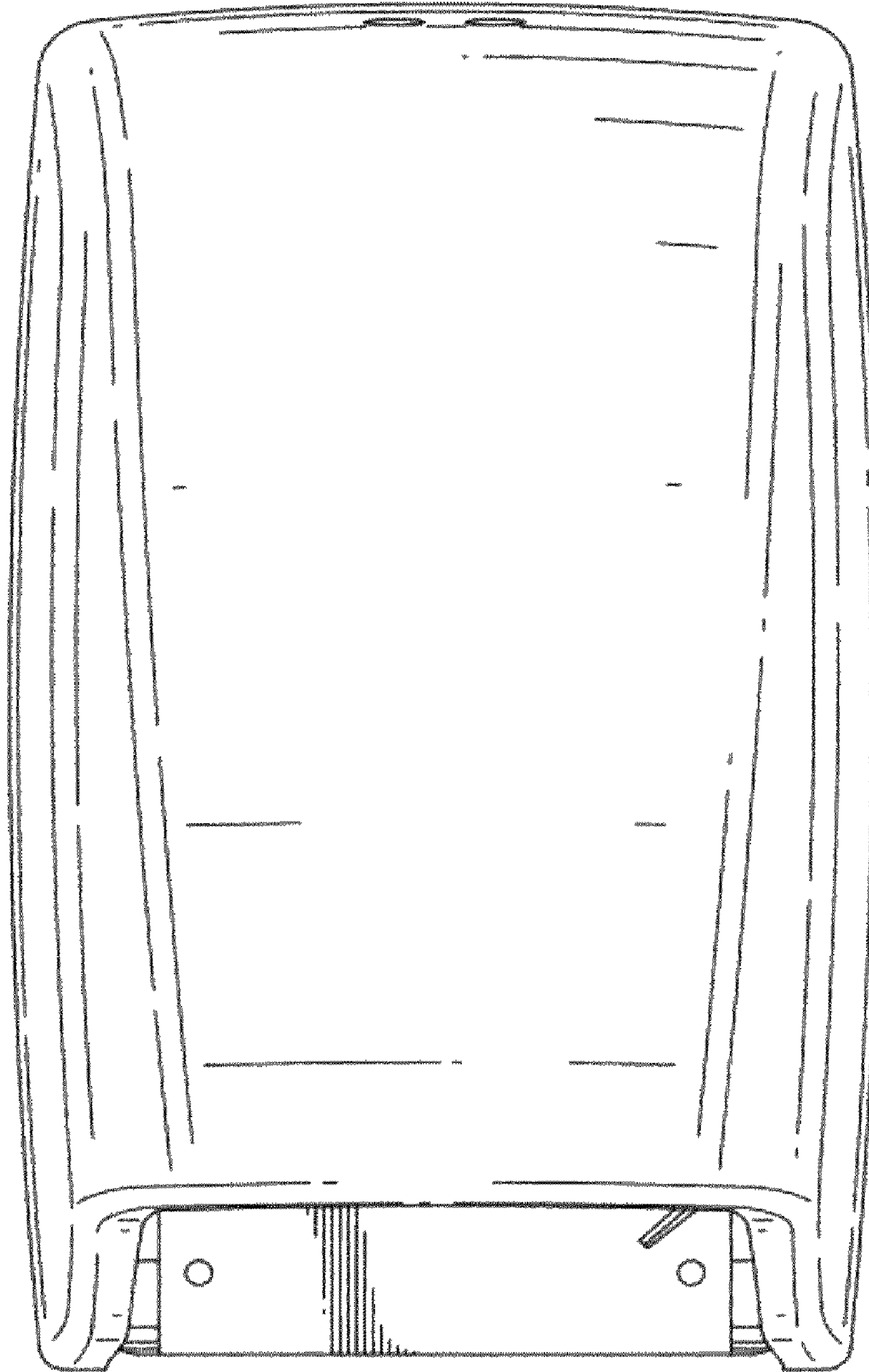

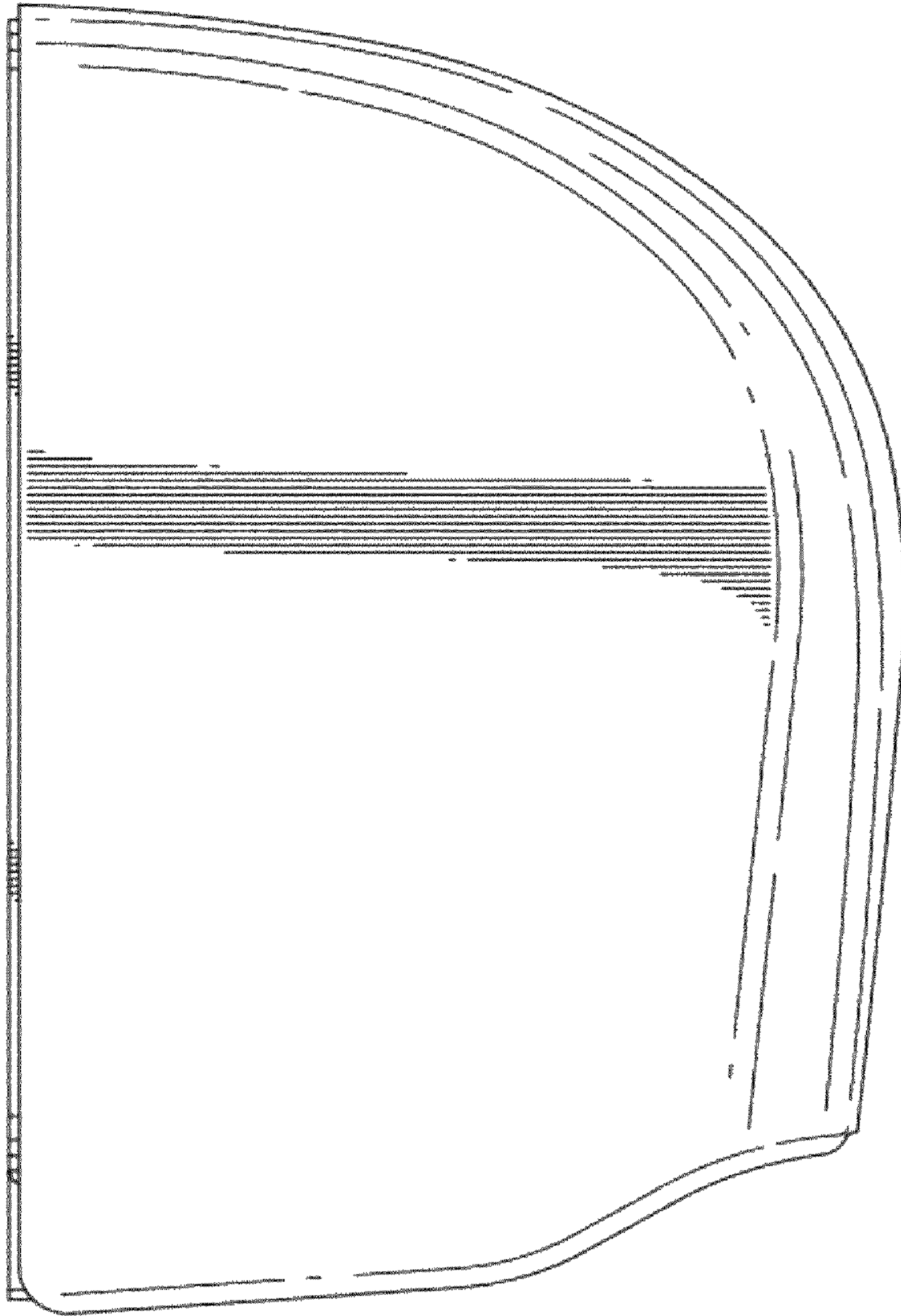

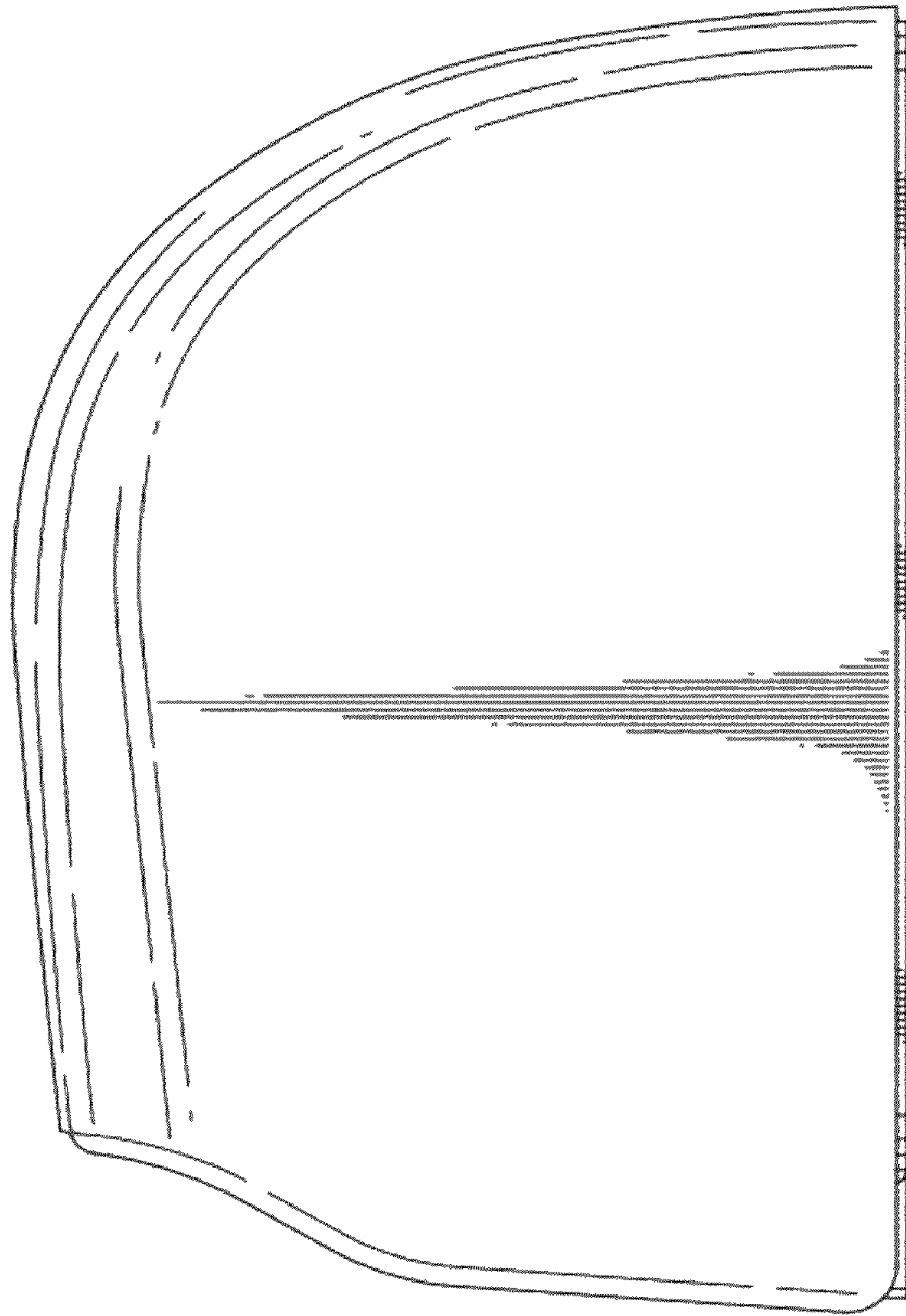

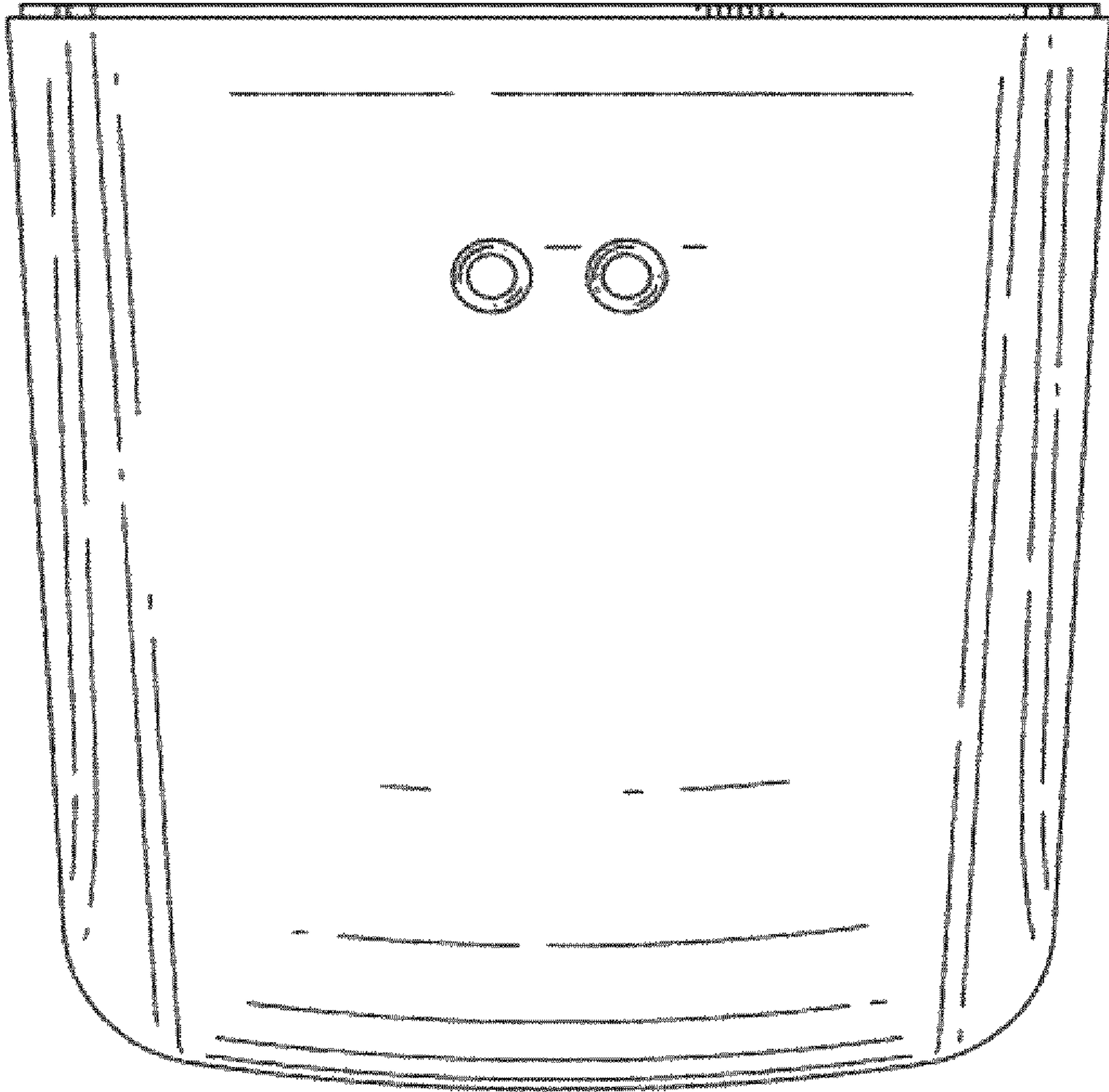
