(57) **CLAIM**

The ornamental design for a cookware side handle having  
contrasting embedded portion, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the “cookware side handle  
having contrasting embedded portion”, showing my new  
design;

FIG. 2 is a right side elevation view thereof; the left side  
elevation view being a mirror image thereof;

FIG. 3 is a top plan view thereof;

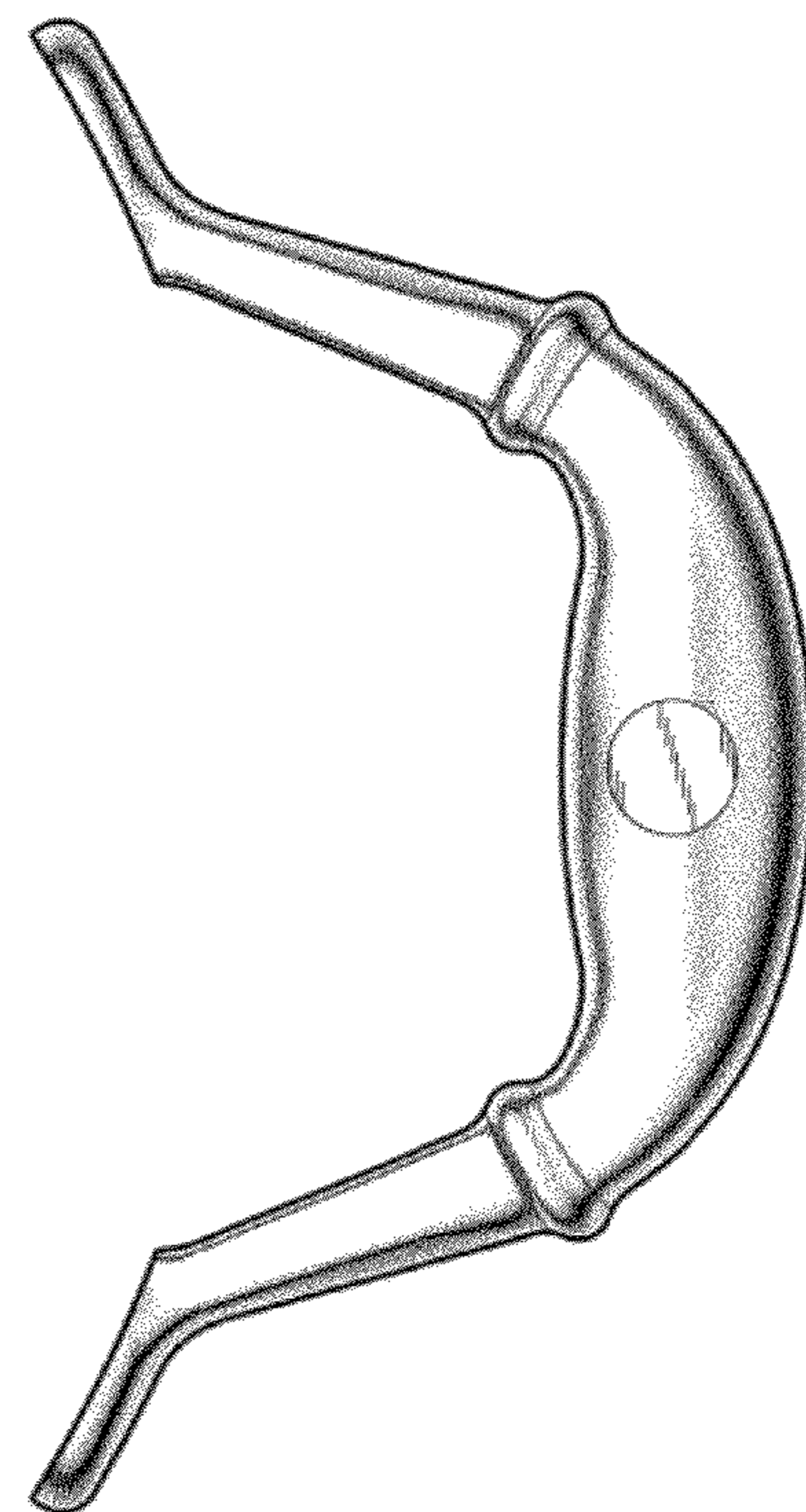
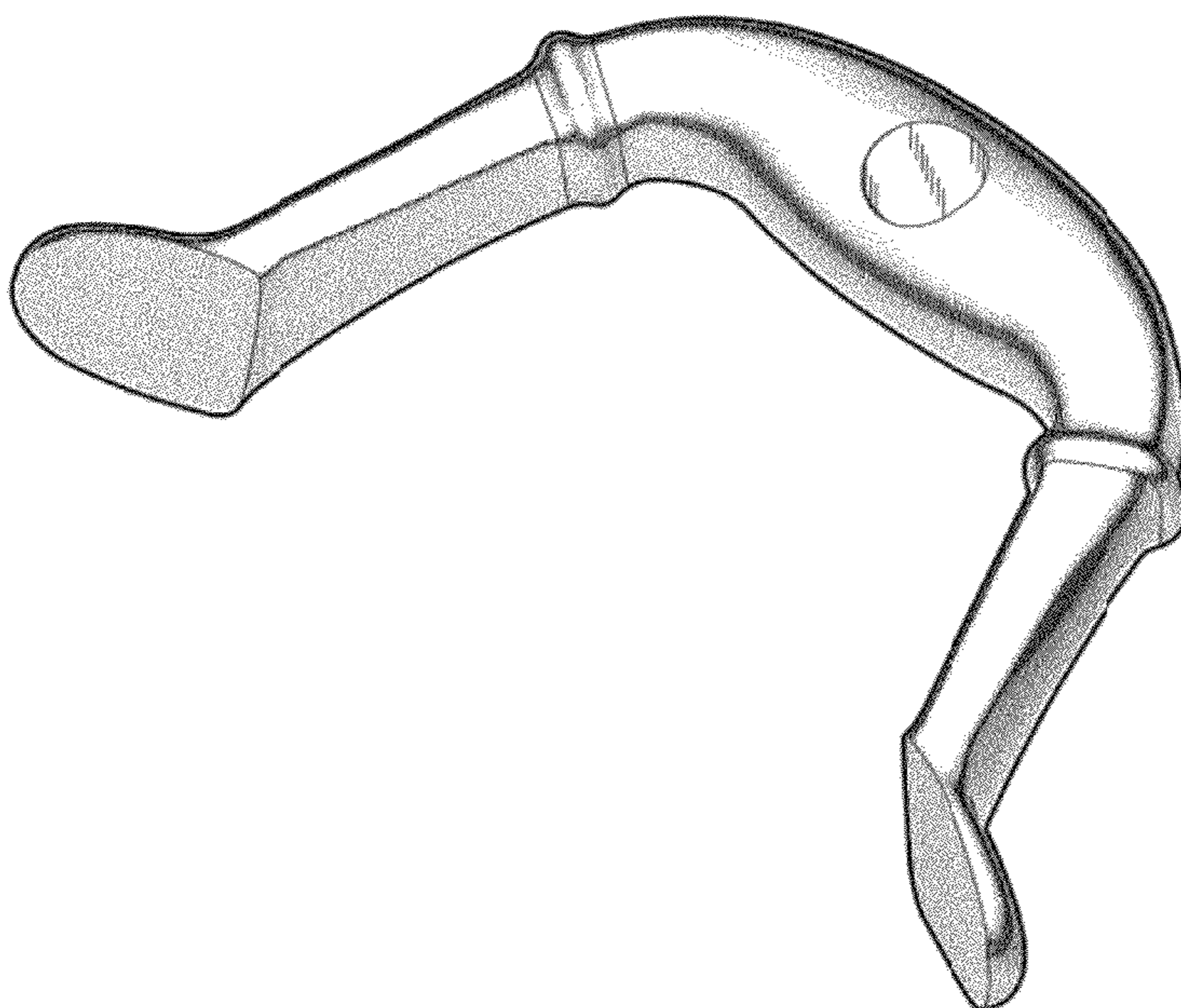
FIG. 4 is a bottom plan view thereof;

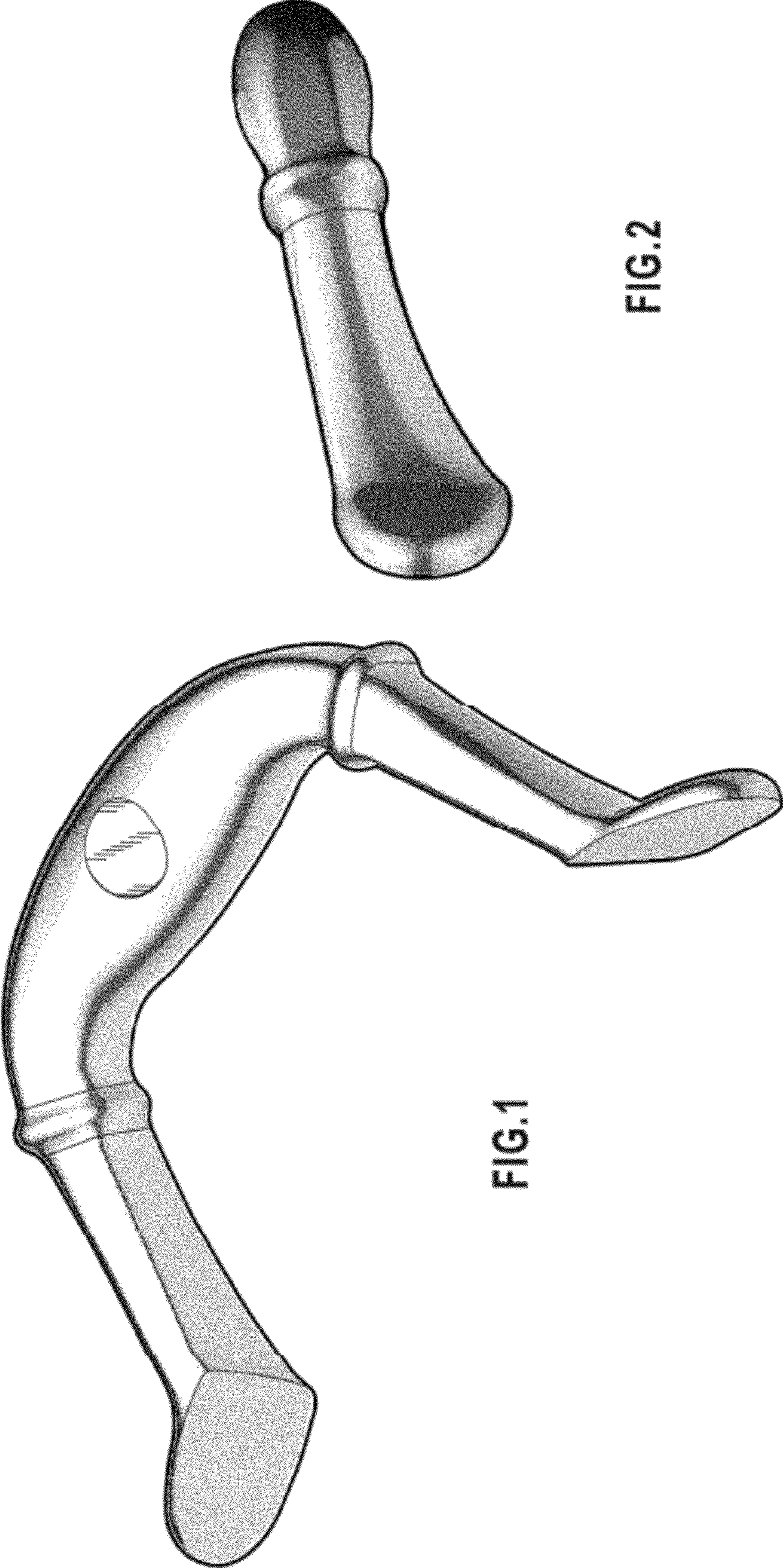

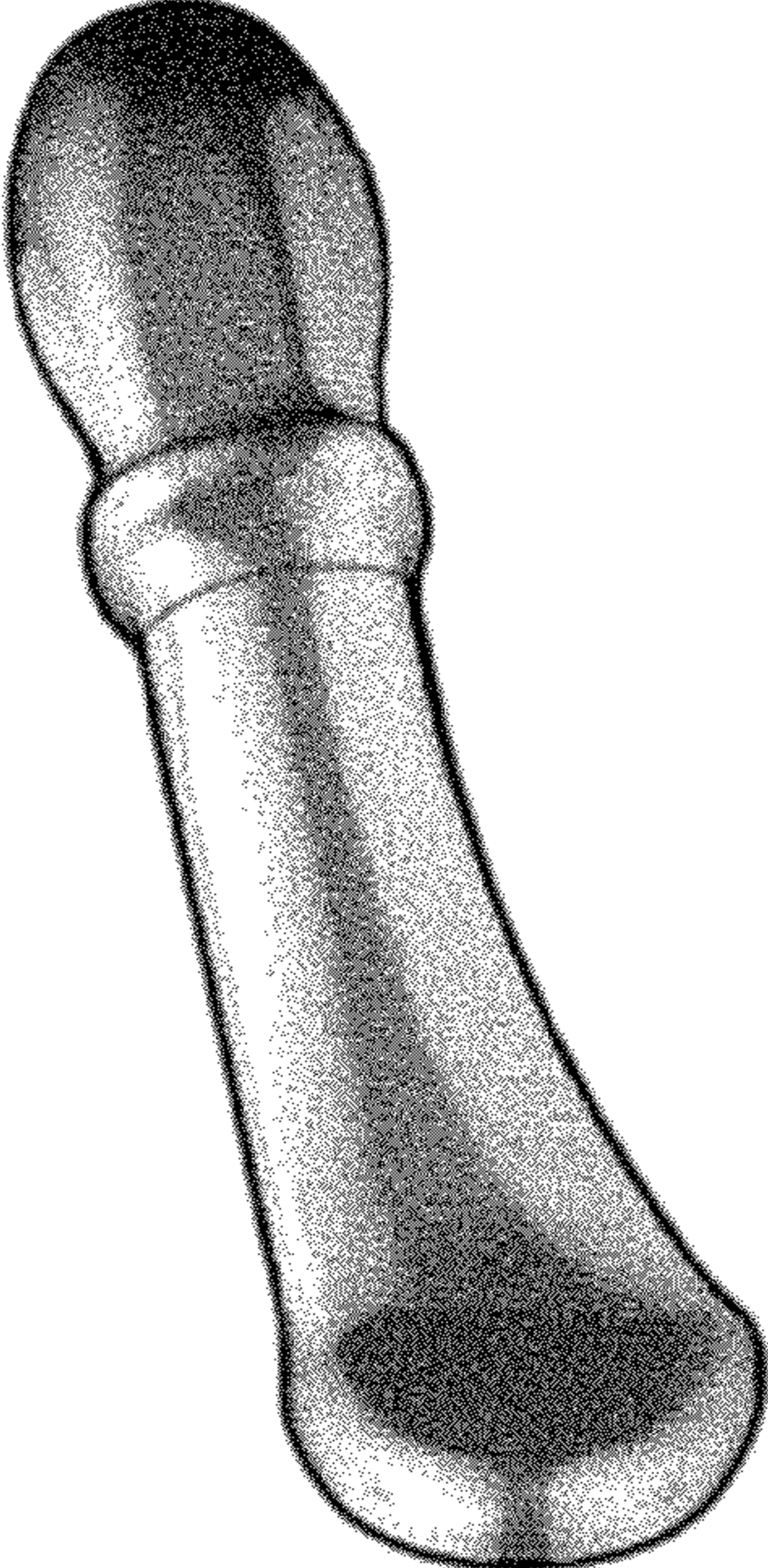

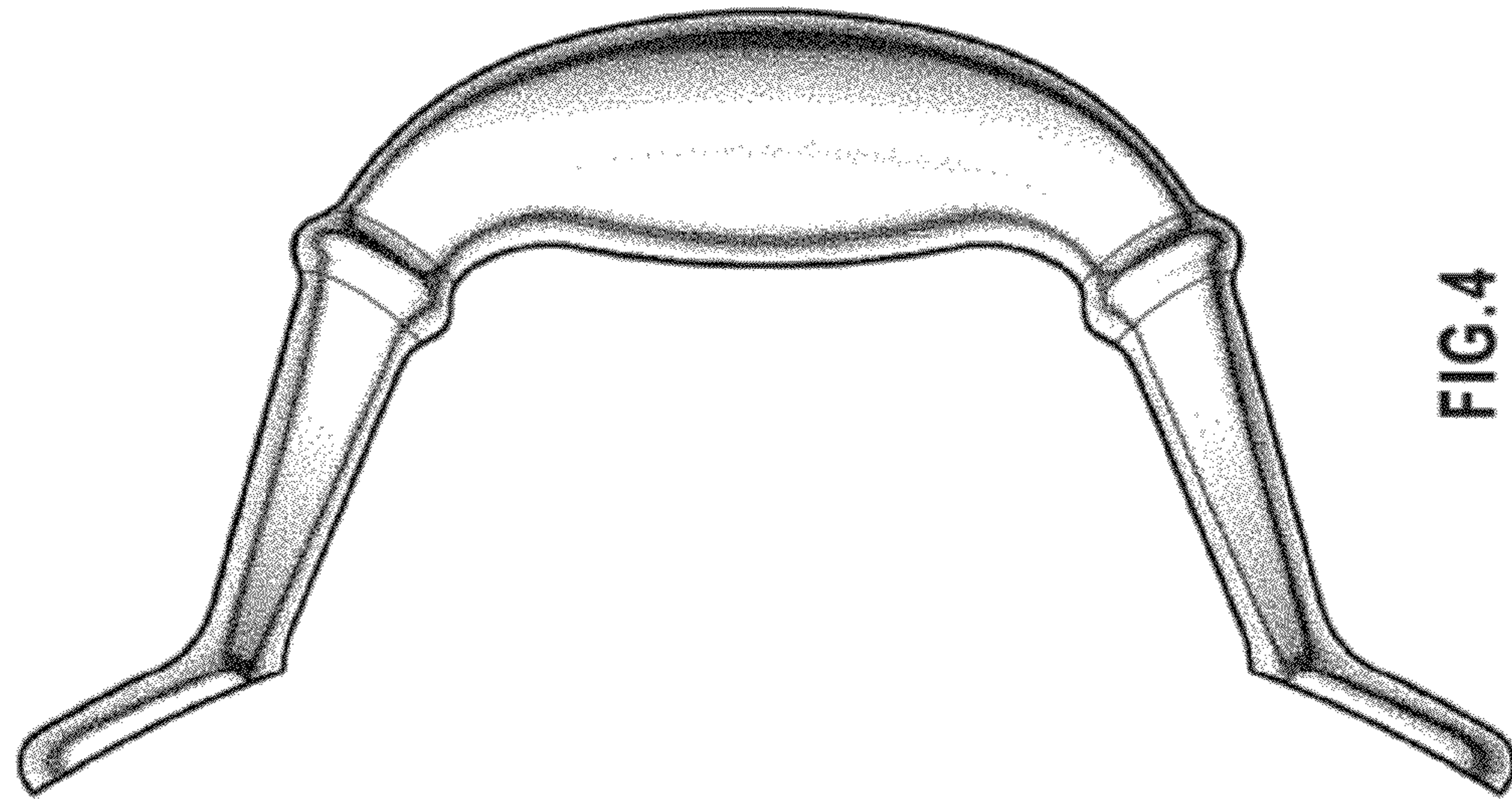

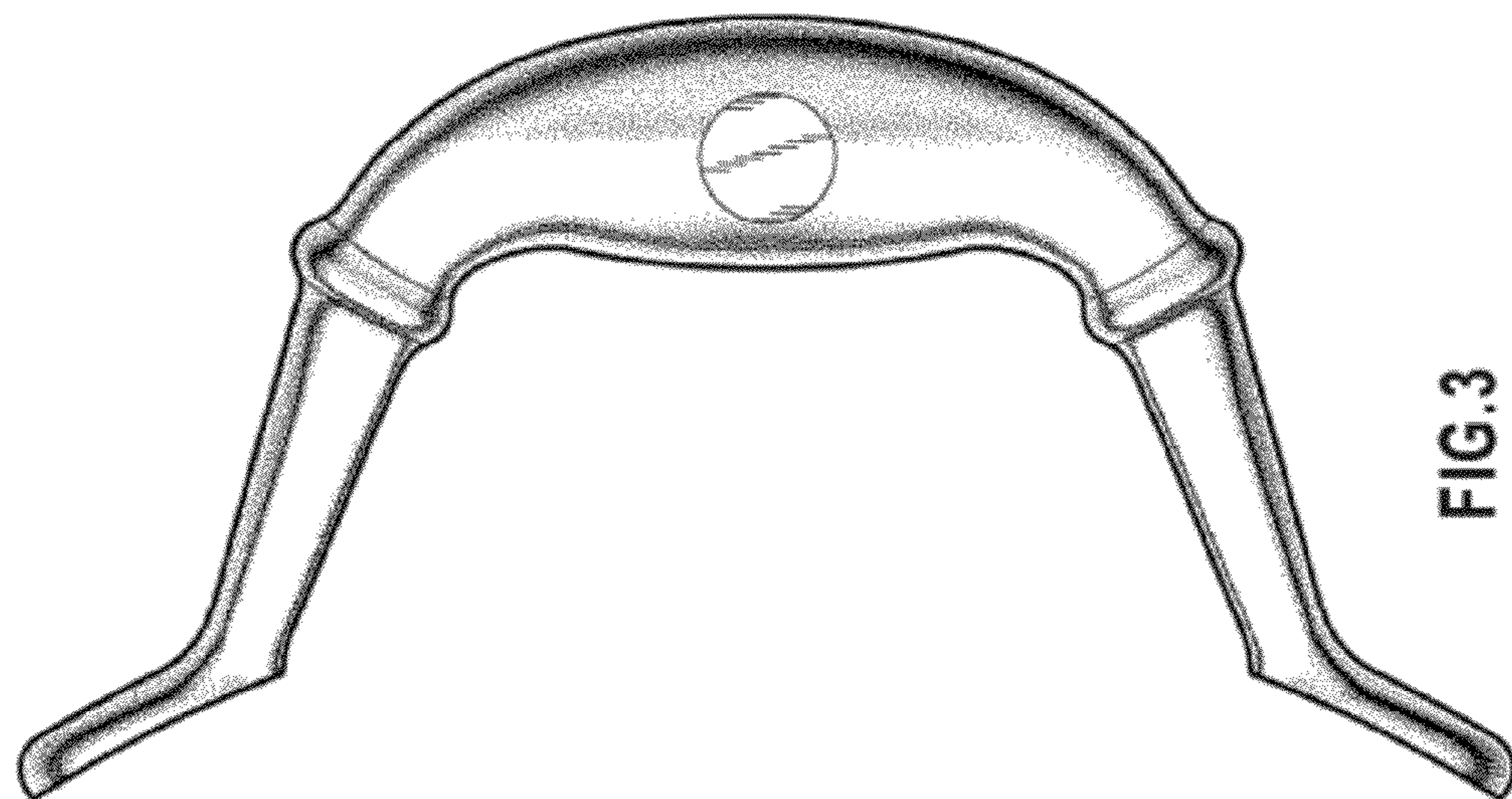

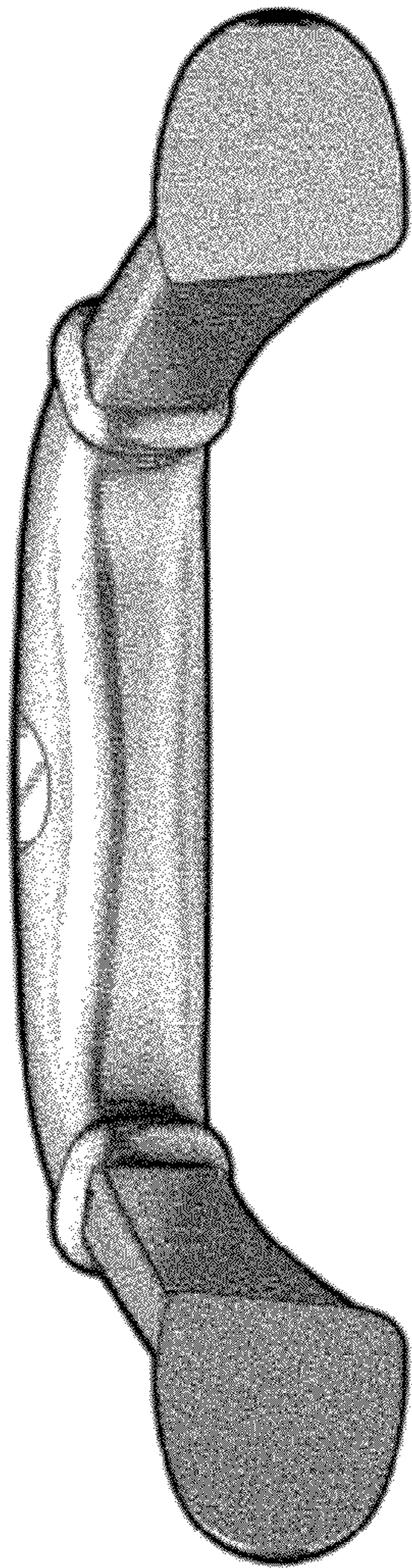

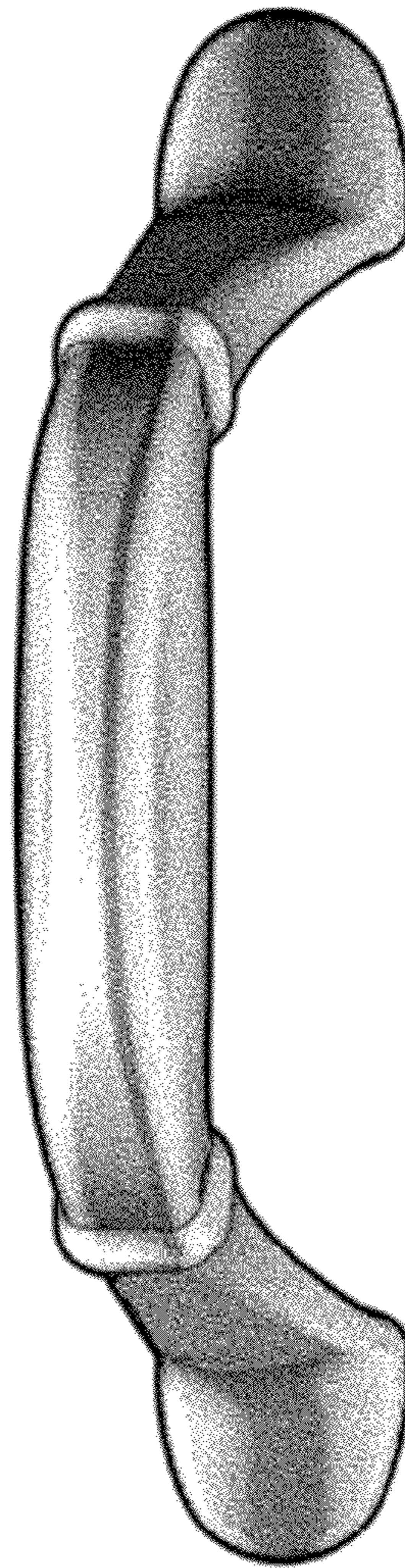
