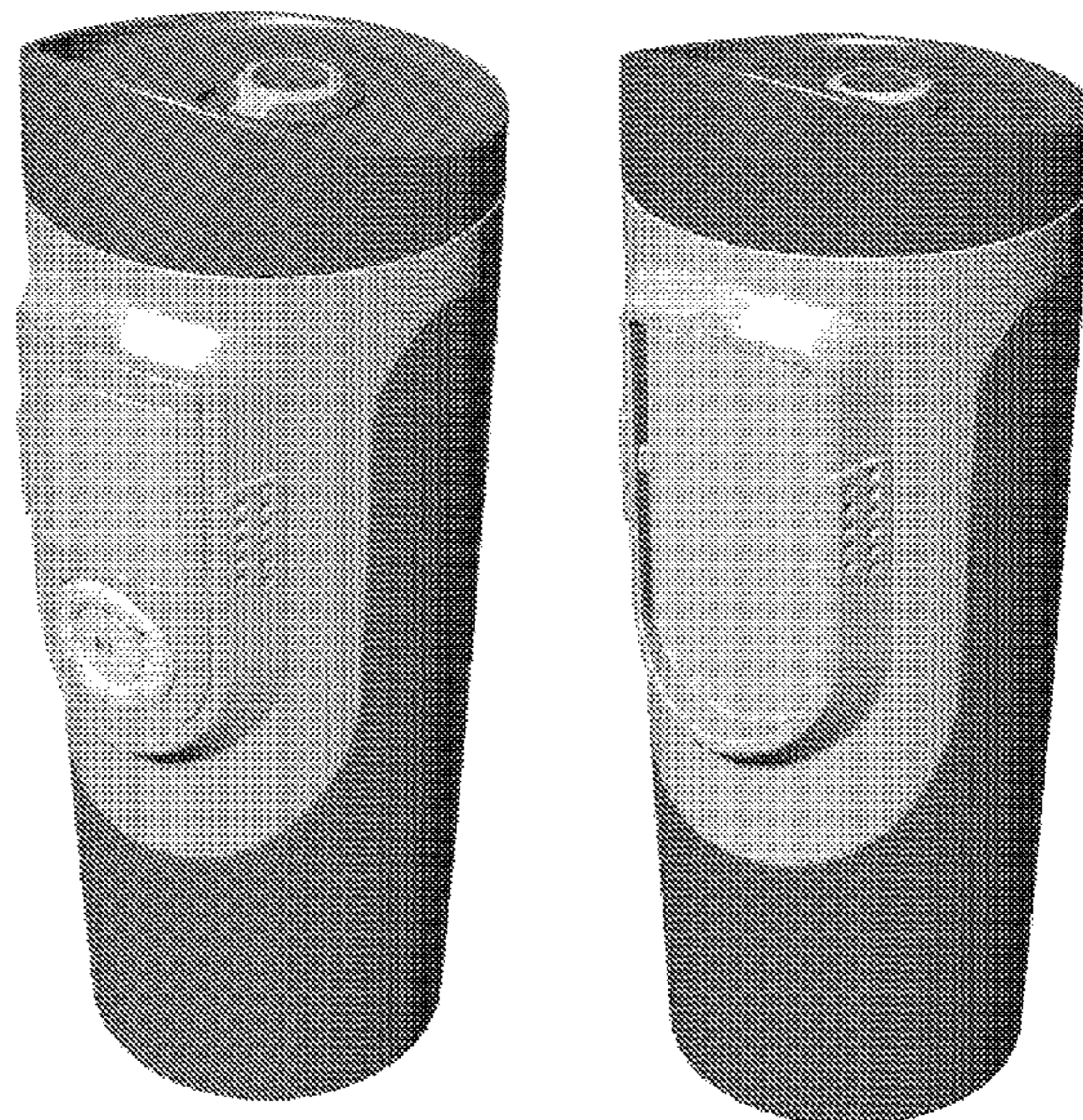
(57) **CLAIM**

The ornamental design for a drinking ware with multi-media module, as shown and described.

DESCRIPTION

FIG. 1 is a left-front perspective view of a drinking ware with multi-media module showing my new design;
 FIG. 2 is a left-front perspective view of a drinking ware shown separated from the multi-media module;
 FIG. 3 is a left-front perspective view of a multi-media module shown separated from the drinking ware;
 FIG. 4 is a front elevation view of the drinking ware shown separated from the multi-media module;
 FIG. 5 is a rear elevation view of the drinking ware;
 FIG. 6 is a right side elevation view of the drinking ware shown separated from the multi-media module;
 FIG. 7 is a left side elevation view of the drinking ware shown separated from the multi-media module;
 FIG. 8 is a top plan view of the drinking ware;
 FIG. 9 is a bottom plan view of the drinking ware;
 FIG. 10 is a front elevation view of the multi-media module shown separated from the drinking ware;
 FIG. 11 is a rear elevation view of the multi-media module shown separated from the drinking ware;
 FIG. 12 is a right side elevation view of the multi-media module shown separated from the drinking ware;
 FIG. 13 is a left side elevation view of the multi-media module shown separated from the drinking ware;

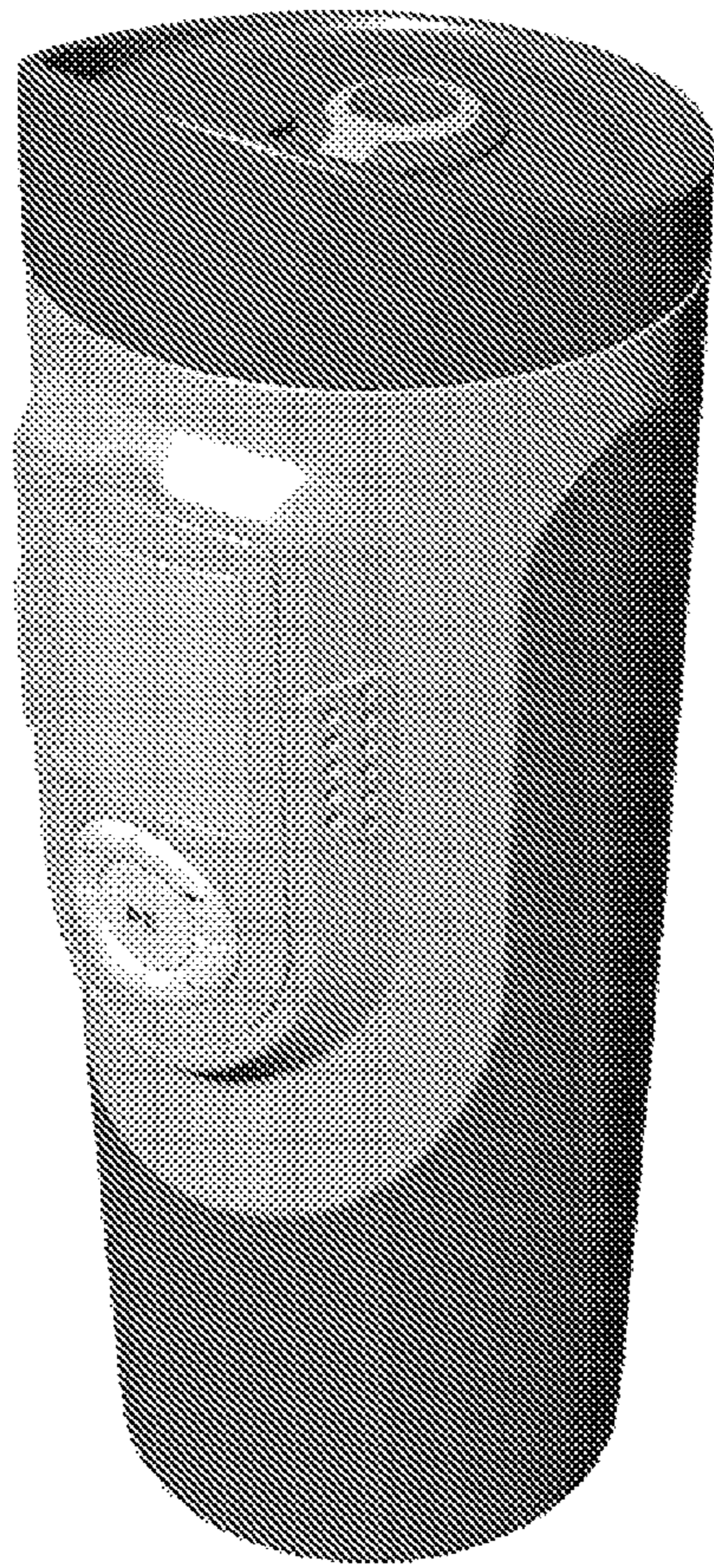

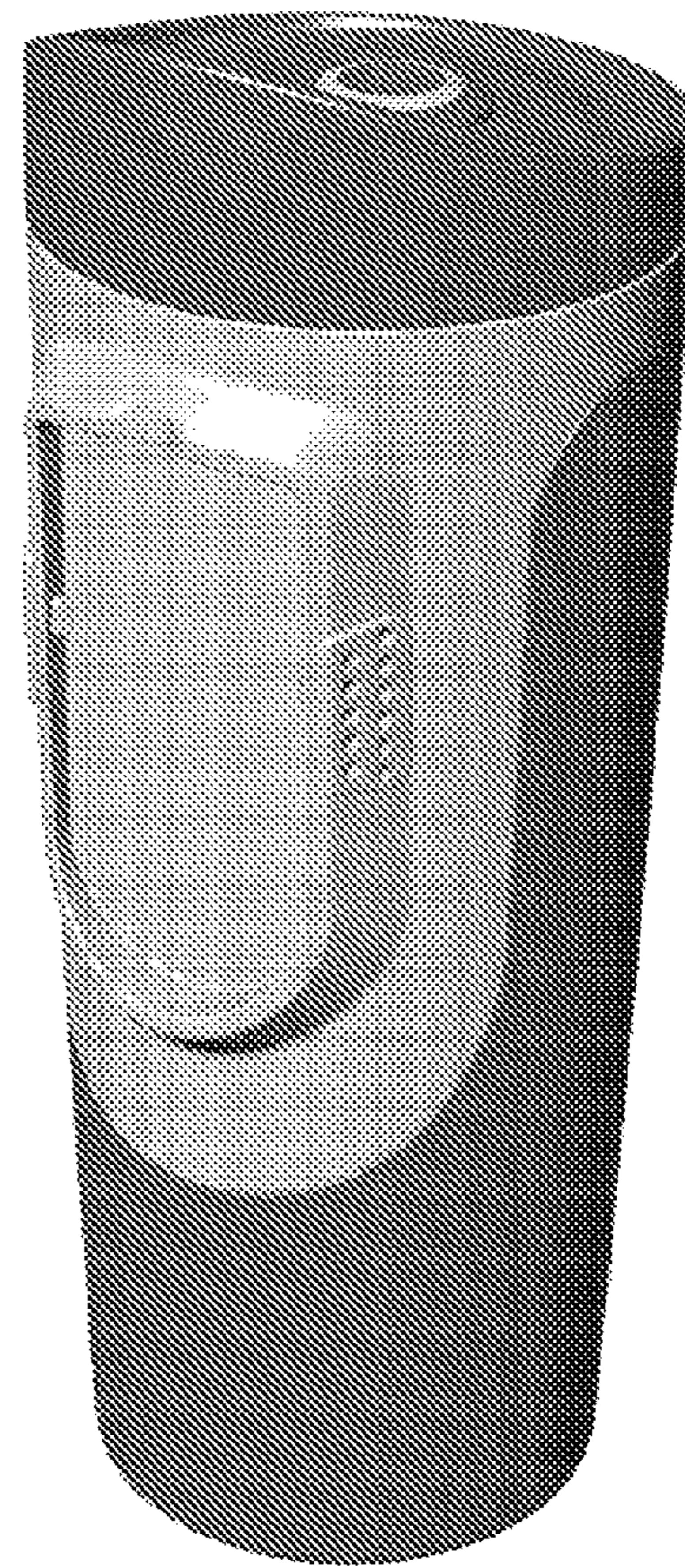

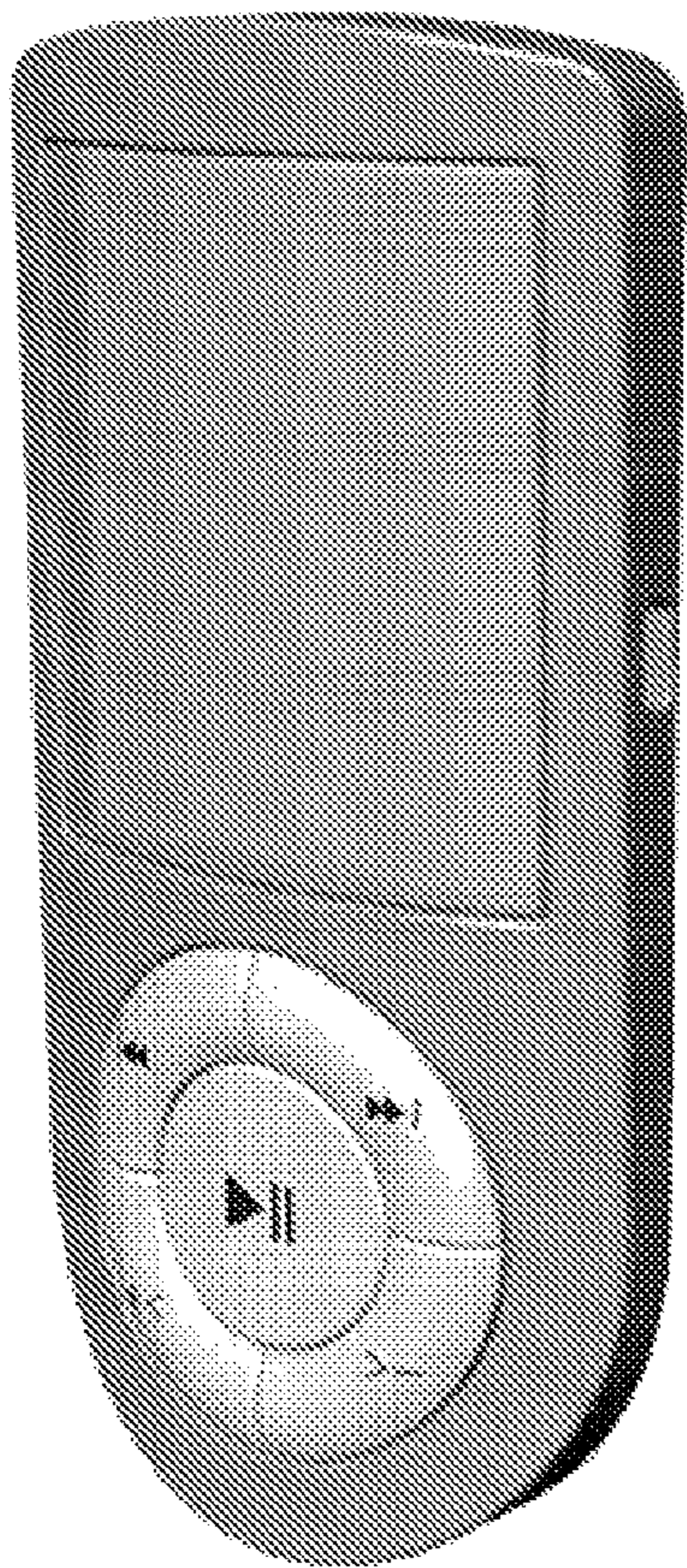

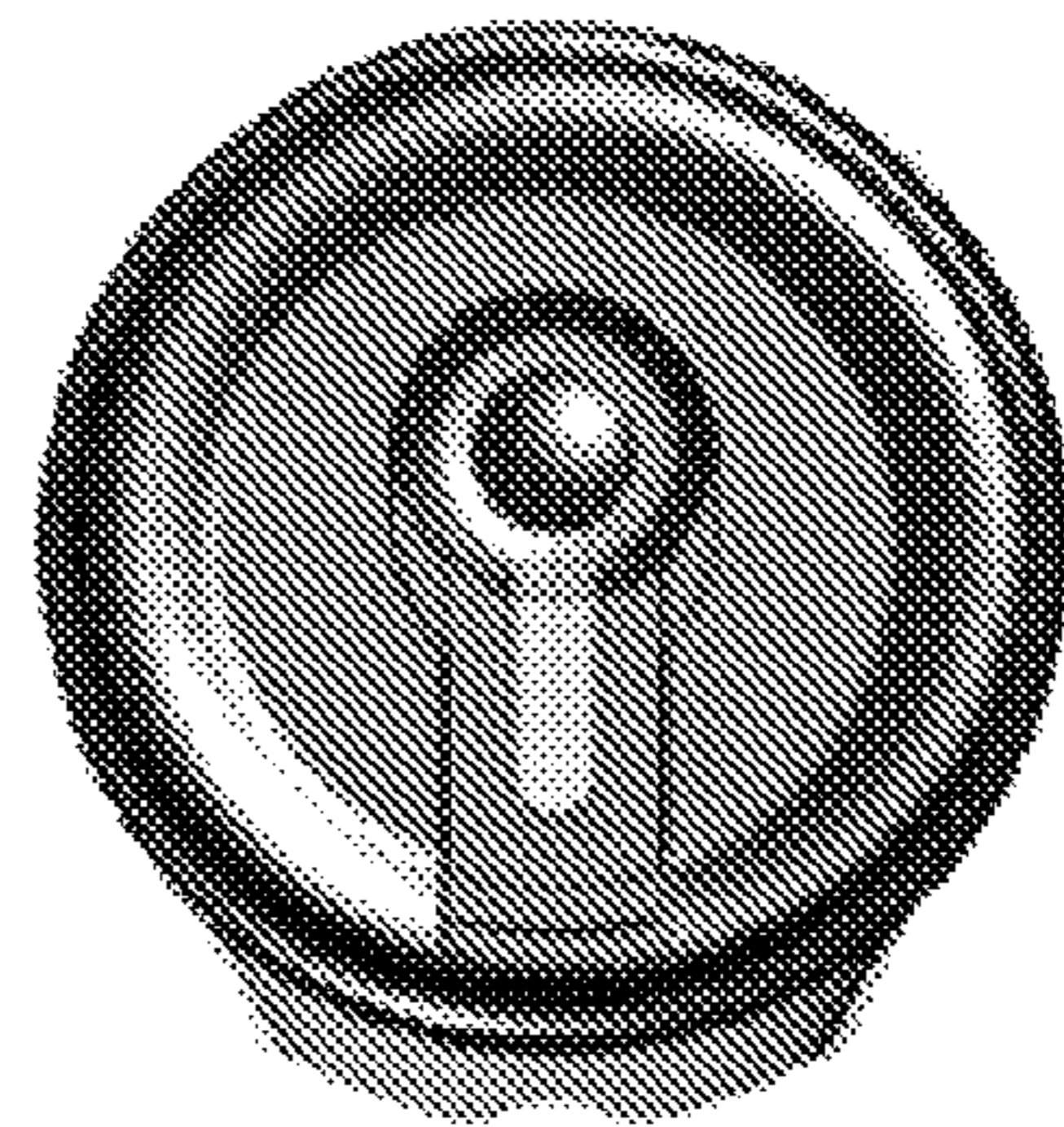

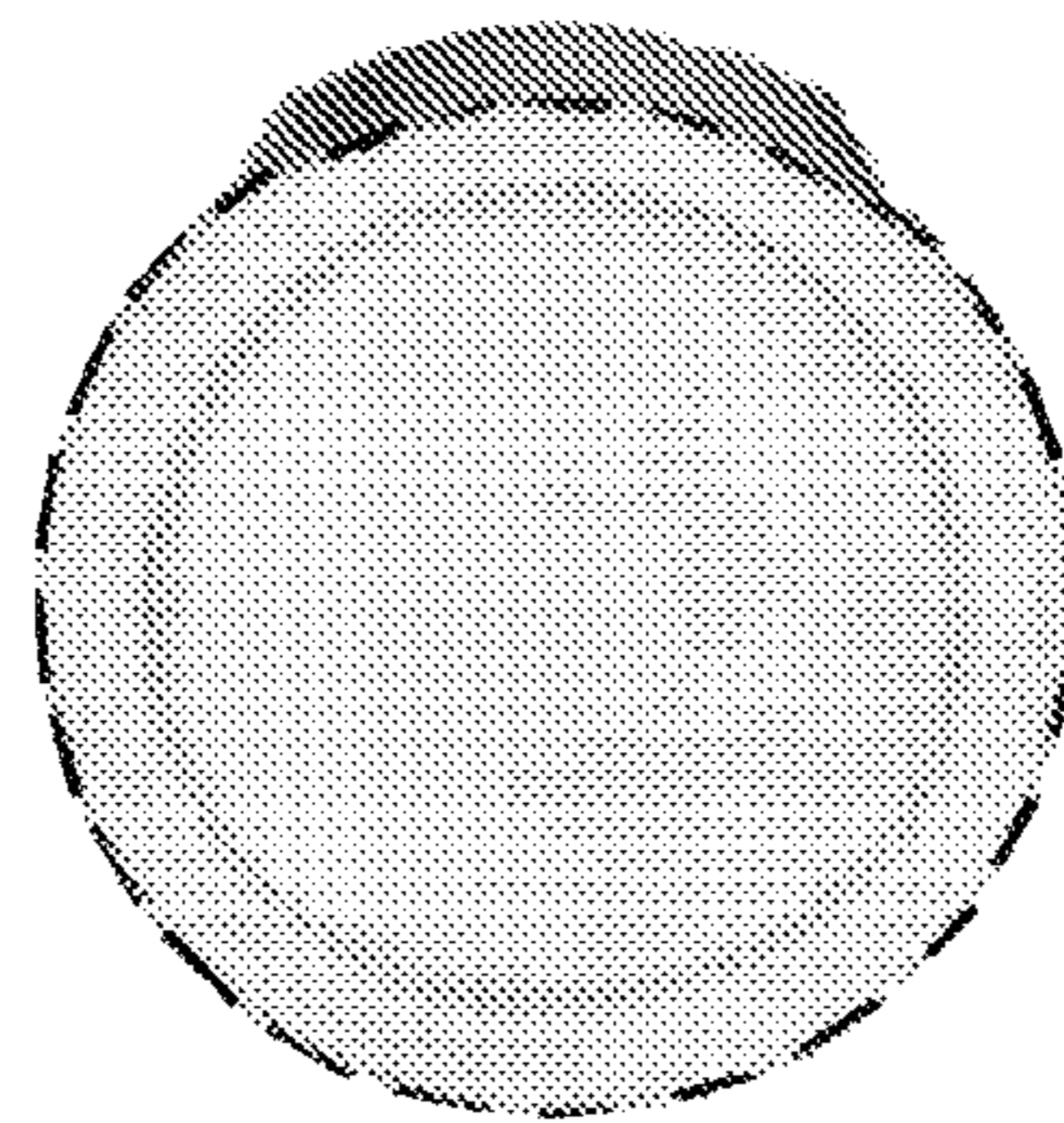

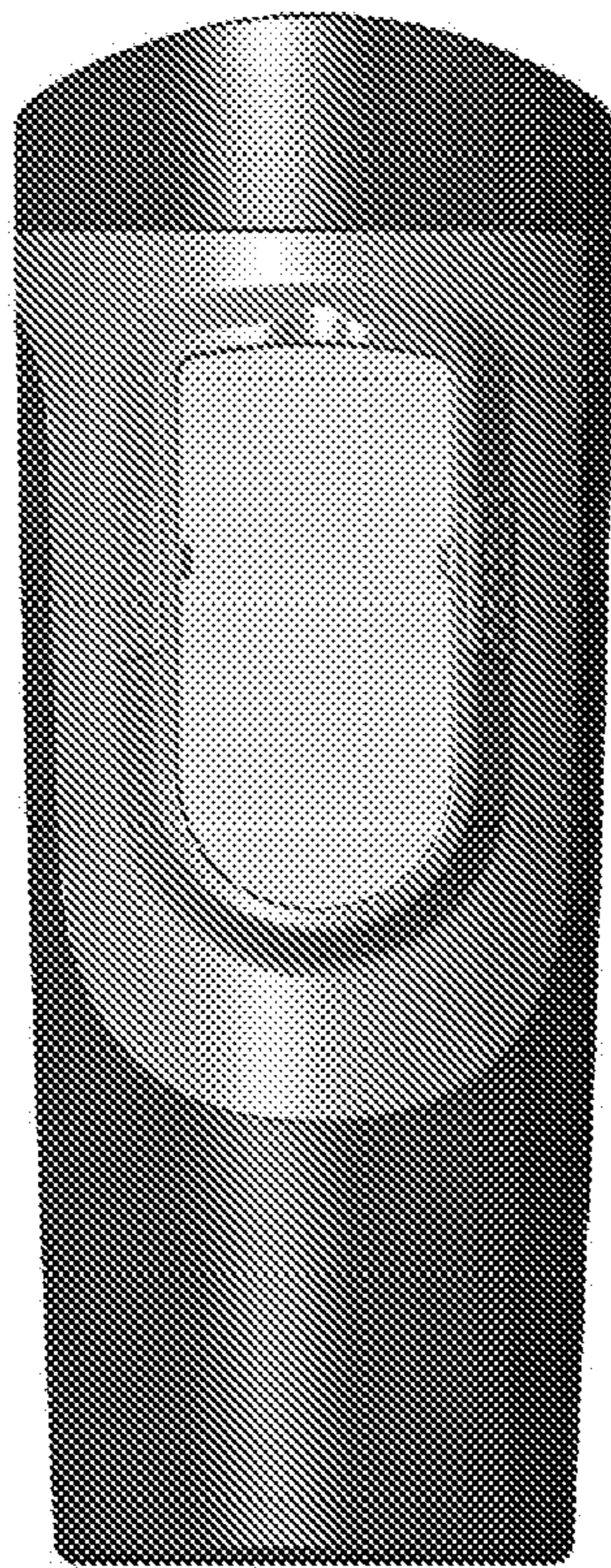

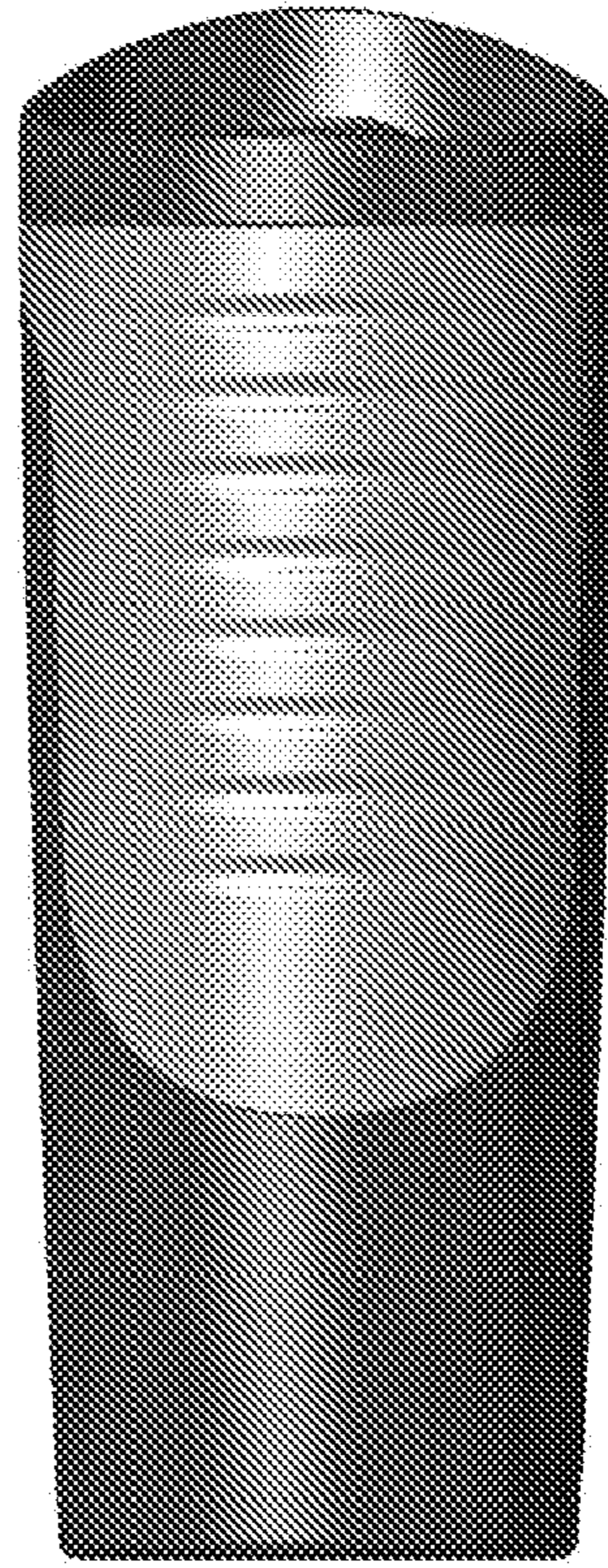

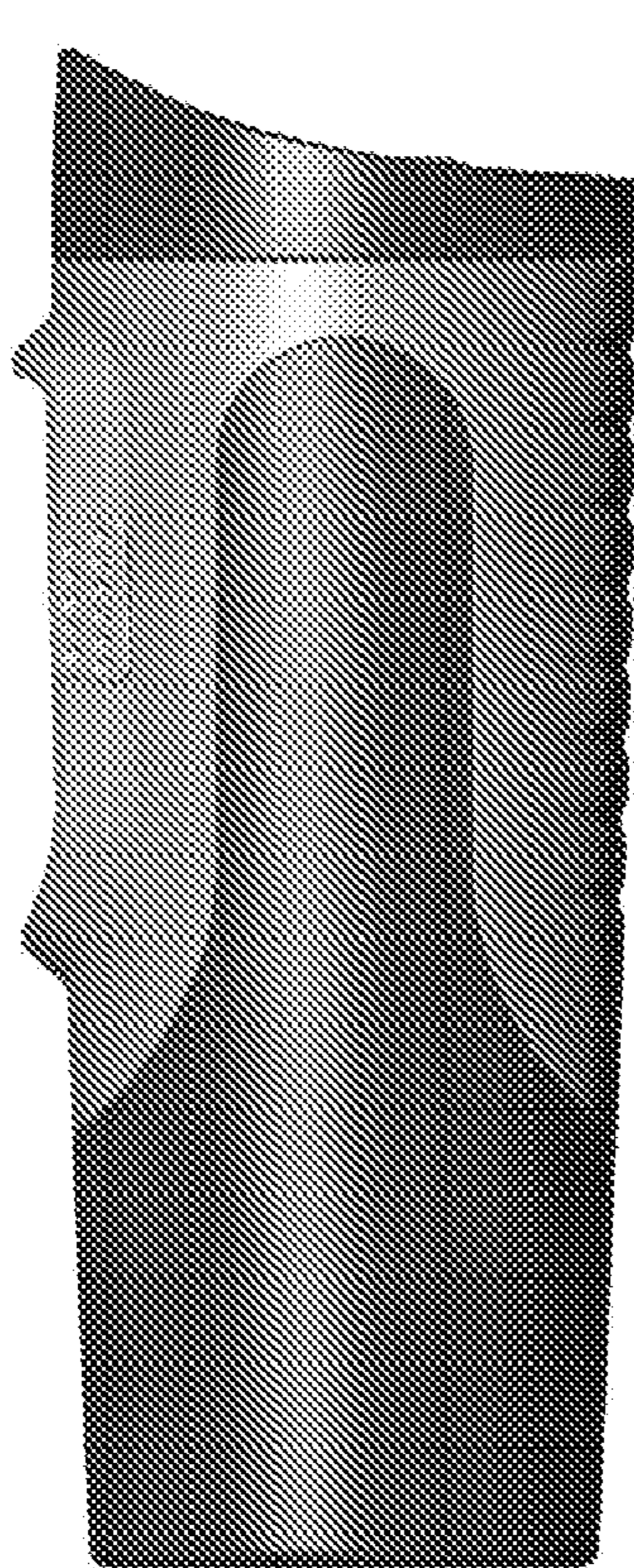

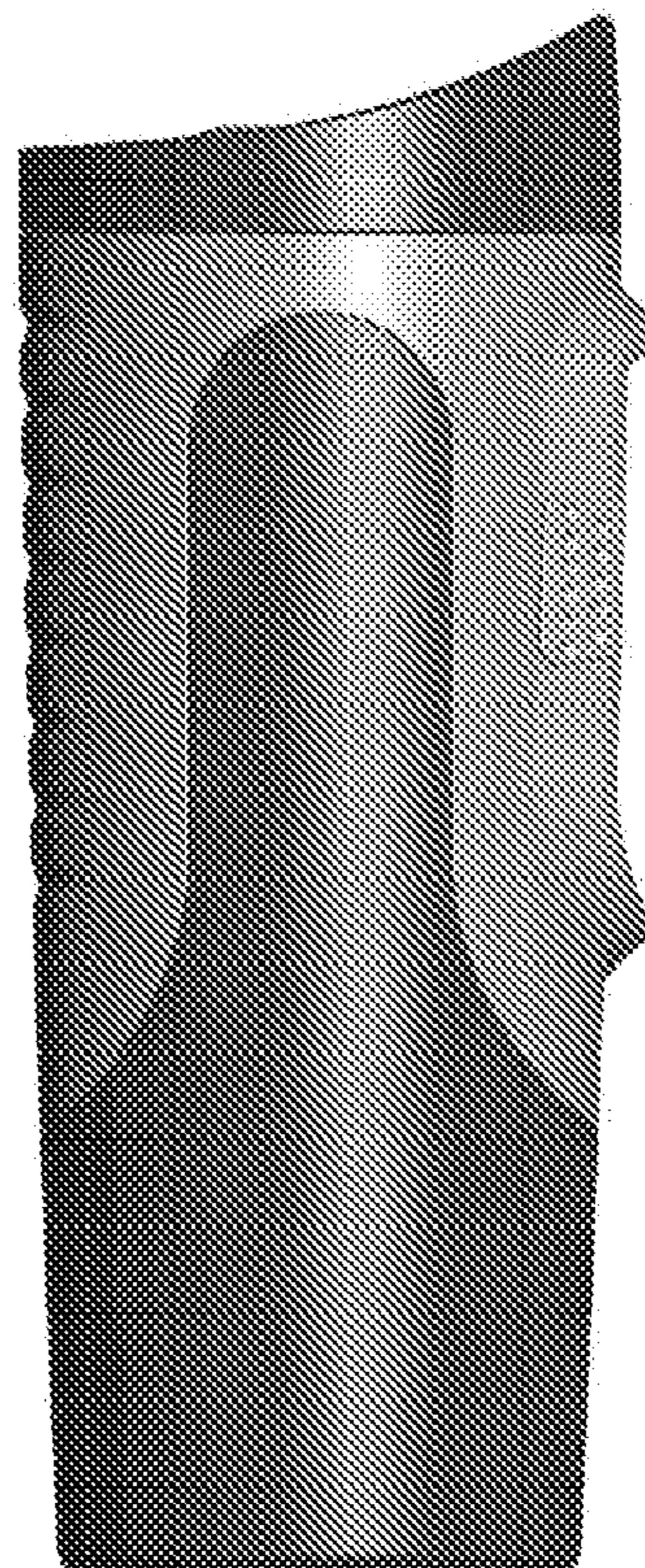

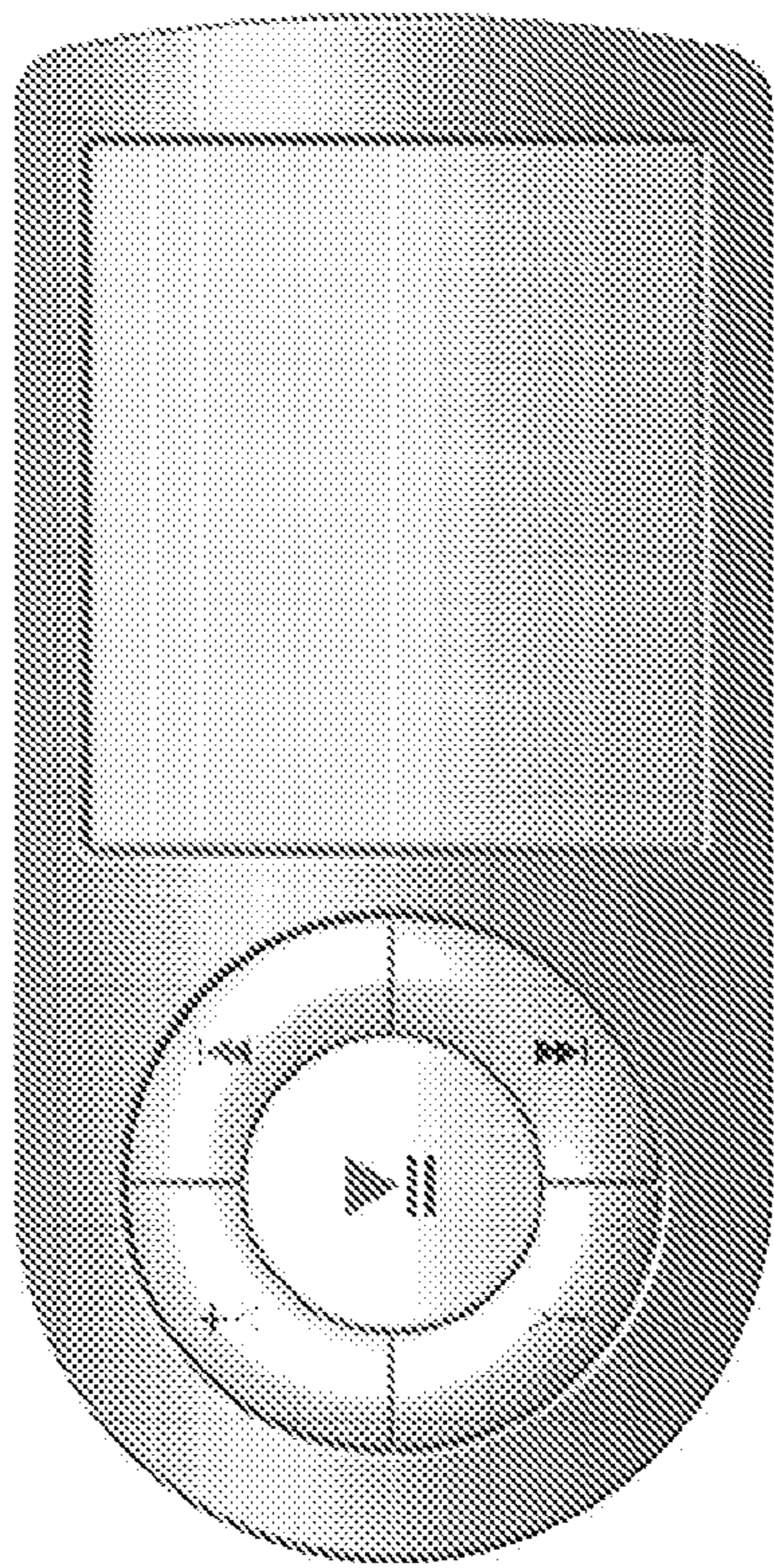

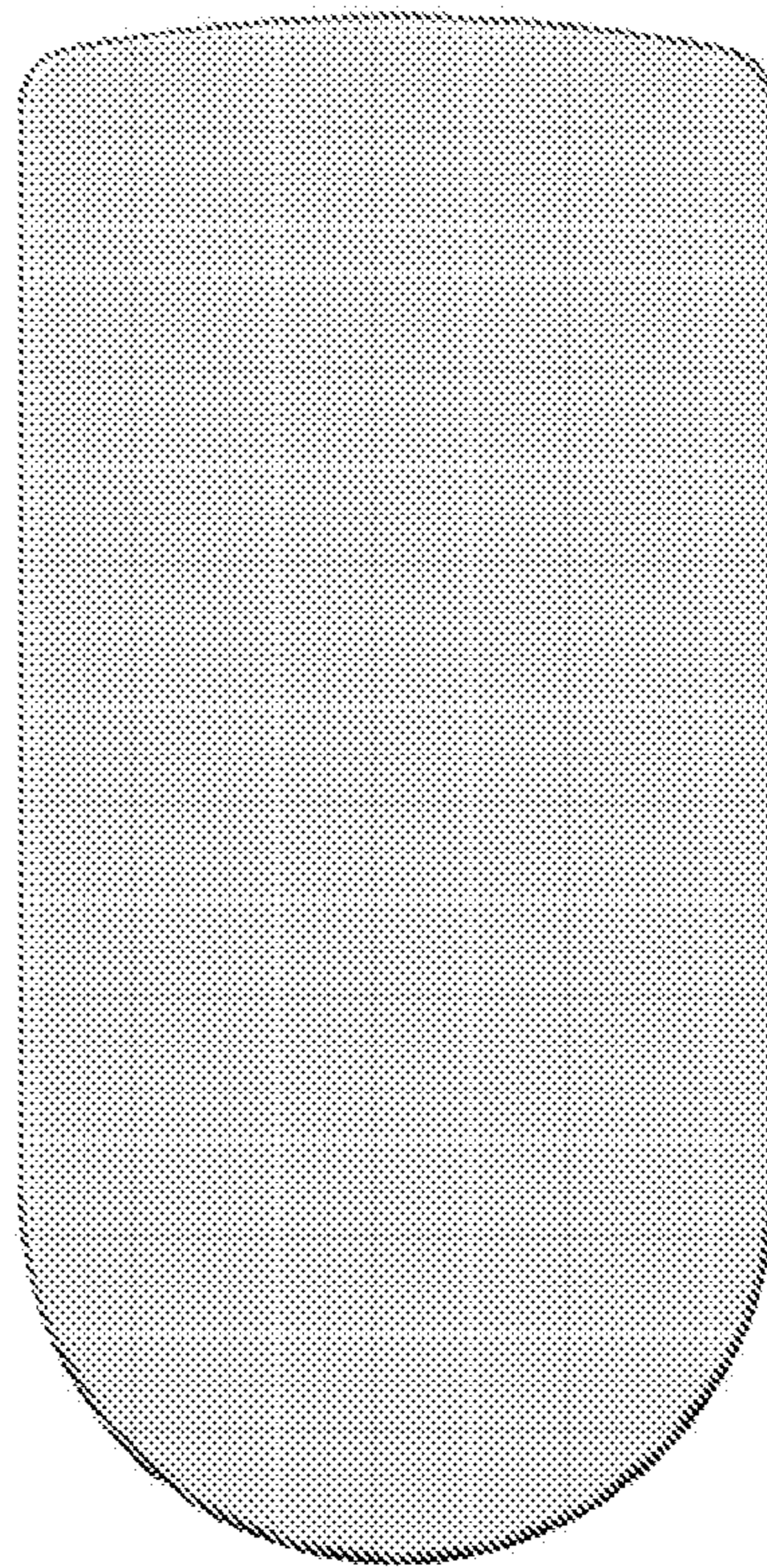

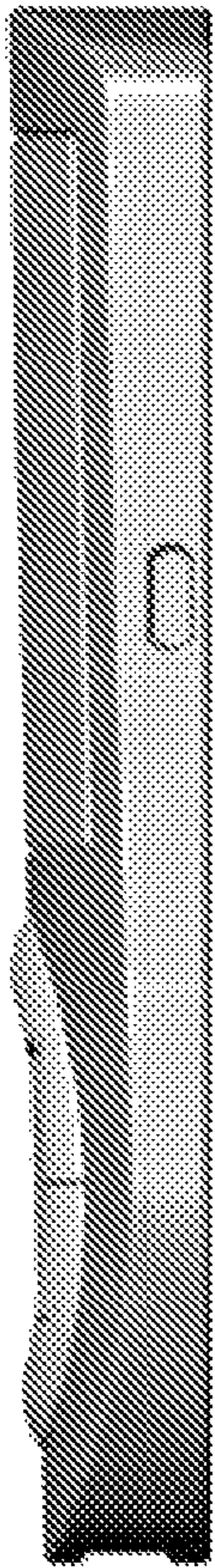

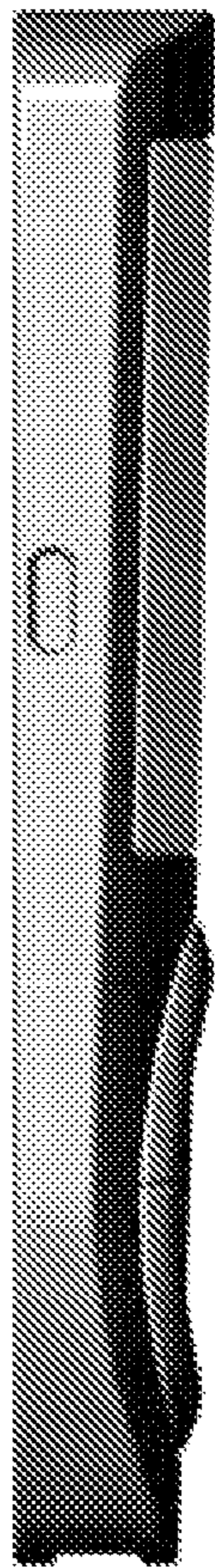

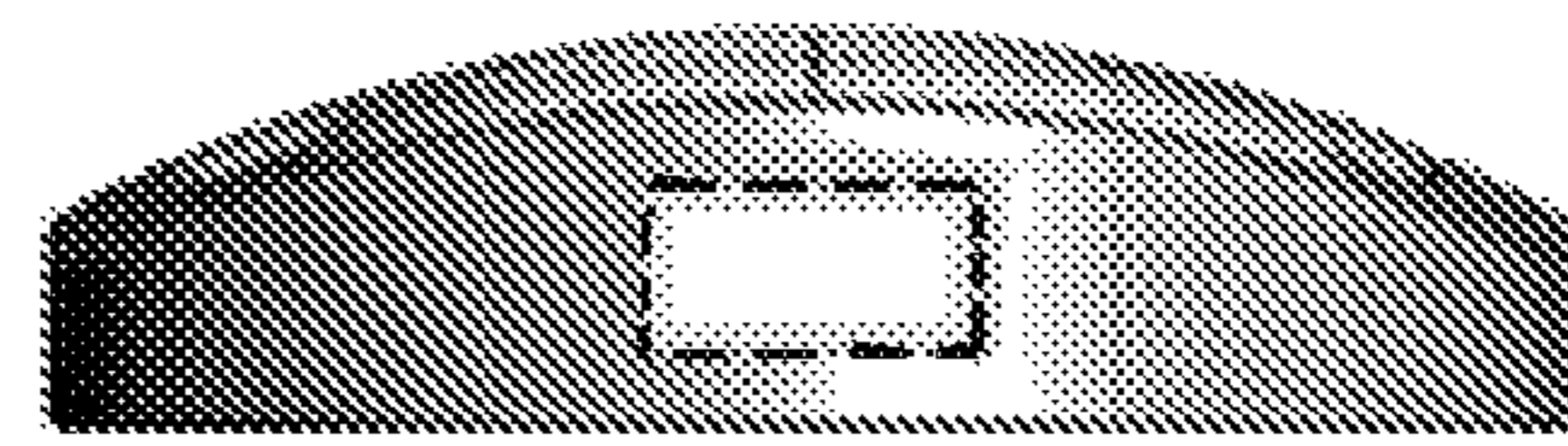

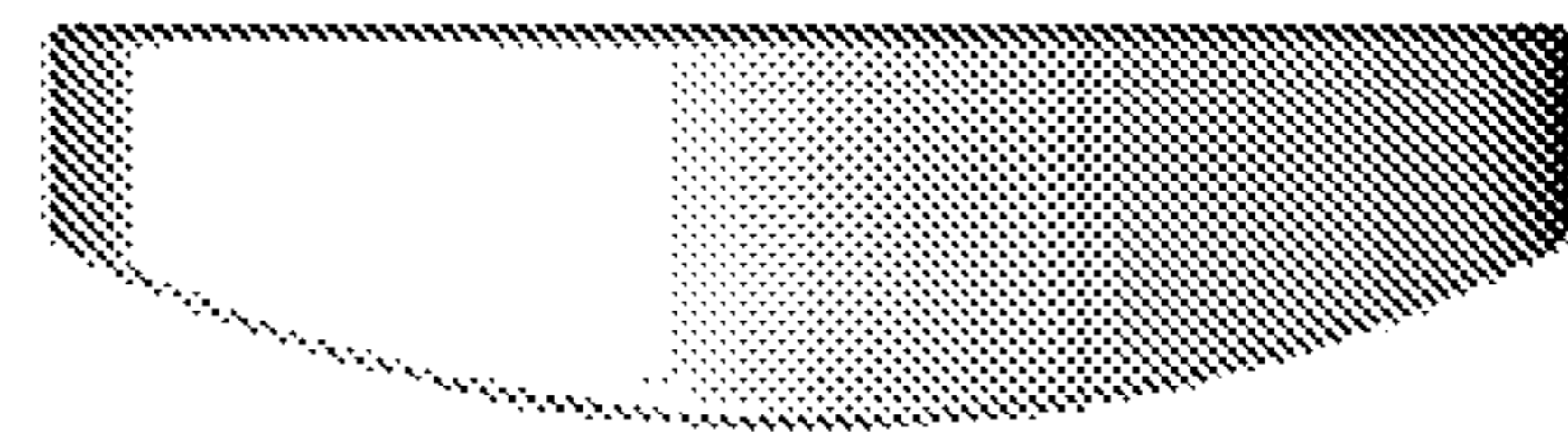
