(57) **CLAIM**

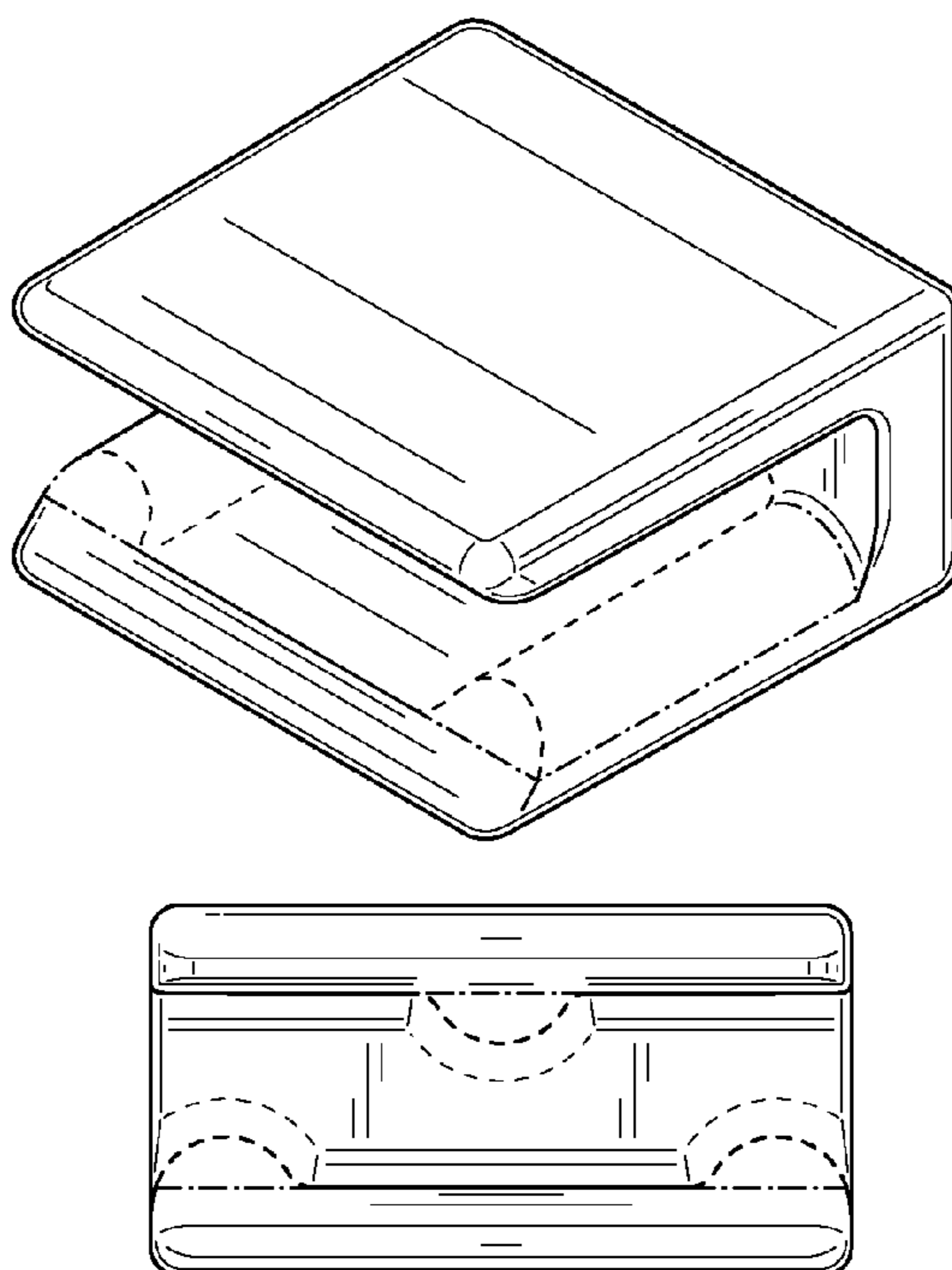
The ornamental design for a puzzle clip, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of the puzzle clip.
FIG. 2 is a bottom view of the puzzle clip.
FIG. 3 is a top view of the puzzle clip.
FIG. 4 is a left side view of the puzzle clip.
FIG. 5 is a right side view of the puzzle clip.
FIG. 6 is a back view of the puzzle clip; and,
FIG. 7 is a front view of the puzzle clip.

The broken lines in the figures depict portions of the puzzle clip that form no part of the claimed design. The dot-dash lines in the figures represent the boundary between claimed and unclaimed portions of the puzzle clip.

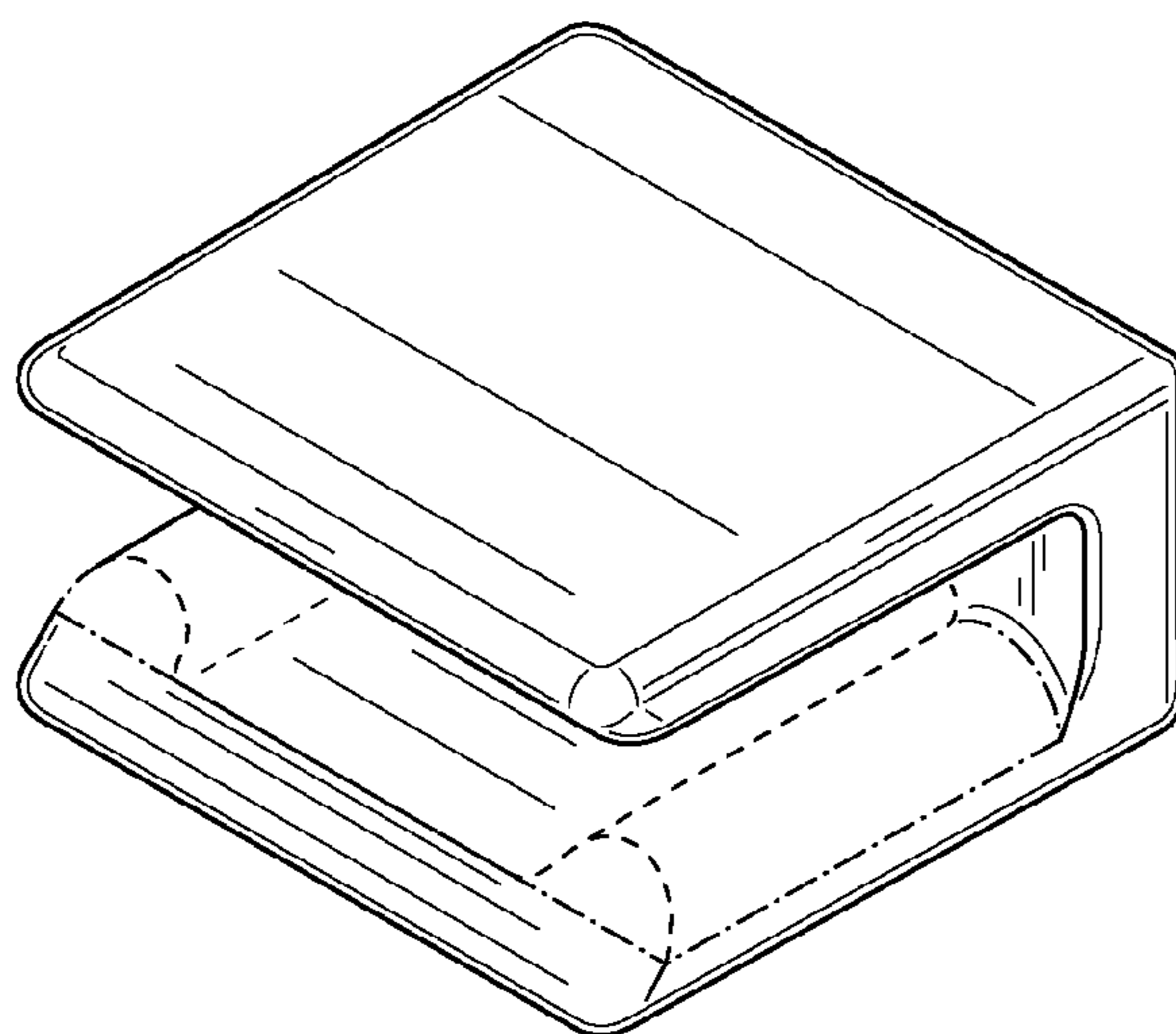

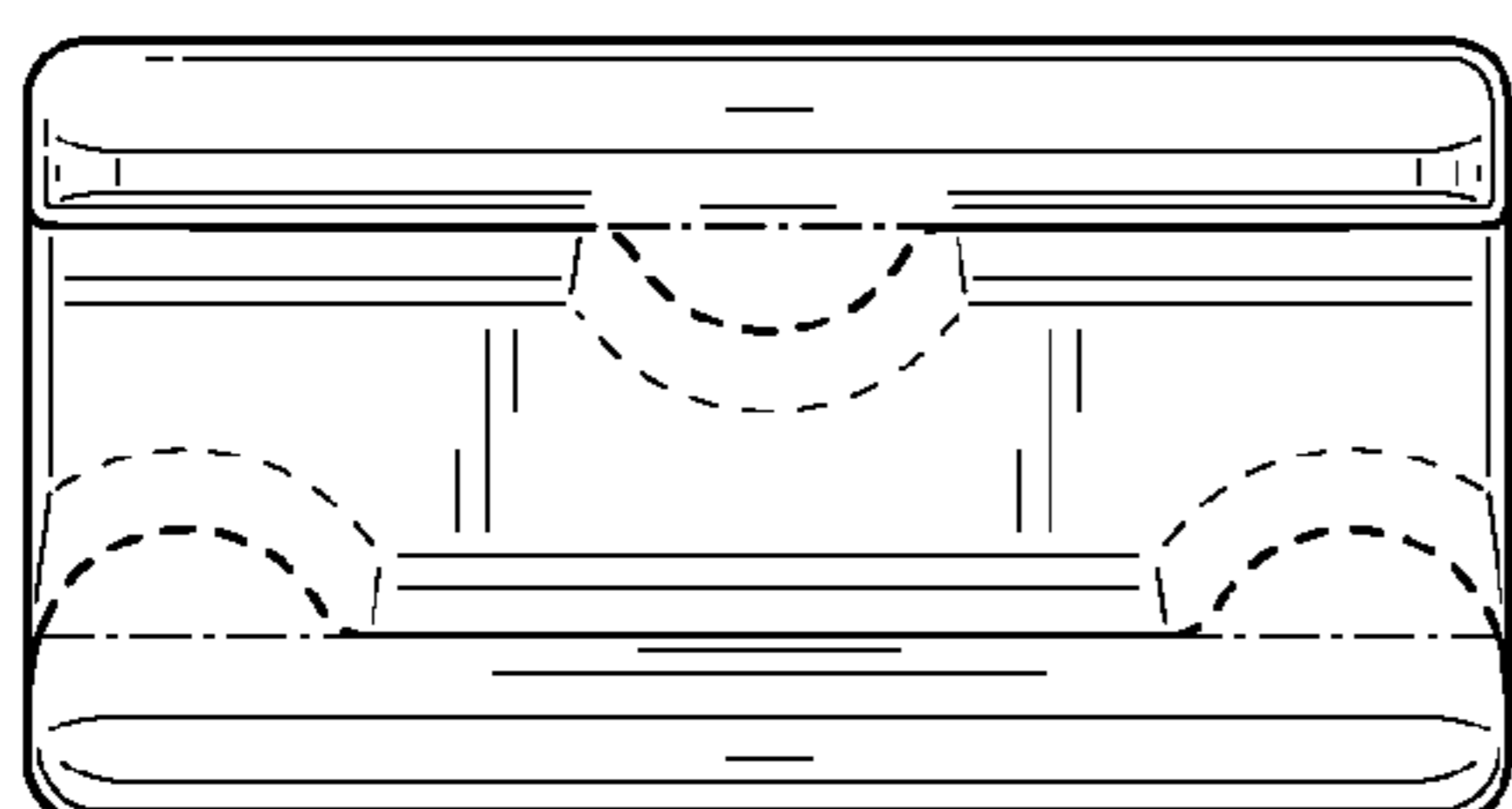

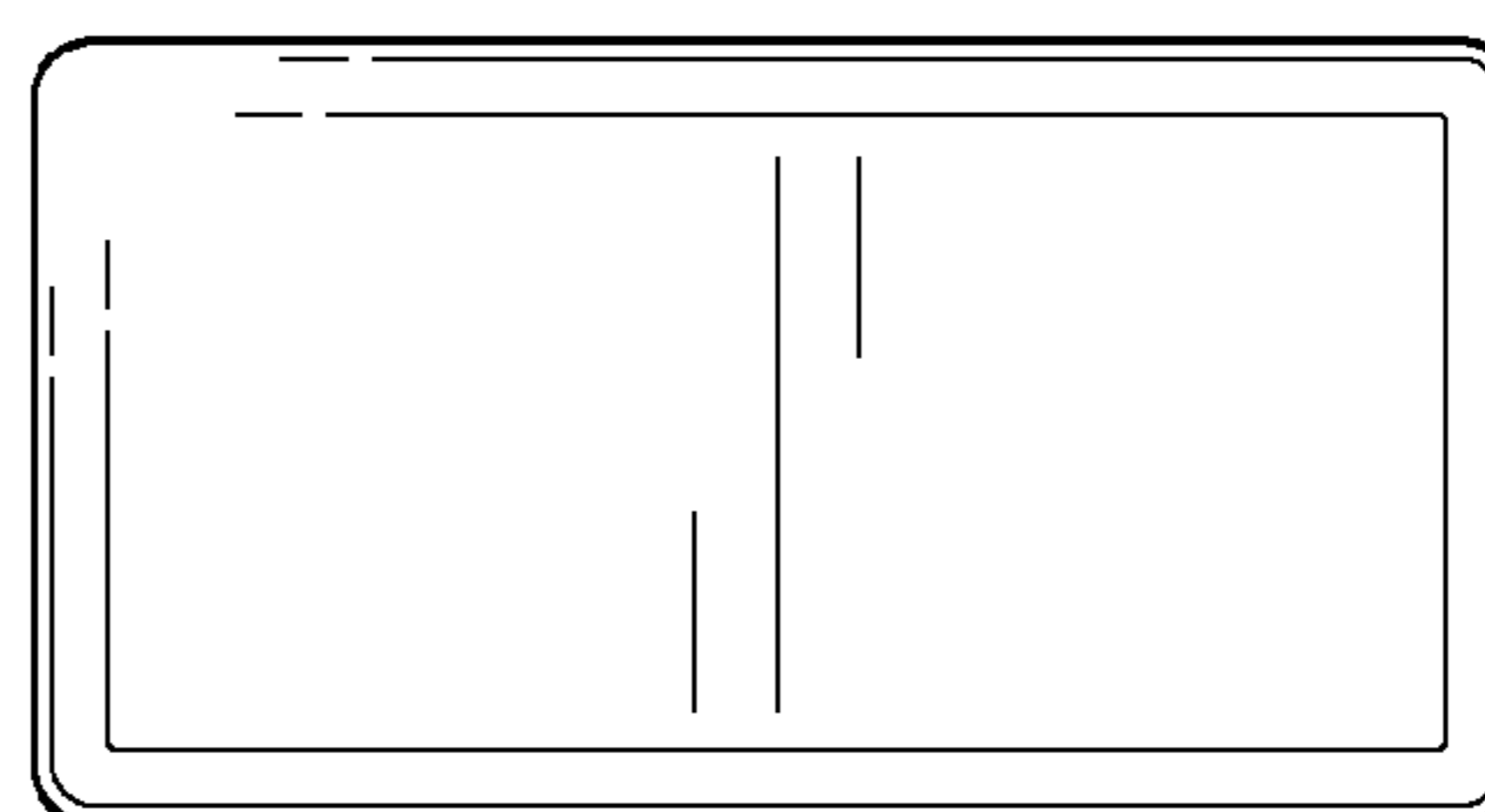

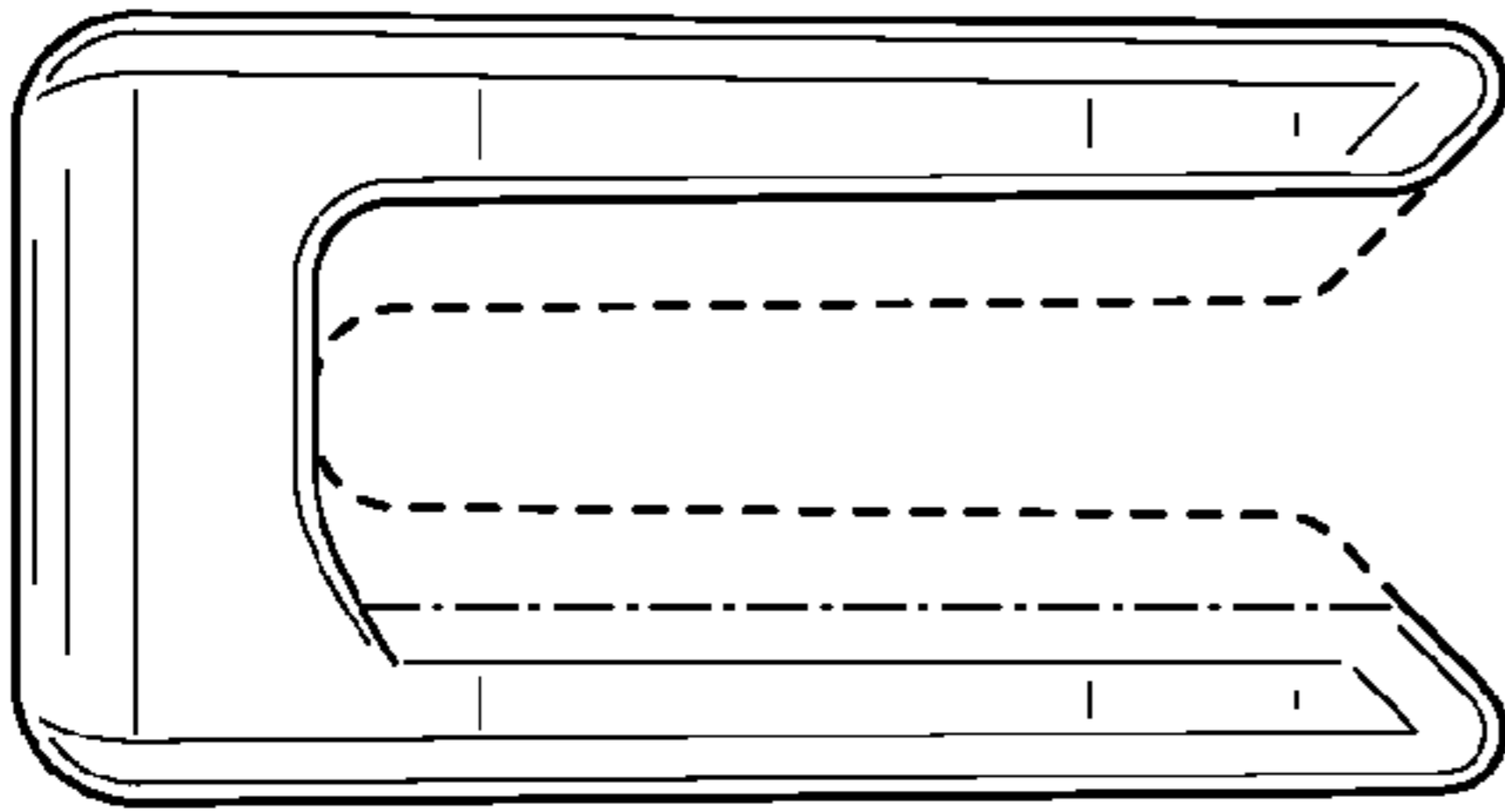

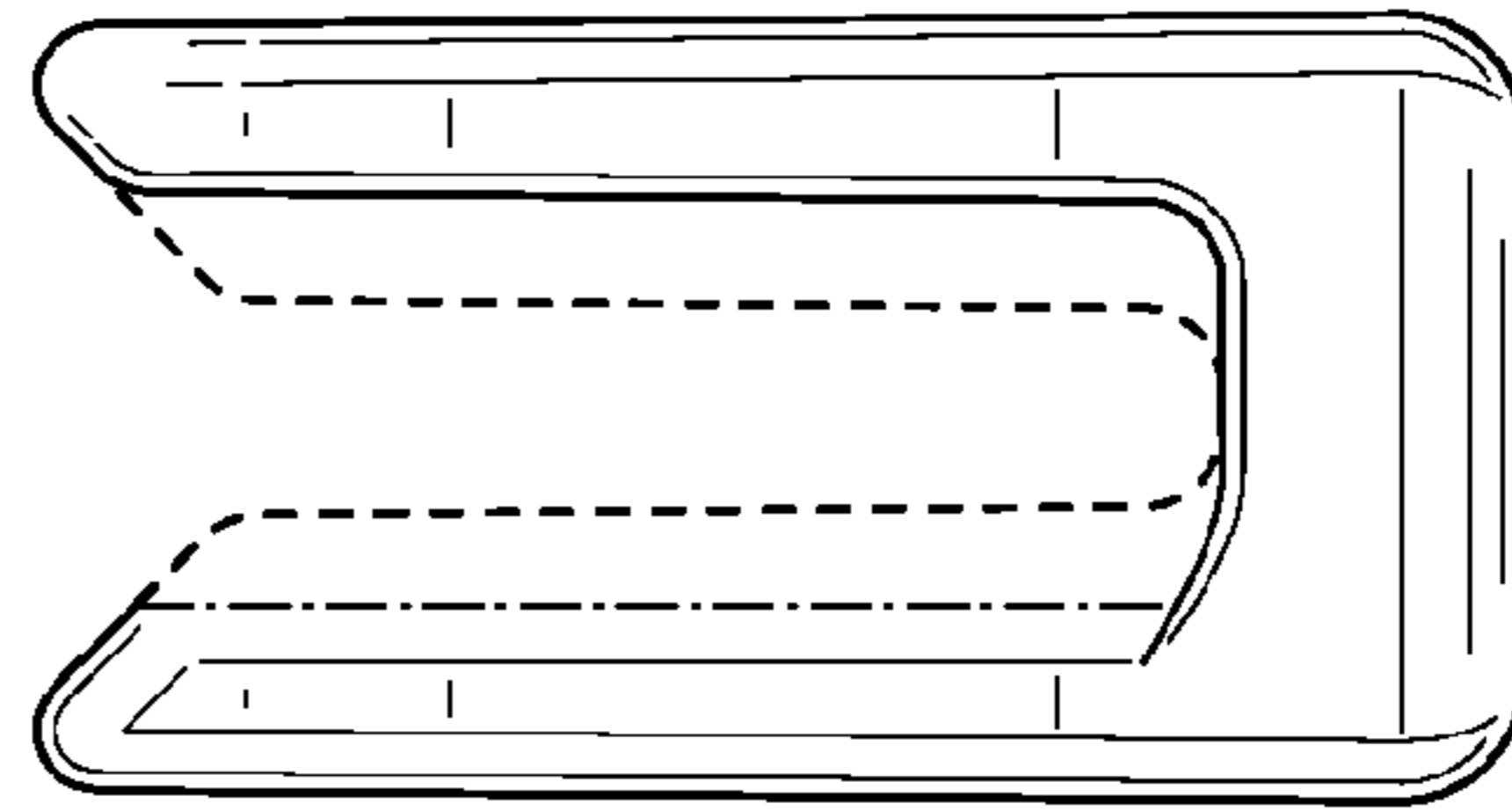

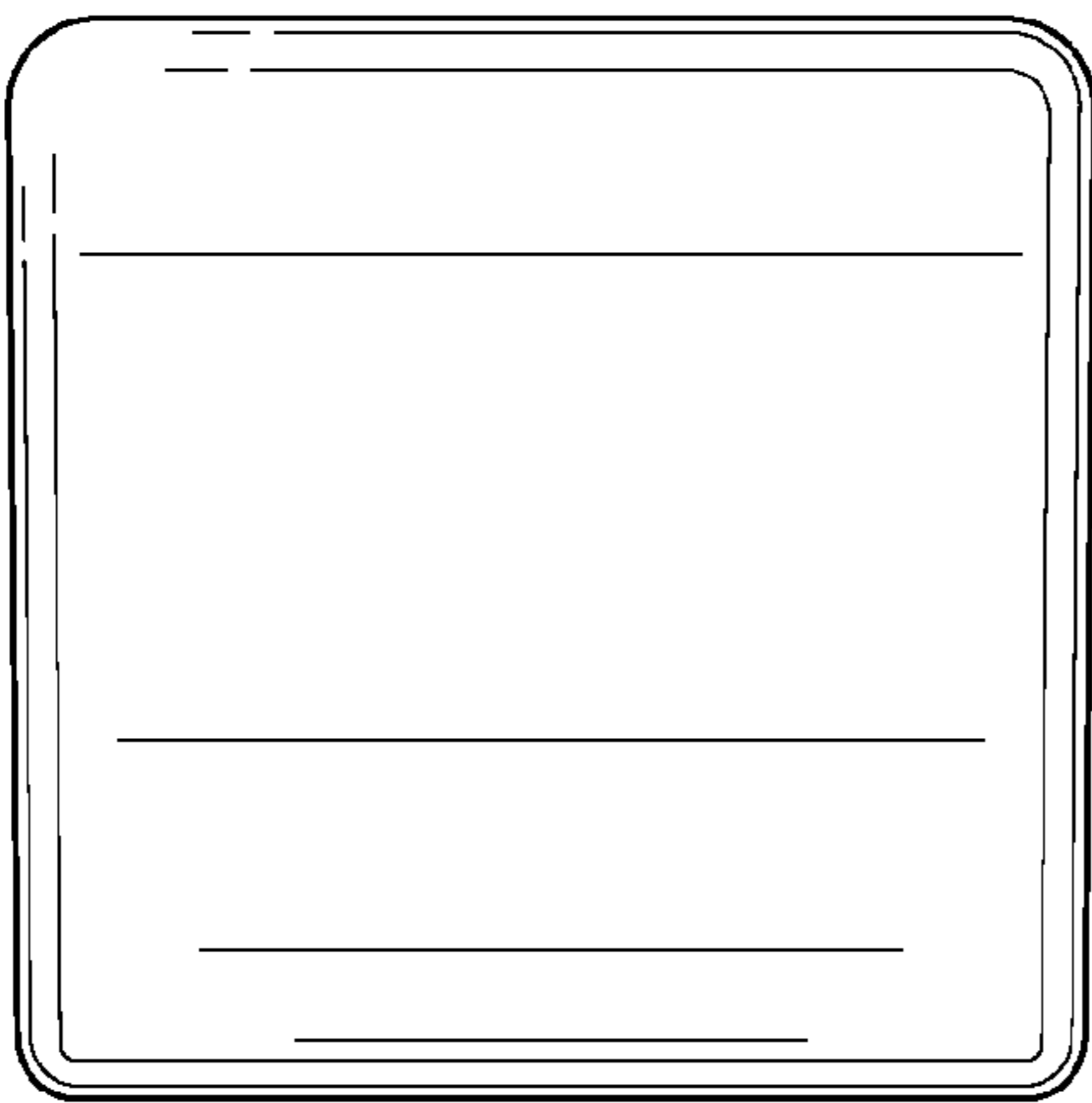

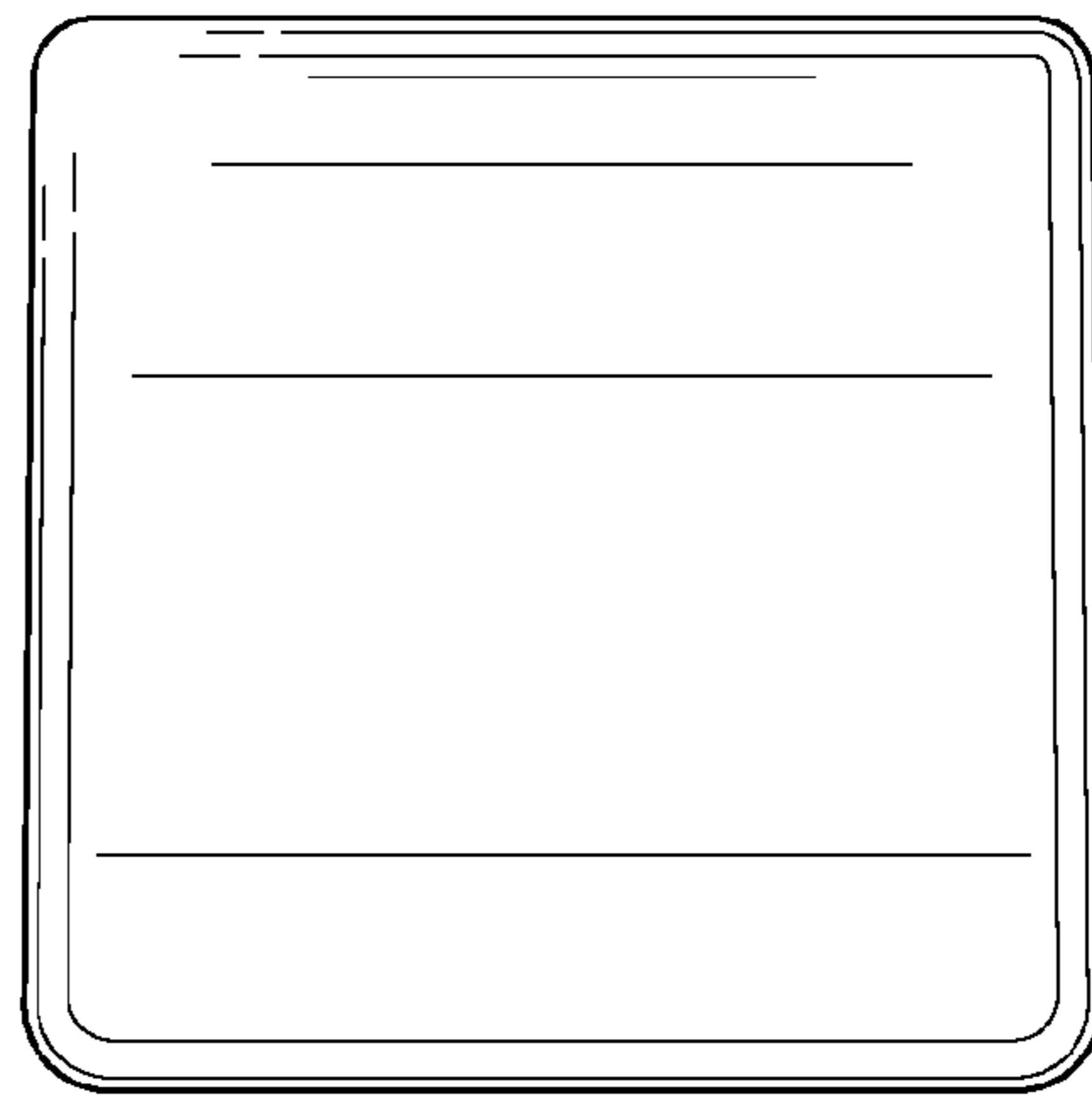
