(57) **CLAIM**

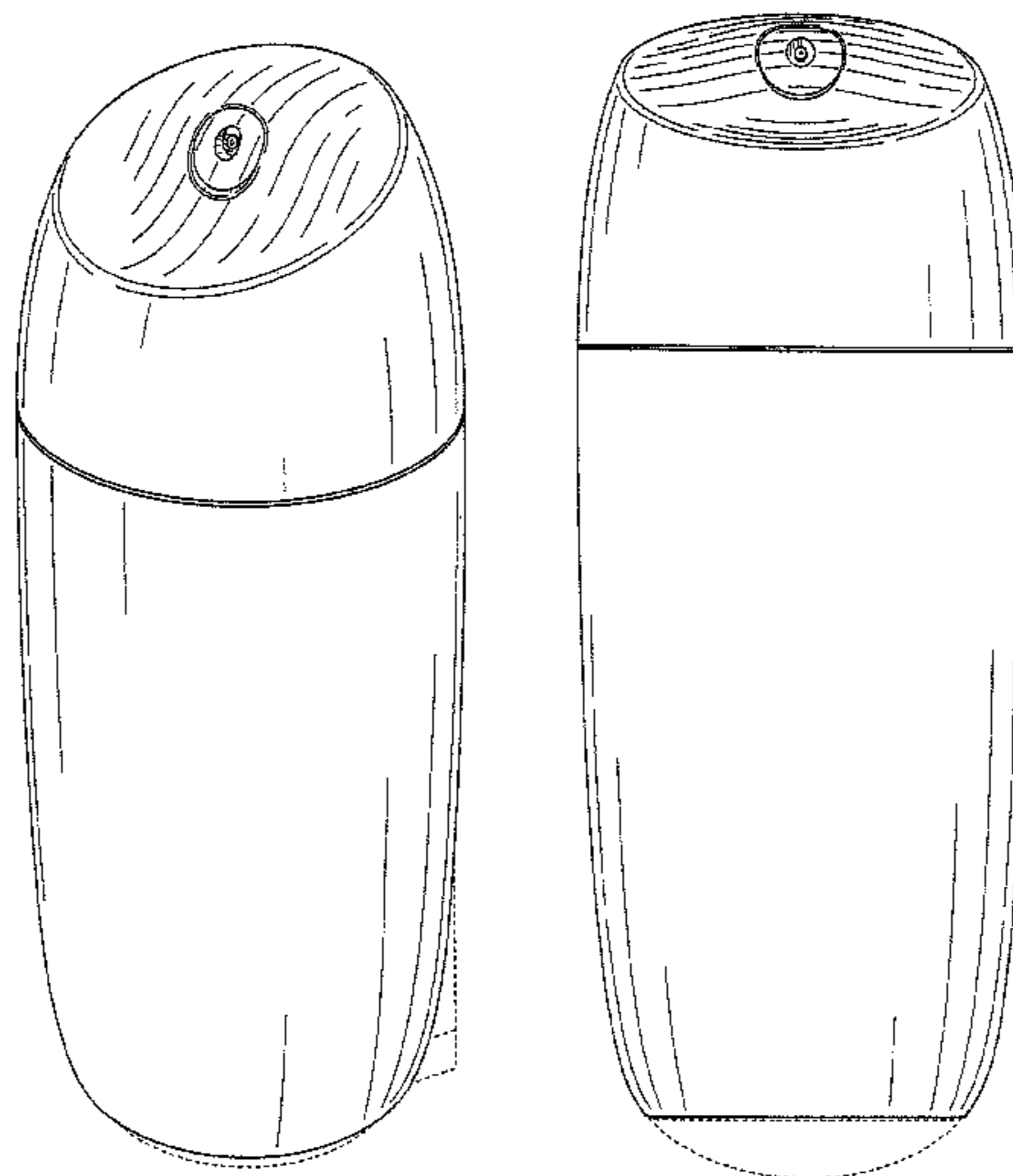
The ornamental design for a dispenser housing, as shown and

DESCRIPTION

FIG. 1 is an isometric view showing our new design for a
dispenser housing from the top, front and left side;
FIG. 2 is a rear elevational view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a right side elevational view thereof;
FIG. 5 is a left side elevational view thereof;
FIG. 6 is a top plan view thereof; and,

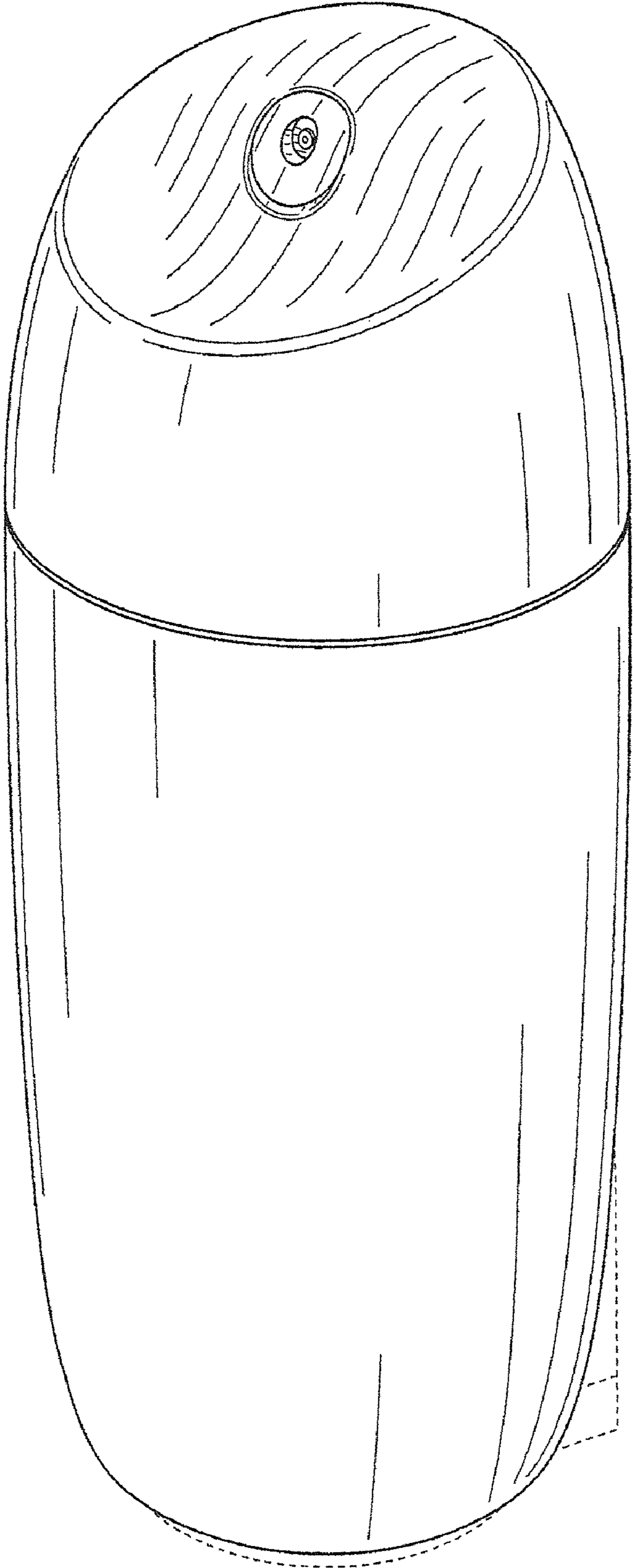

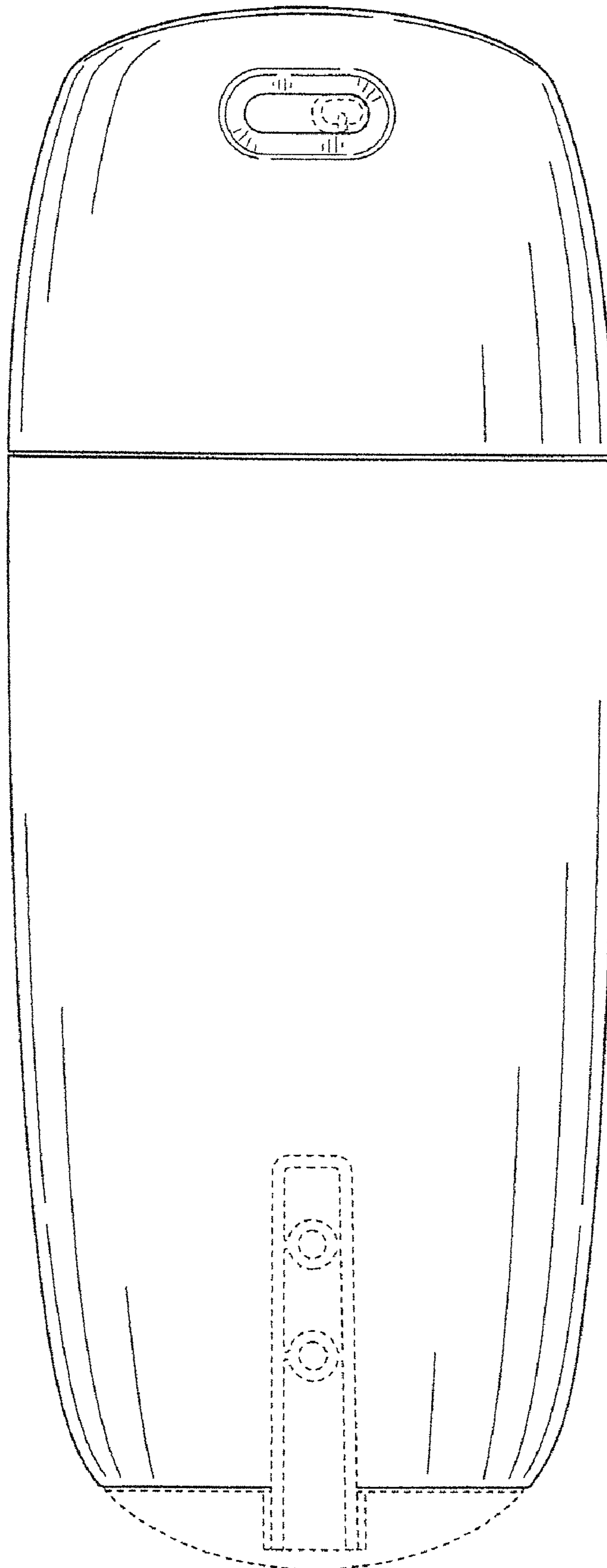

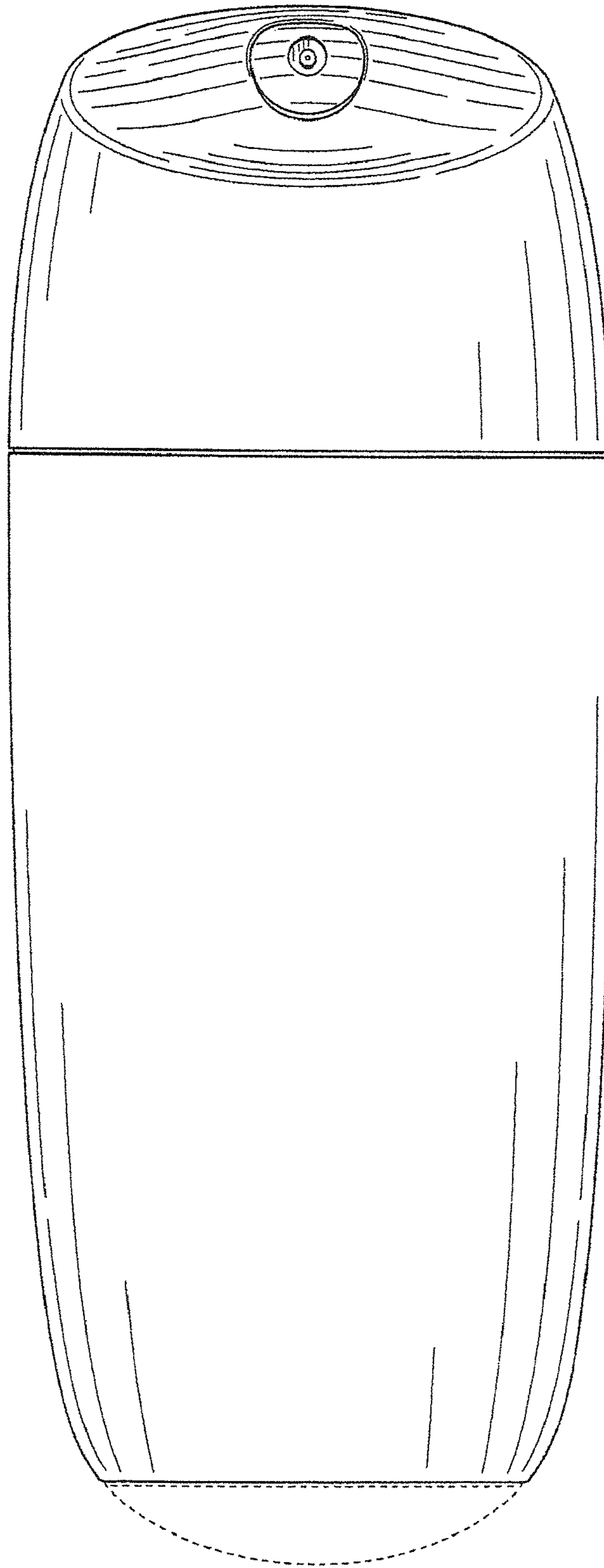

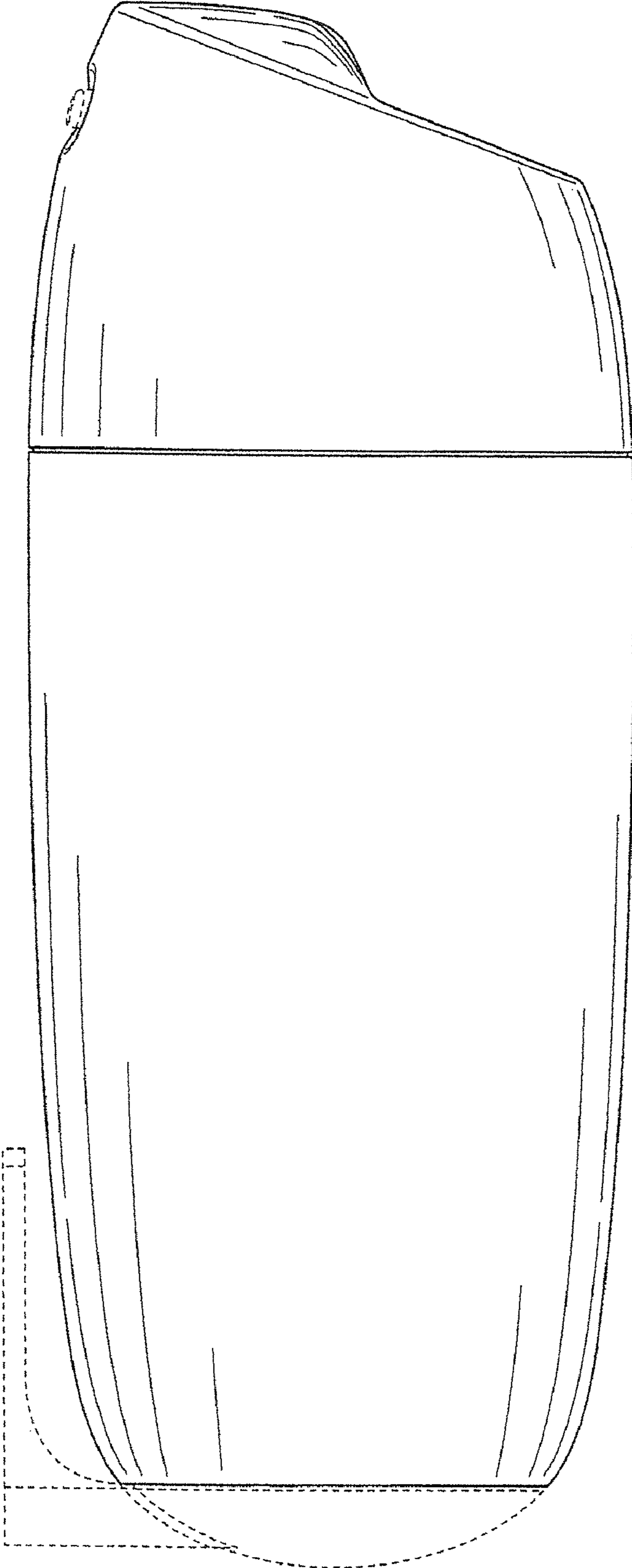

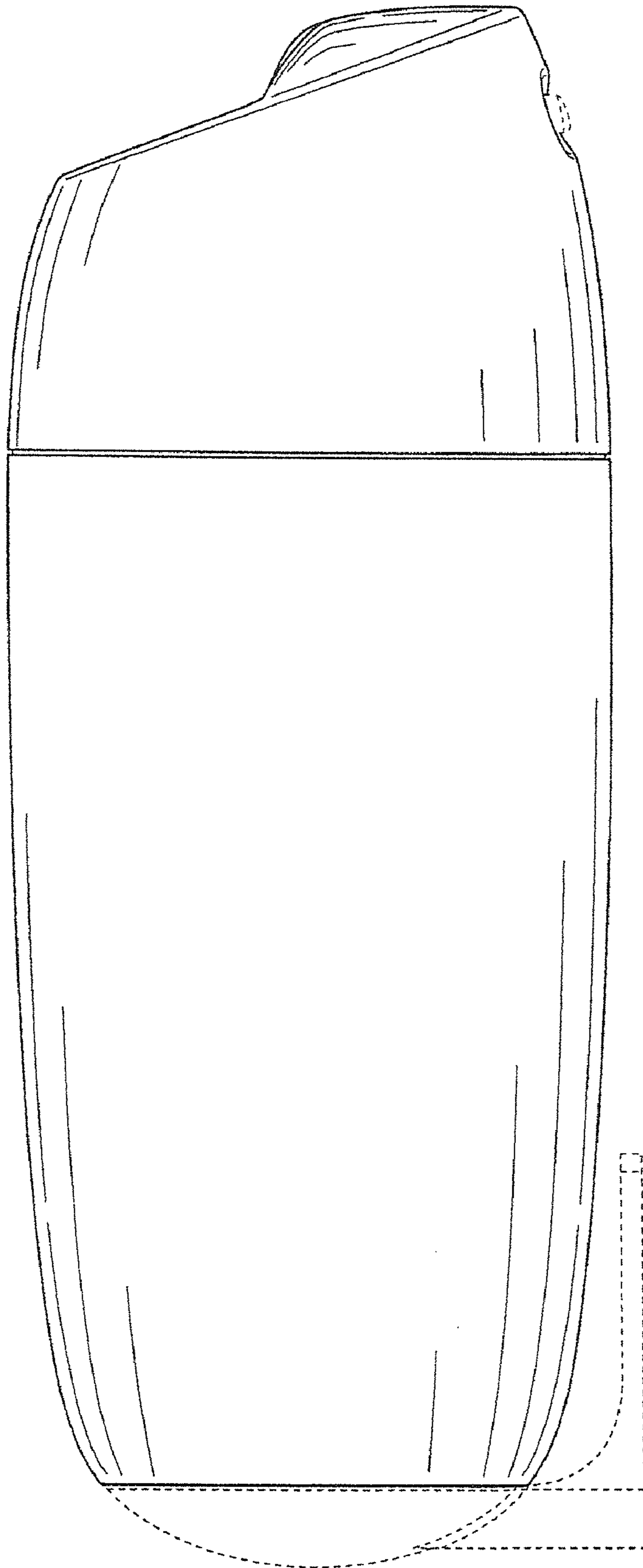

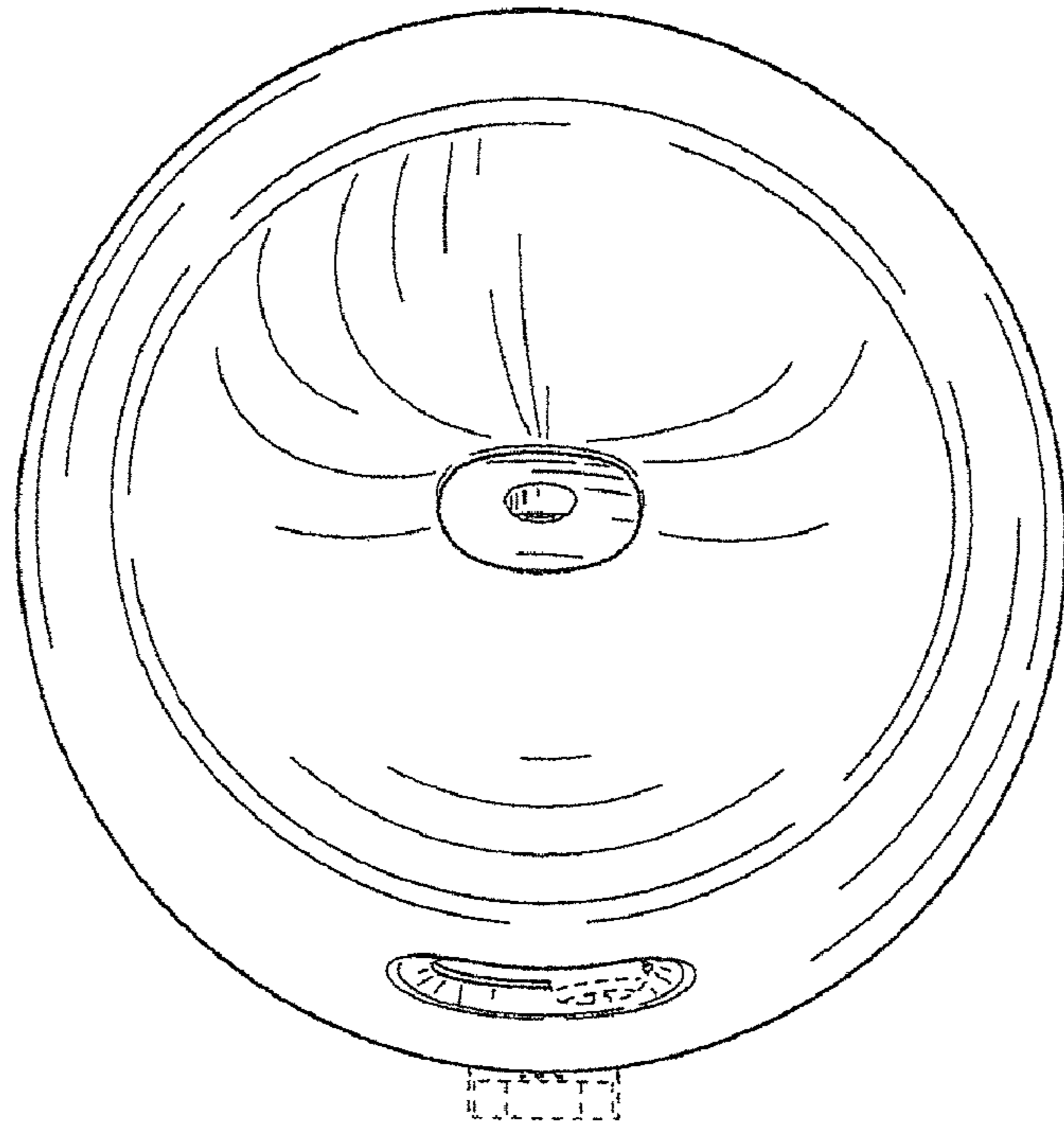

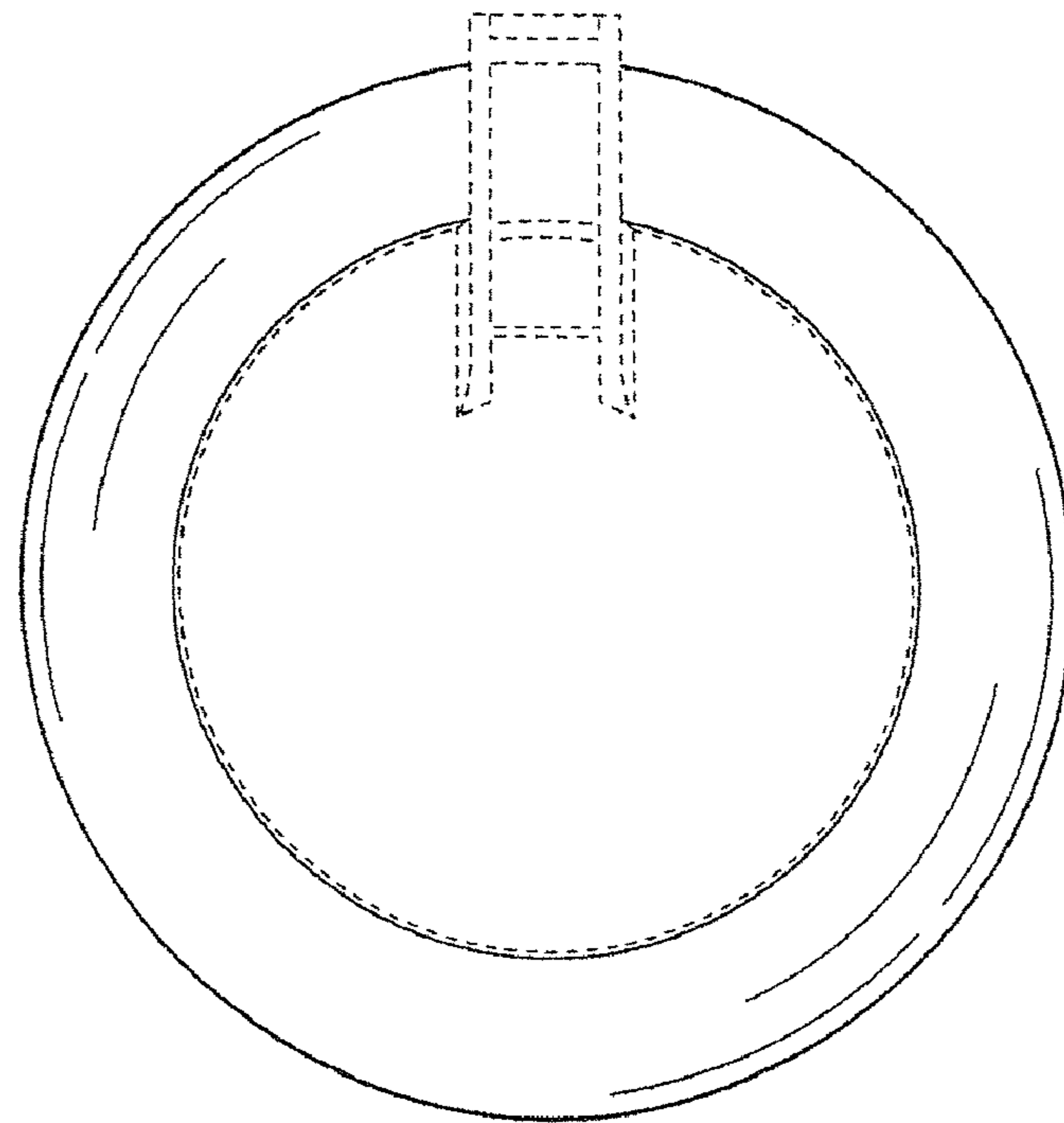
