(57) **CLAIM**

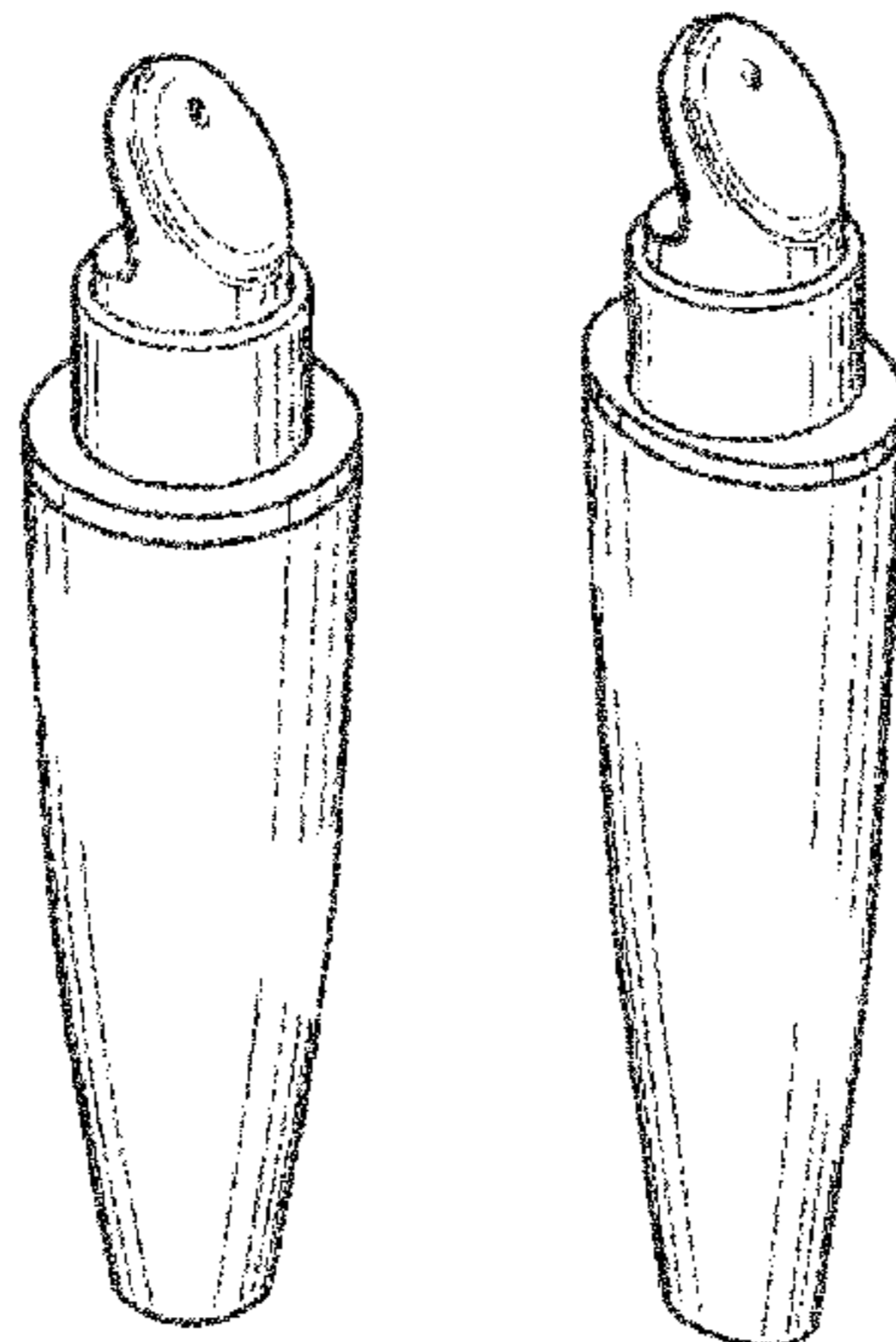
We claim the ornamental design for an applicator, substantially as shown and described.

DESCRIPTION

FIG. 1 is a top, front and left side perspective view of a first embodiment of my new design for an applicator;
FIG. 2 is a top, rear and right side perspective view of the applicator shown in FIG. 1;
FIG. 3 is a front elevation view of the applicator shown in FIG. 1;
FIG. 4 is a rear elevation view of the applicator shown in FIG. 1;
FIG. 5 is a right side elevation view of the applicator shown in FIG. 1;
FIG. 6 is a left side elevation view of the applicator shown in FIG. 1;
FIG. 7 is a top plan view of the applicator shown in FIG. 1;

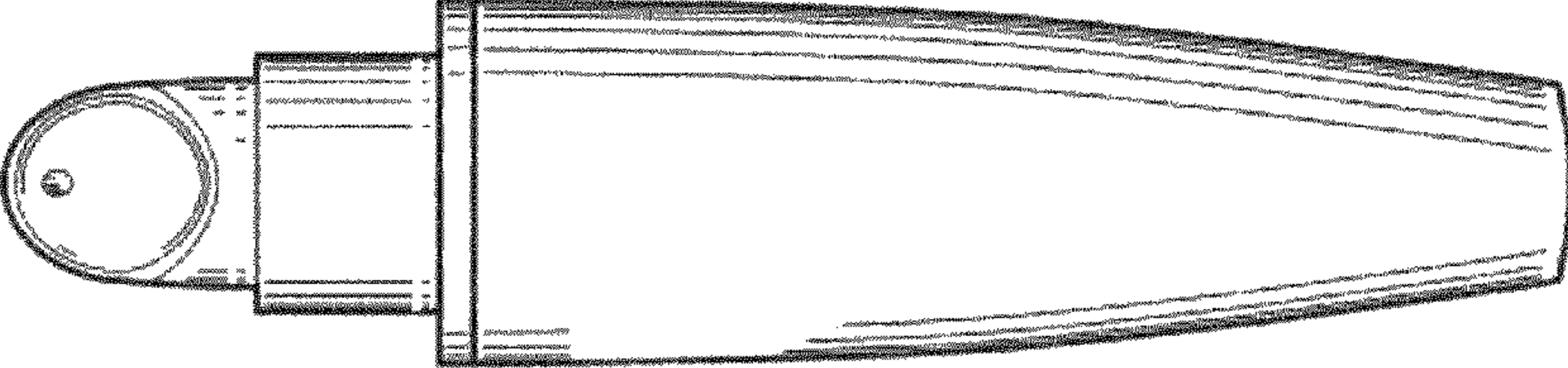

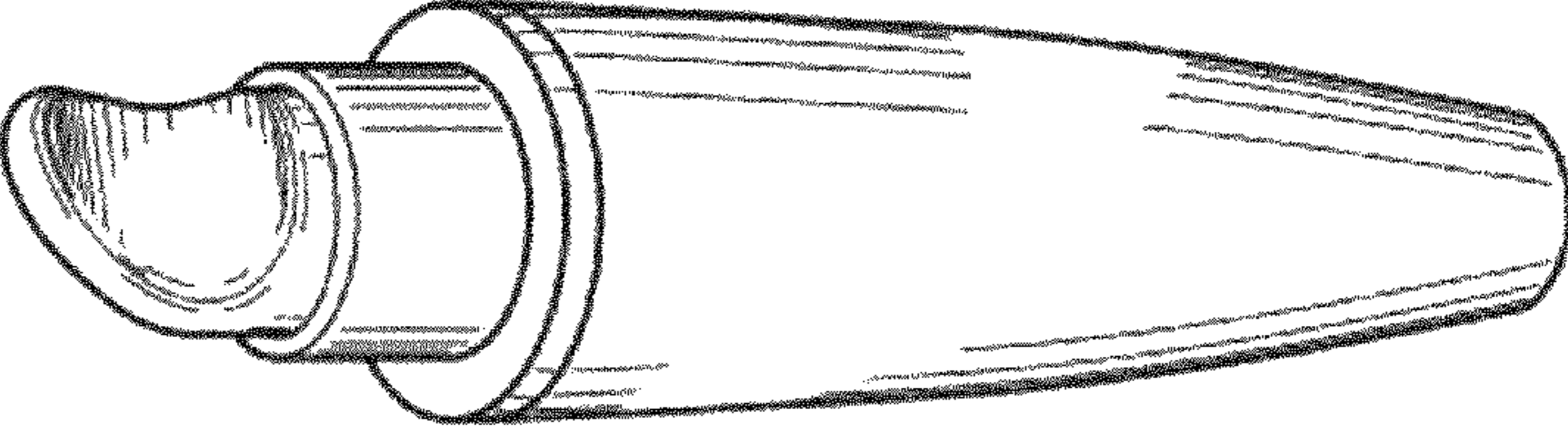

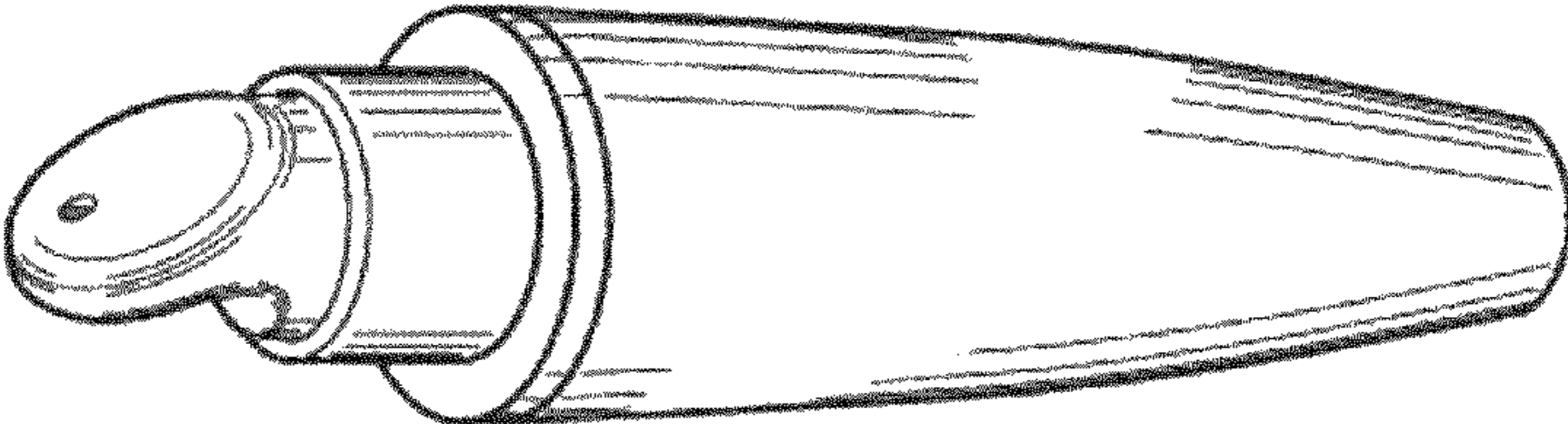

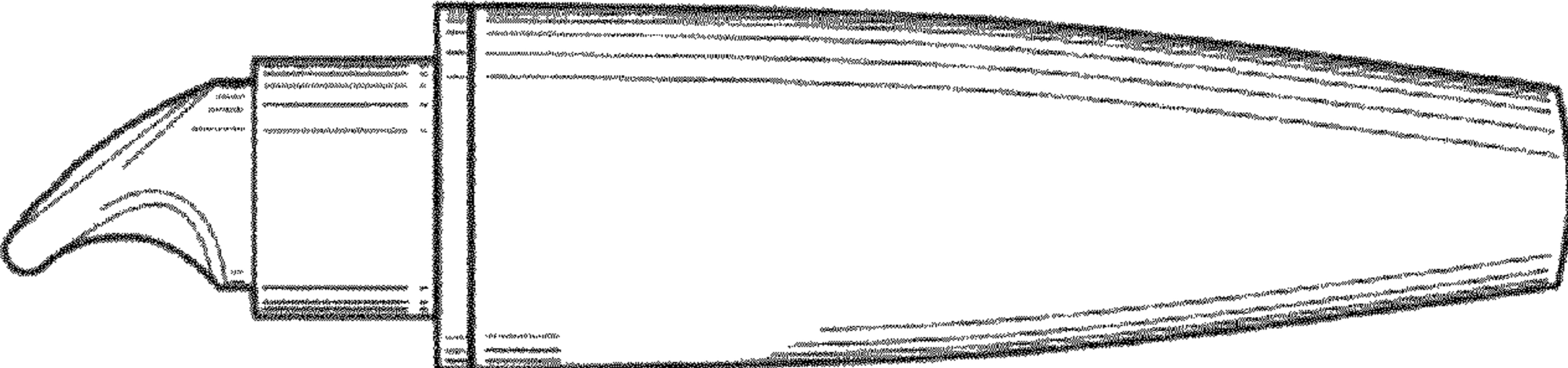

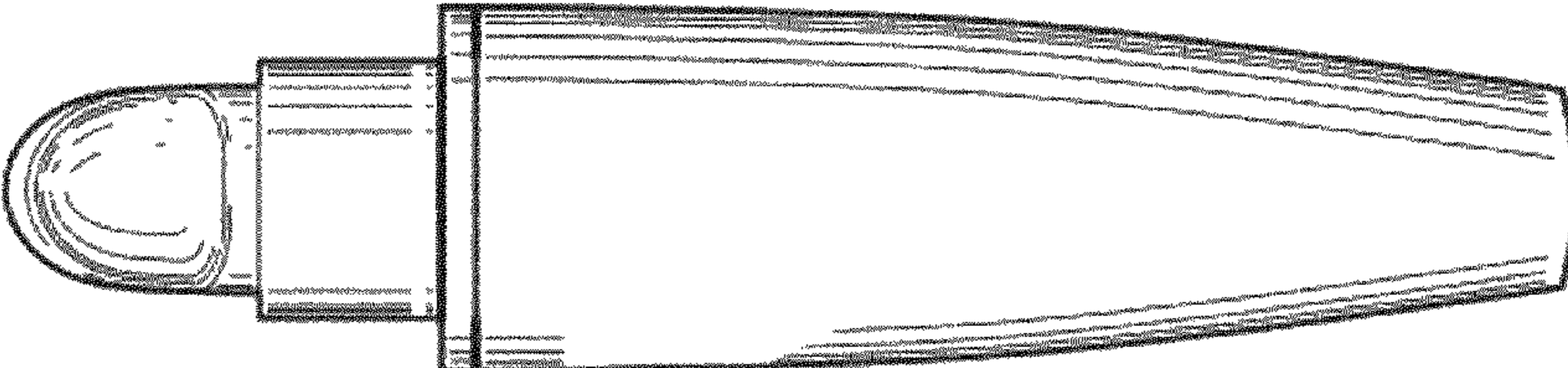

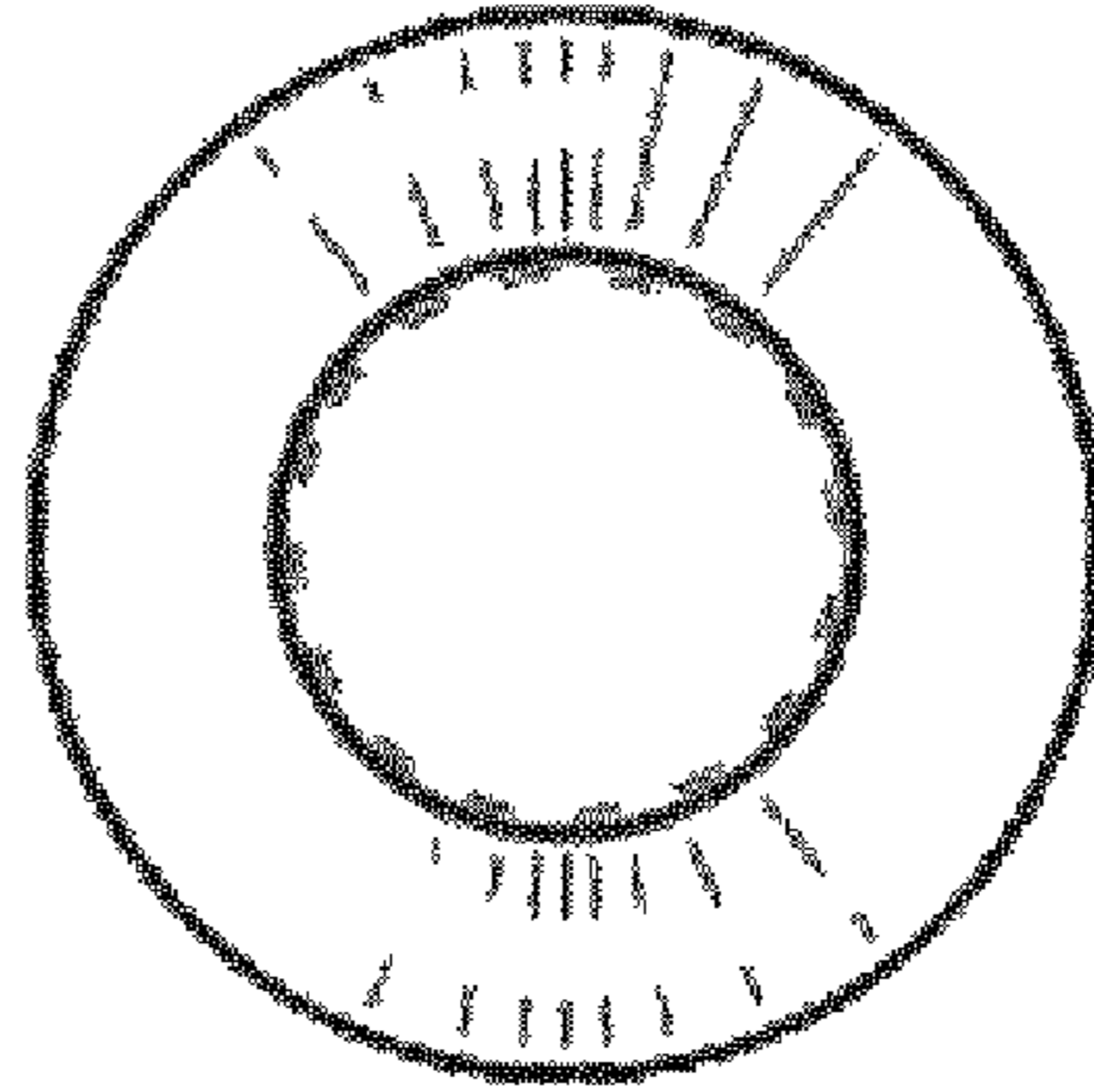

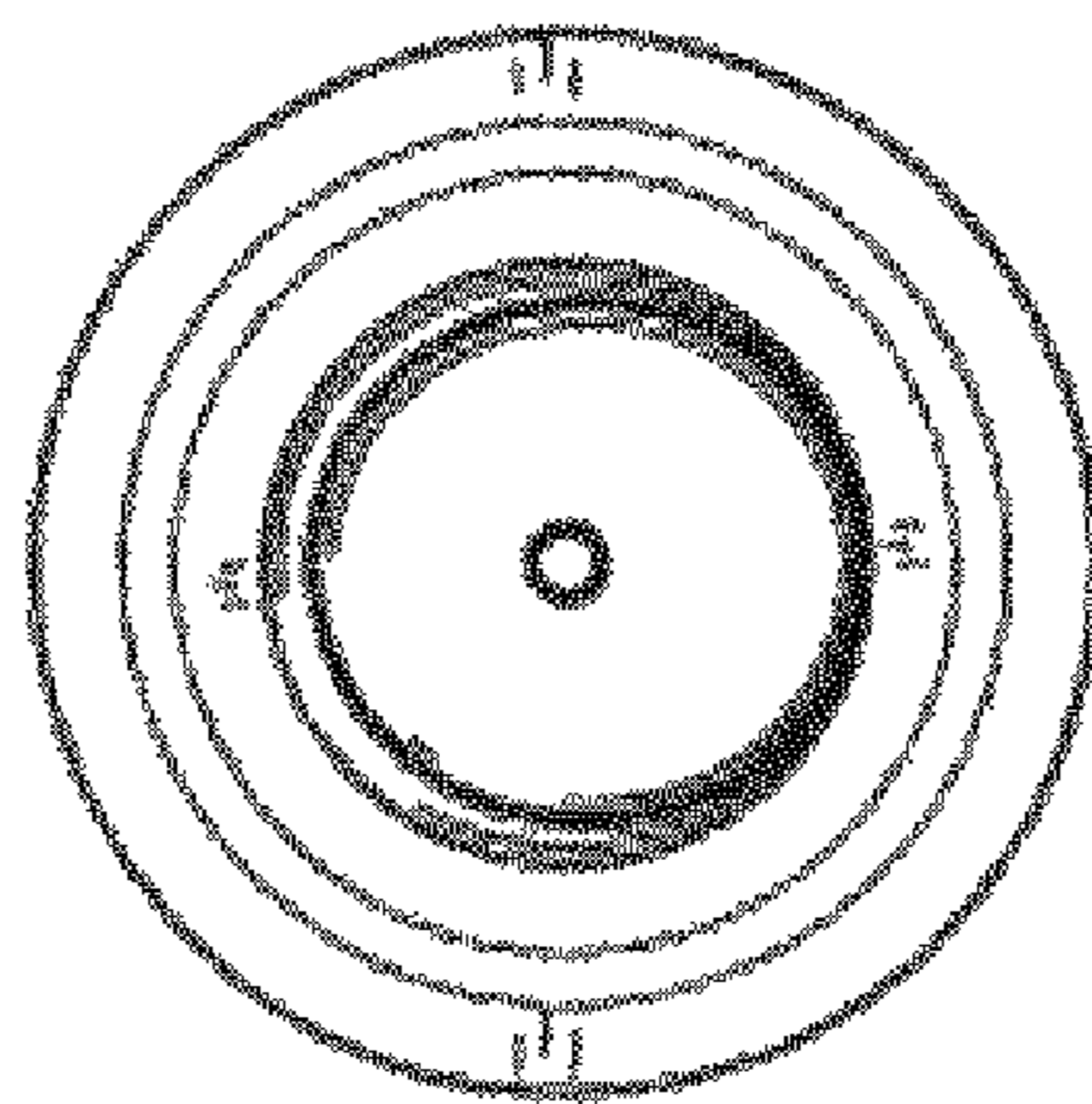

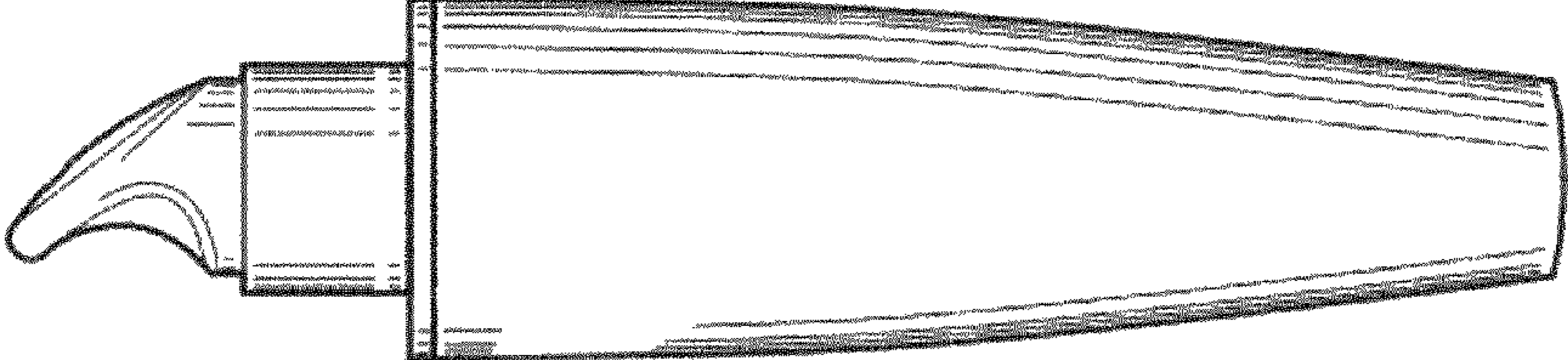

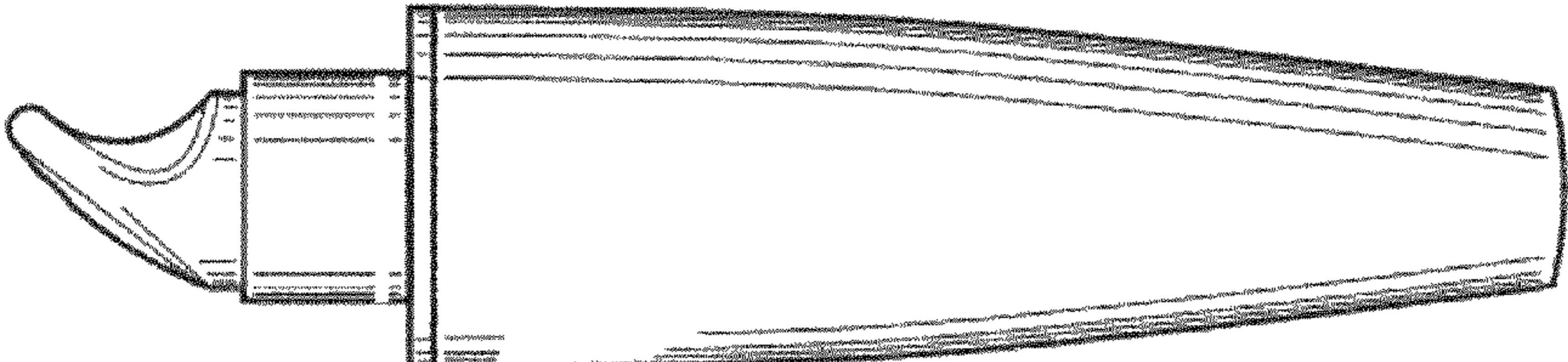

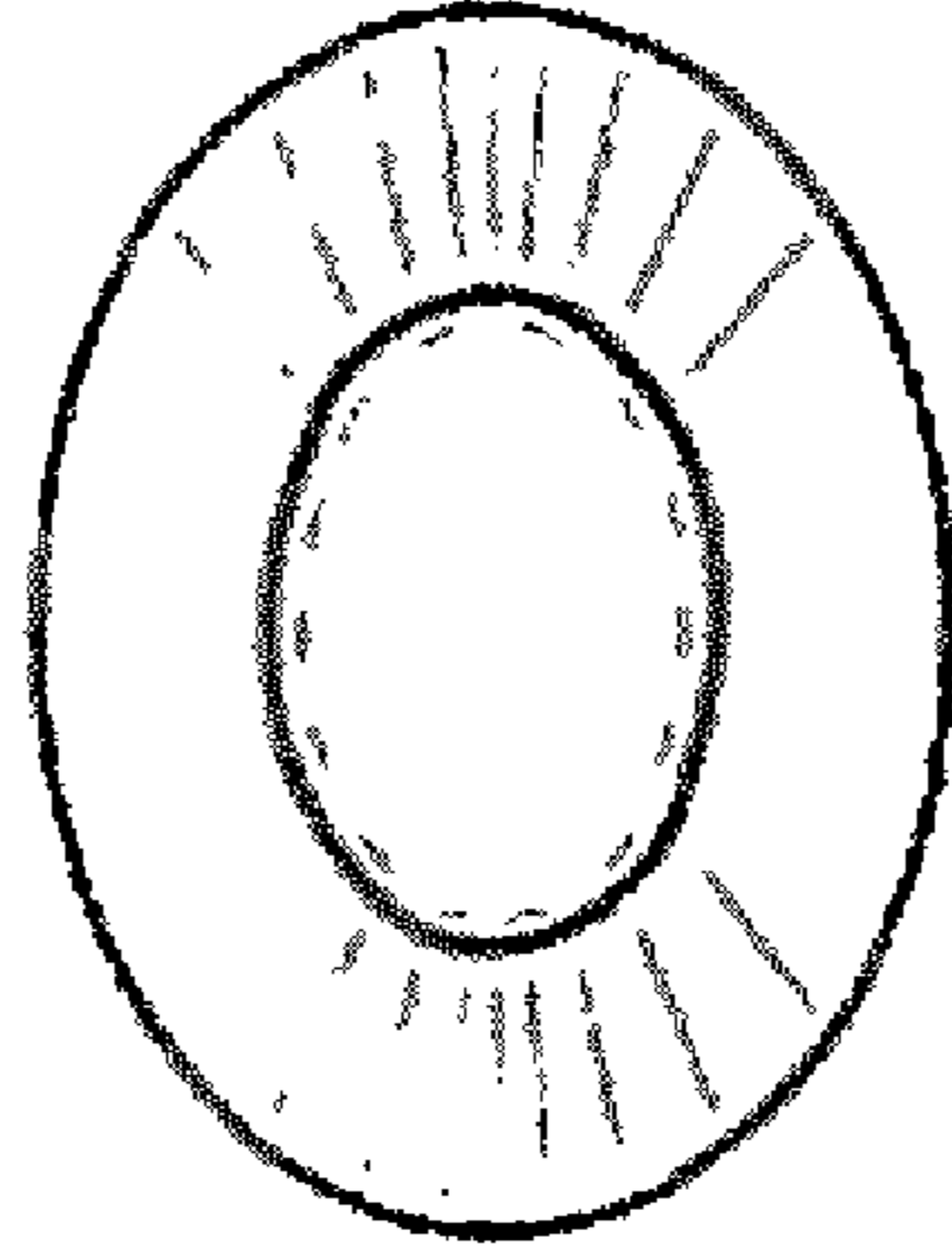
