The ornamental design for a wheel or wheel cover, as shown and described.

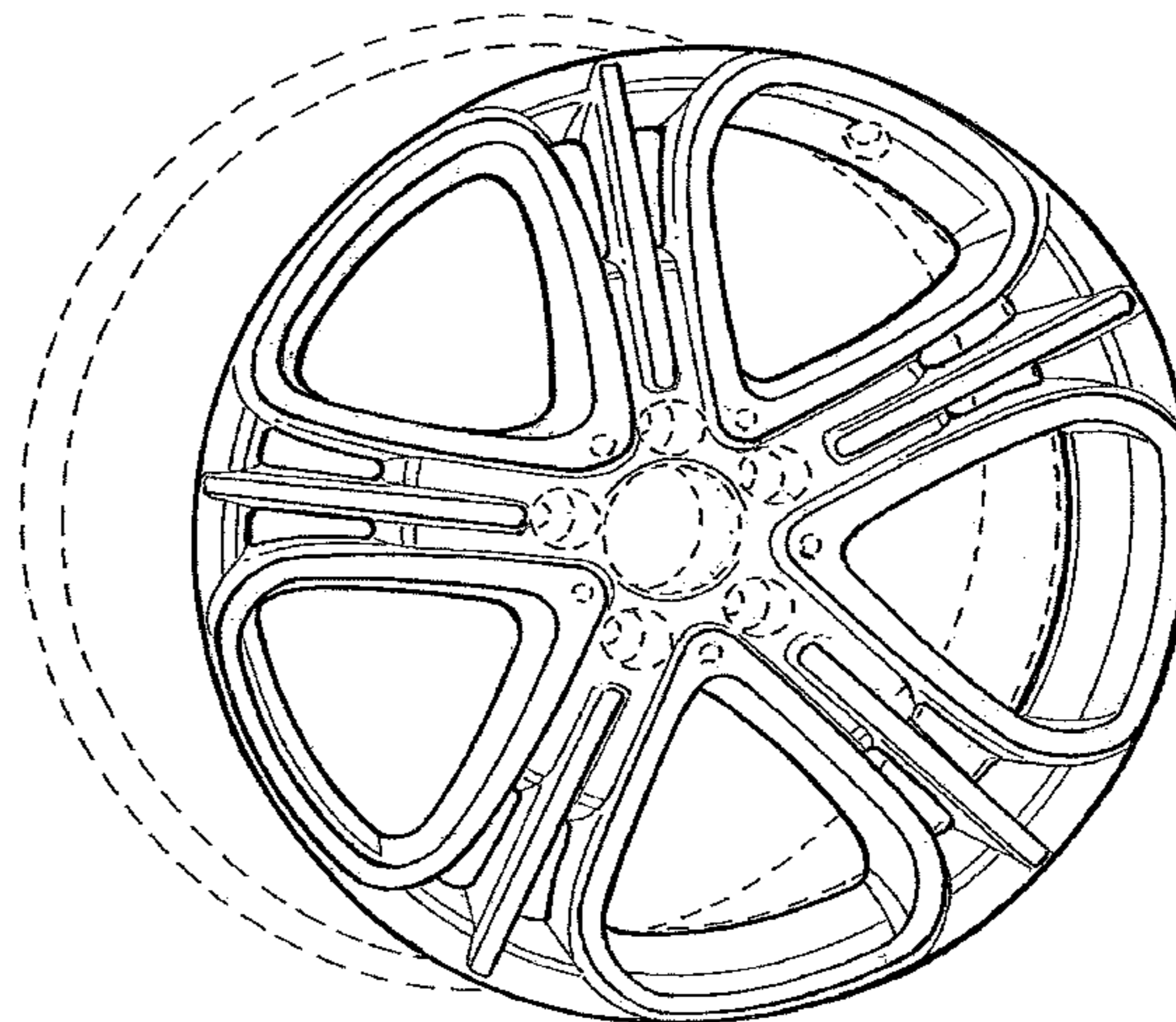
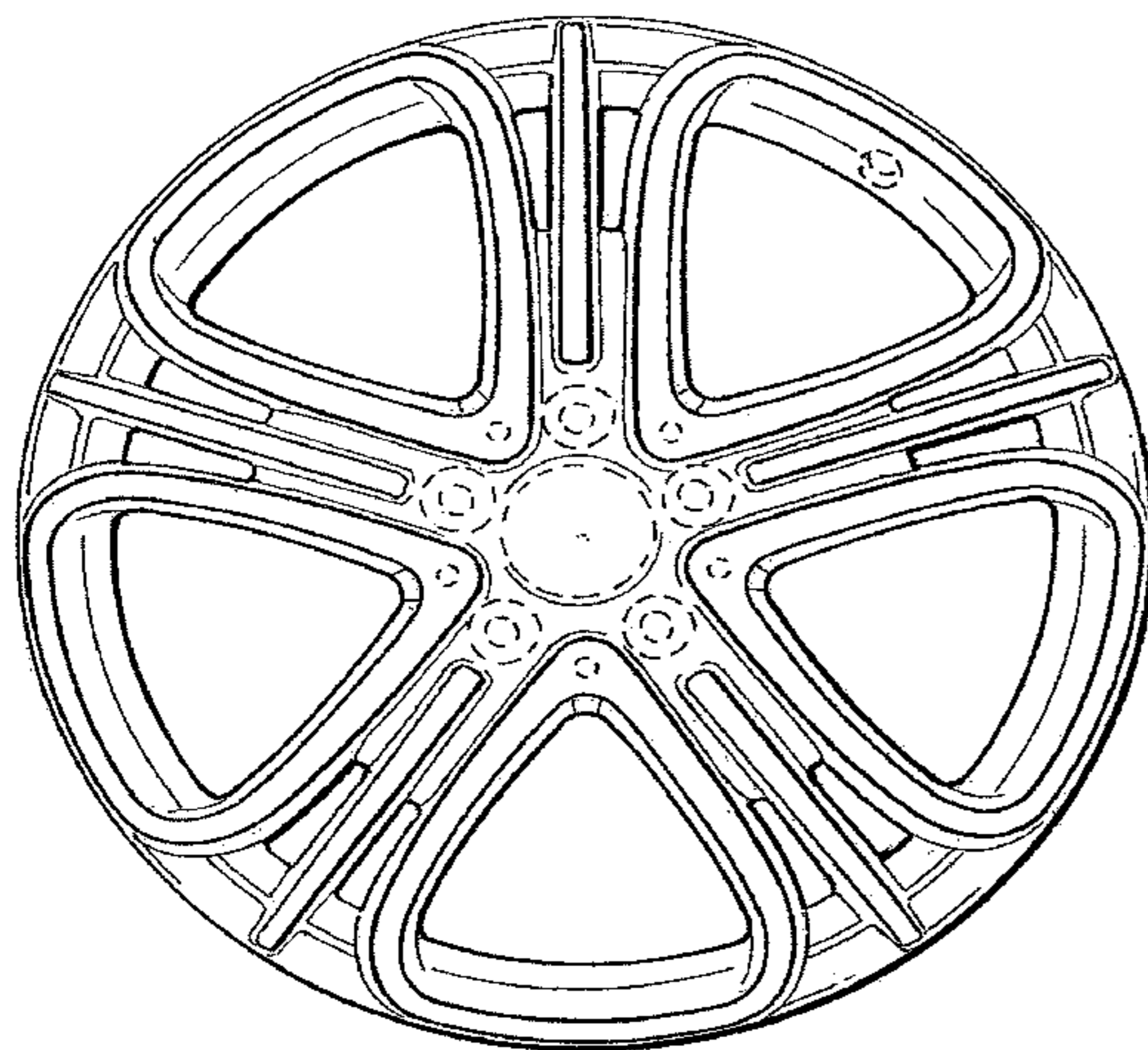
**DESCRIPTION**

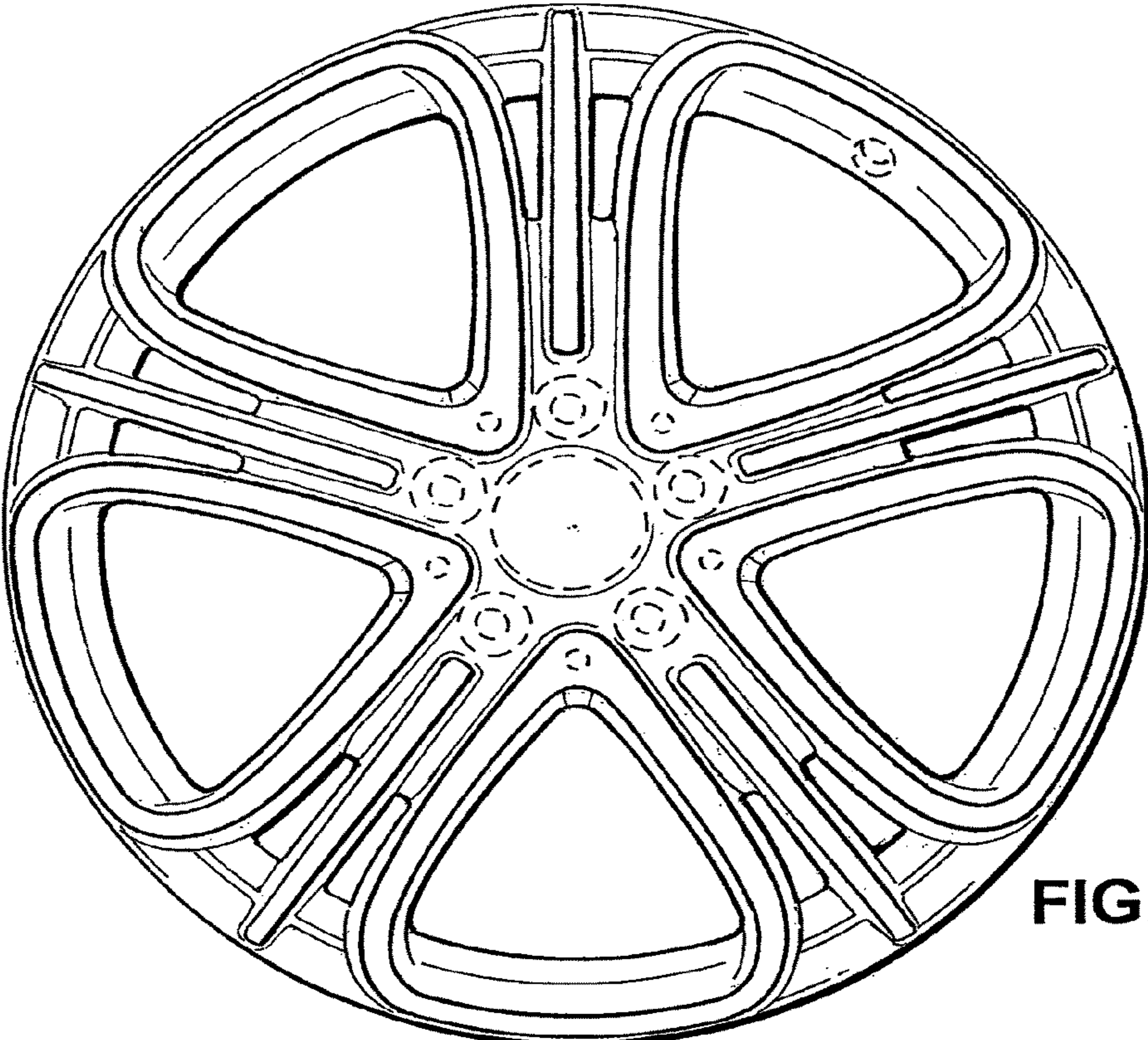

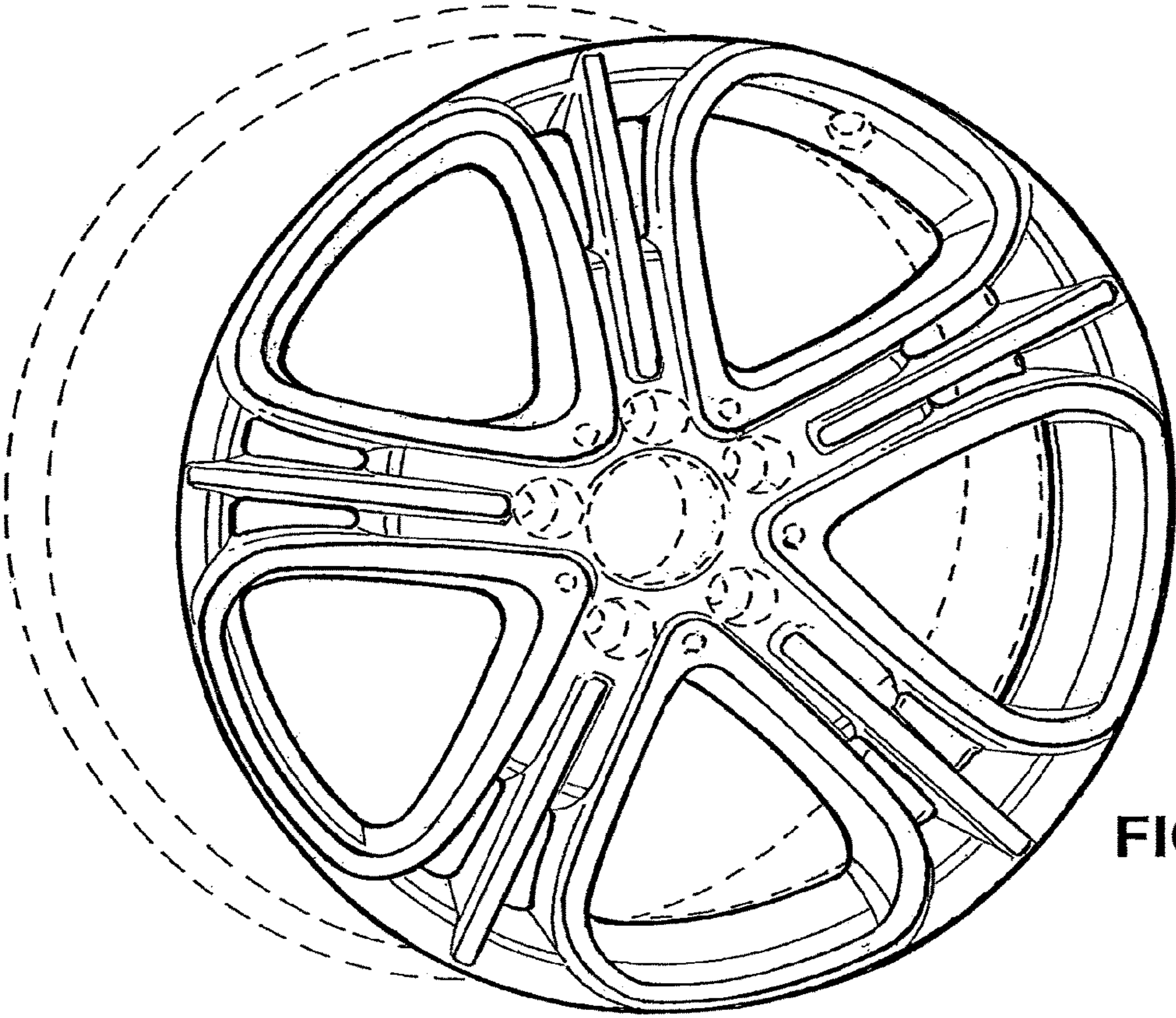
