(57) **CLAIM**

The ornamental design for a vehicle bump guard, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the vehicle bump guard in use on a vehicle, thereby causing a design element to be shown bent instead of straight as in the other Figures.

FIG. 2 is a right side elevation view of the vehicle bump guard of FIG. 1;

FIG. 3 is a left side elevation view of the vehicle bump guard of FIG. 1;

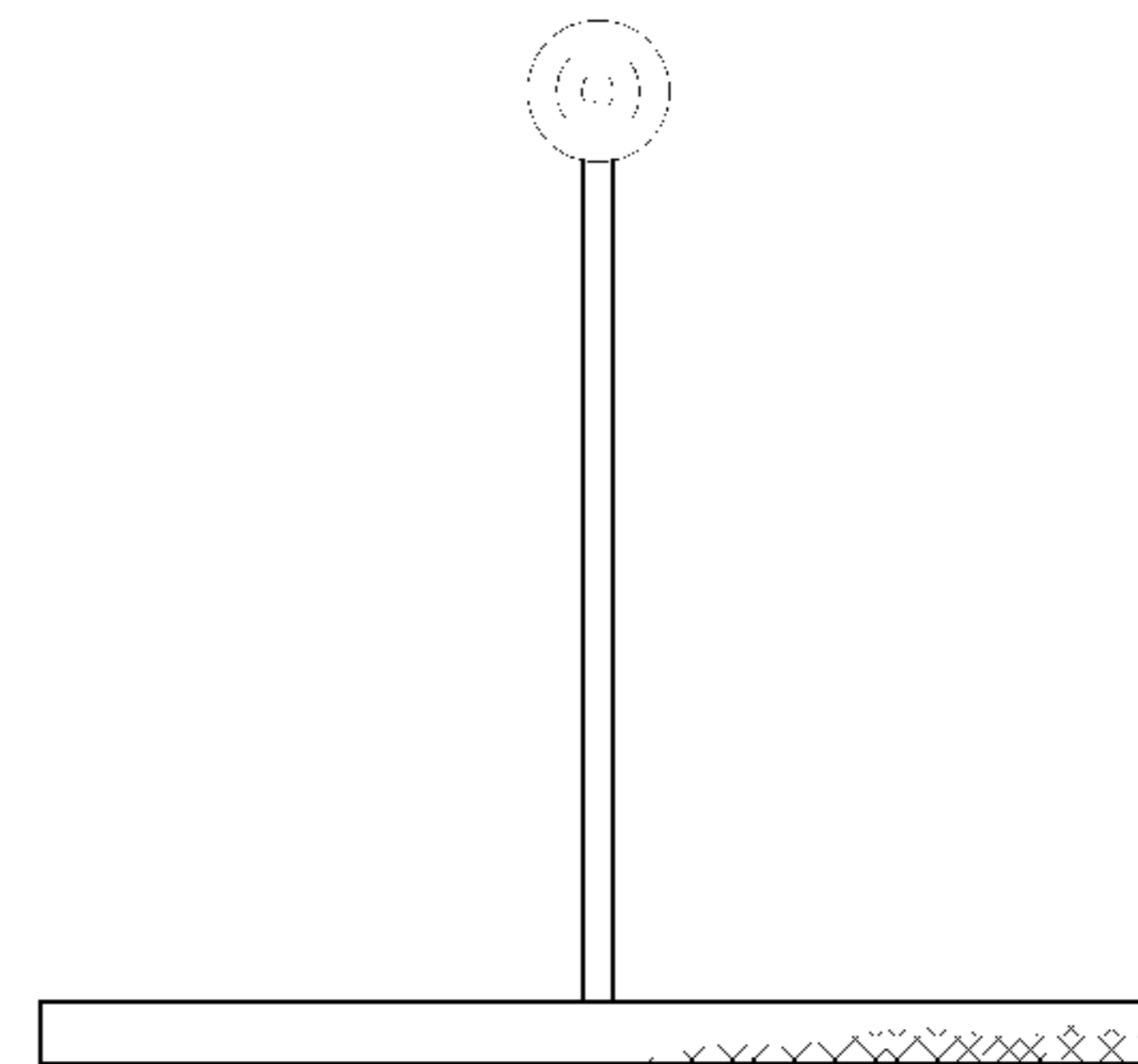
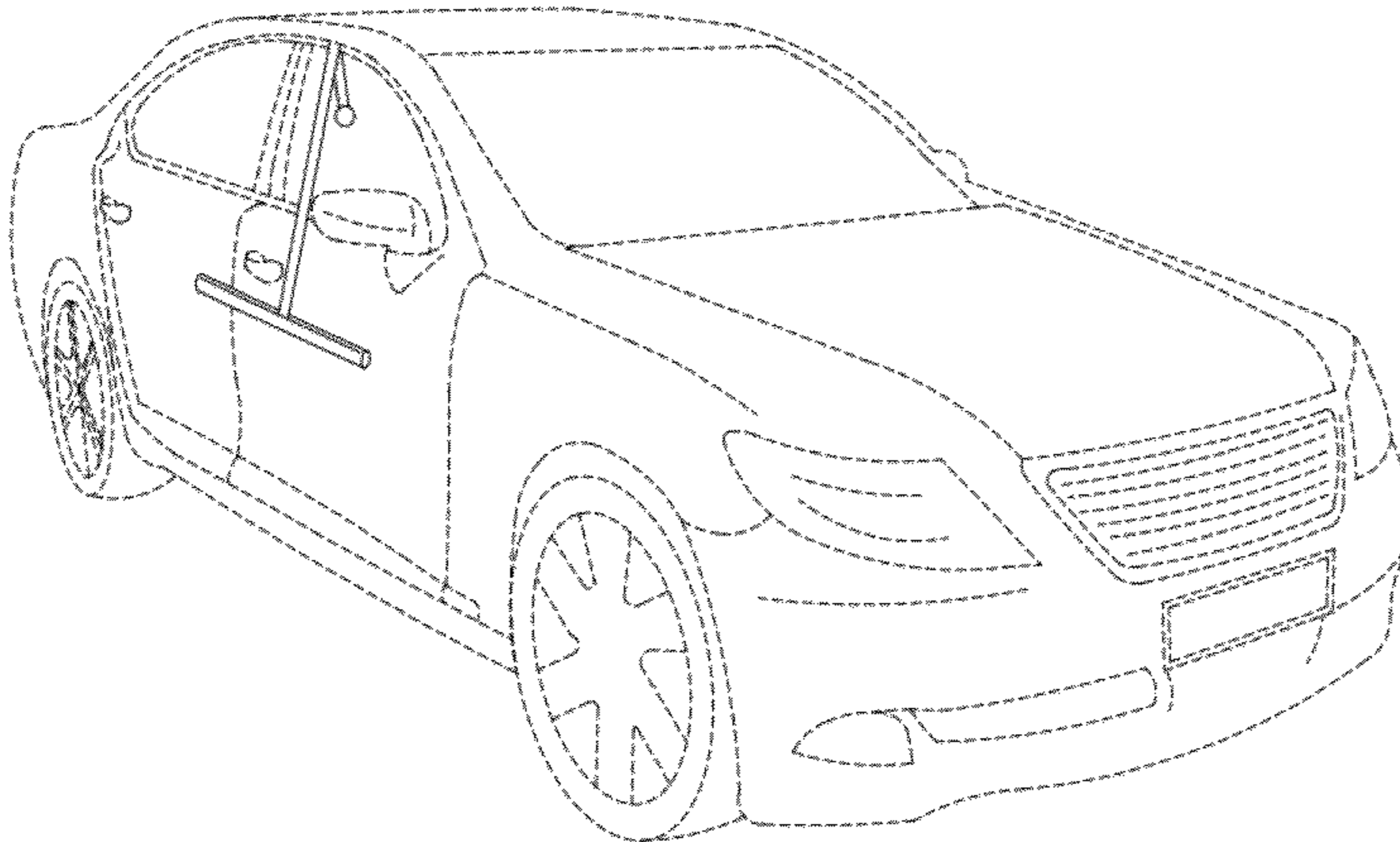

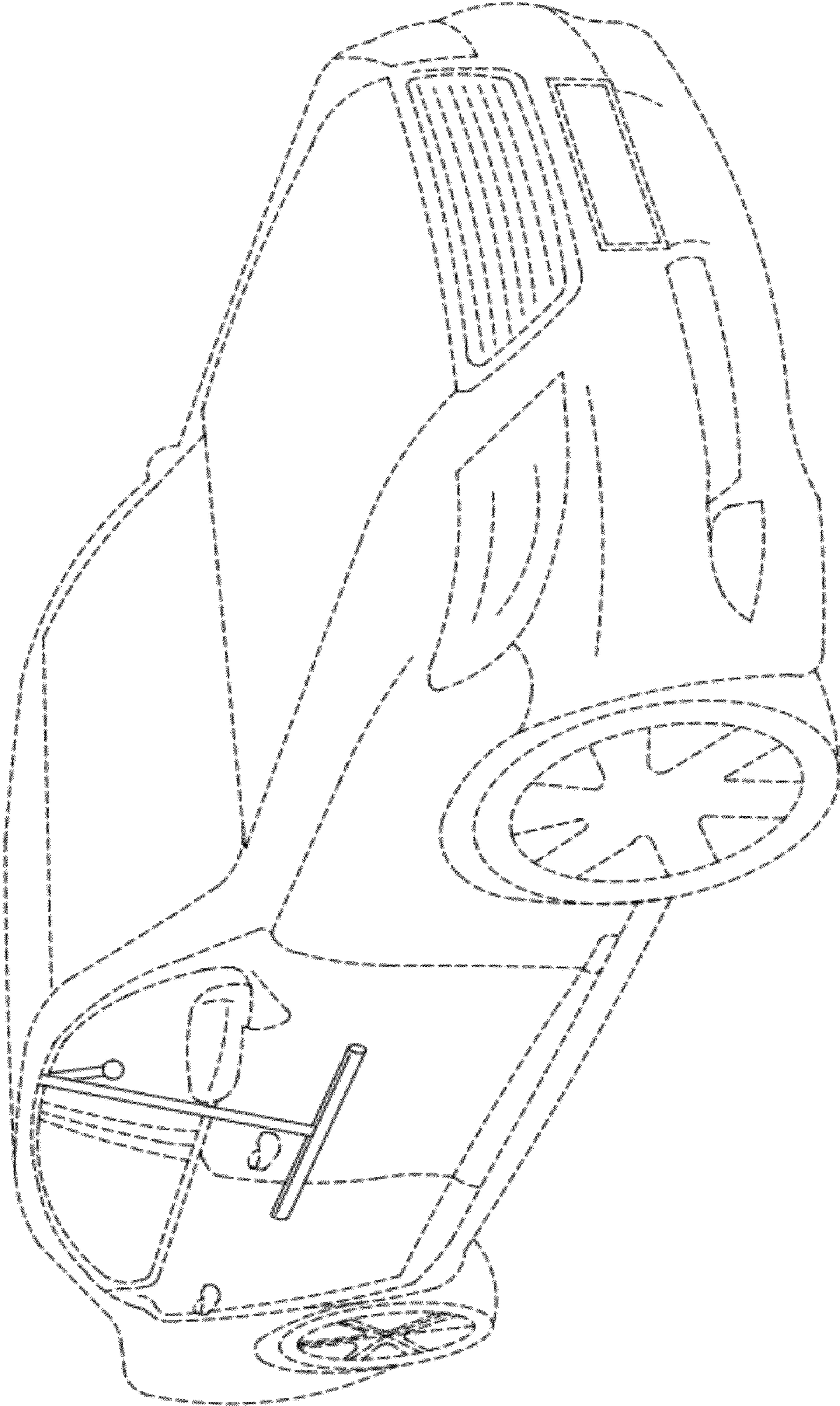

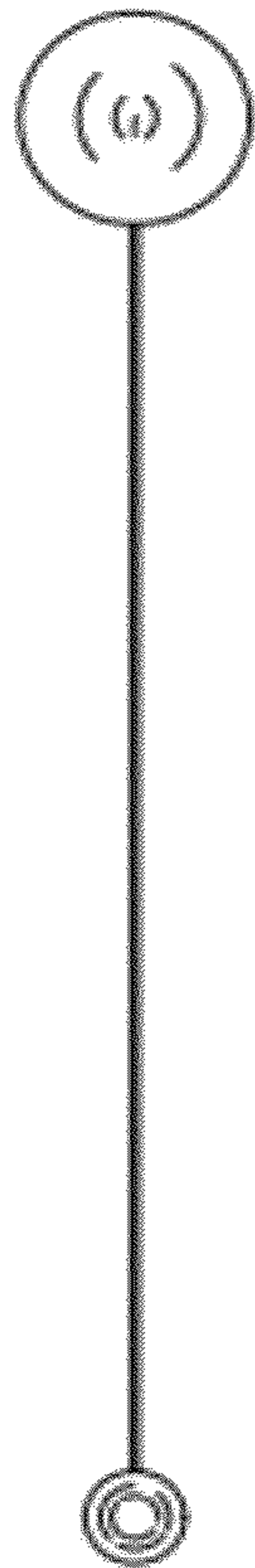

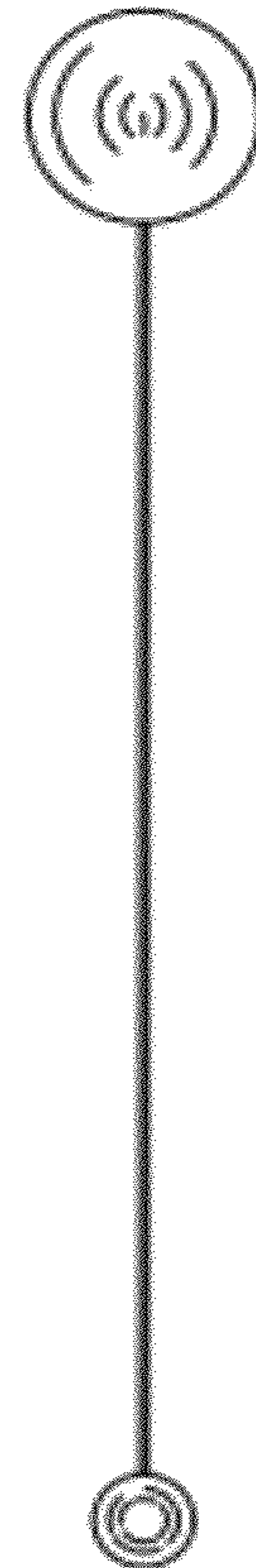

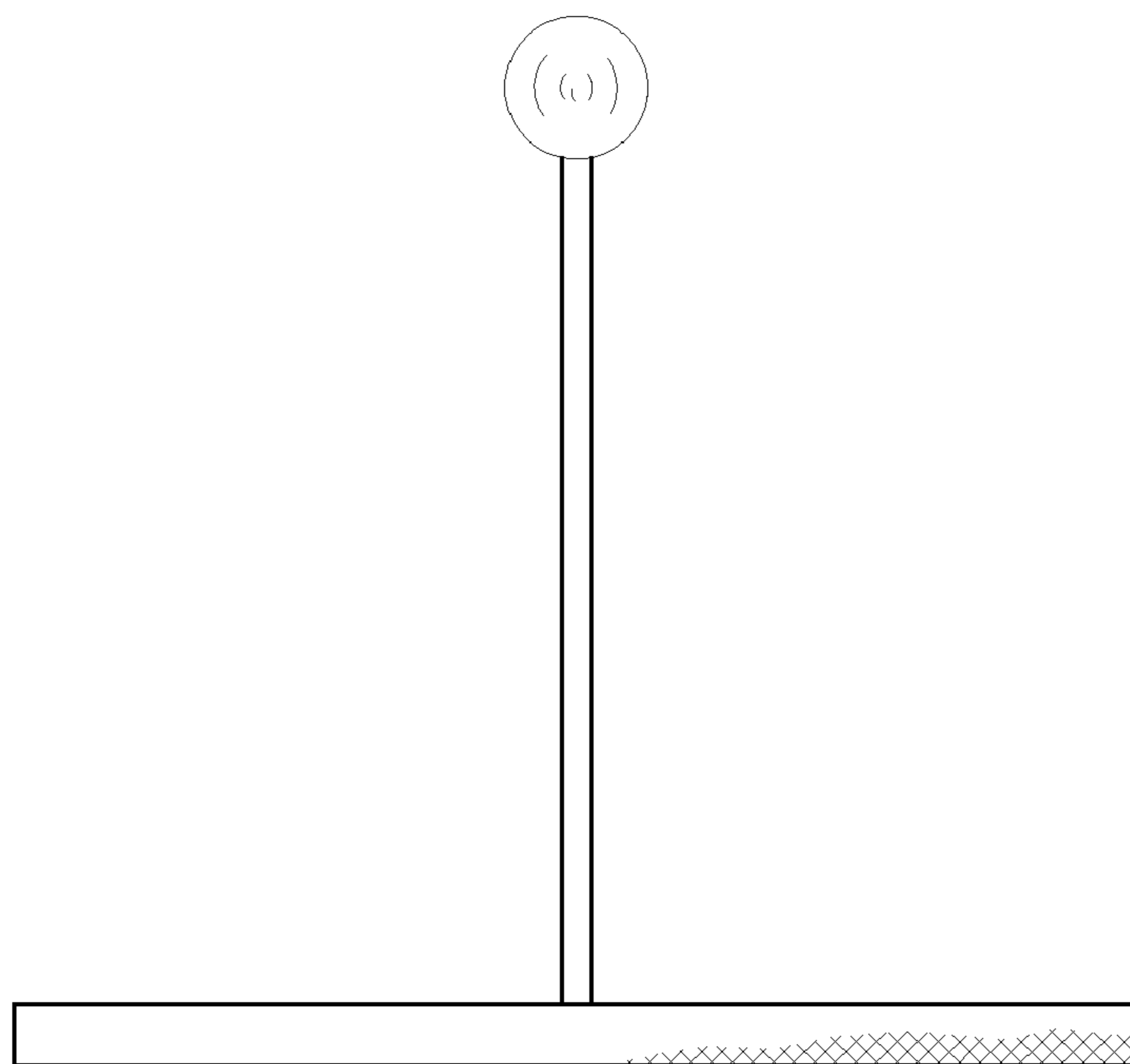

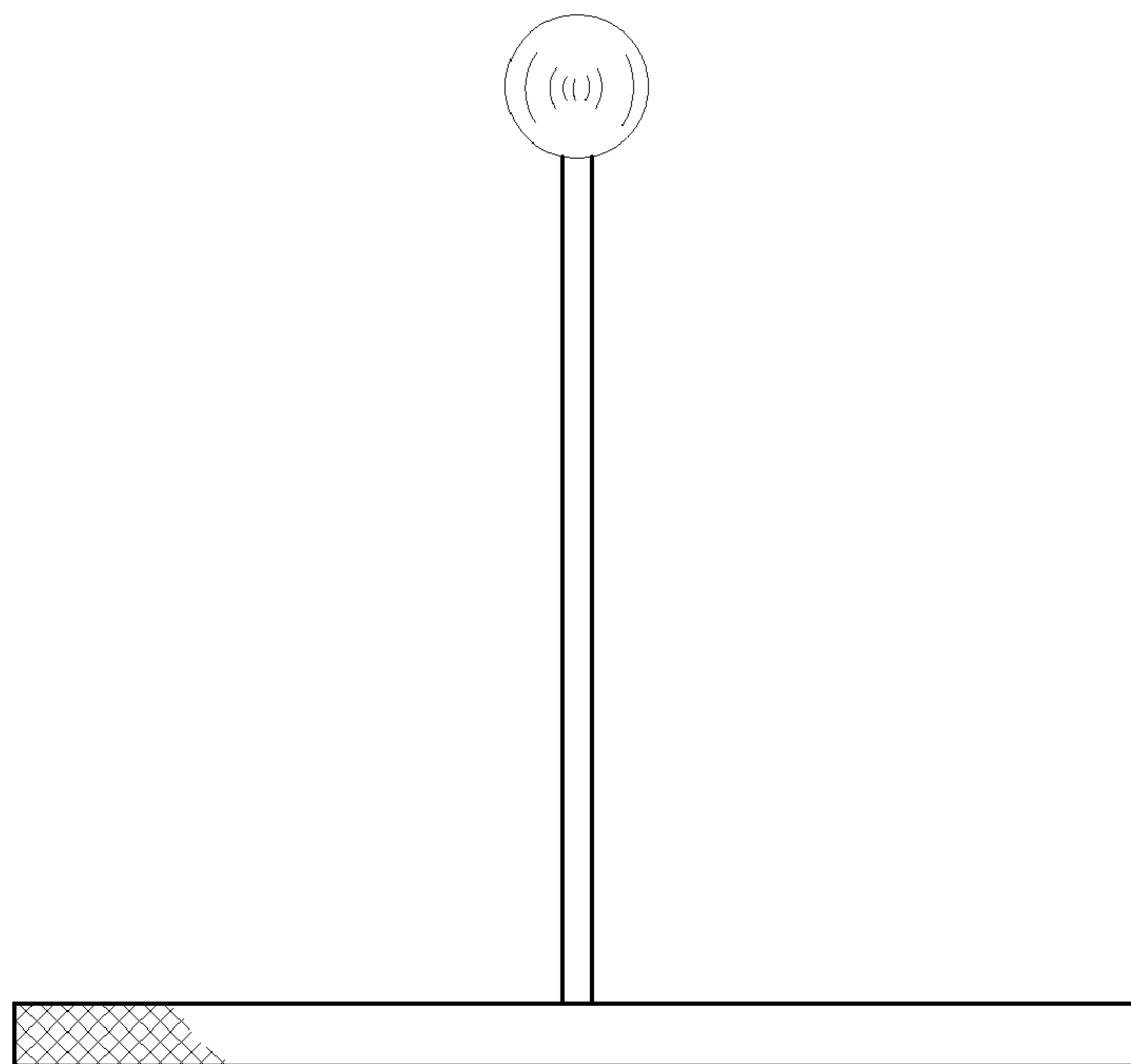

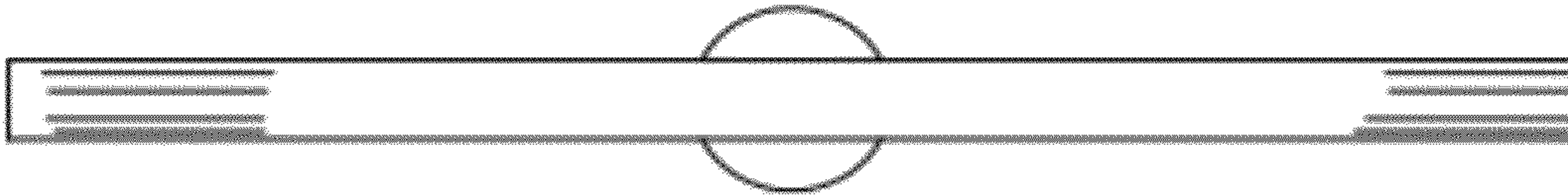
