The design for the portable miniaturized audio amplifier, as shown in the attached drawings.

FIG. 1 is a perspective view of a portable miniaturized audio amplifier, embodying our new design, in a state of use.

FIG. 2 is a top view thereof.

FIG. 3 is a side view thereof.

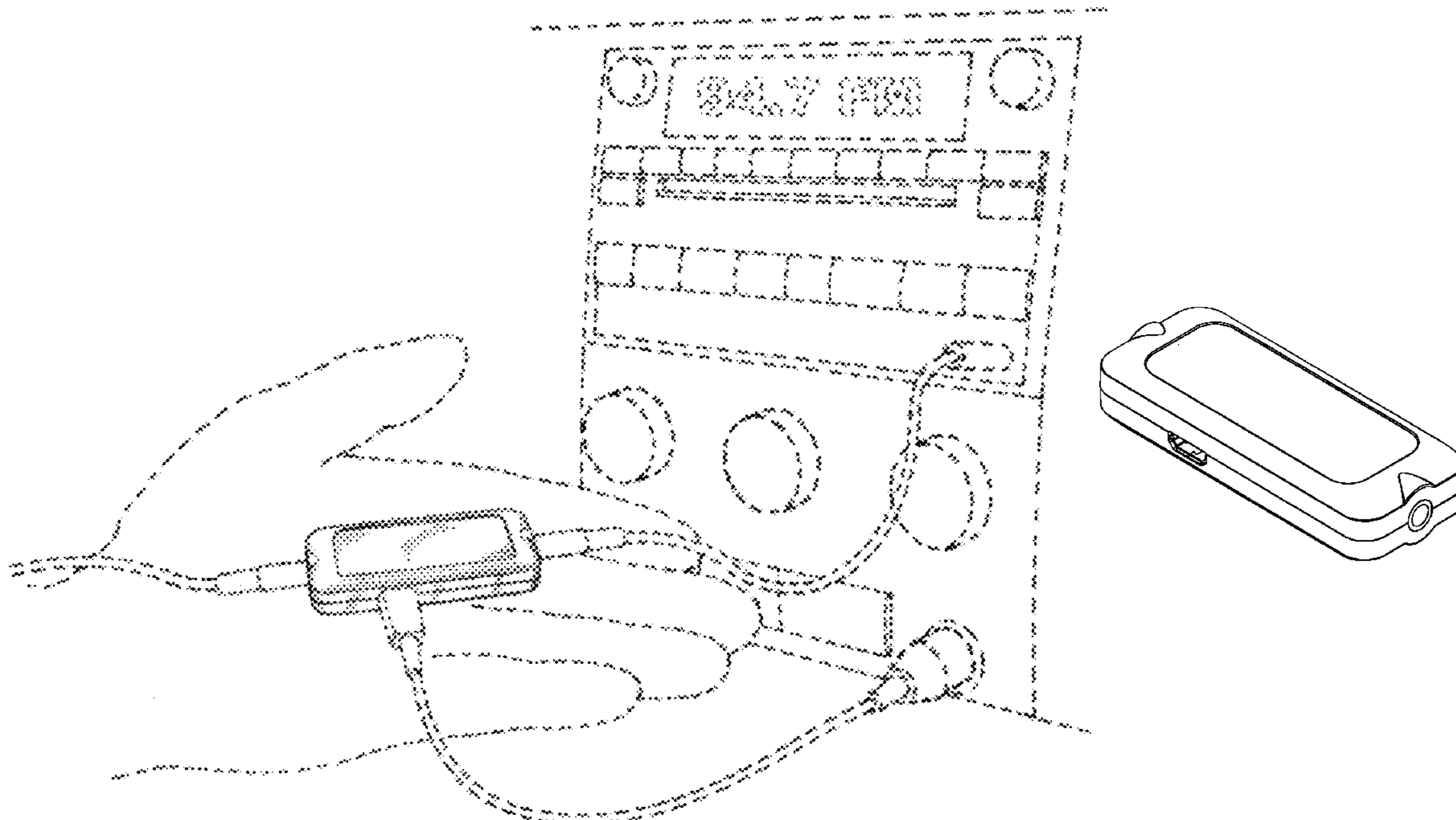
FIG. 4 is a bottom view thereof.

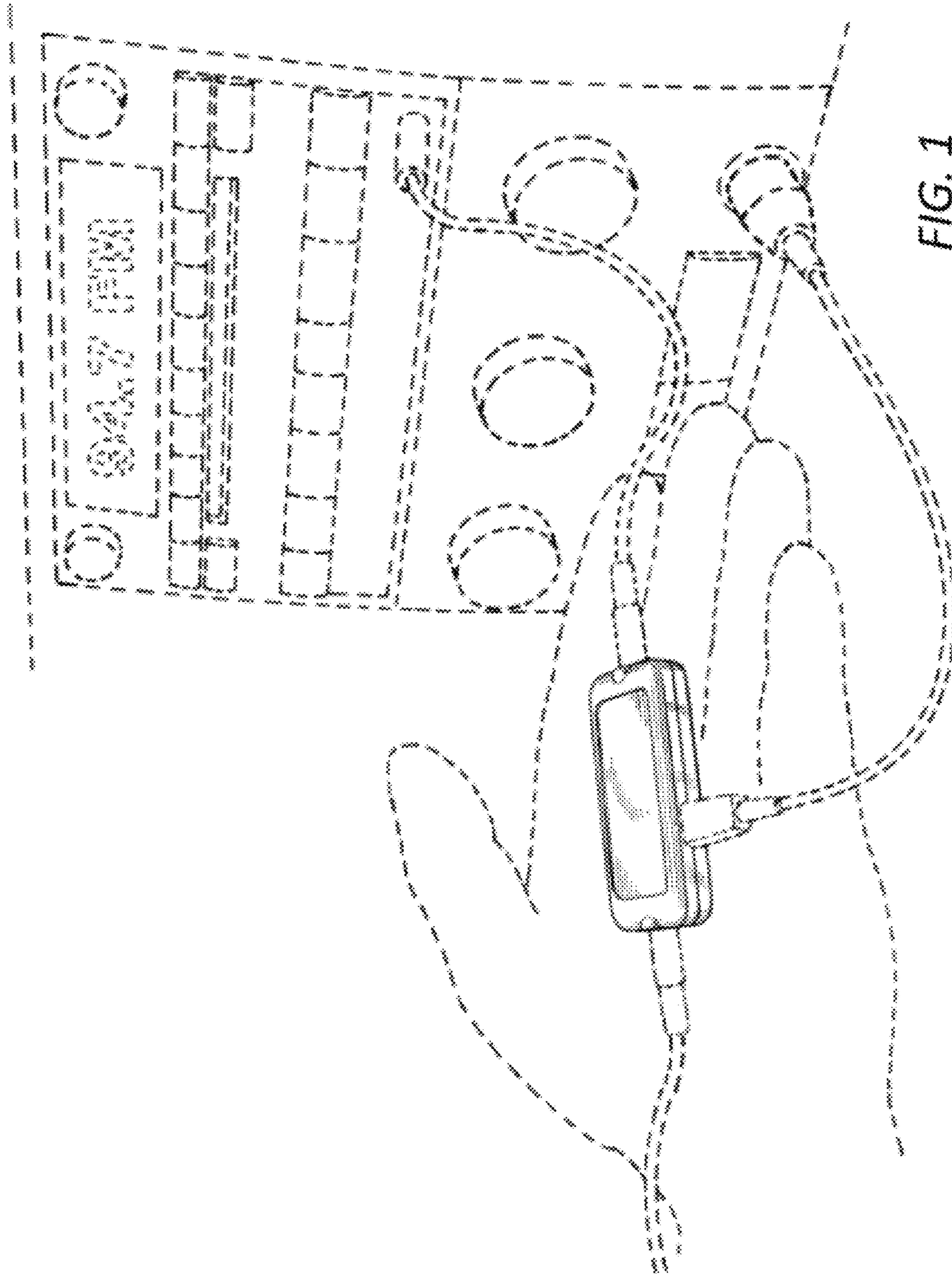

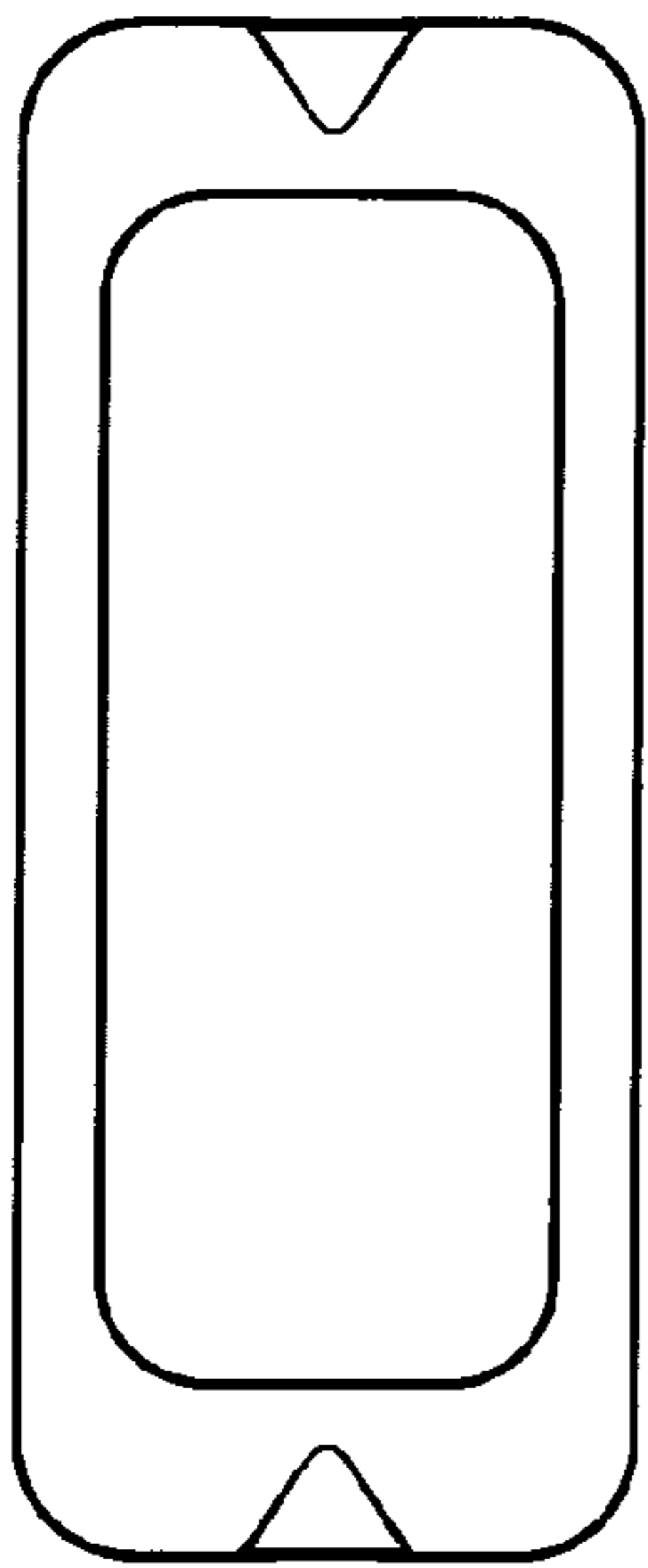

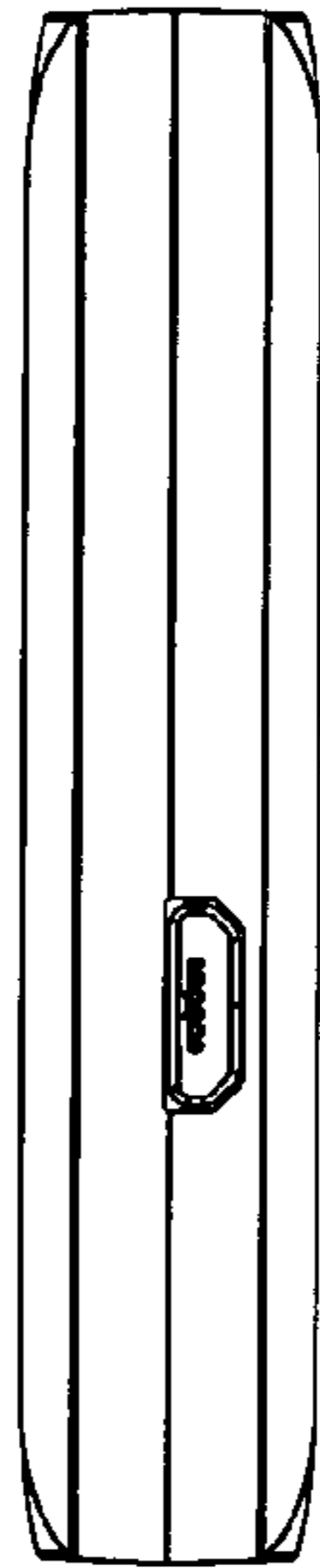

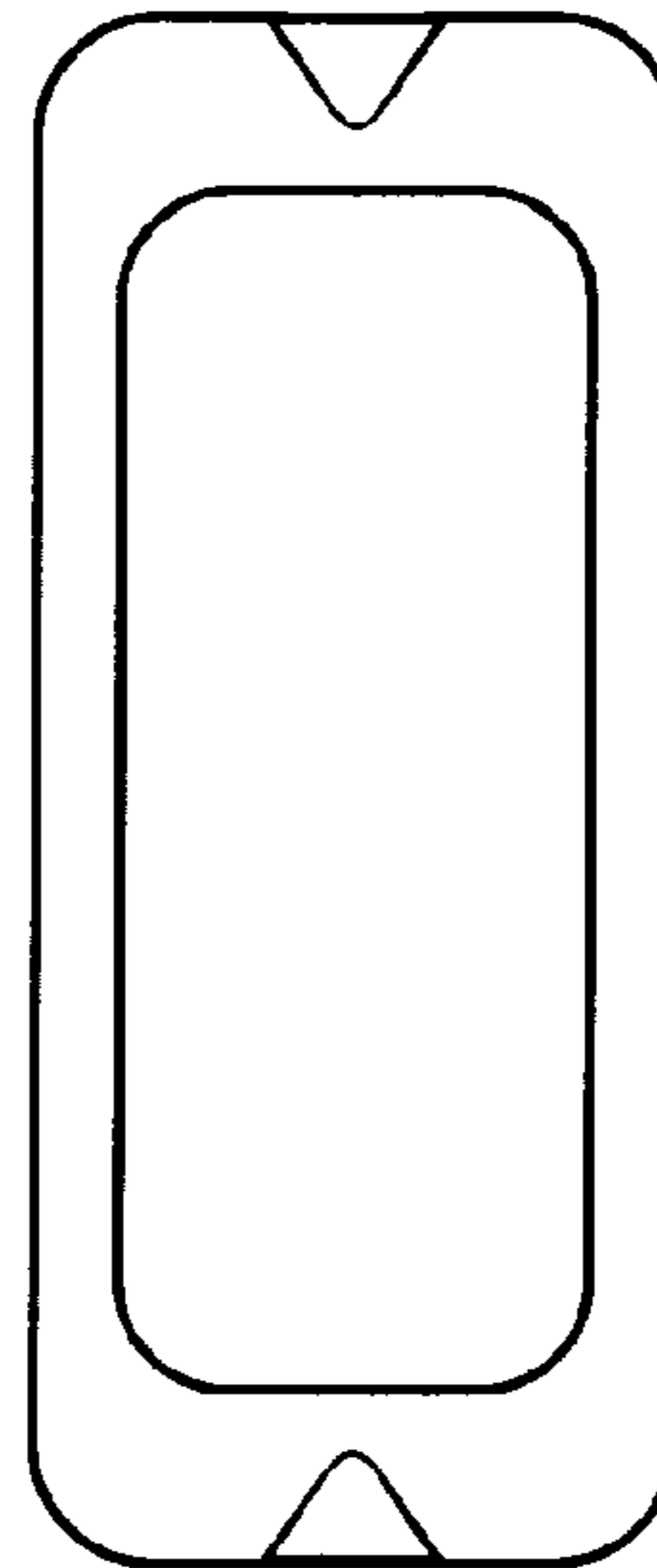

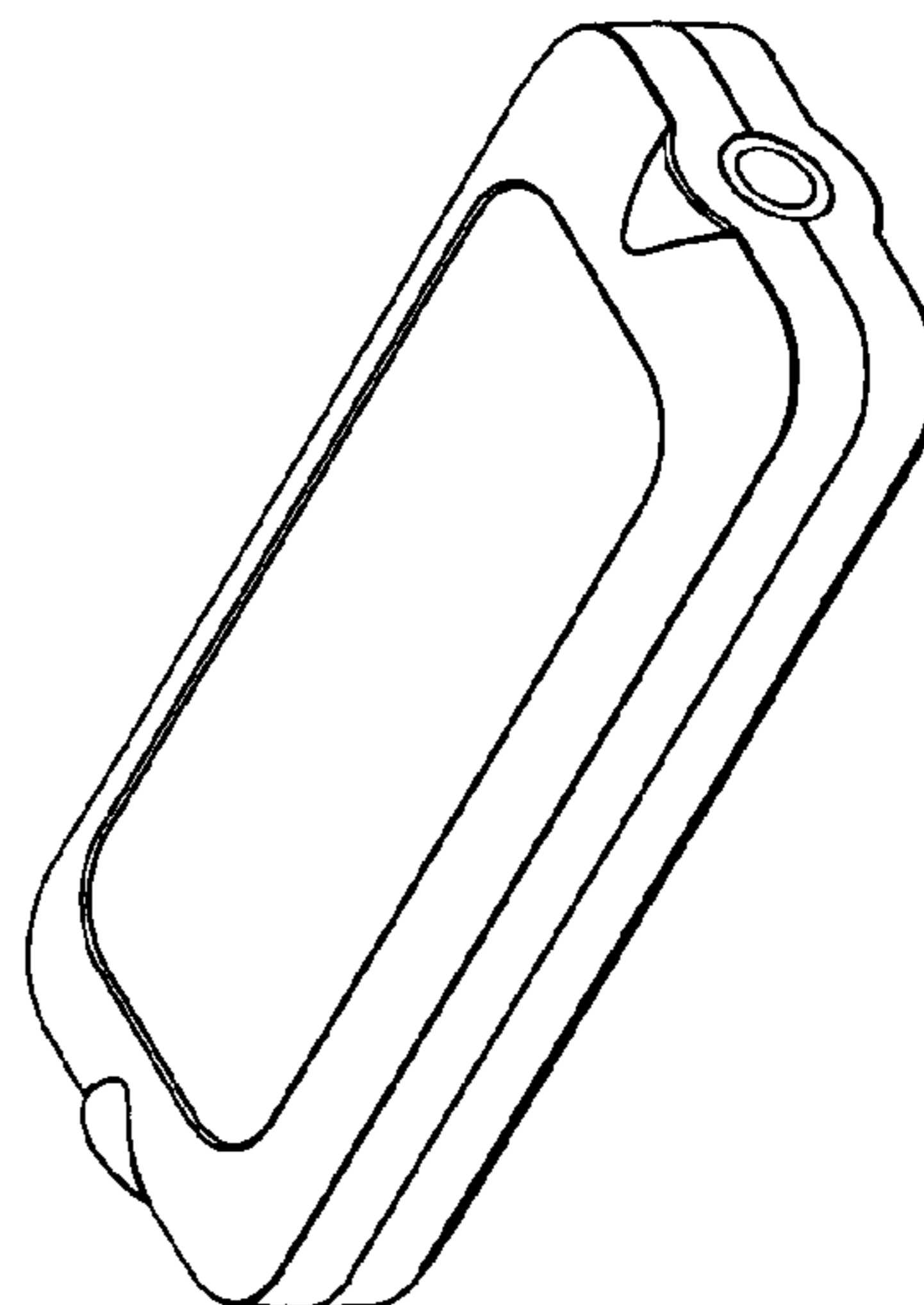

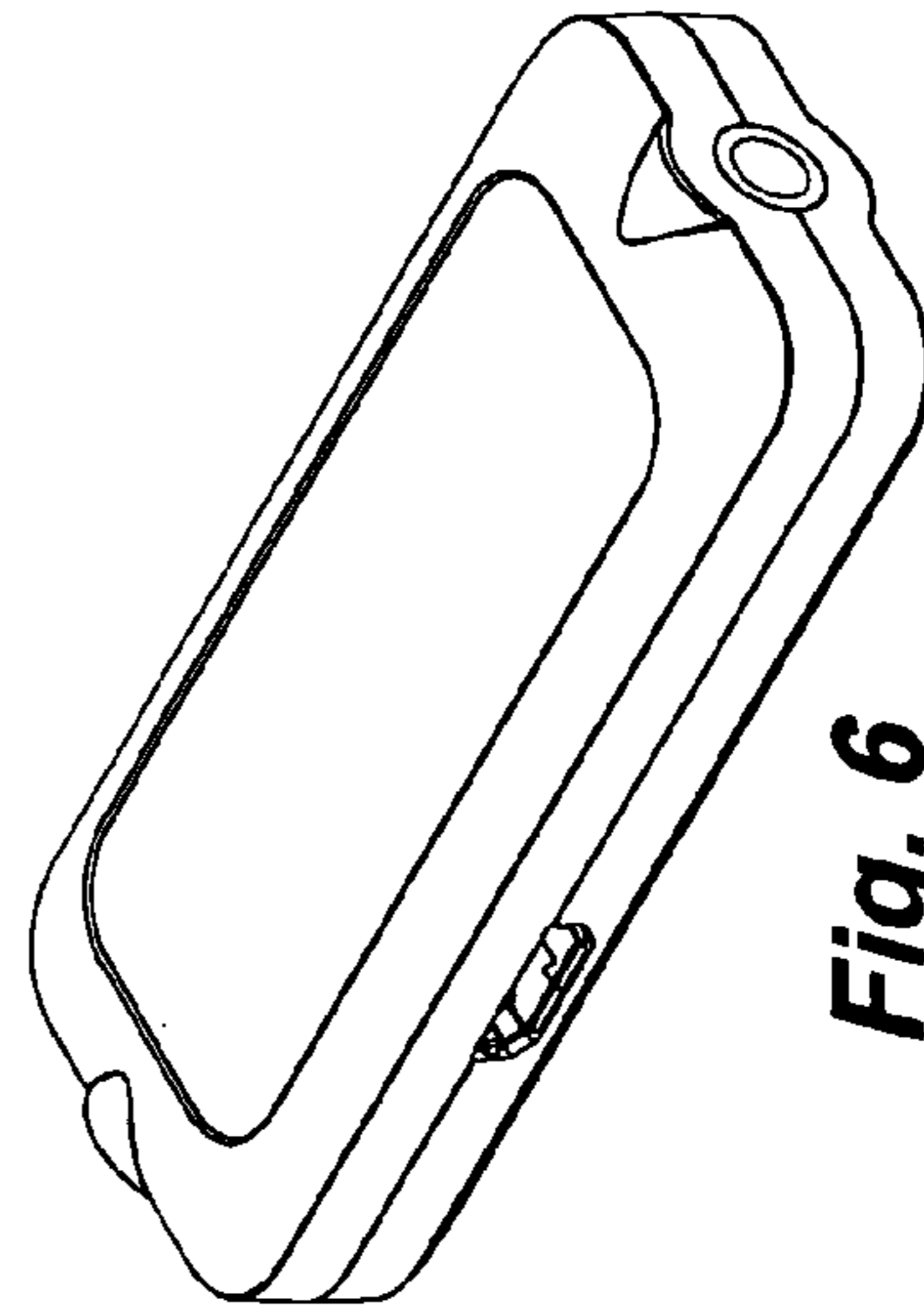
