The ornamental design for a display screen or portion thereof with animated graphical user interface, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a display screen or portion thereof with animated graphical user interface showing our new design;

FIG. 2 is a front view of the second image thereof;

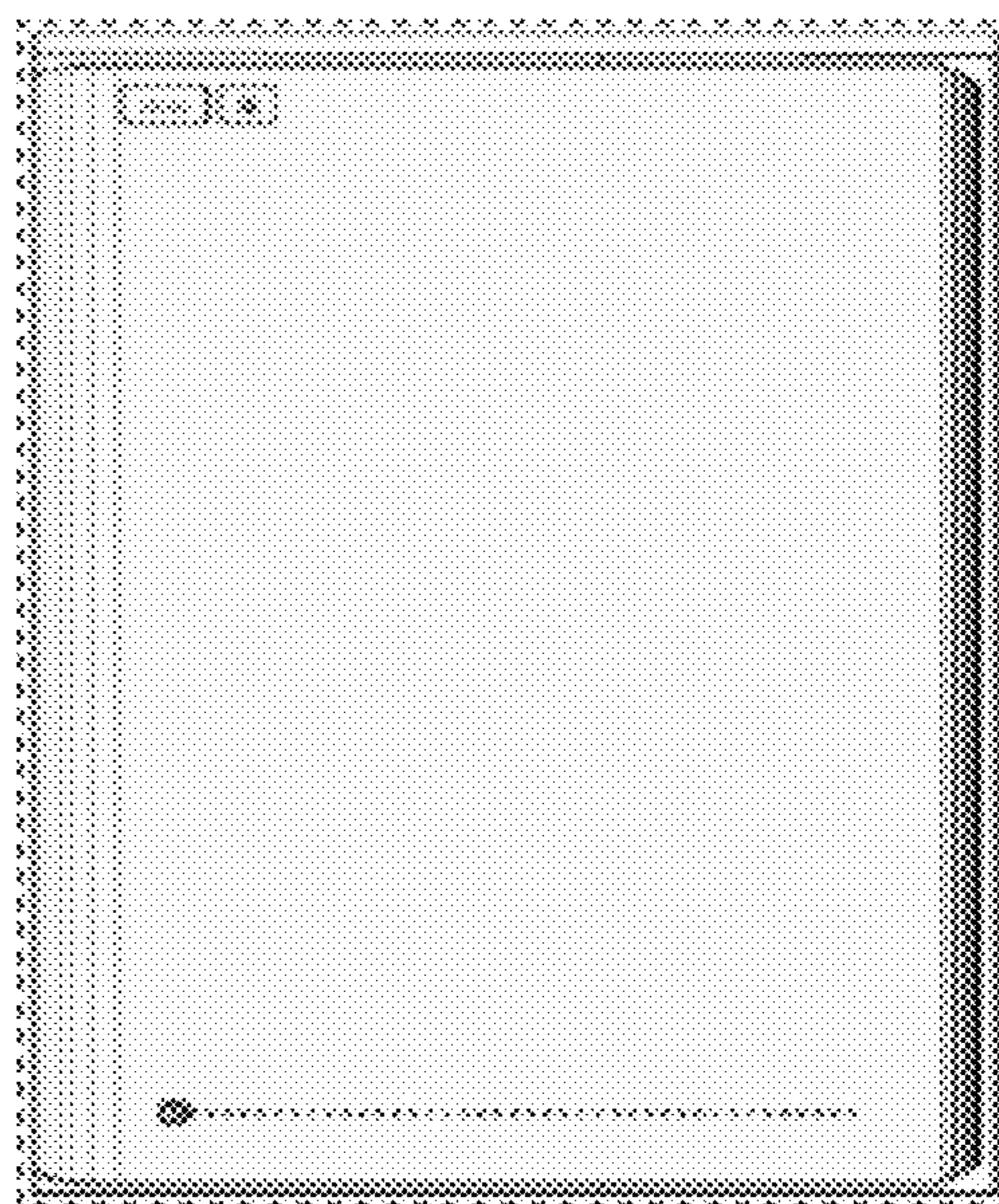
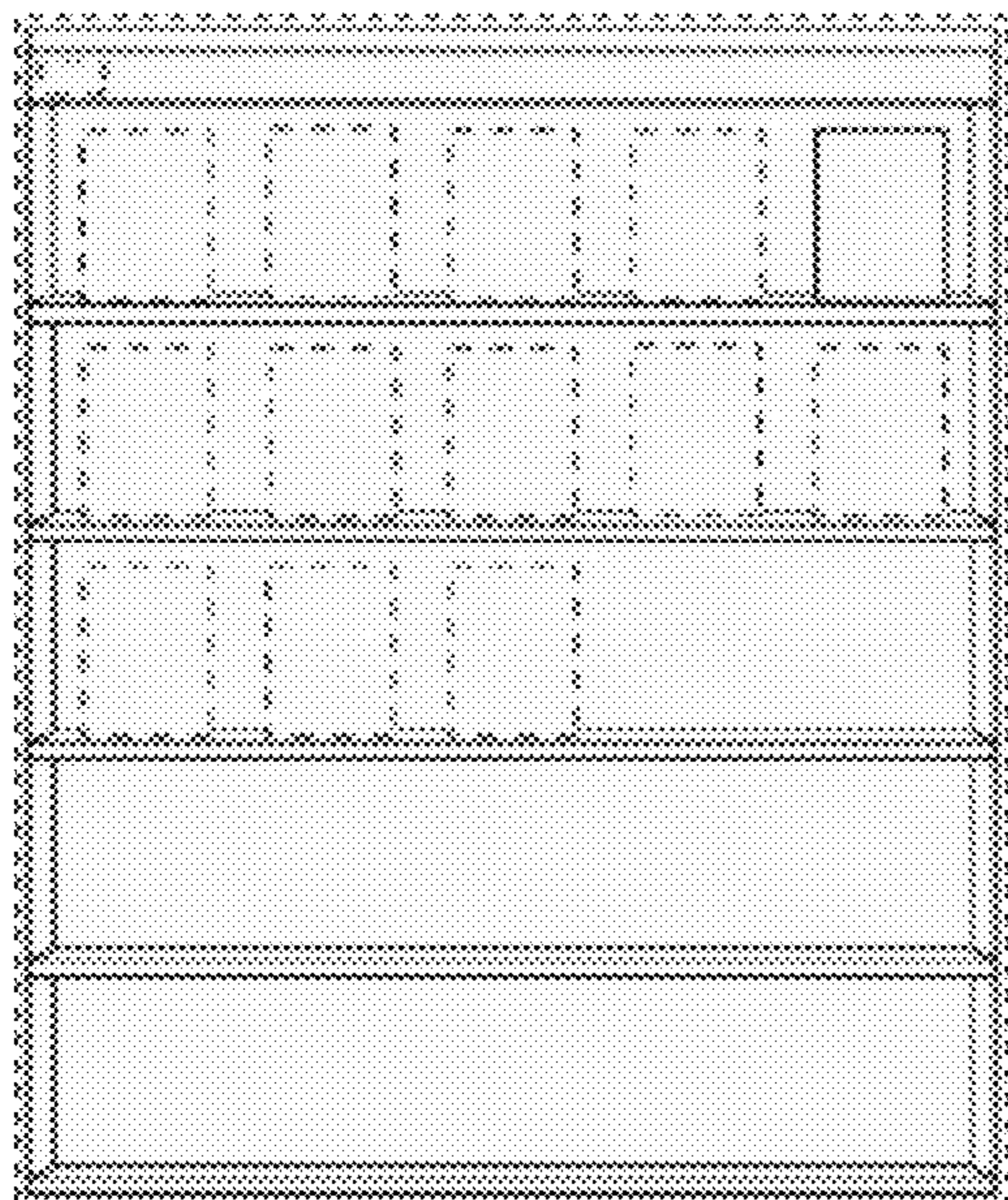
FIG. 3 is a front view of the third image thereof; and,

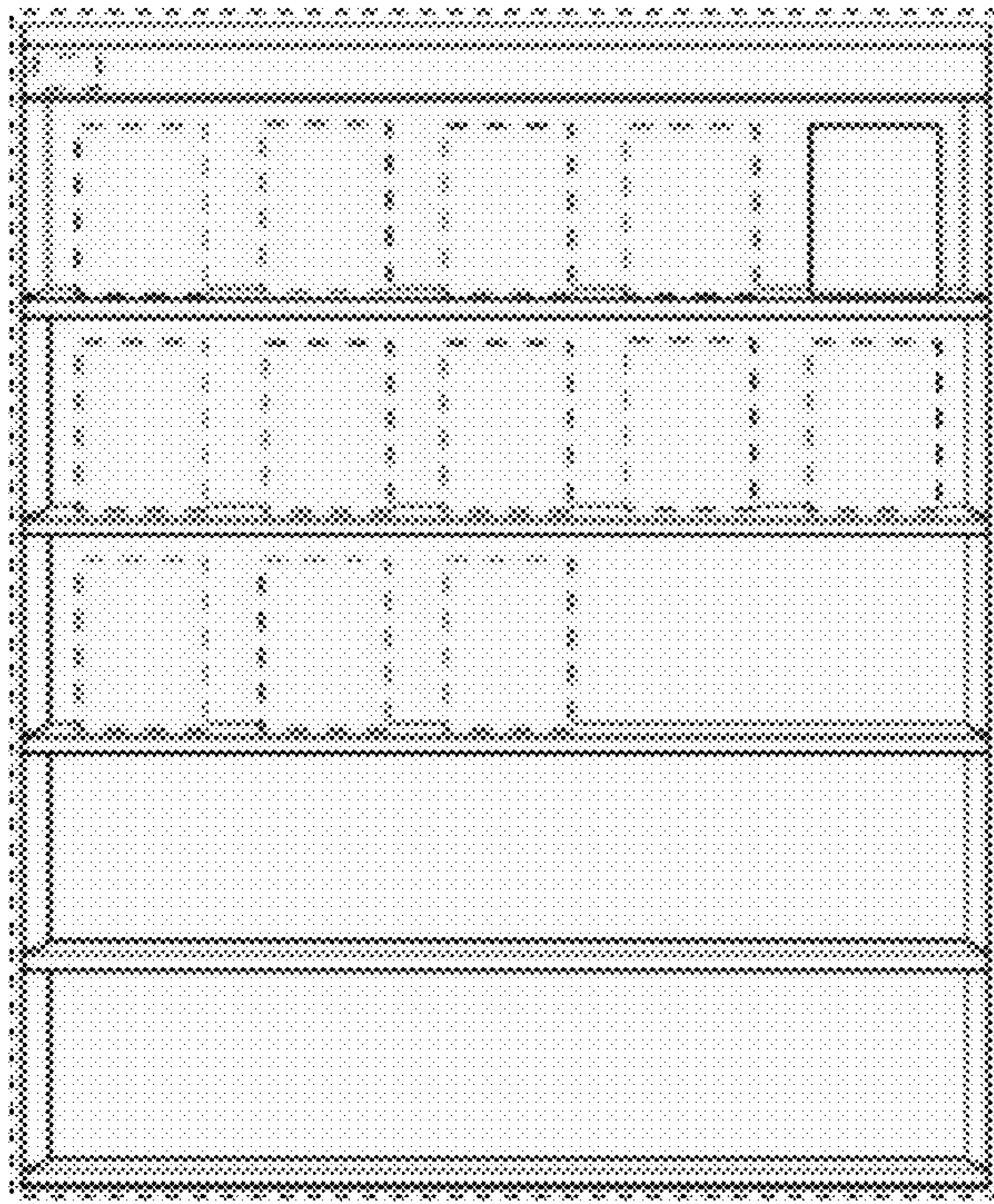

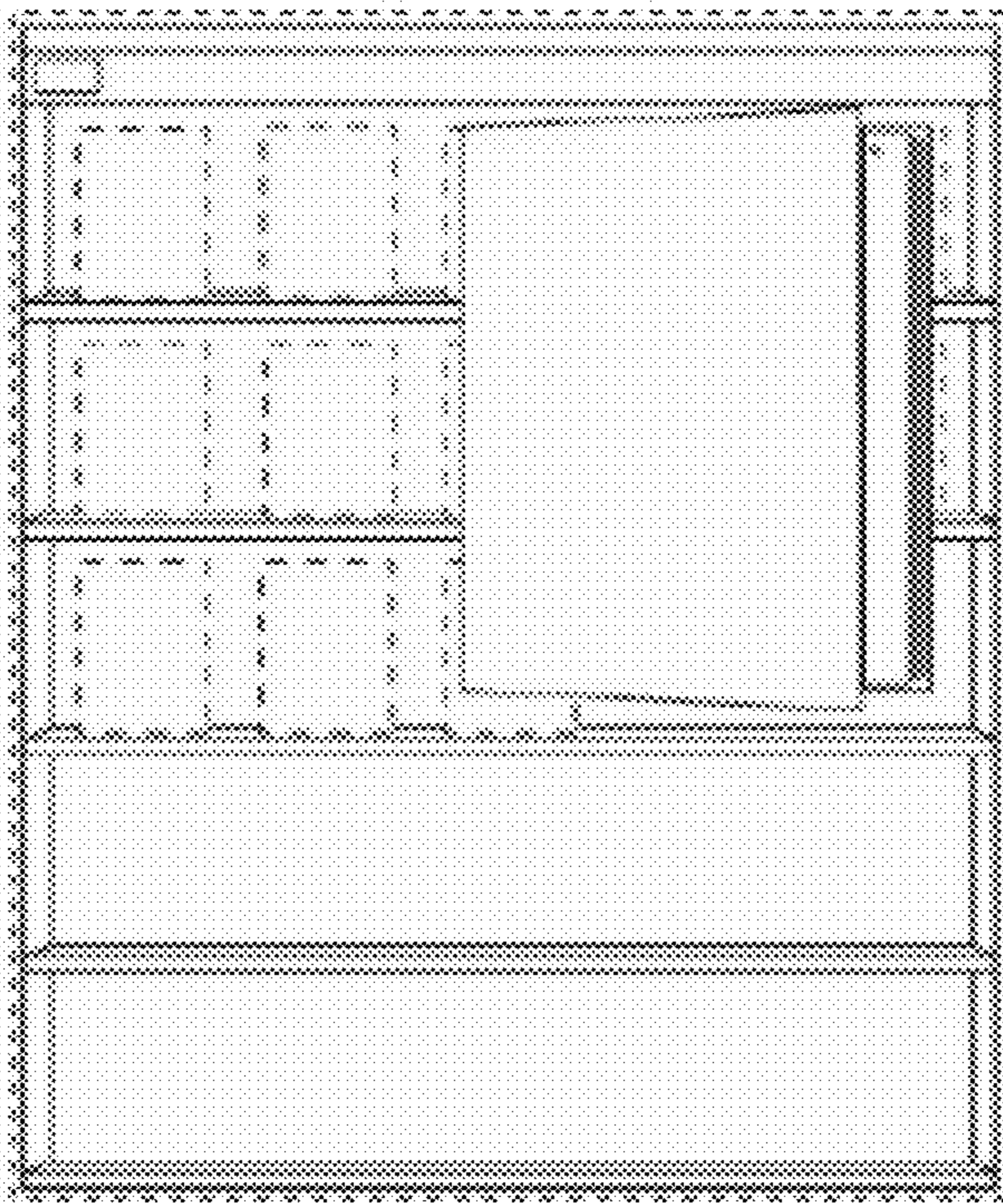

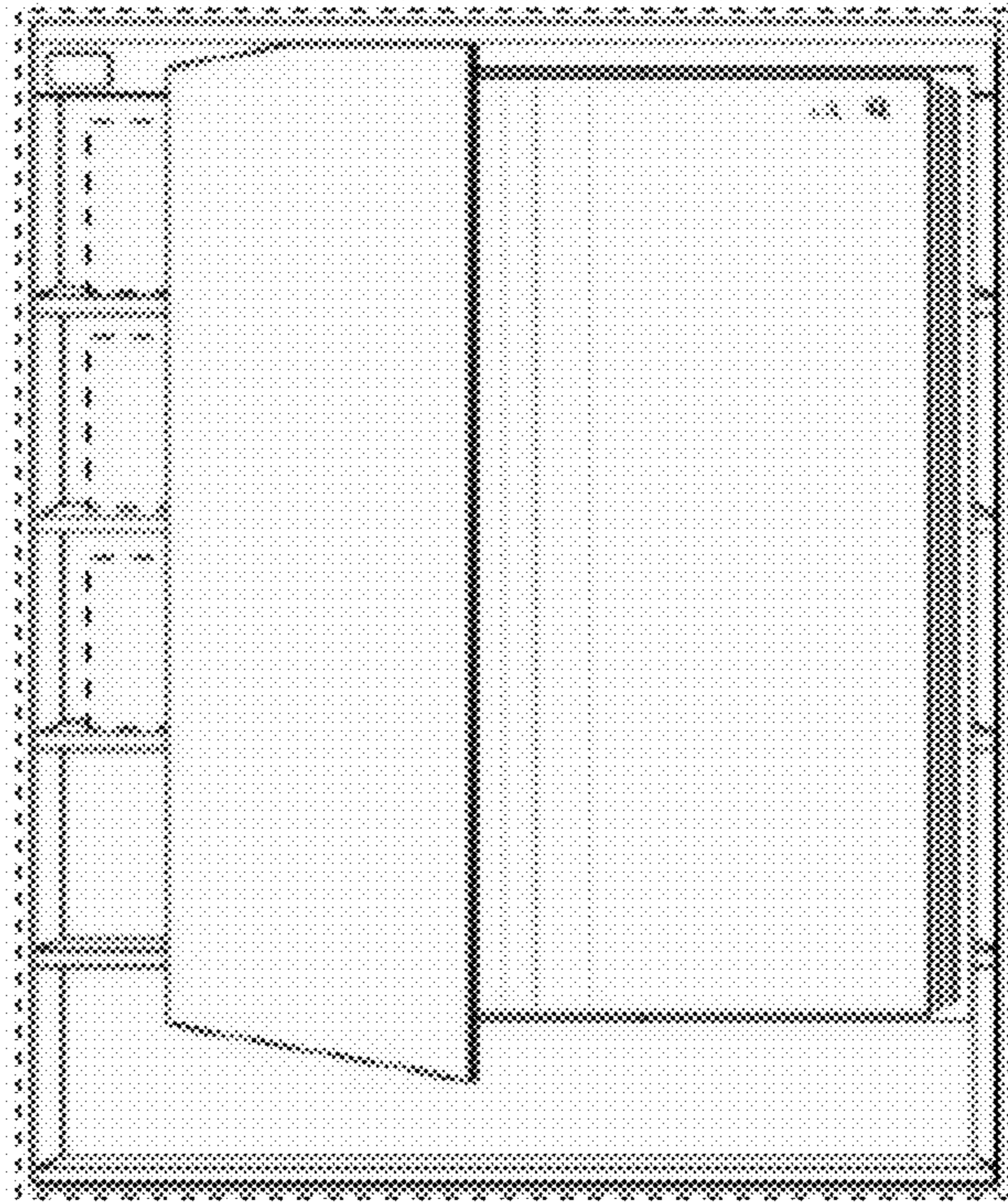

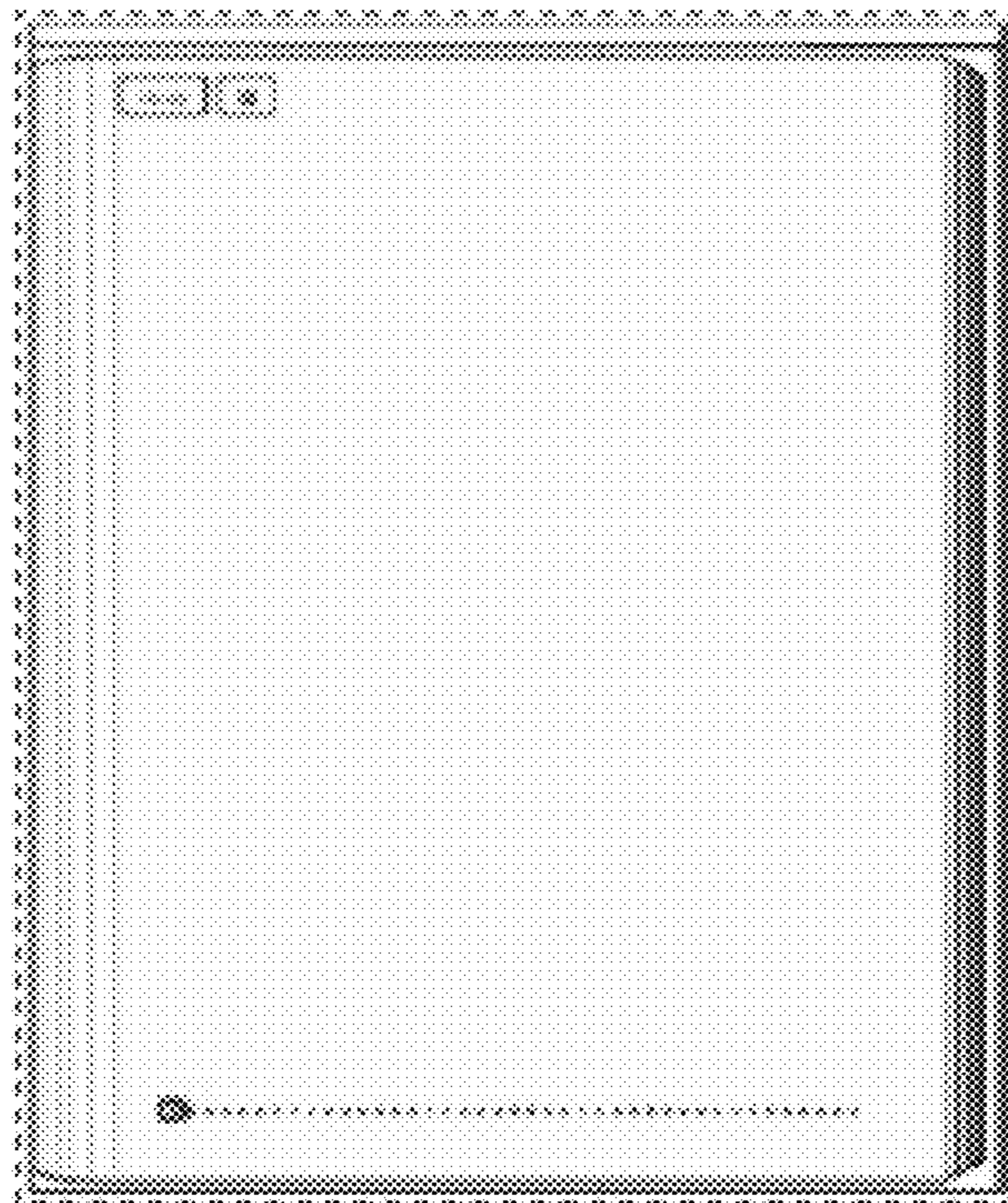
