(57) **CLAIM**

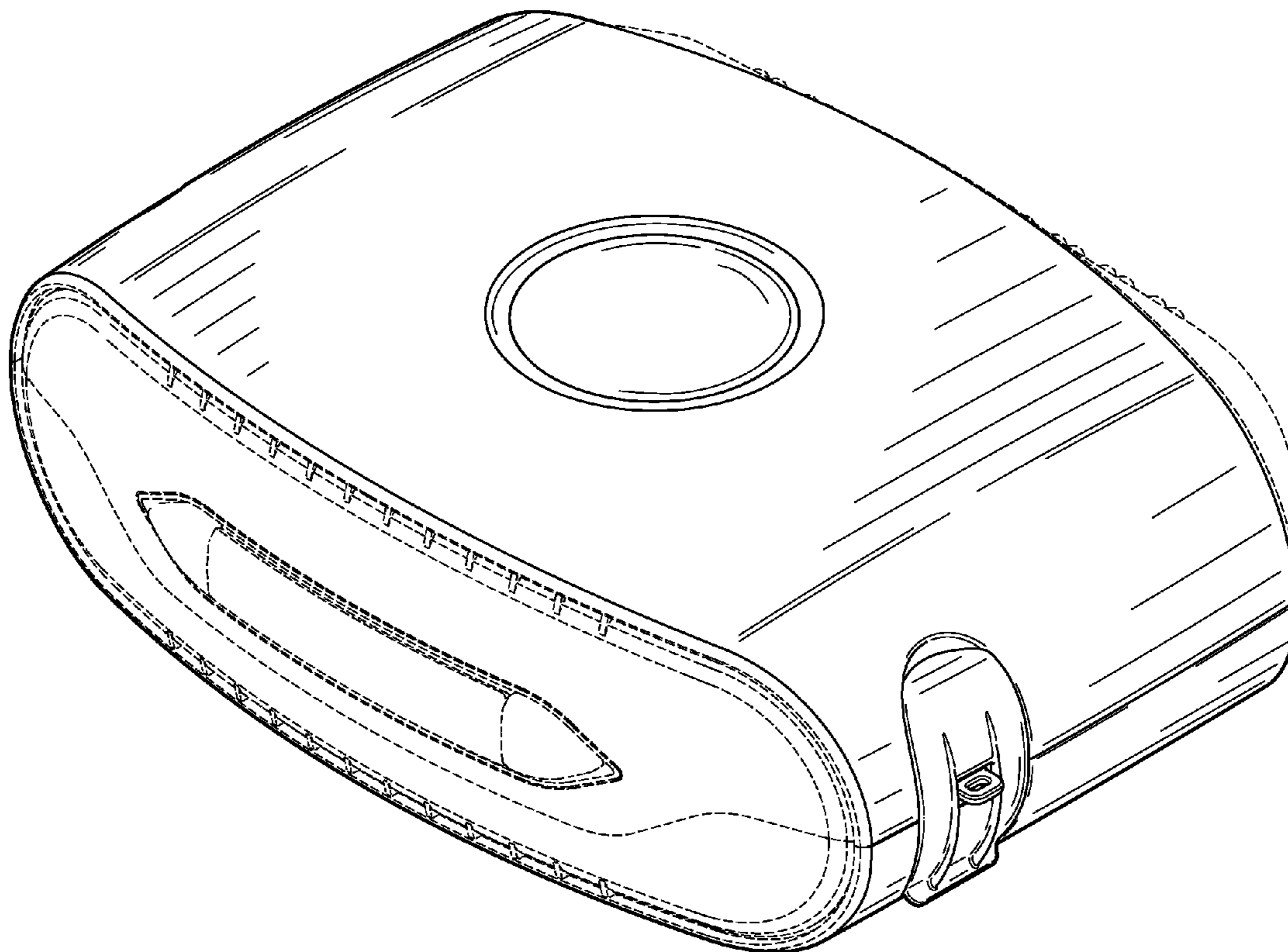
The ornamental design for a chassis for a video game console, as shown and described.

DESCRIPTION

FIG. 1 is a top front perspective view of a chassis for a video game console showing our new design; FIG. 2 is a top plan view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a left side elevational view thereof; FIG. 6 is a right side elevational view thereof; and, FIG. 7 is a bottom plan view thereof.

The broken lines represent the disclaimed portions of a chassis for a video game console and form no part of the claimed design.

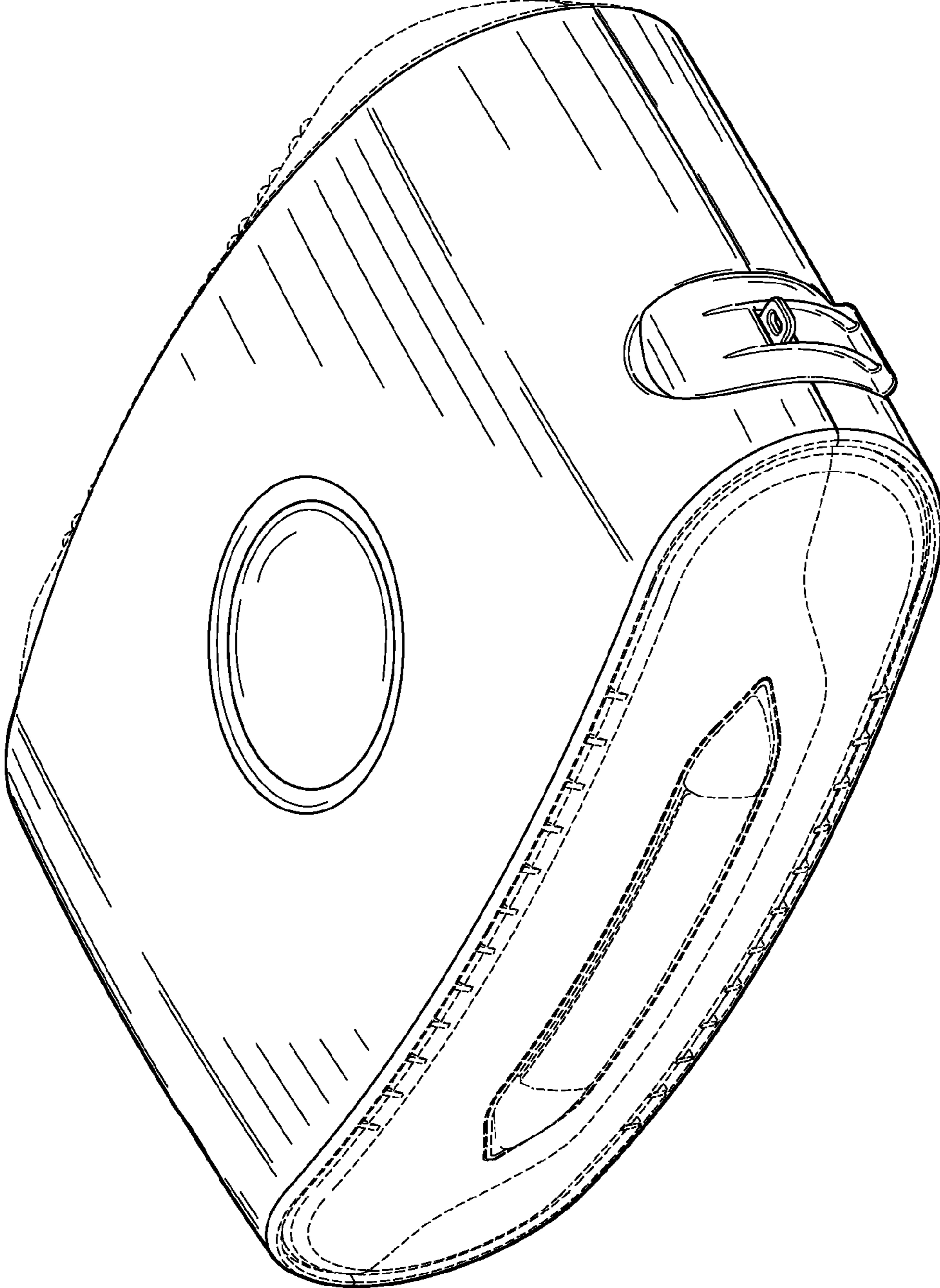

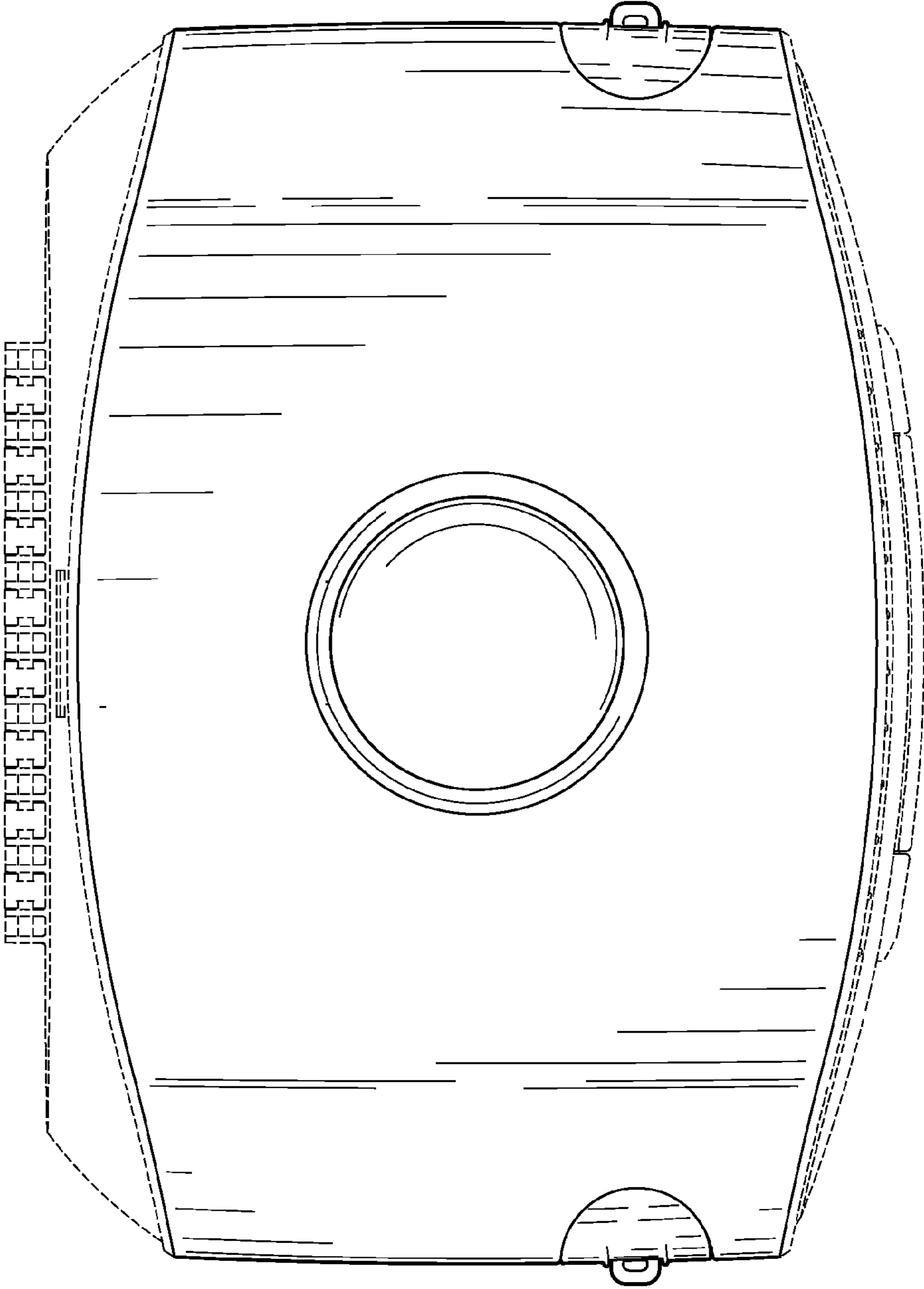

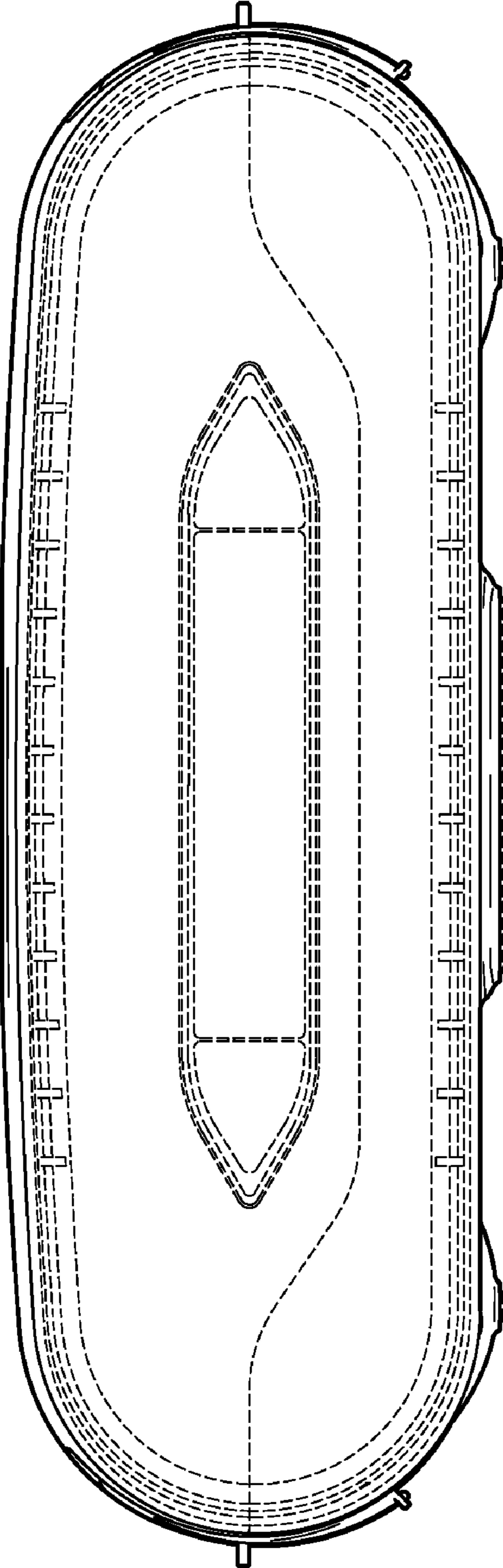

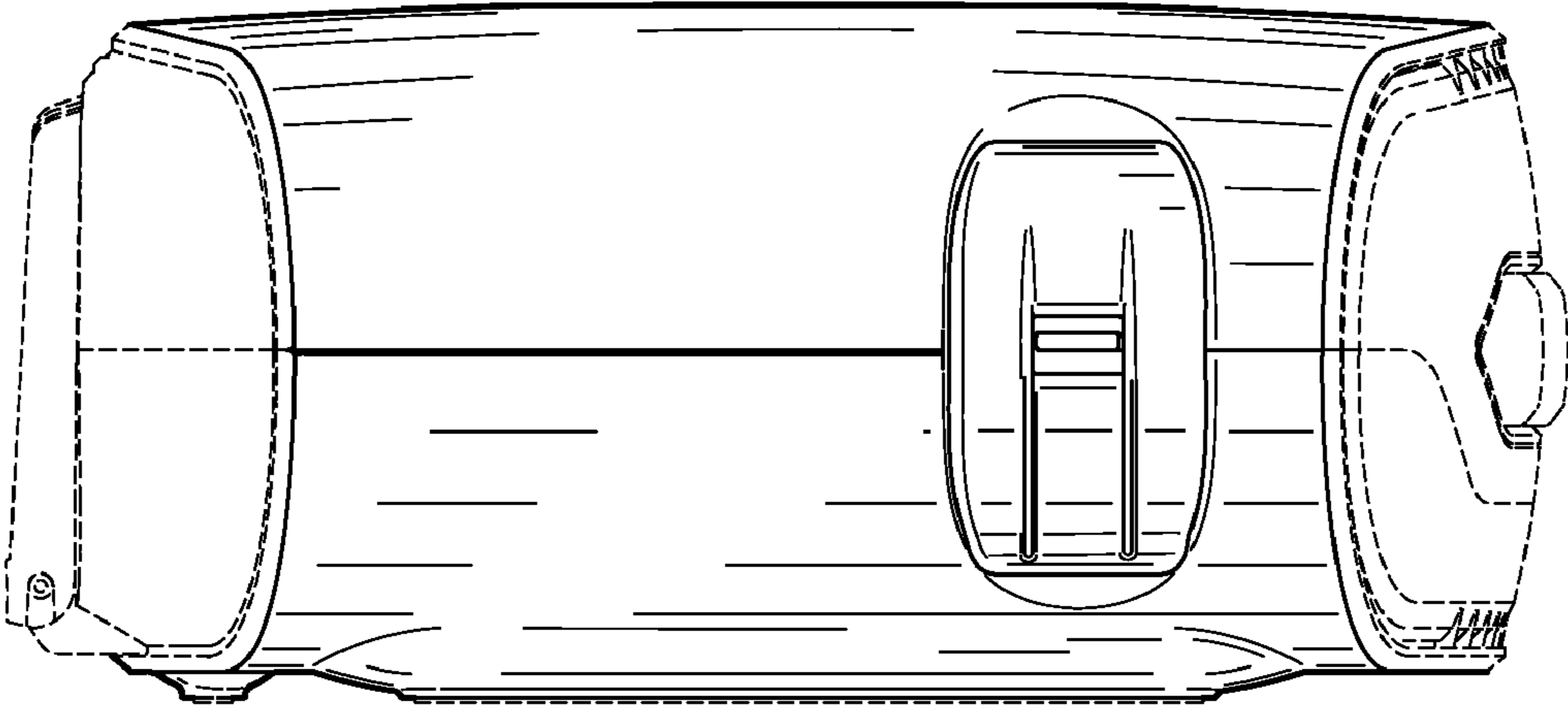

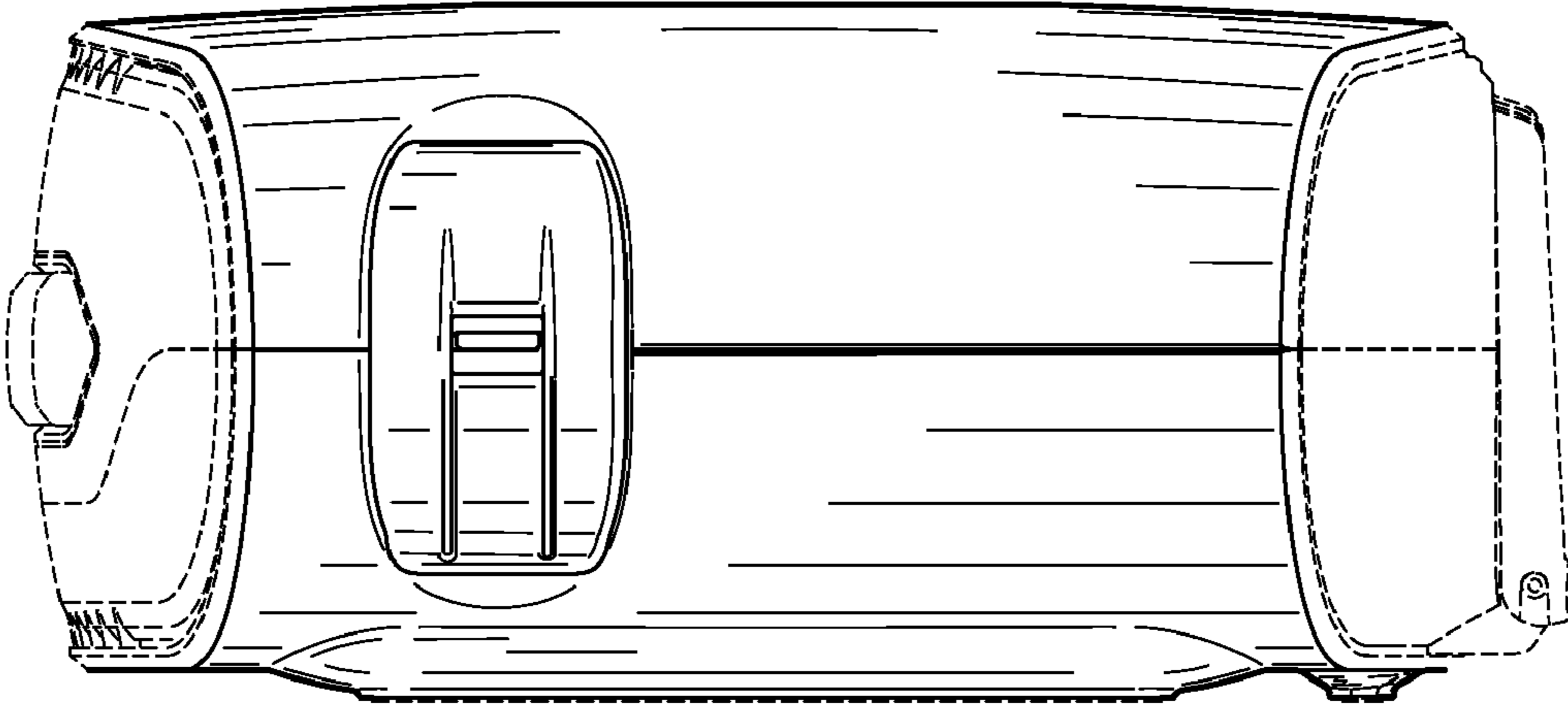

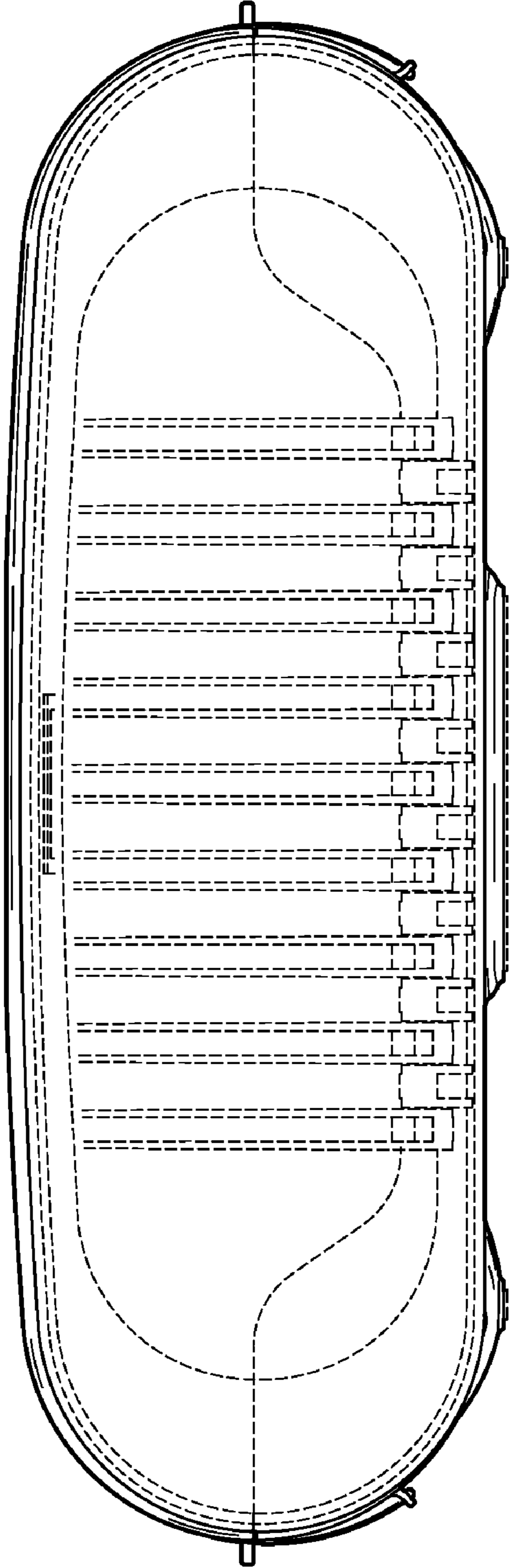

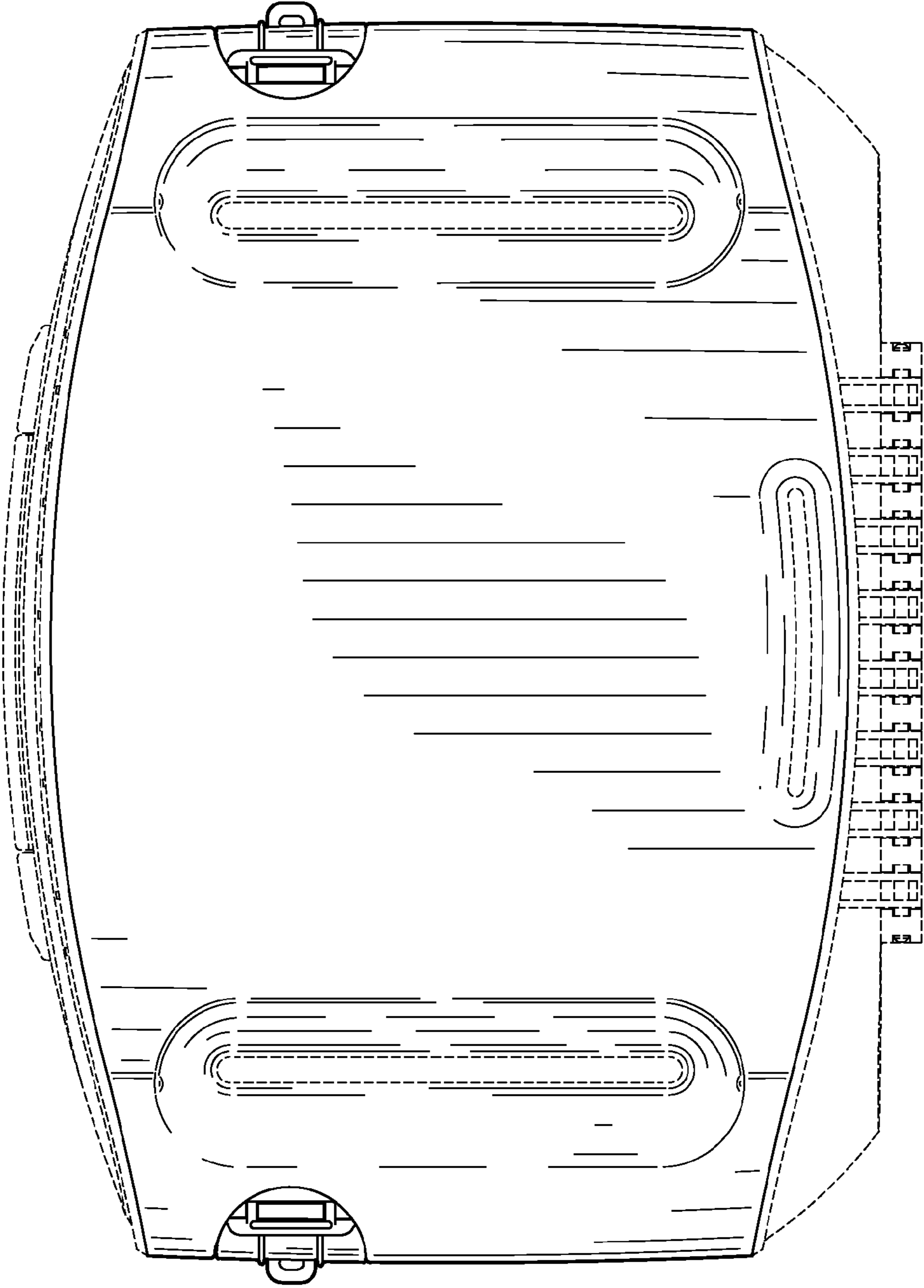
