(57) **CLAIM**

The ornamental design for a chewable children's toy in the shape of a car, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a chewable children's toy of the present design.

FIG. 2 is a rear view of the chewable children's toy of FIG. 1.

FIG. 3 is a top view of the chewable children's toy of FIG. 1.

FIG. 4 is a bottom view of the chewable children's toy of FIG. 1.

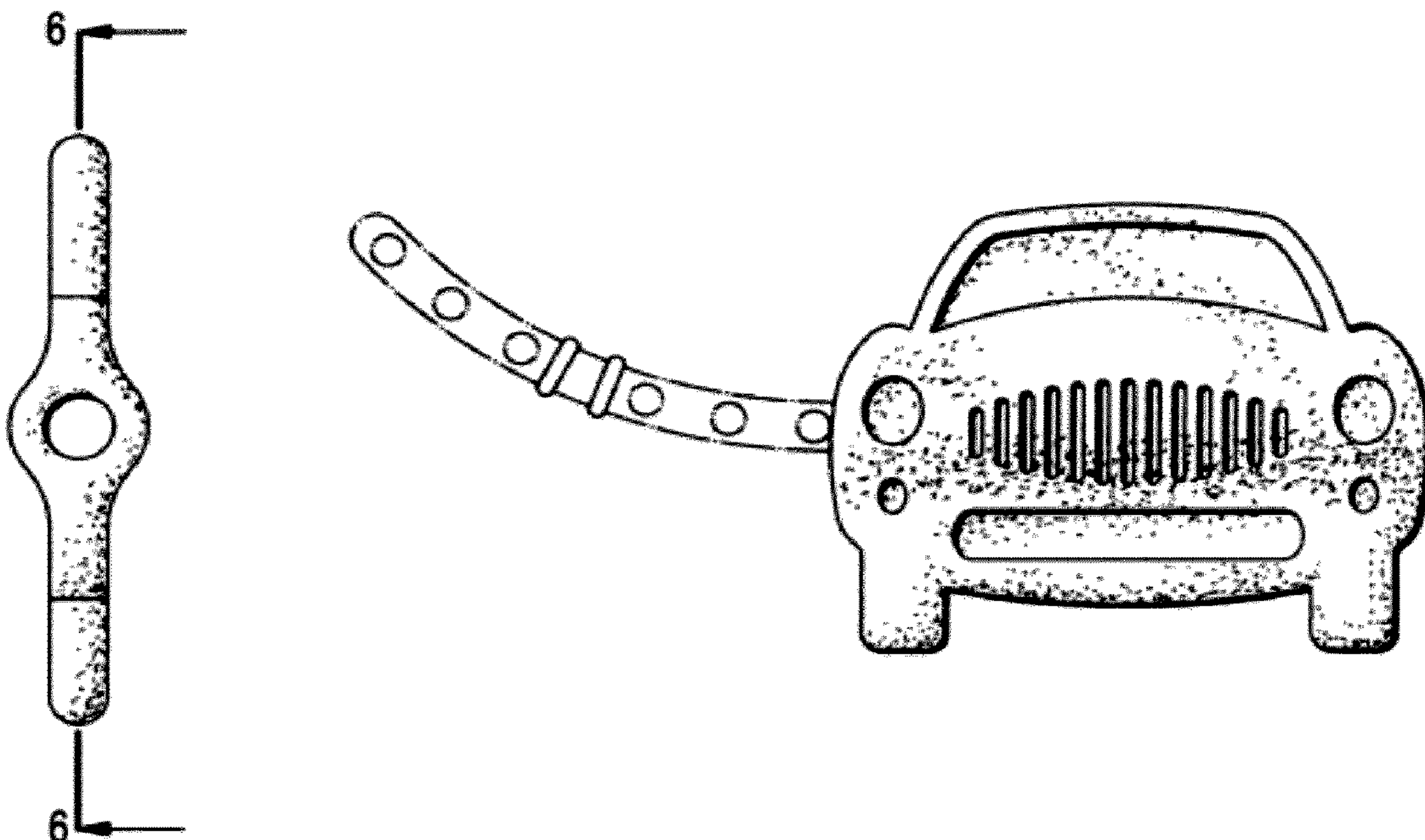
FIG. 5 is a side view of the chewable children's toy of FIG. 1. FIG. 6 is a view of the chewable children's toy of FIG. 1 showing a cross-section taken at a line 6-6 shown in FIG. 5, the cross-section showing a through-hole of the chewable children's toy.

FIG. 7 is a front view of the chewable children's toy of FIG. 1 mounted on a pencil via the through-hole.

FIG. 8 is a front view of the chewable children's toy of FIG. 1 mounted on a decorative stem via the through-hole; and, FIG. 9 is a front view of the chewable children's toy of FIG. 1 mounted on a necklace passing through the through-hole.

The broken lines shown in the figures of the drawing are for the purposes of illustrating items to which the chewable children's toy may attach and form no part of the claim.

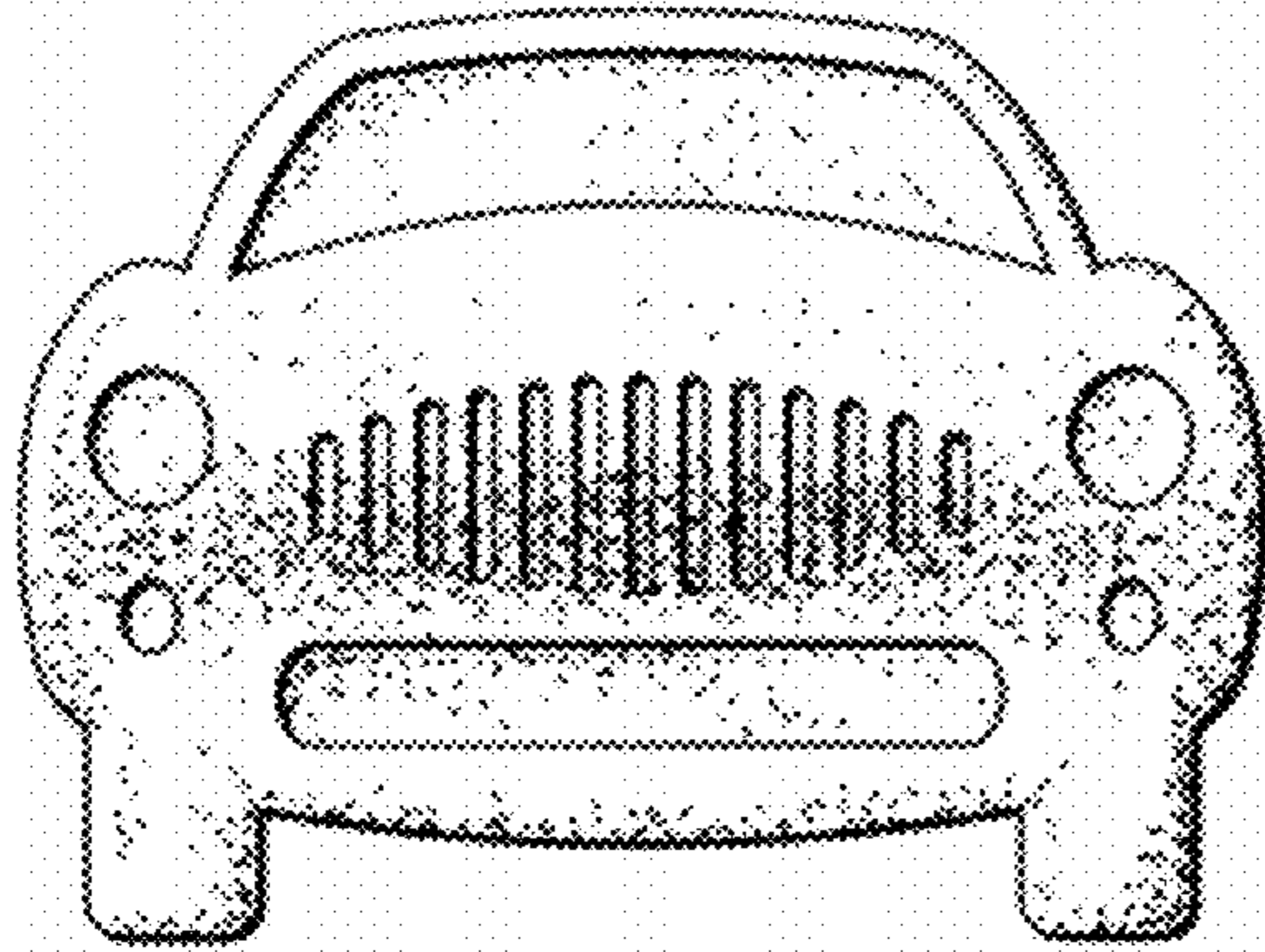

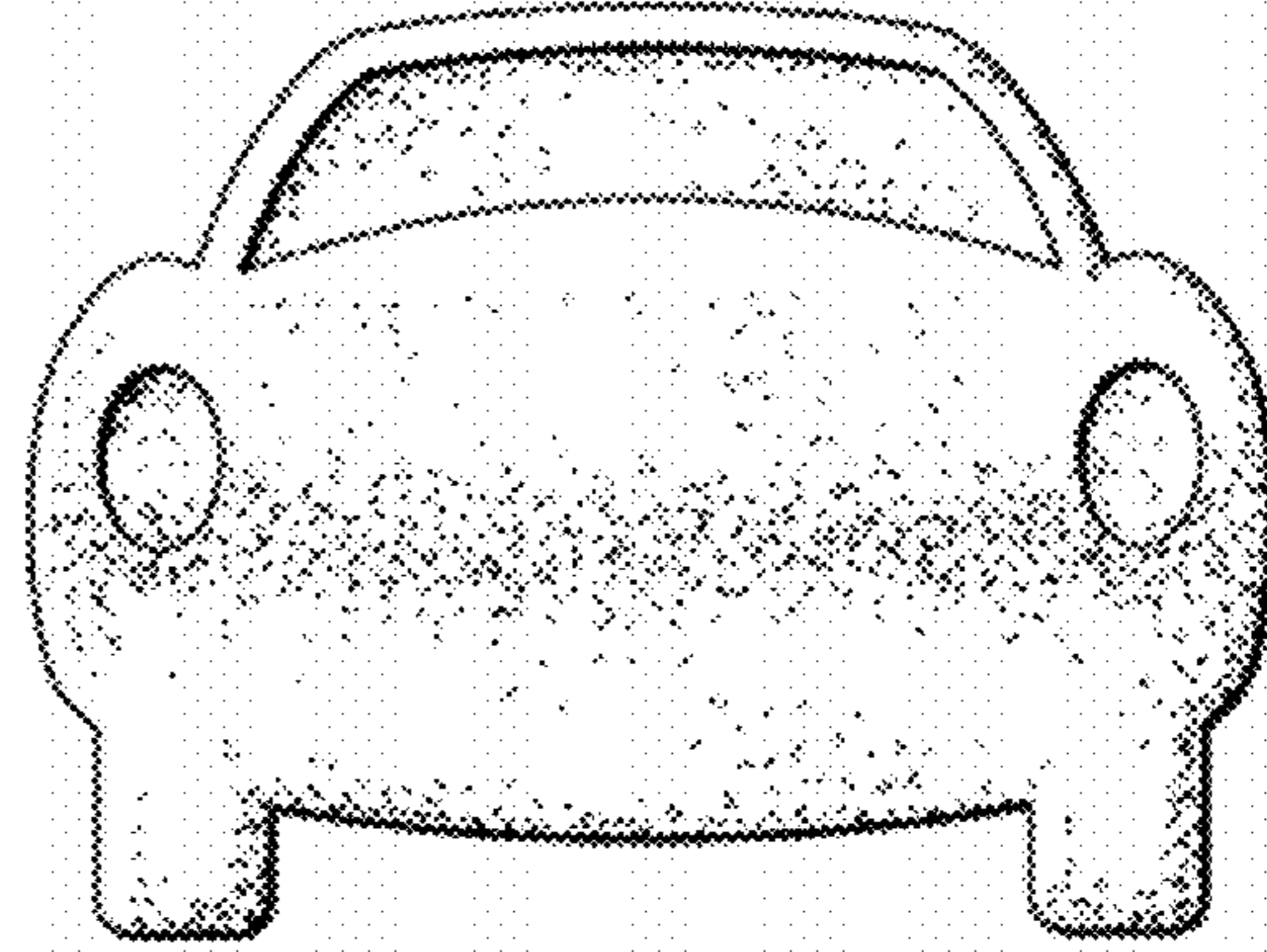

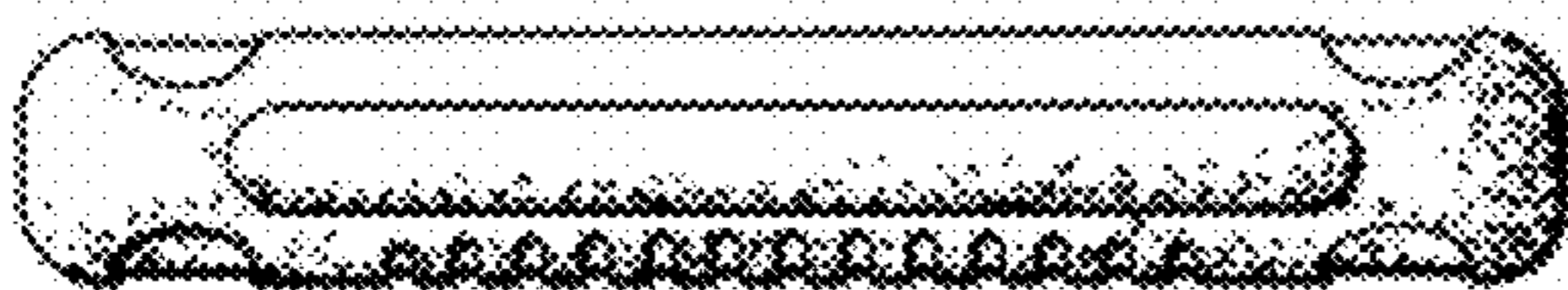

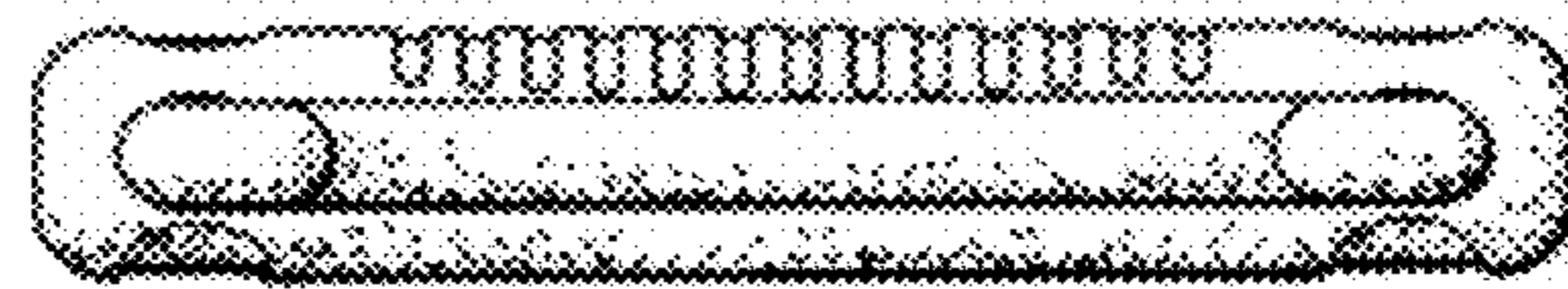

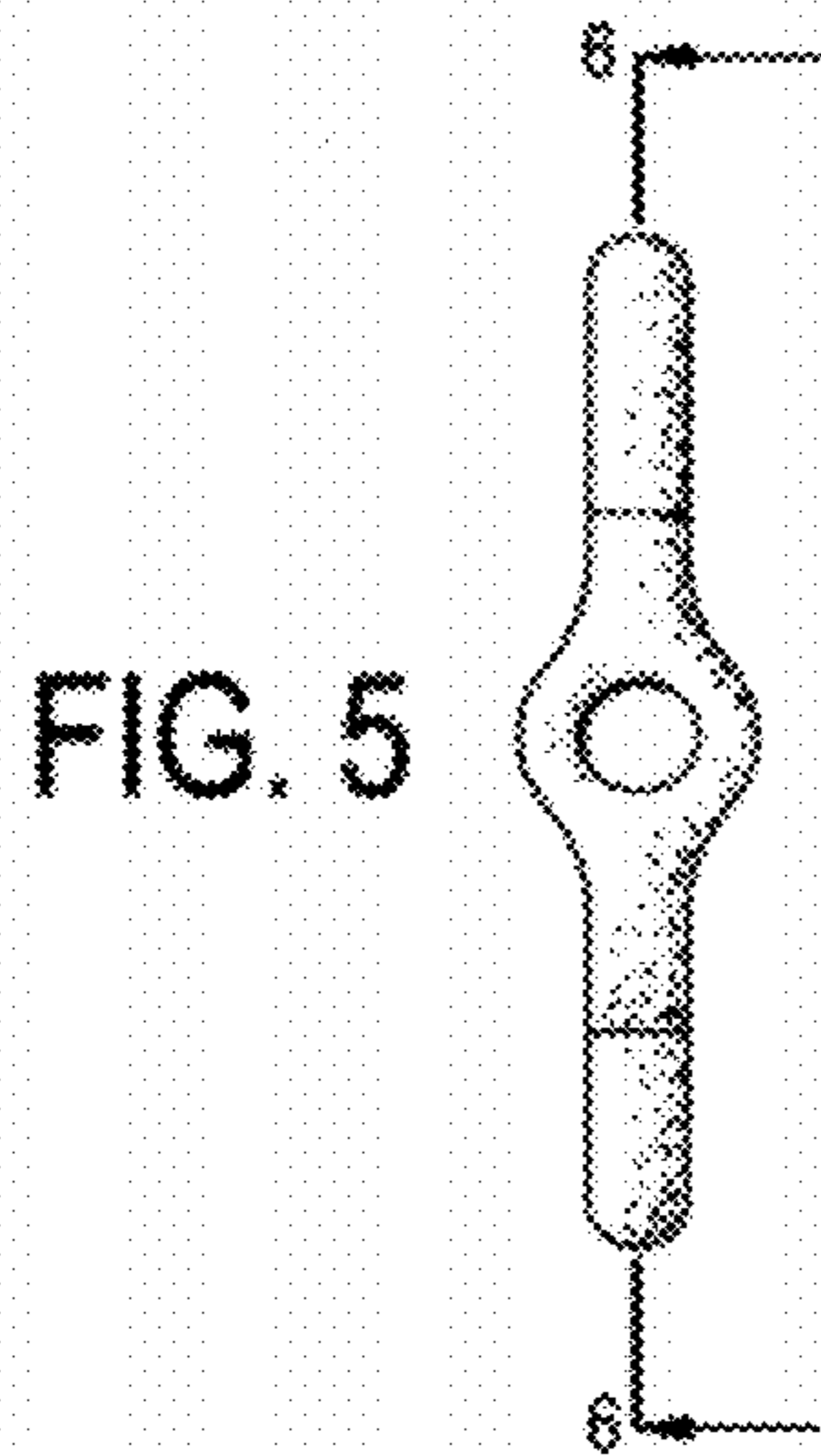

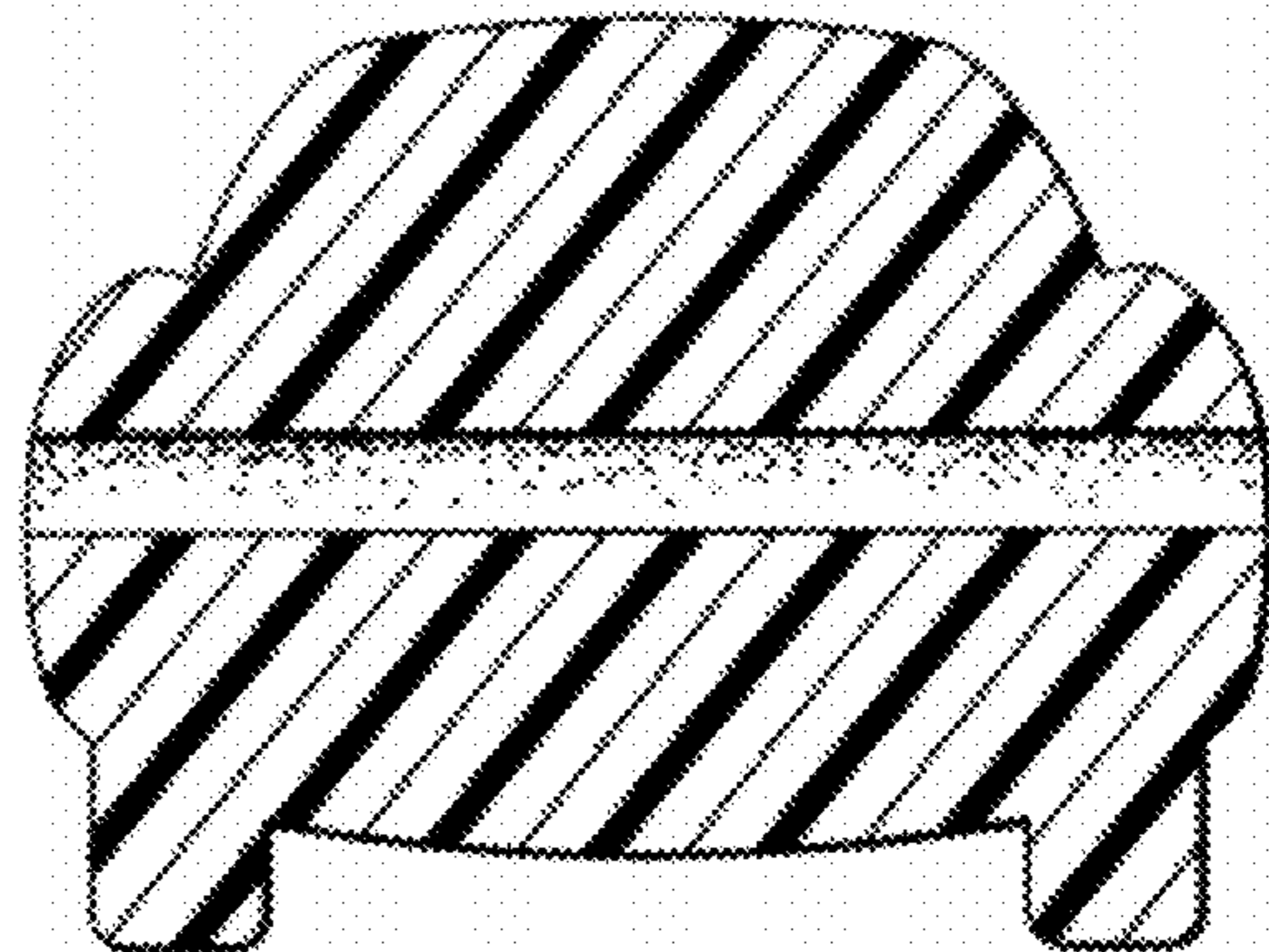

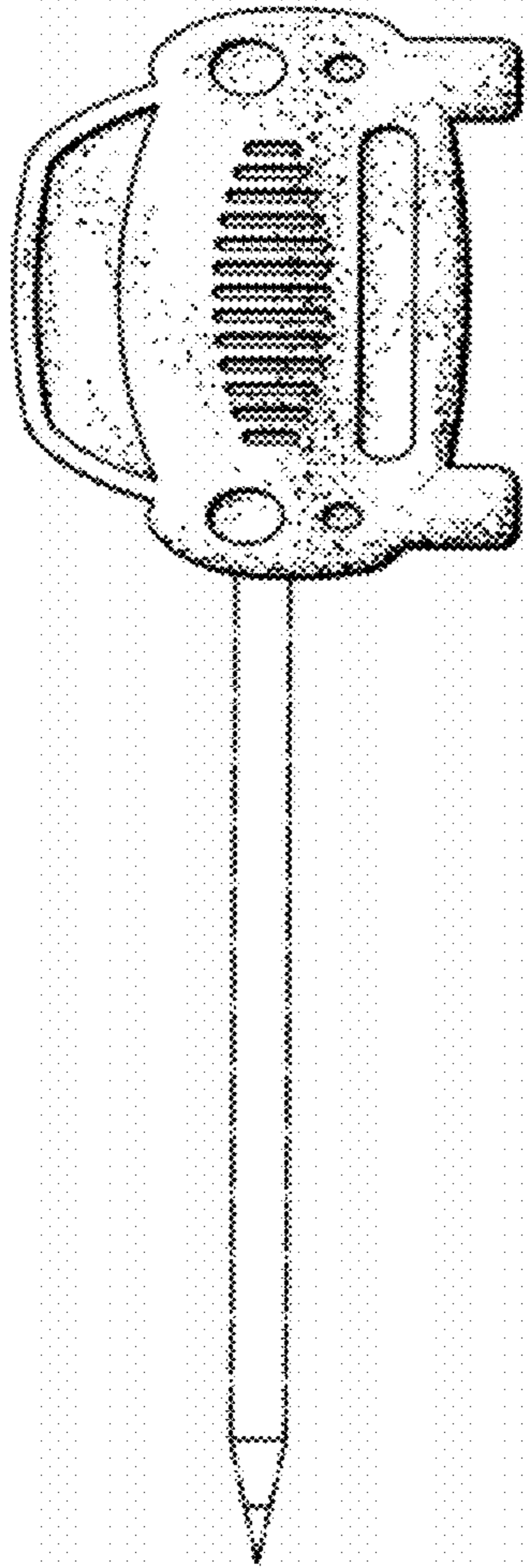

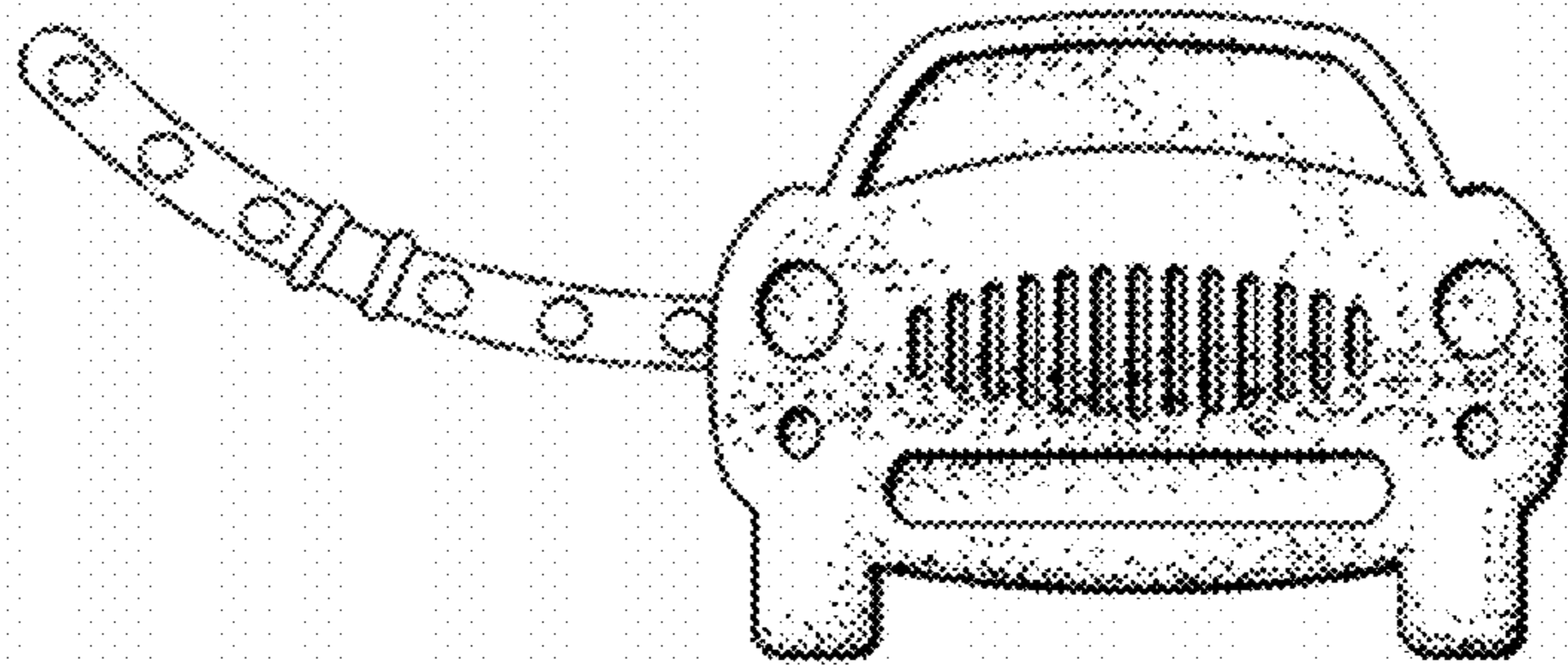

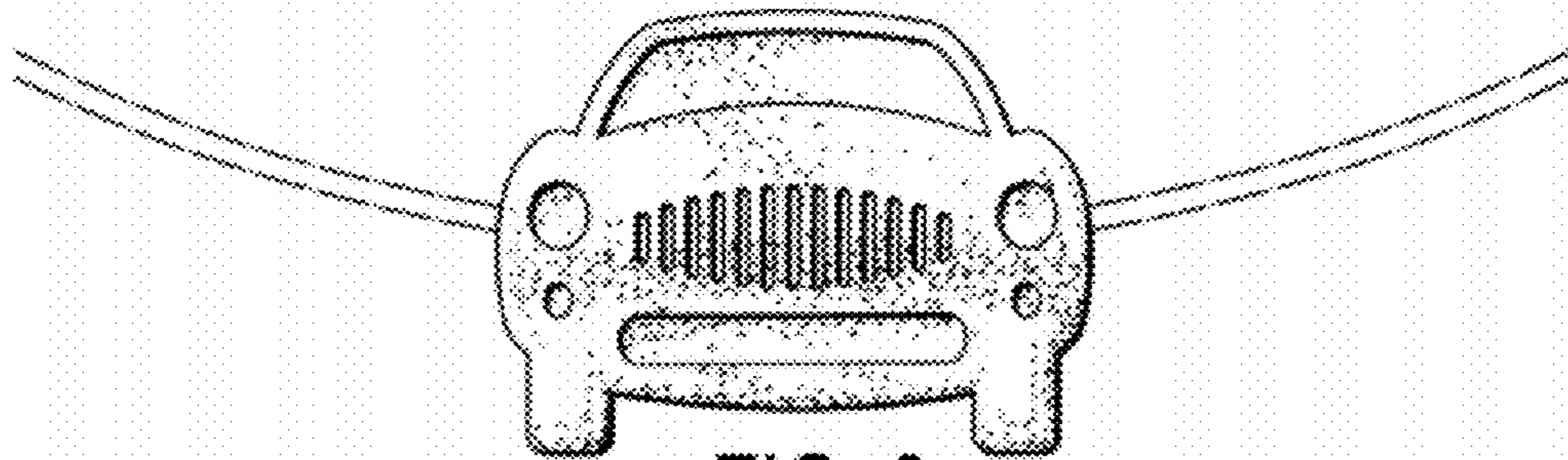
