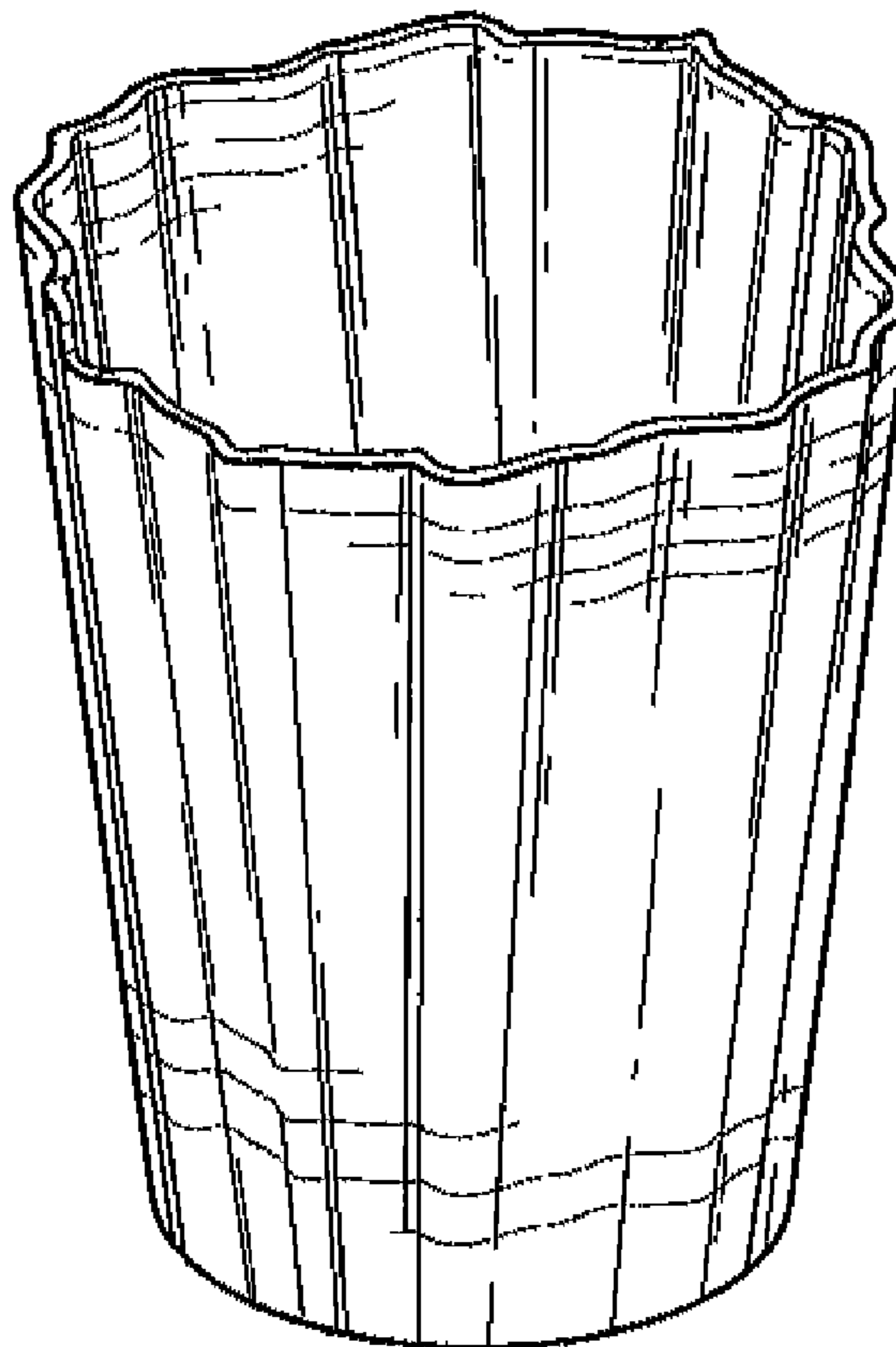
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a trash can showing our new design;
FIG. 2 is a bottom perspective view thereof;
FIG. 3 is a top view thereof;
FIG. 4 is a first side view thereof, the opposite side being a mirror image of the side shown; and,
FIG. 5 is a second side view thereof, the opposite side being a mirror image of the side shown.

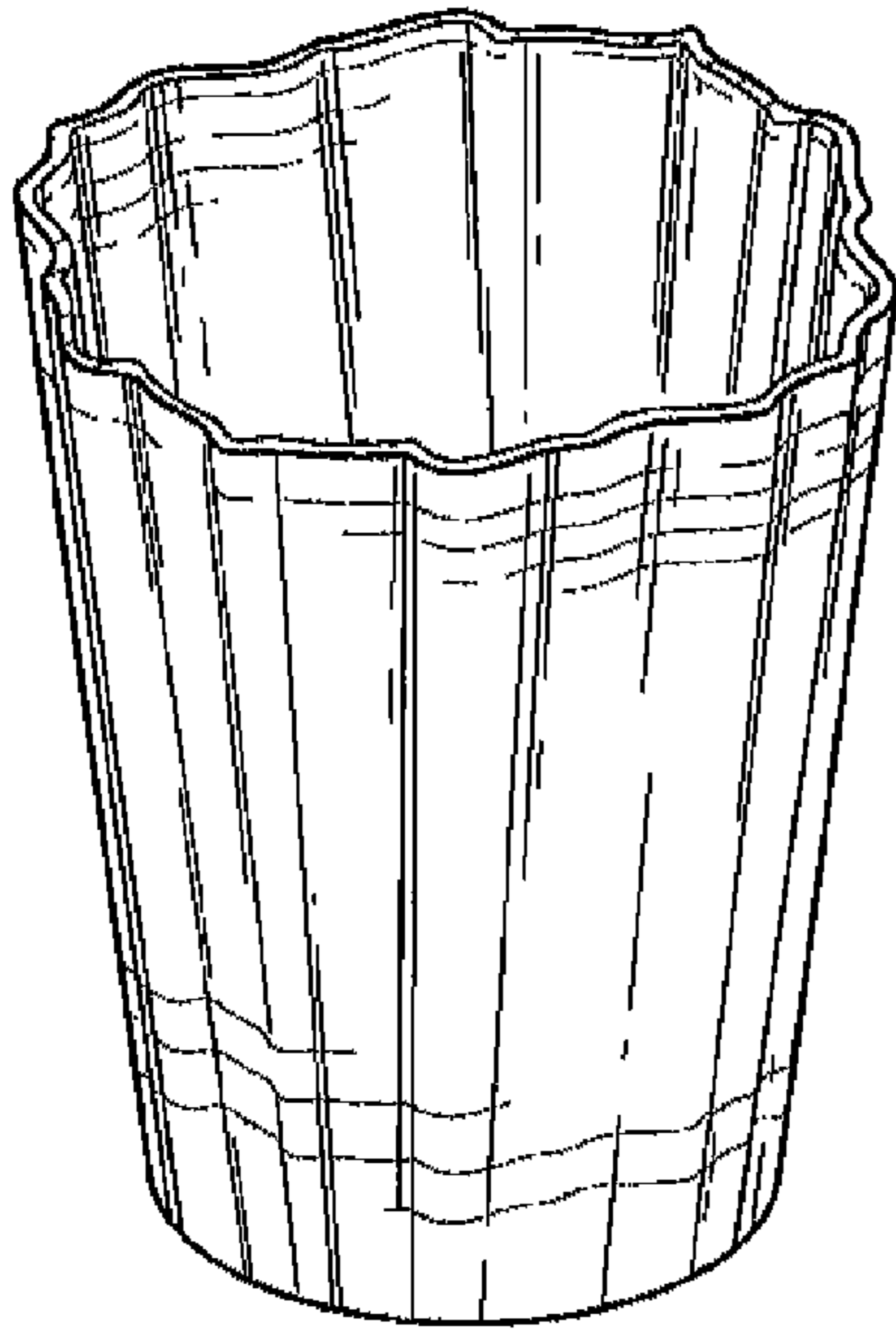

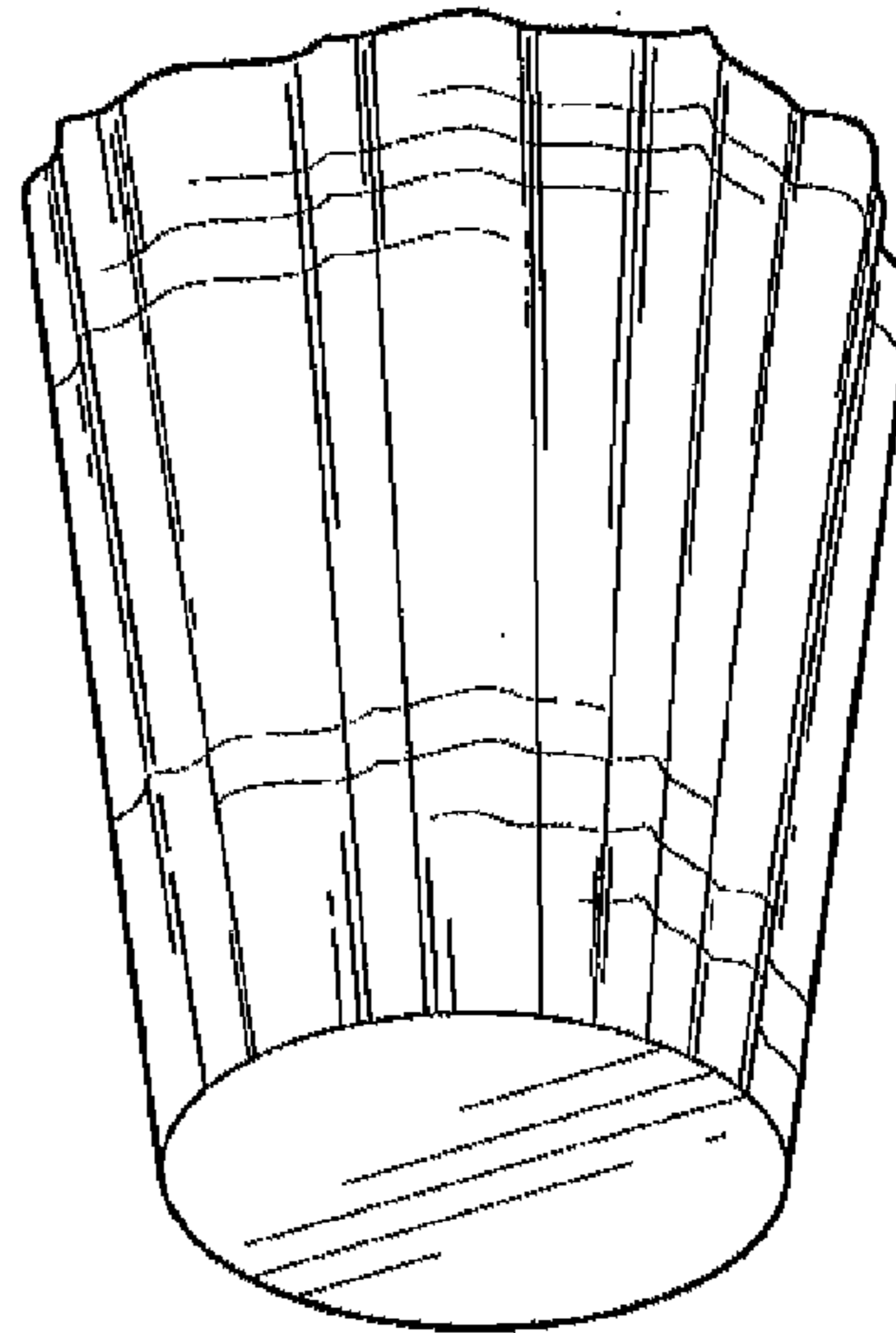

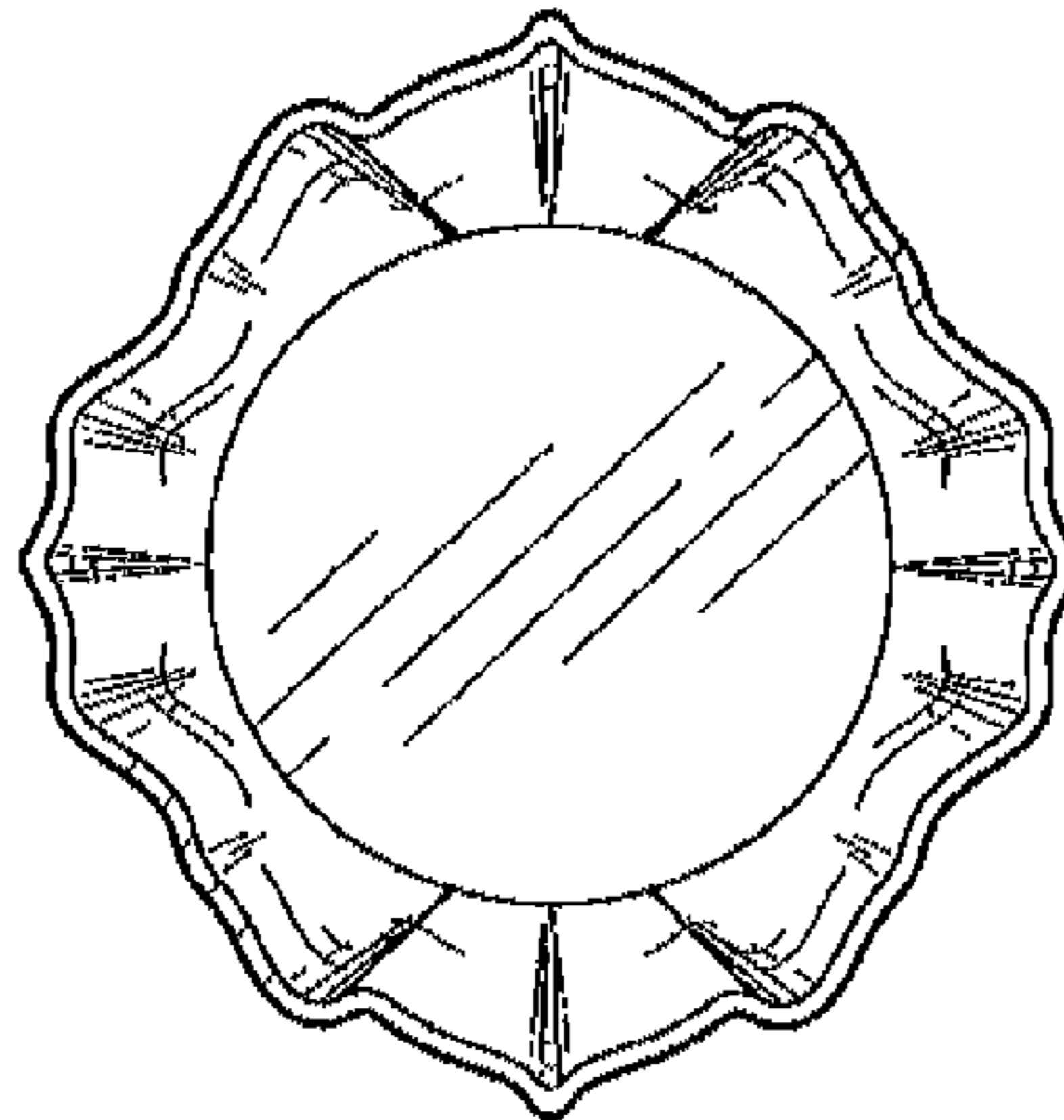

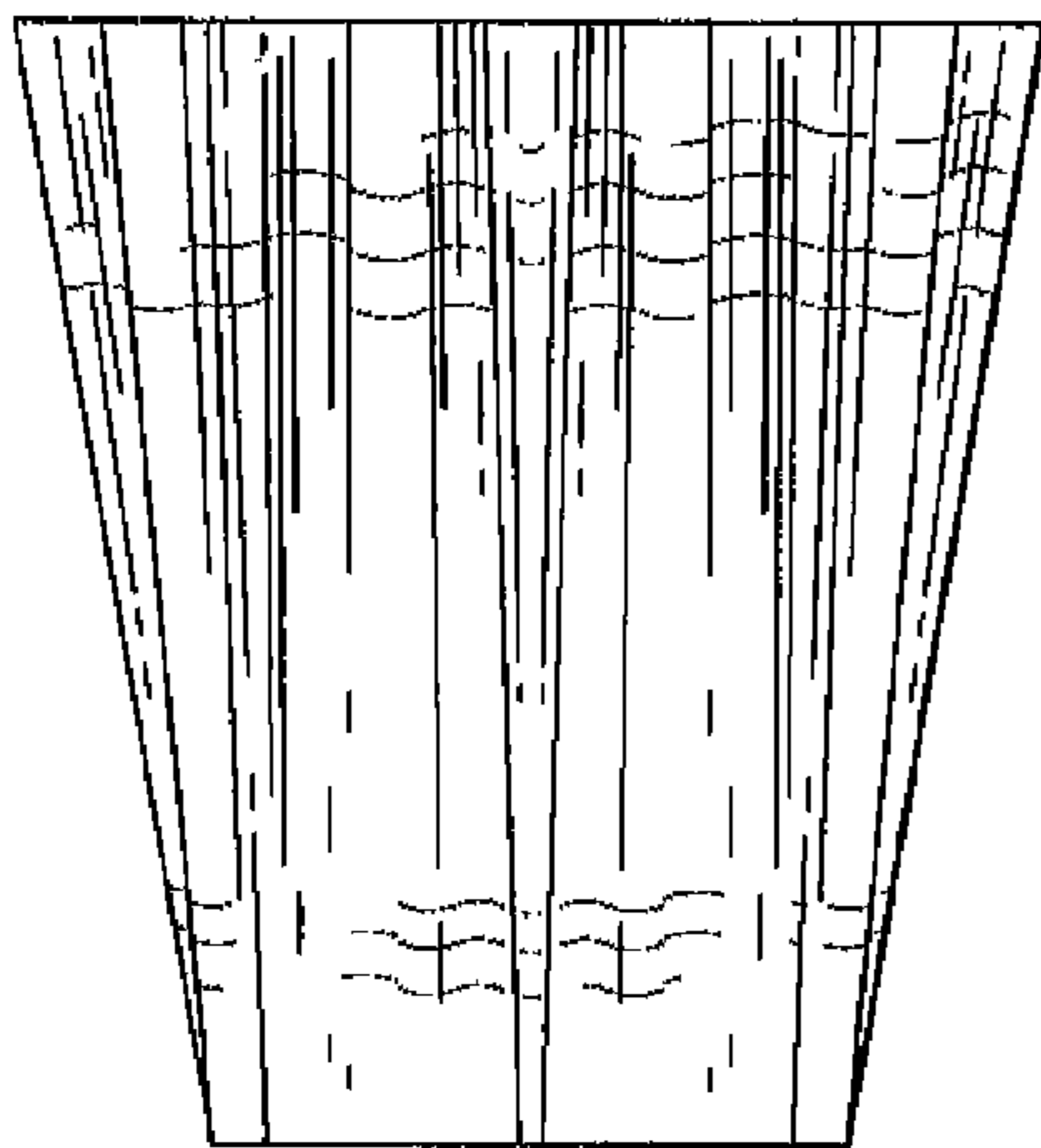

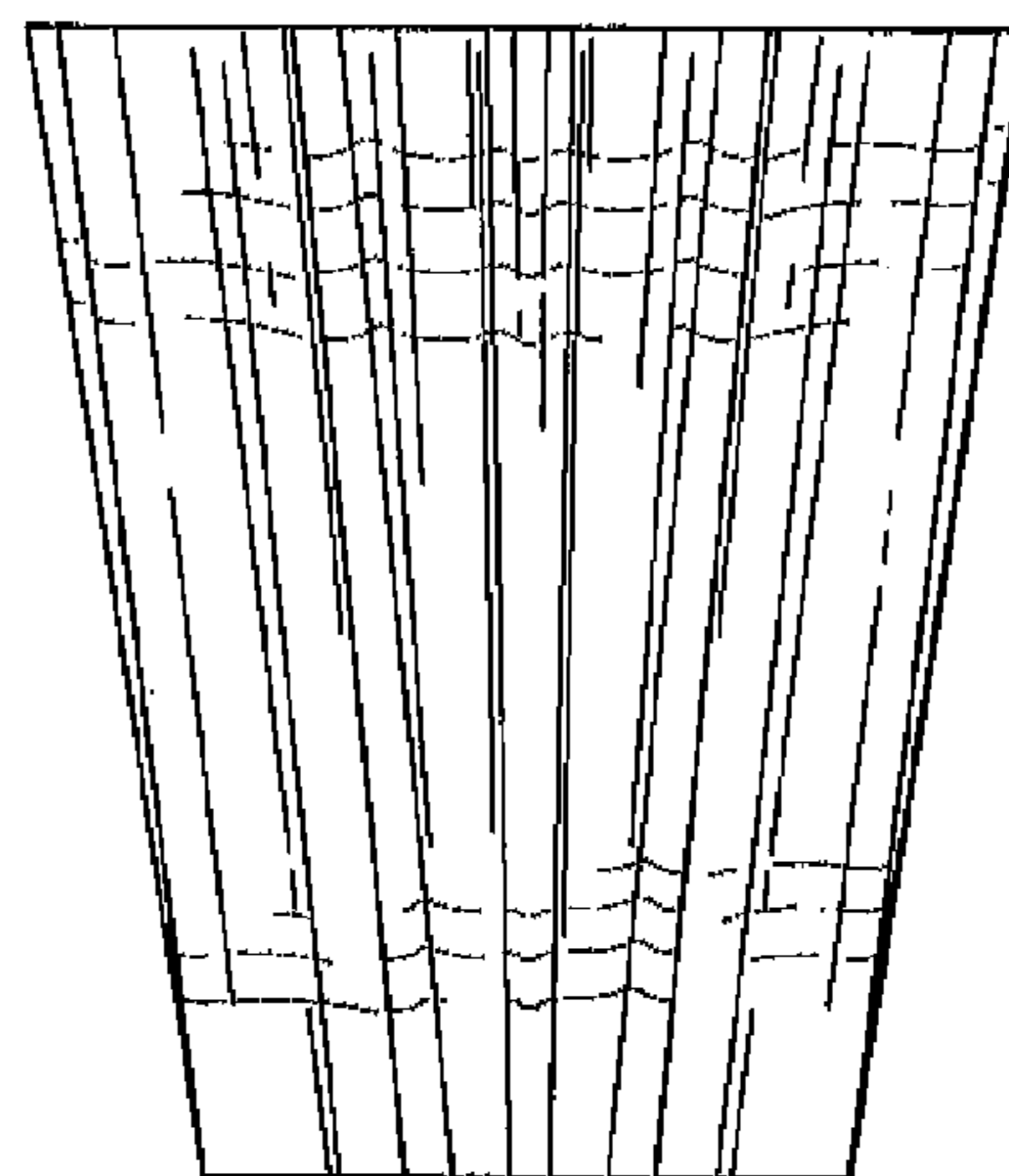
