The ornamental design for an athletic garment with integral sports bra, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of the invention, the outer jersey portion (connected to the shoulder straps of the sports bra portion) being shown in phantom lines as it forms no part of the claimed design.

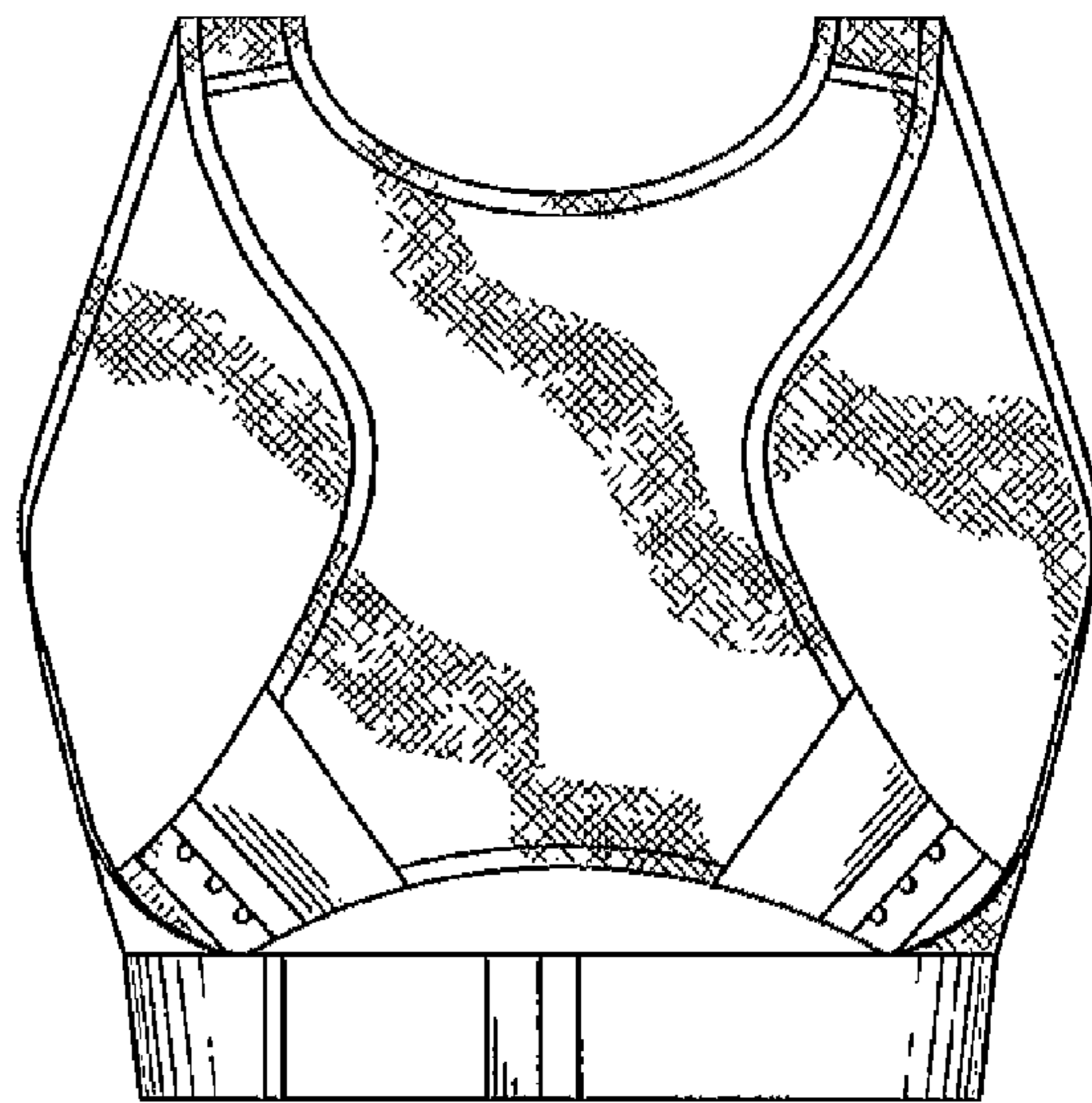
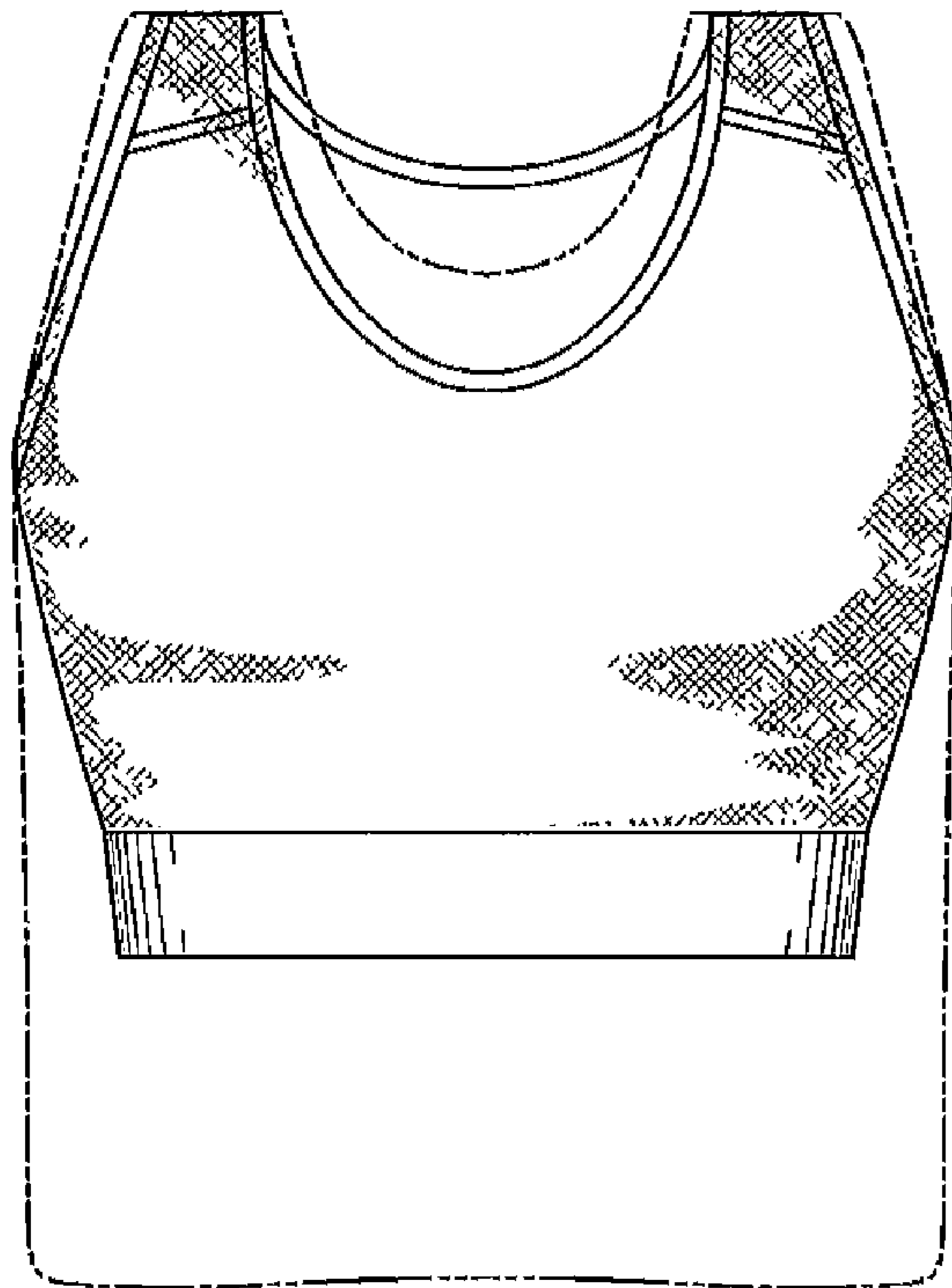
FIG. 2 is a rear elevation view.

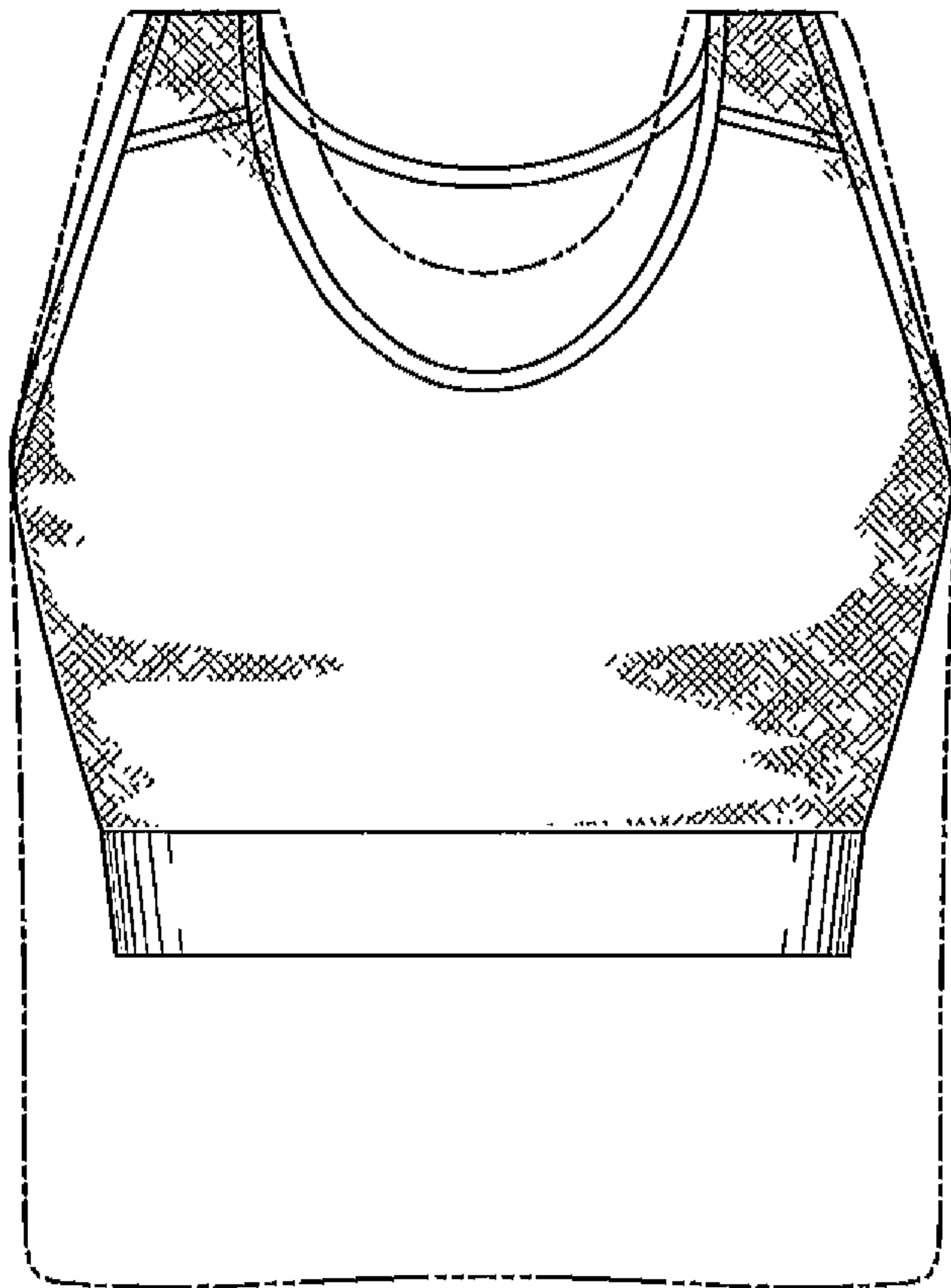

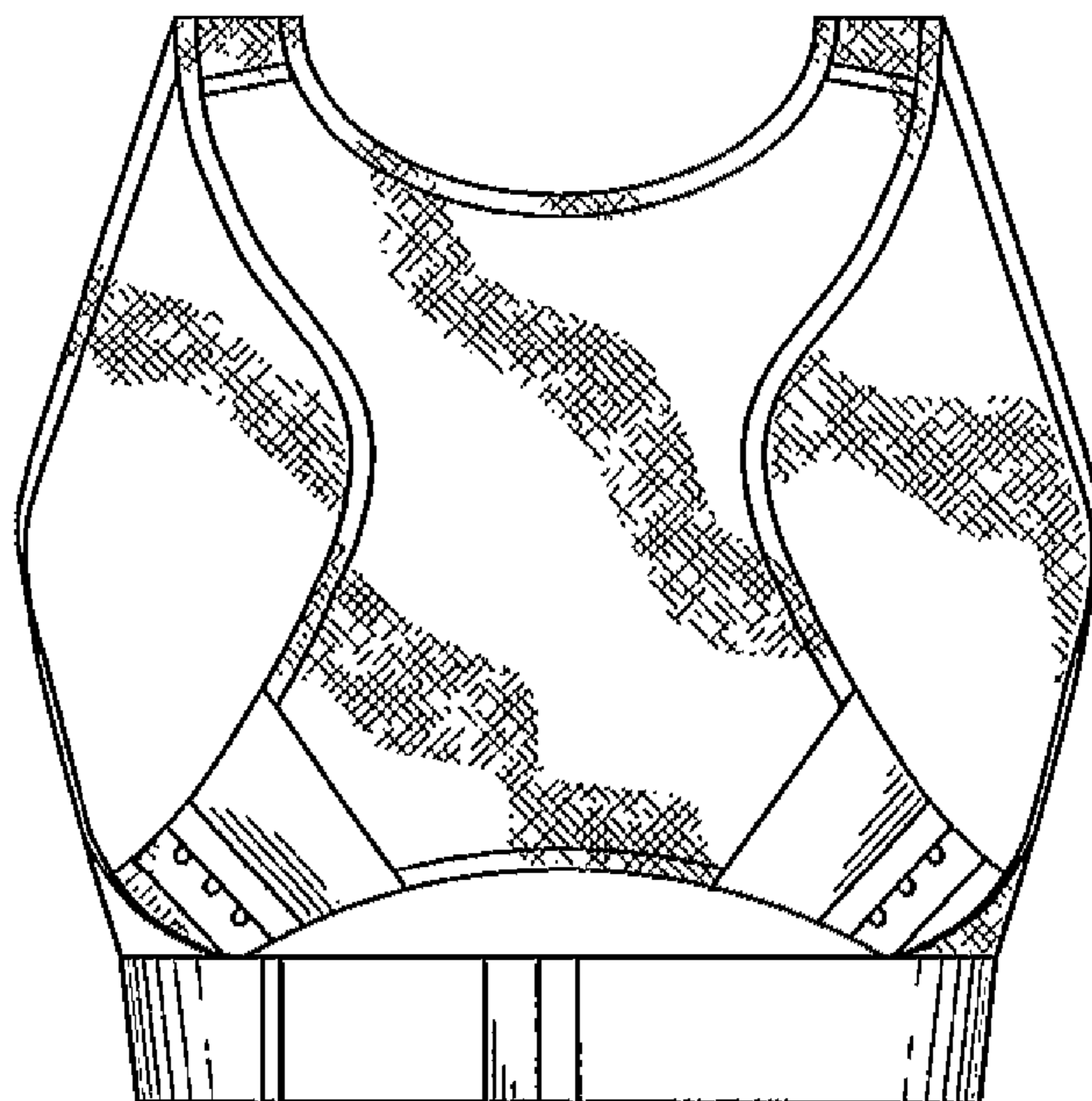

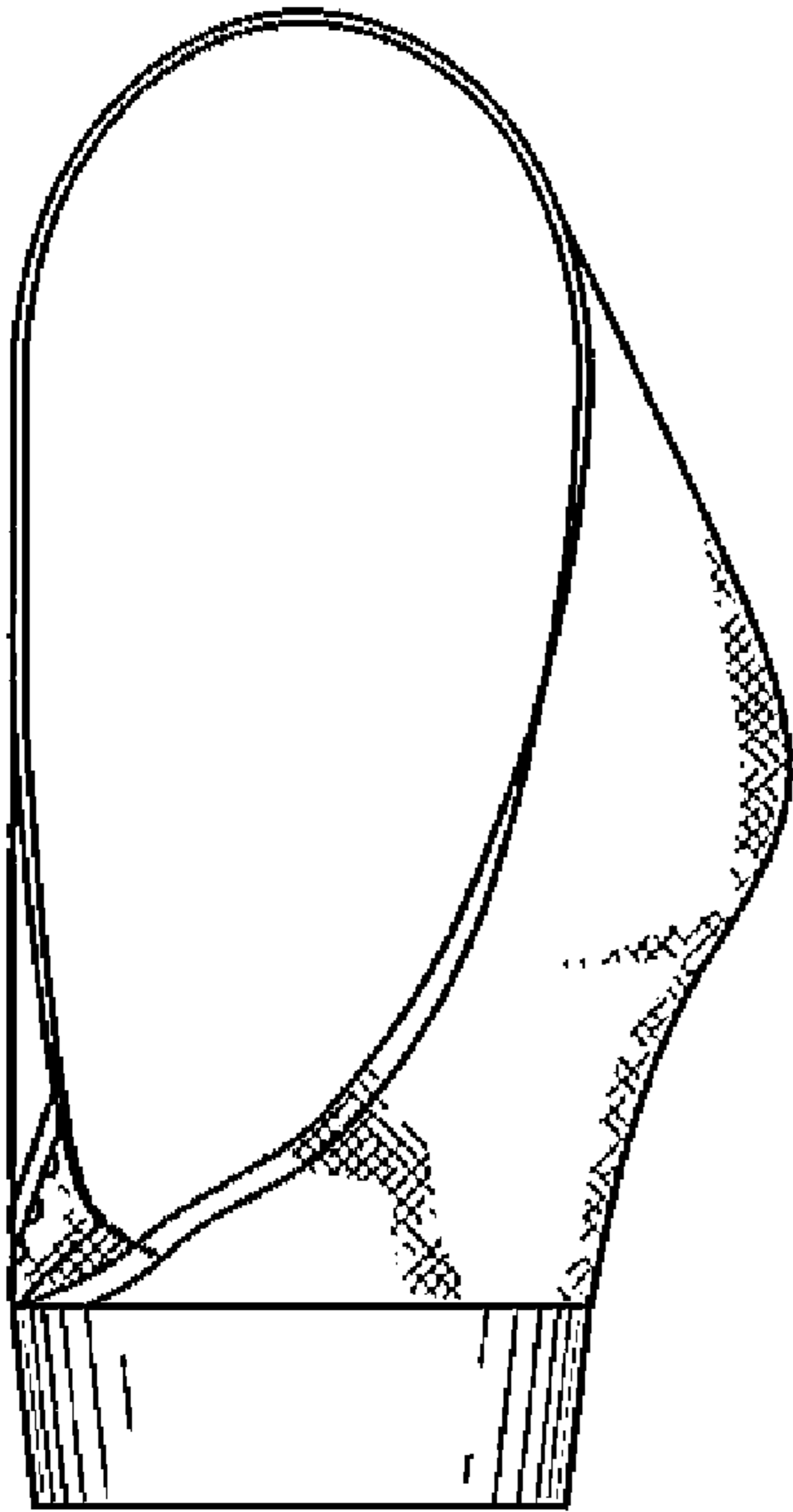

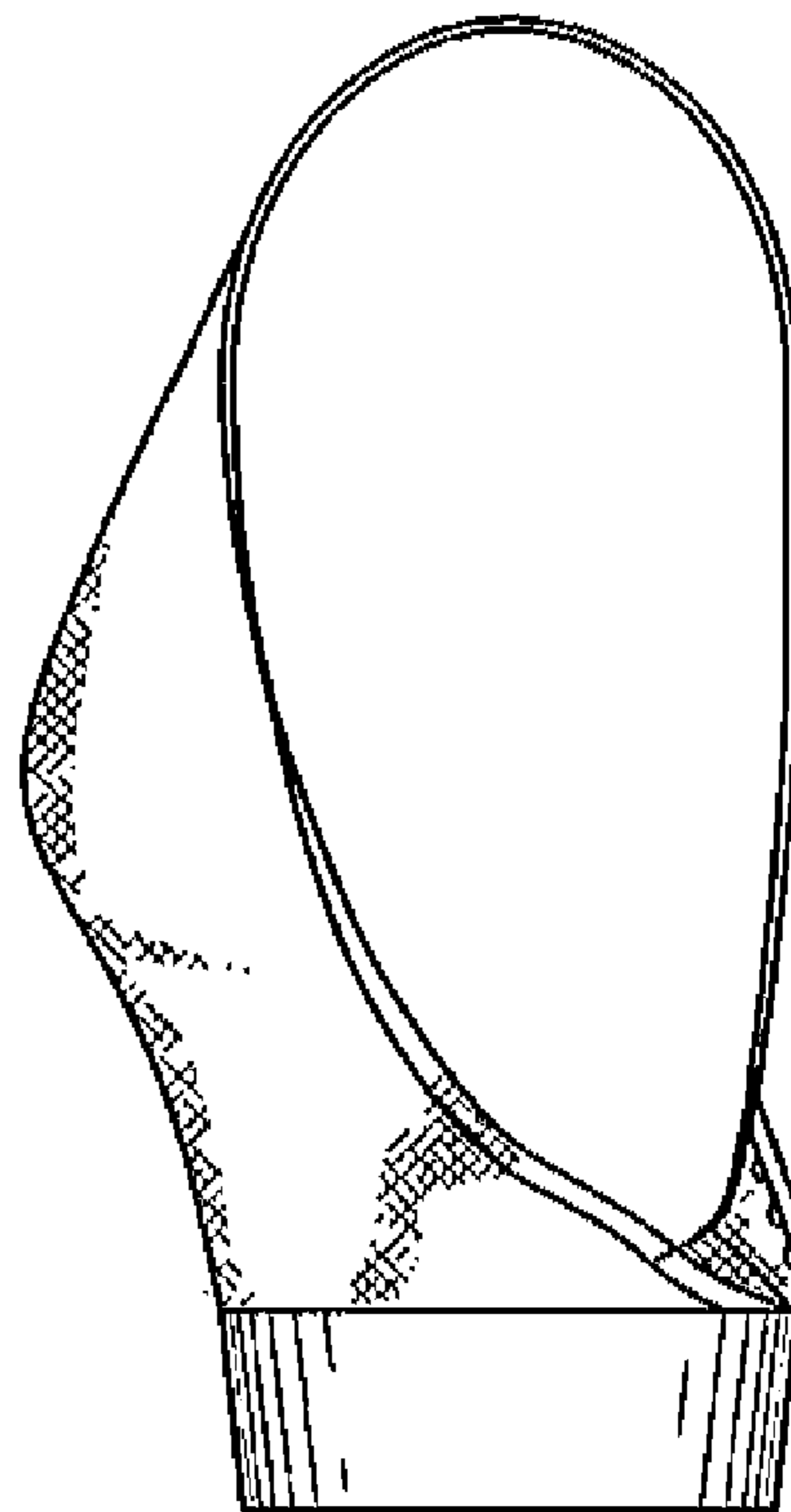

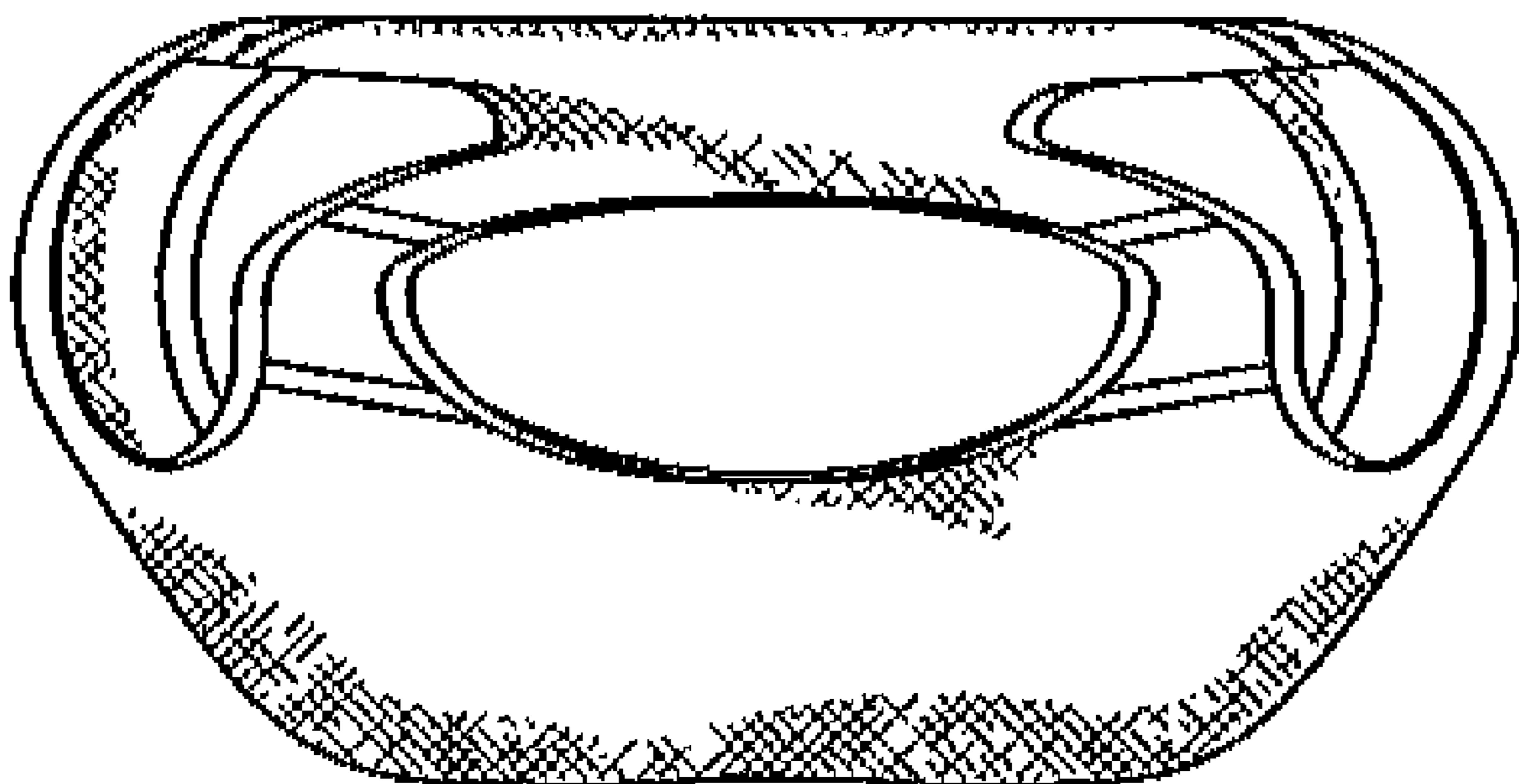
