The ornamental design for a shorts, as shown and described.

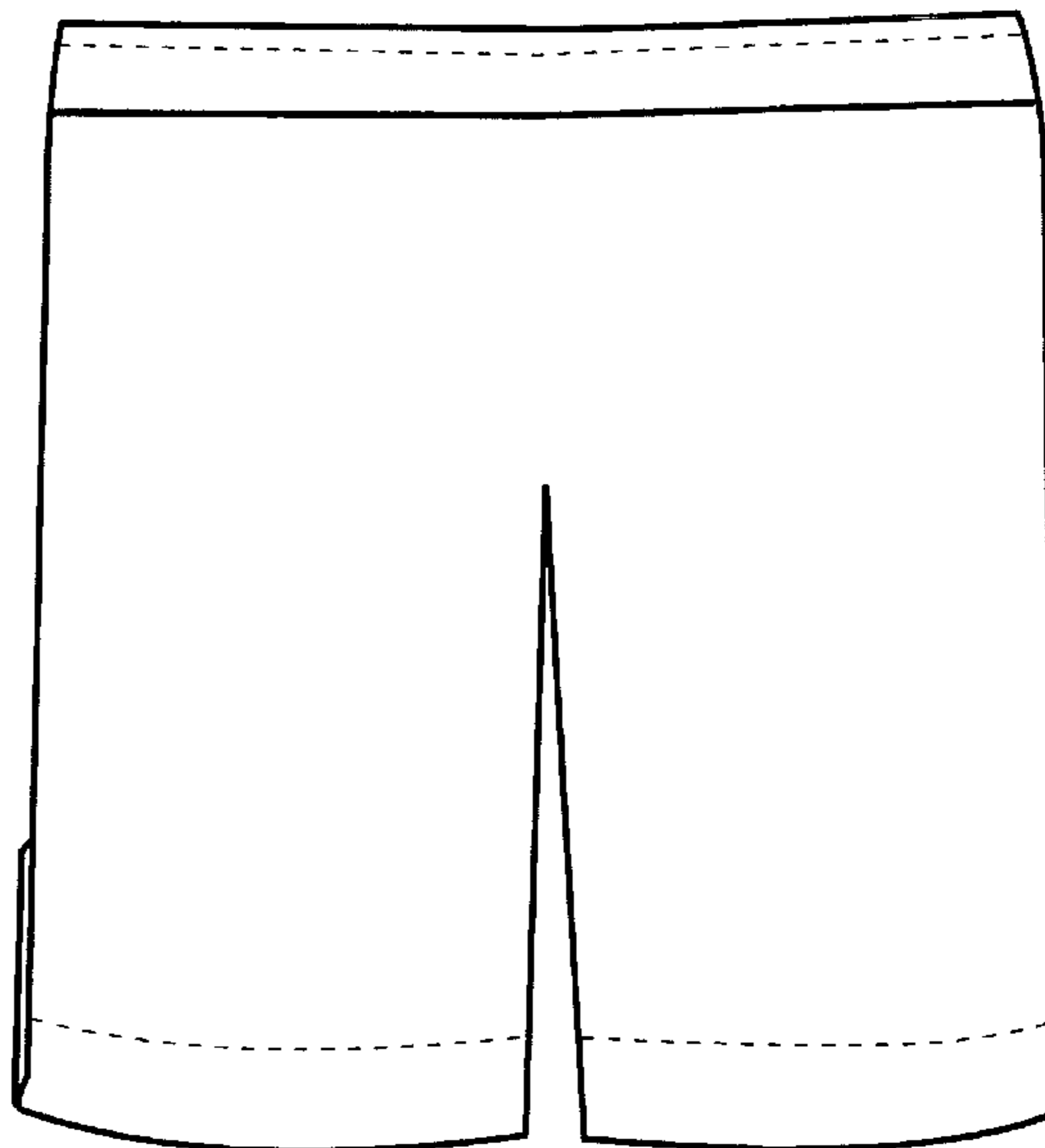
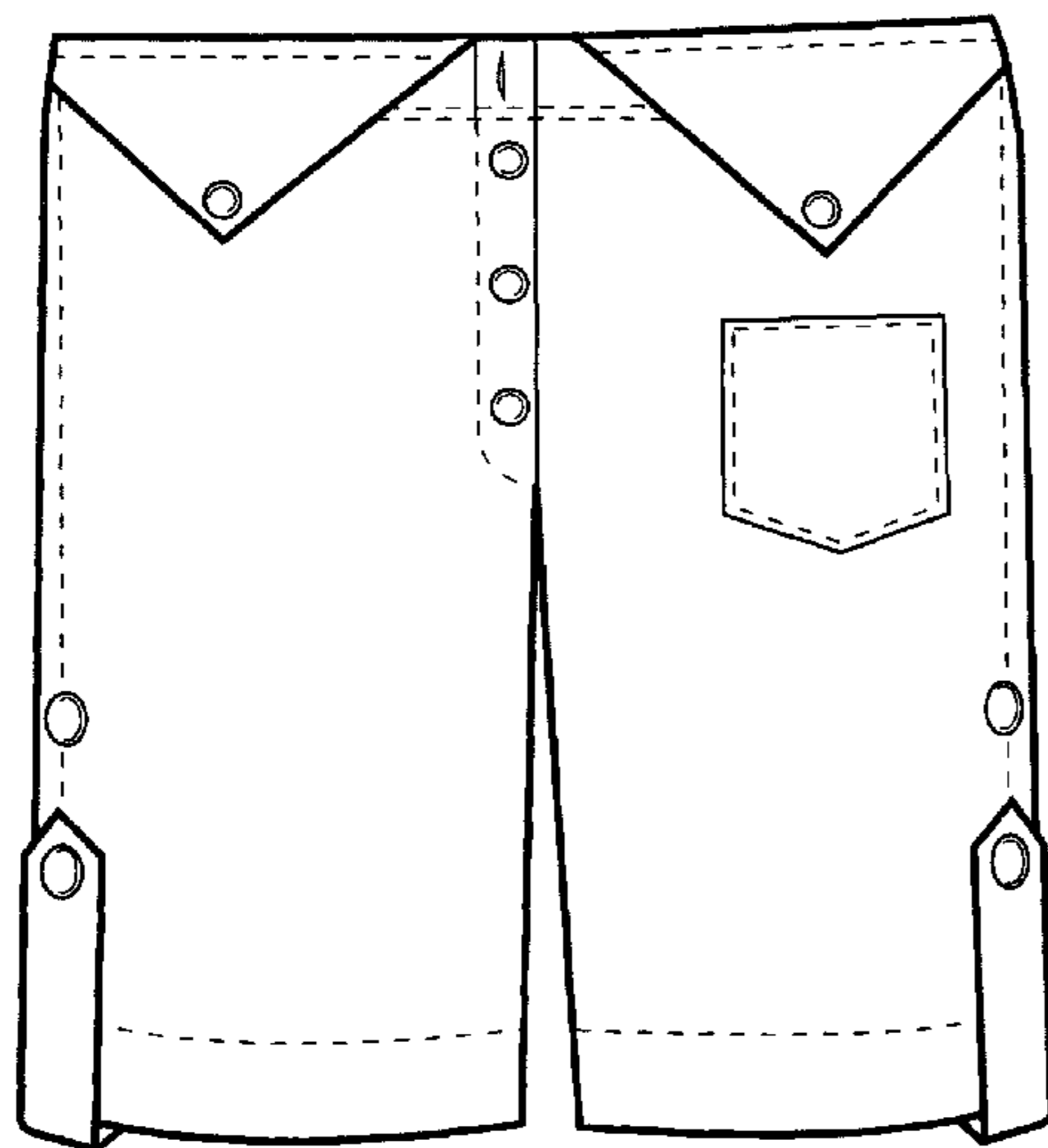
**DESCRIPTION**

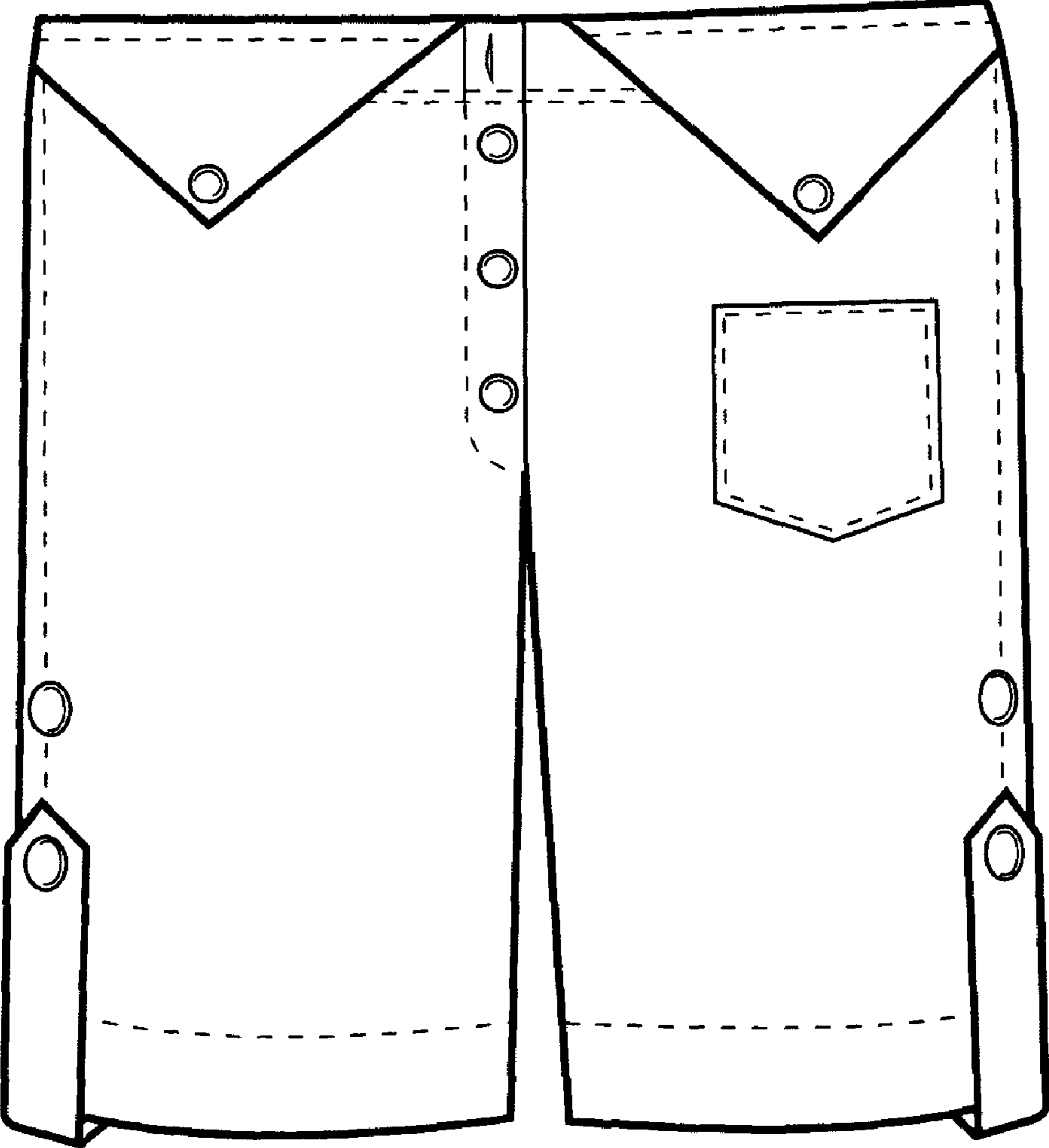
FIG. 1 is a front elevational view of a shorts showing our new design; and,

FIG. 2 is a rear elevational view thereof;

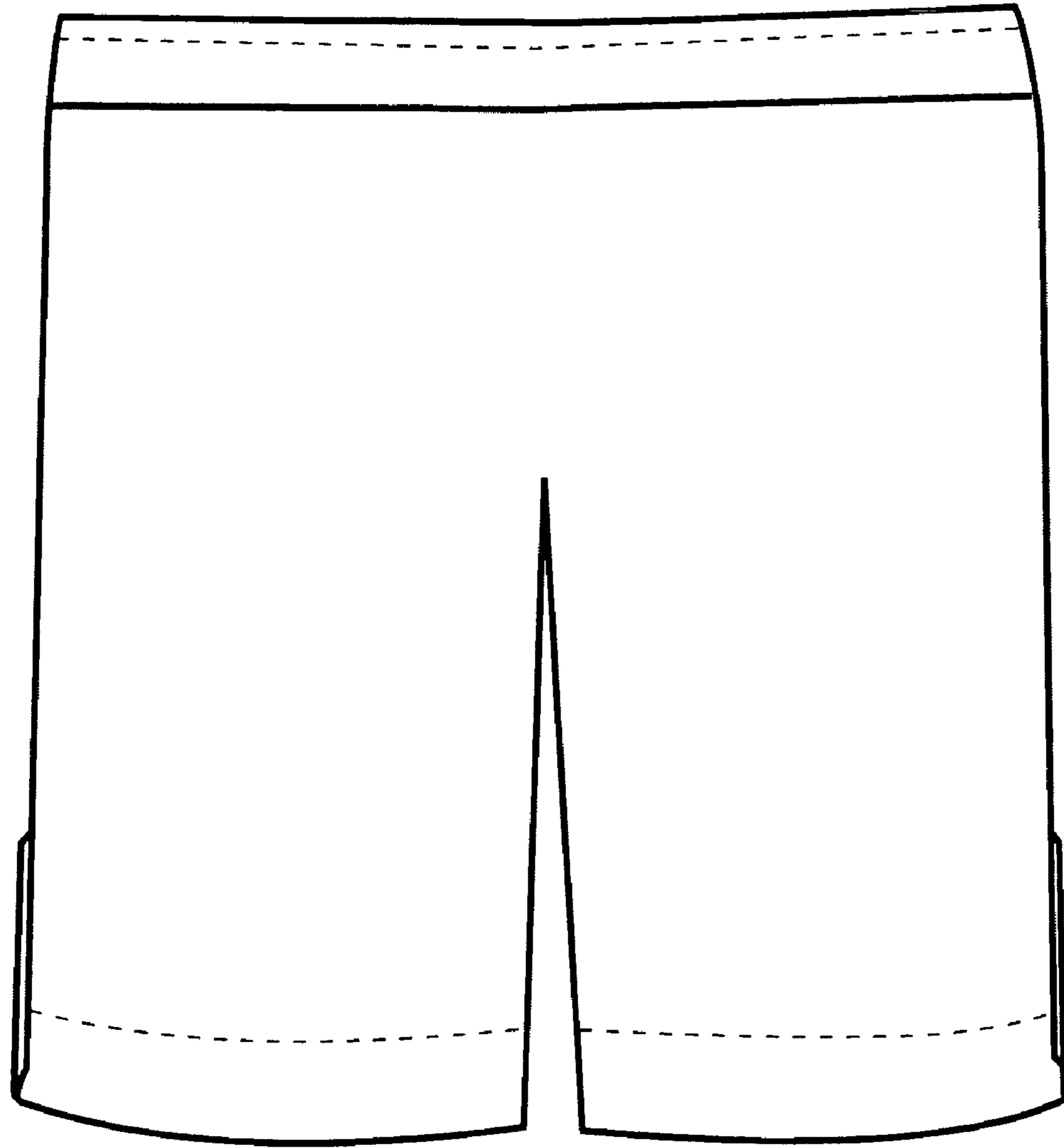
It is to be understood that any portion of any figure shown in broken lines illustrate stitching and forms a part of the claimed design.
