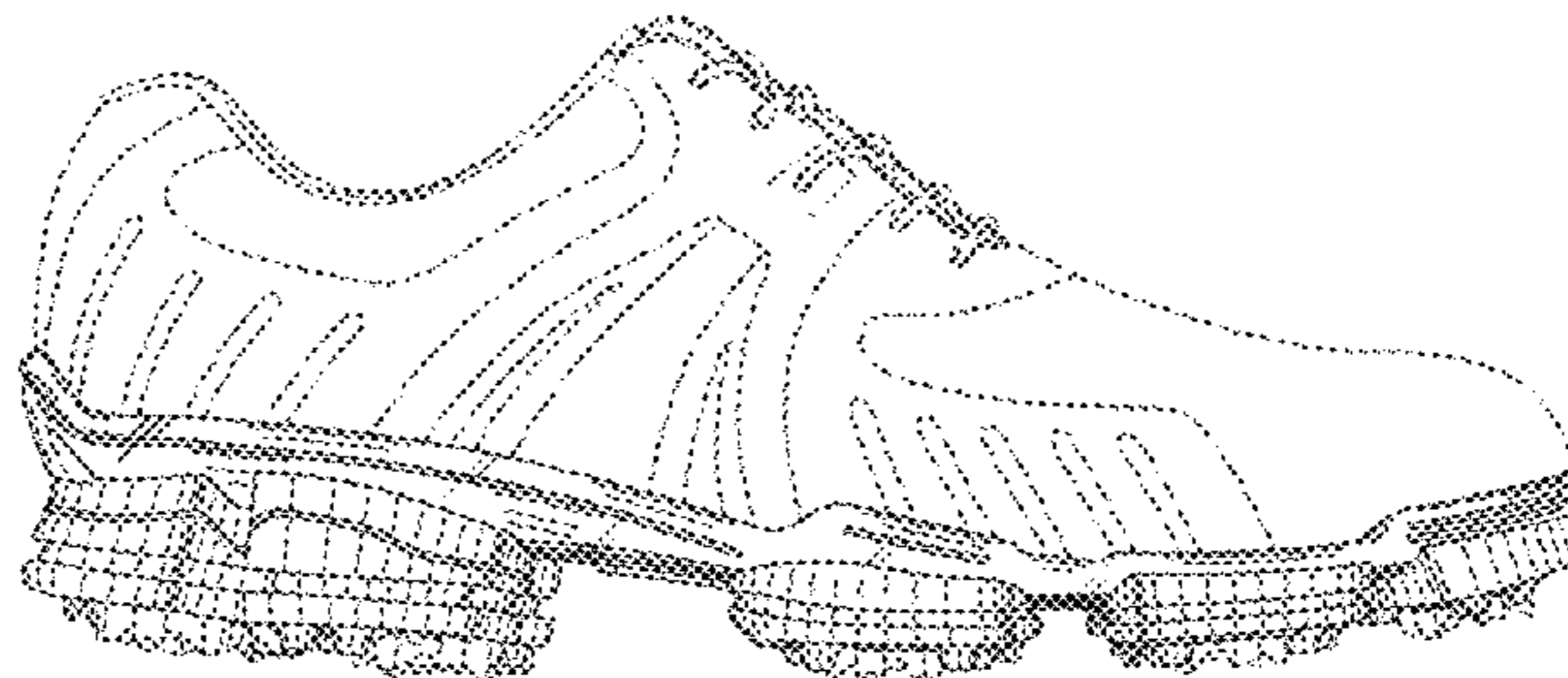
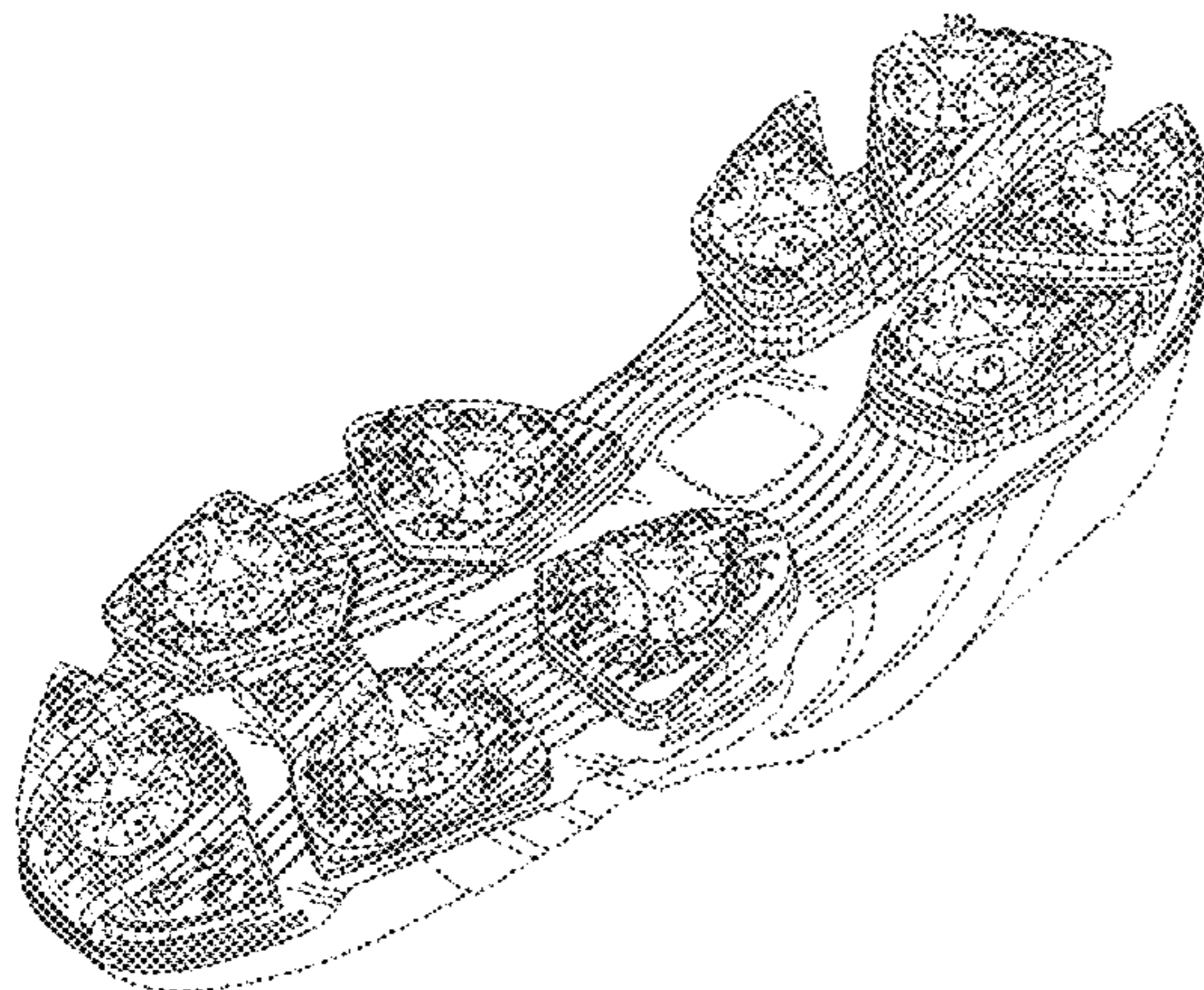
(57) **CLAIM**

The ornamental design for an outsole for a golf shoe, as shown and described.

DESCRIPTION

FIG. 1 is a bottom perspective view of an outsole for a golf shoe showing our new design; FIG. 2 is a left side elevational view thereof; FIG. 3 is a bottom plan view thereof; FIG. 4 is a right side elevational view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a rear elevational view thereof; and, FIG. 7 is a front elevational view thereof. The broken line showing a shoe upper in FIGS. 1-7 is for illustrative purposes only and represent the portions of the design that form no part of the claim.

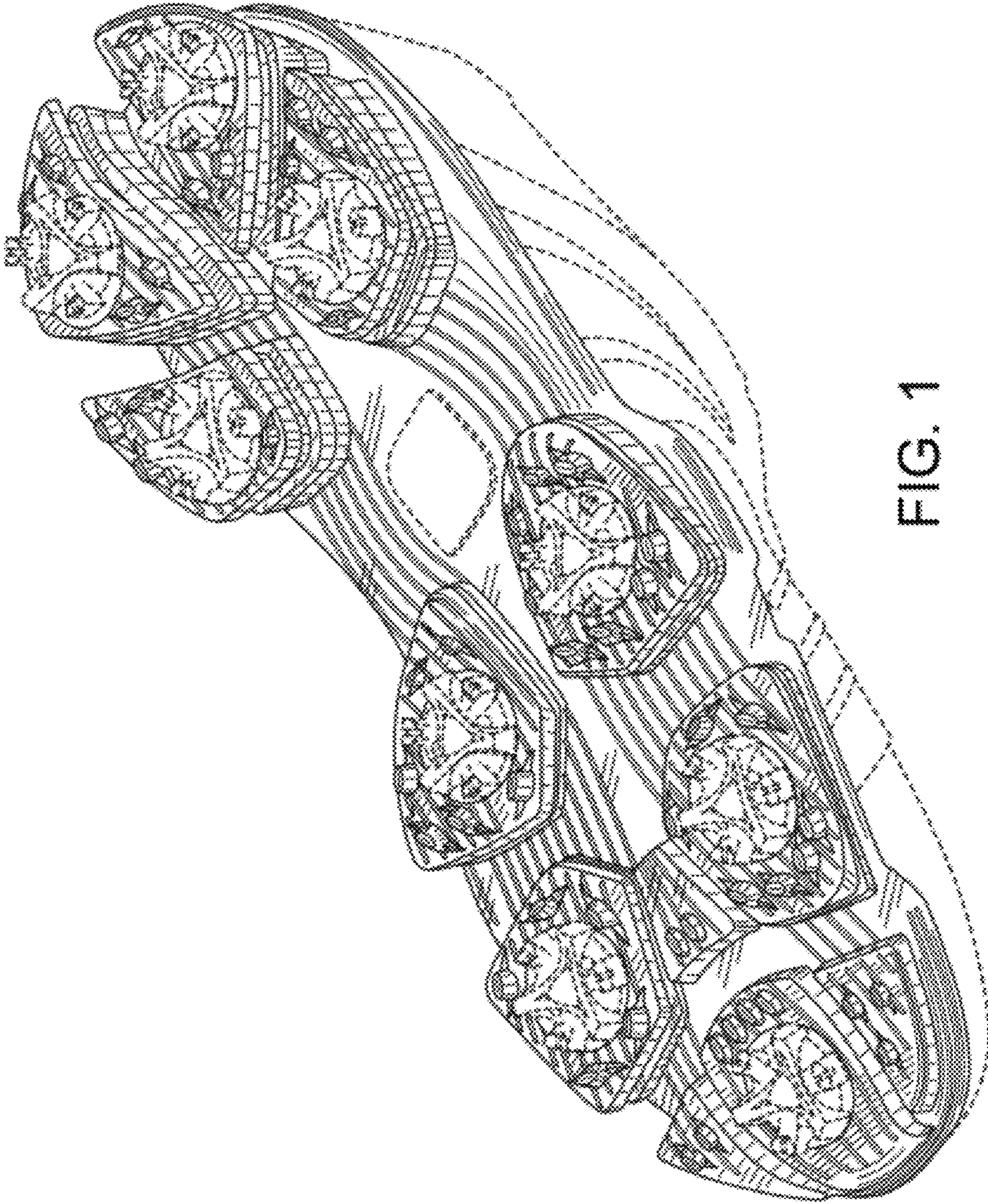

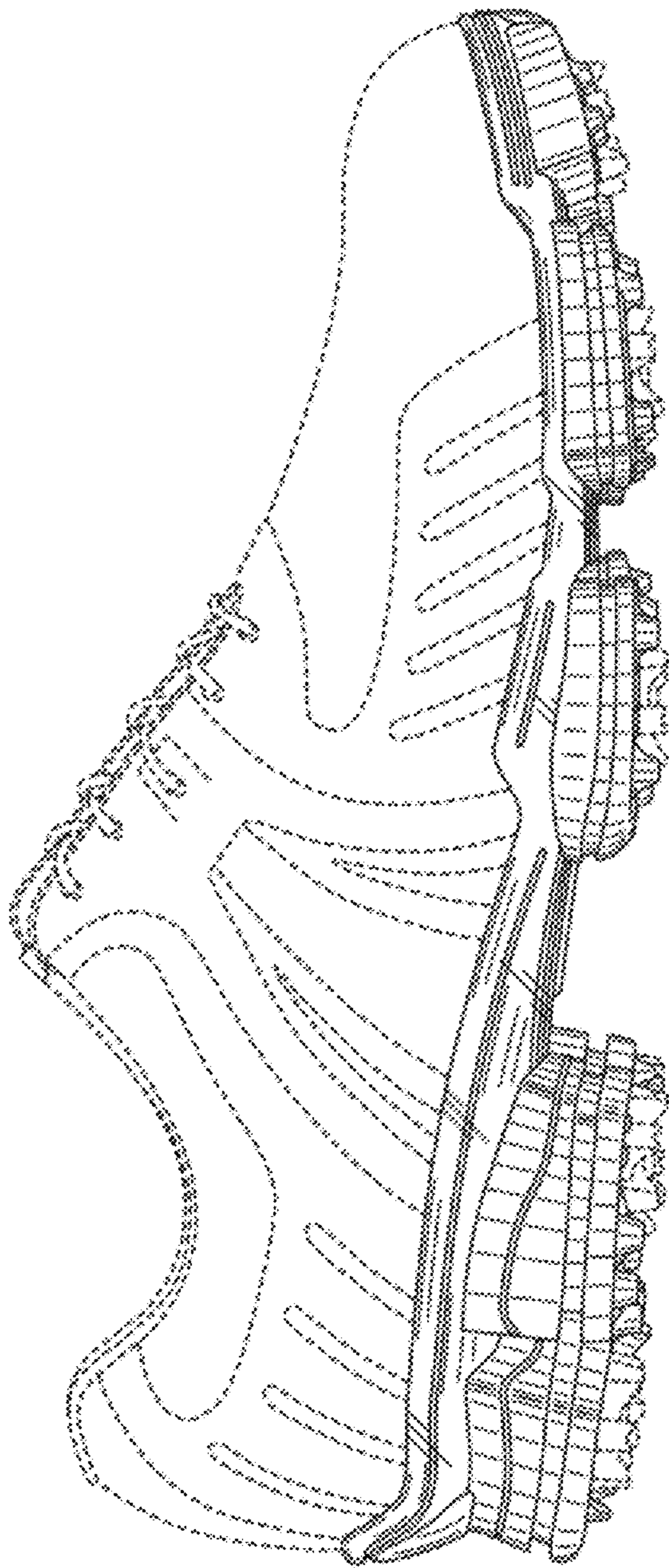

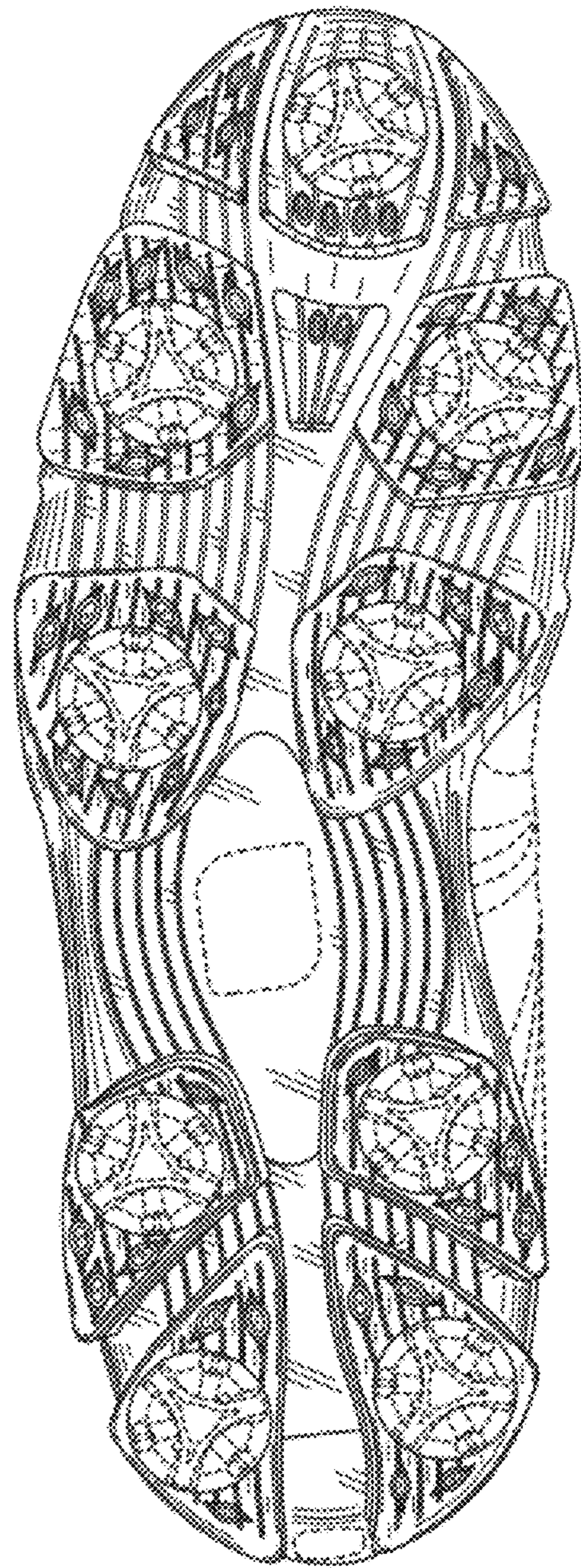

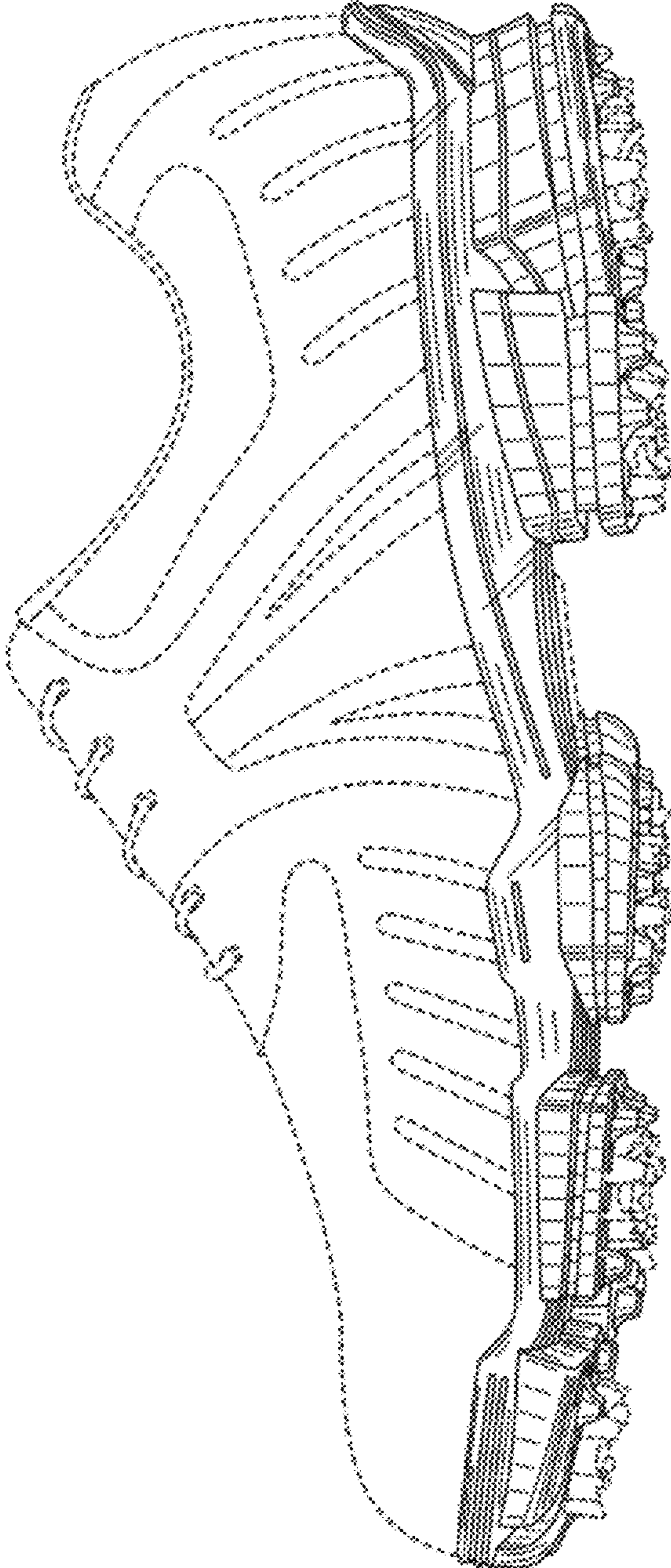
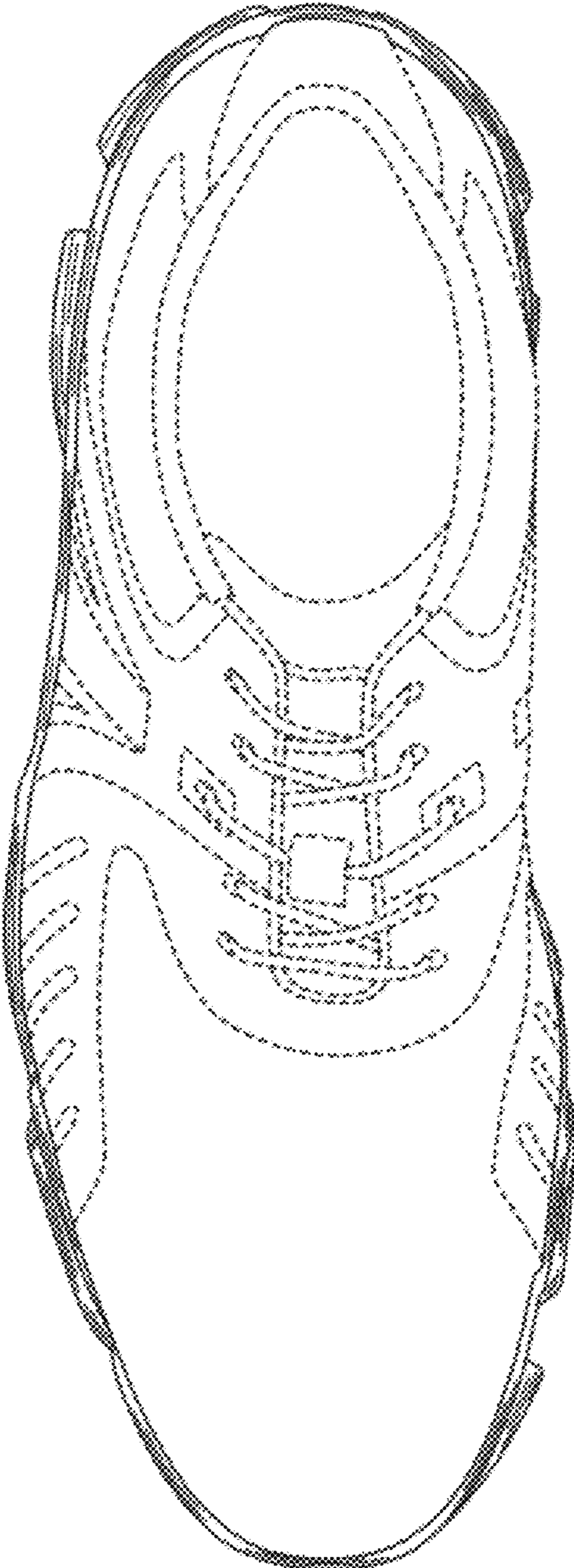

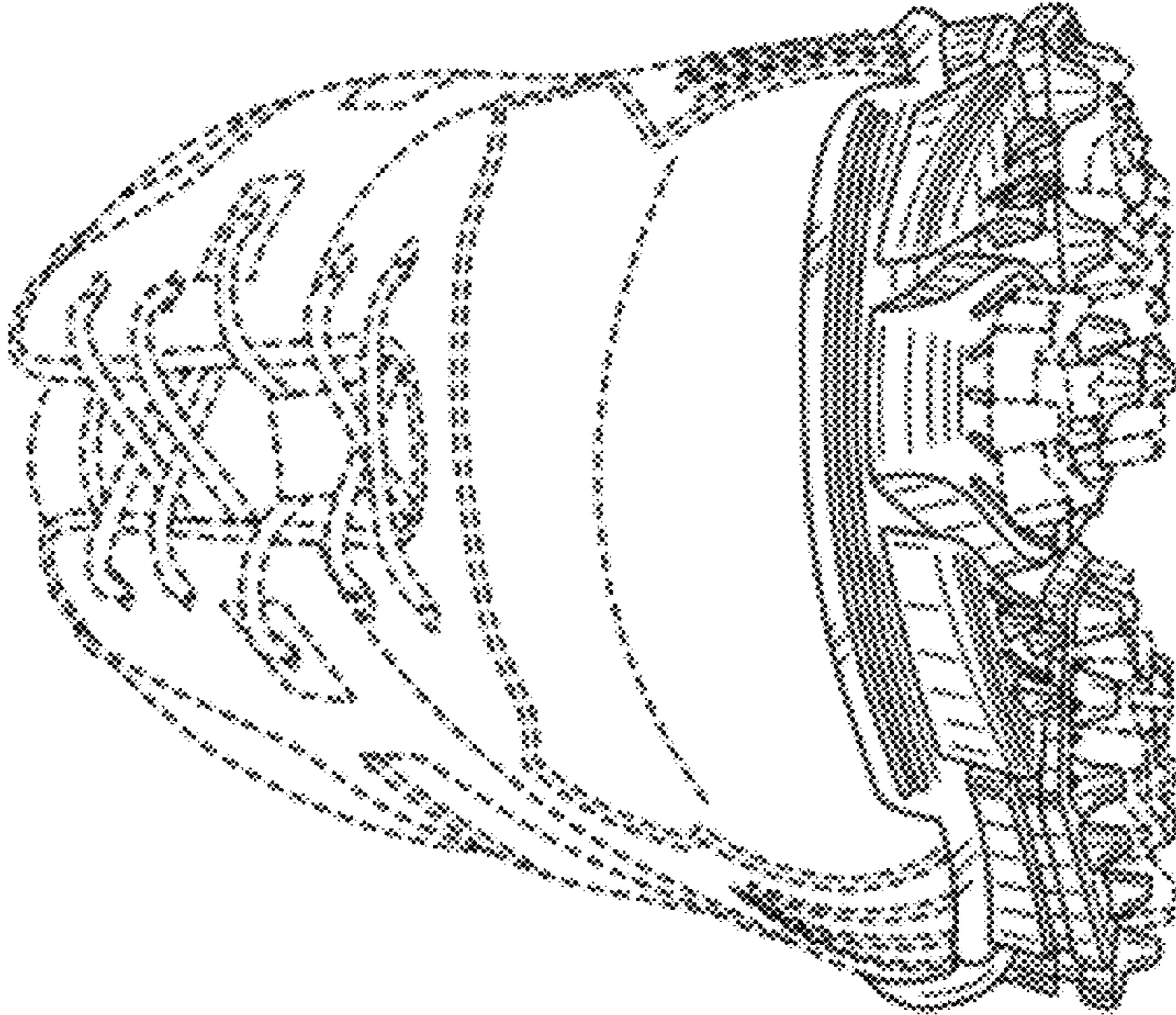

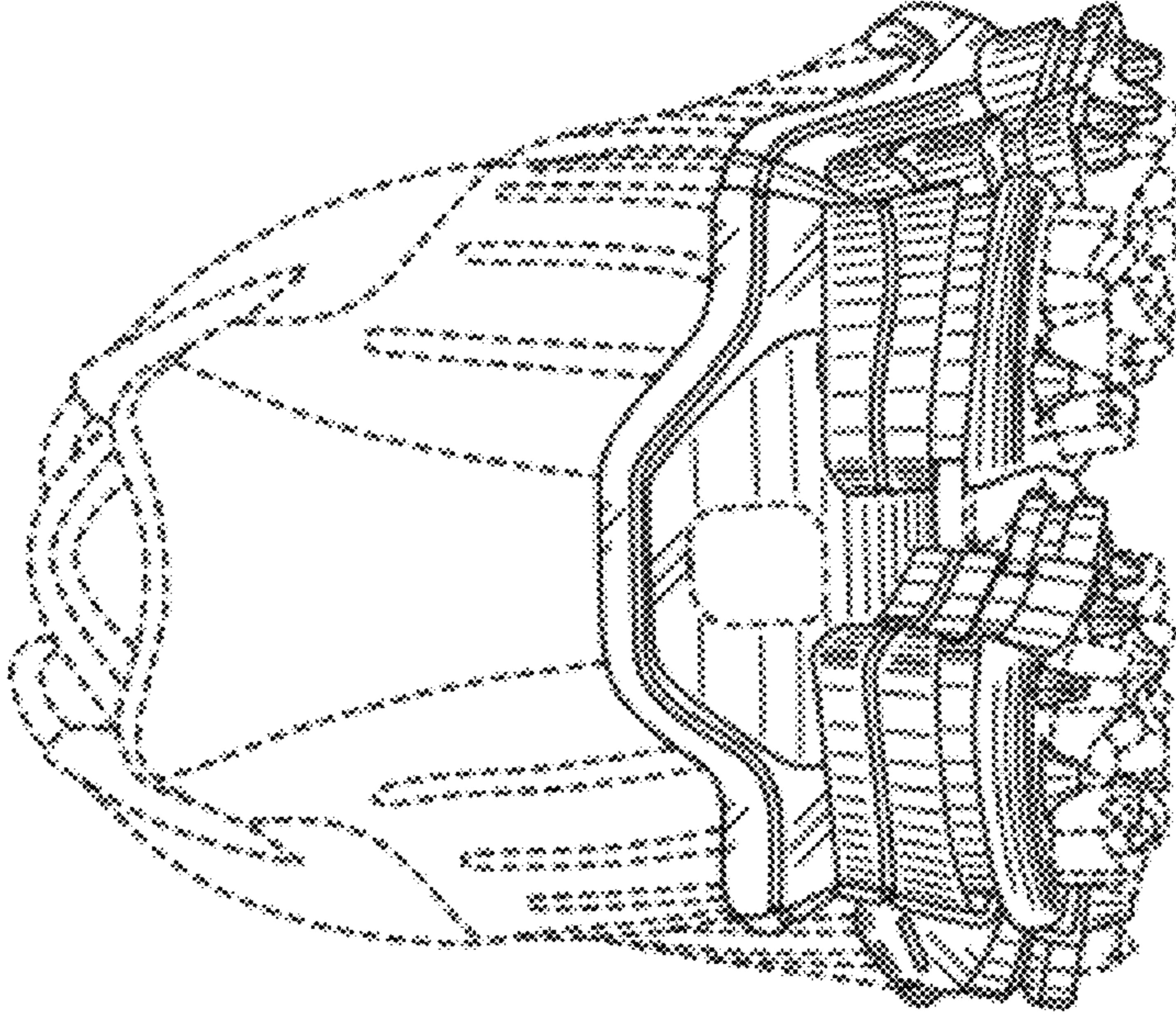
