DESCRIPTION

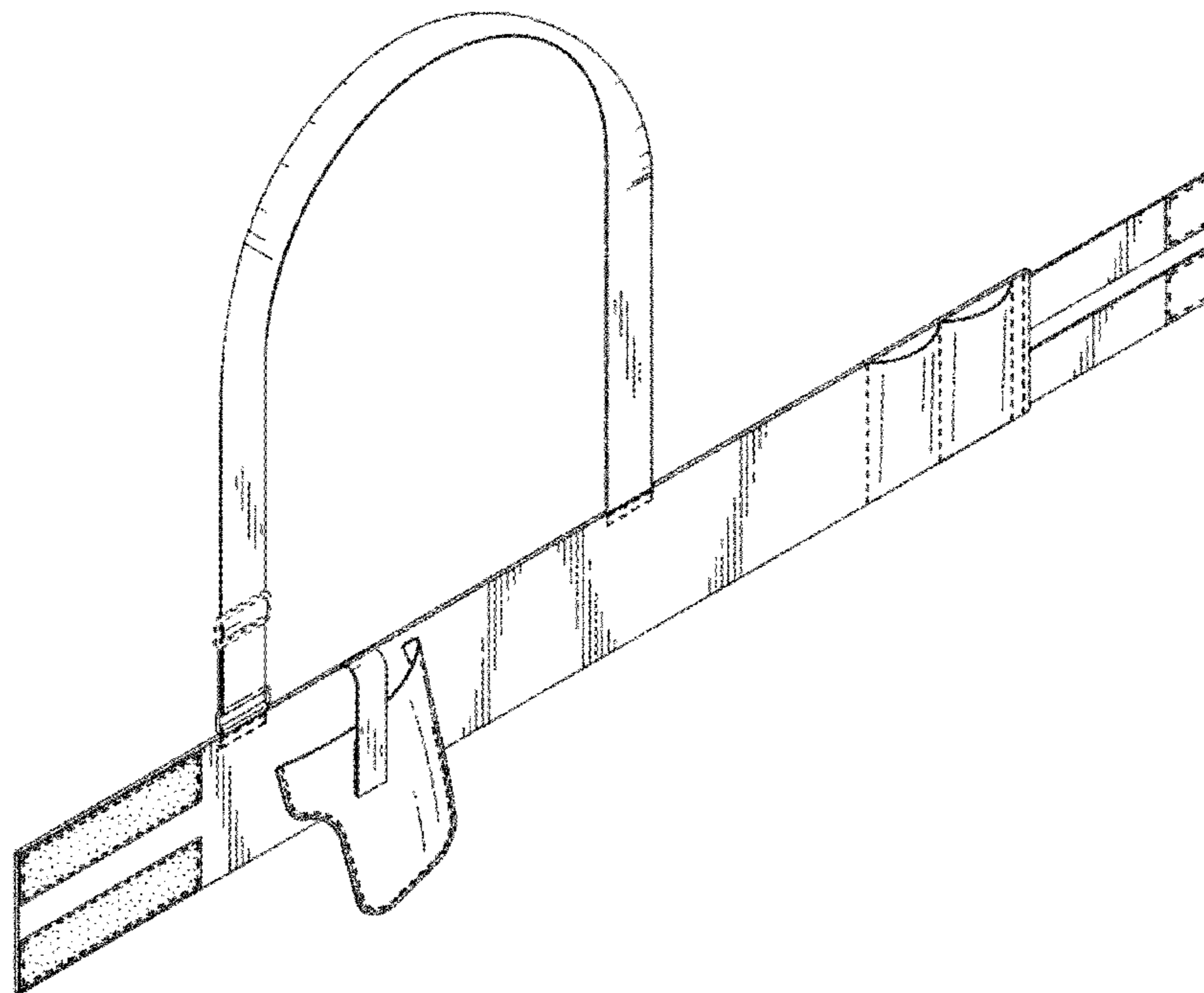

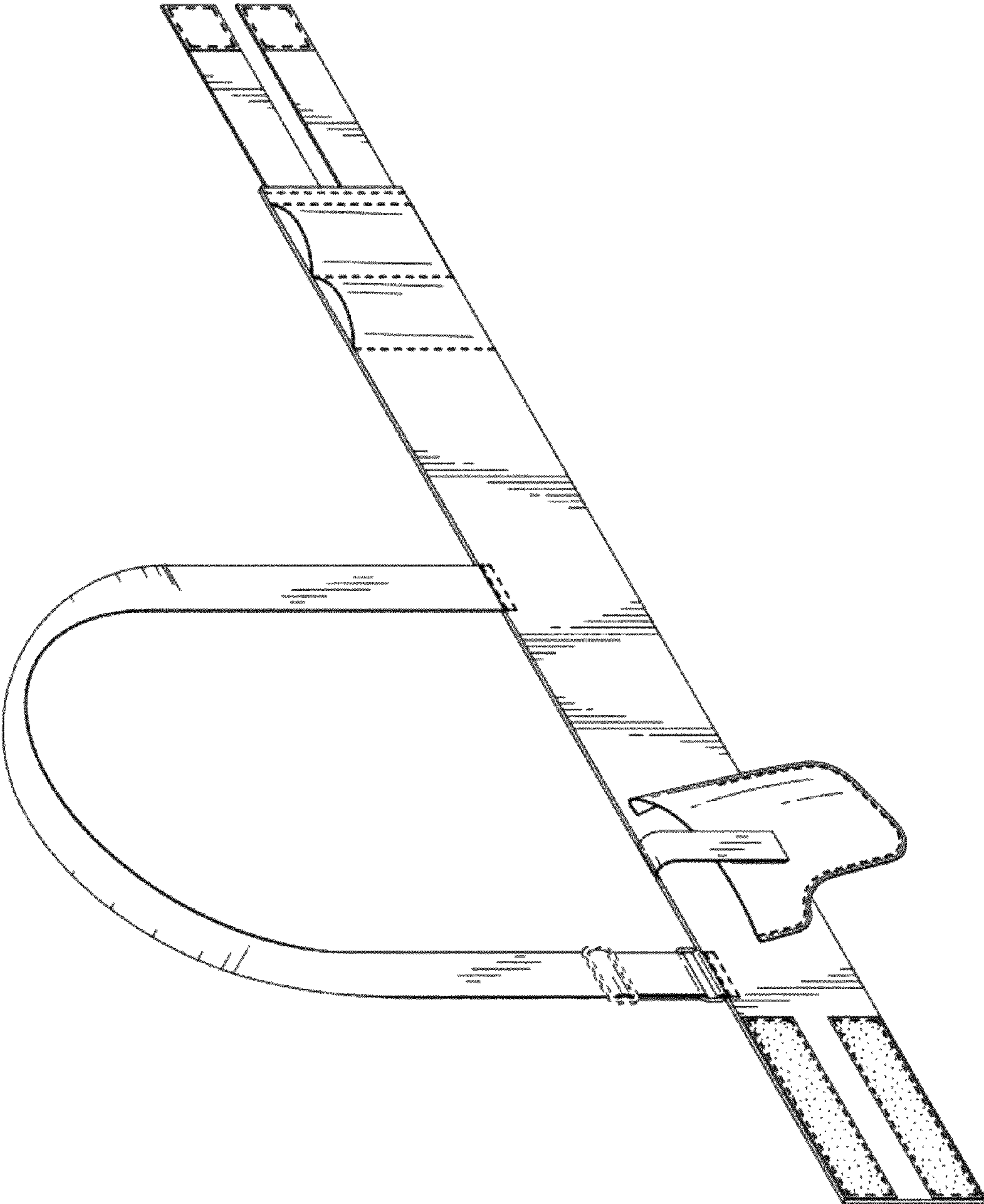

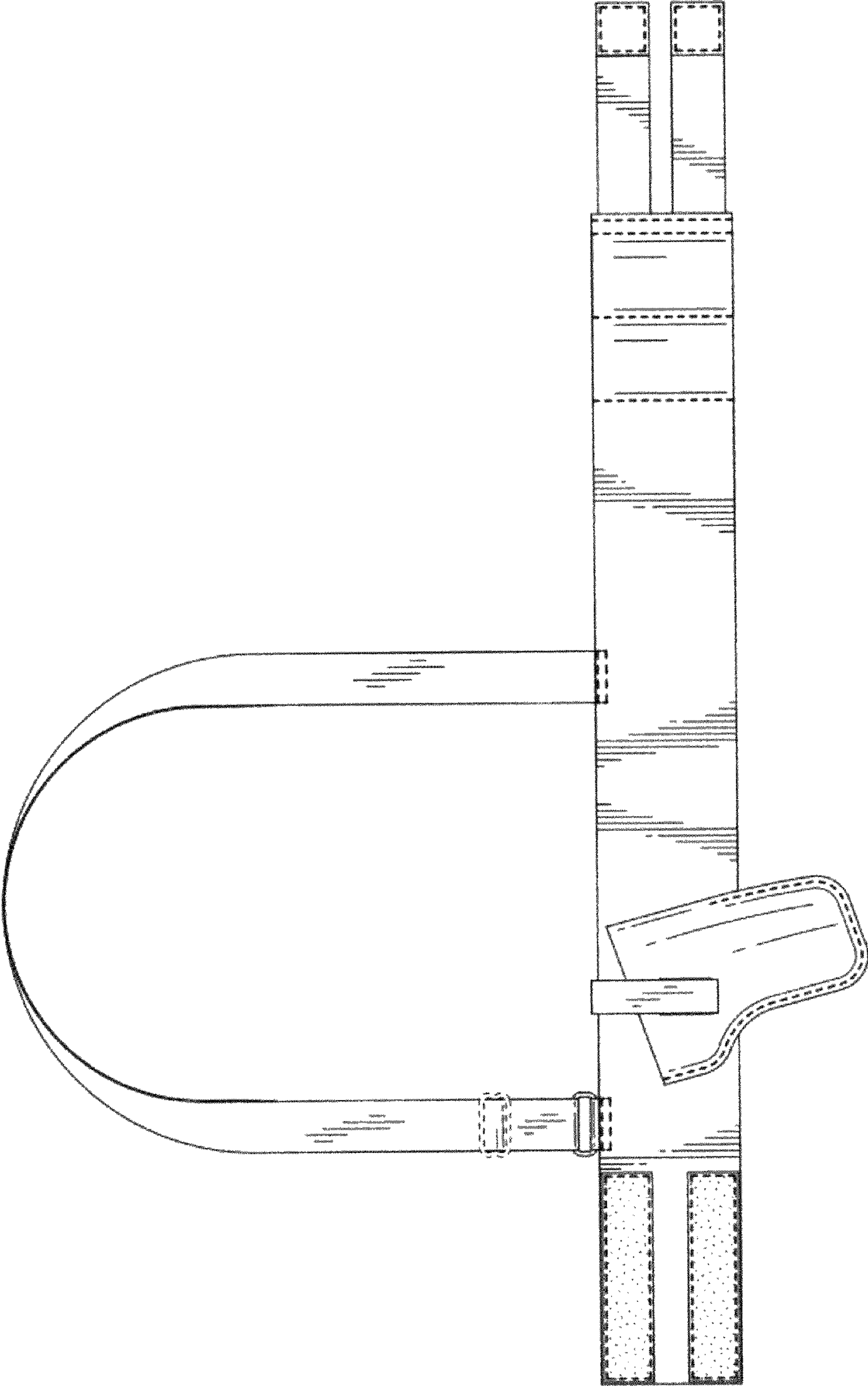

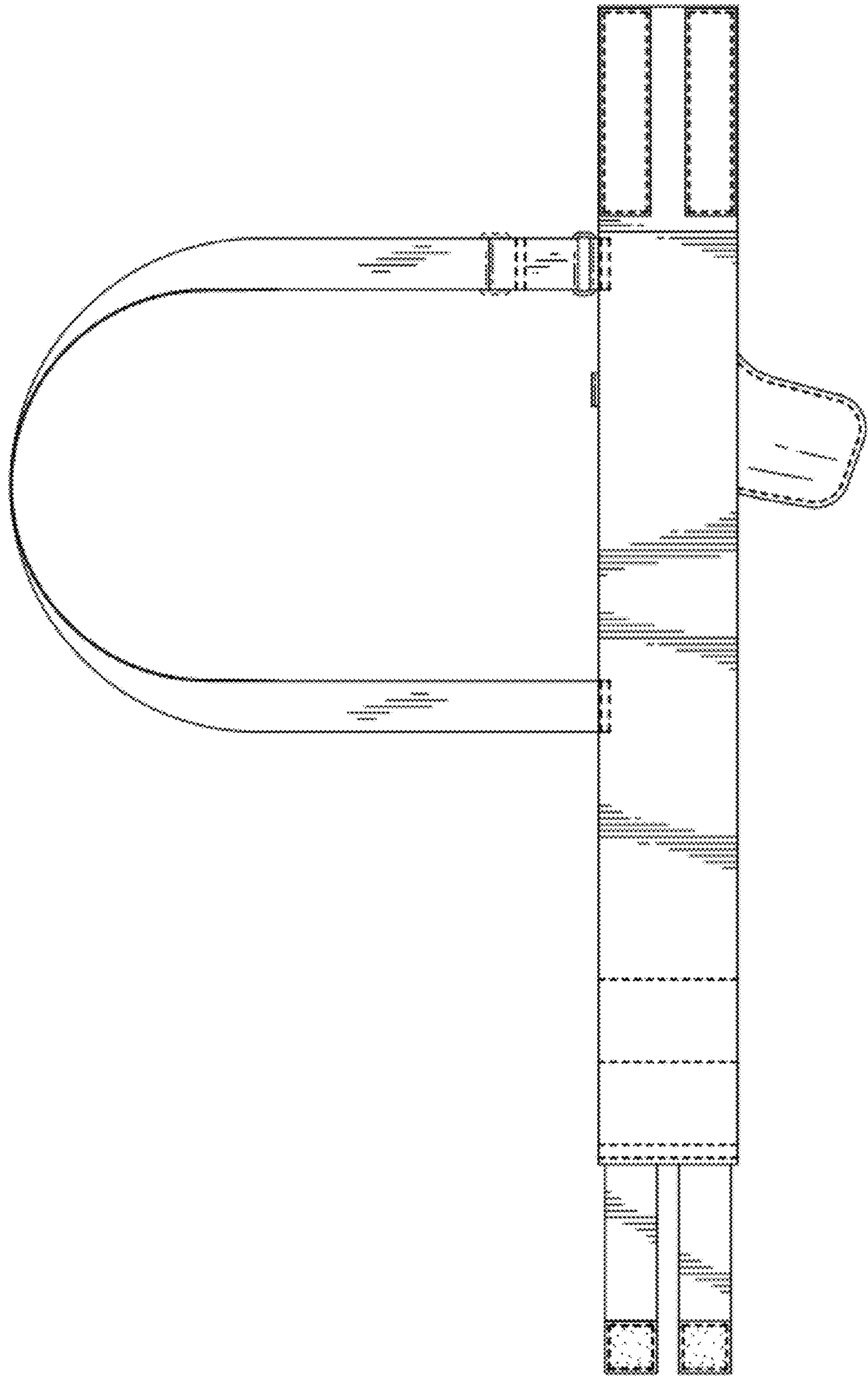

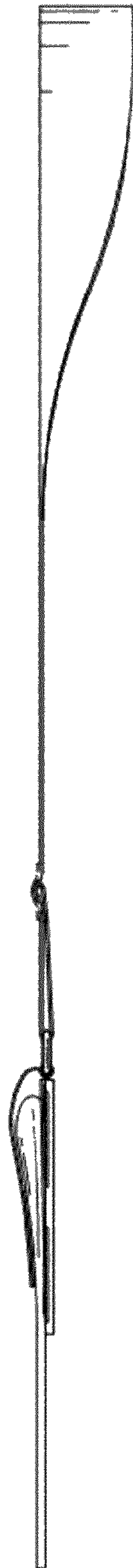

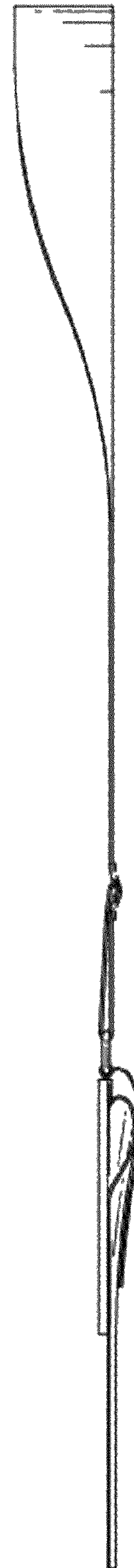

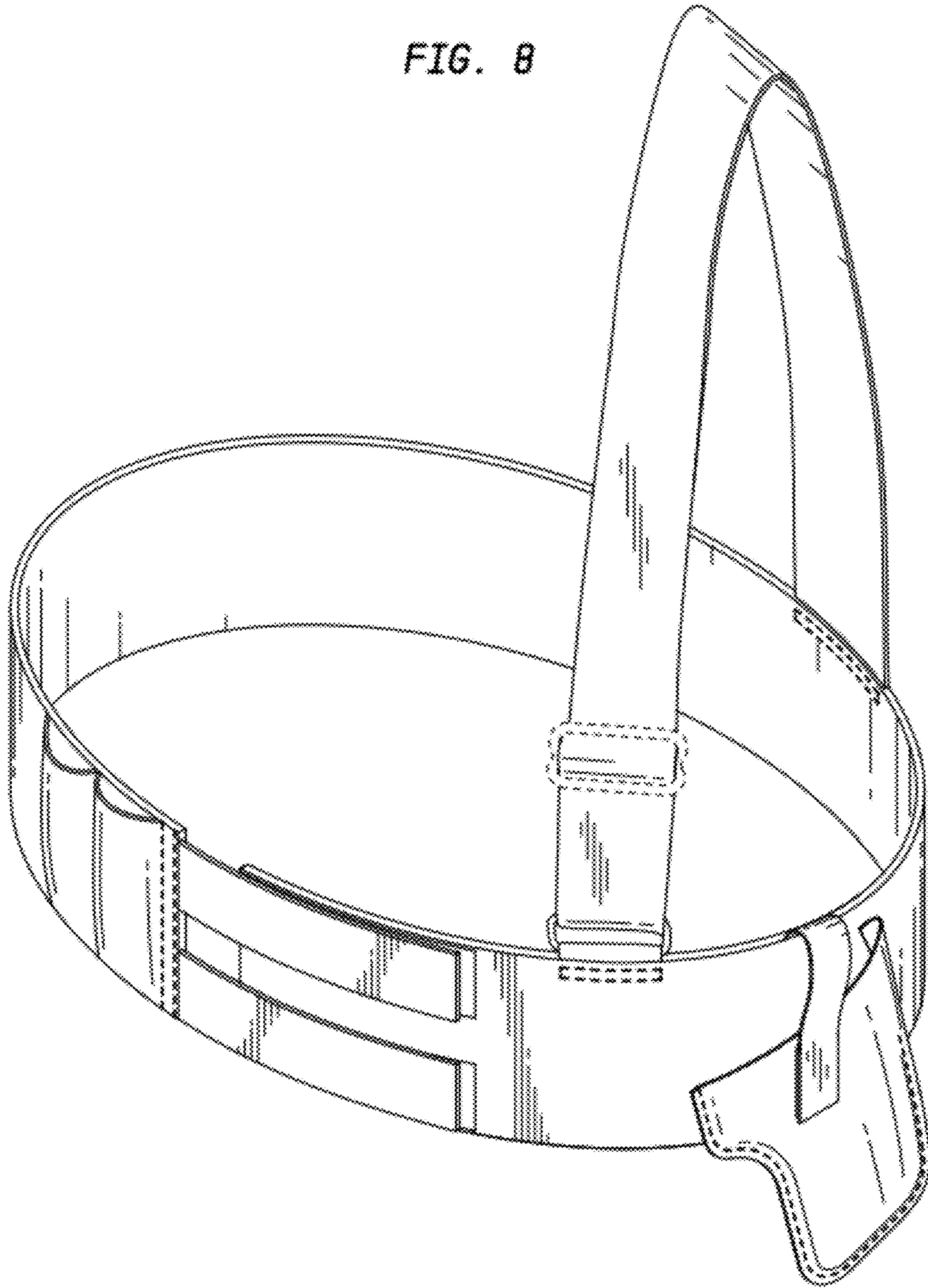

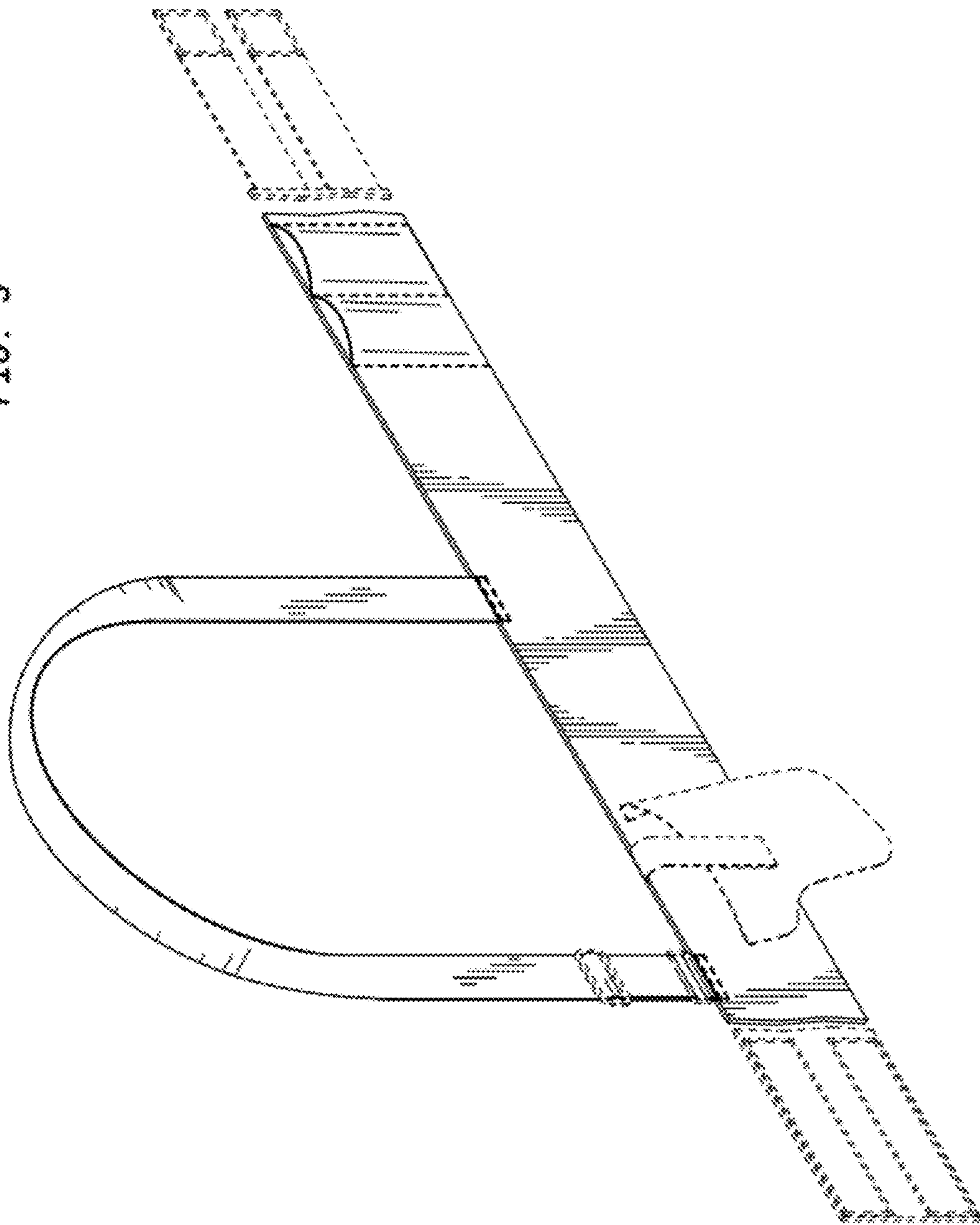

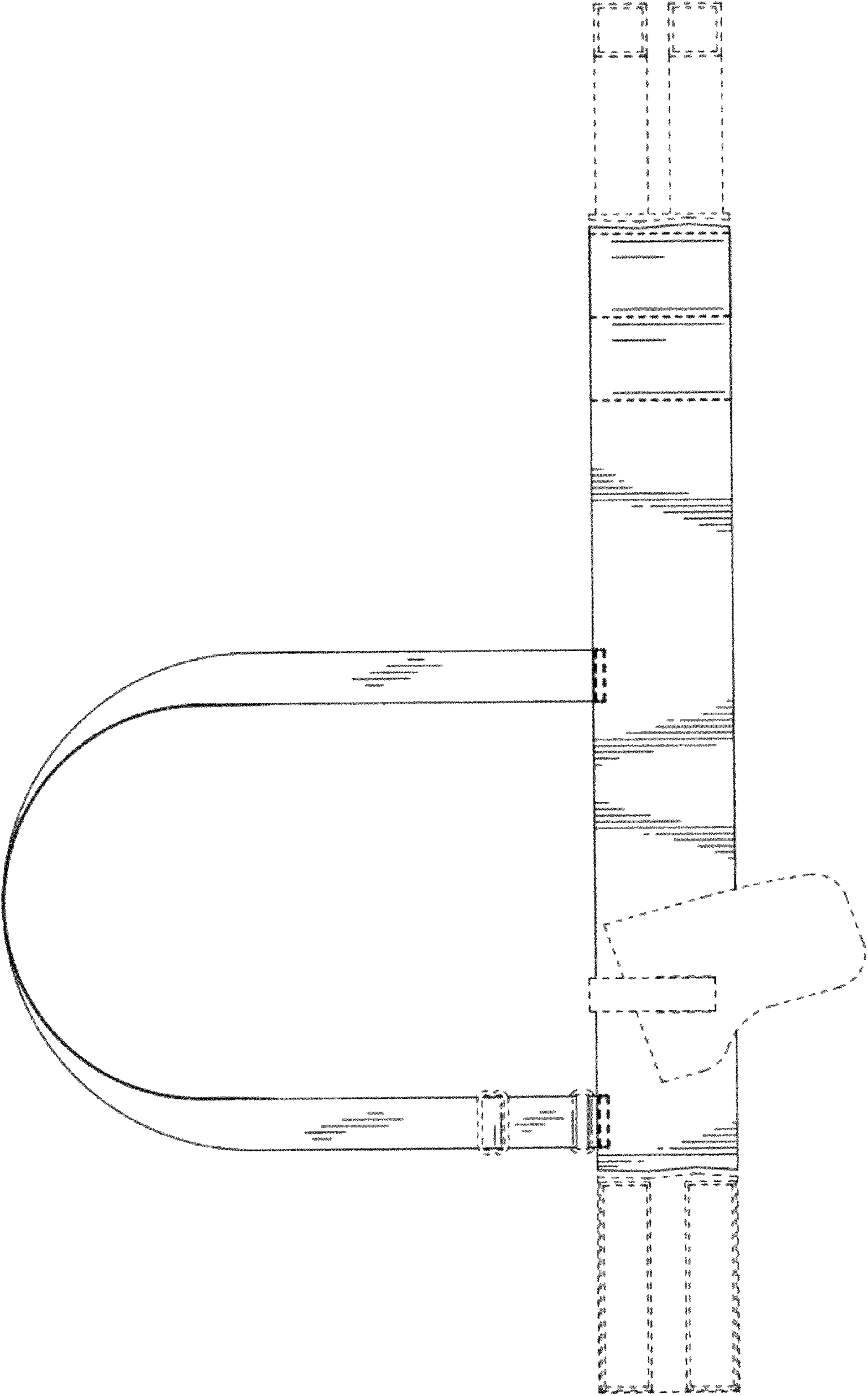

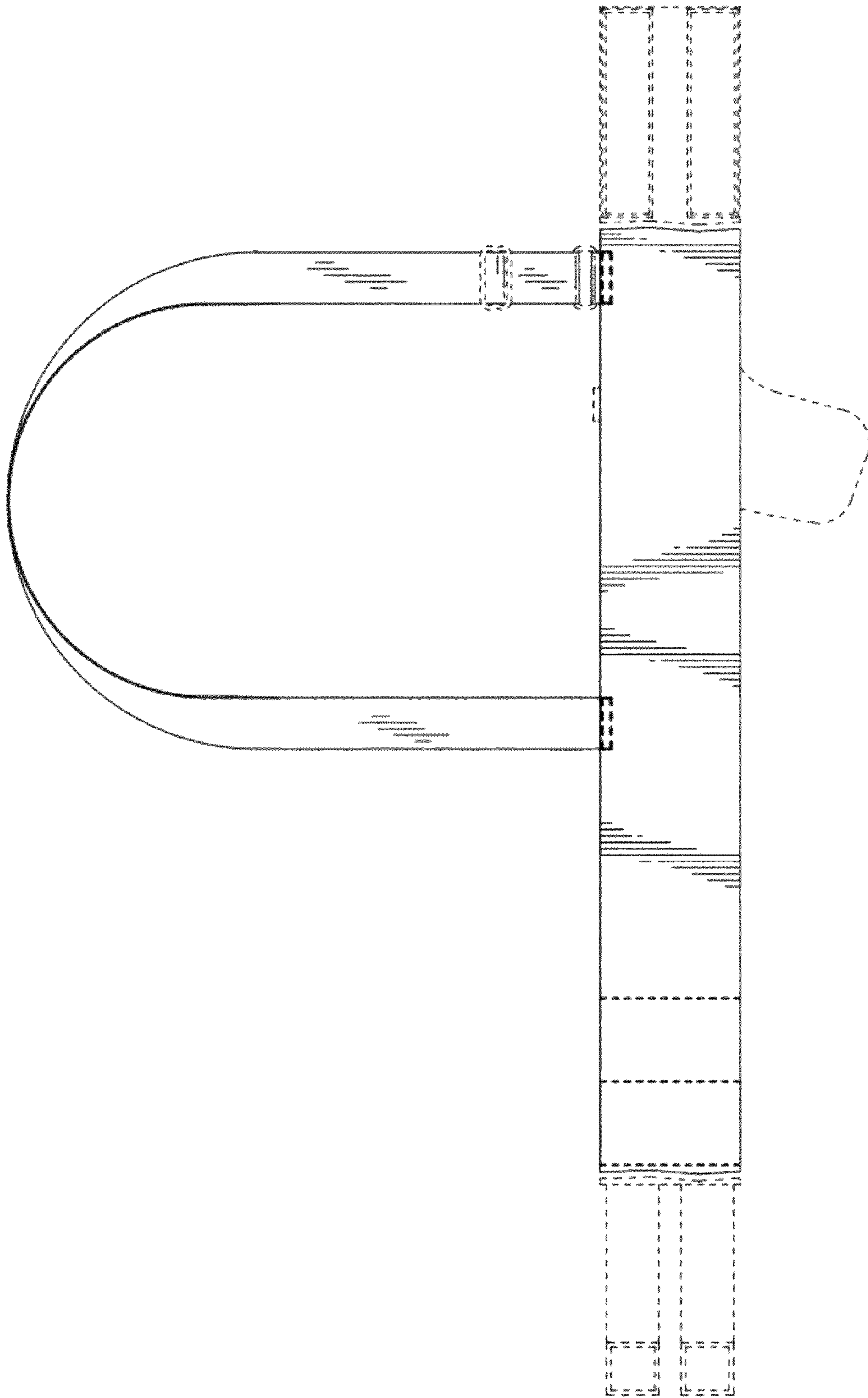

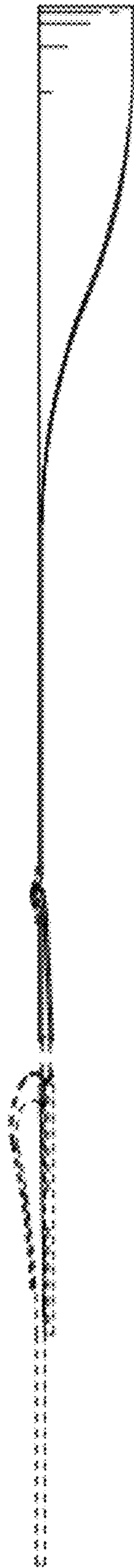

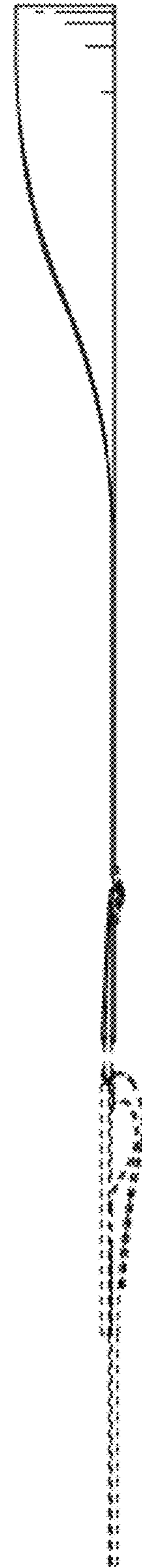
