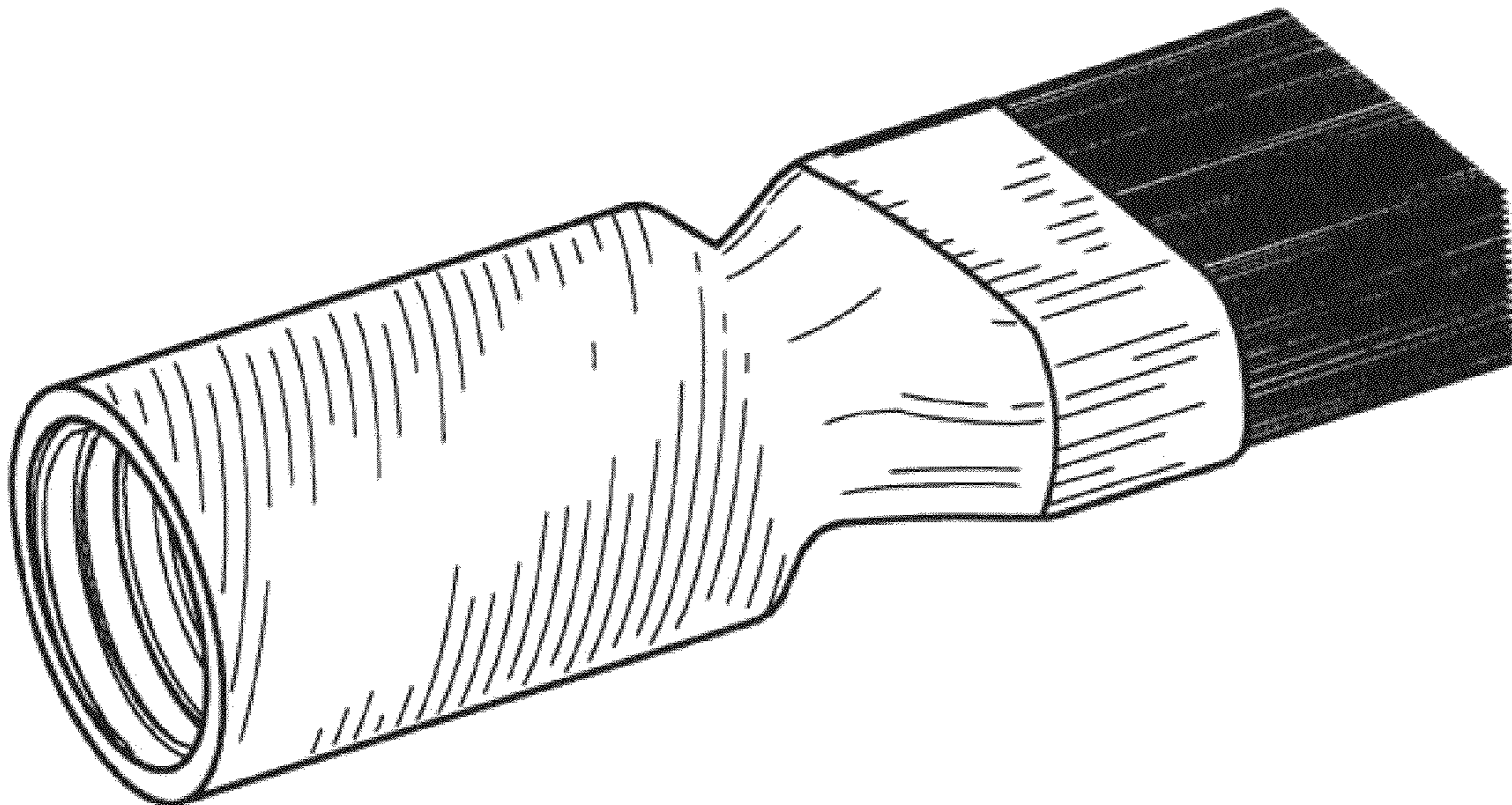
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a paint brush with an internally threaded opening in the handle showing my new design;

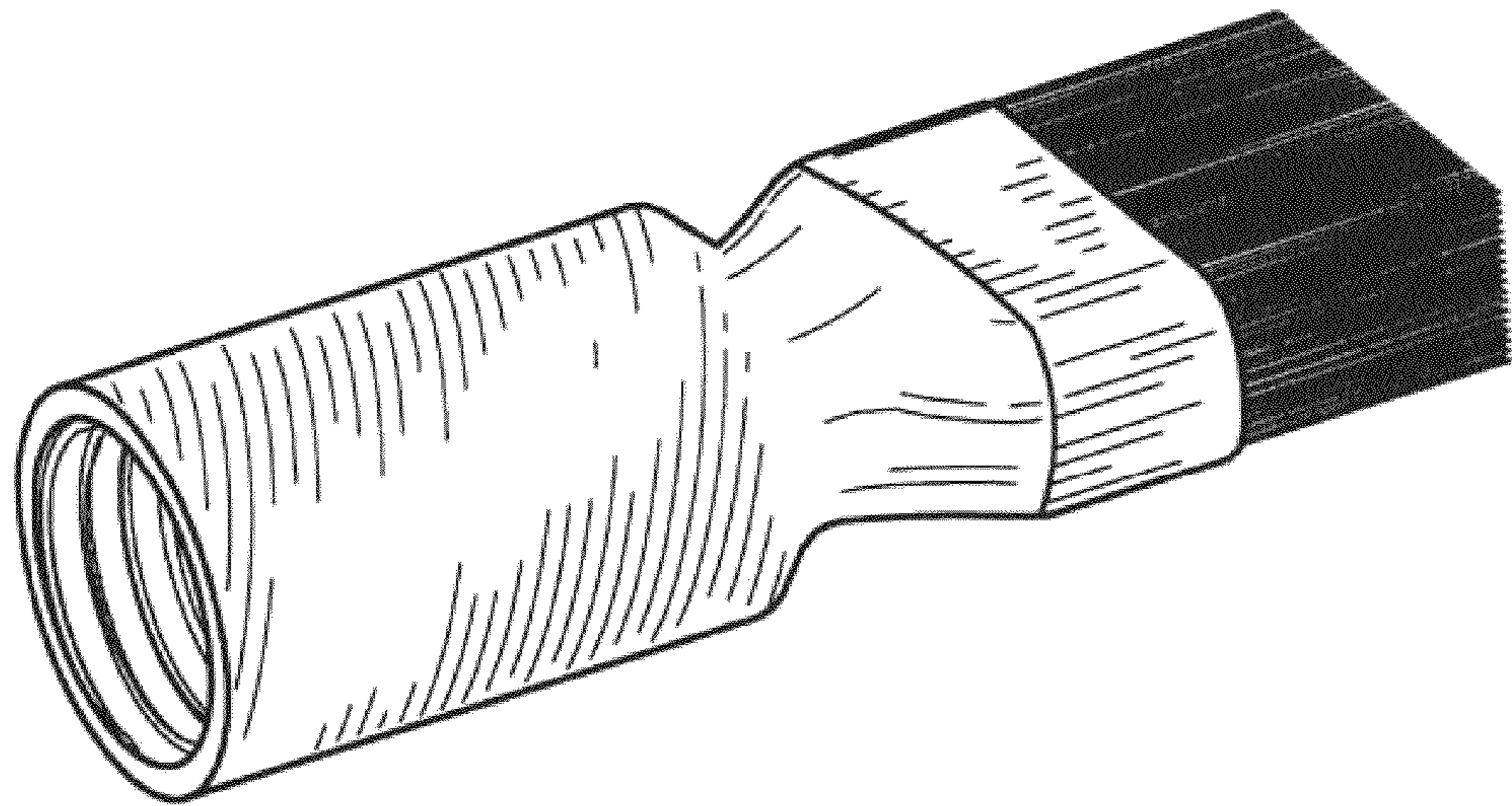

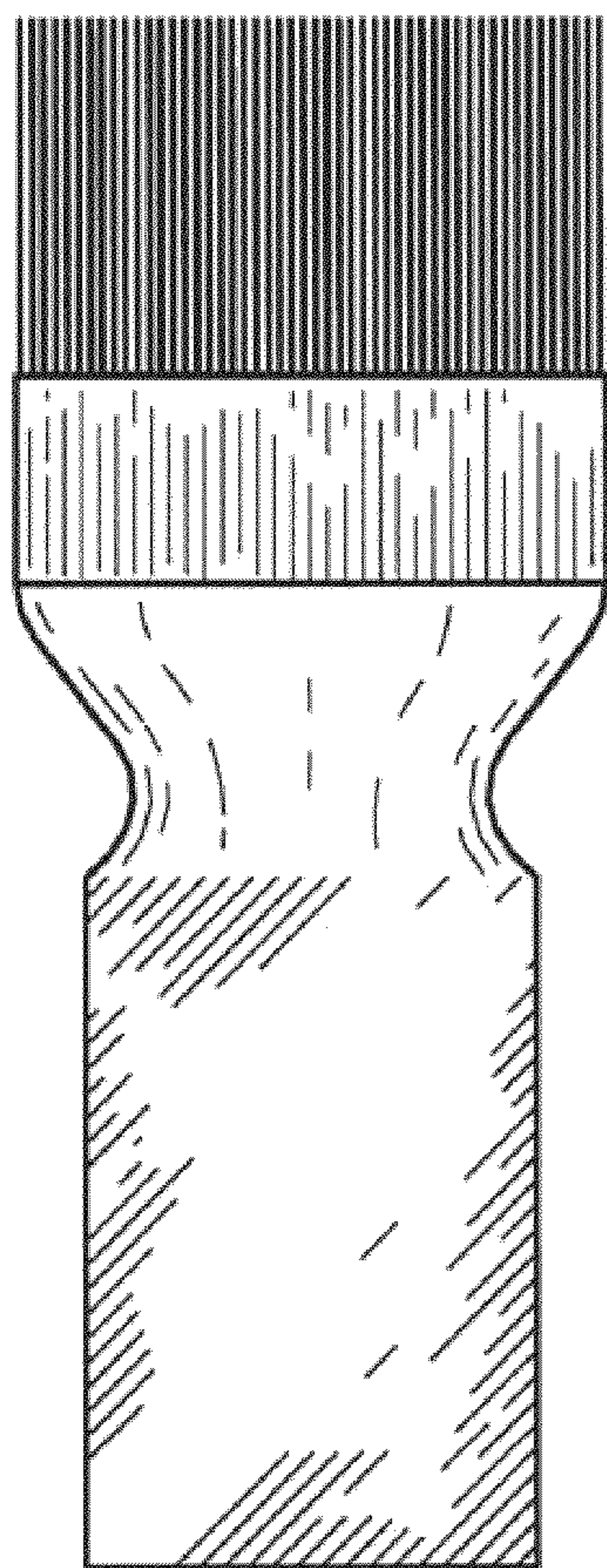

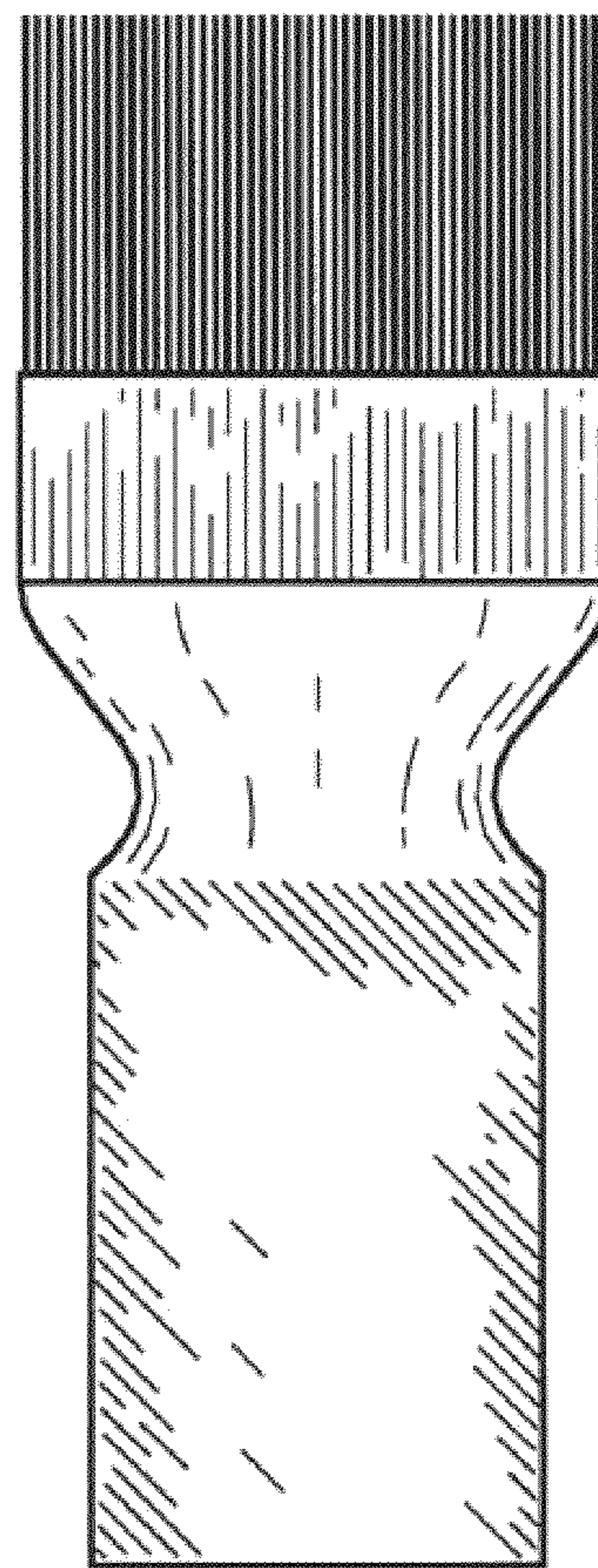

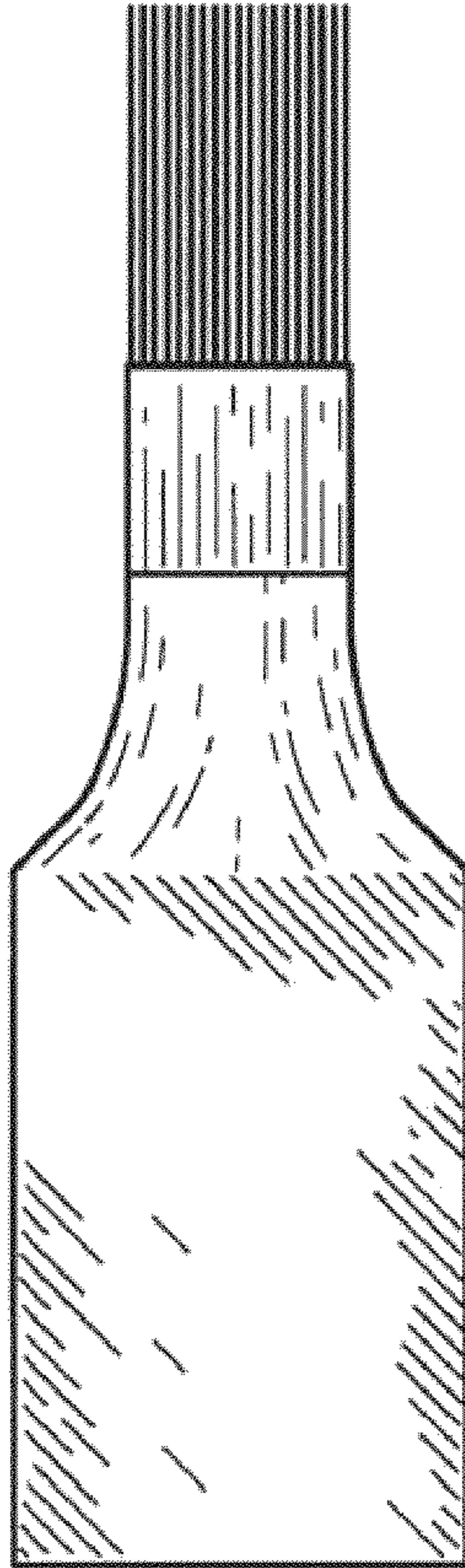

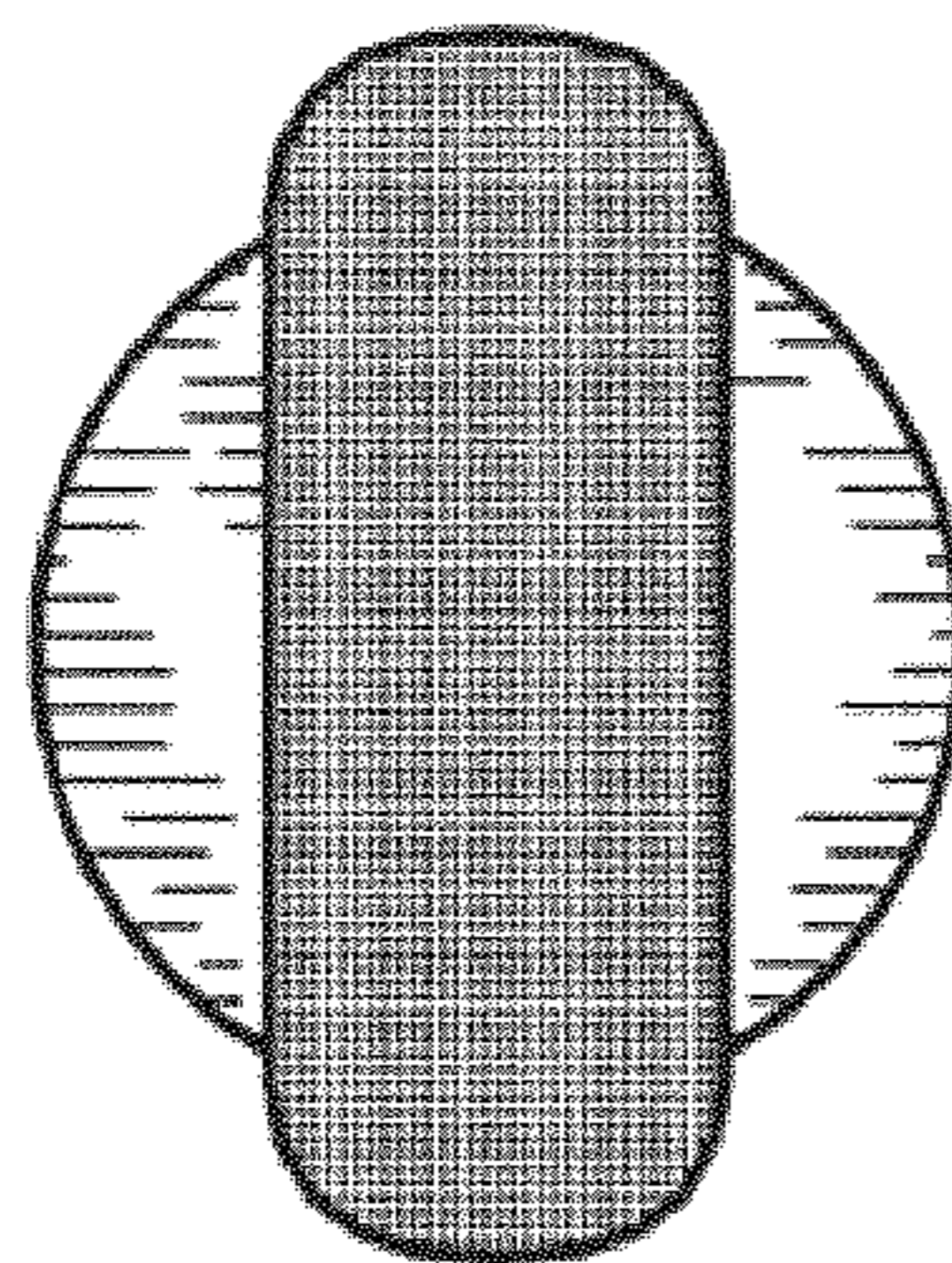

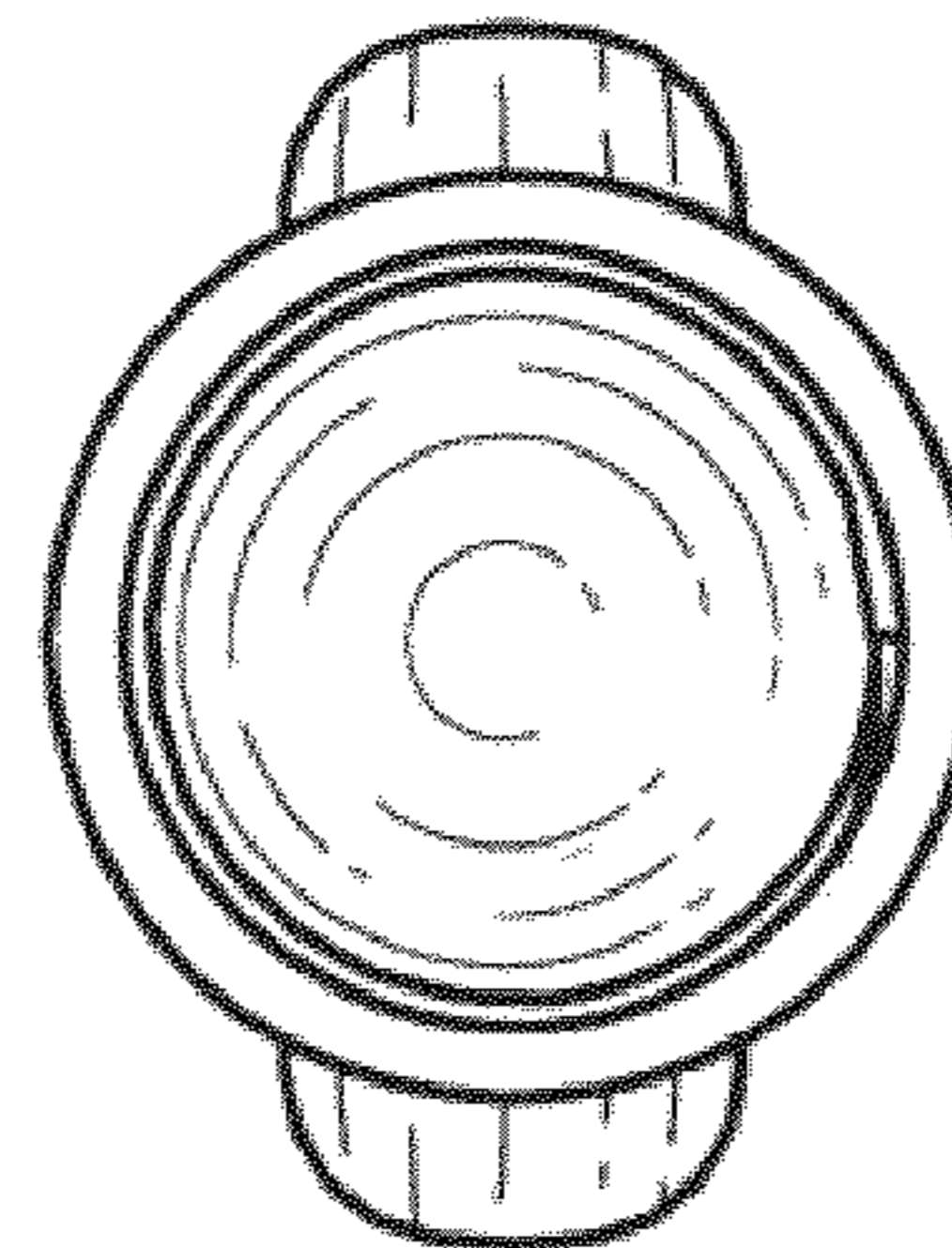
