(57) **CLAIM**

The ornamental design of a towel with a zippered segmented storage compartment, as shown and described.

**DESCRIPTION**

FIG. 1 is a first perspective view of the front side of a towel with a zippered segmented storage compartment.

FIG. 2 is a plan view of the front of a towel with a zippered segmented storage compartment.

FIG. 3 is a first side view of a towel with a zippered segmented storage compartment.

FIG. 4 is a second side view of a towel with a zippered segmented storage compartment.

FIG. 5 is a plan view of the back of a towel with a zippered segmented storage compartment.

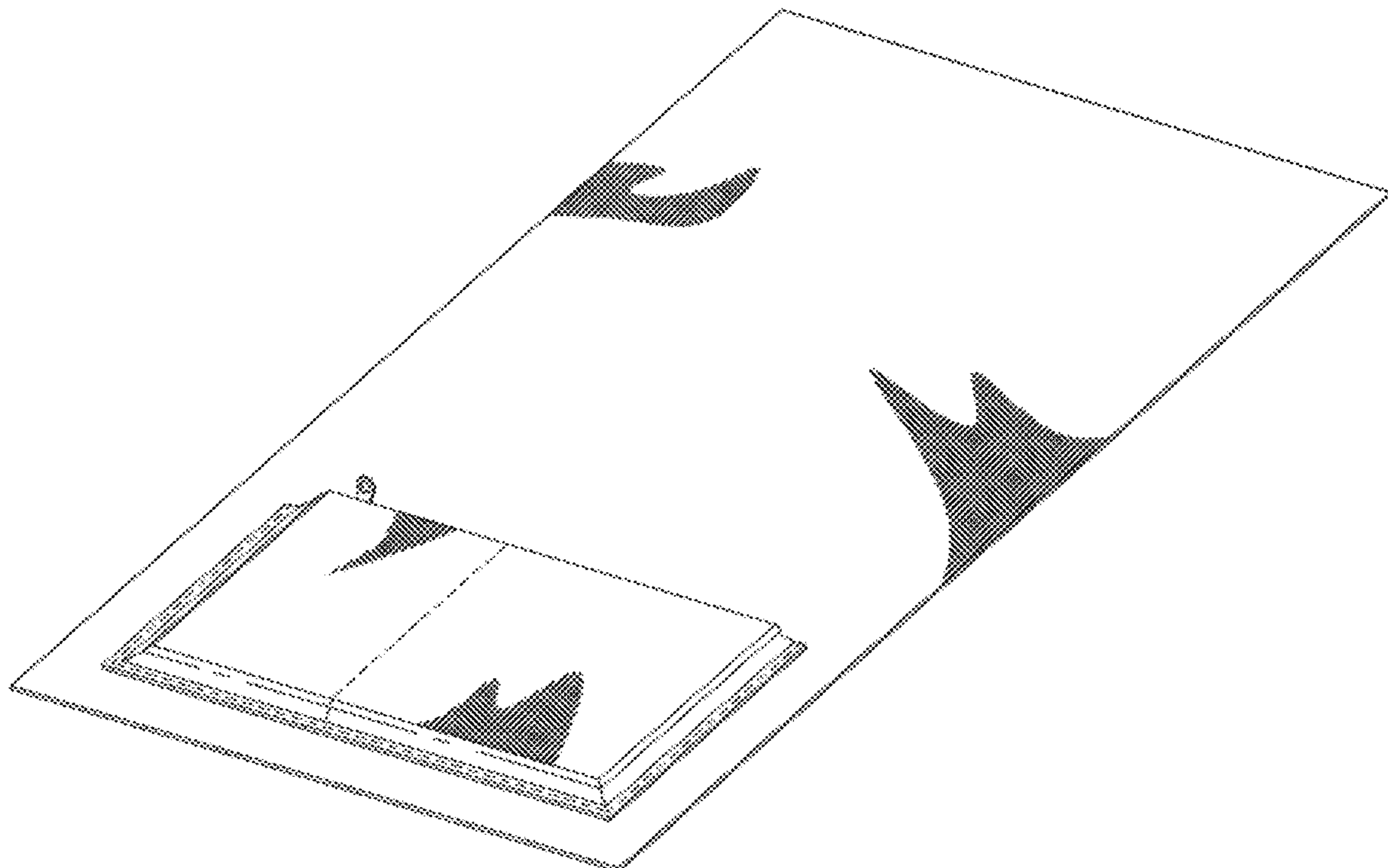
FIG. 6 is a third side view of a towel with a zippered segmented storage compartment.

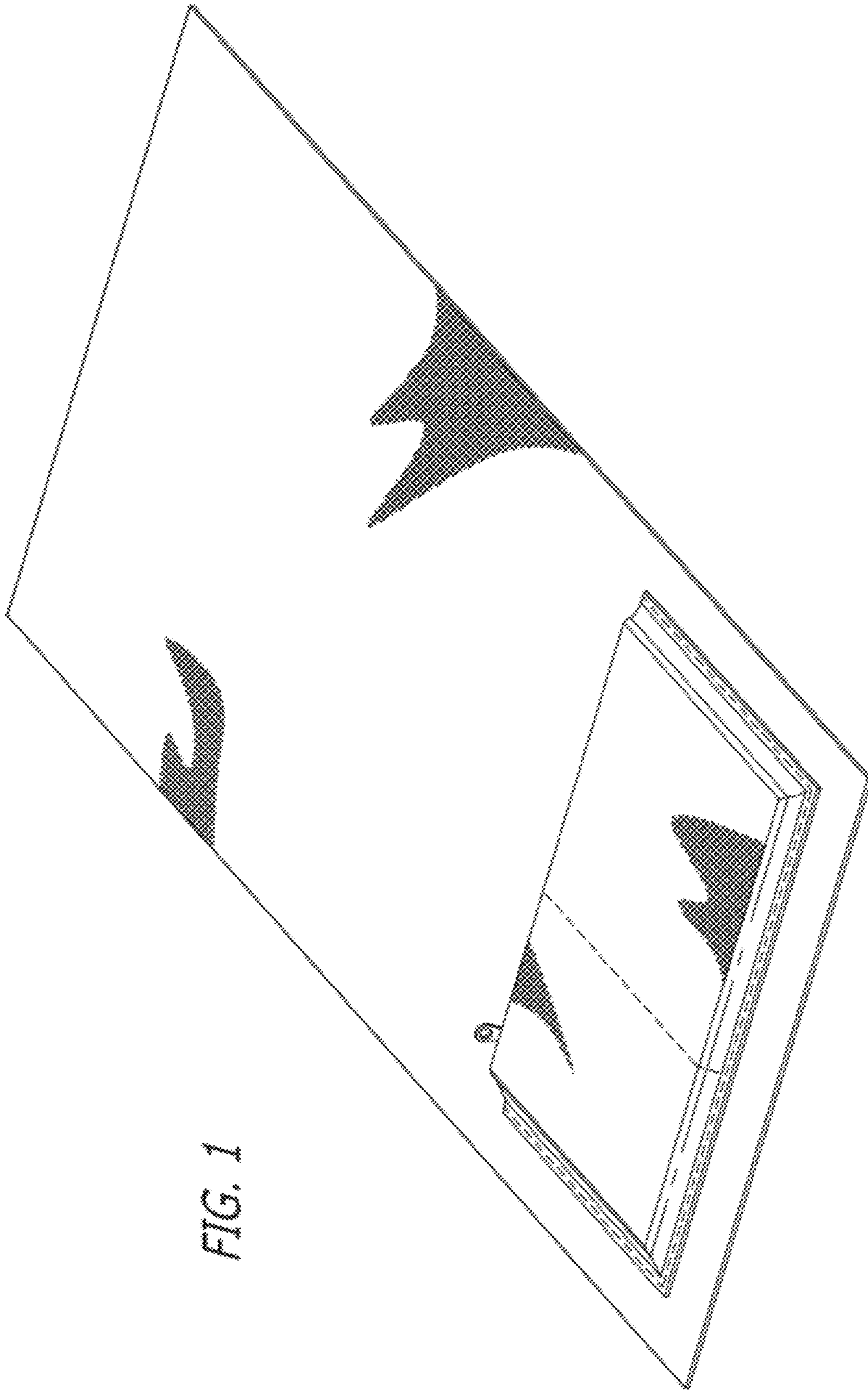

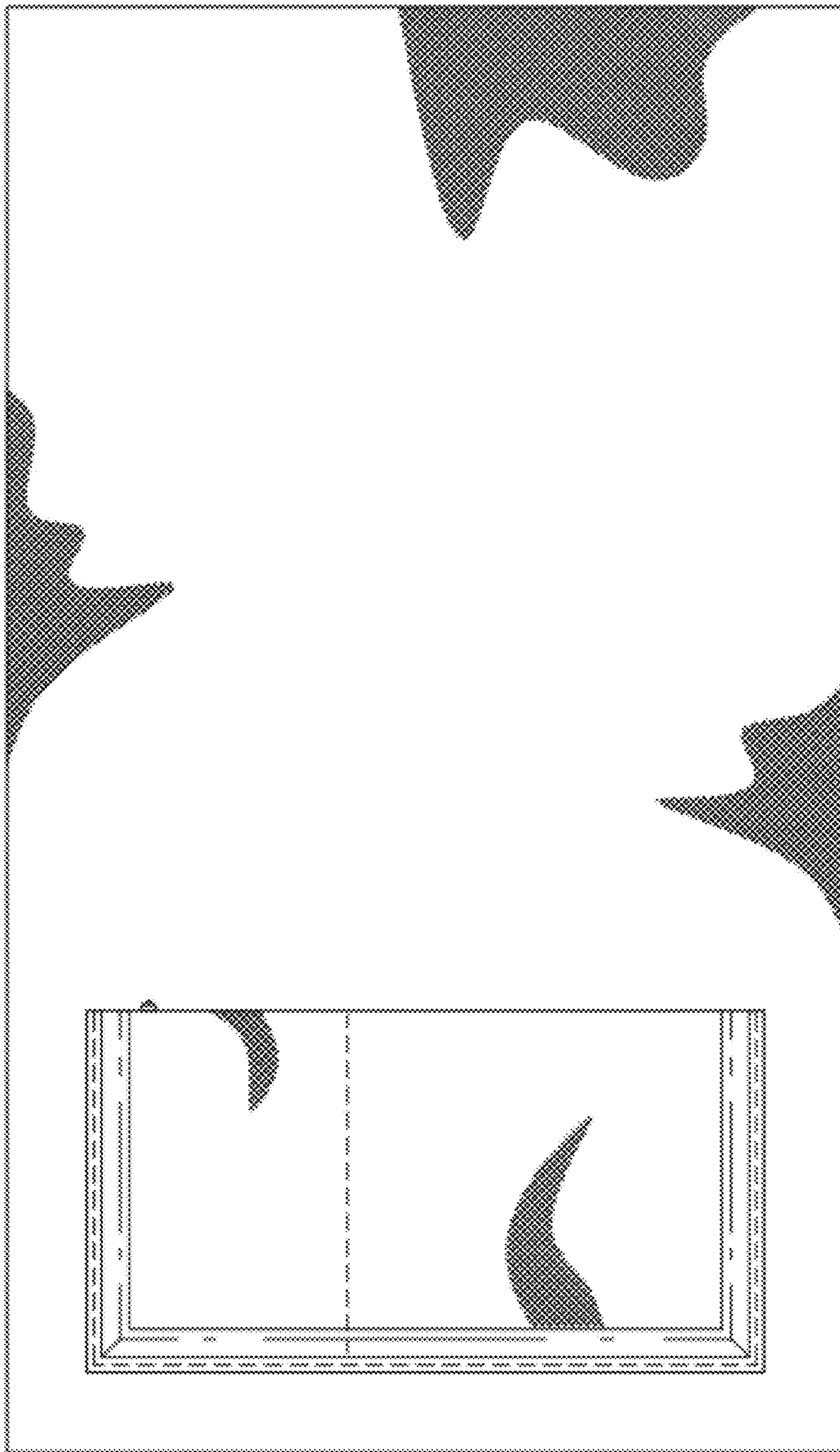

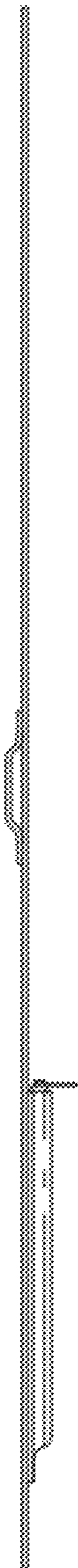

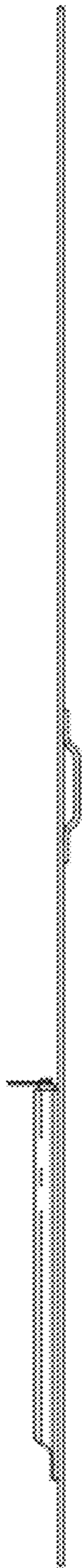

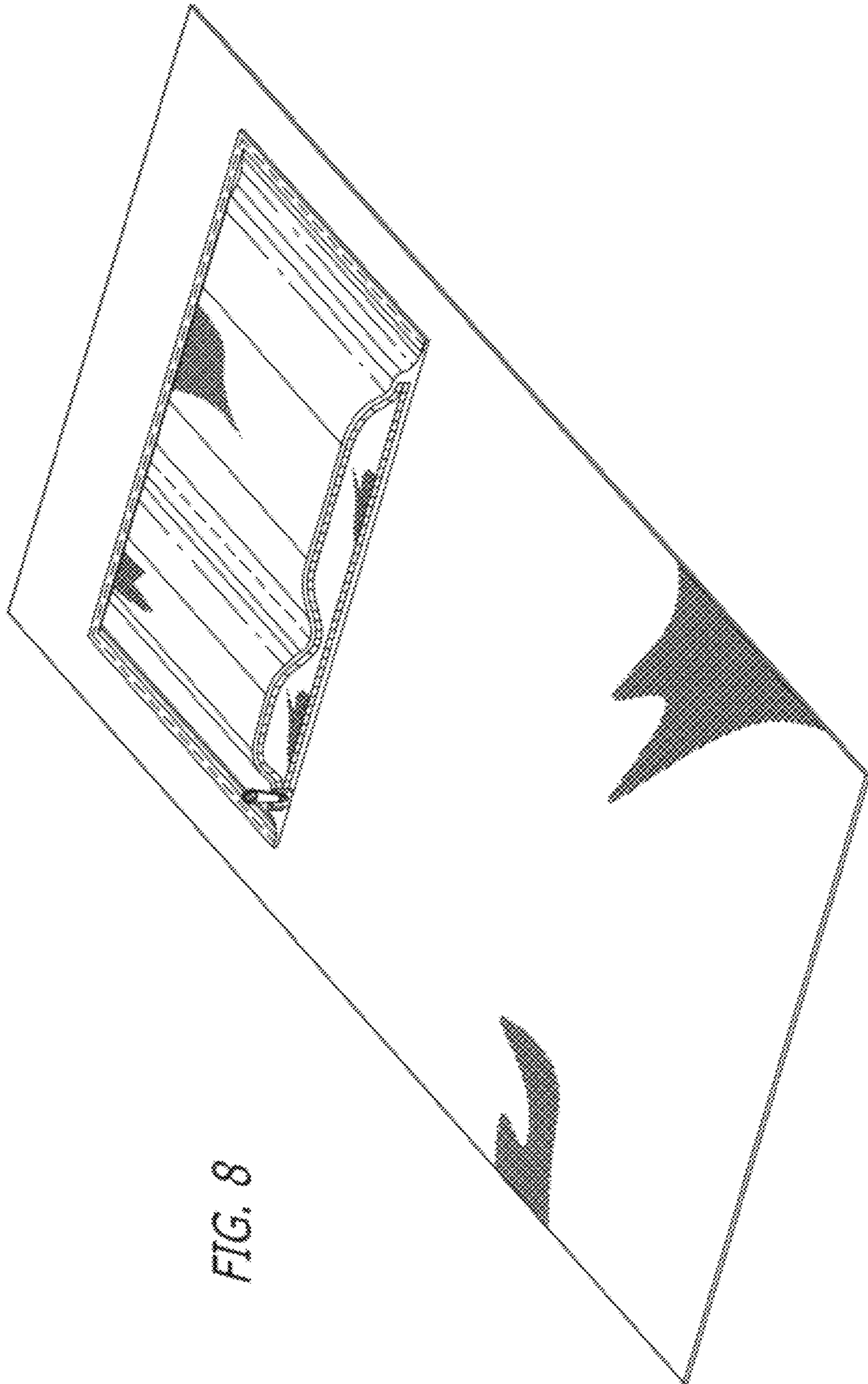
