DESCRIPTION

FIG. 4 is a right end view of the bottle shown in FIG. 1;

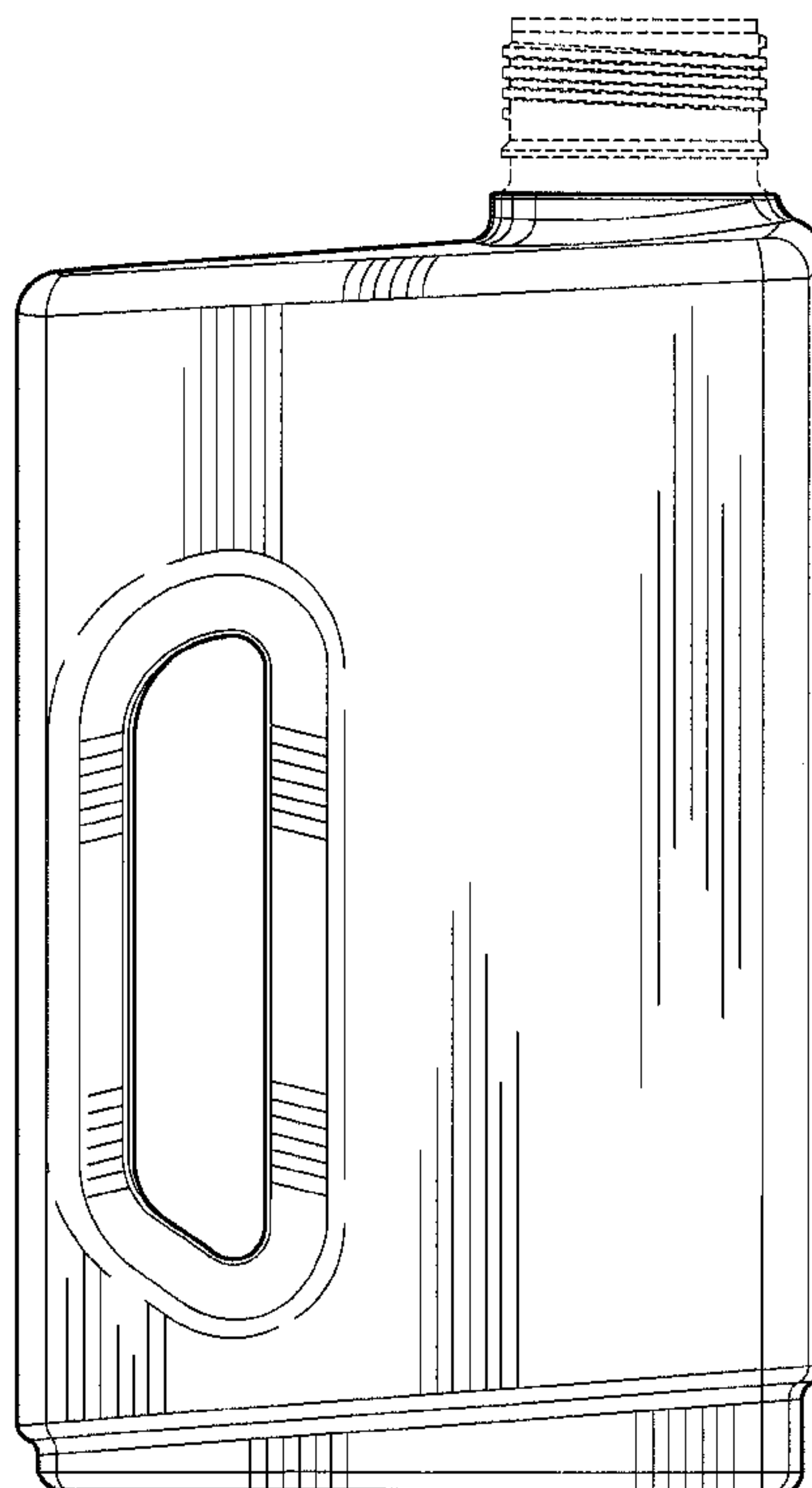
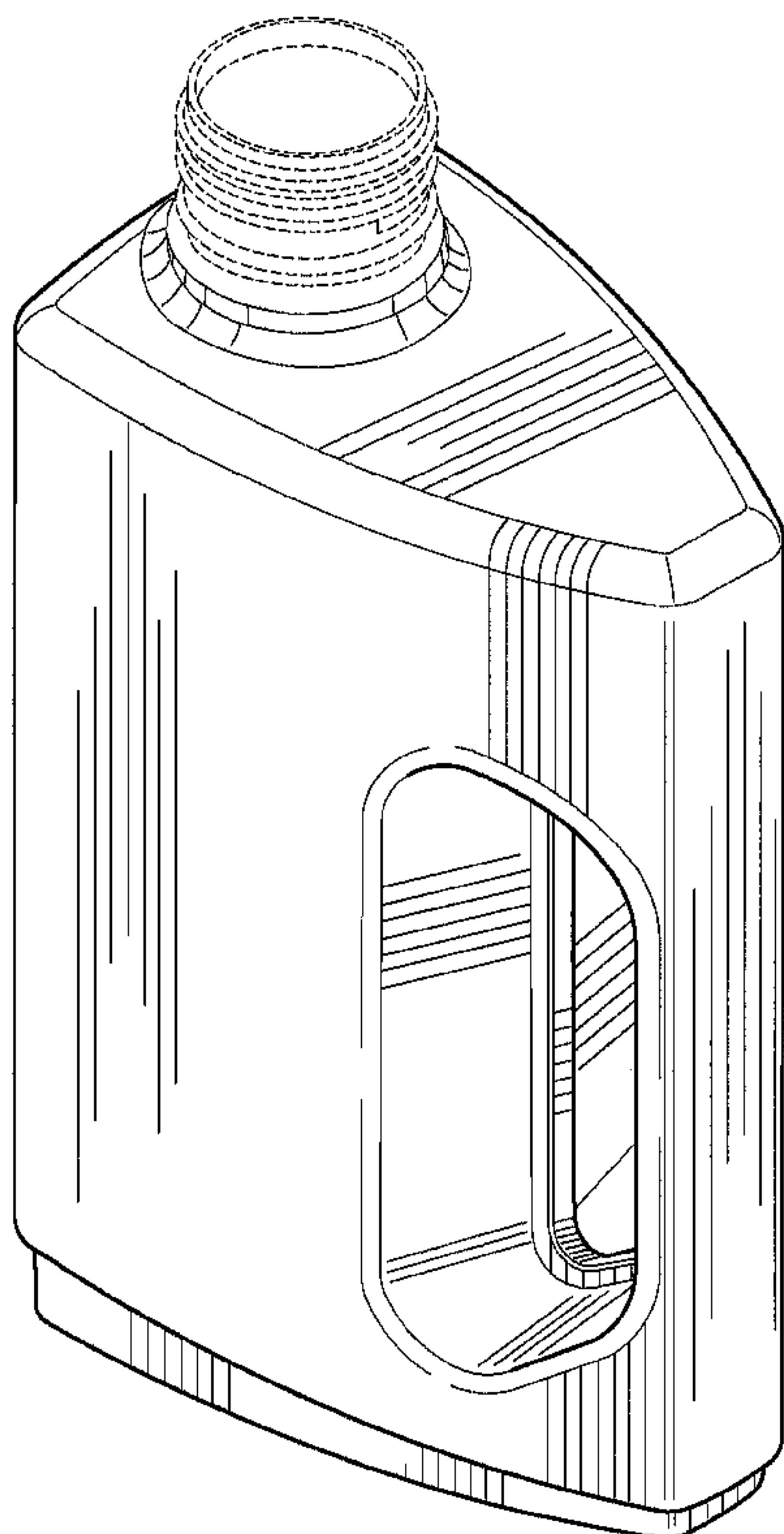
FIG. 5 is a left end view of the bottle shown in FIG. 1;

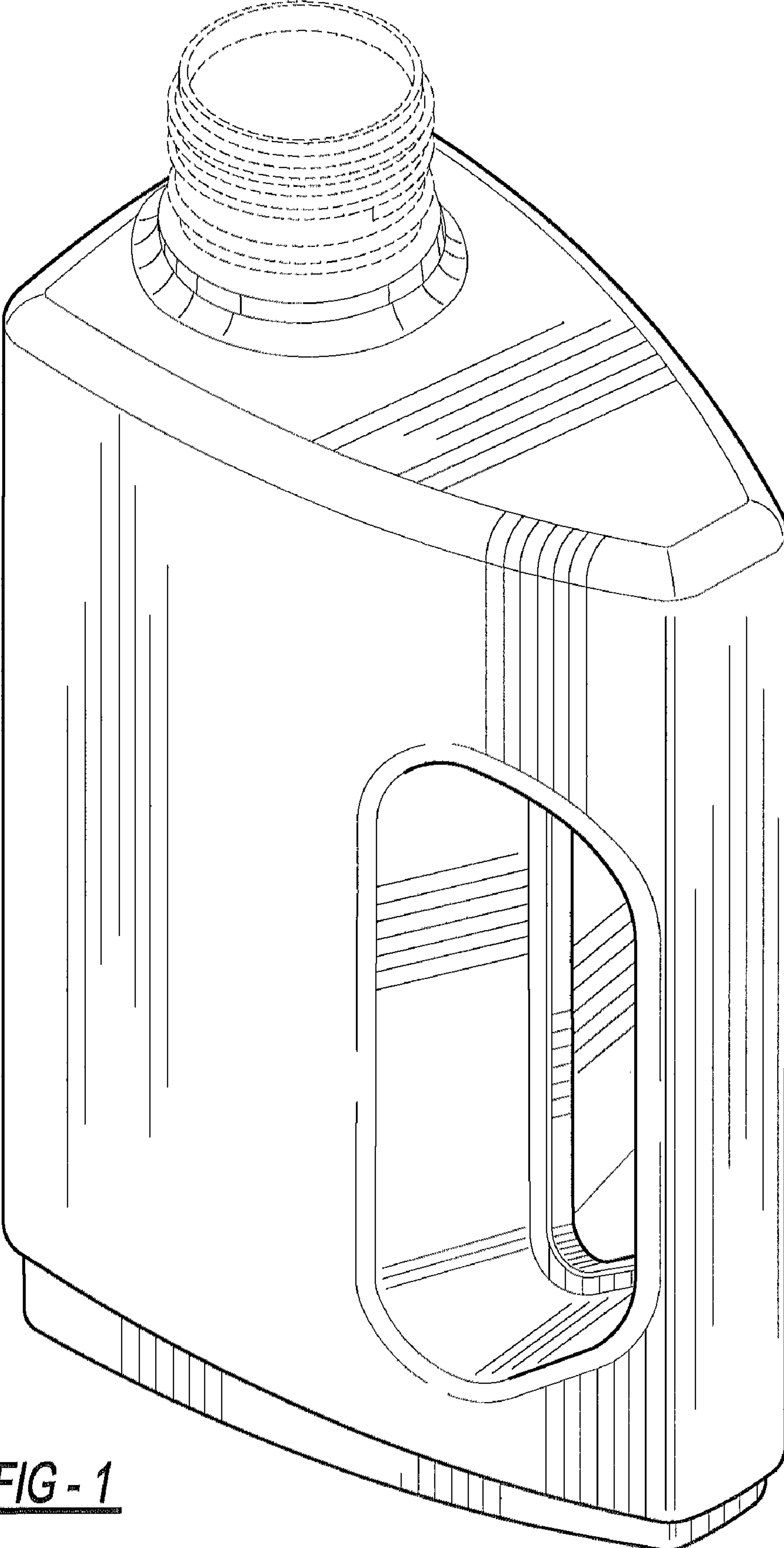

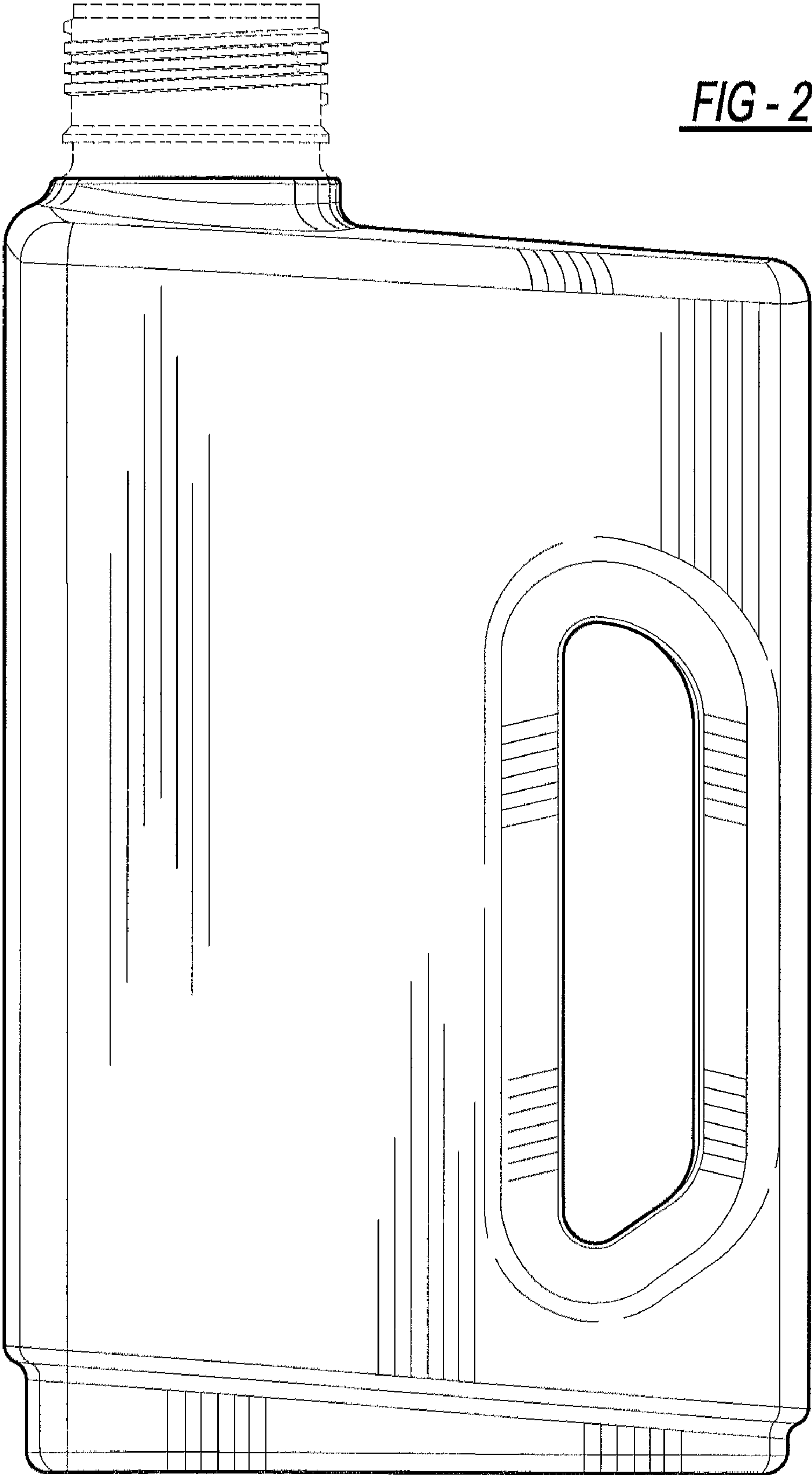
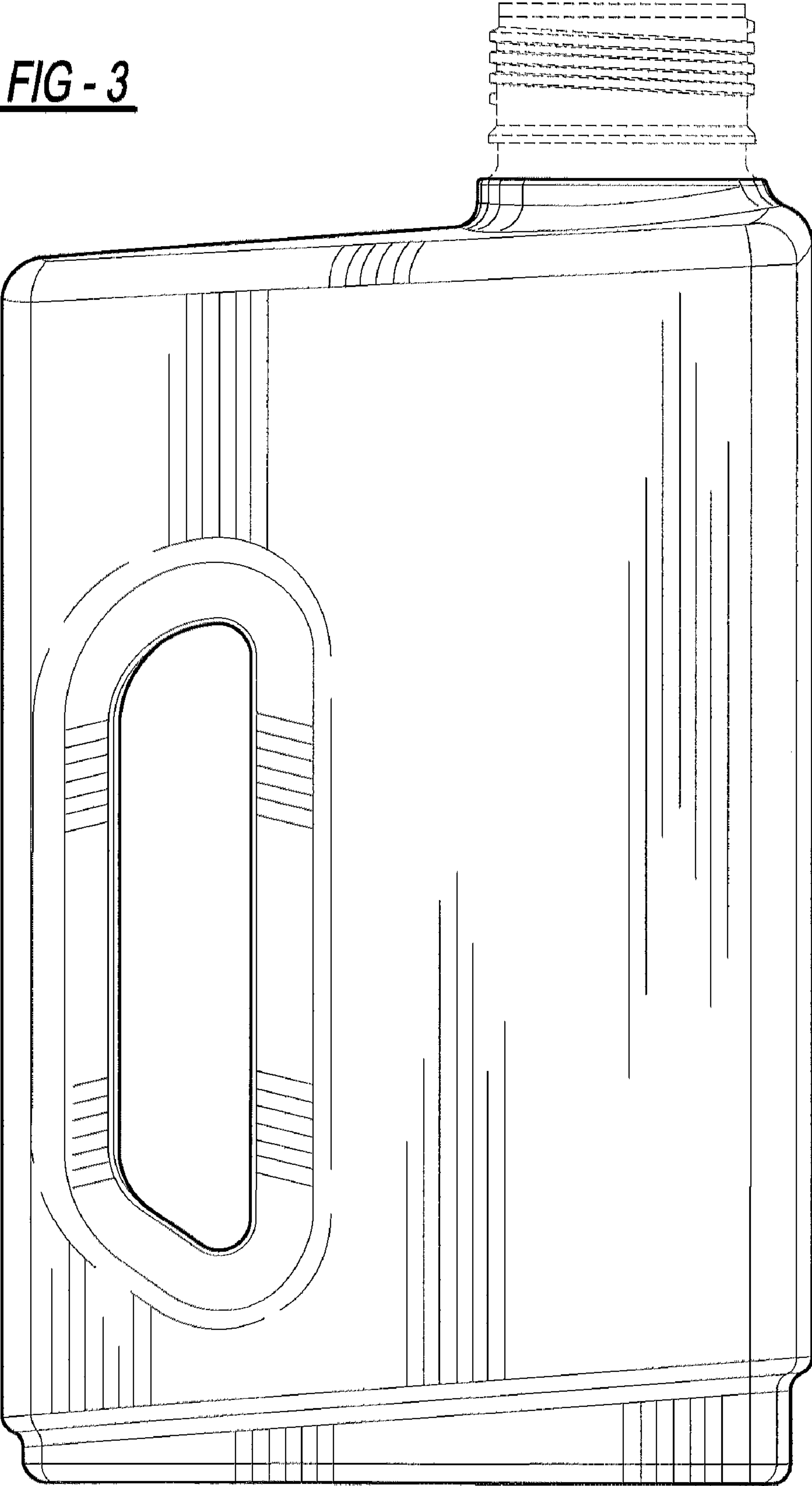

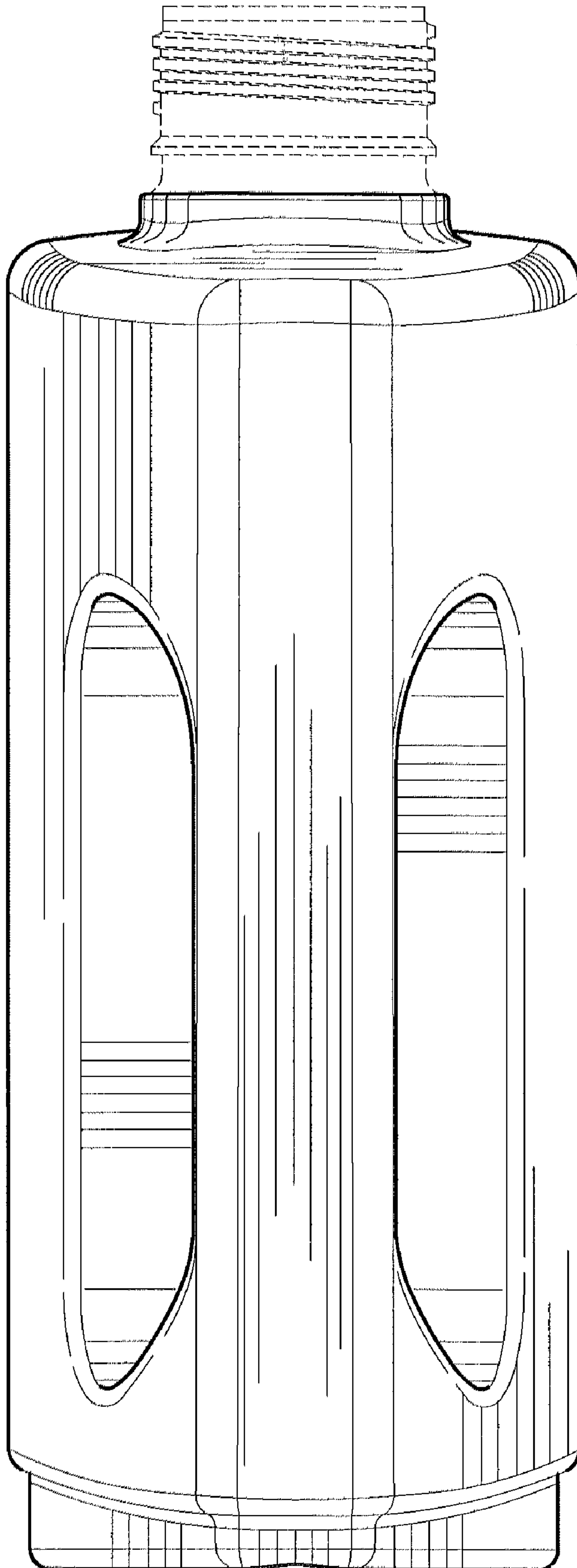

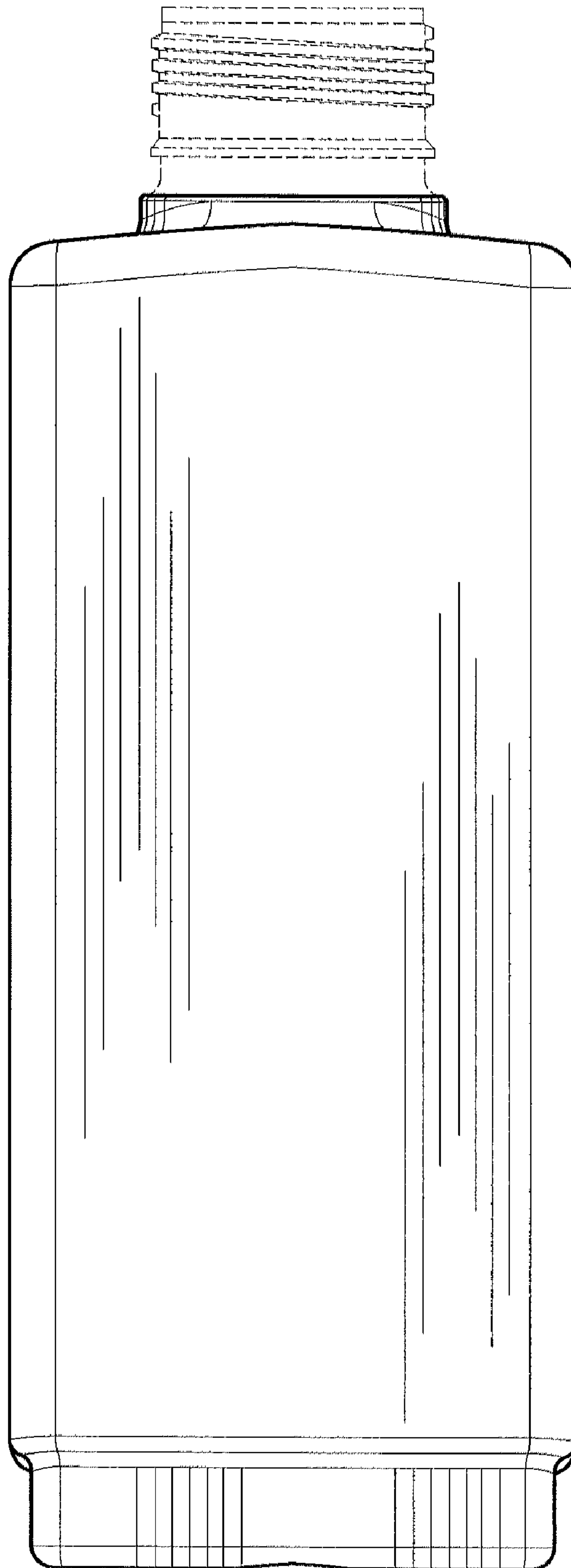

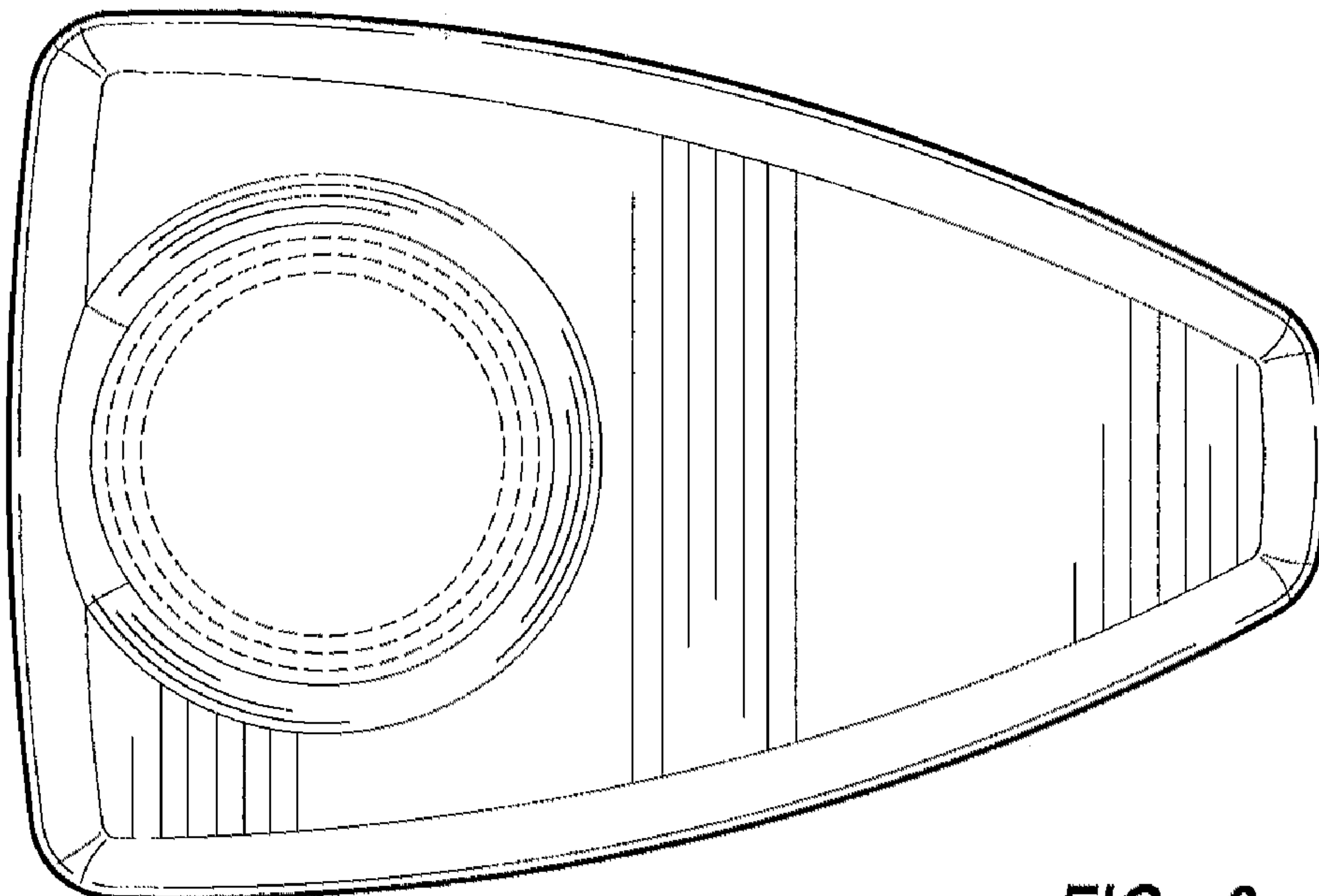

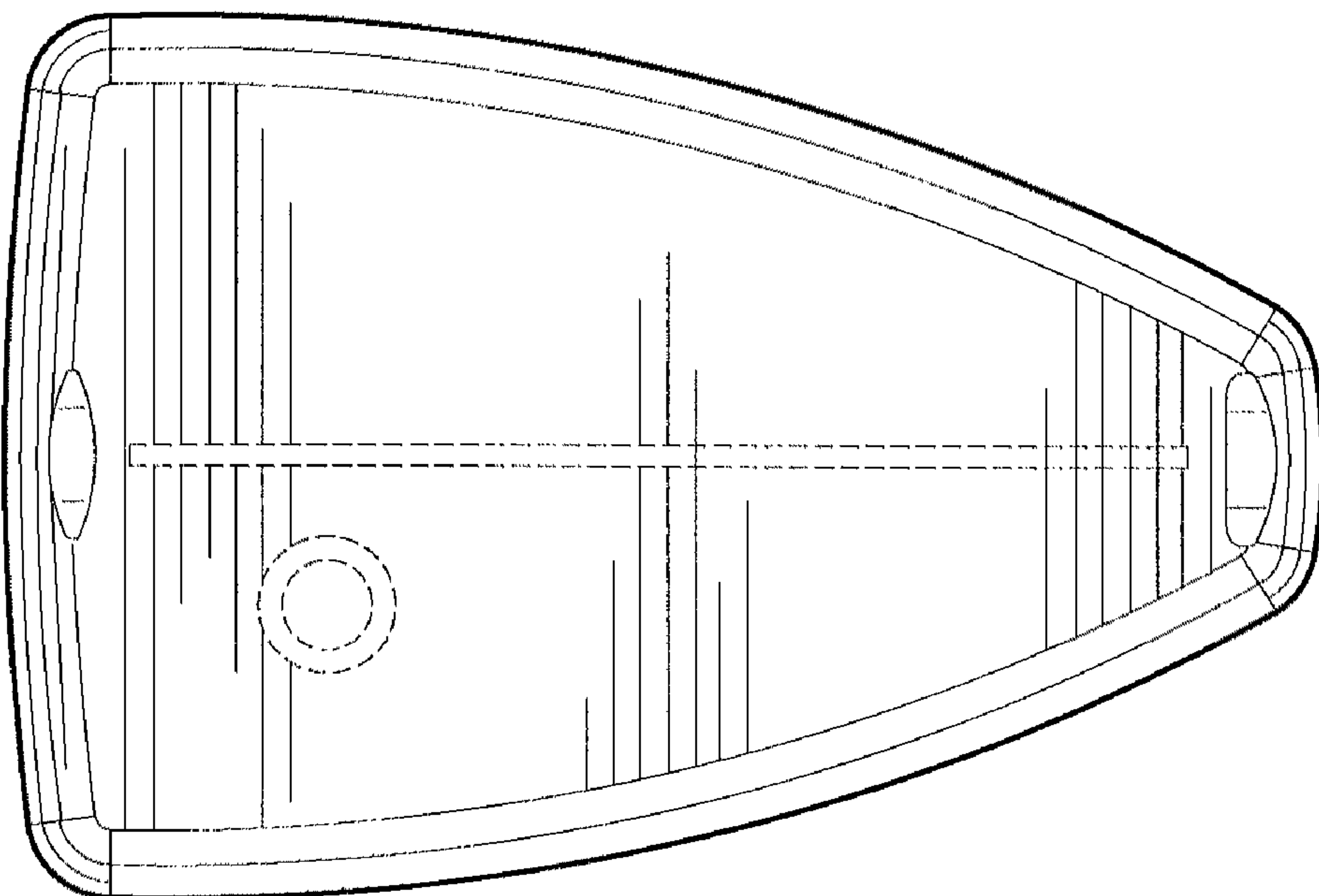
