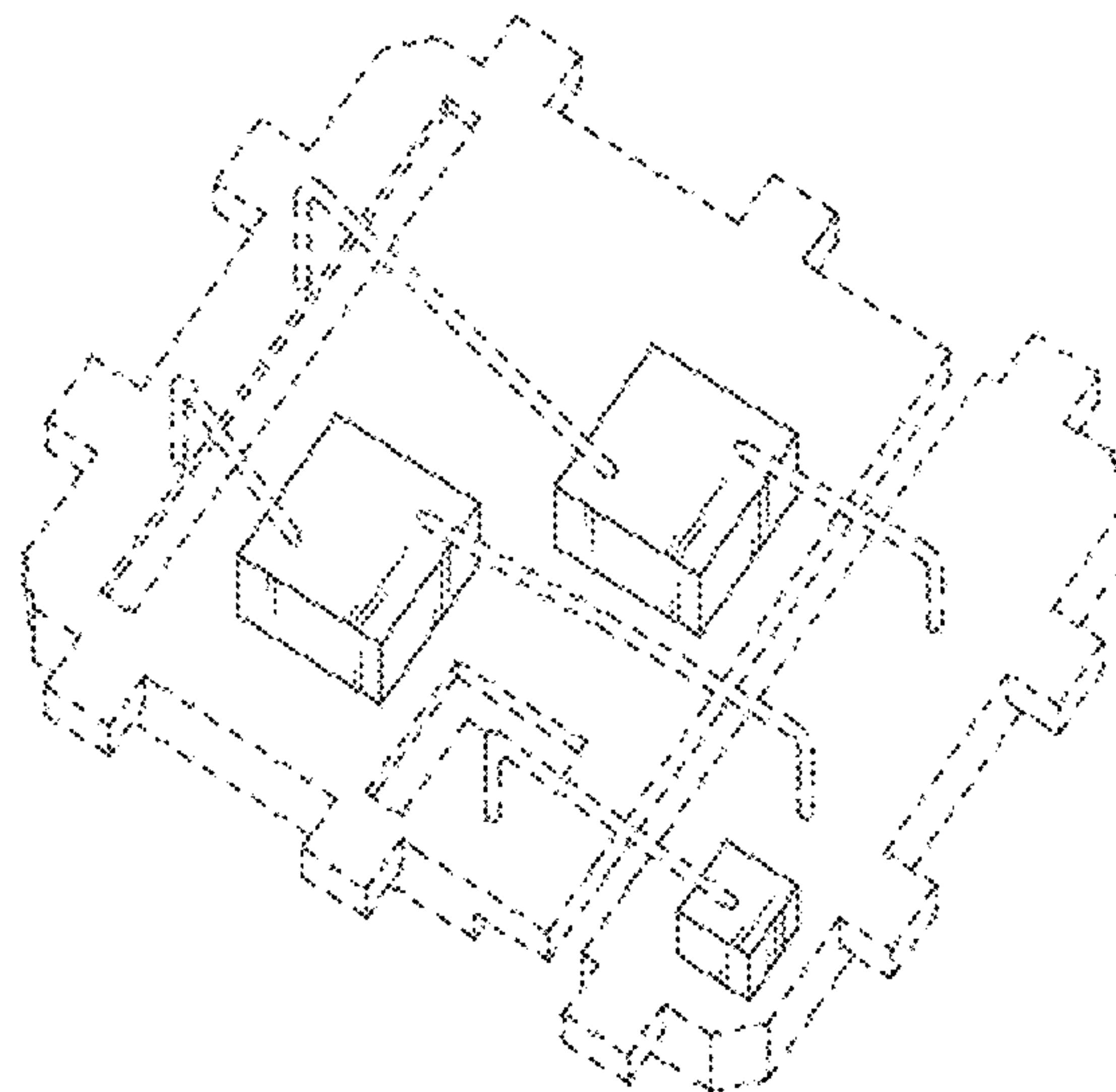
(57) **CLAIM**

The ornamental design for a portion of a light-emitting diode, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a portion of a light-emitting diode, showing our new design; FIG. 2 is a rear perspective view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a bottom plan view thereof; FIG. 7 is a right side elevational view thereof; FIG. 8 is a left side elevational view thereof; FIG. 9 is a front perspective view of a portion of a light-emitting diode of FIG. 1; and, FIG. 10 is a rear perspective view of a portion of a light-emitting diode of FIG. 1. The broken line showing of the remainder of the light-emitting diode is for illustrative purpose only and forms no part of the claimed design.

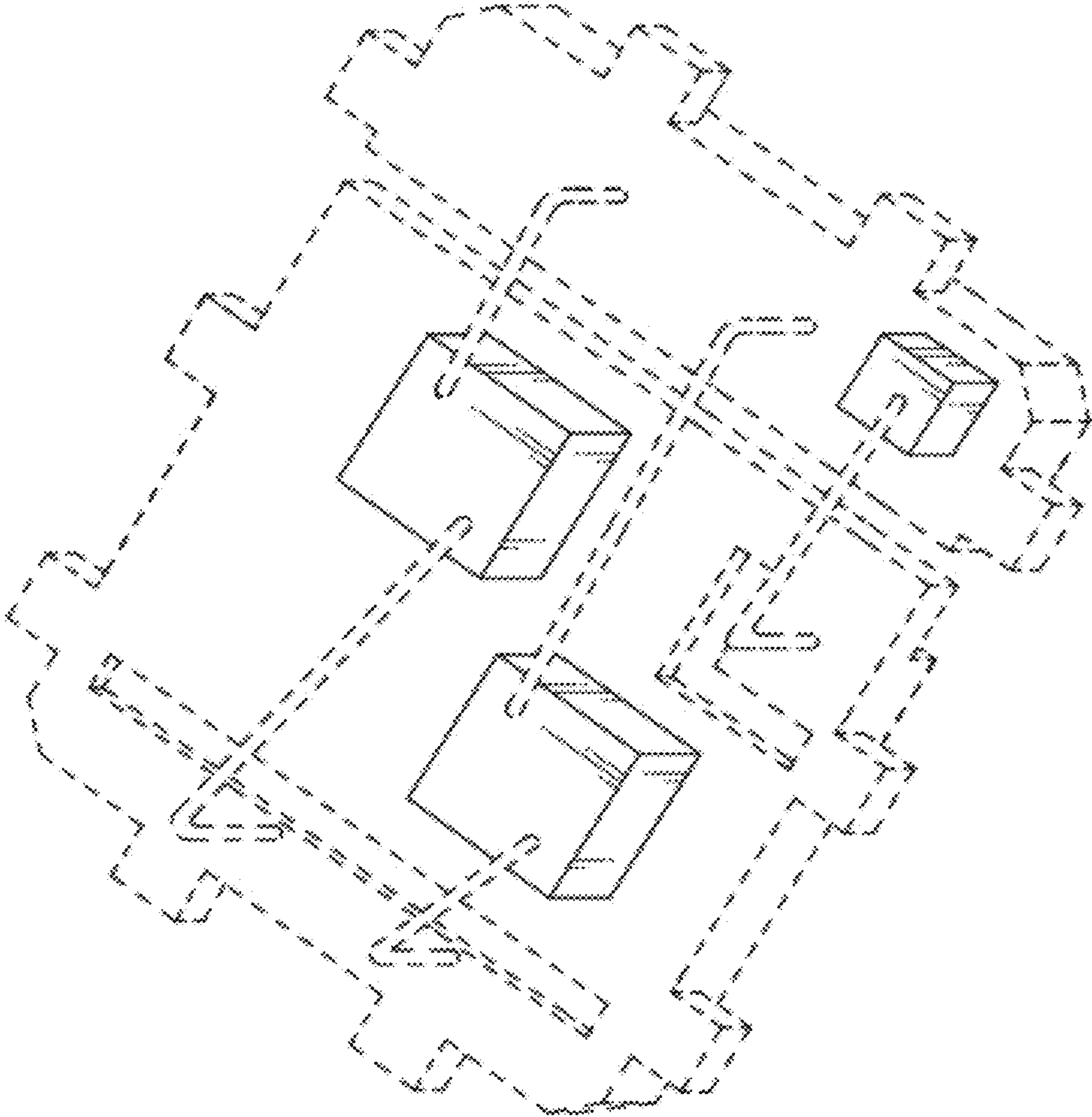

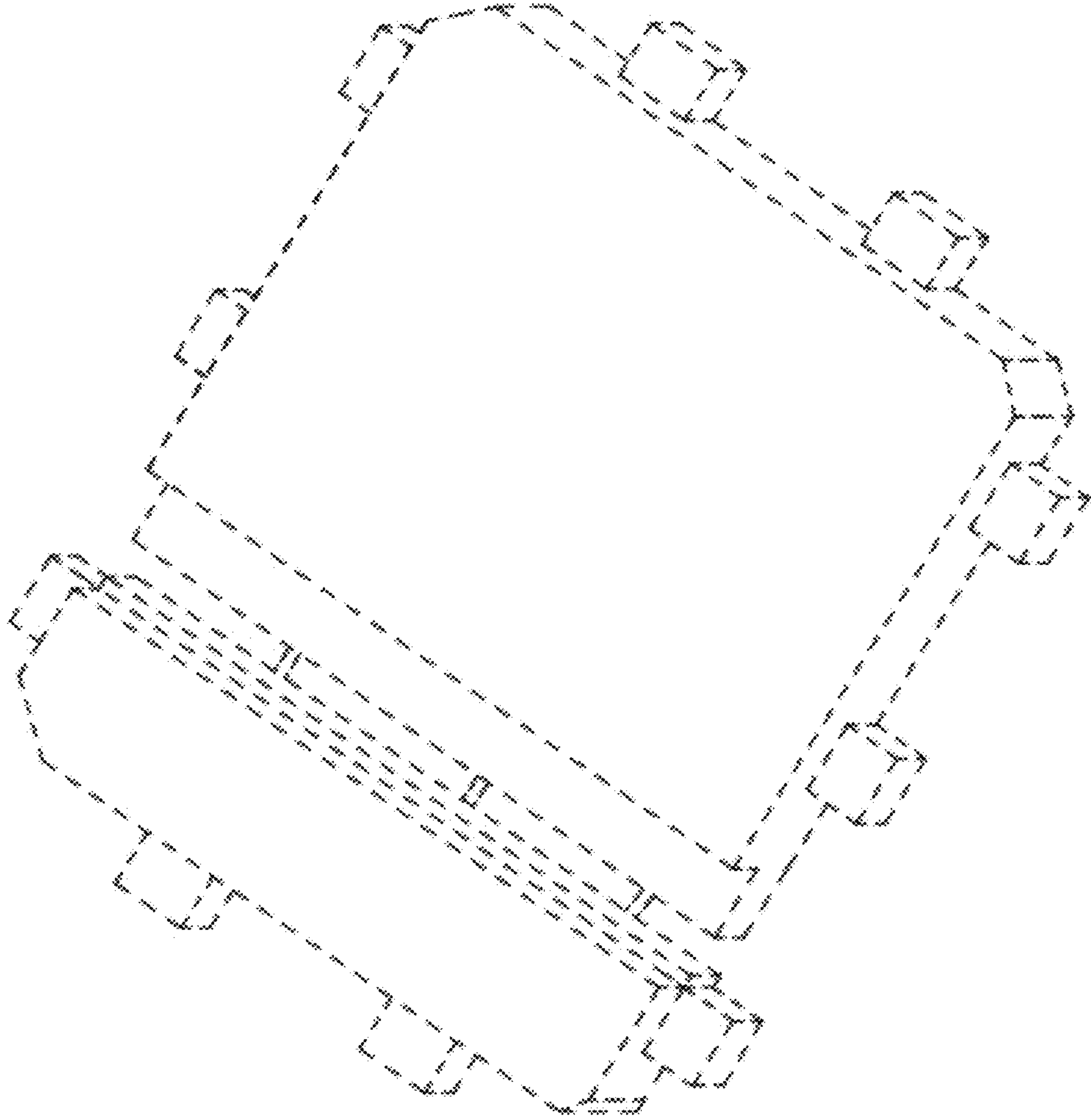

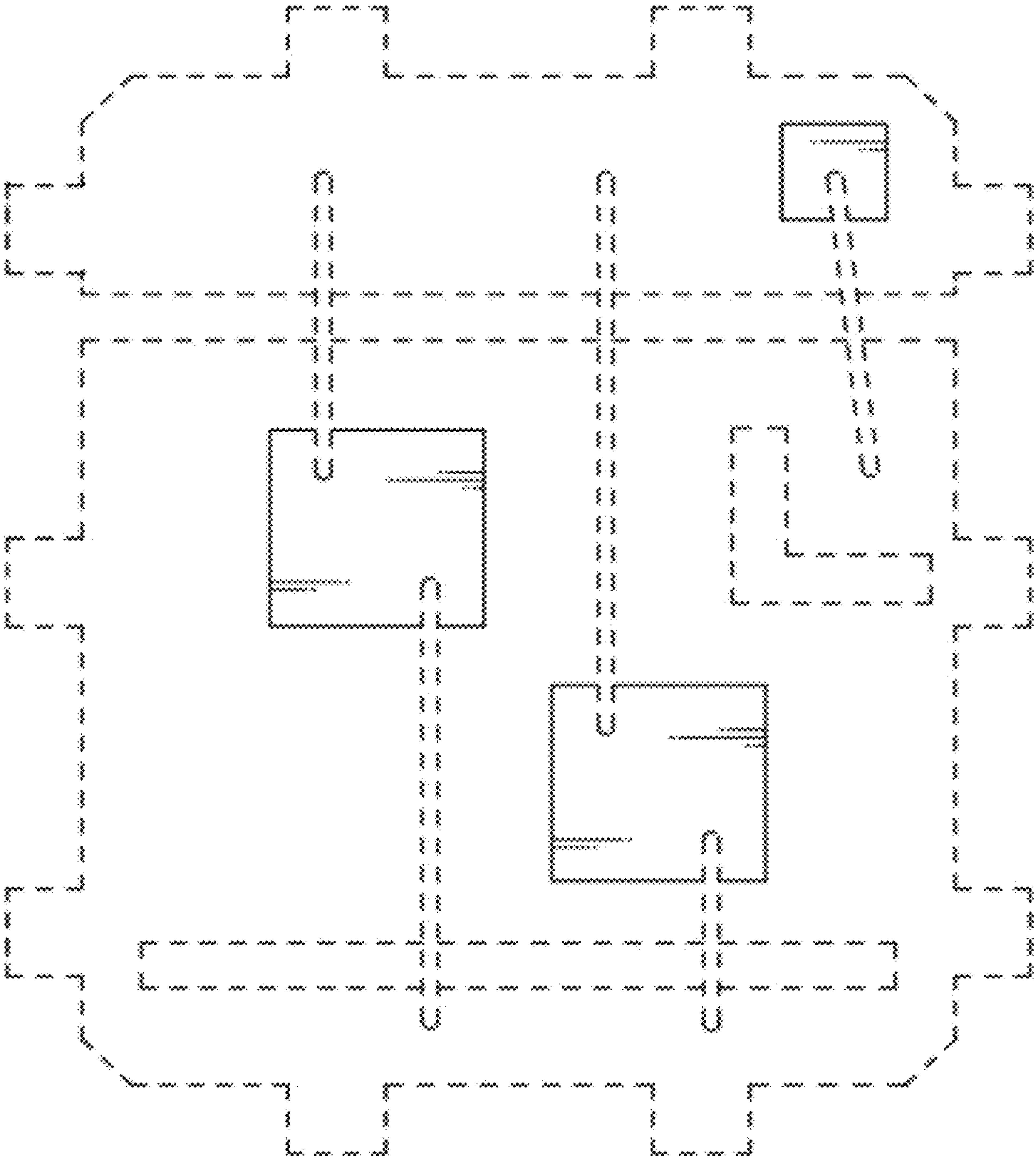

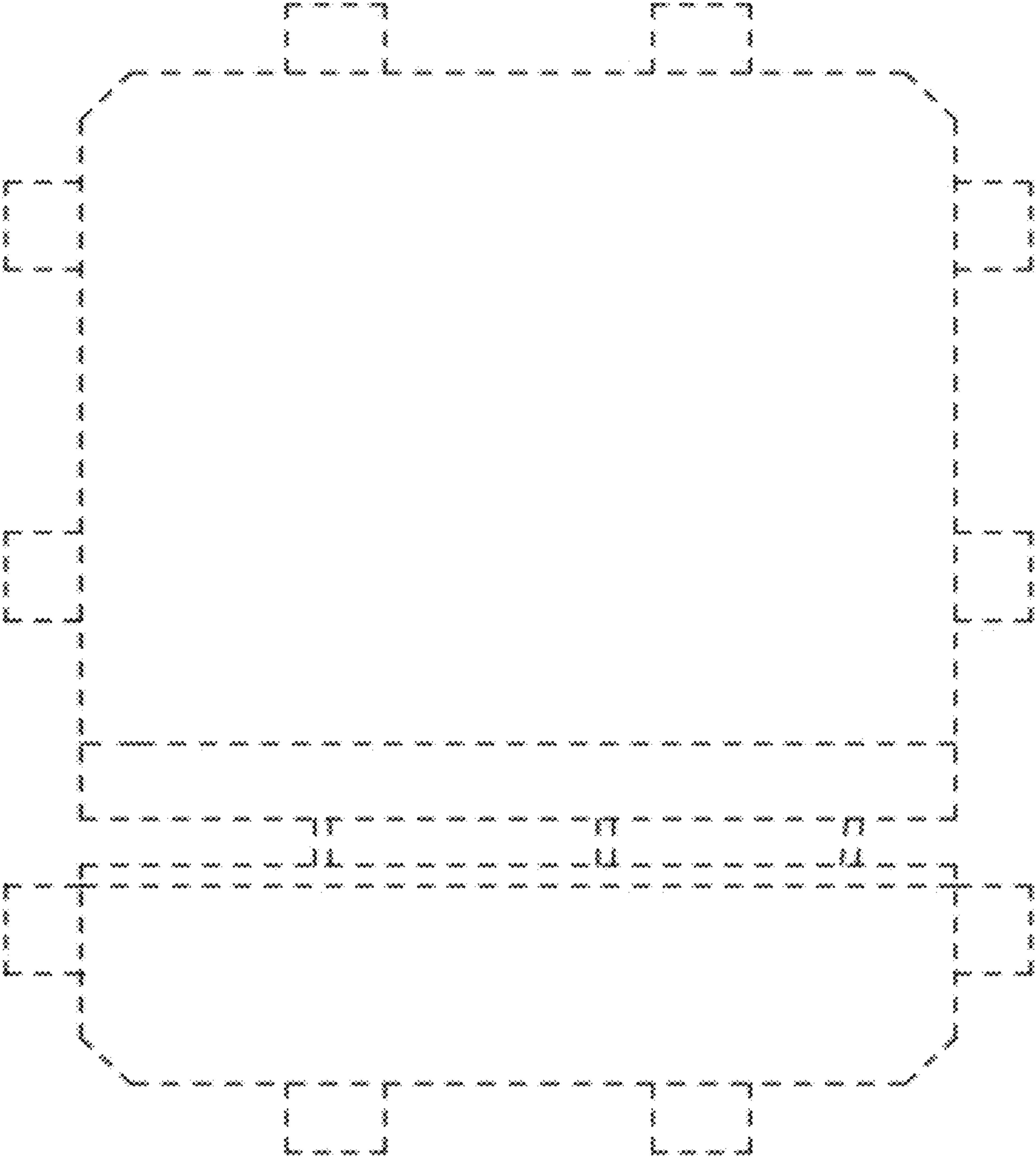

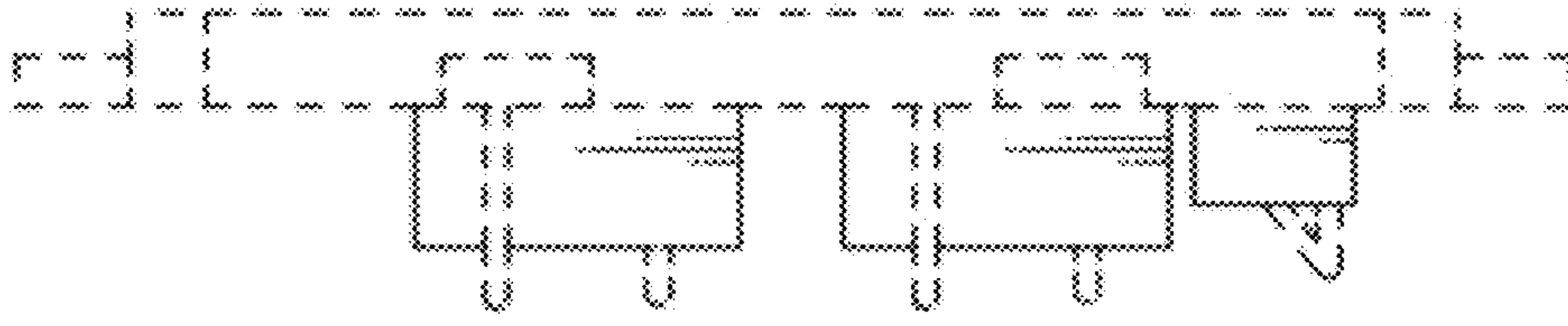

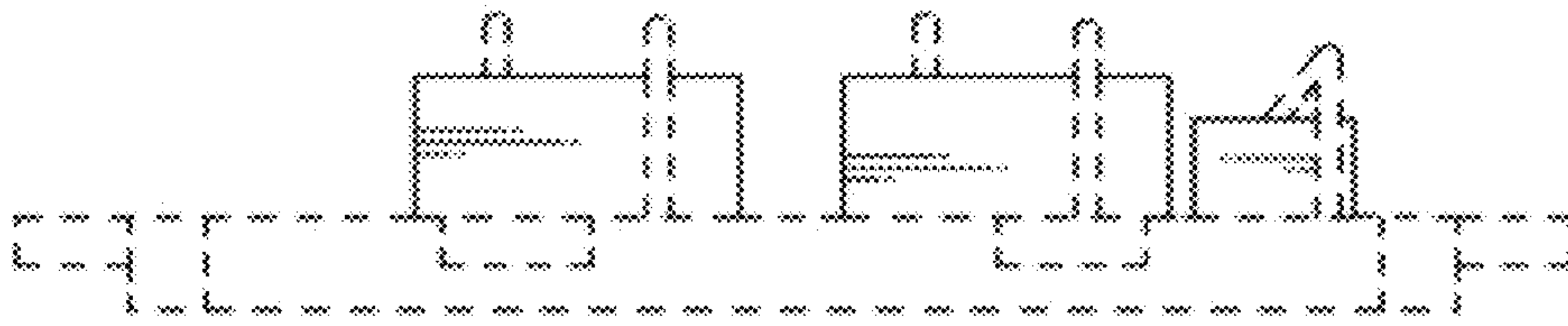

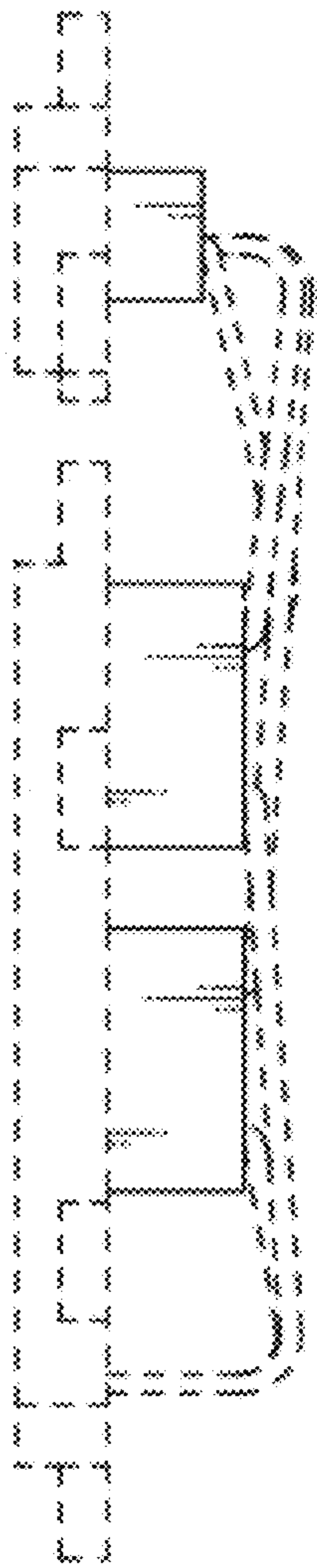

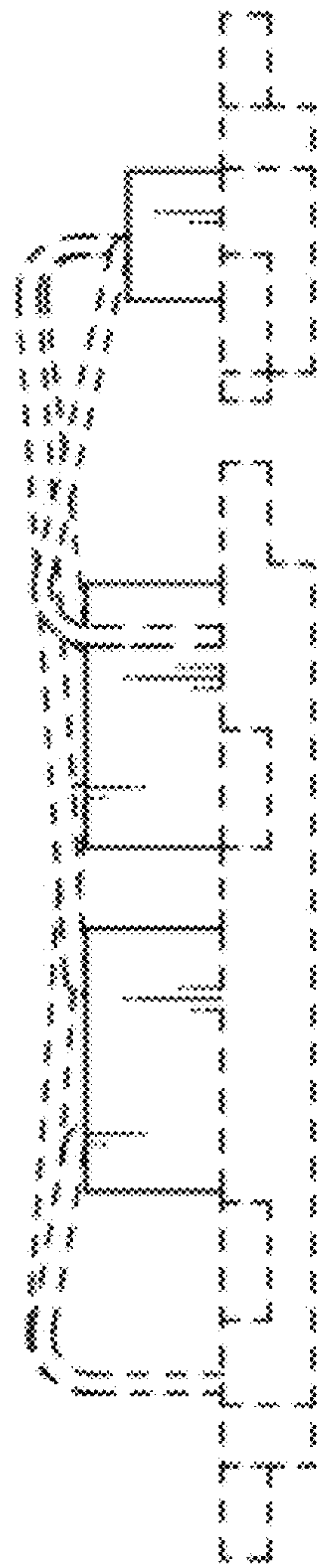

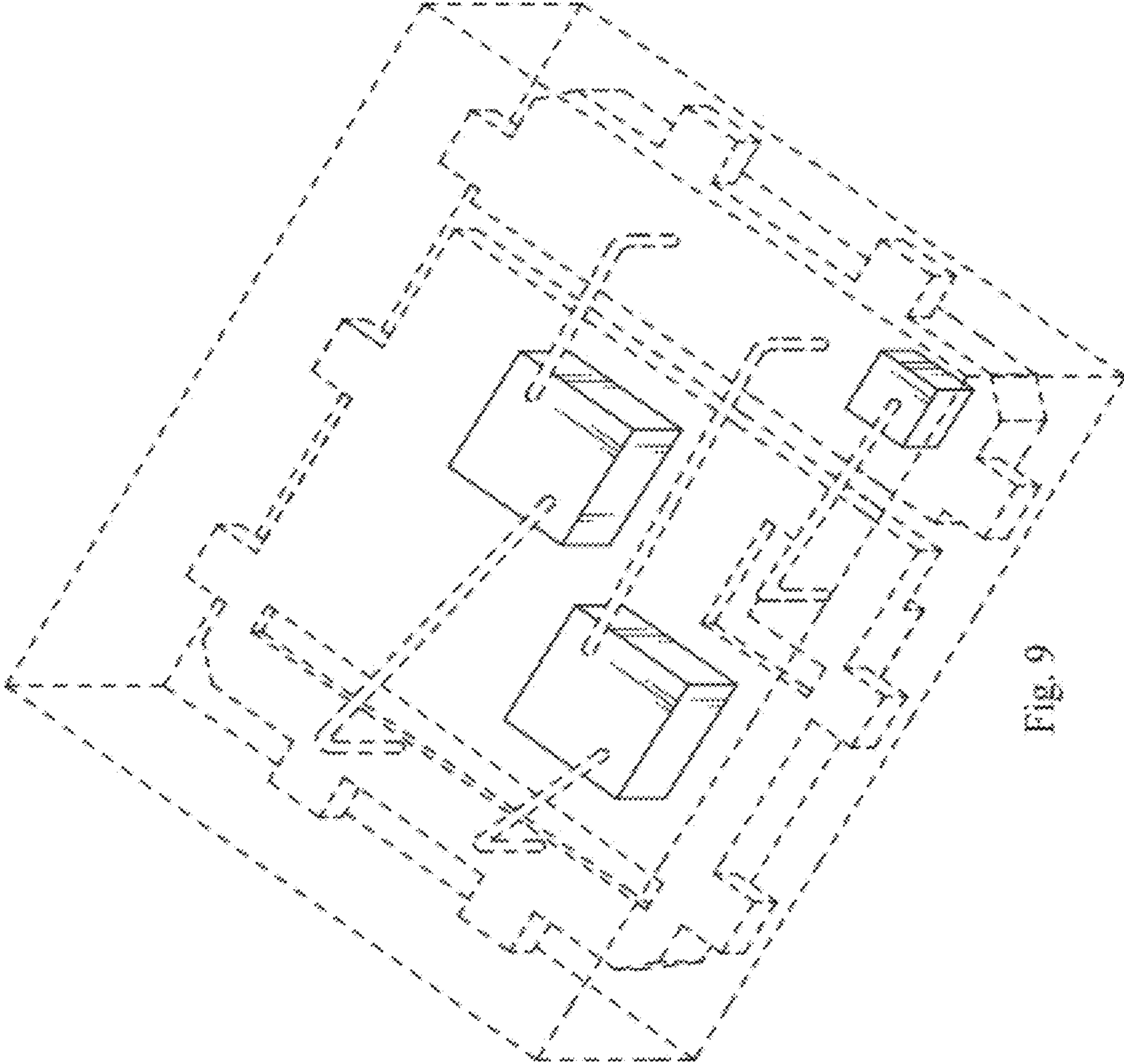

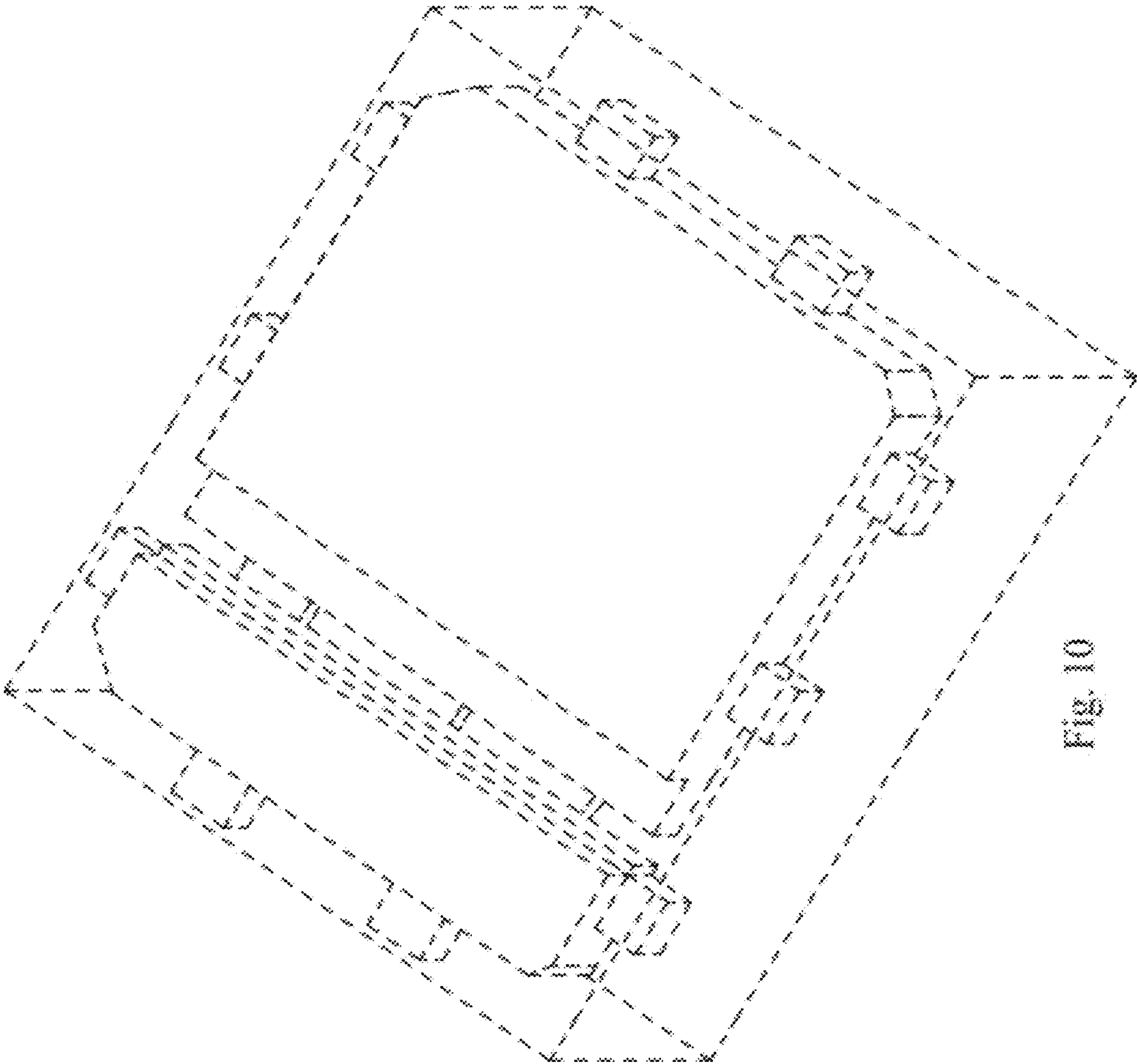
