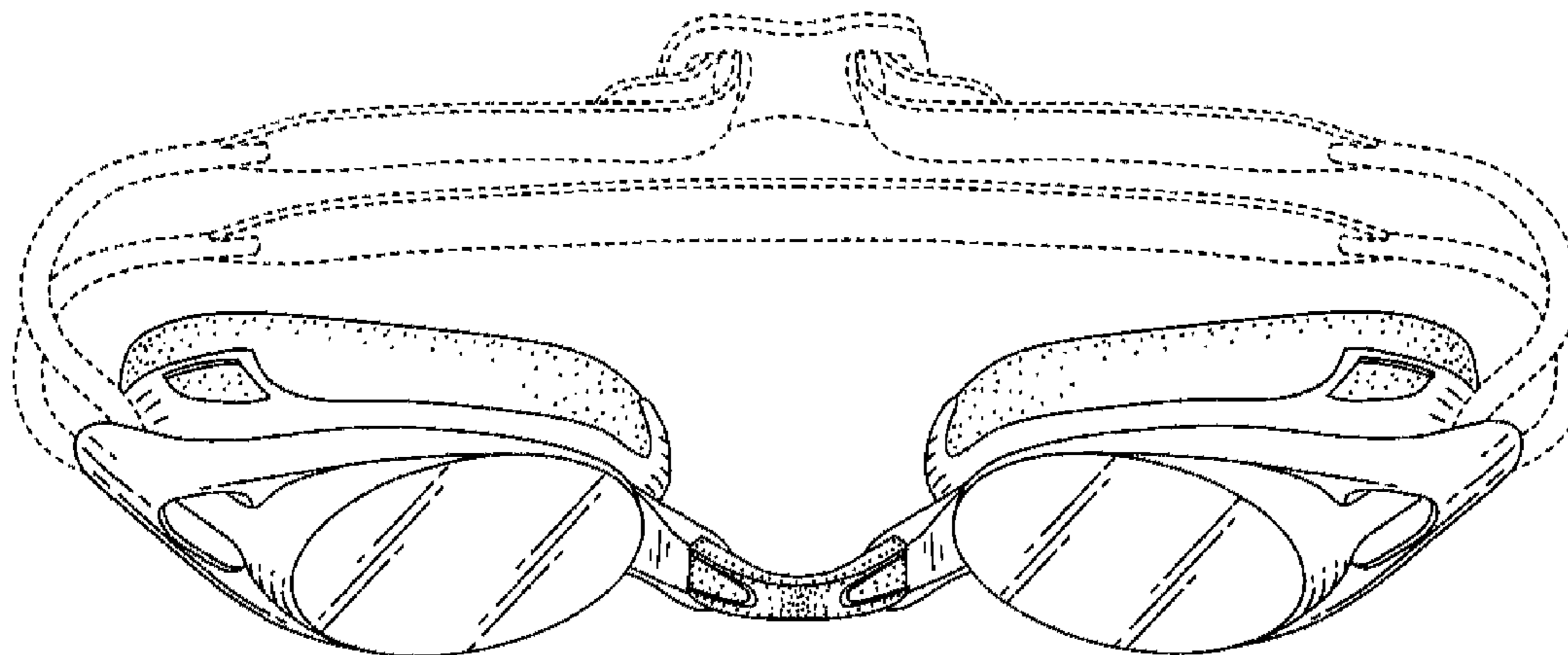
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front top perspective view of the swimming goggle of the present invention showing our new design, with the dotted lines depicting solely environmental structure and not forming any portion of the claimed design;  
FIG. 2 is a front view thereof;  
FIG. 3 is a rear view thereof;  
FIG. 4 is a top plan view thereof; and,  
FIG. 5 is a side elevational view thereof.

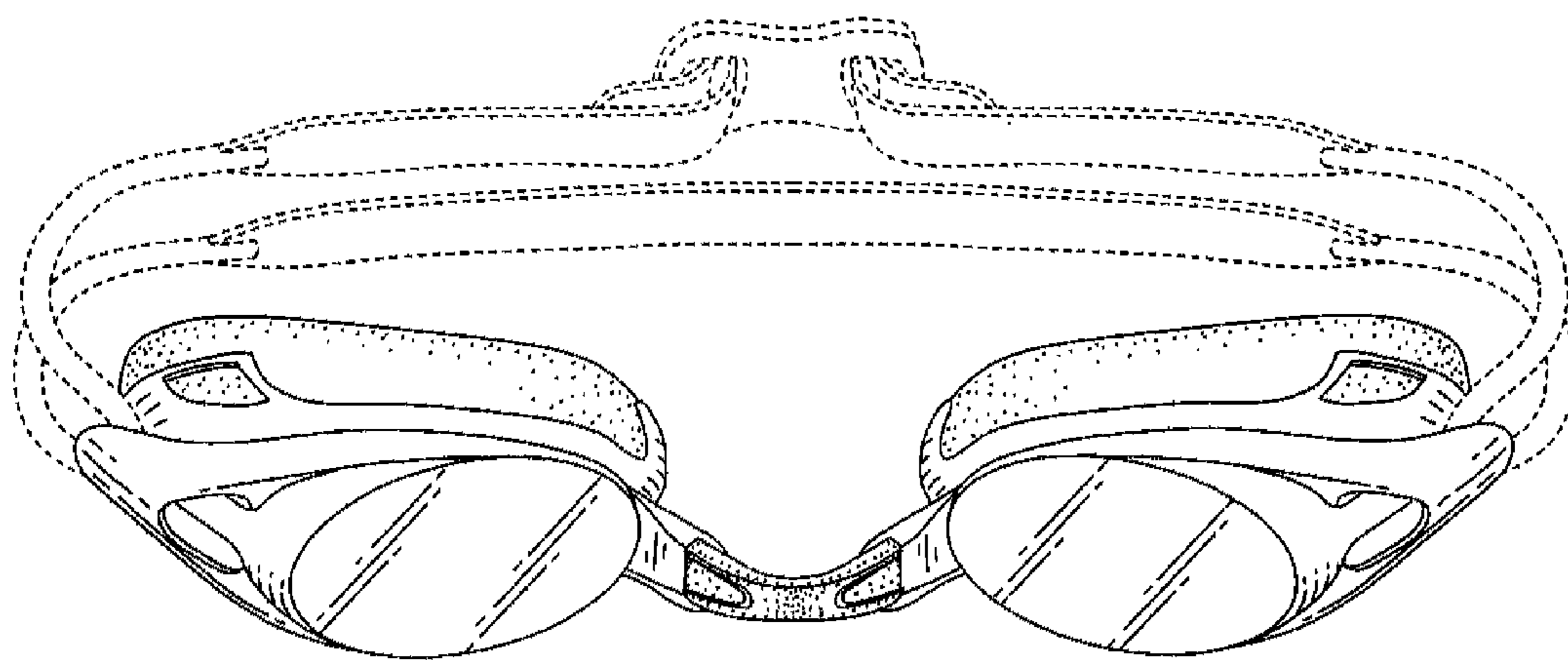

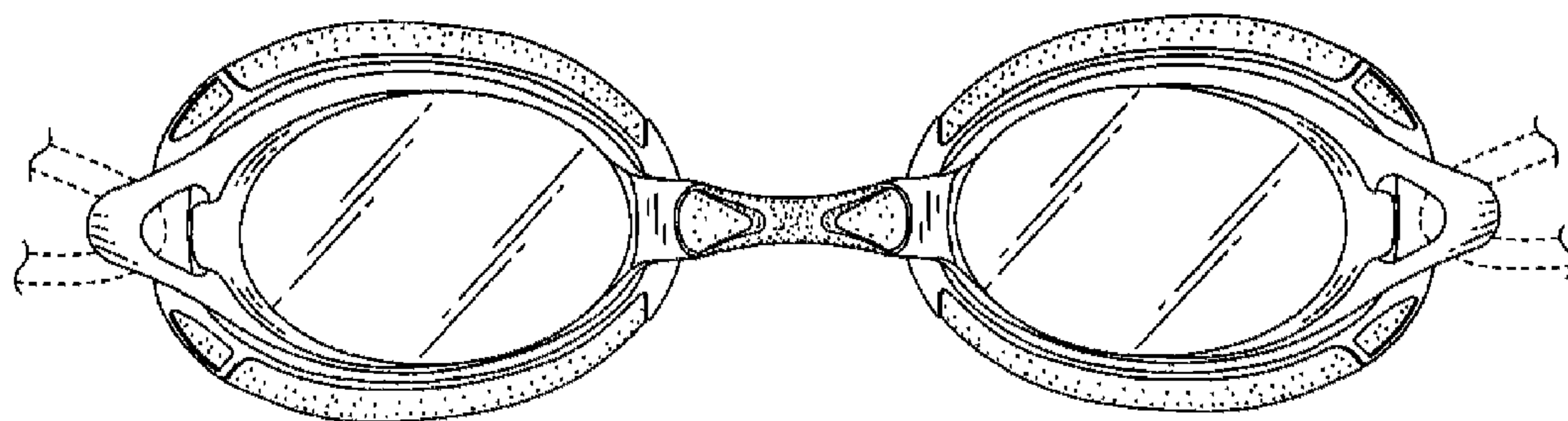

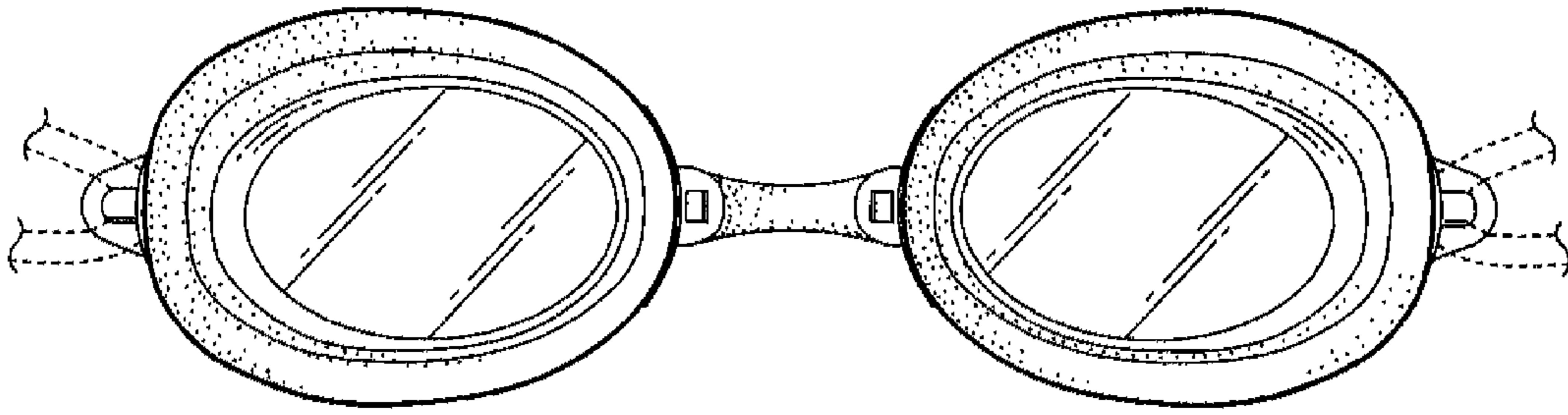

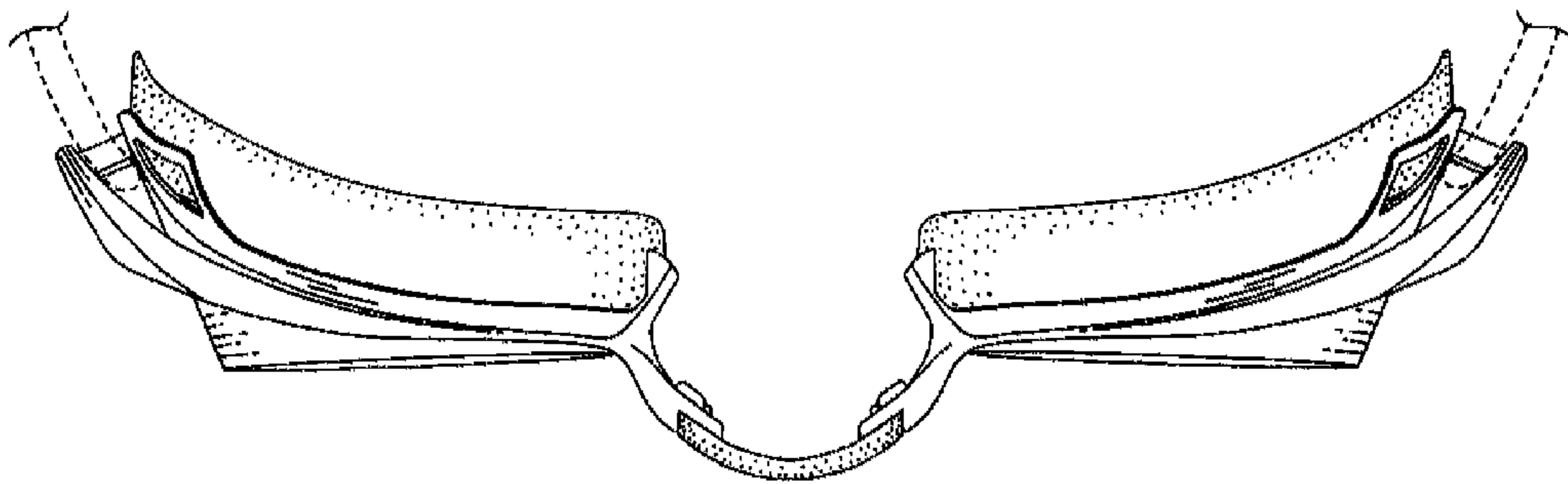

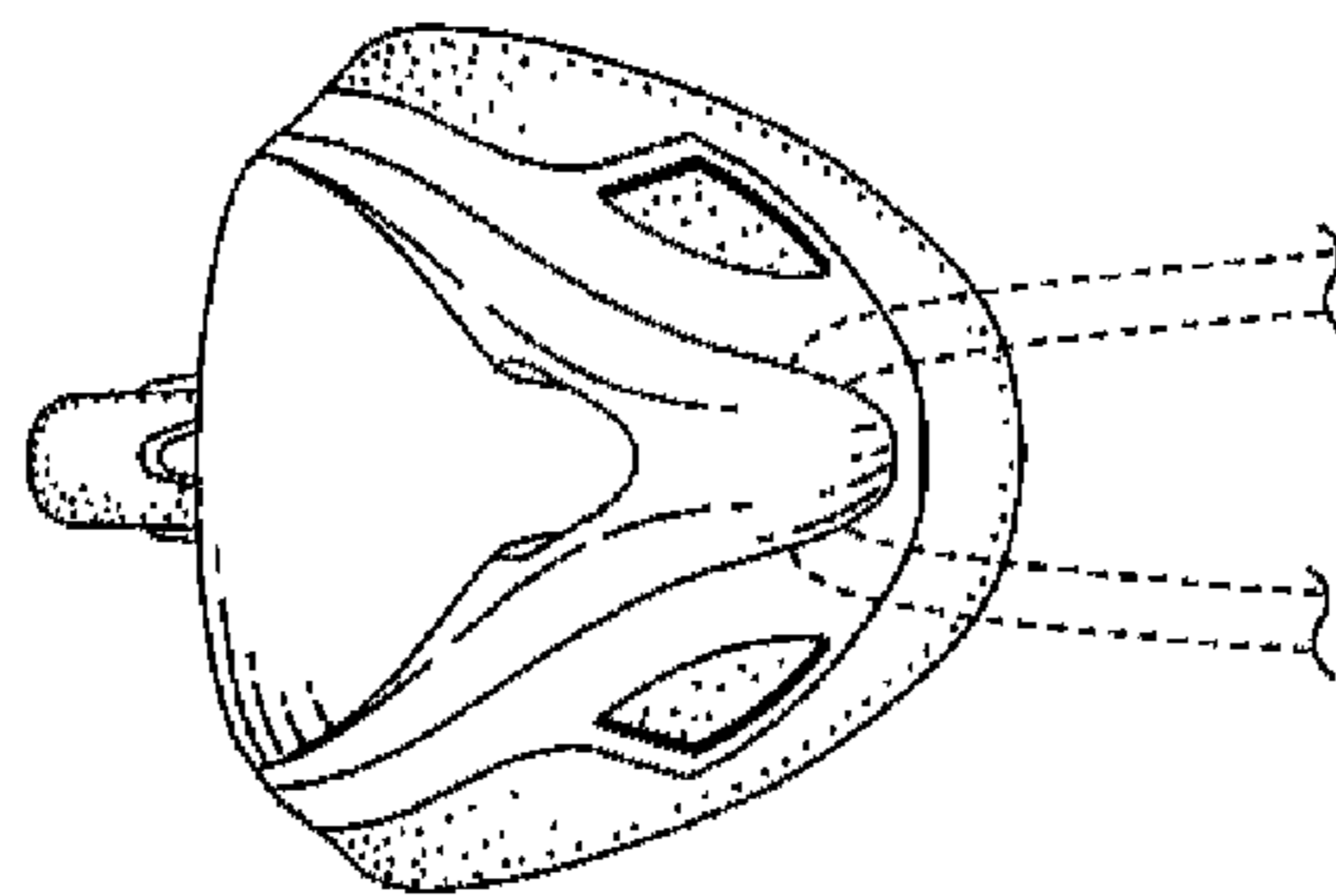
