The ornamental design for a doll compartment, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a valve, showing my new design;

FIG. 2 is a front elevational view of the doll compartment shown in FIG. 1;

FIG. 3 is a rear elevational view of the doll compartment shown in FIG. 1;

FIG. 4 is a left-side elevational view of the doll compartment shown in FIG. 1;

FIG. 5 is a right-side elevational view of the doll compartment shown in FIG. 1;


FIG. 6 is a top plan view of the doll compartment shown in FIG. 1;














