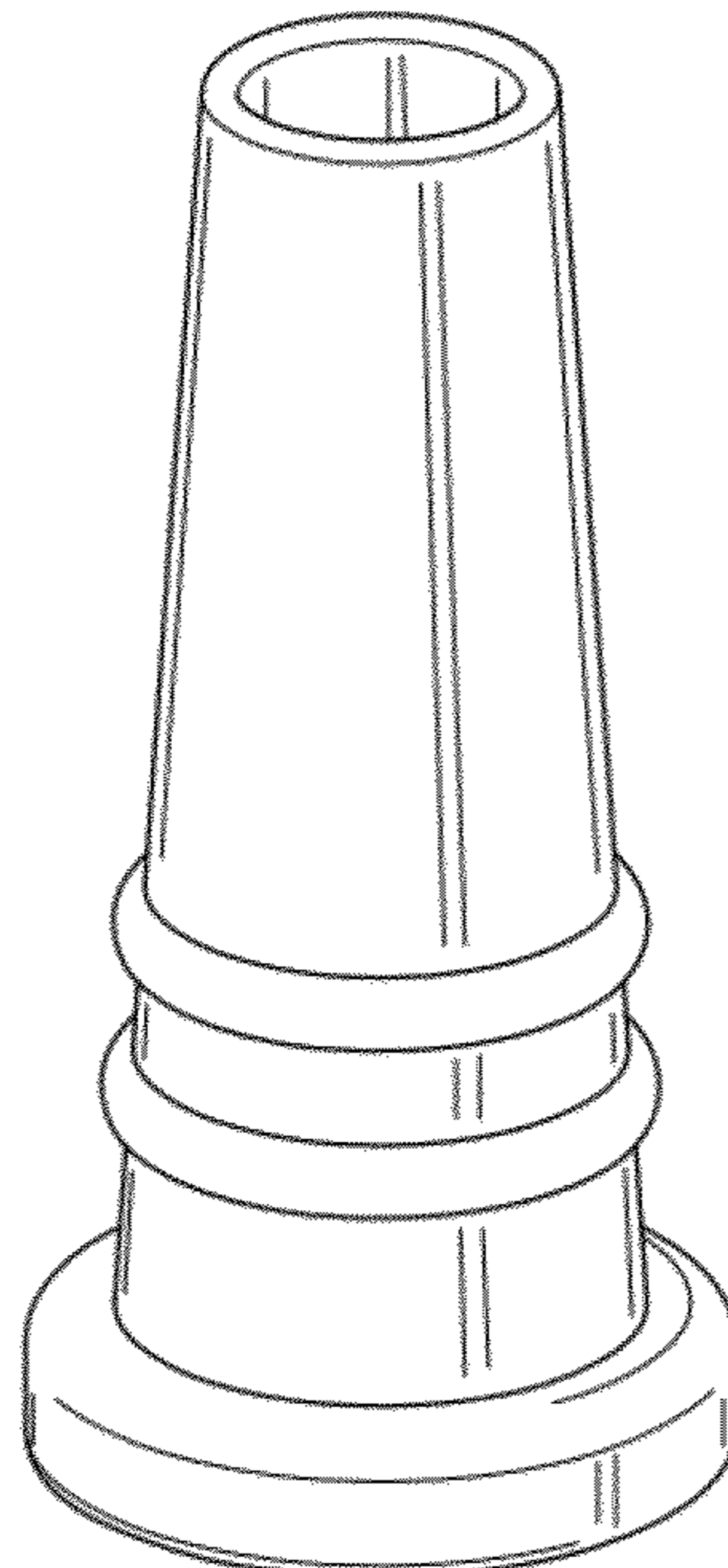
(57) **CLAIM**  
The ornamental design for a water pipe mouthpiece, as shown and described.

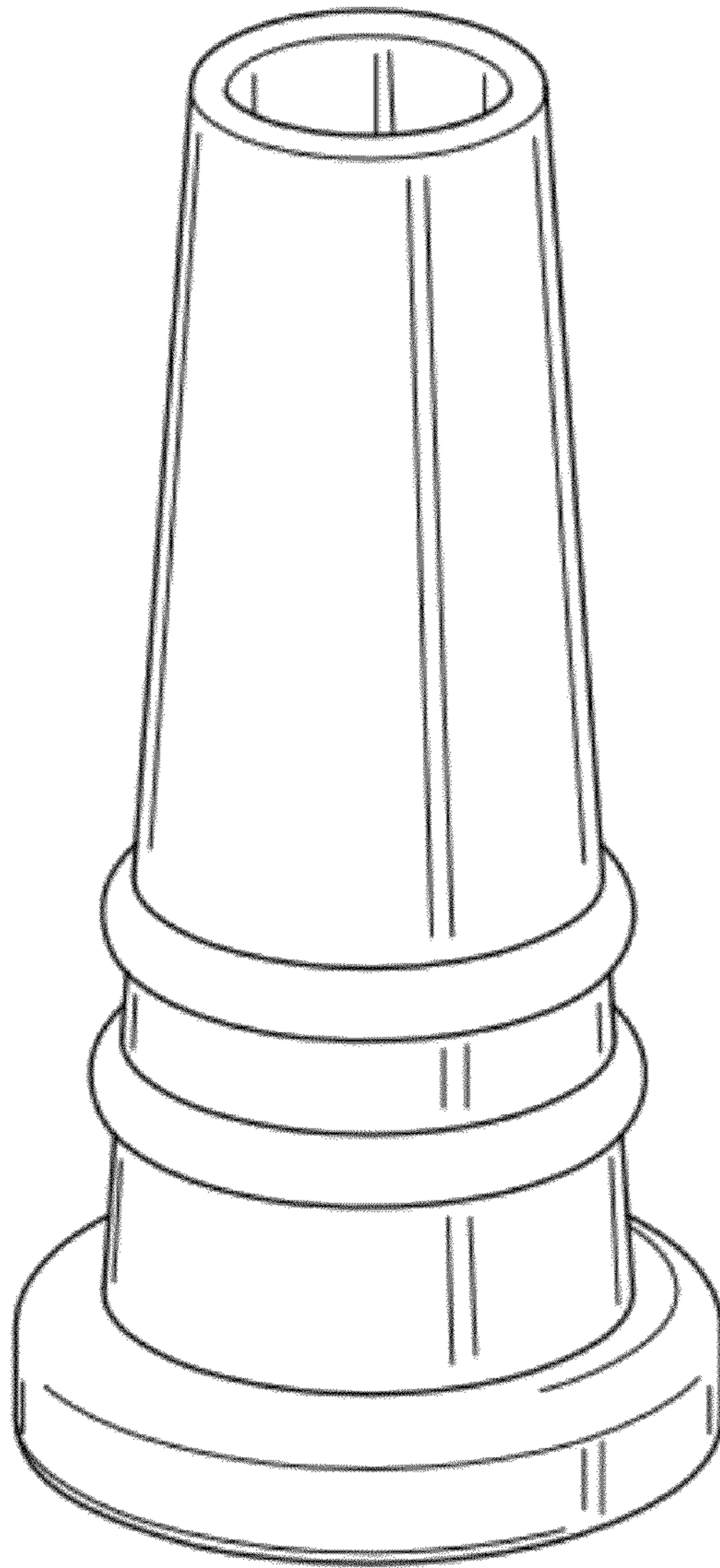
**DESCRIPTION**

FIG. 1 is a perspective view of the water pipe mouthpiece with a filter shown in broken lines.  
FIG. 2 is a front elevational view thereof.  
FIG. 3 is a rear elevational view thereof.  
FIG. 4 is a right side elevational view thereof.  
FIG. 5 is a left side elevational view thereof.  
FIG. 6 is a top plan view thereof; and,  
FIG. 7 is a bottom plan view thereof.  
The broken lines shown in the drawings illustrate portions of the water pipe mouthpiece that form no part of the claimed design.

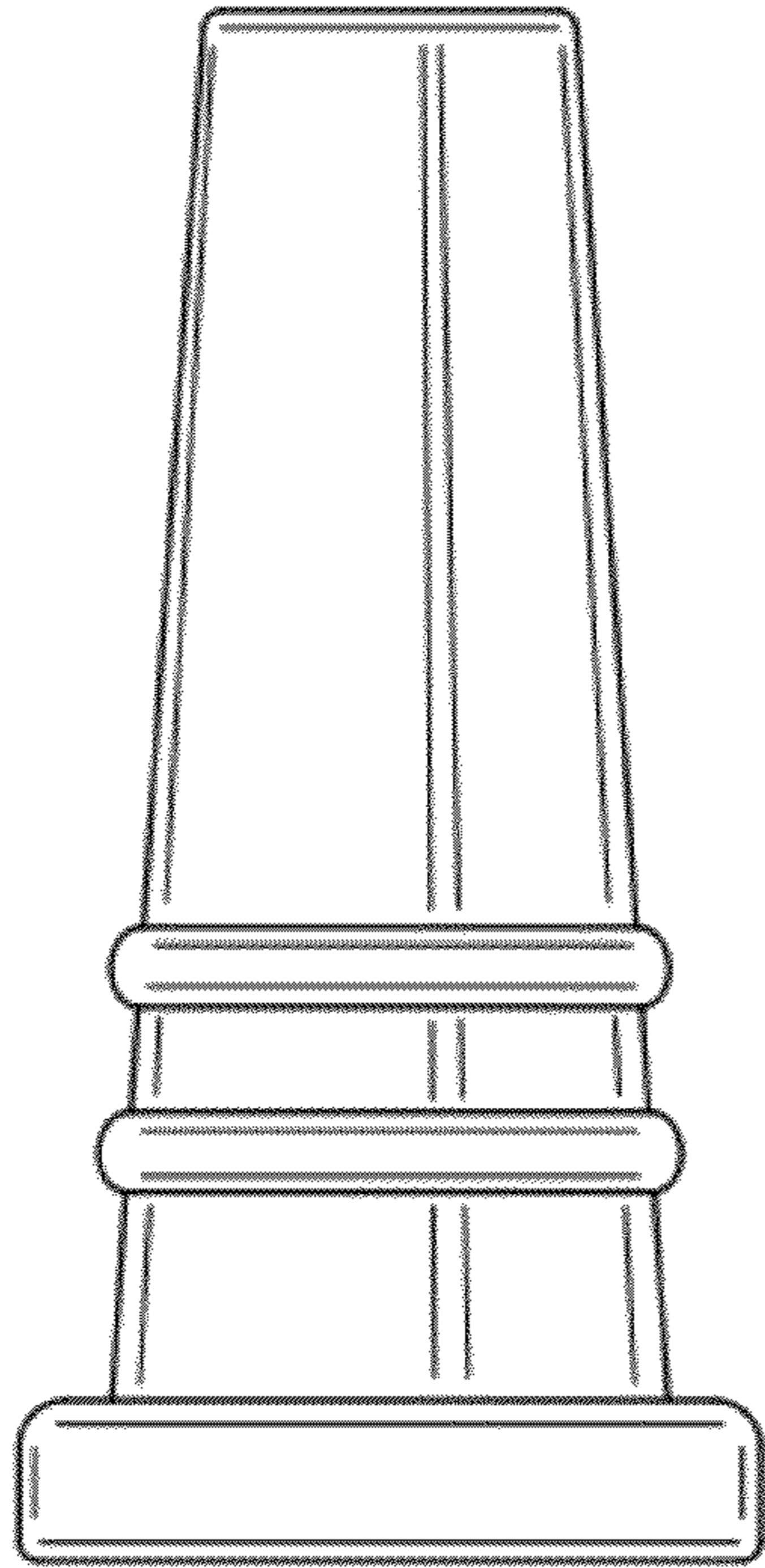

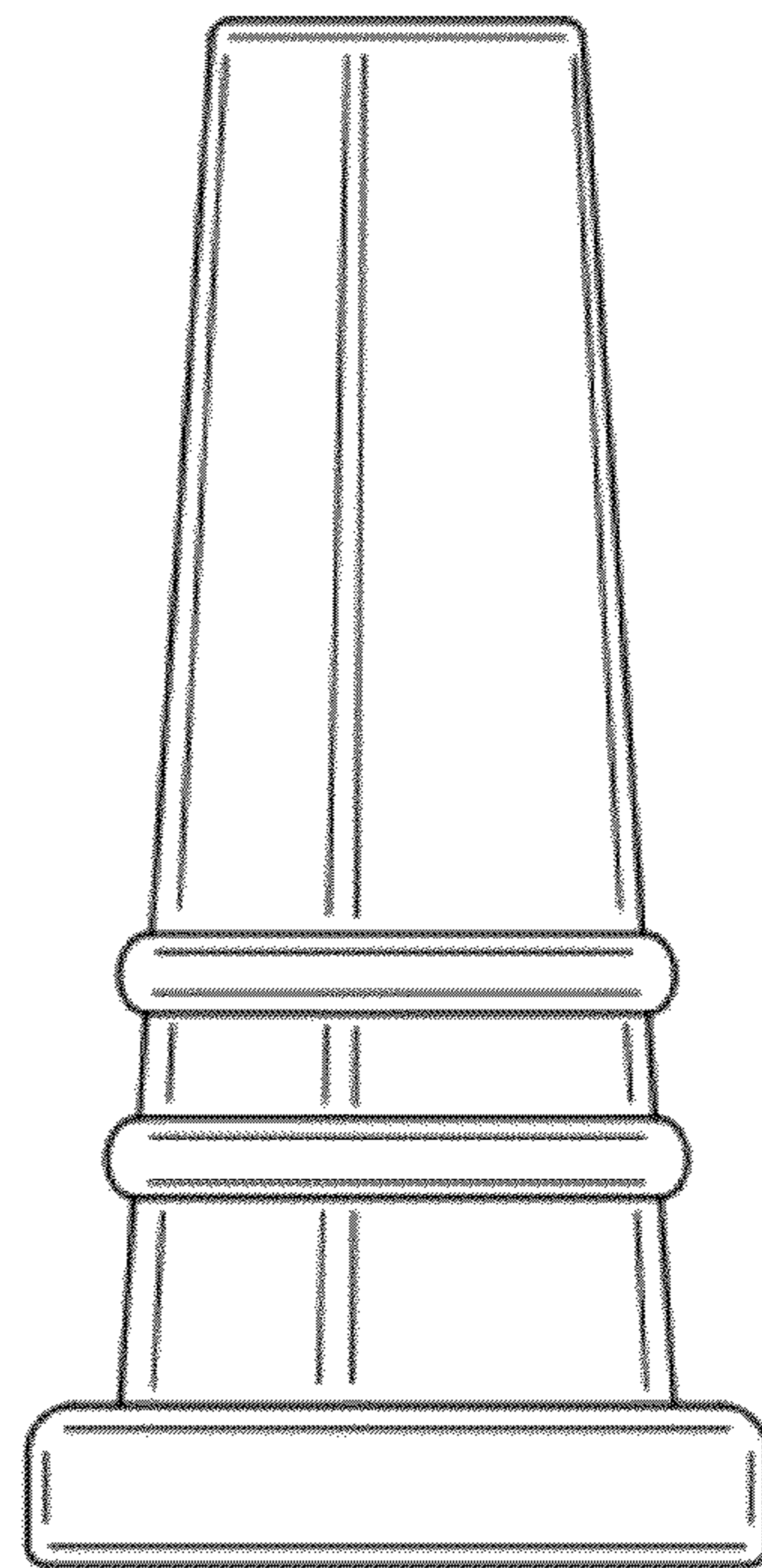




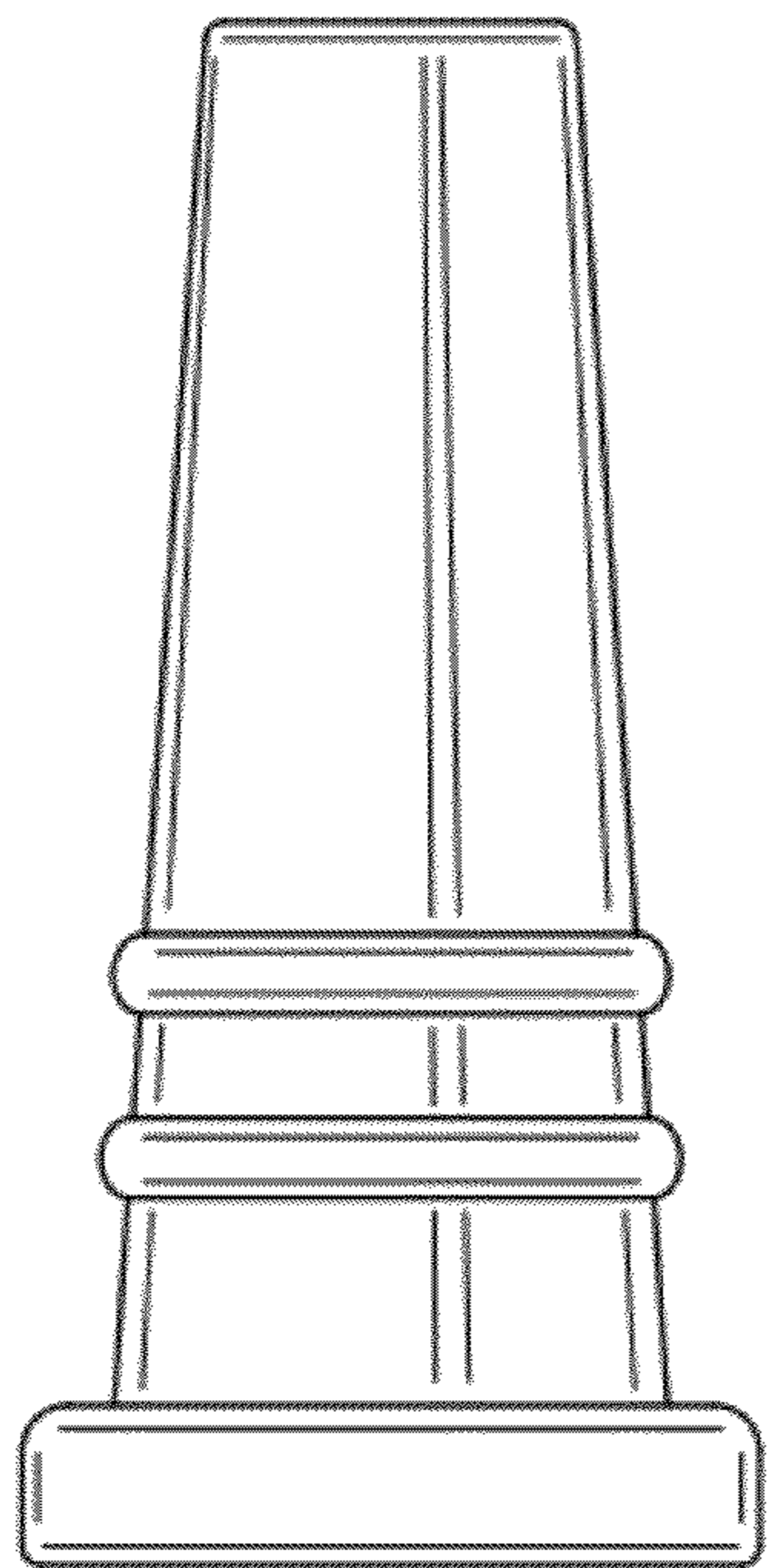

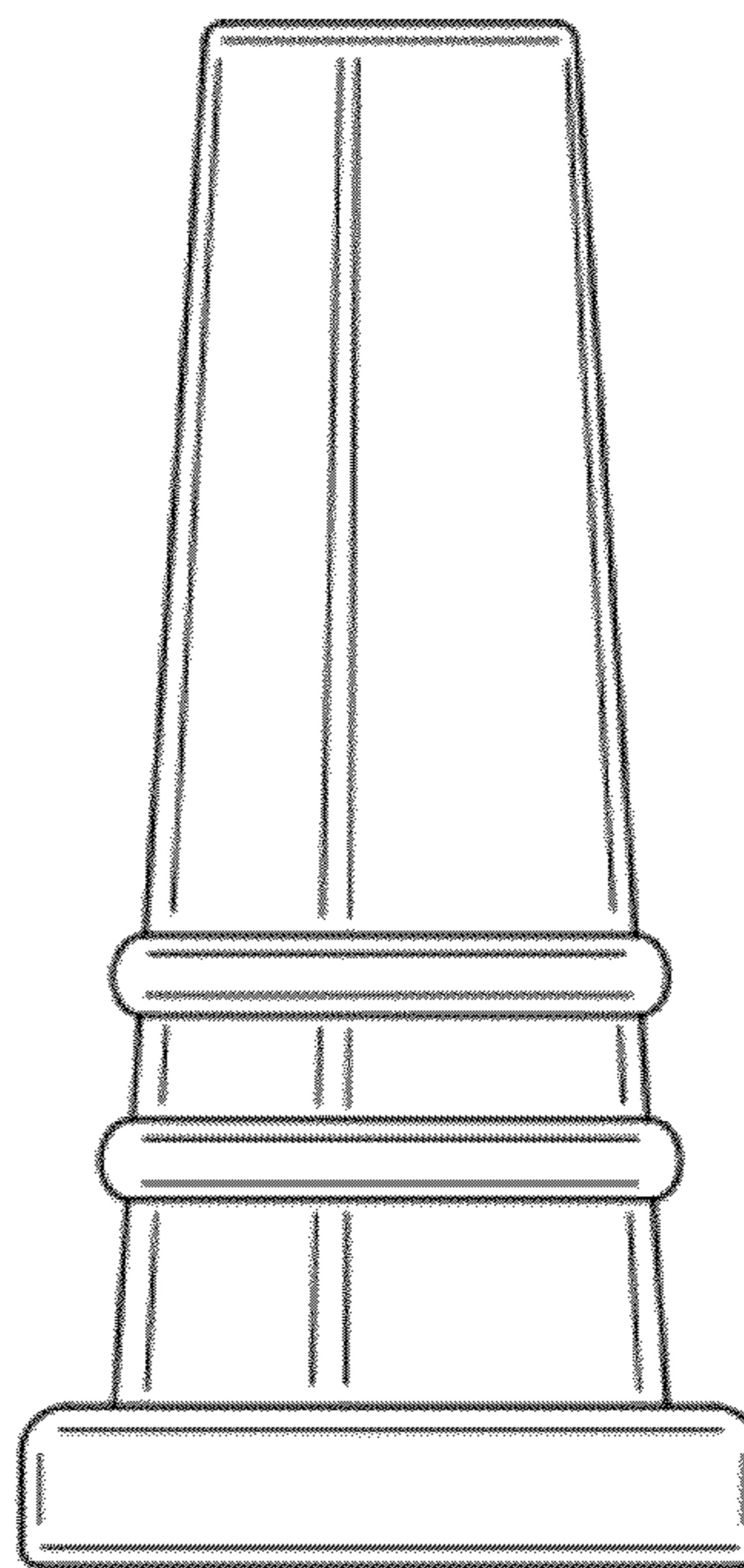

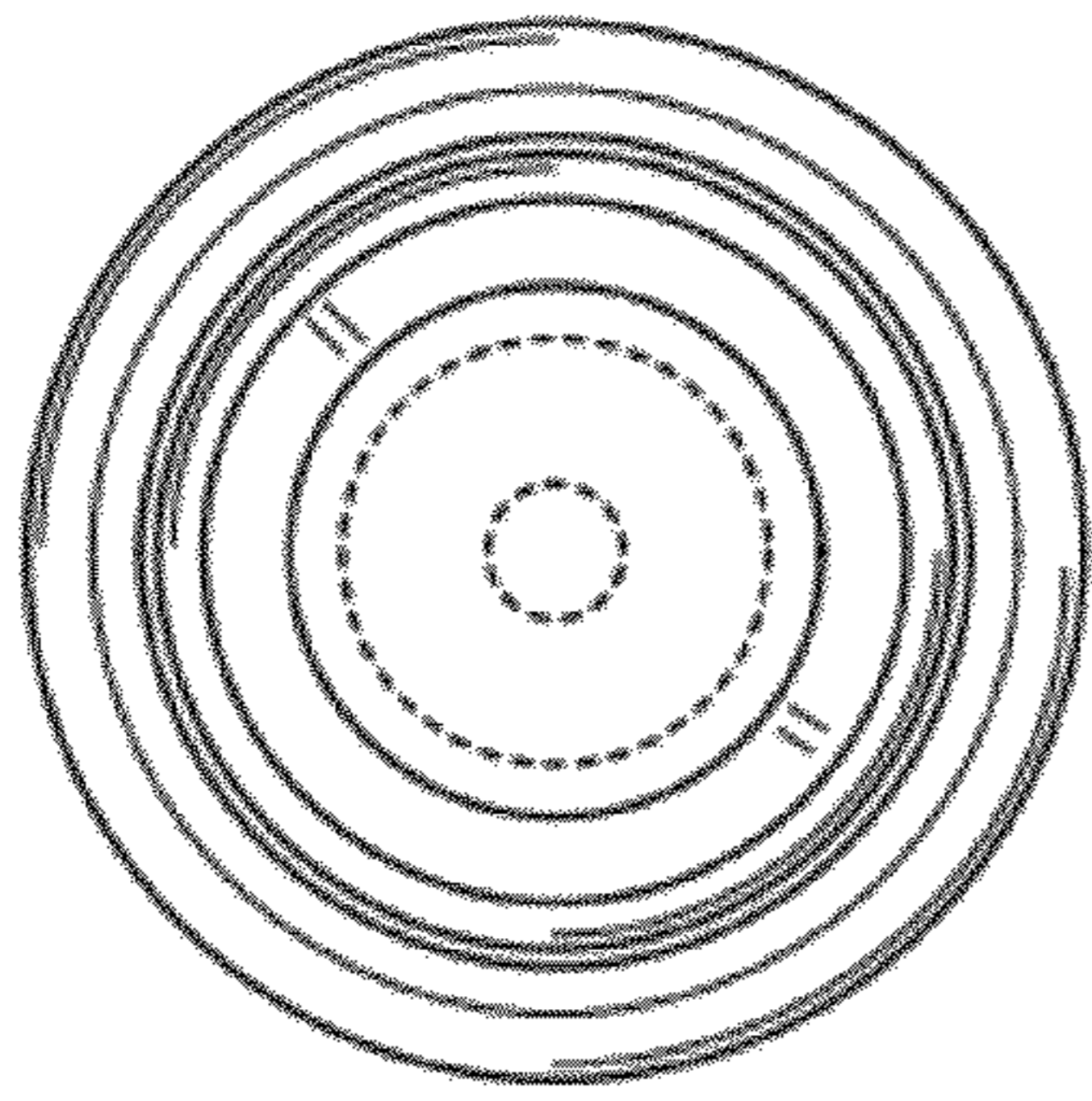

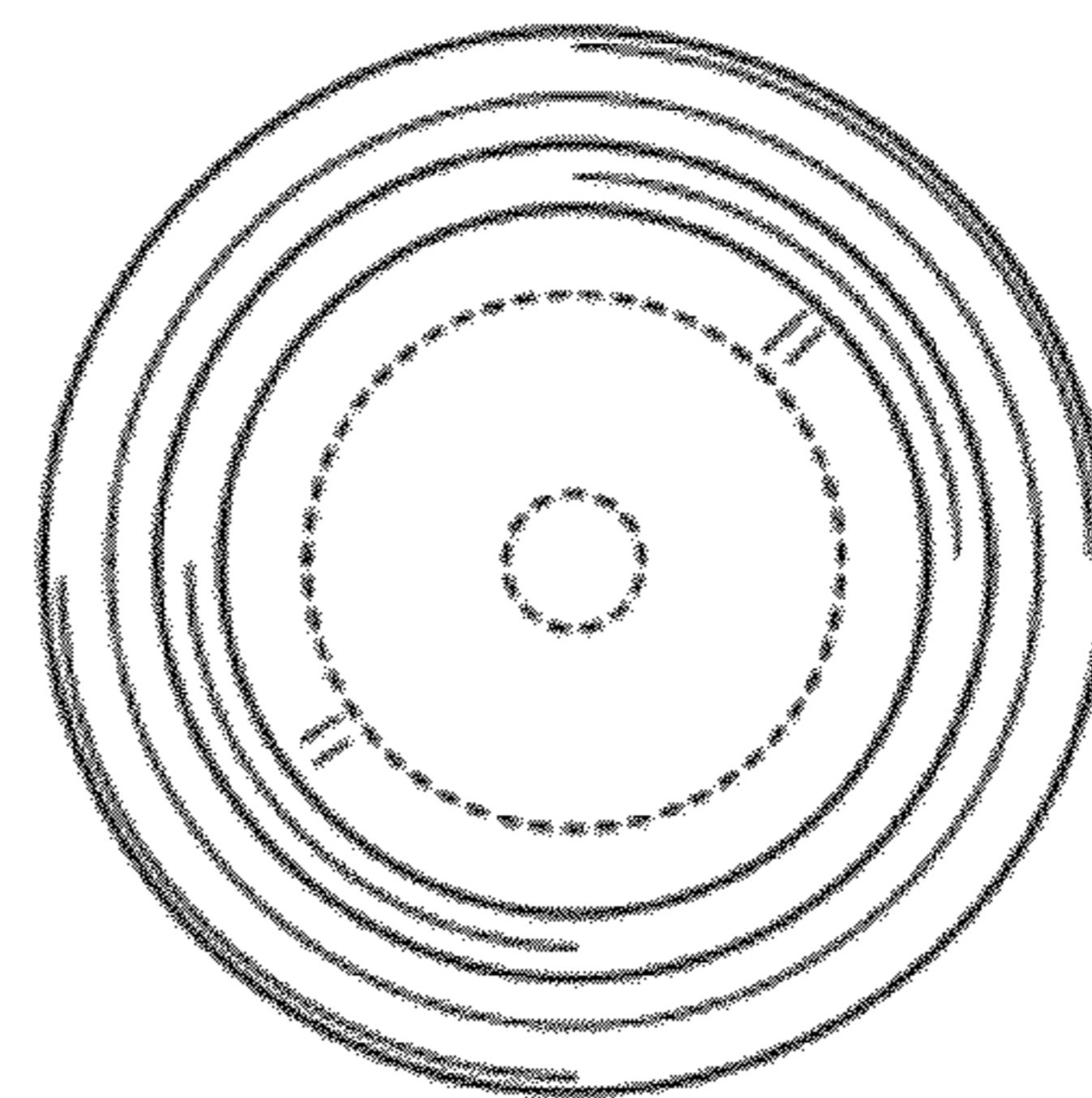
