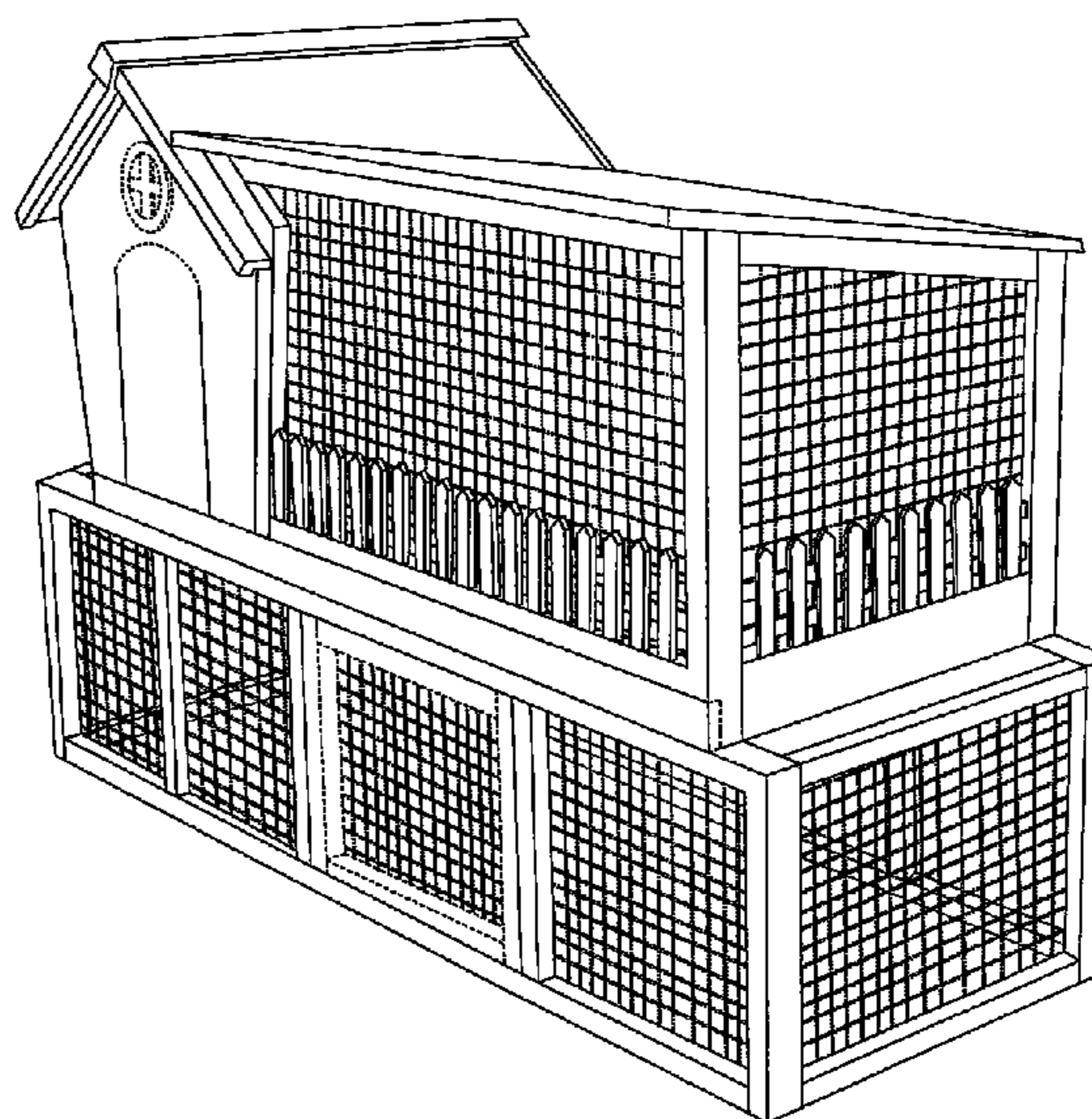
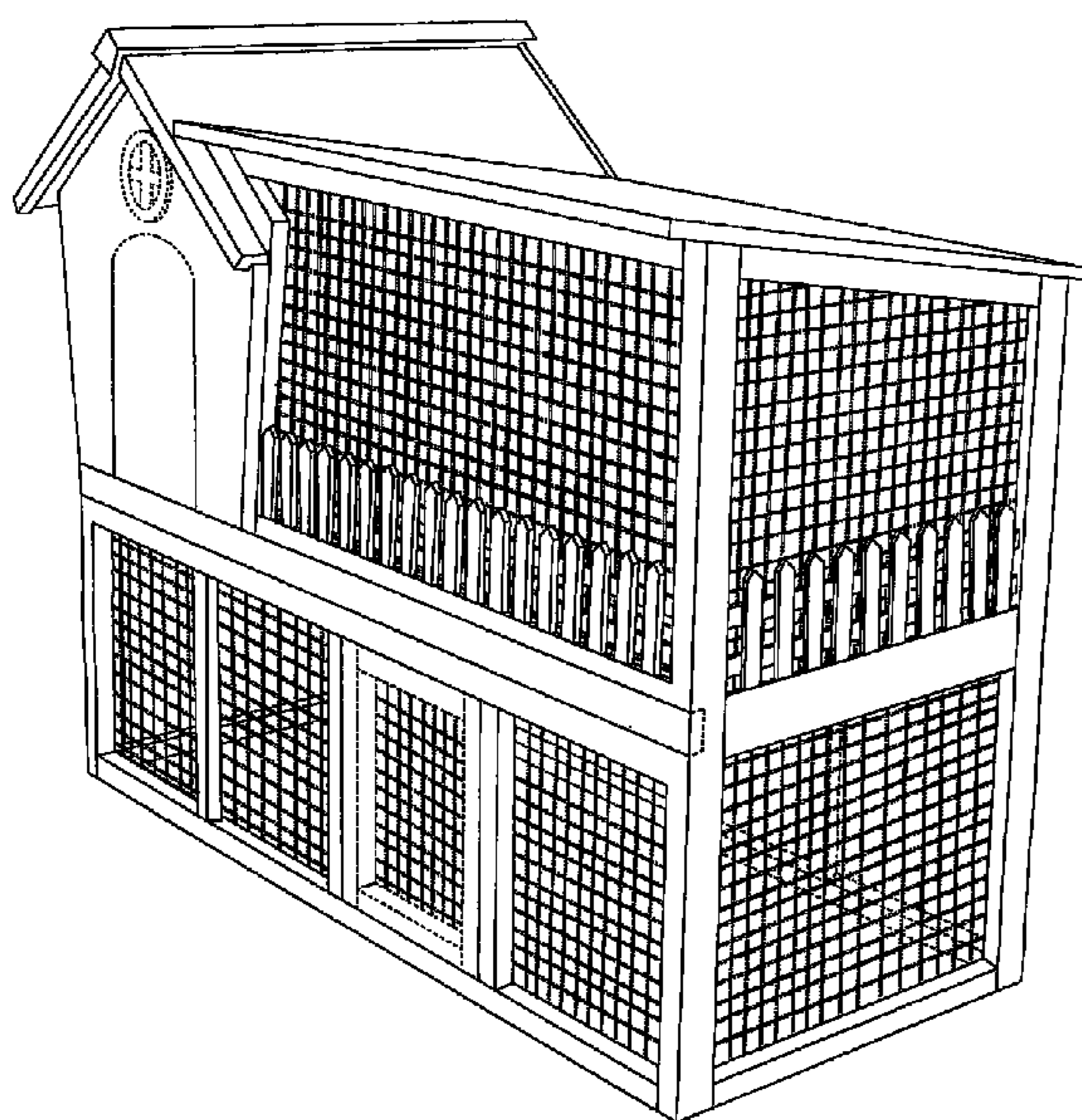
The ornamental design for an animal house, as shown and described.

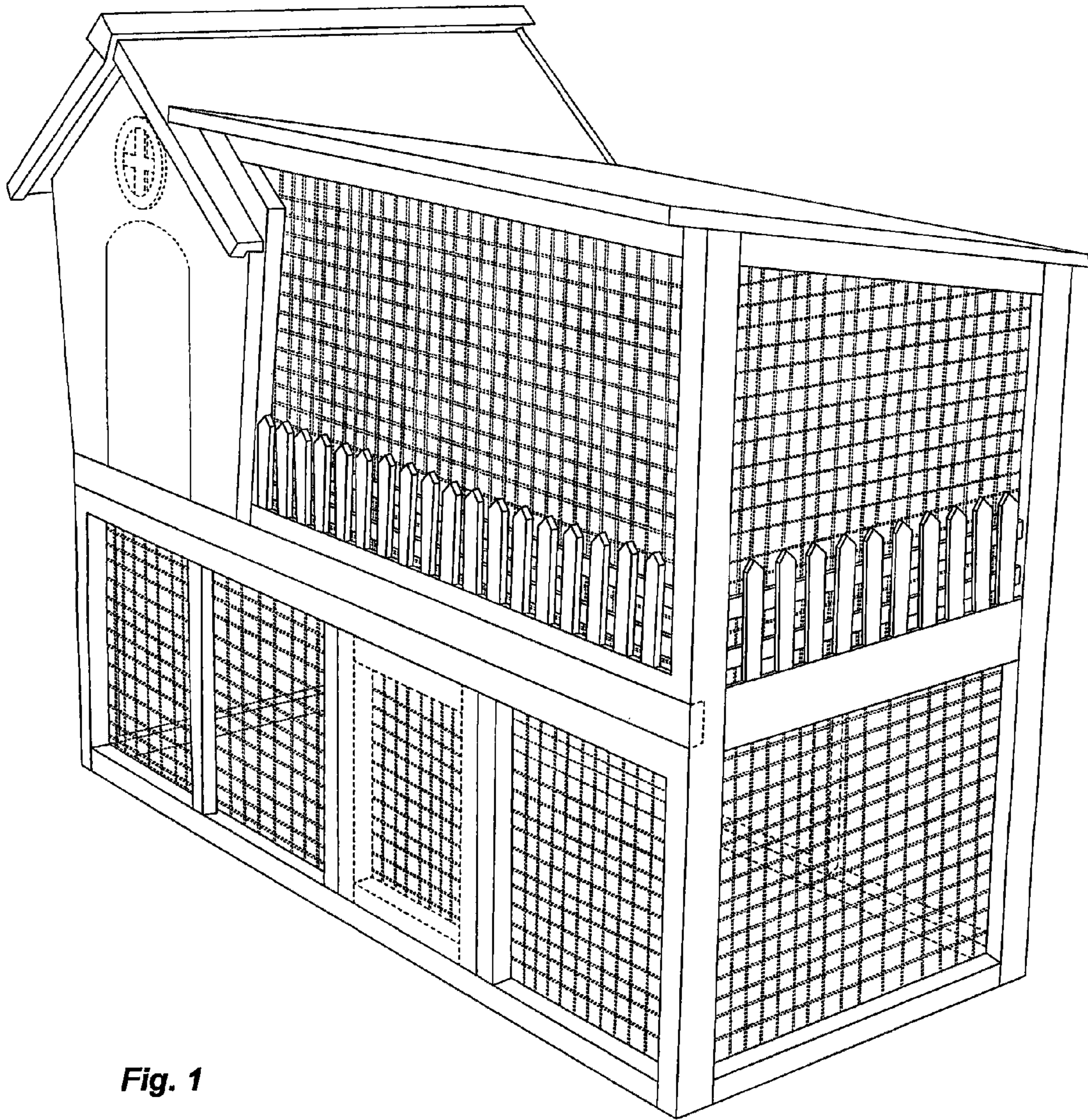
**DESCRIPTION**

 FIG. 10 is a top view thereof.

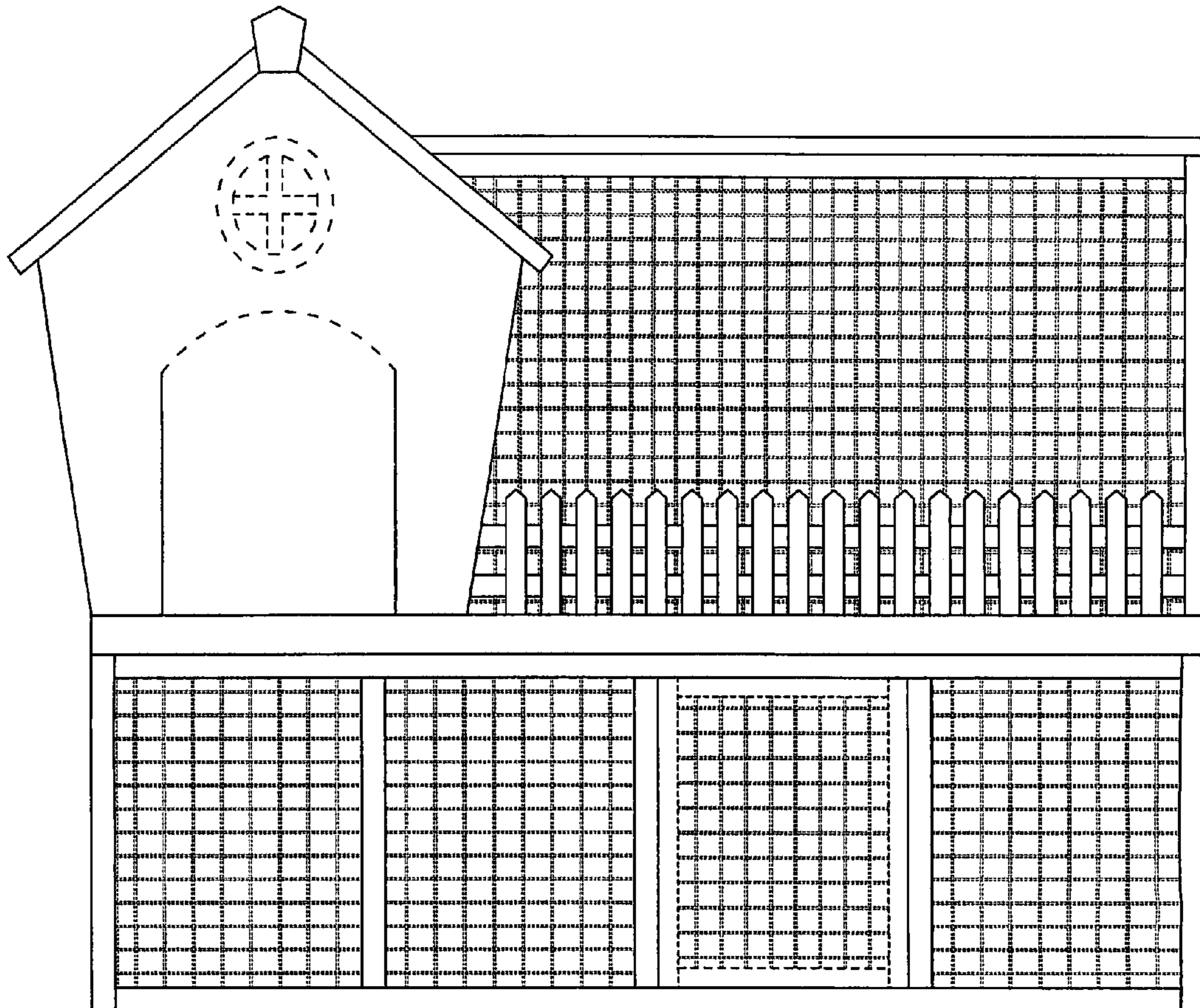

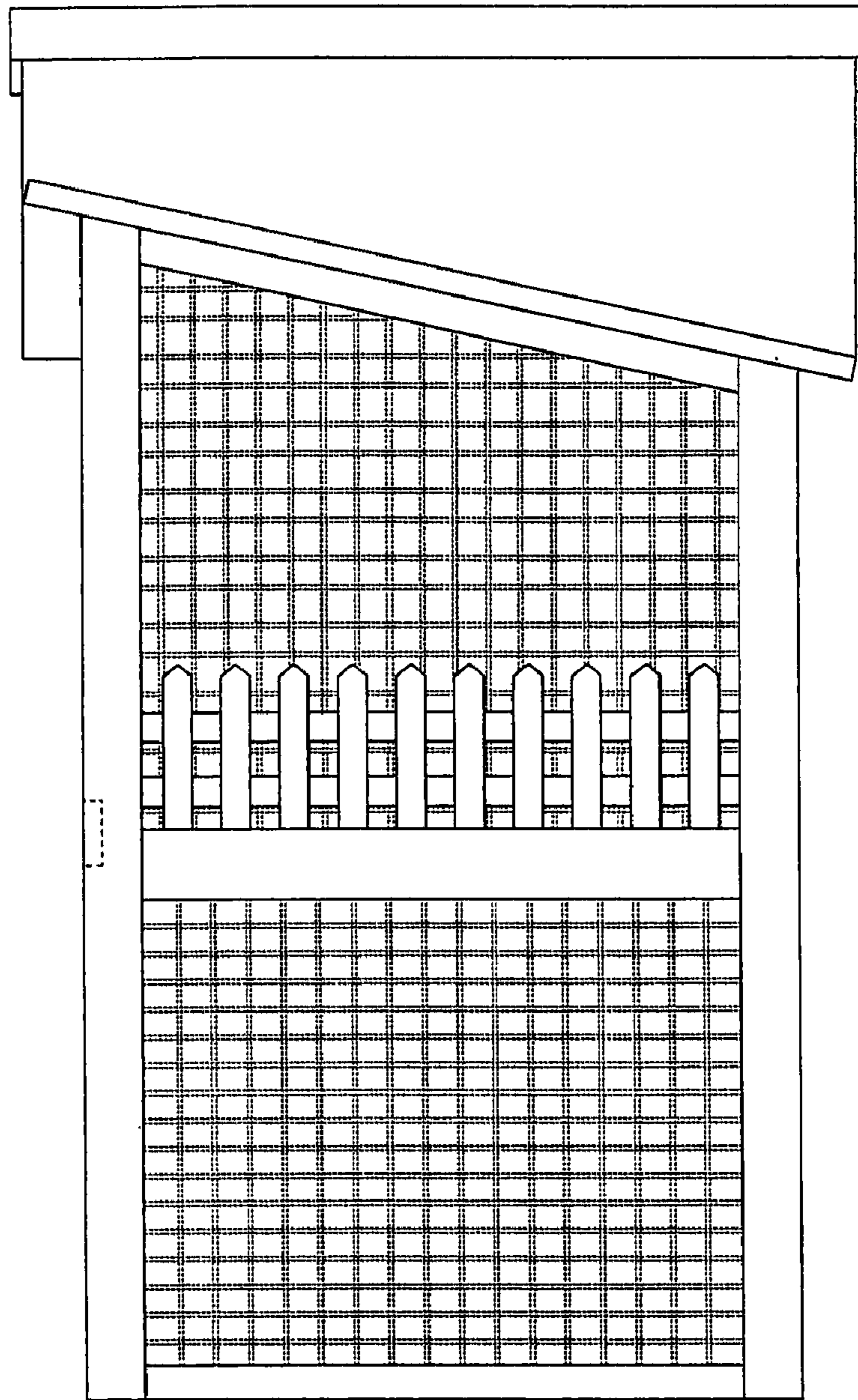




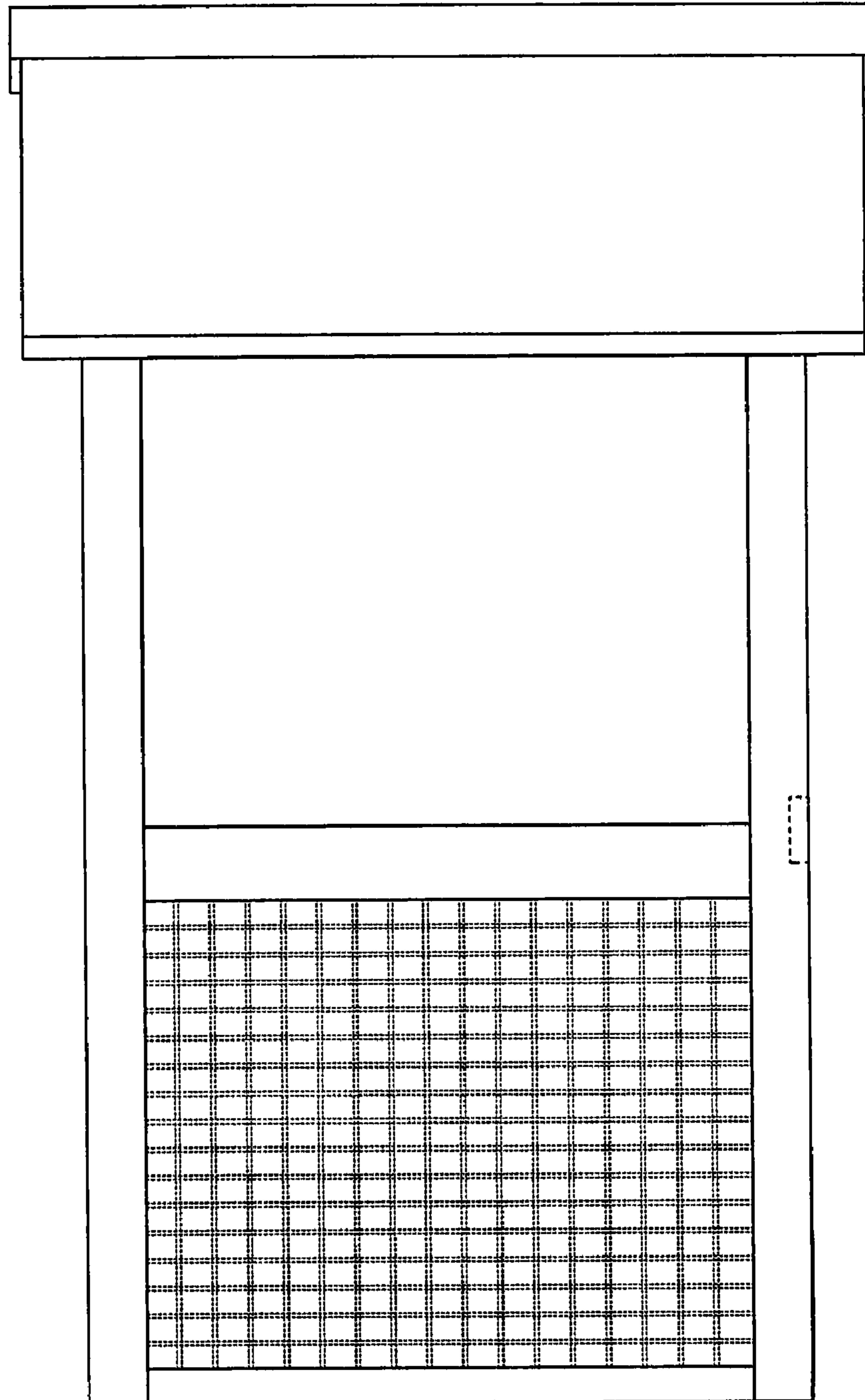

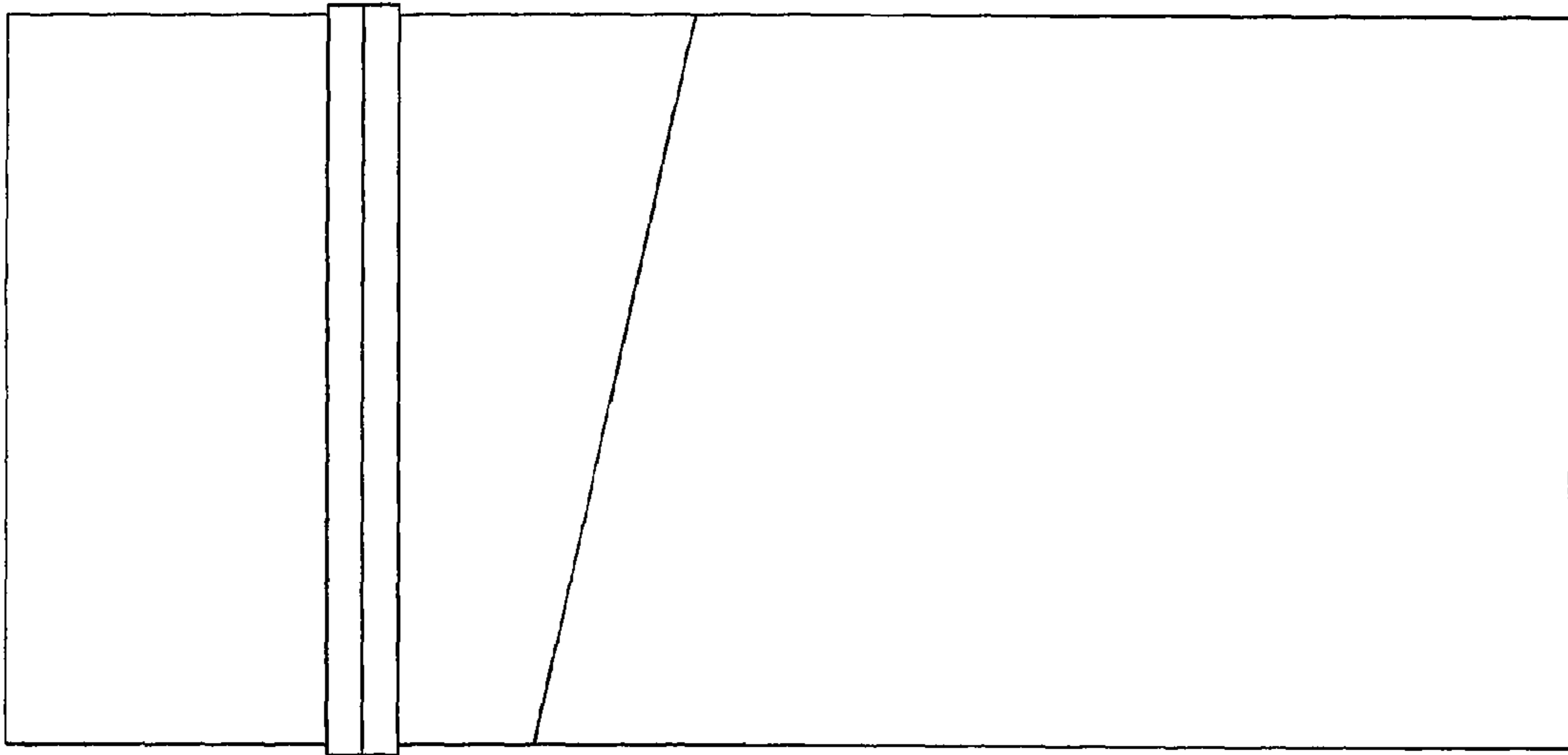

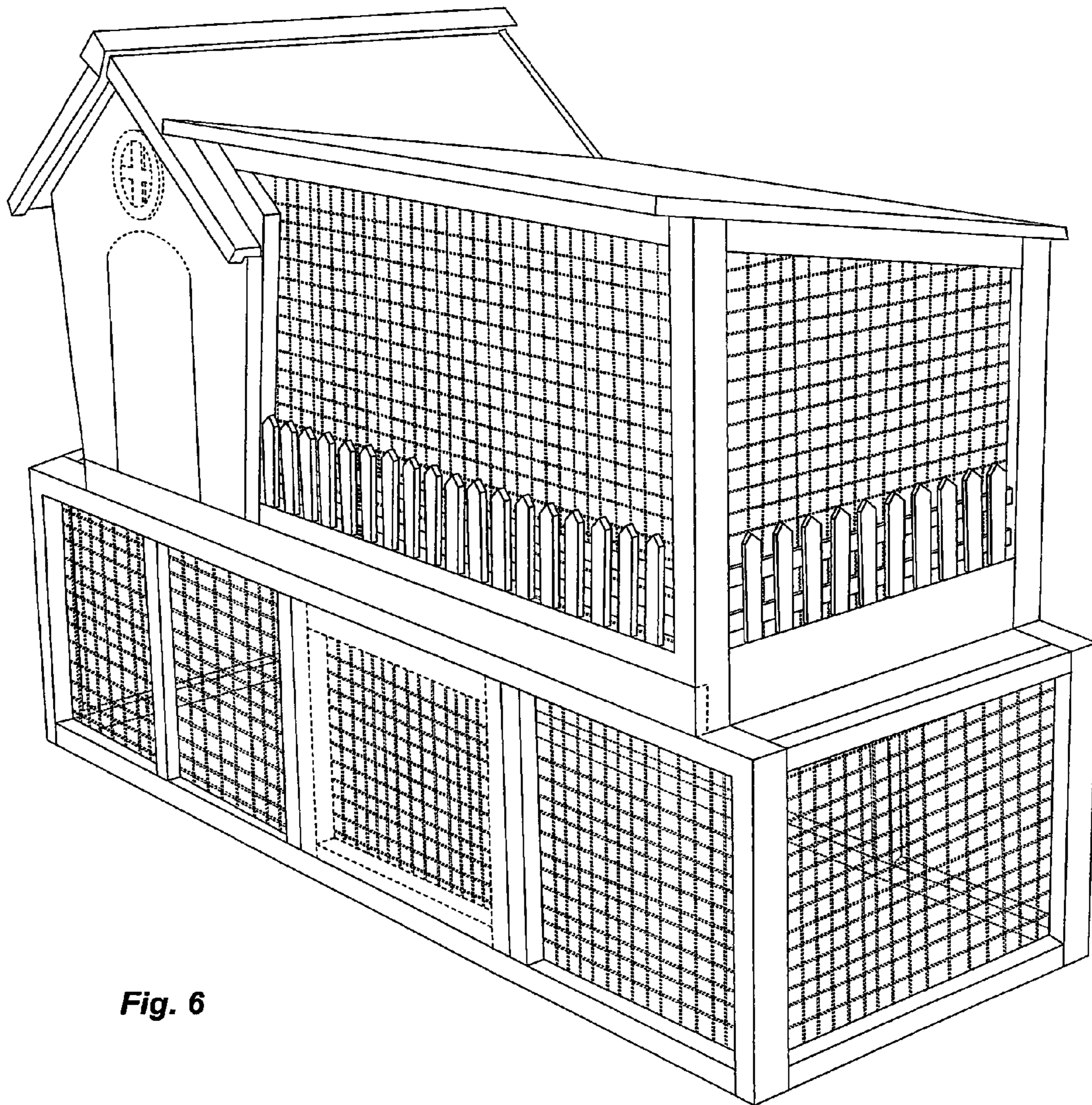

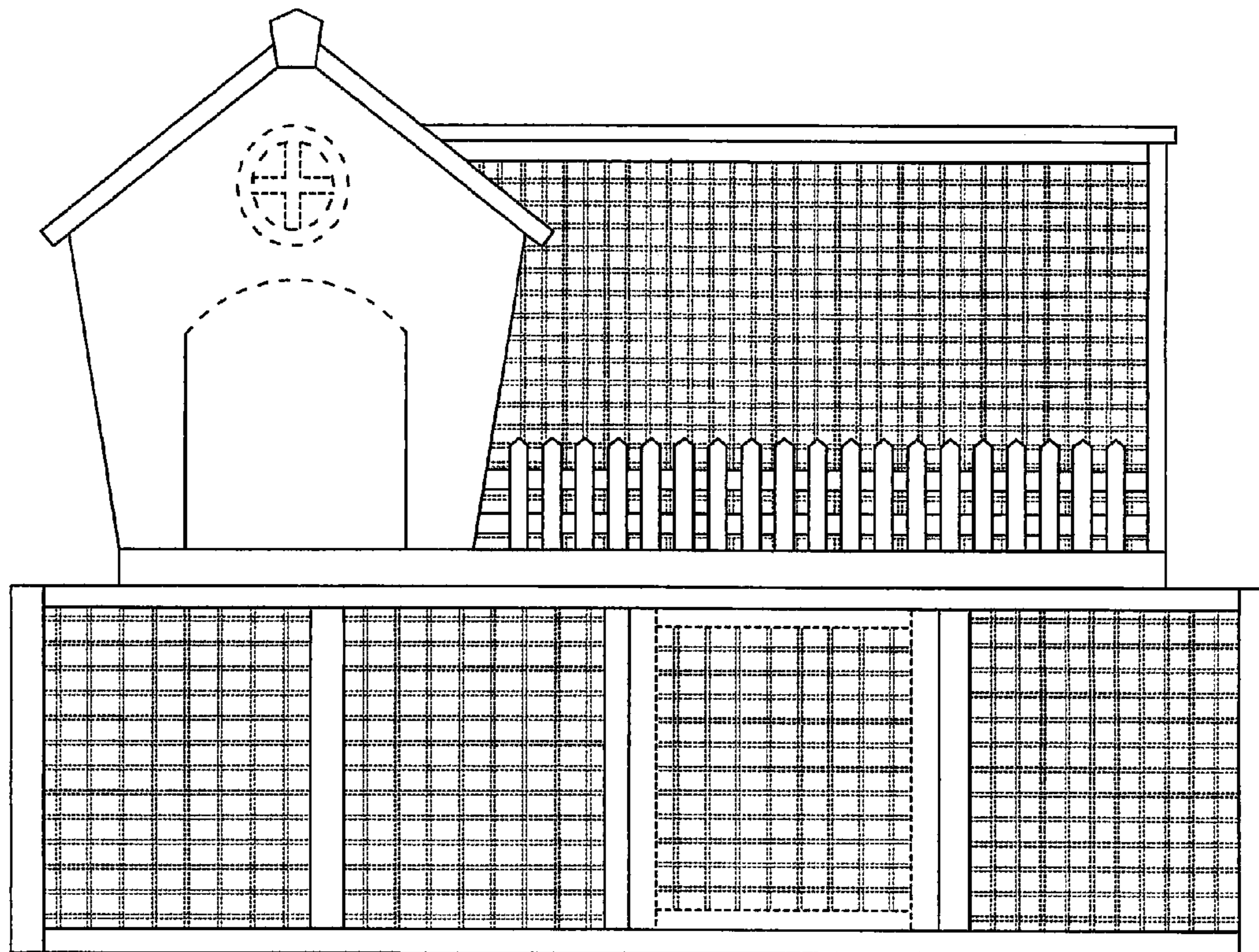

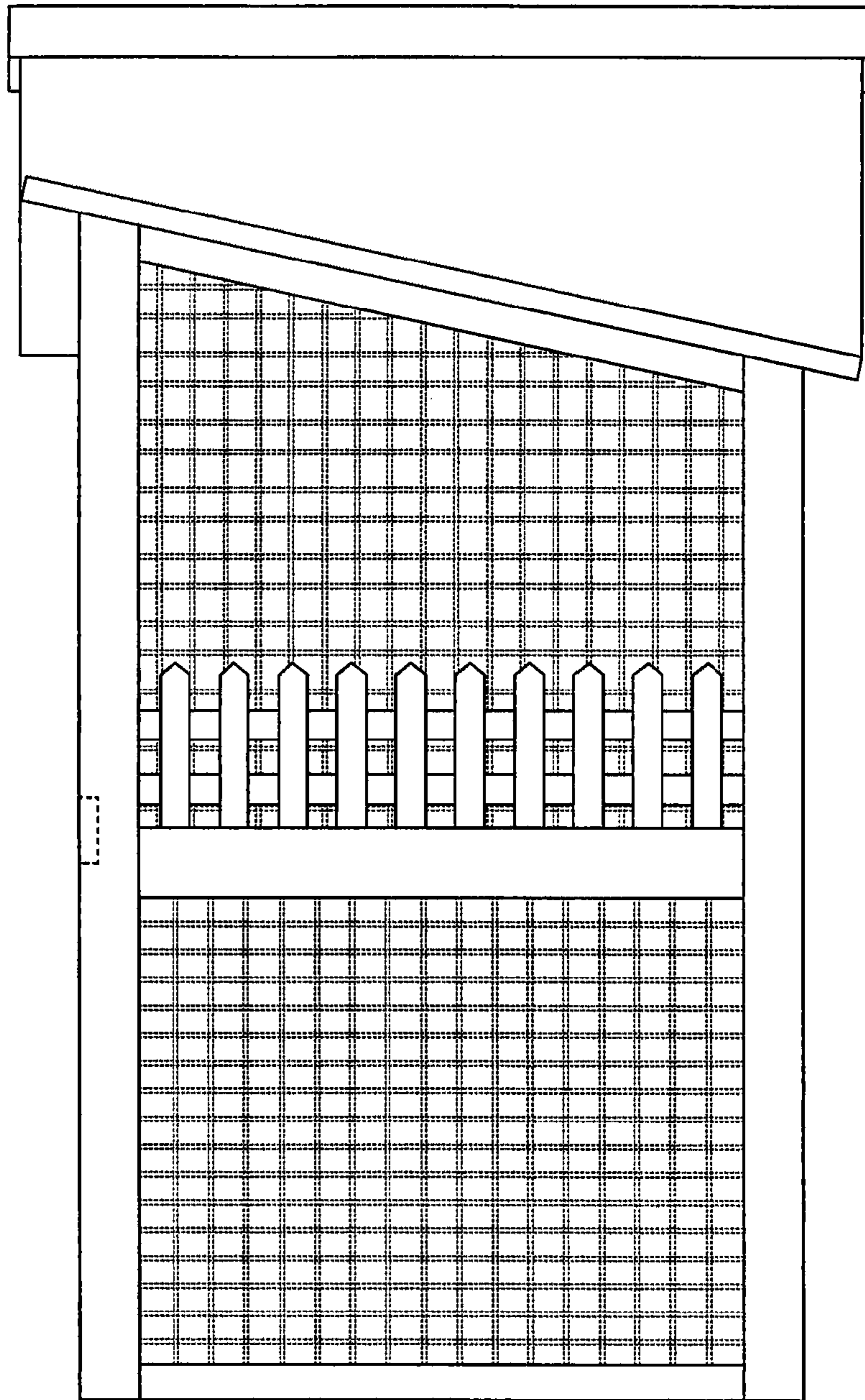

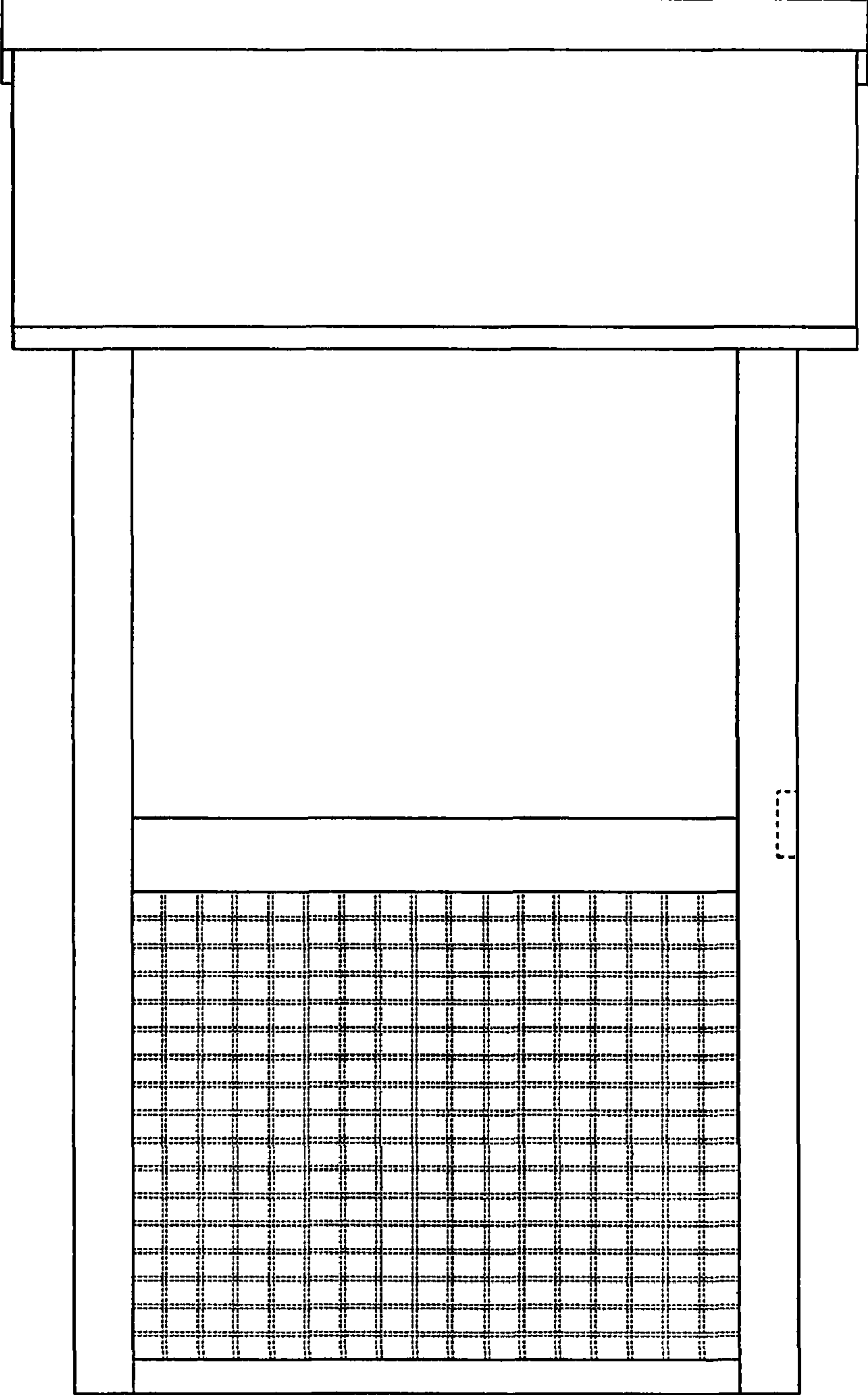

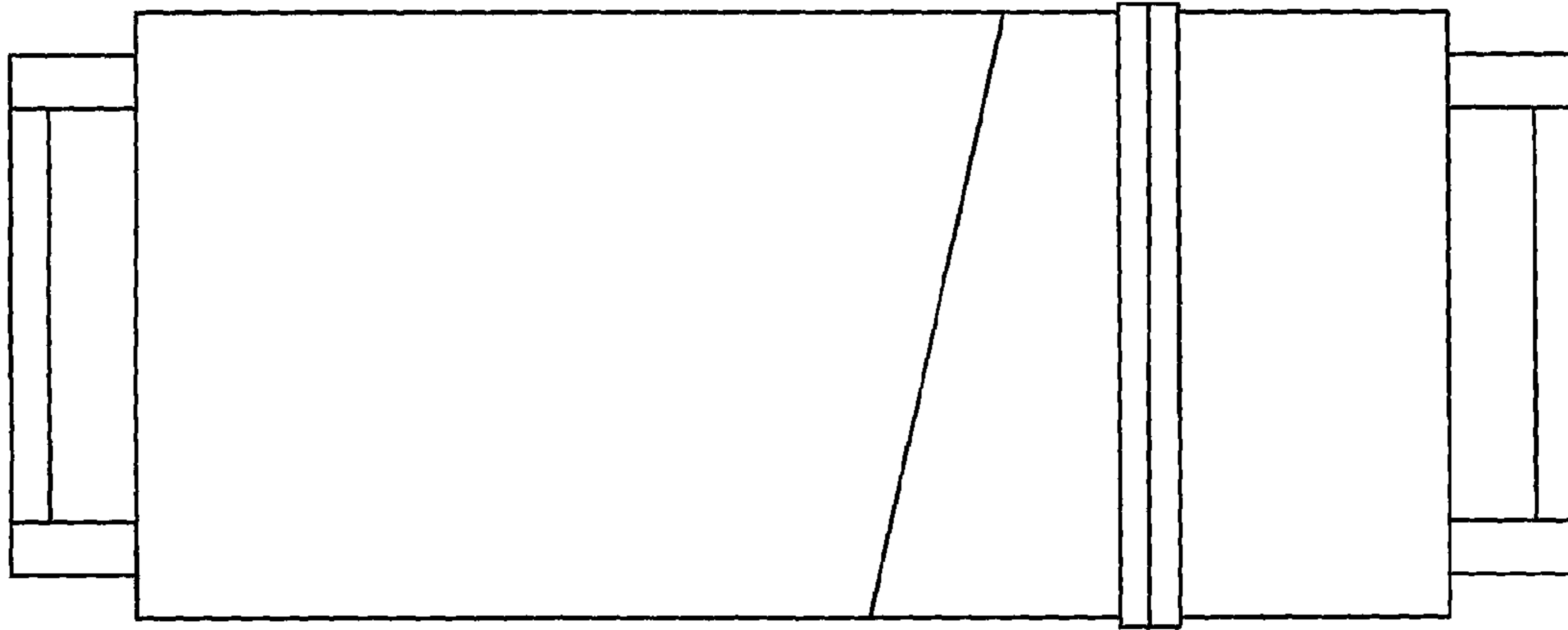
