The ornamental design for an organizer, as shown and described.

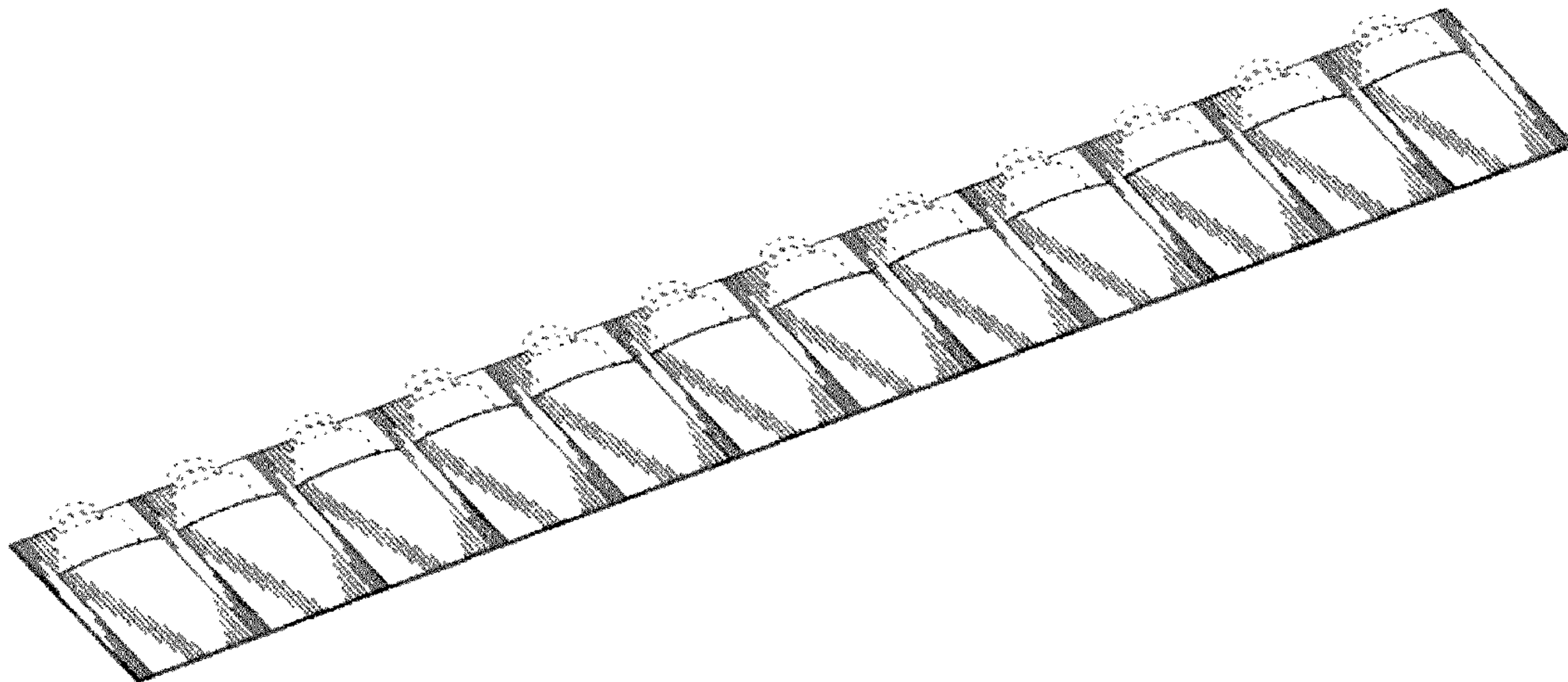
**DESCRIPTION**

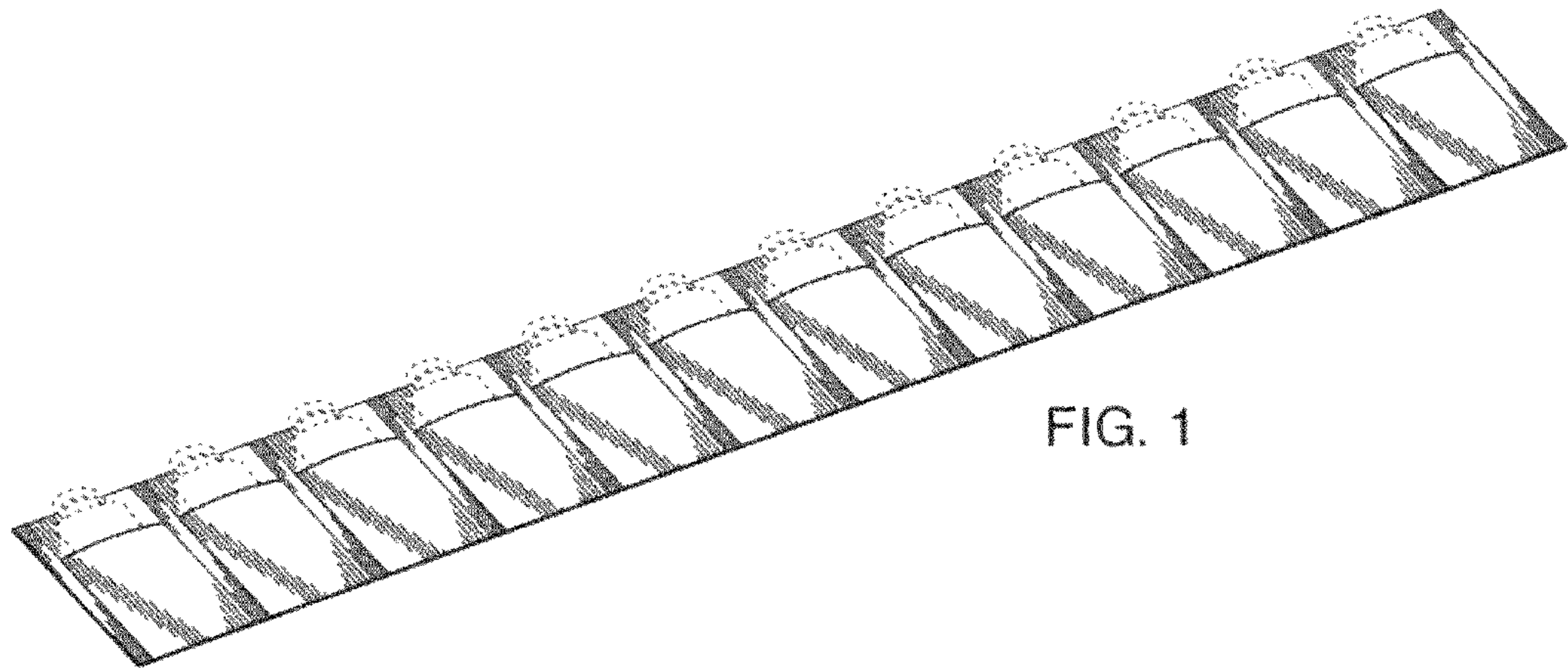

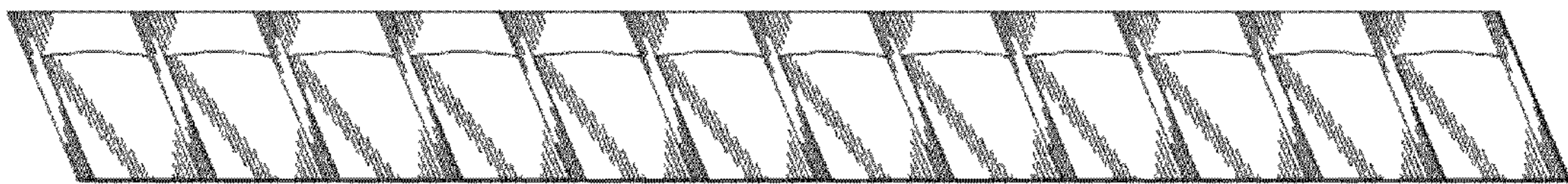

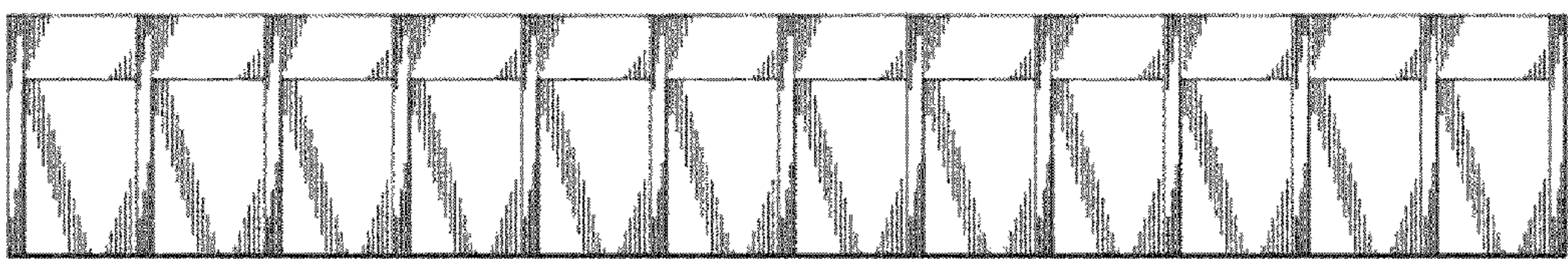

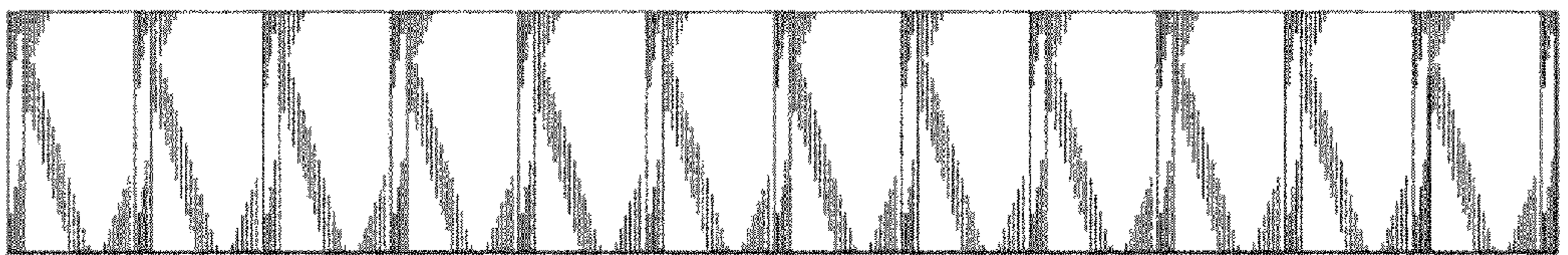

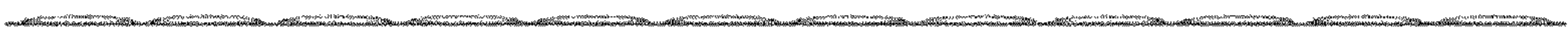
