**DESCRIPTION**

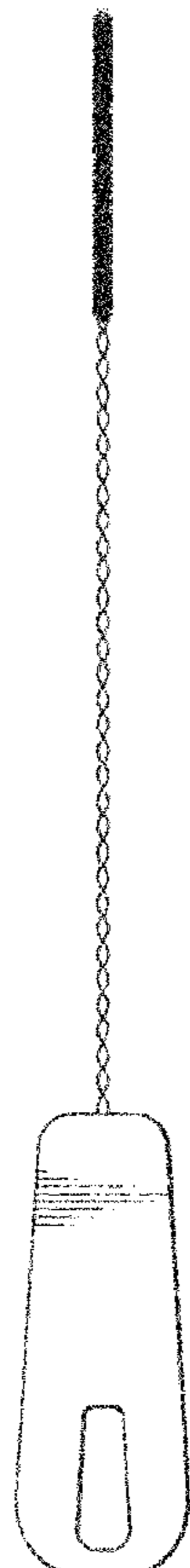
FIG. 1 is a front elevational view of a flexible straw brush showing my new design;

 FIG. 6 is a bottom plan view thereof.

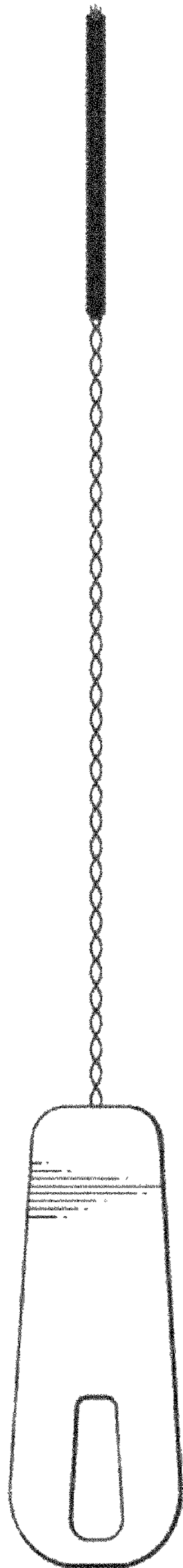

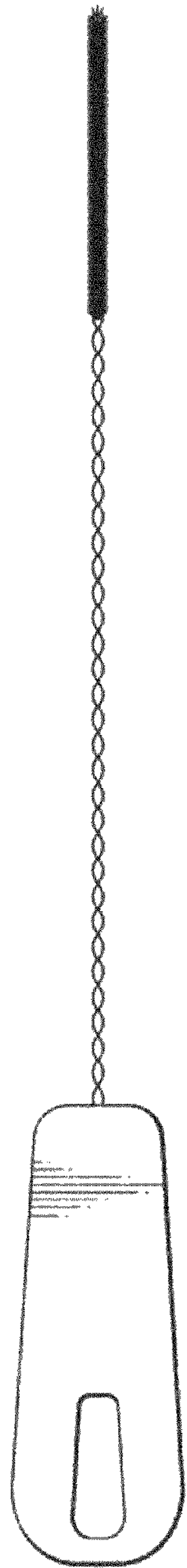

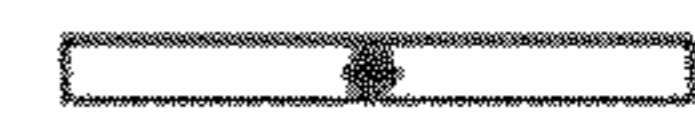

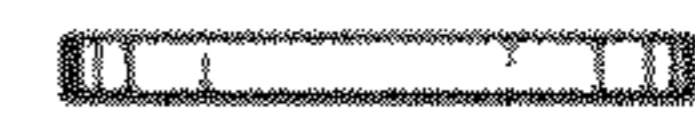
