FIG. 2 is a front view thereof, the rear view being a mirror image thereof;

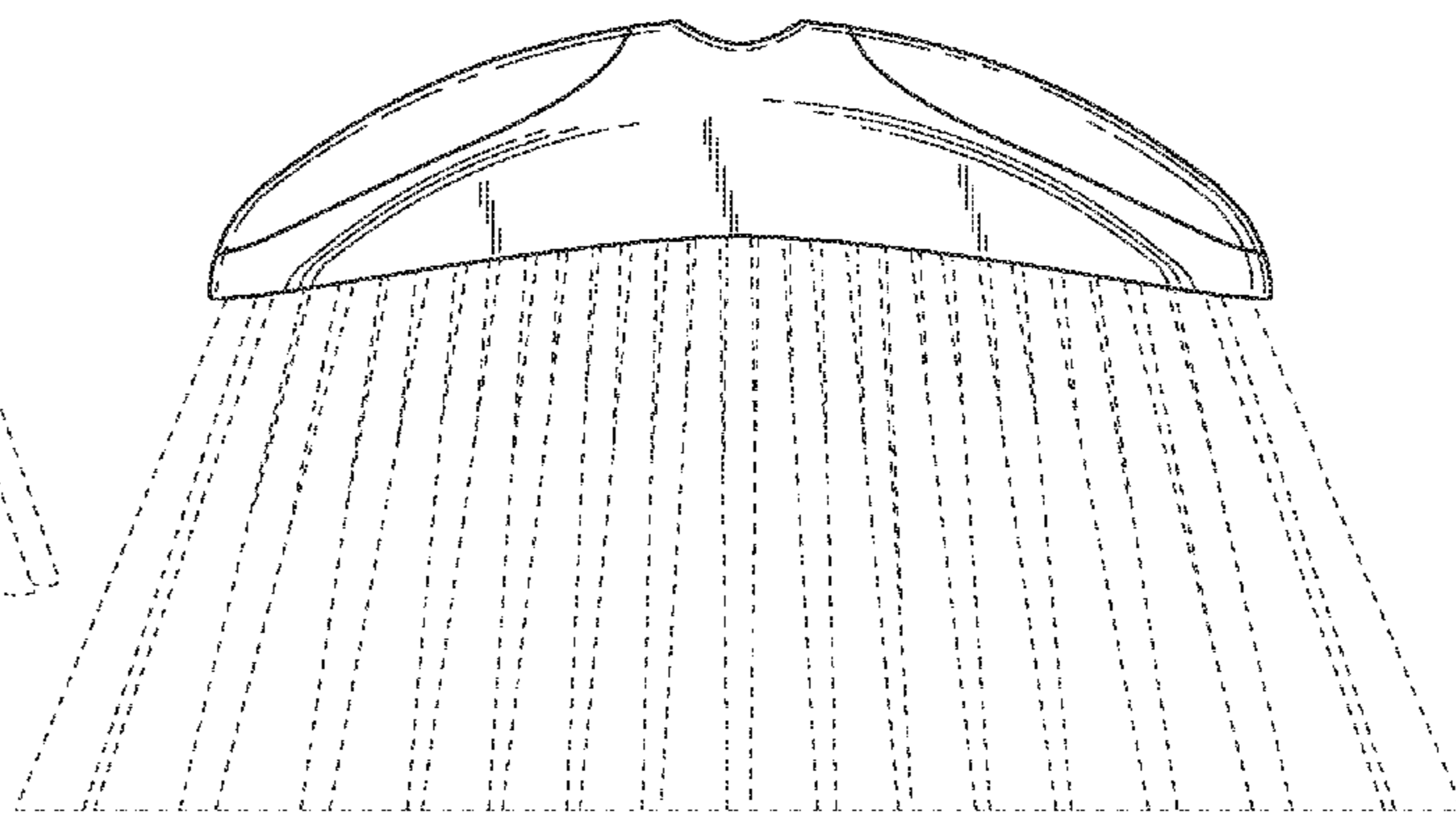
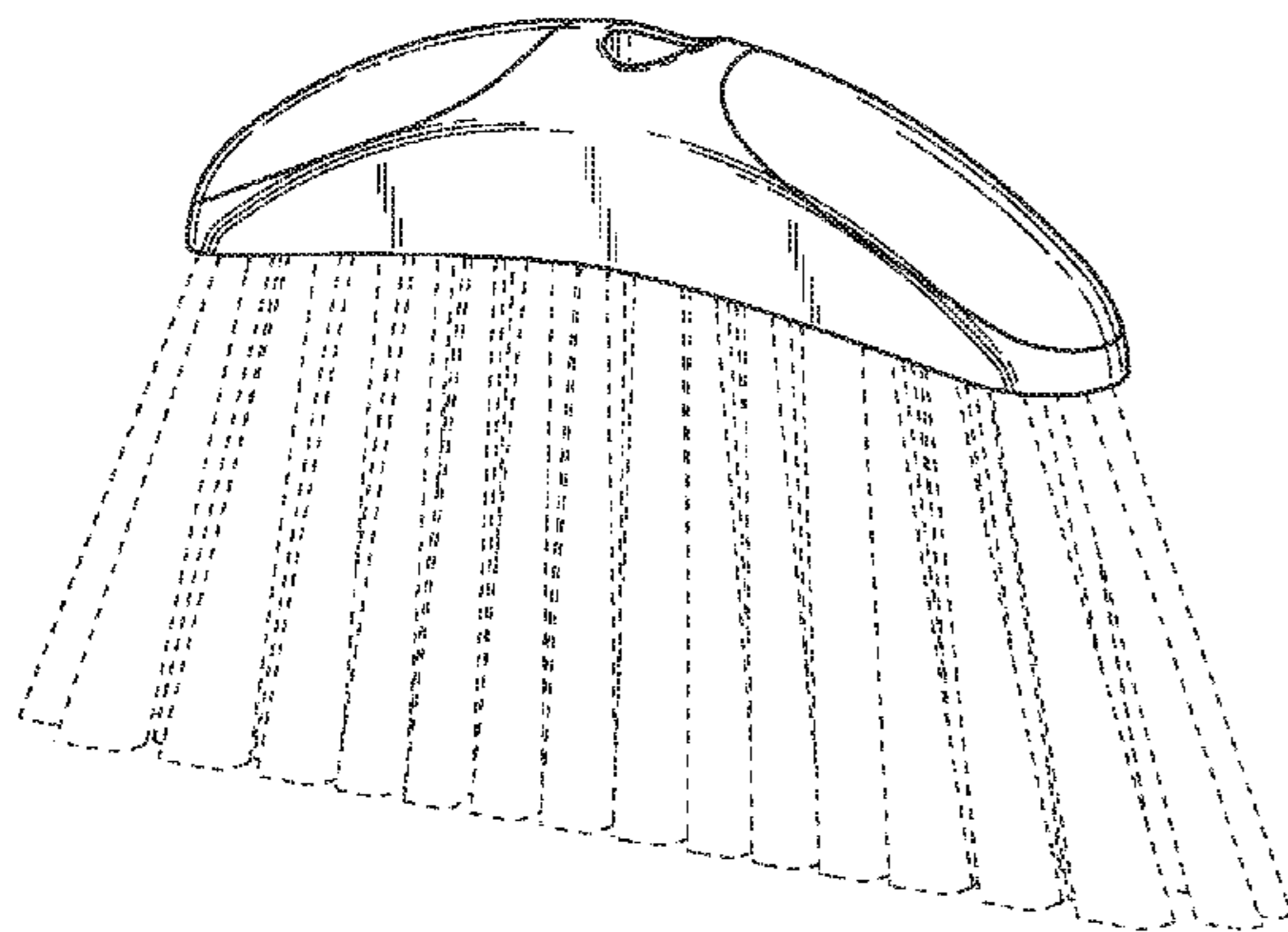
FIG. 3 is a top view thereof;

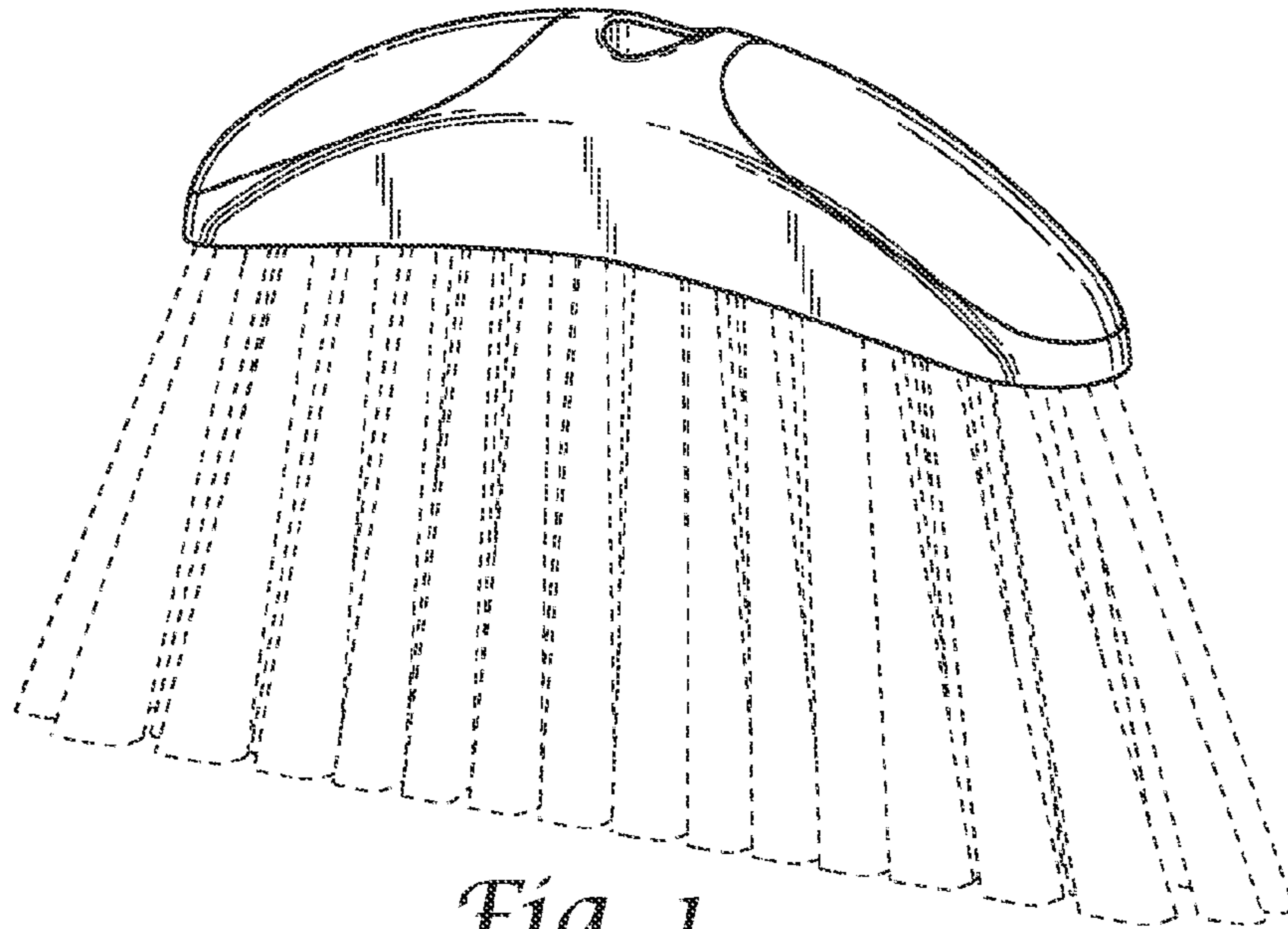

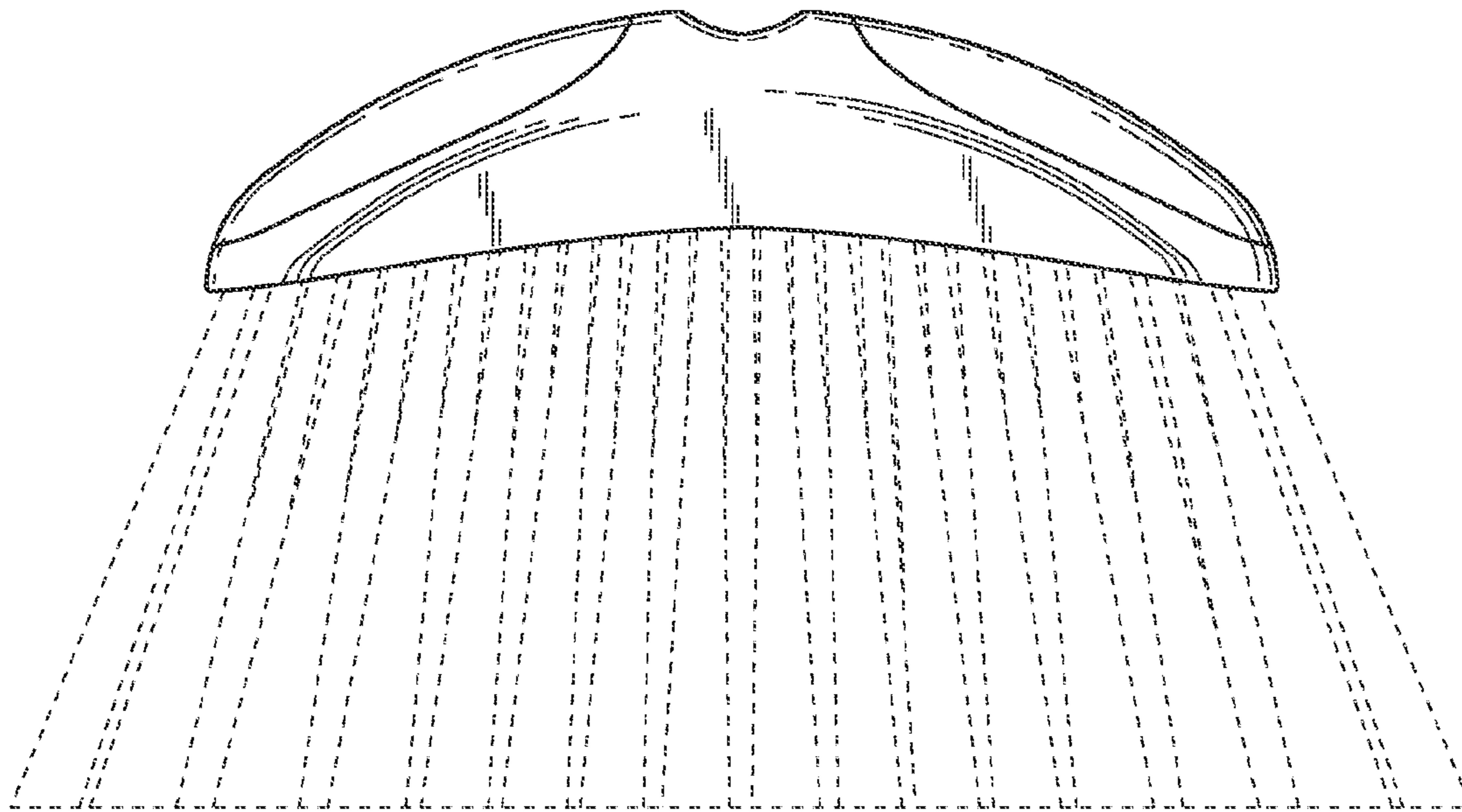

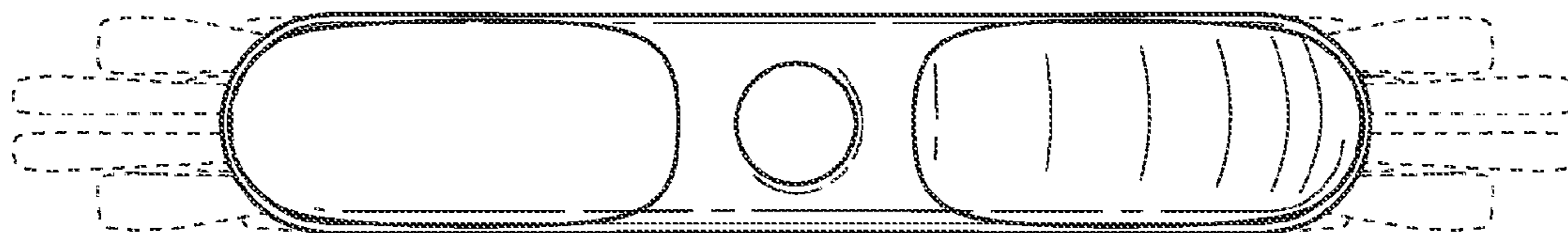

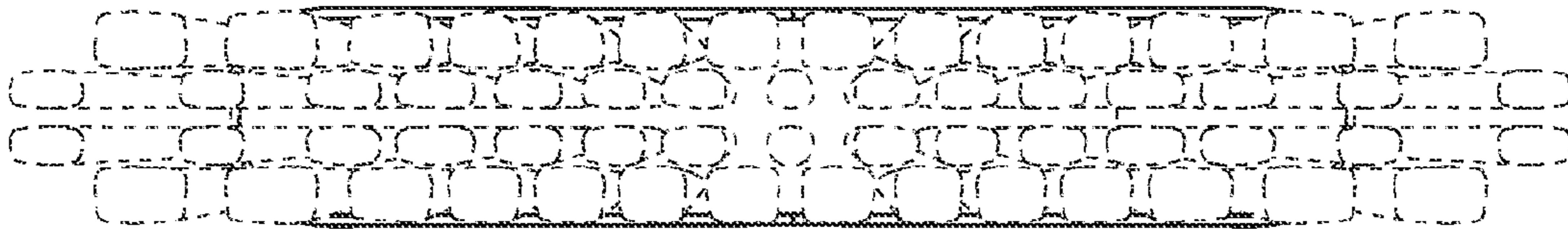

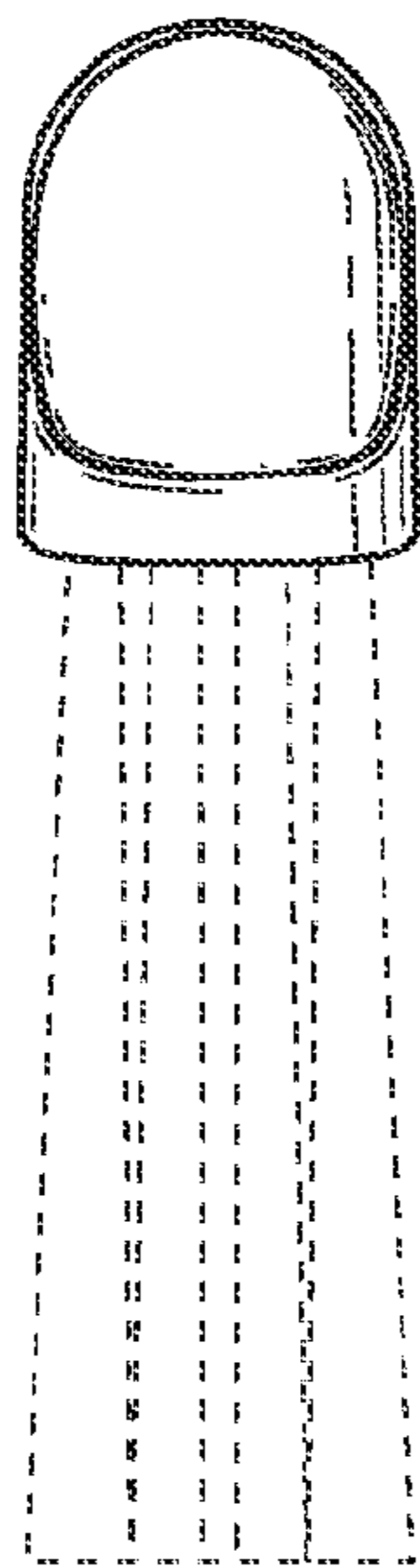

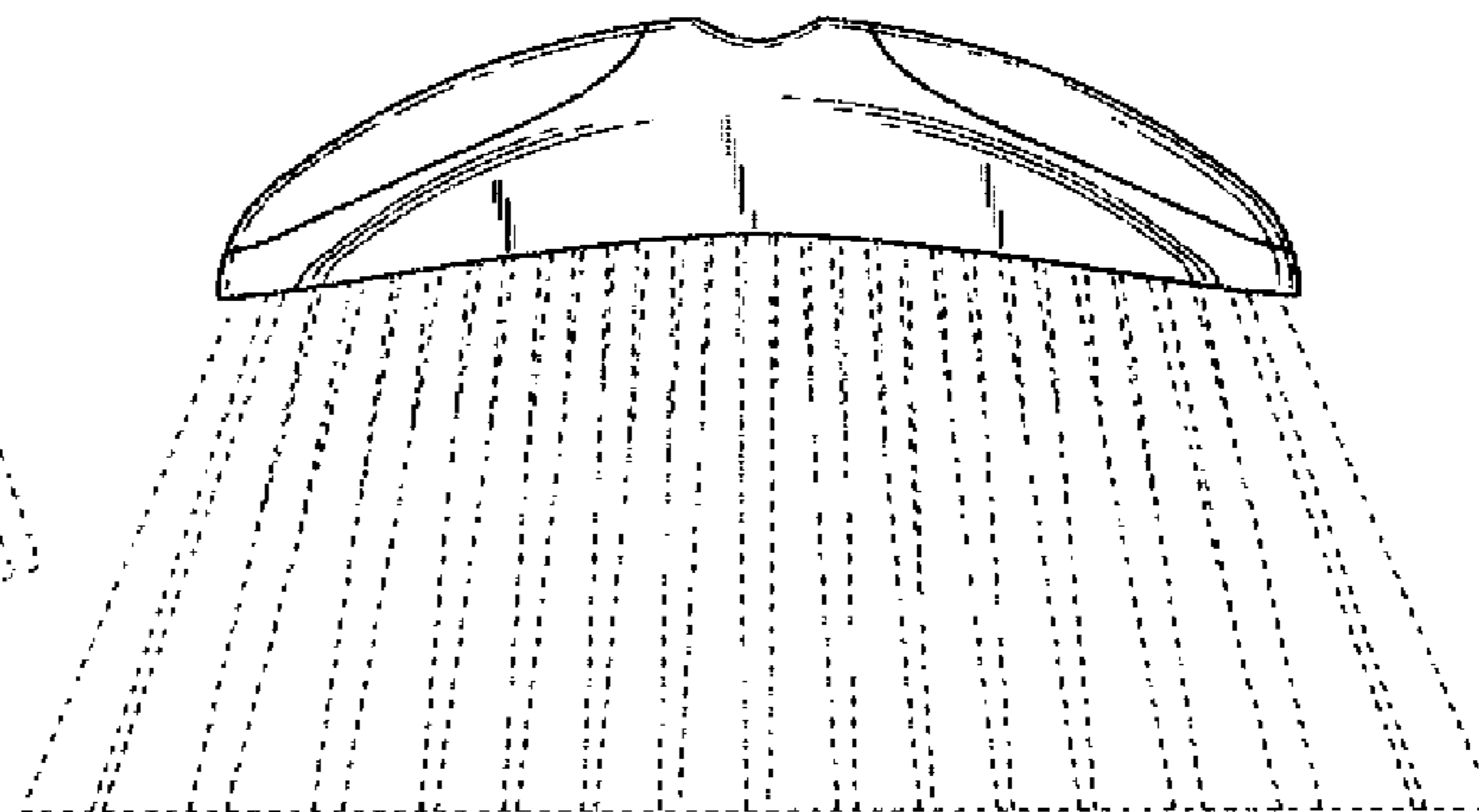
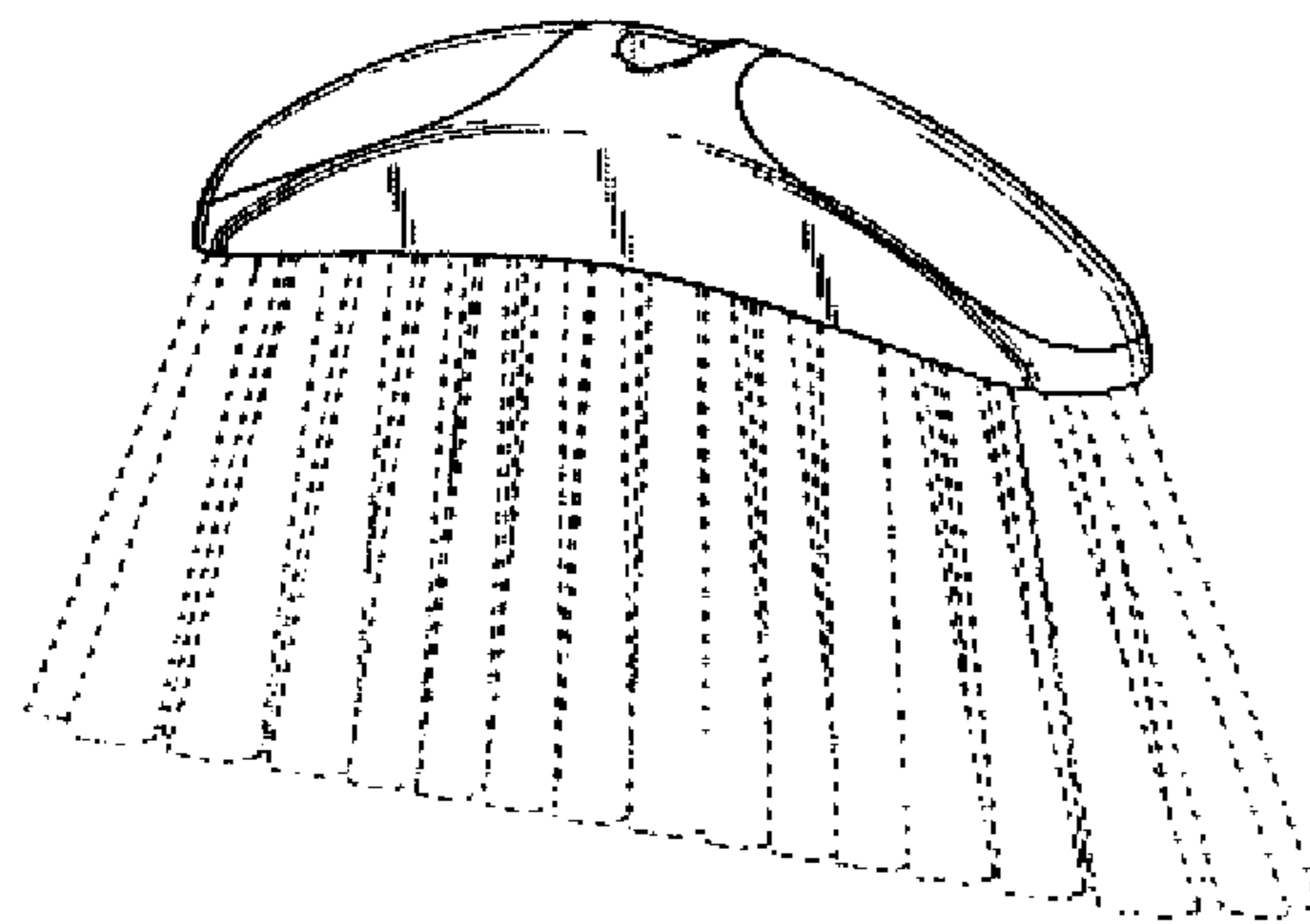
FIG. 3 is a top view thereof;

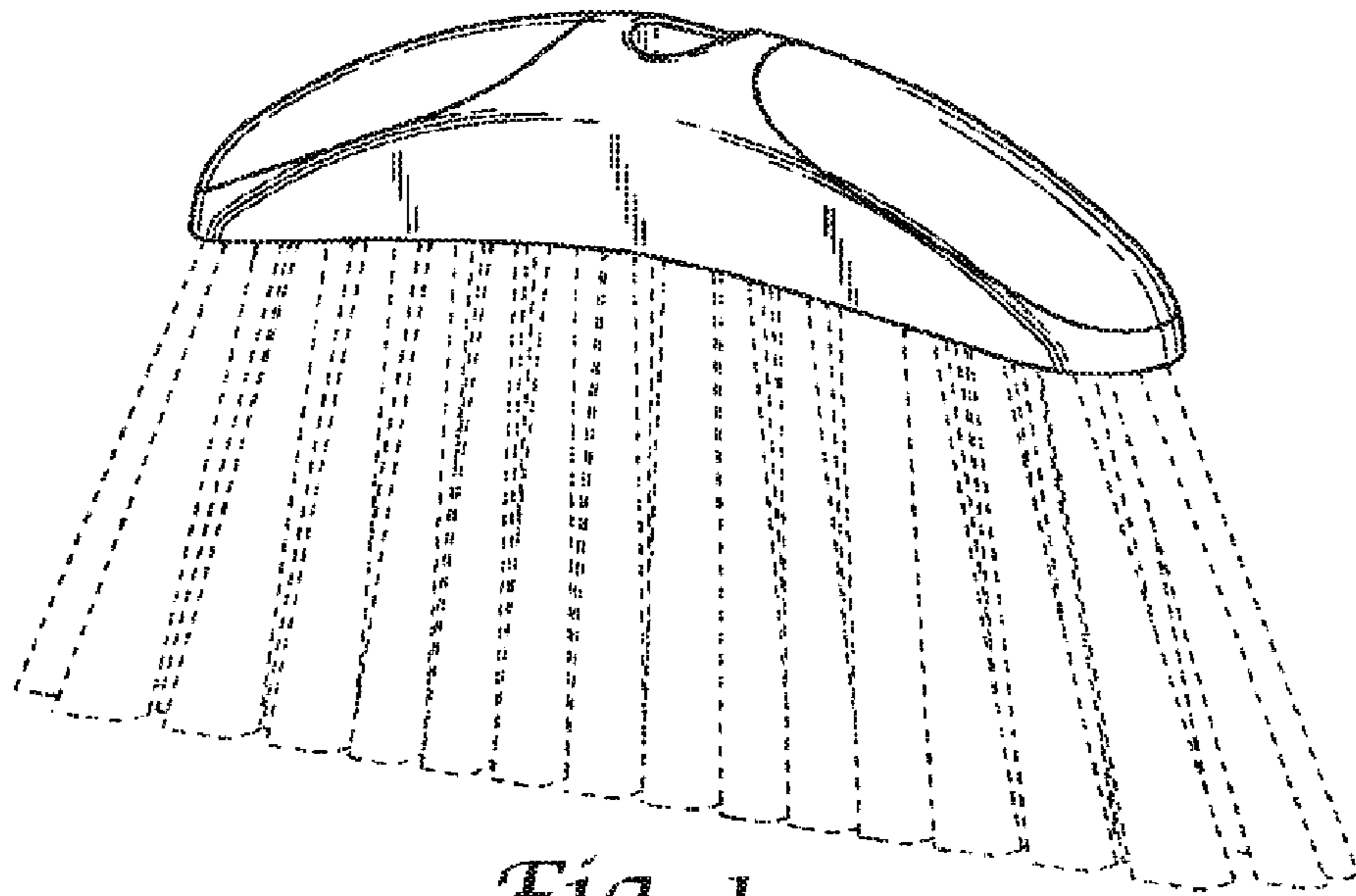

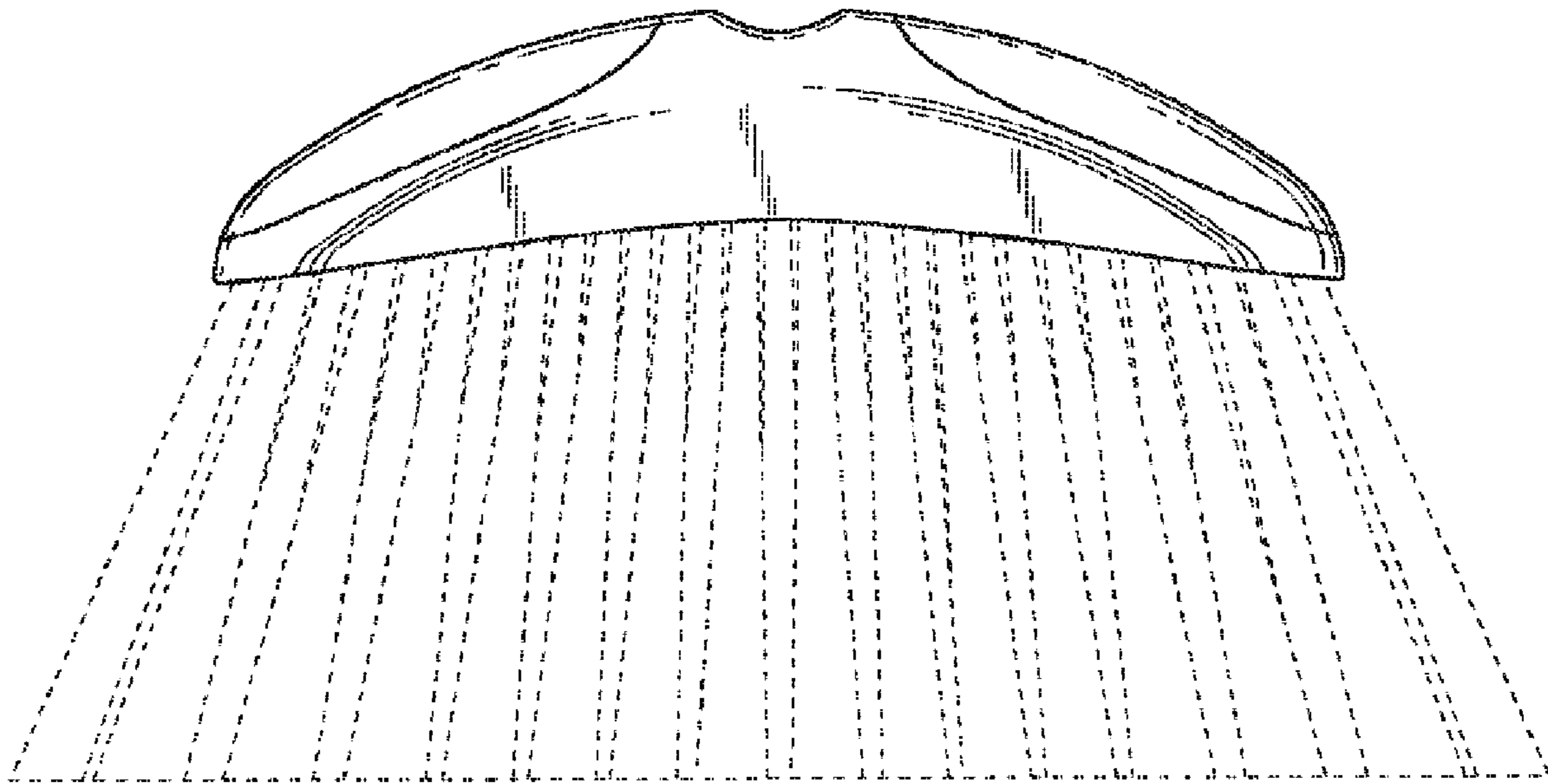

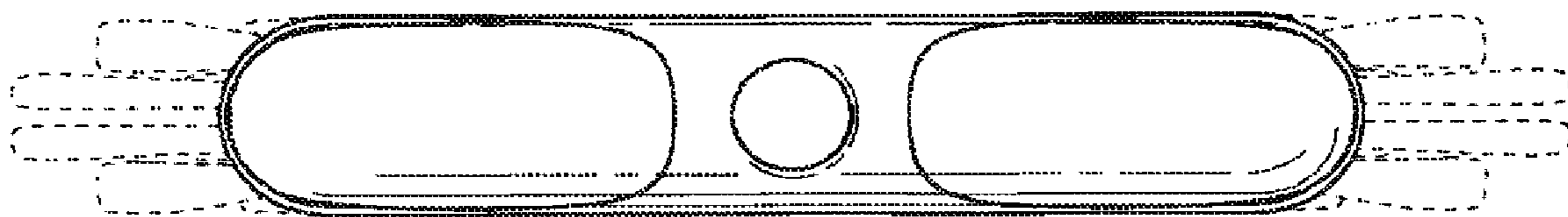

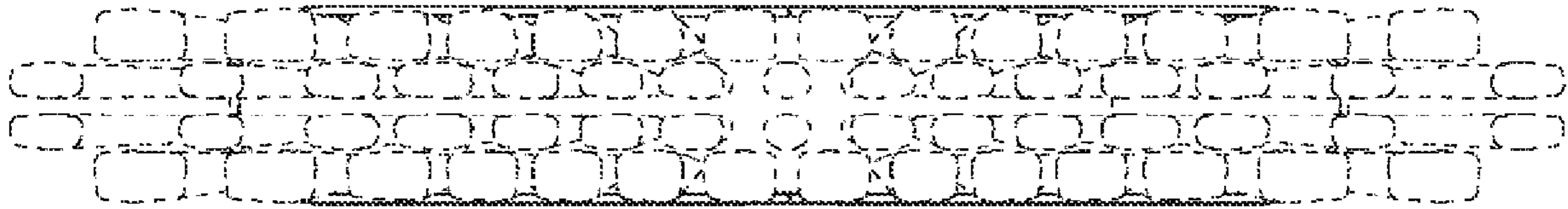

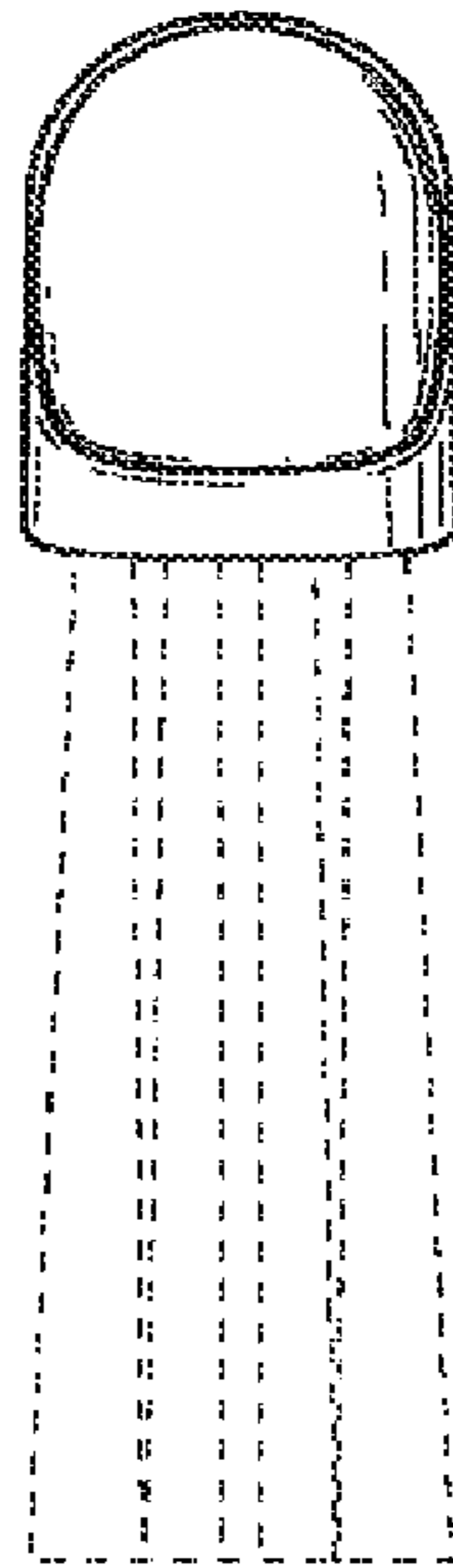
