(57) **CLAIM**

The ornamental design for a drying mat, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an embodiment of a drying mat showing our new design;

FIG. 2 is an alternate perspective view of the drying mat of FIG. 1;

FIG. 3 is a plan view of the drying mat of FIG. 1;

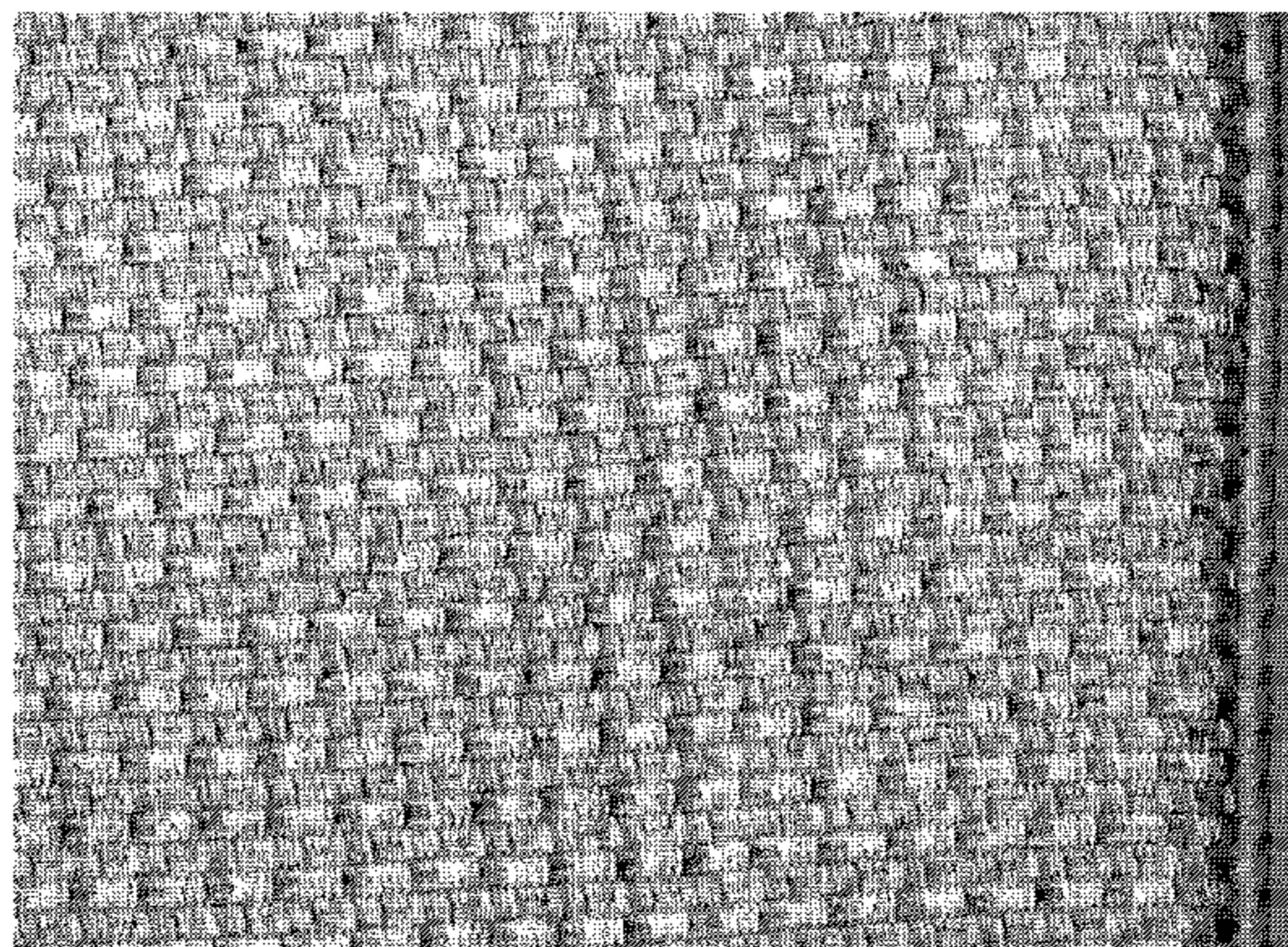
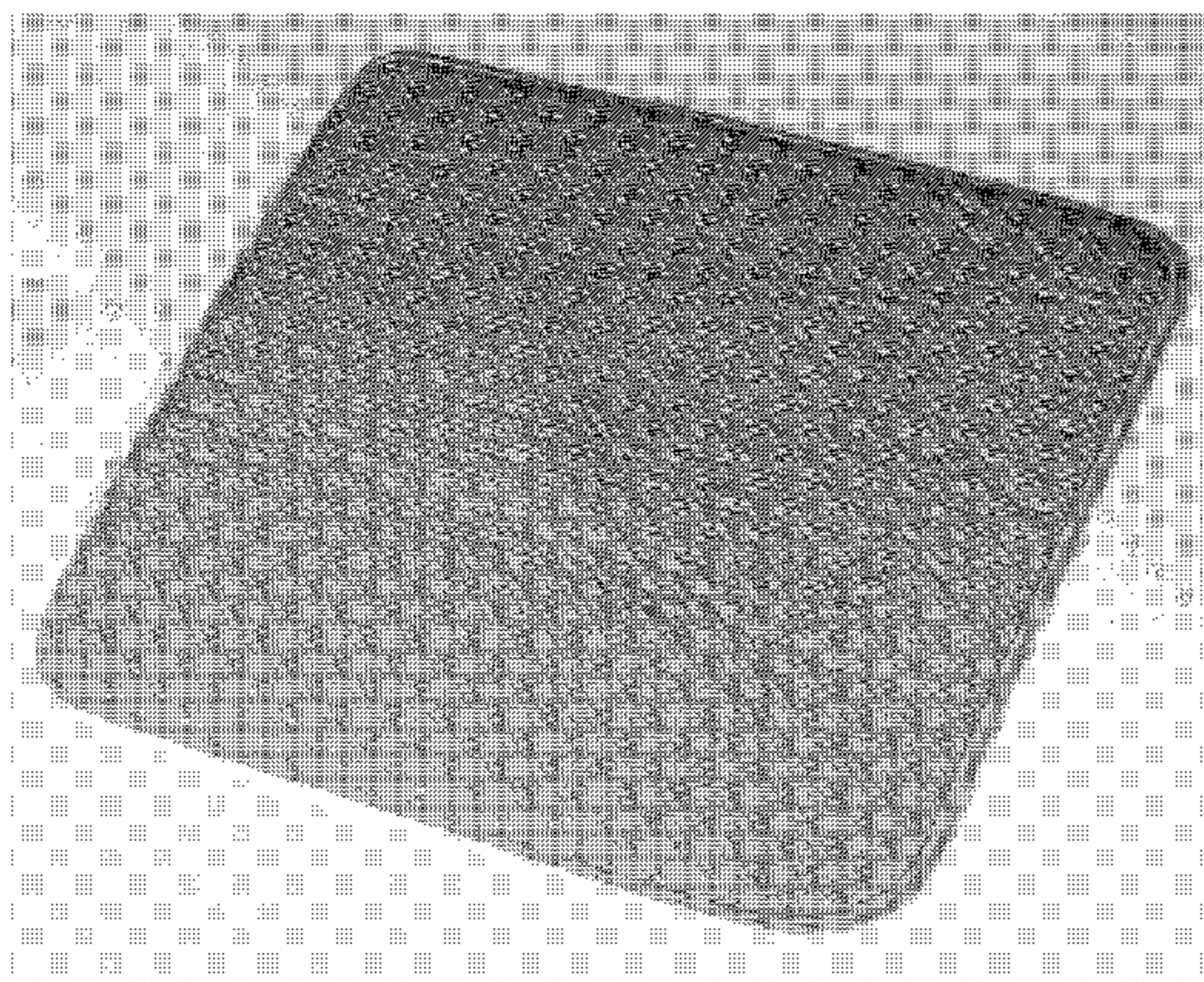
FIG. 4 is an enlarged detail plan view of a representative portion of the drying mat from detail area 4-4 of FIG. 3;

FIG. 5 is an enlarged detail plan view of a portion of the drying mat from detail area 5-5 of FIG. 3 showing a representative side edge.

FIG. 6 is an enlarged detail perspective view of a portion of the drying mat from detail area 6-6 of FIG. 2 showing a representative side edge; and,

FIG. 7 is an enlarged detail perspective view of a portion of the drying mat from detail area 7-7 of FIG. 2 showing a representative and side edges adjacent the corner.

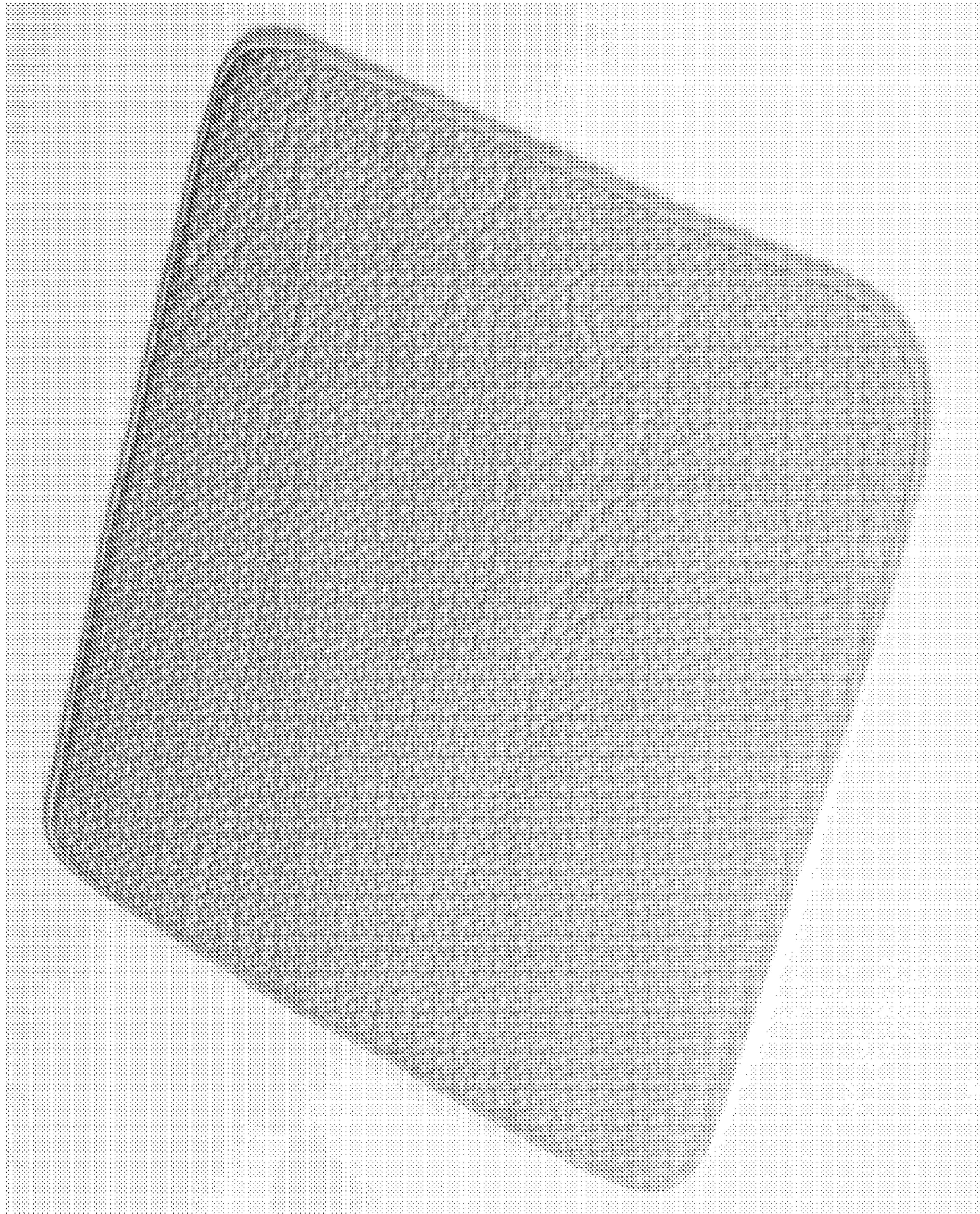

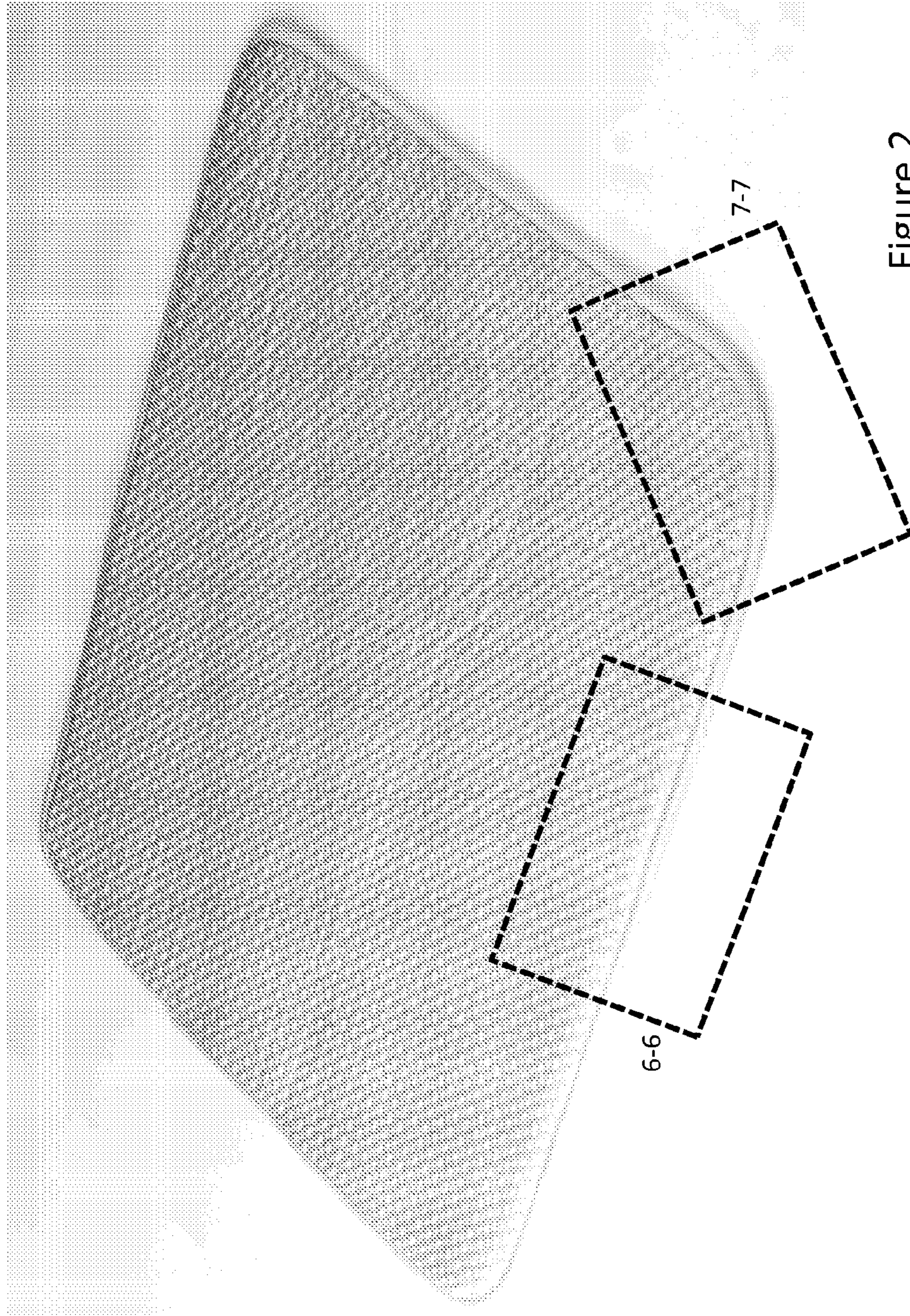

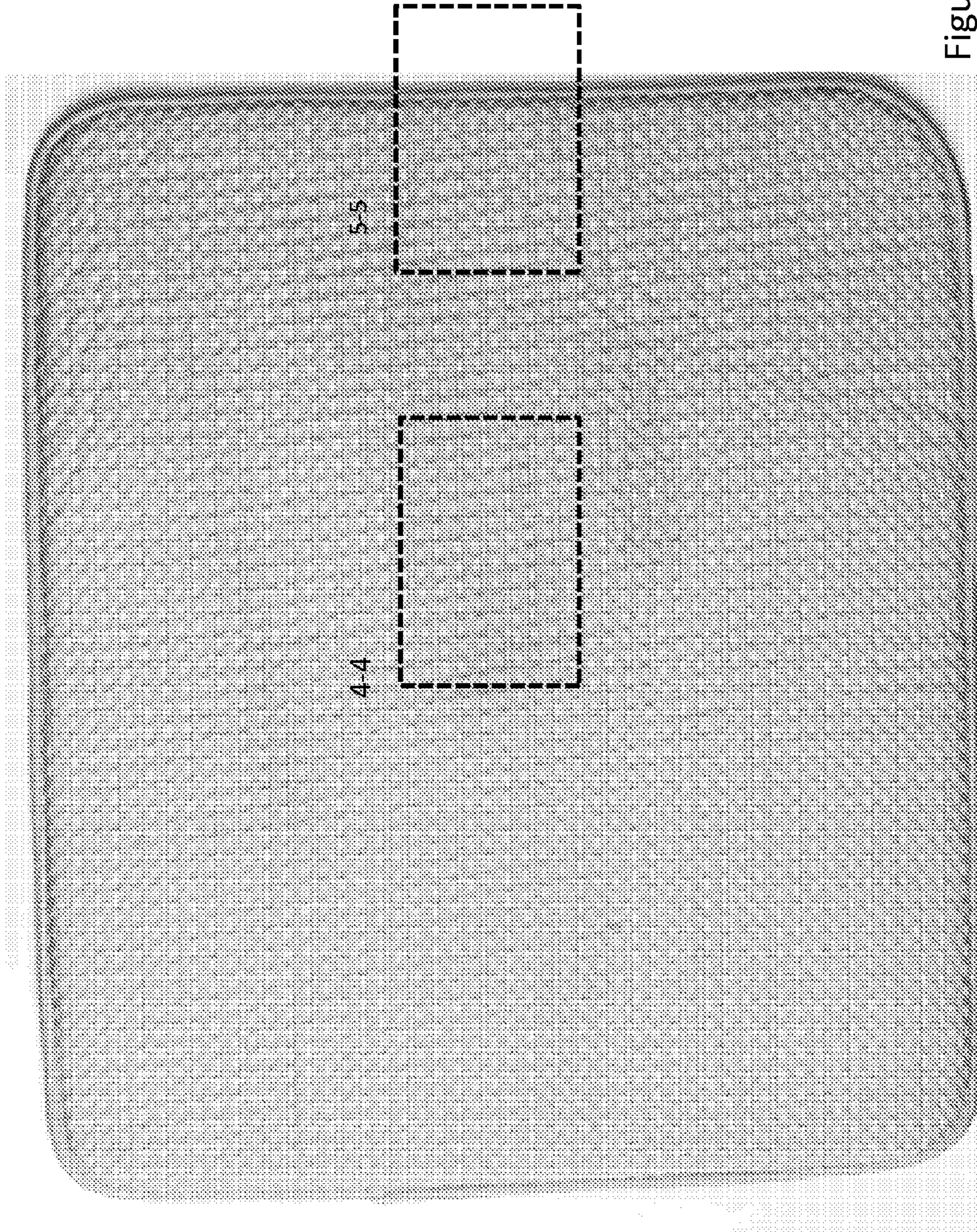

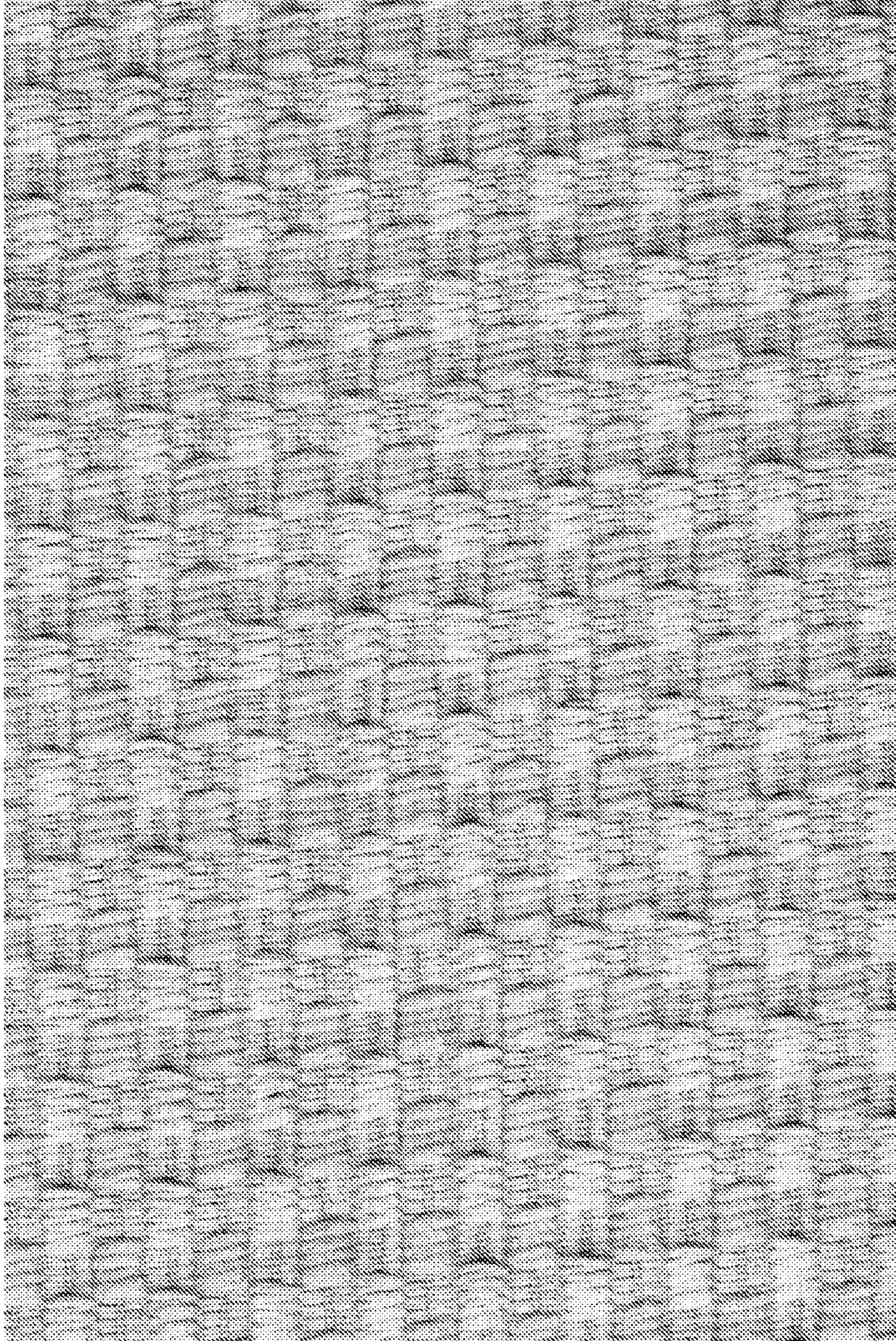

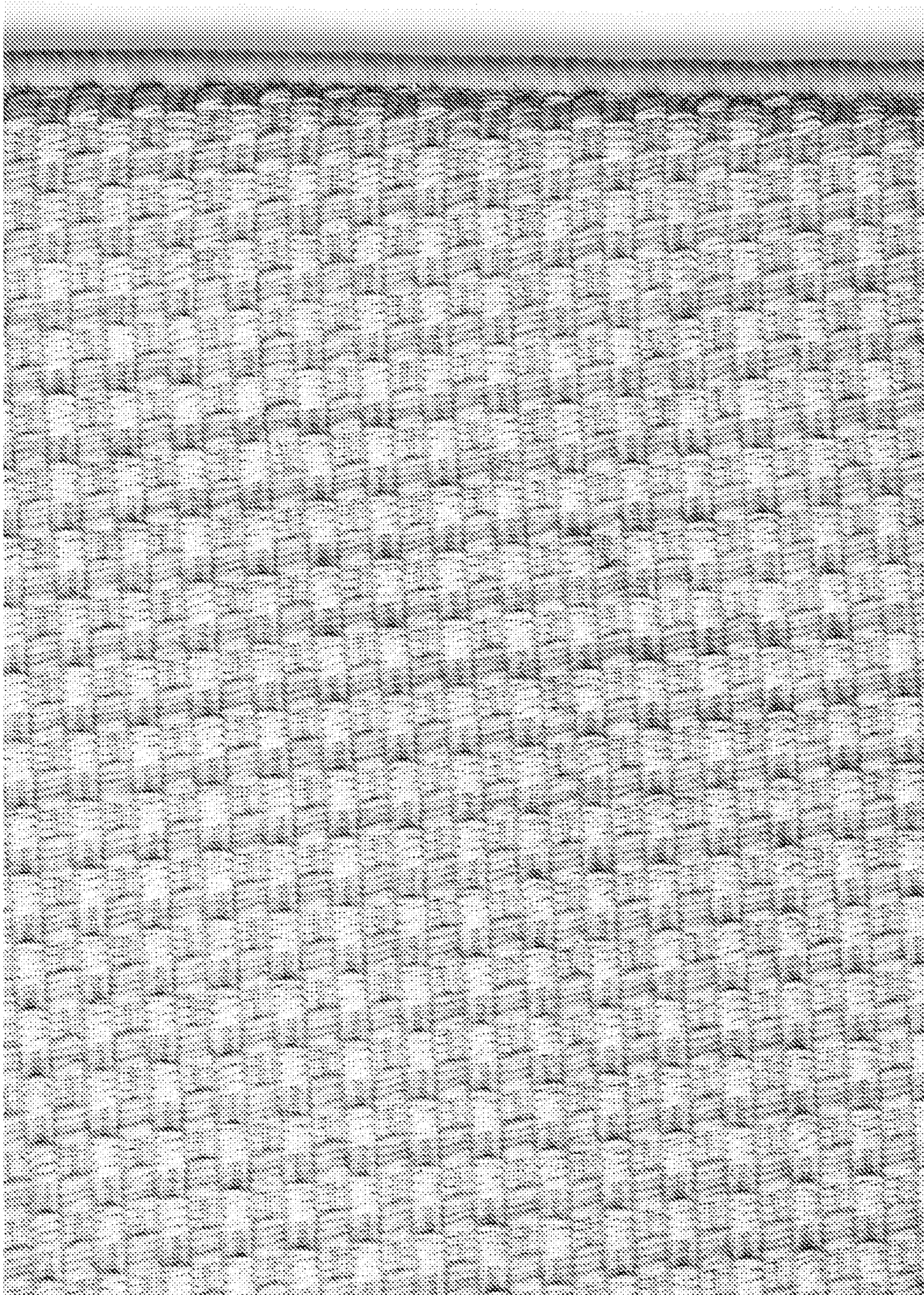

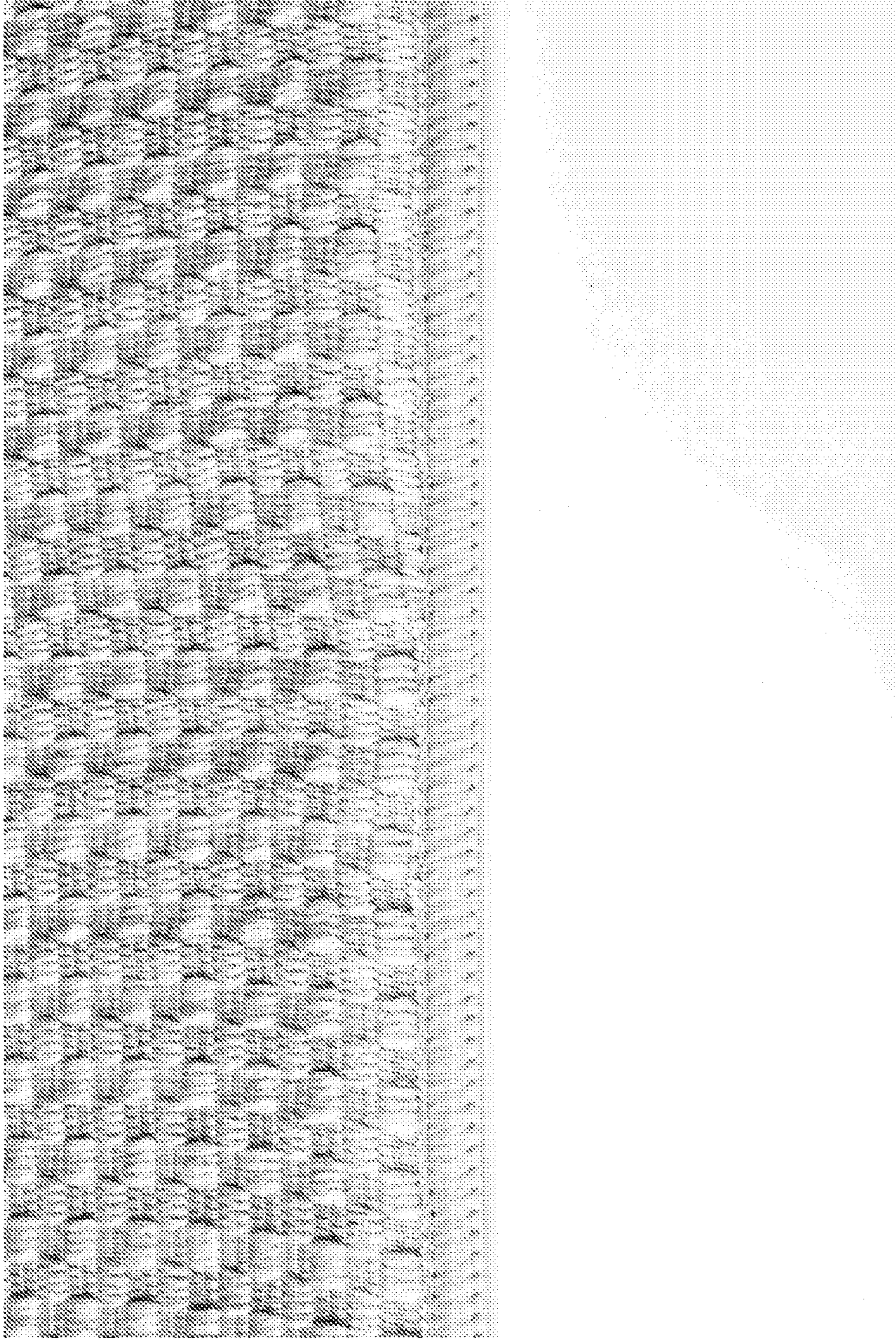

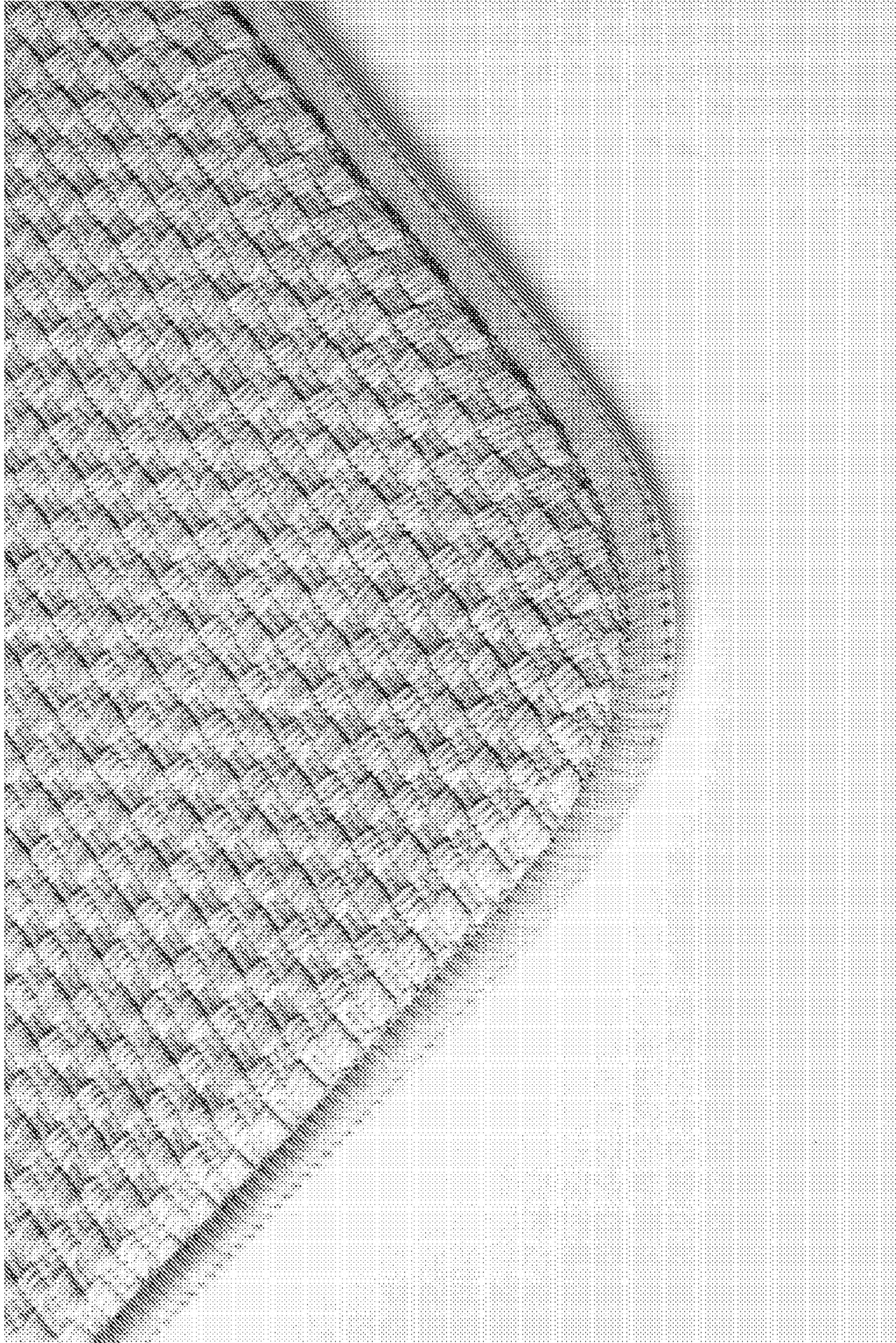
